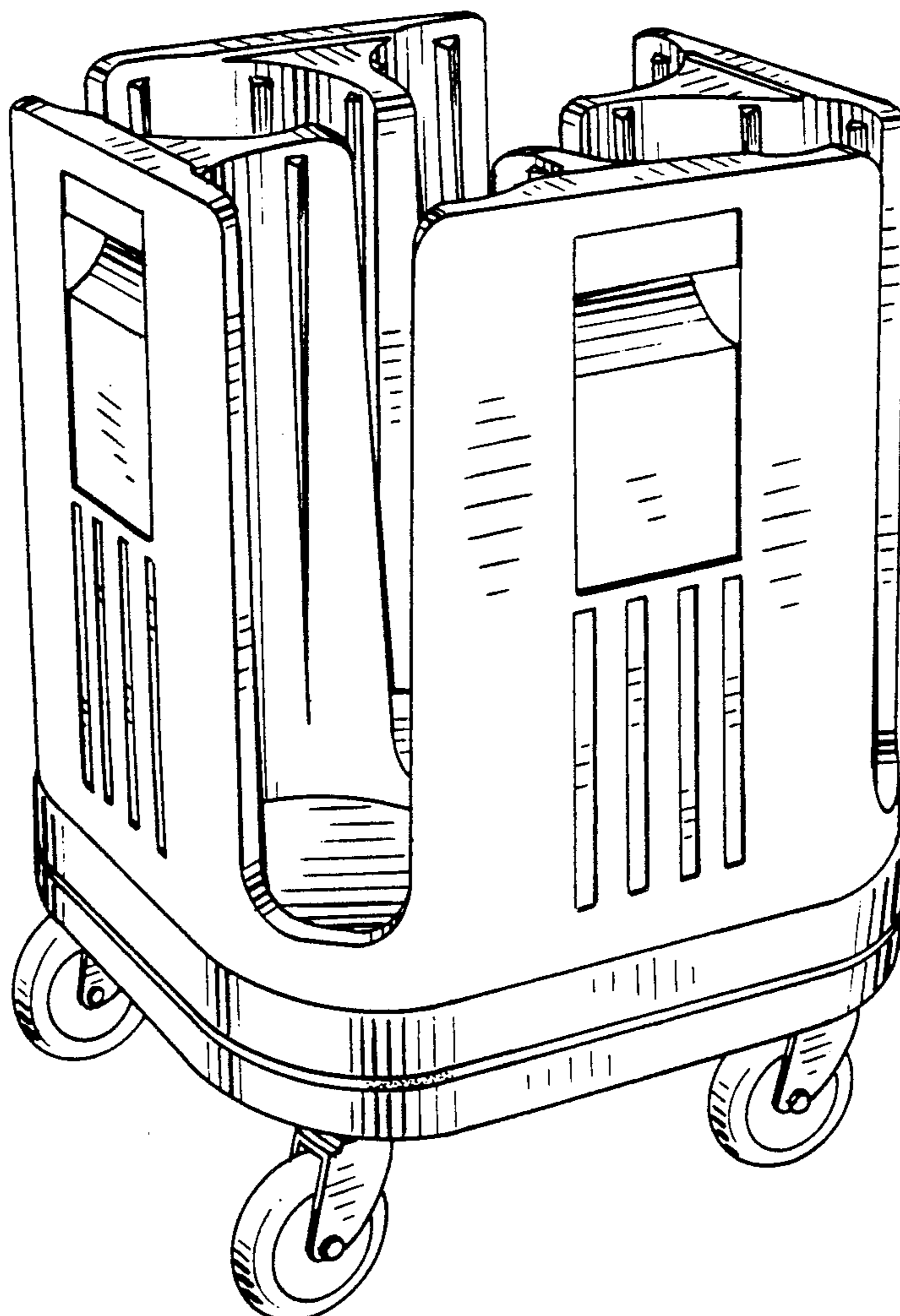

[57] **CLAIM**

The ornamental design for a cart for storing dishes or  
the like, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cart for storing dishes  
or the like showing our new design;  
FIG. 2 is a front perspective view thereof, all other side  
perspective views being identical thereto;  
FIG. 3 is a top perspective view thereof;  
FIG. 4 is a bottom perspective view thereof;  
FIG. 5 is a perspective view of a modified form of FIG.  
1;  
FIG. 6 is a right side perspective view of FIG. 5, the left  
side perspective view being identical thereto;  
FIG. 7 is a front perspective view of FIG. 5, the rear  
perspective view being identical thereto;  
FIG. 8 is a top perspective view of FIG. 5; and  
FIG. 9 is a bottom perspective view of FIG. 5.



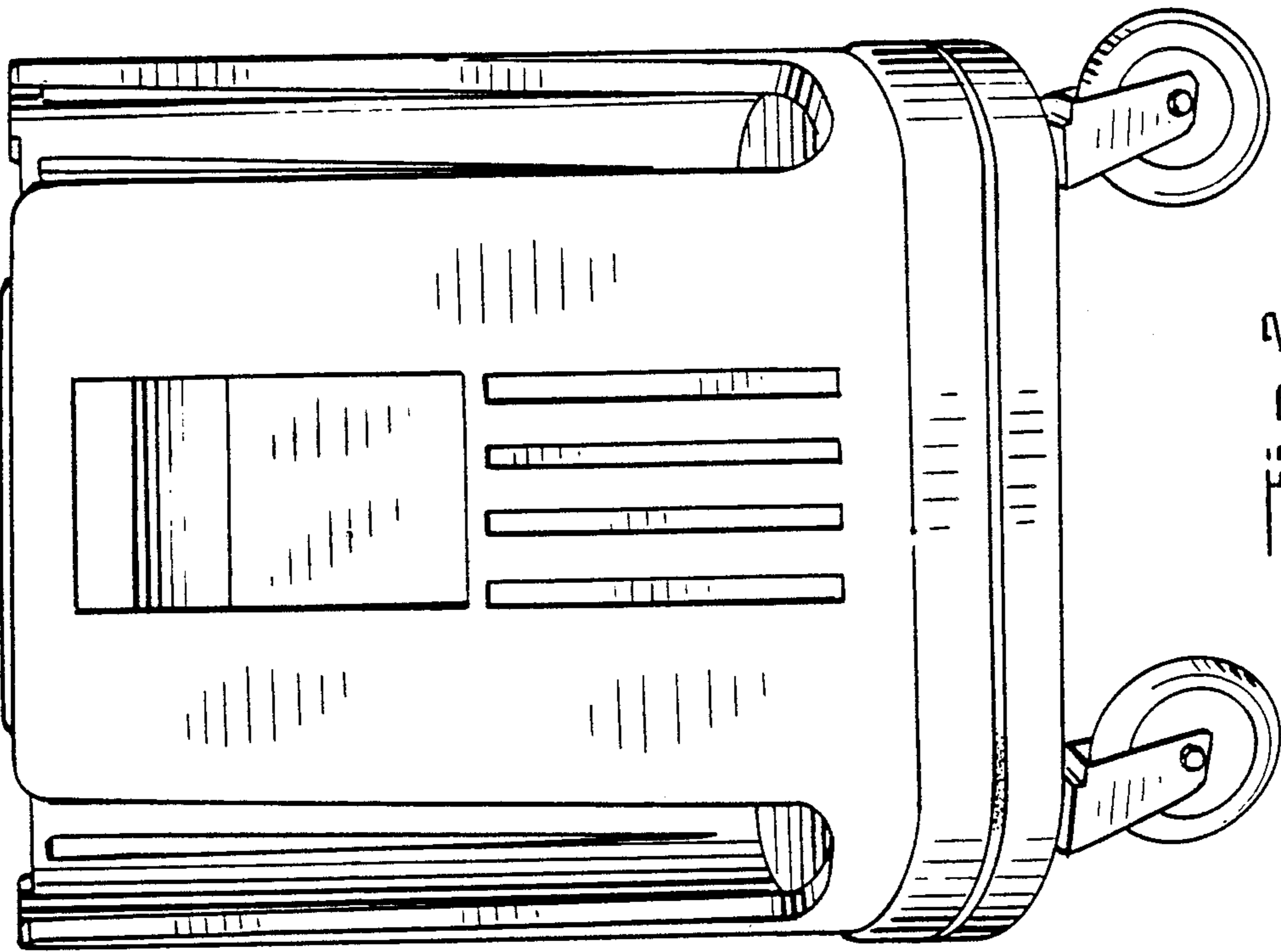

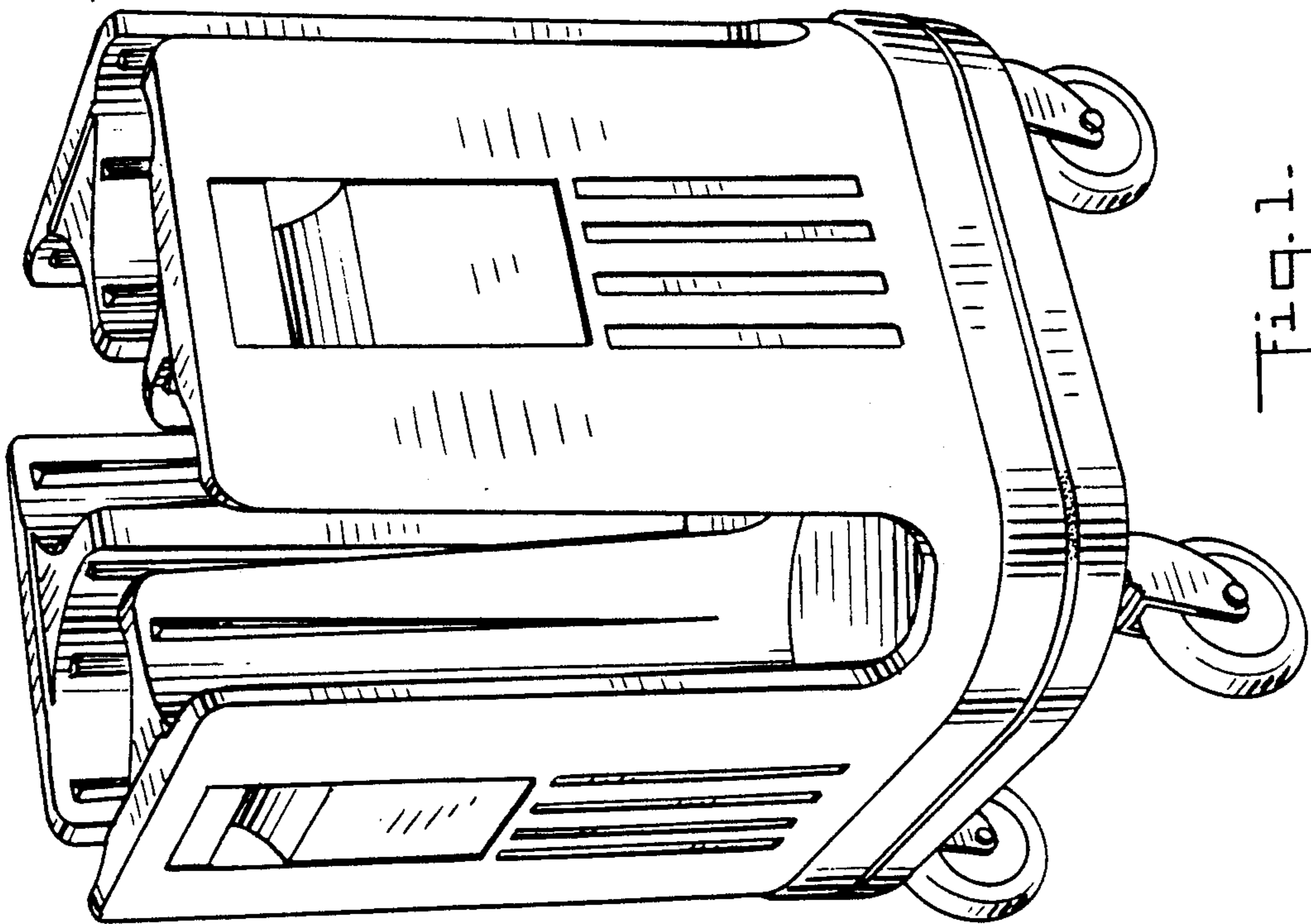

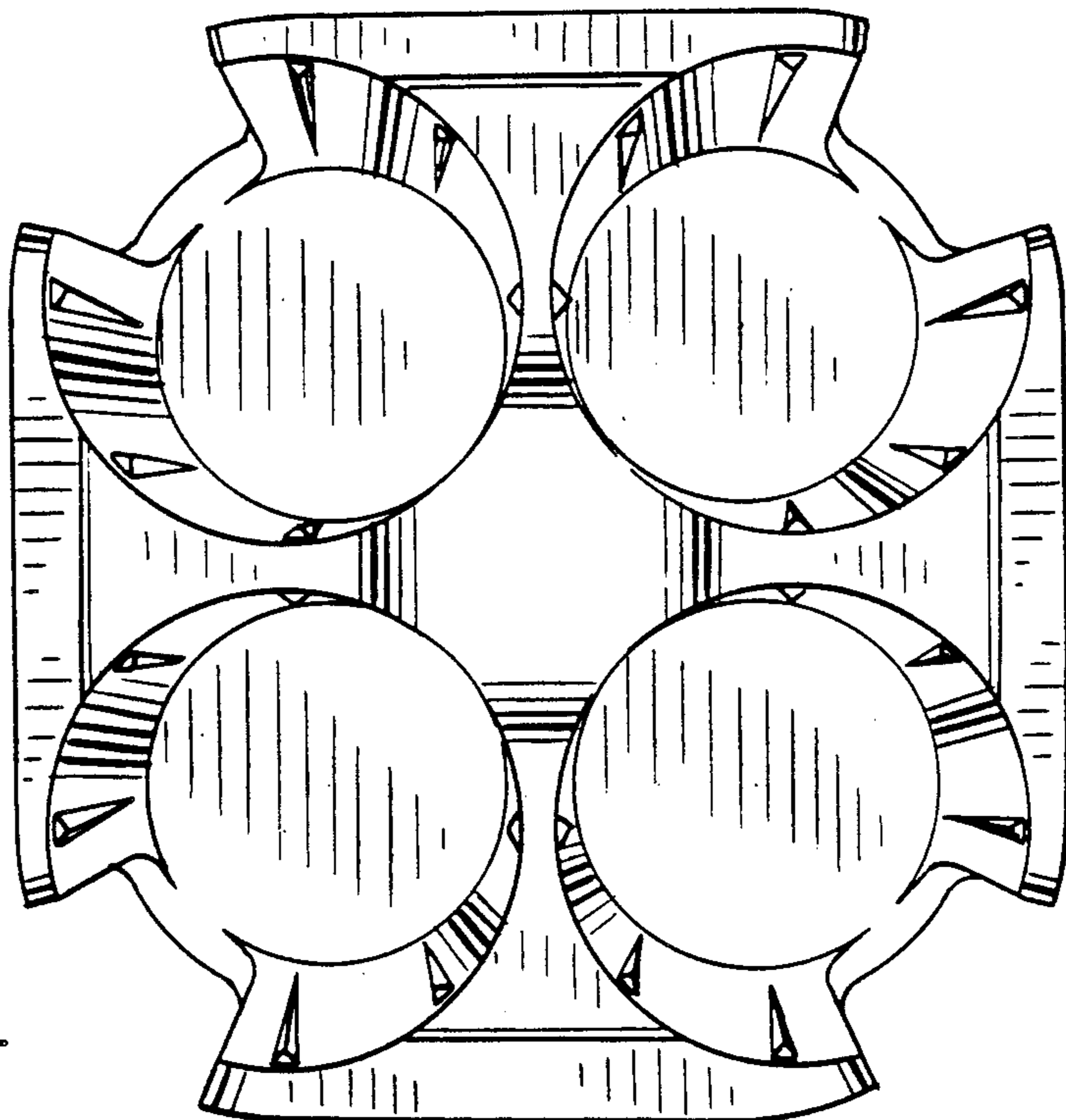

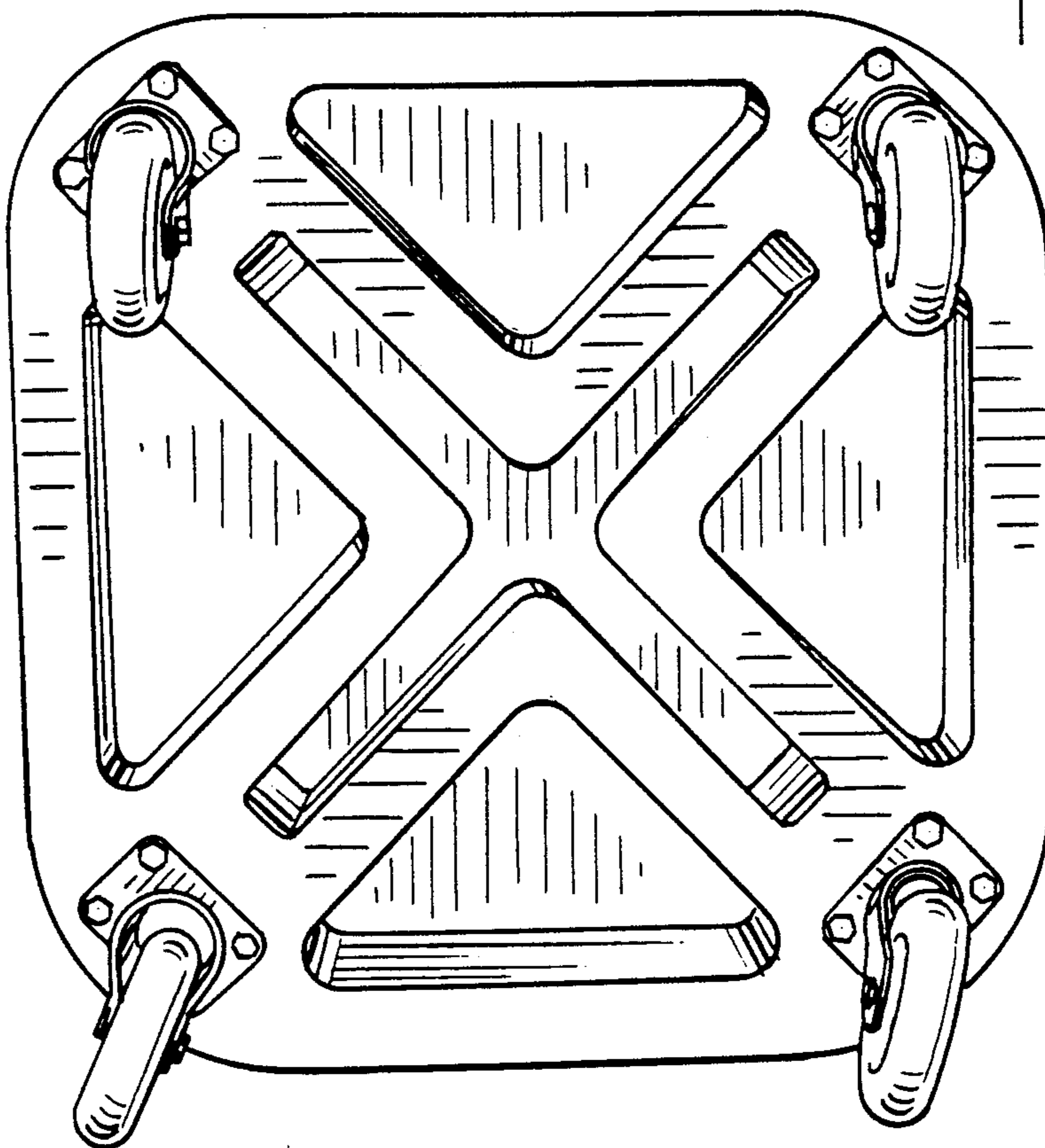

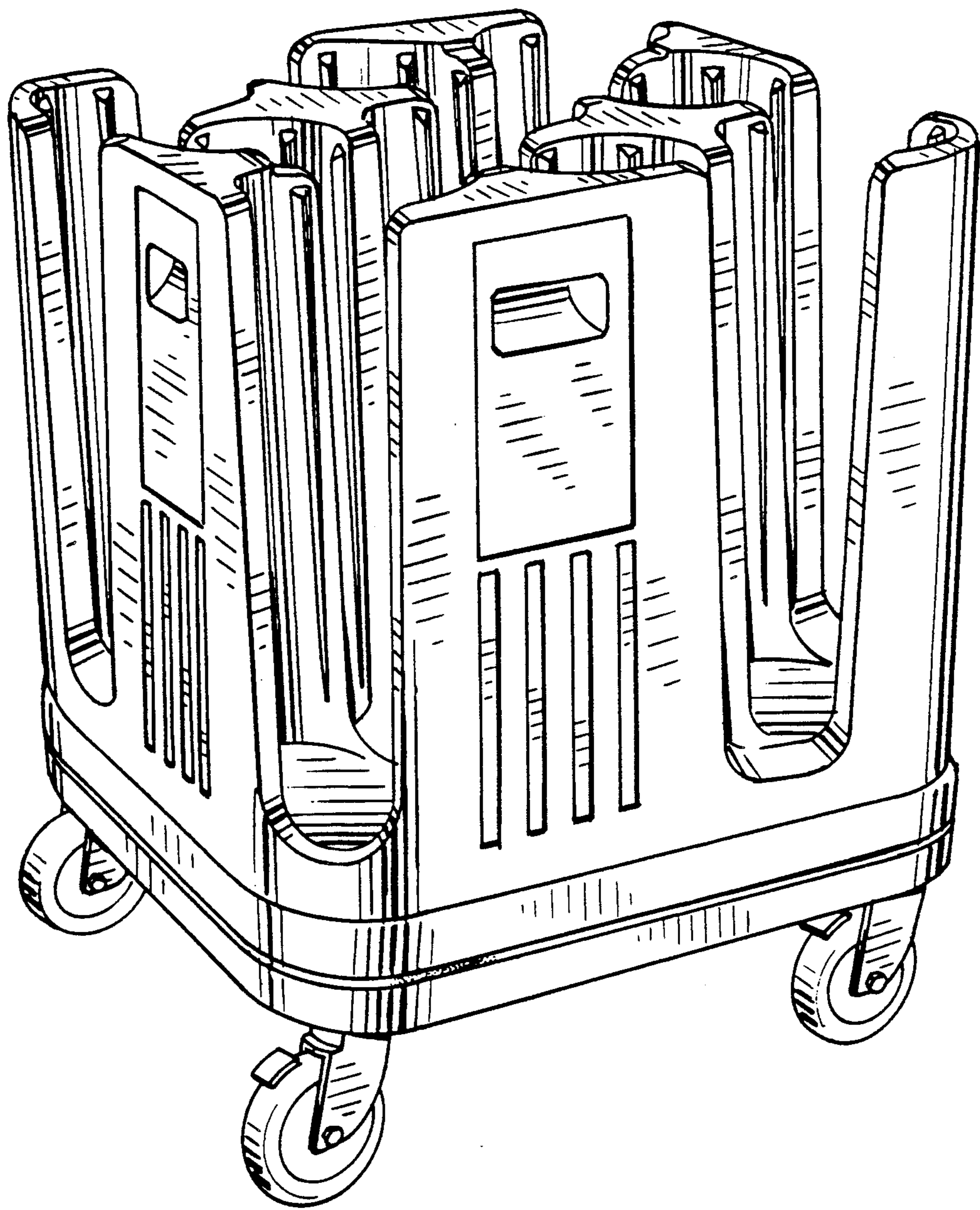

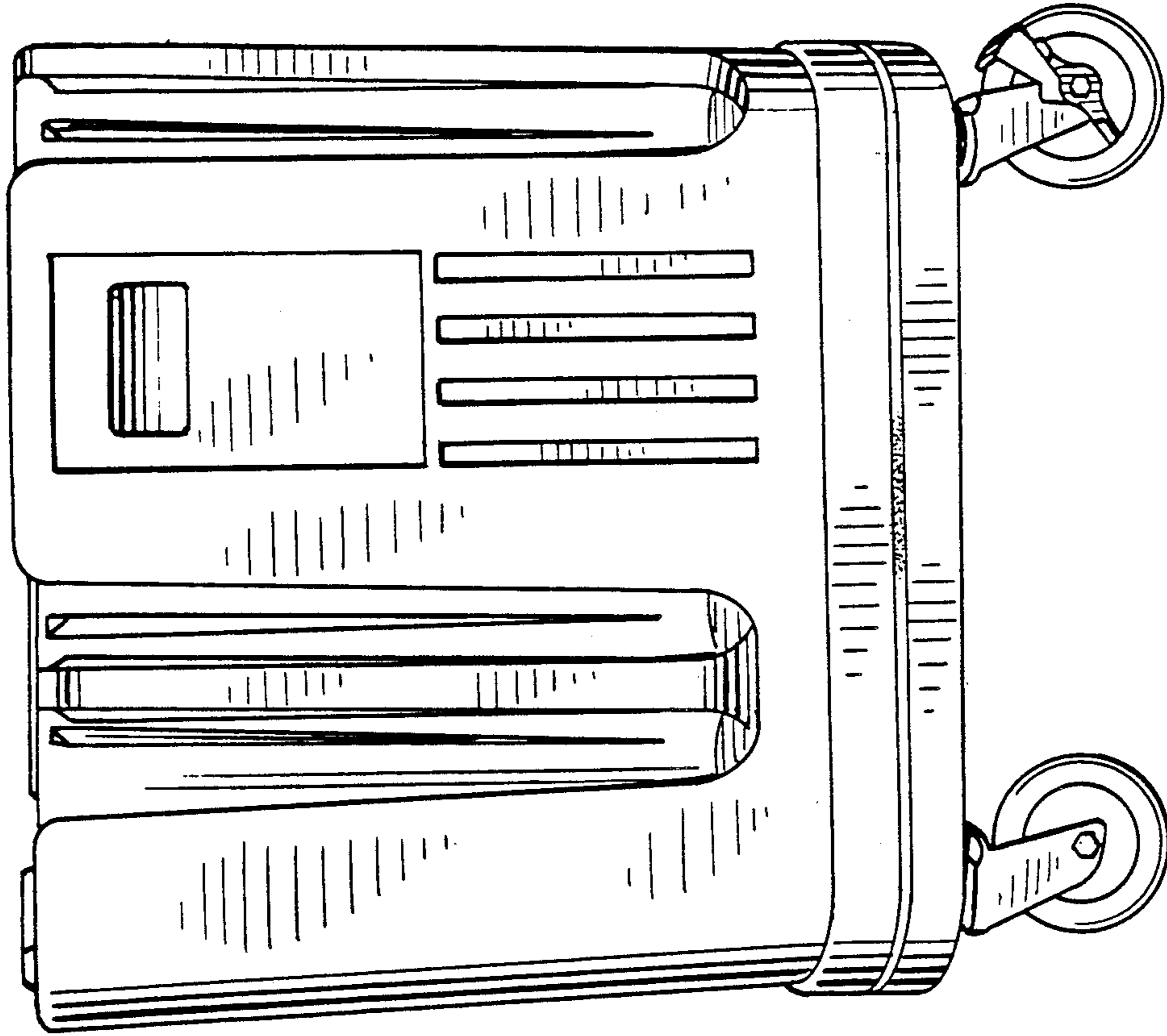

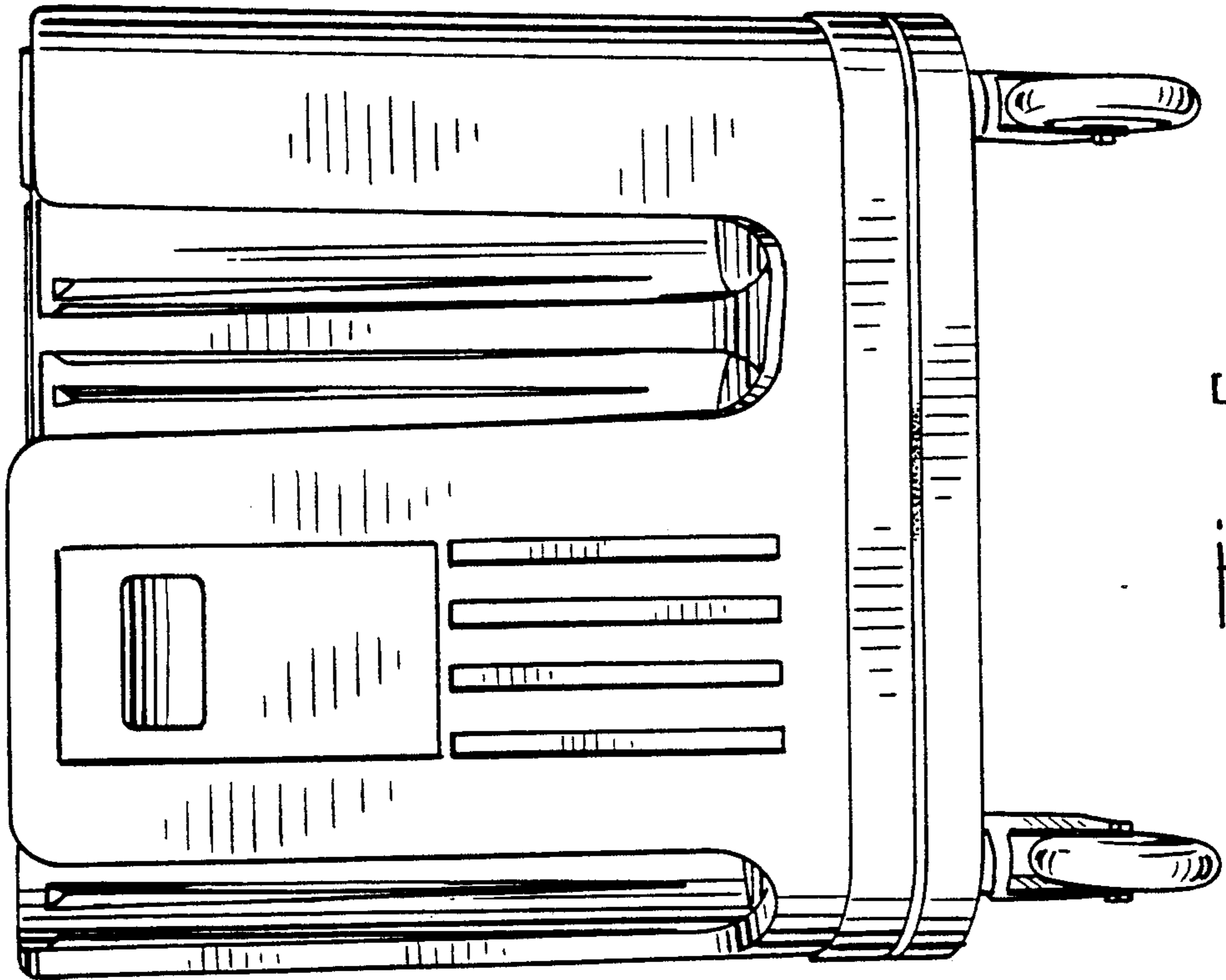

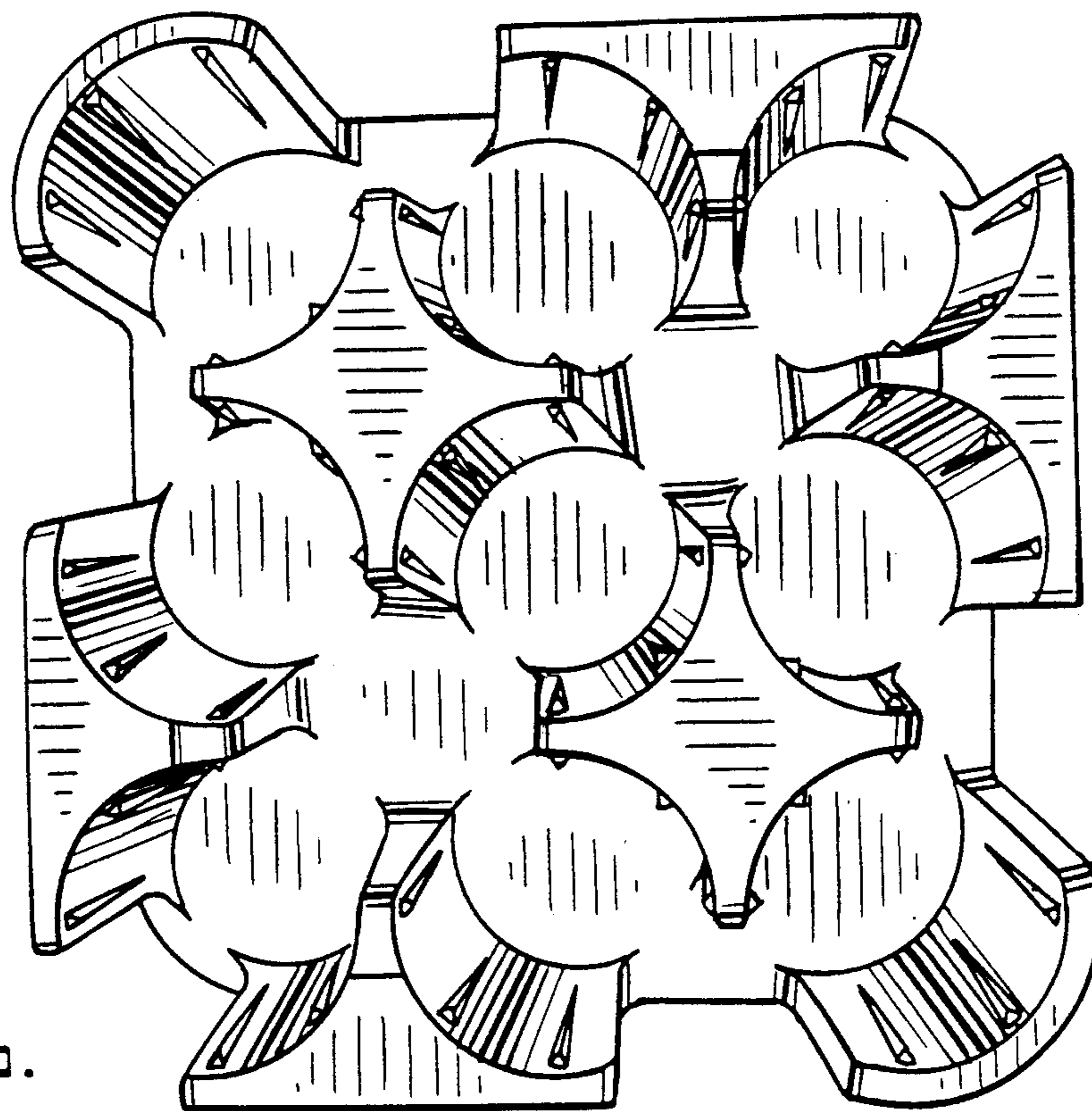

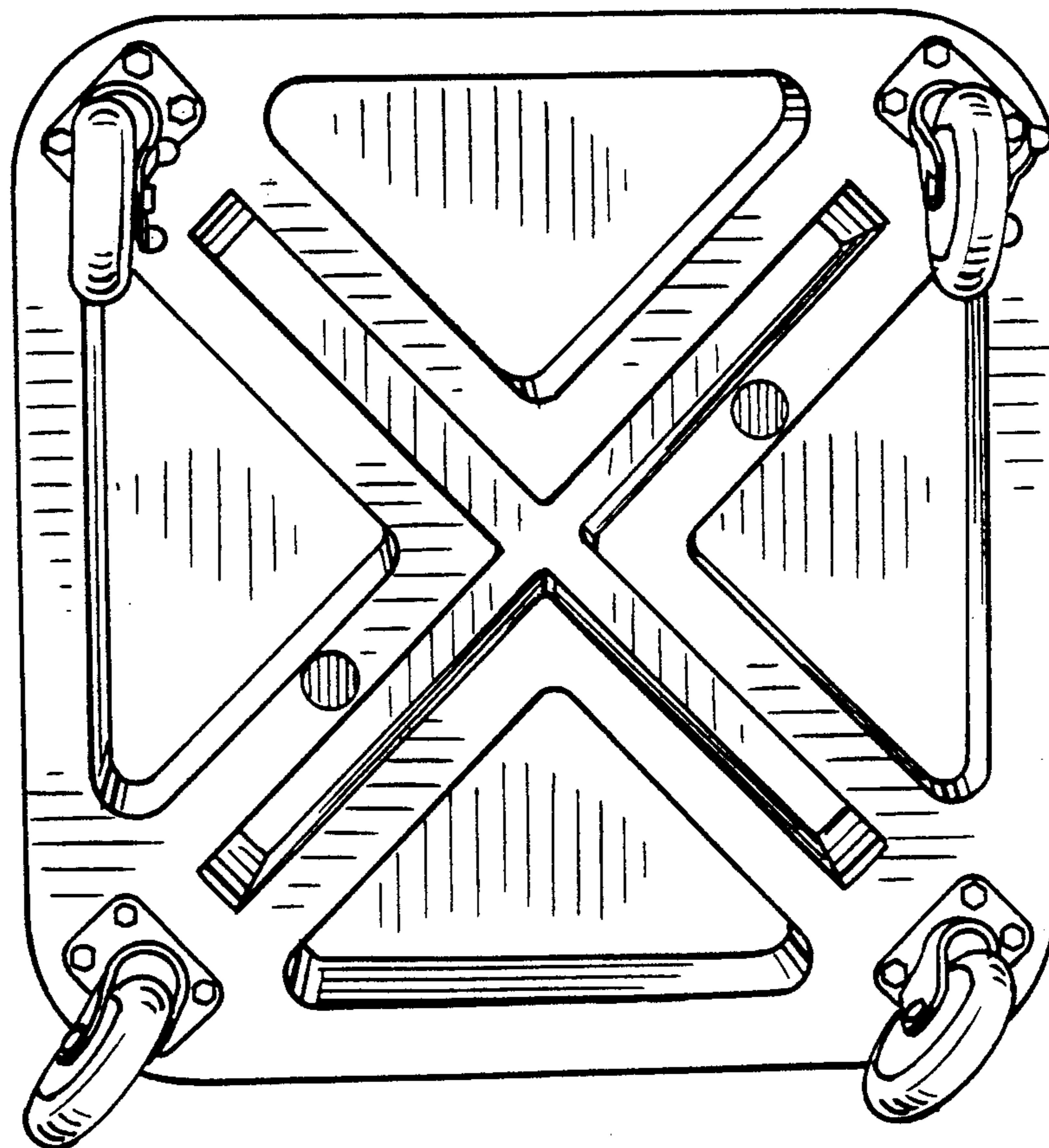
