[57] **CLAIM**

The ornamental design for a water distillation unit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a water distillation unit showing our new design;

FIG. 2 is a top plan view thereof, on an enlarged scale; FIG. 3 is a bottom plan view thereof, on an enlarged scale;

FIG. 4 is a left side elevational view thereof, on an enlarged scale;

FIG. 8 is a perspective view thereof, the access panel shown in an open position;

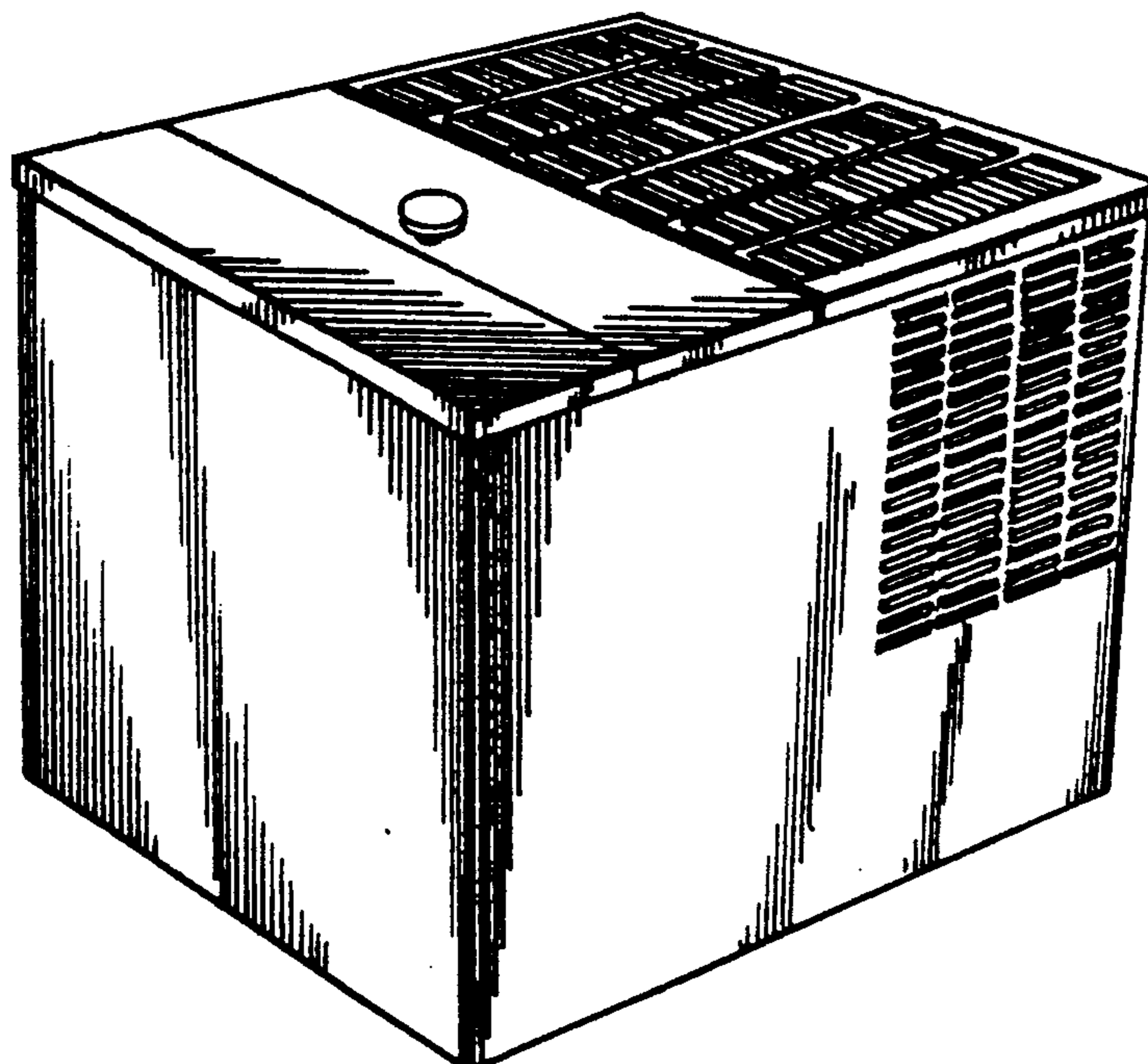
FIG. 9 is a top plan view thereof, on an enlarged scale;

FIG. 13 is a rear elevational view thereof, on an enlarged scale.



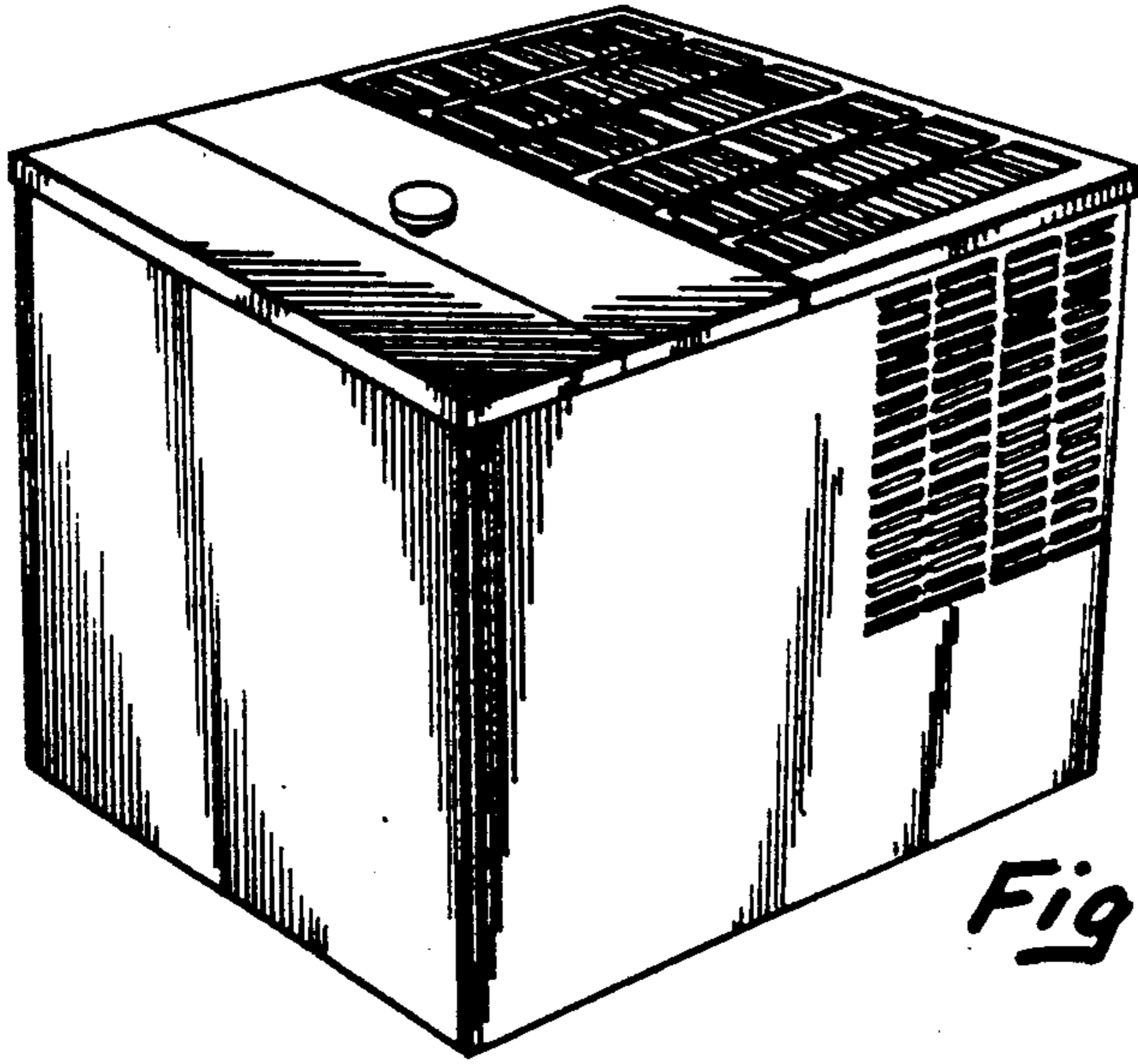

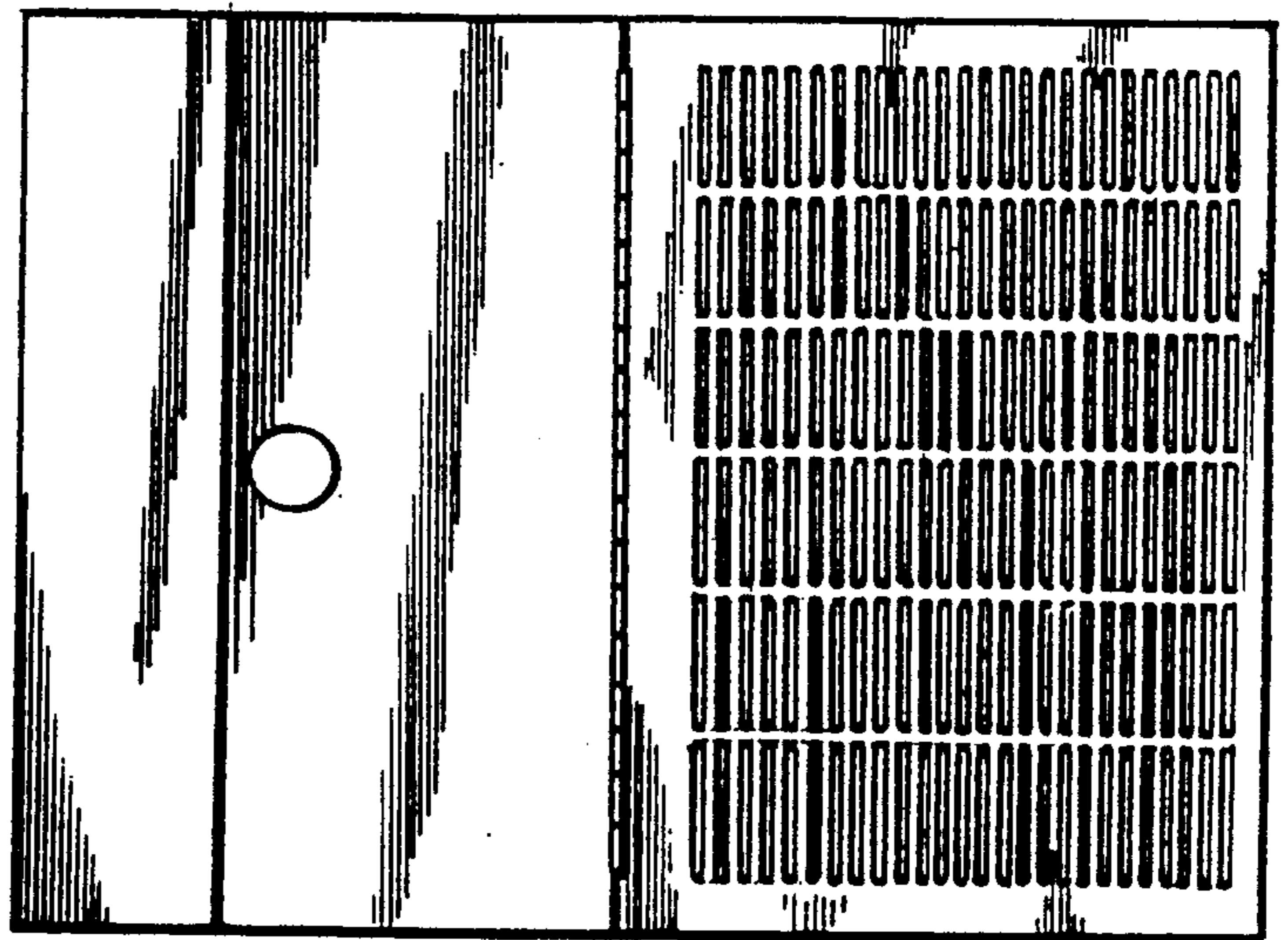

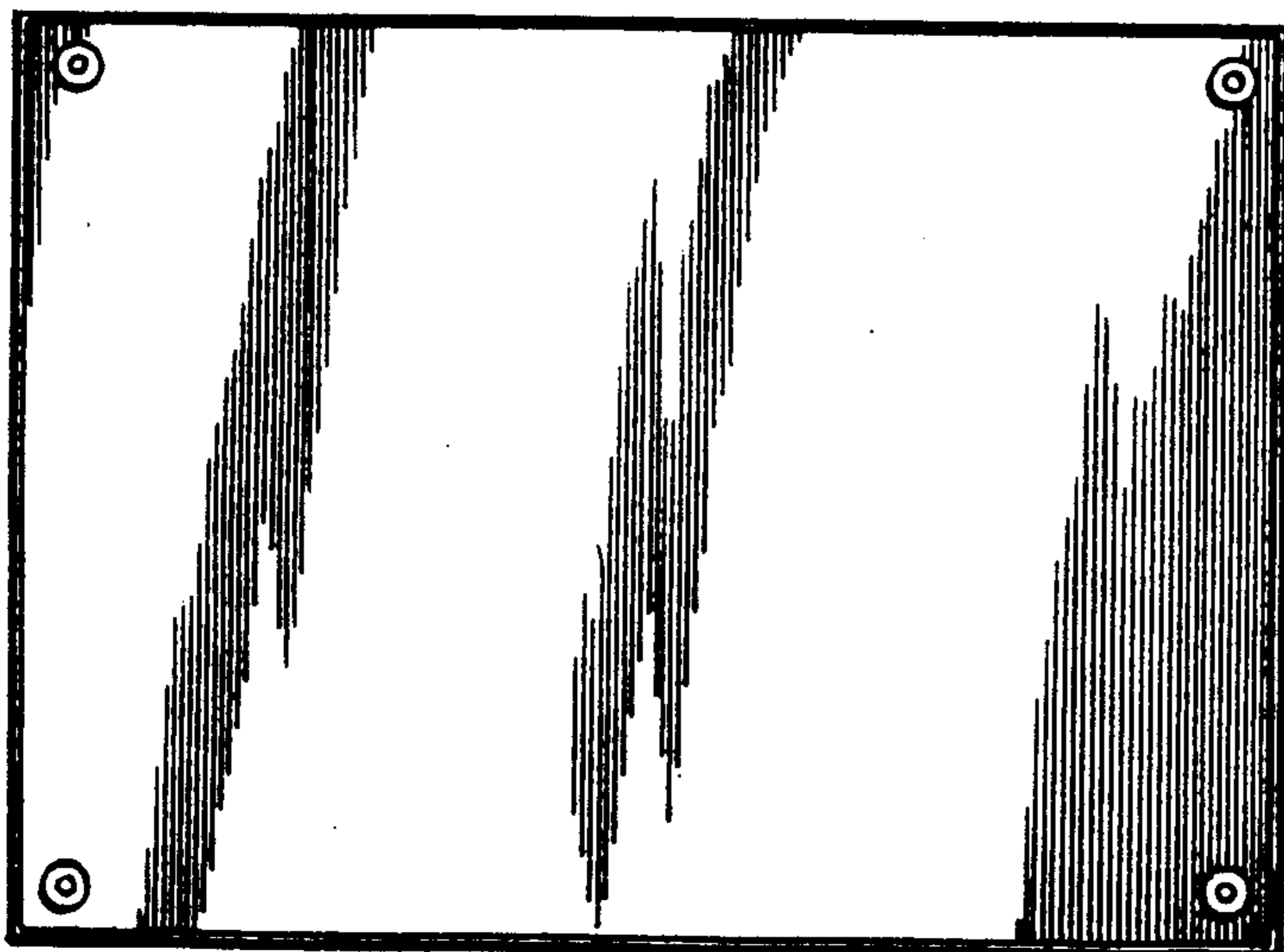

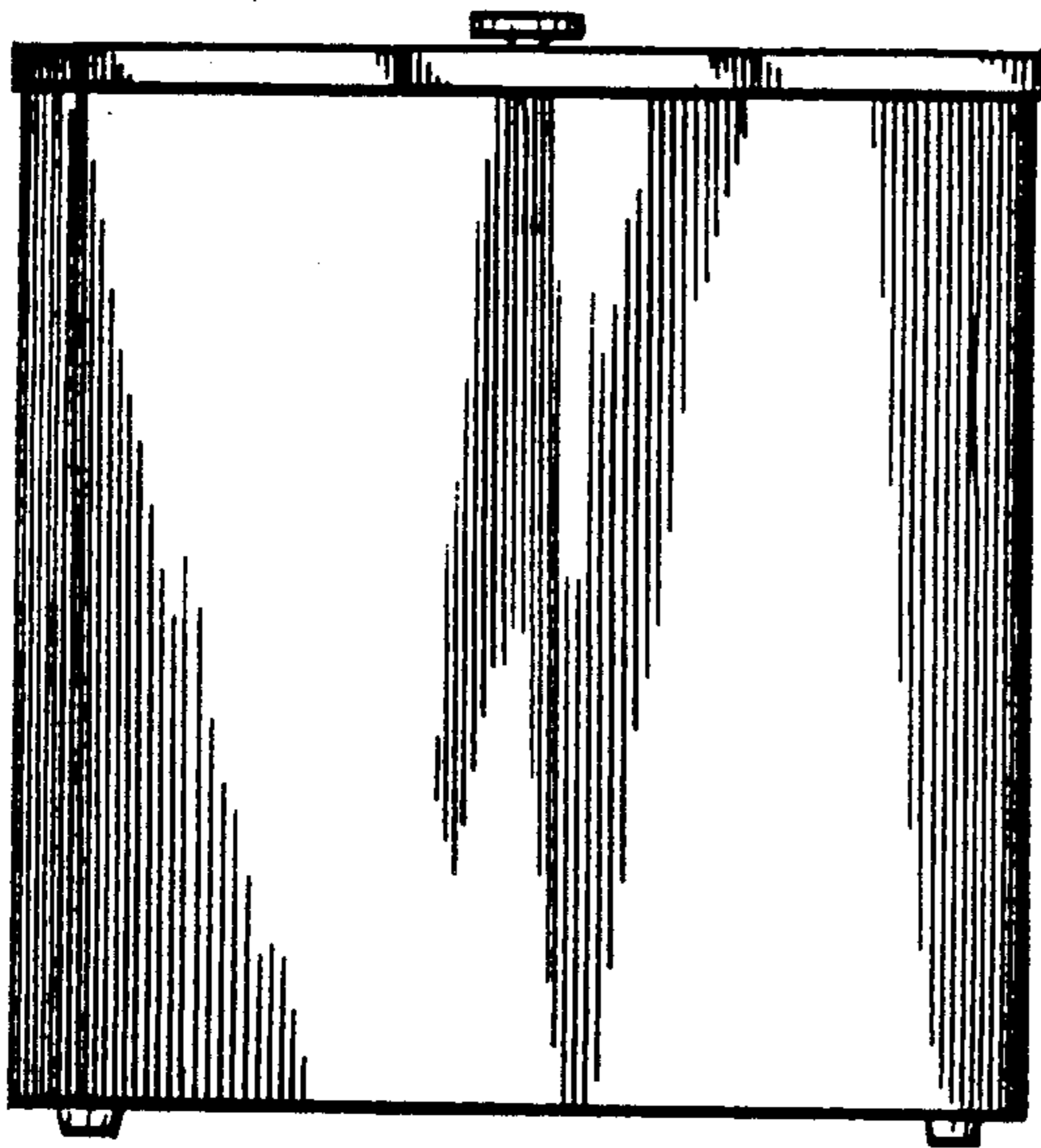

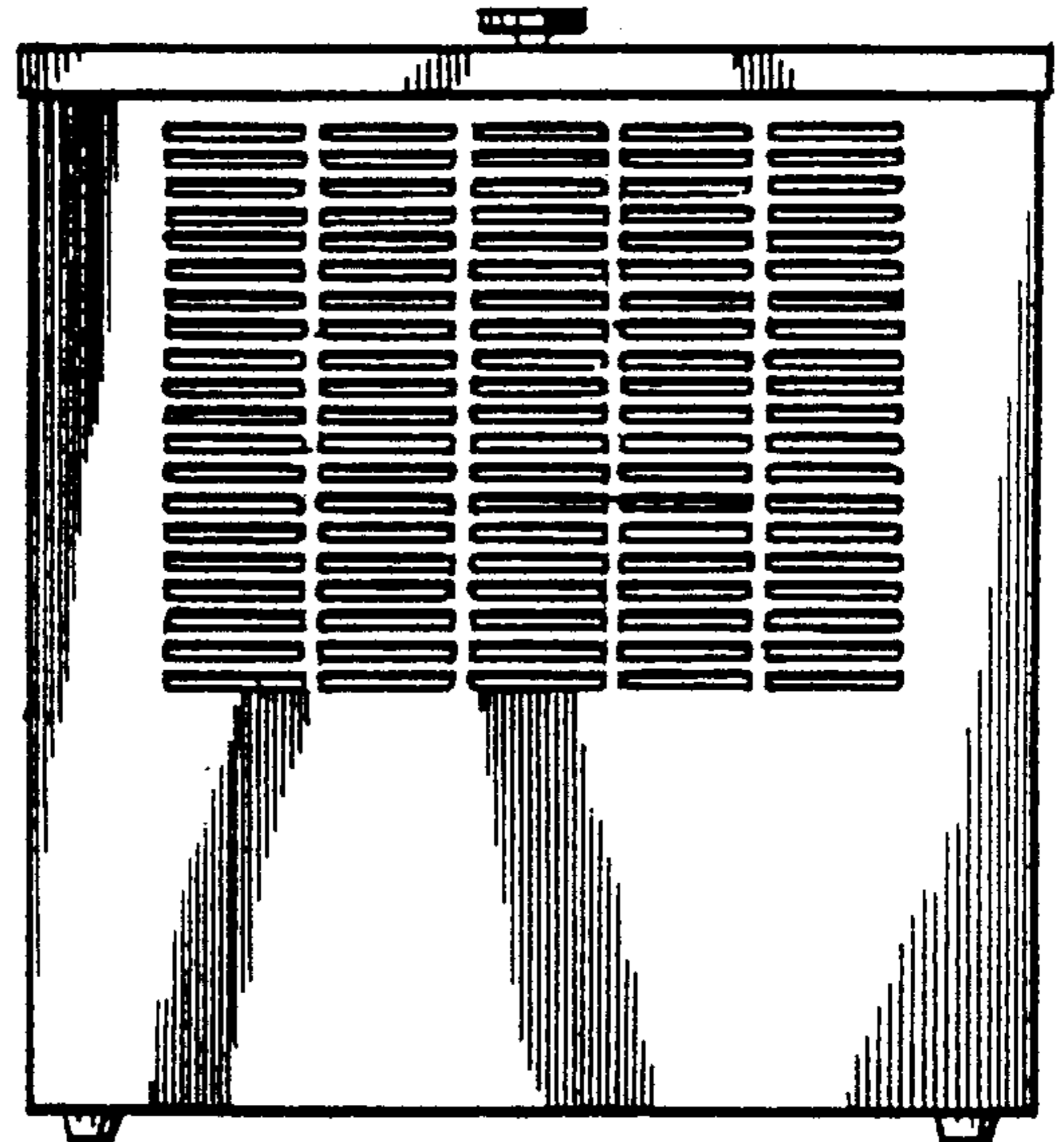

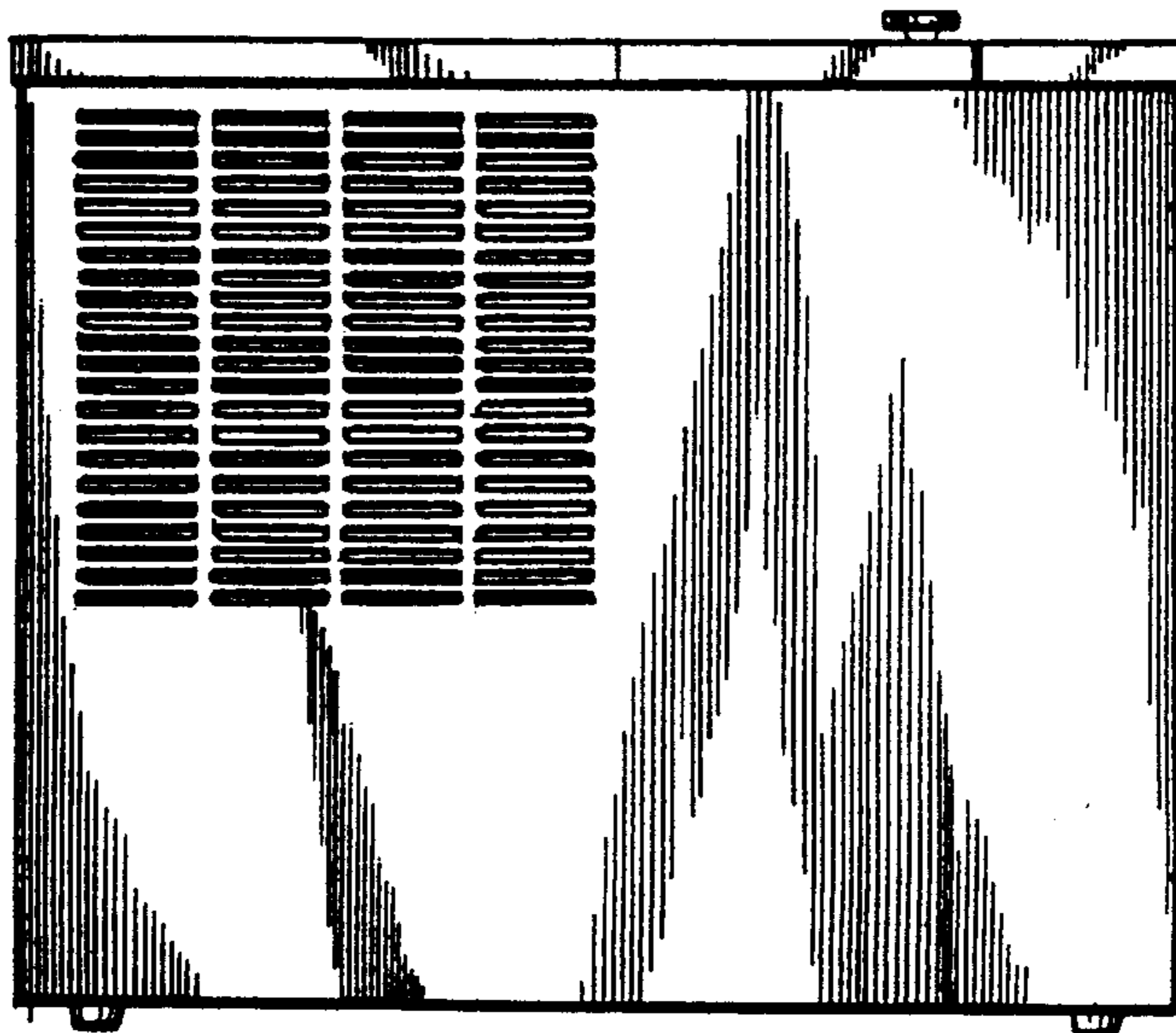

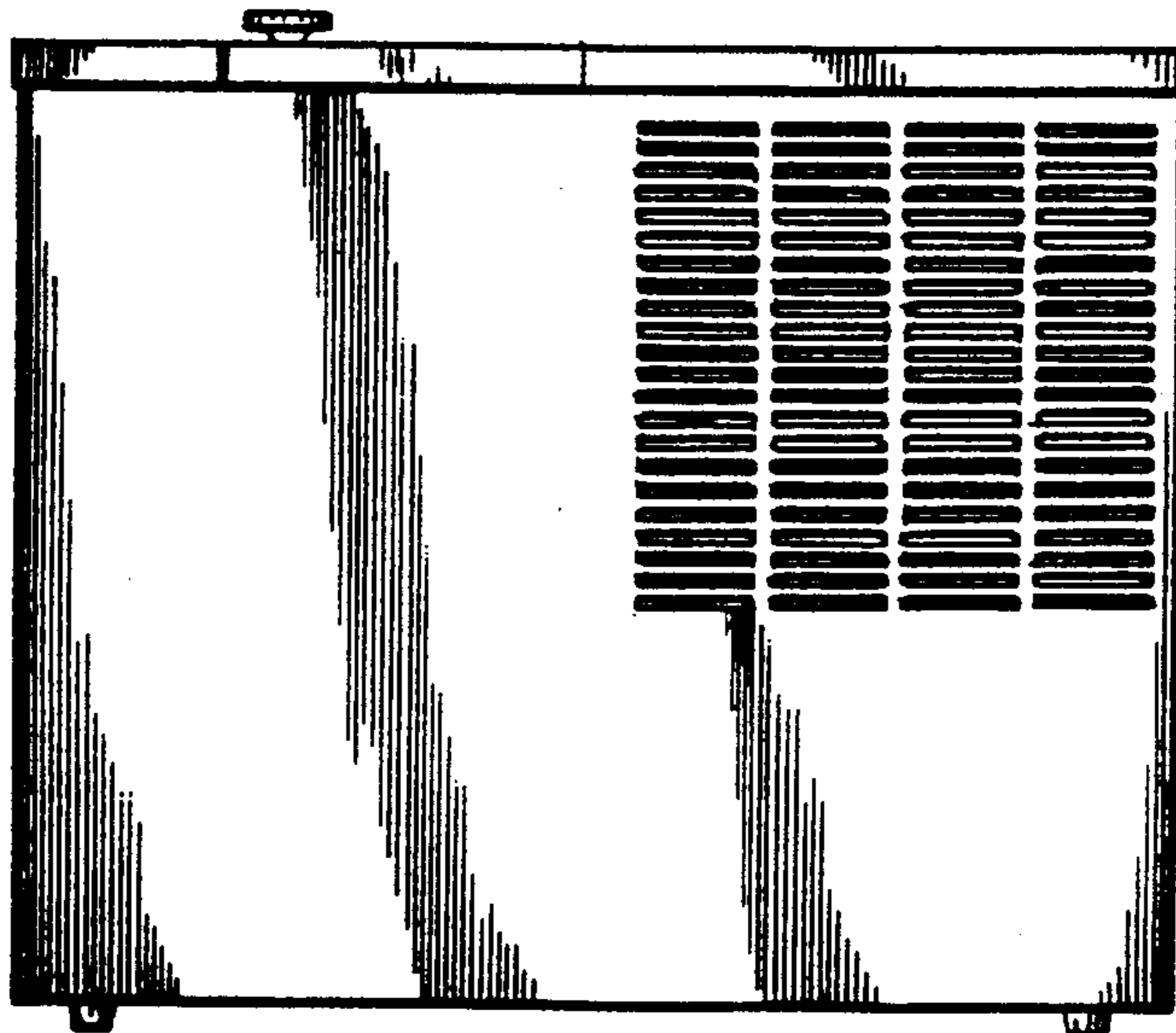

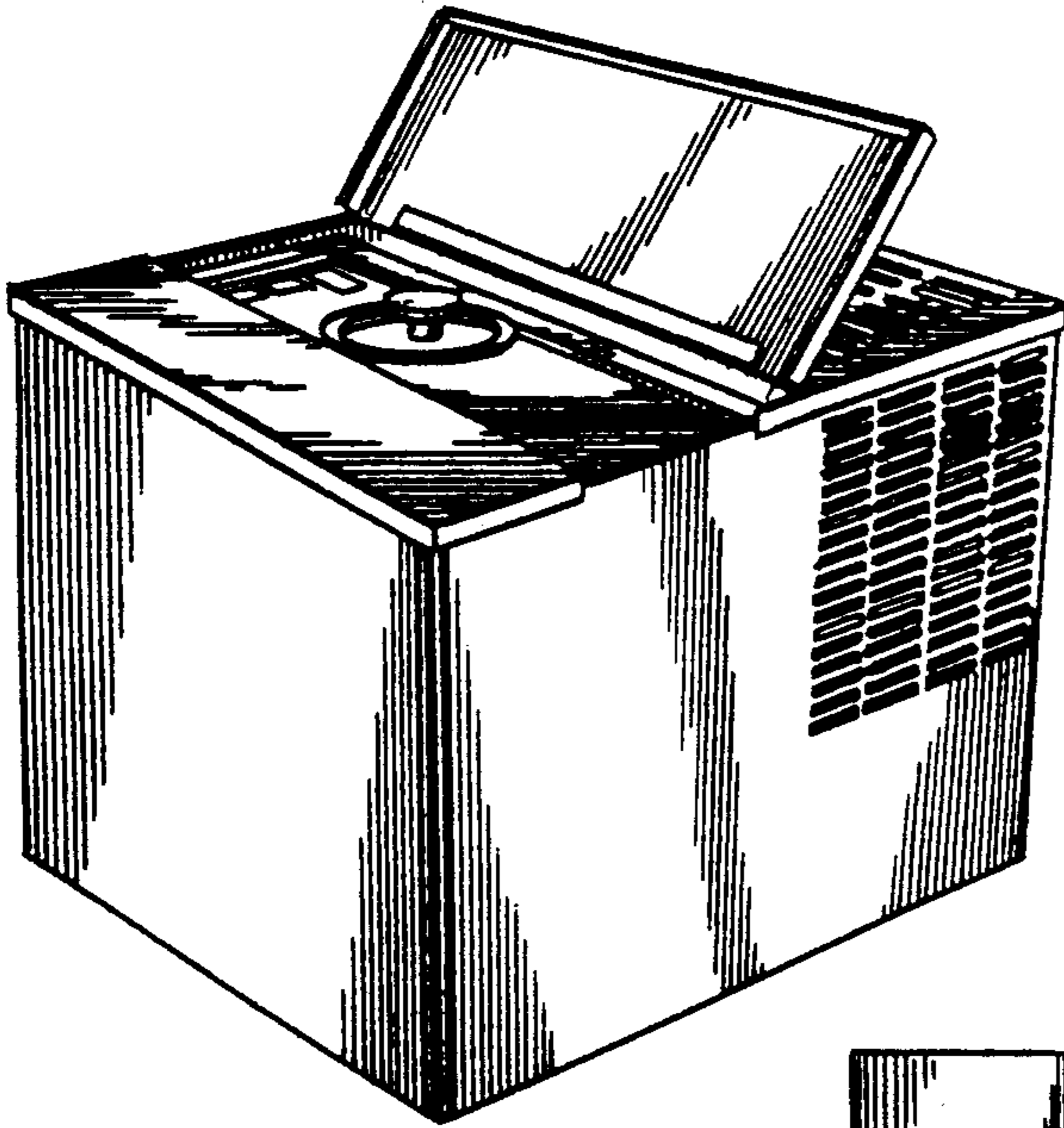

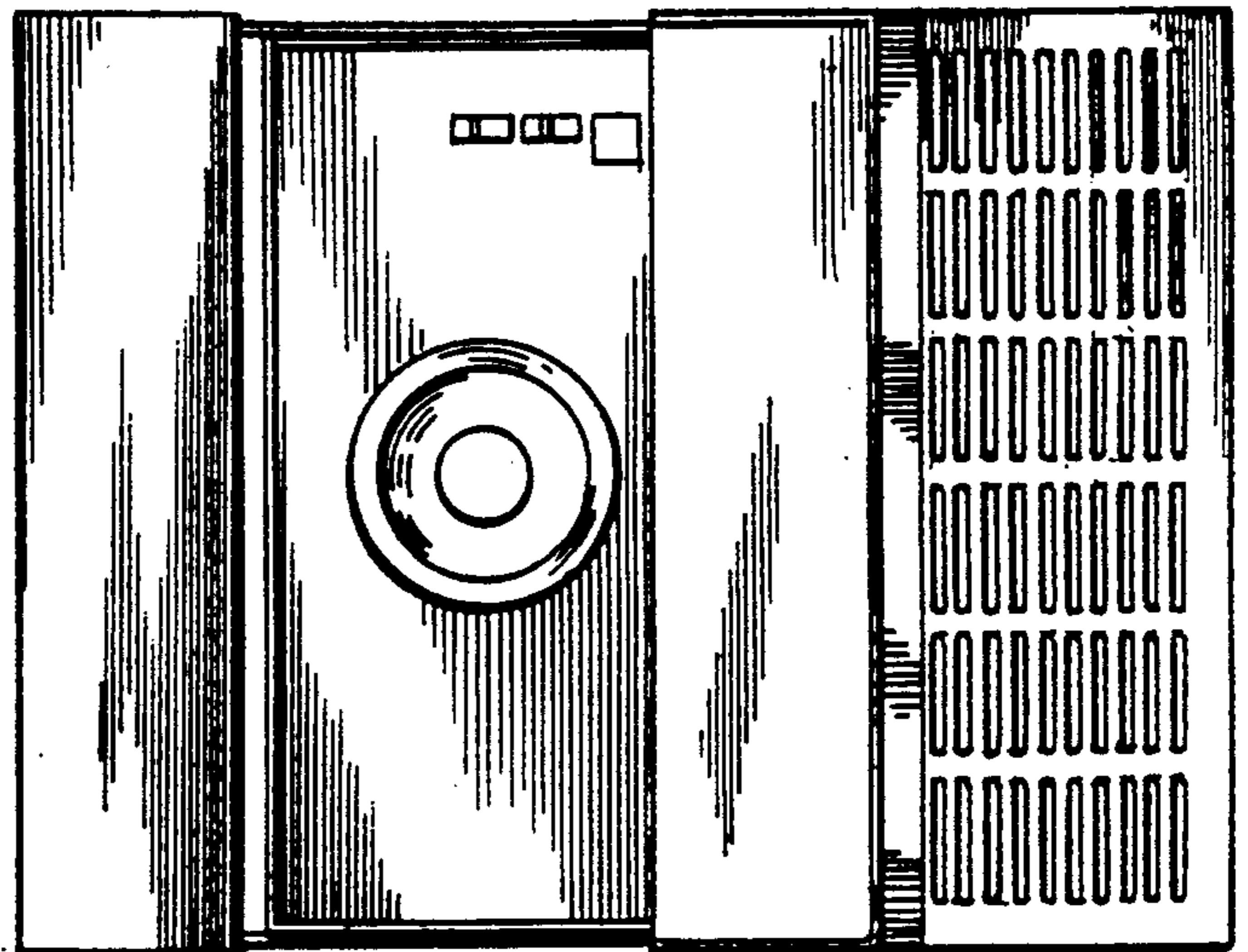

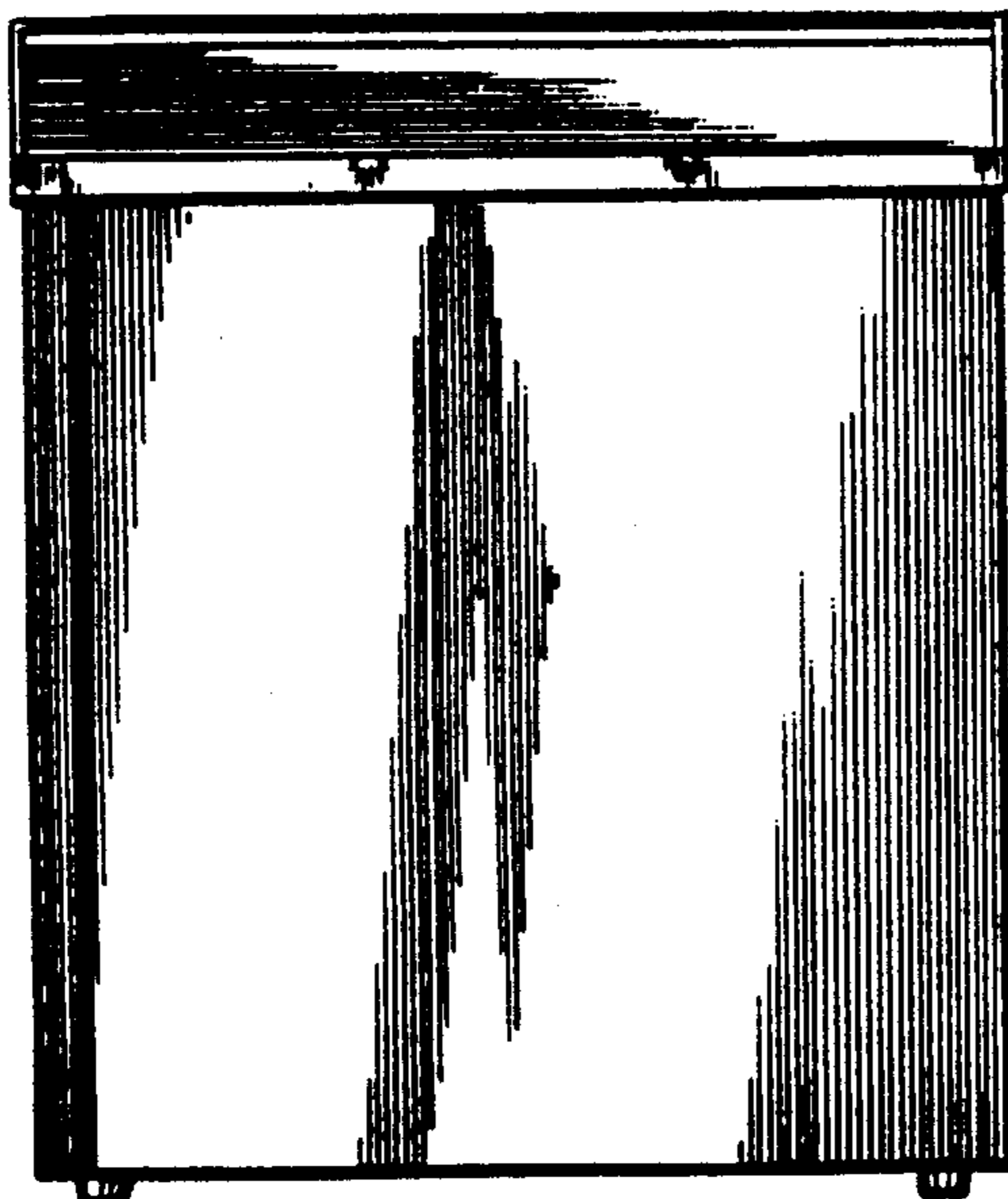

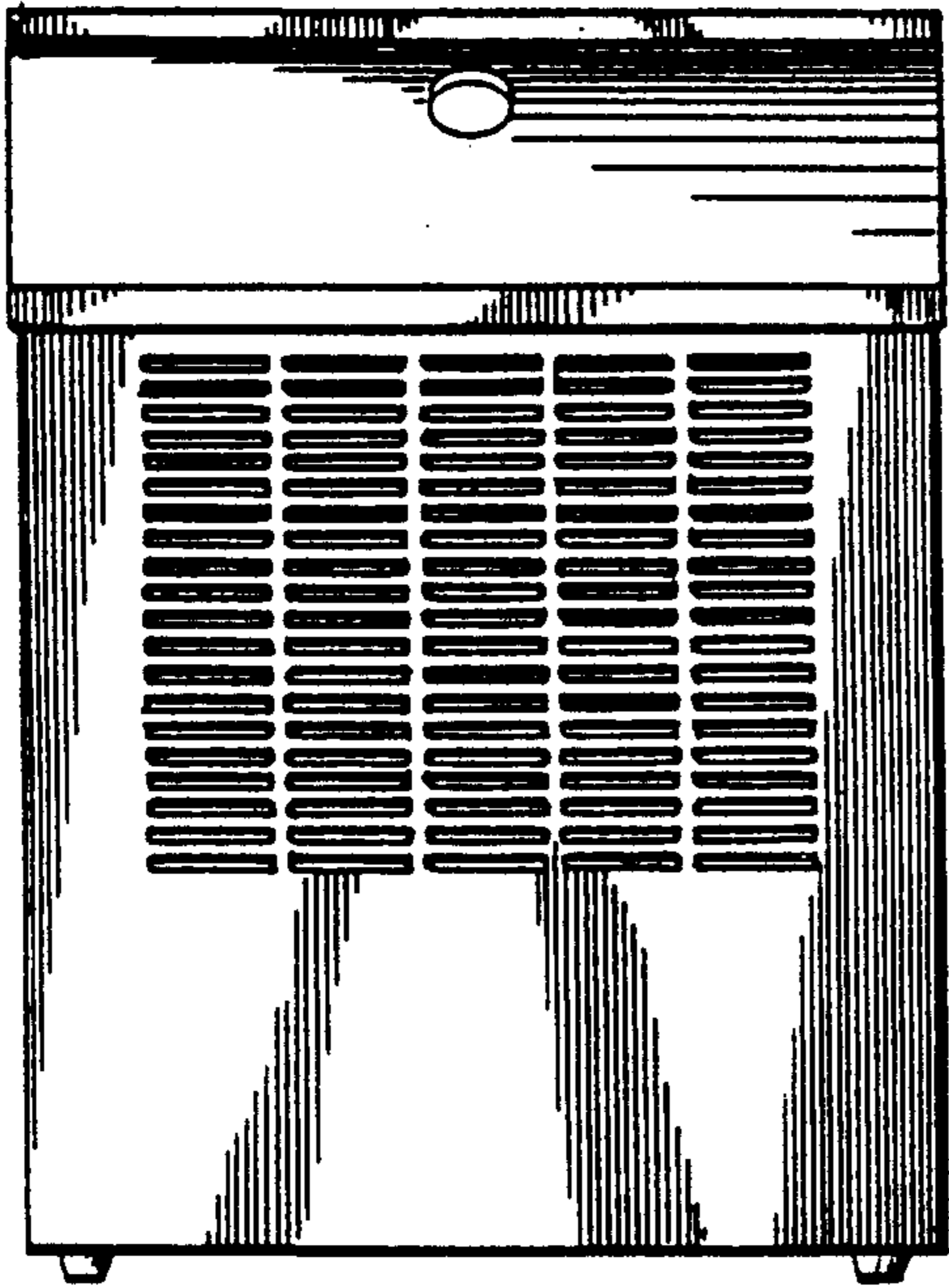

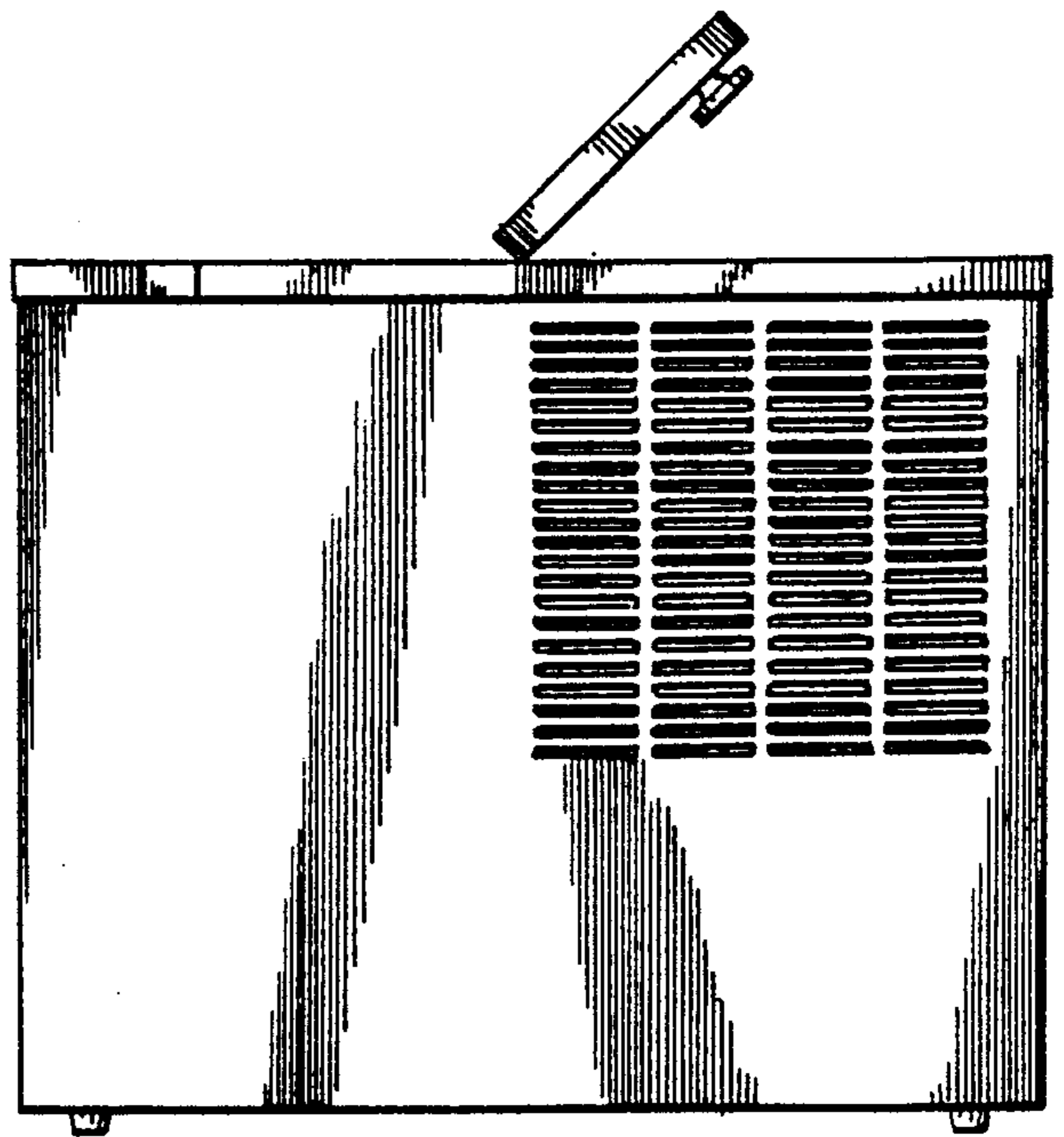

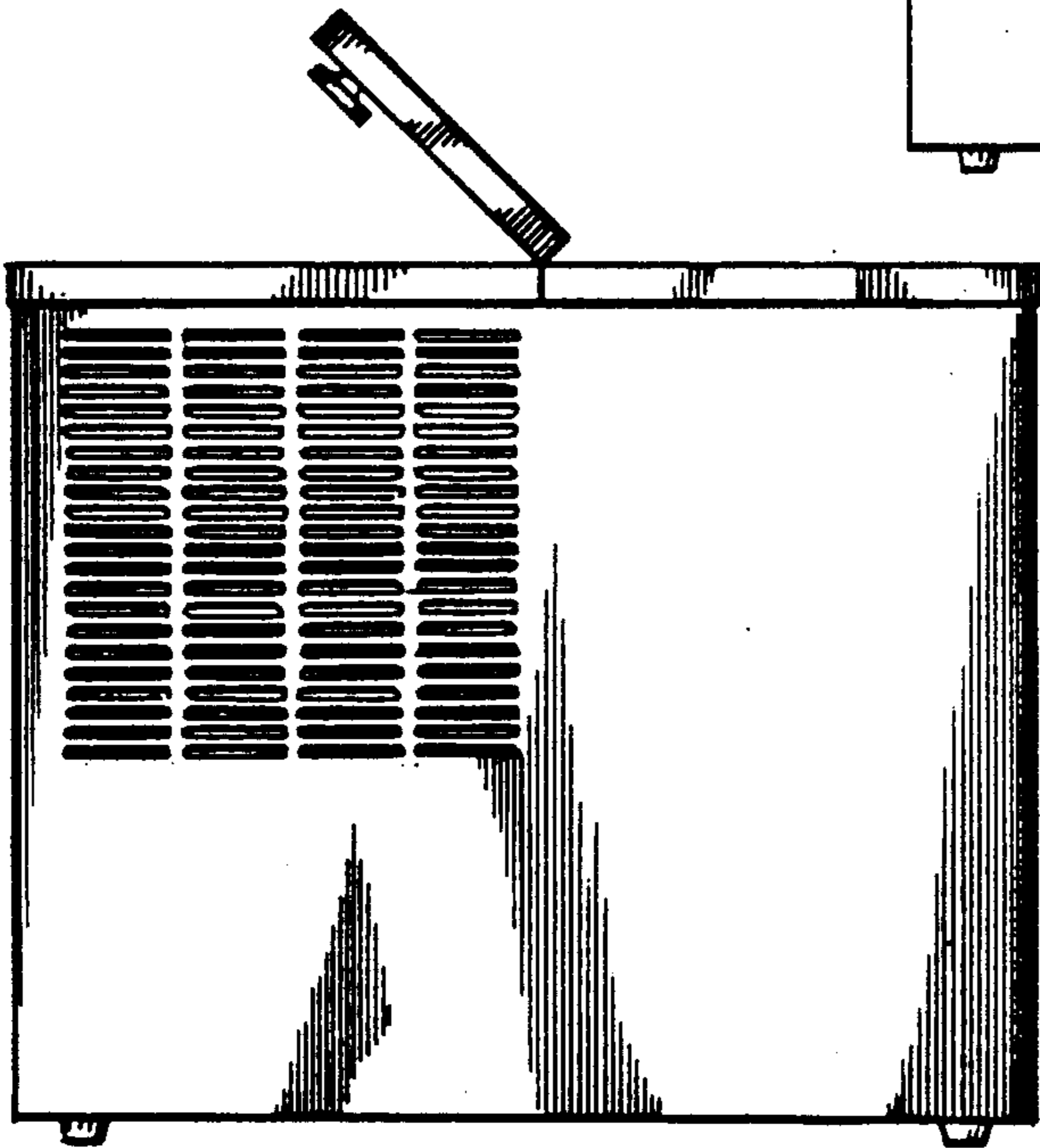
