FIG. 1 is a front, top and side perspective view of a cleaning brush block and handle unit showing my new design.

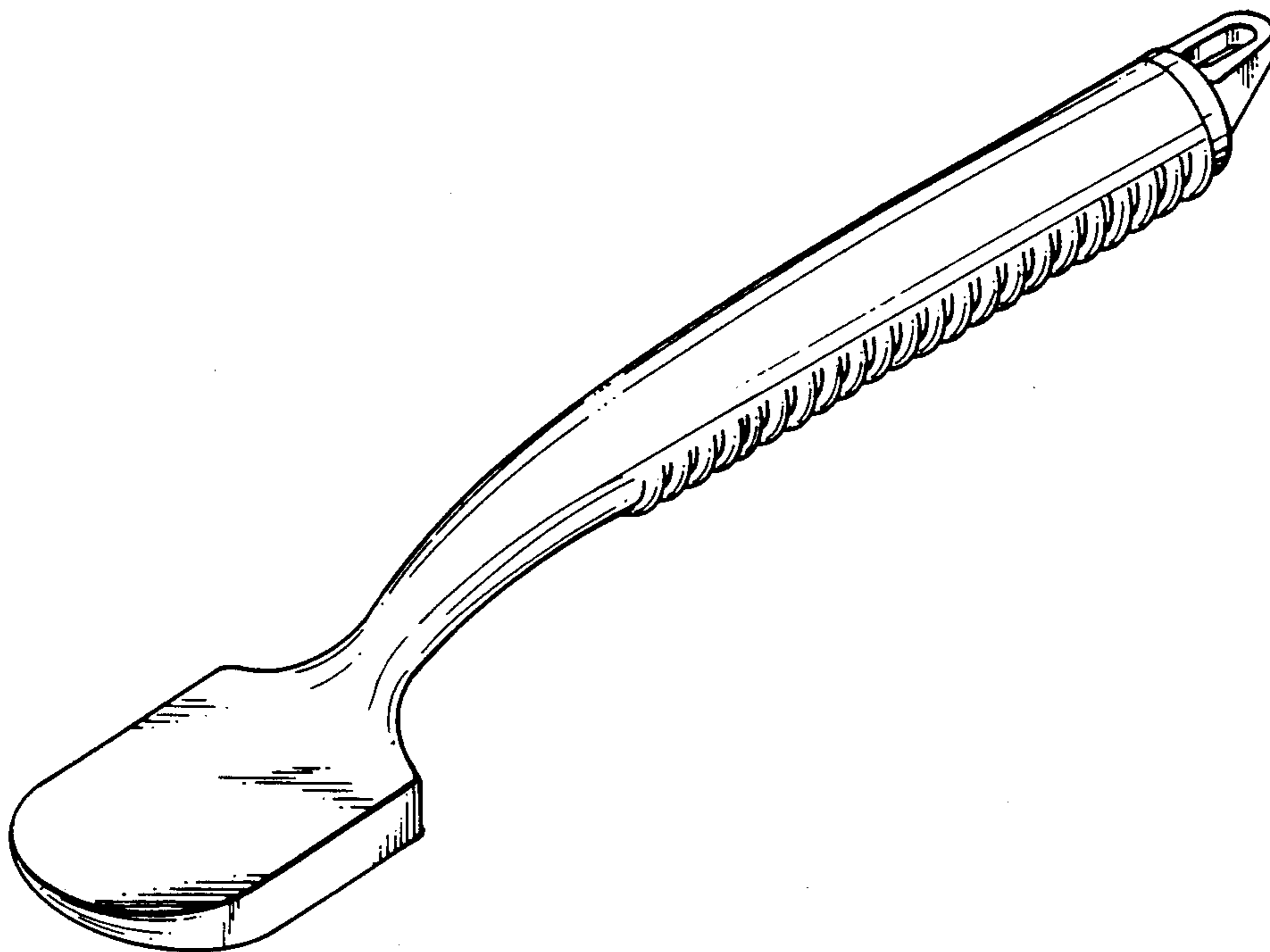
FIG. 2 is a top plan view thereof.

FIG. 6 is a rear elevational view thereof.



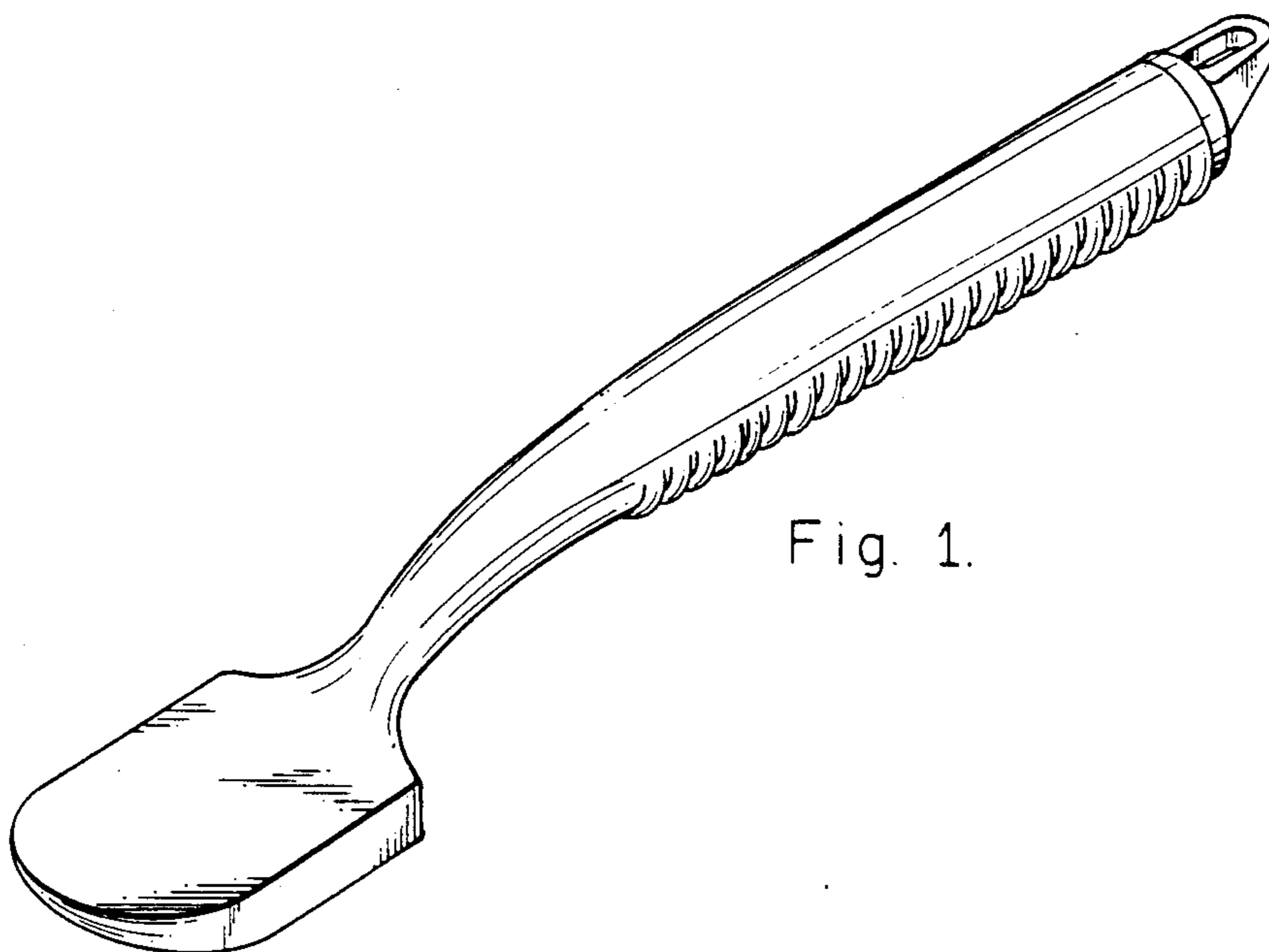

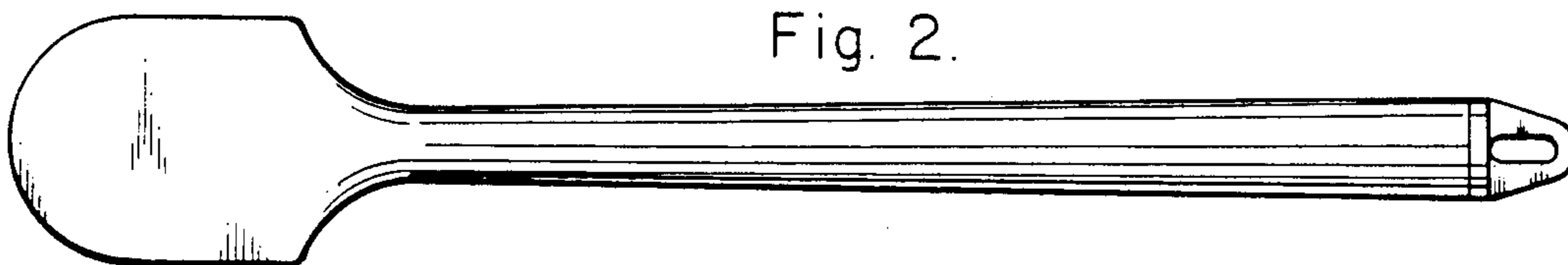

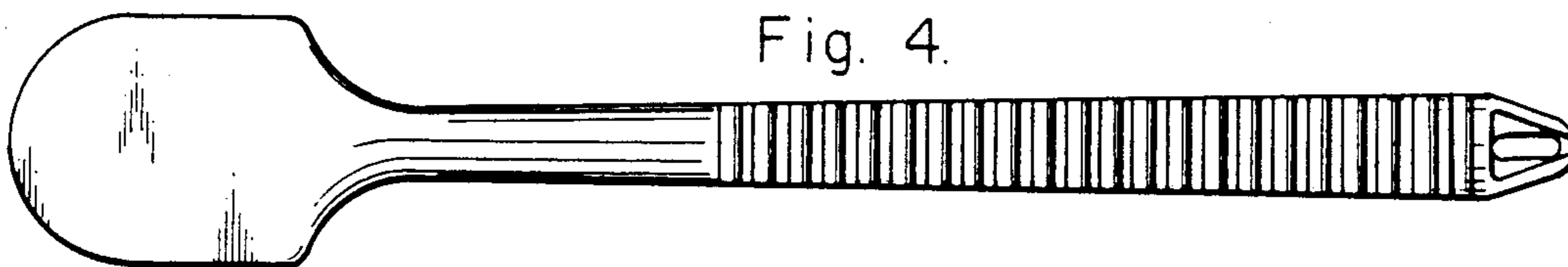

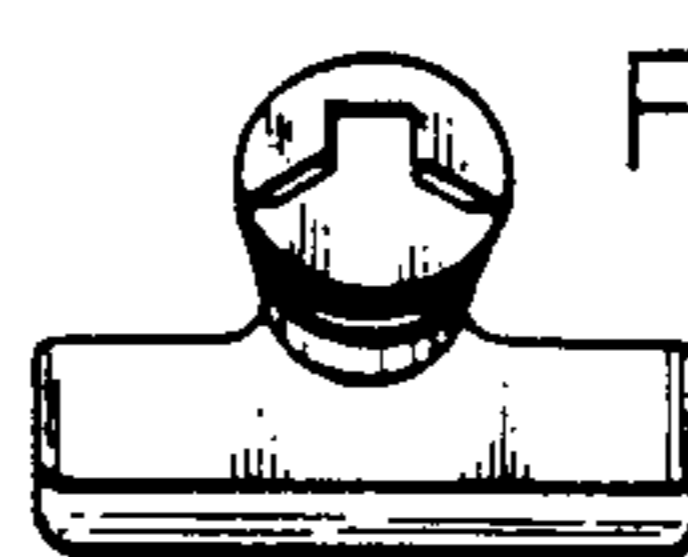
