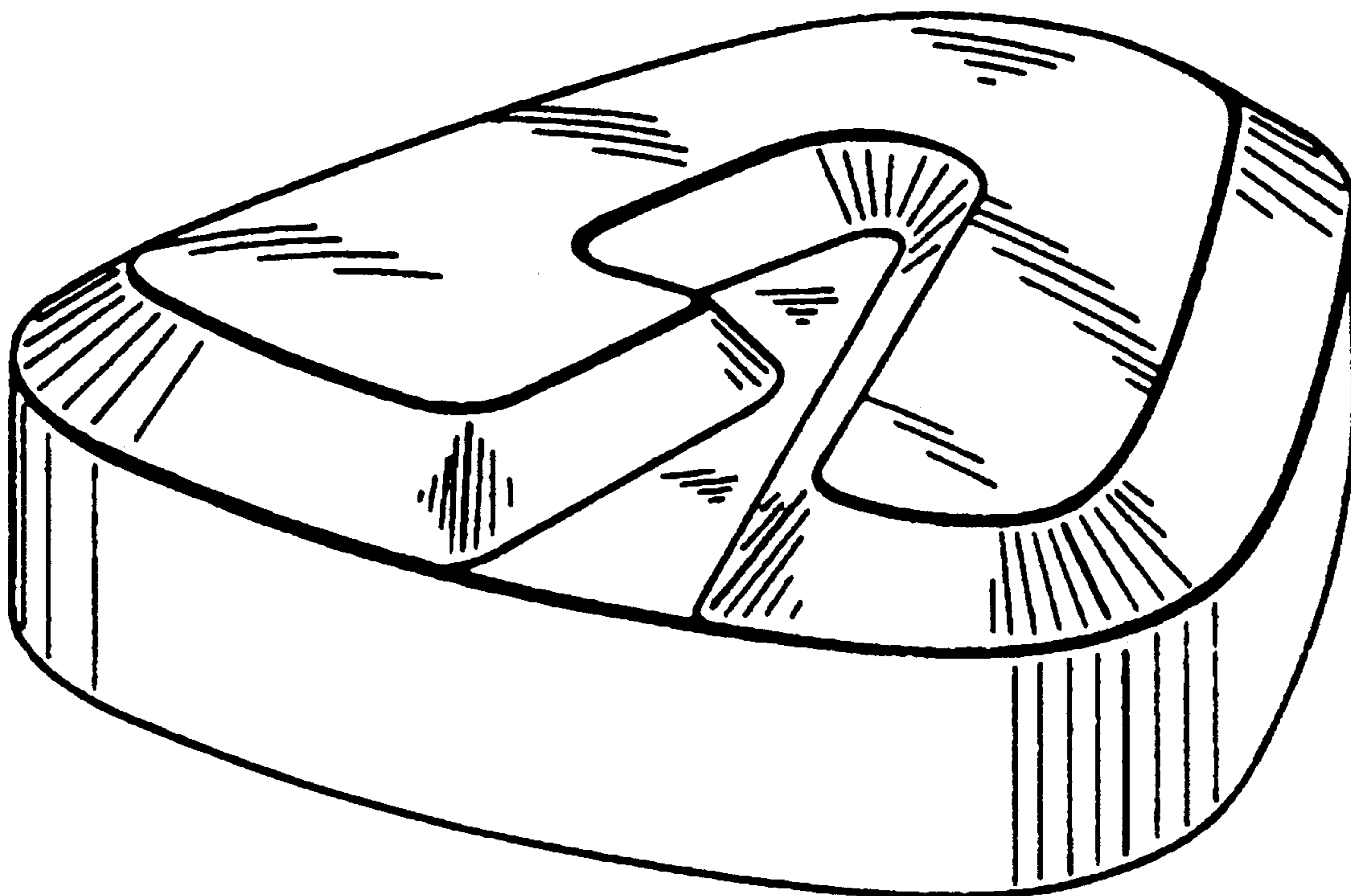

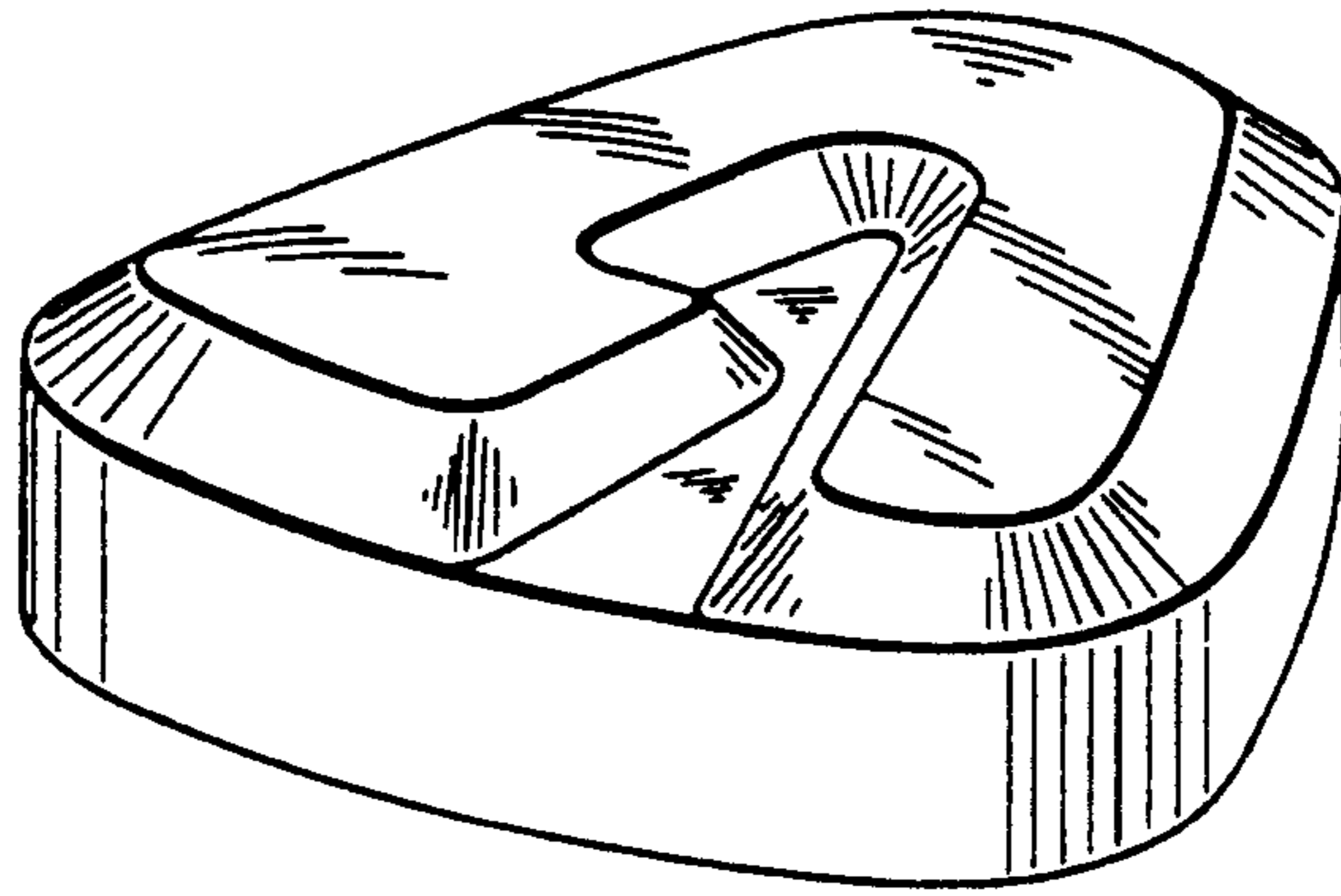
The ornamental design for a tablet, as shown and described.

DESCRIPTION

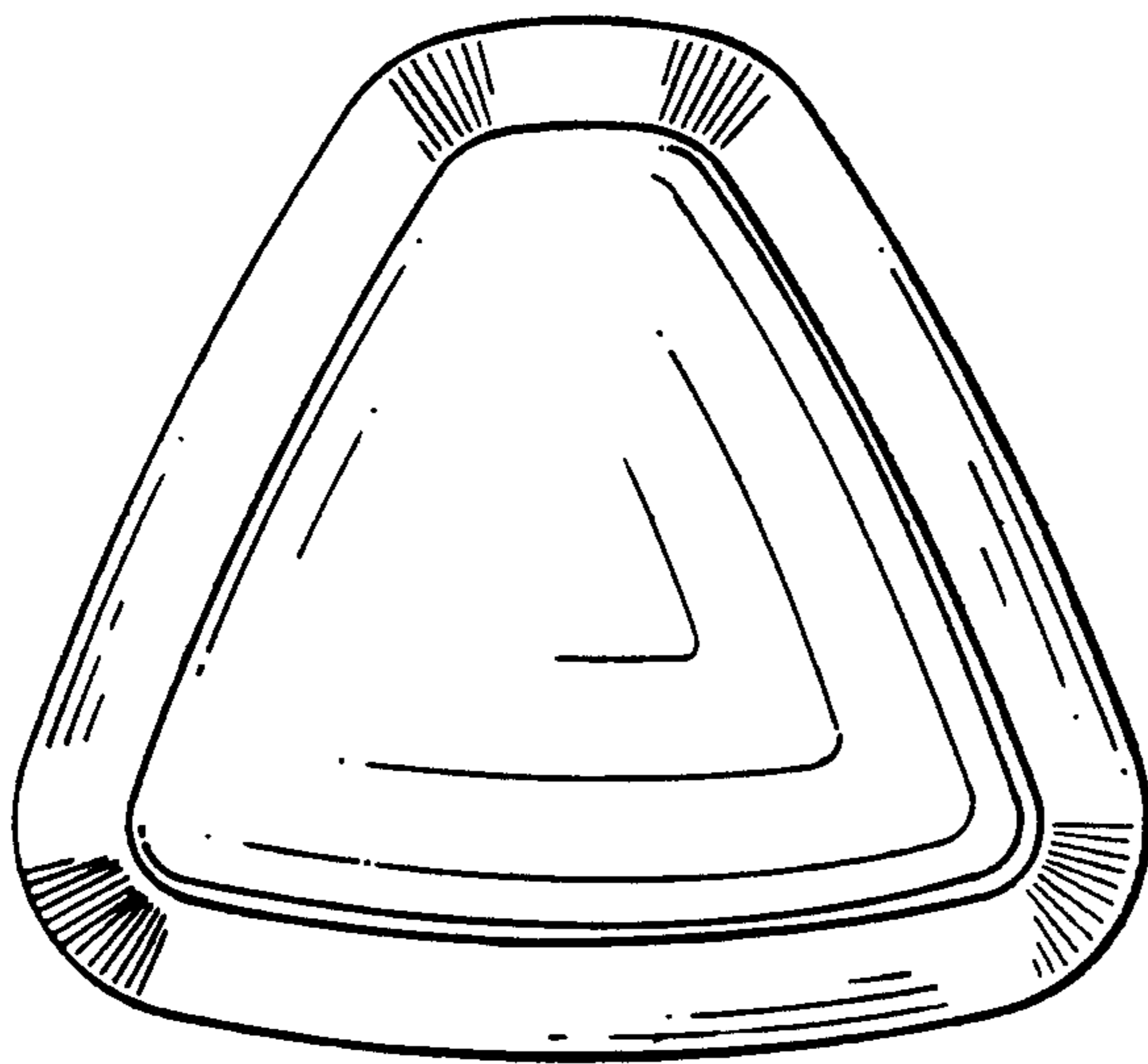
FIG. 1 is a perspective view of a tablet showing our new design;

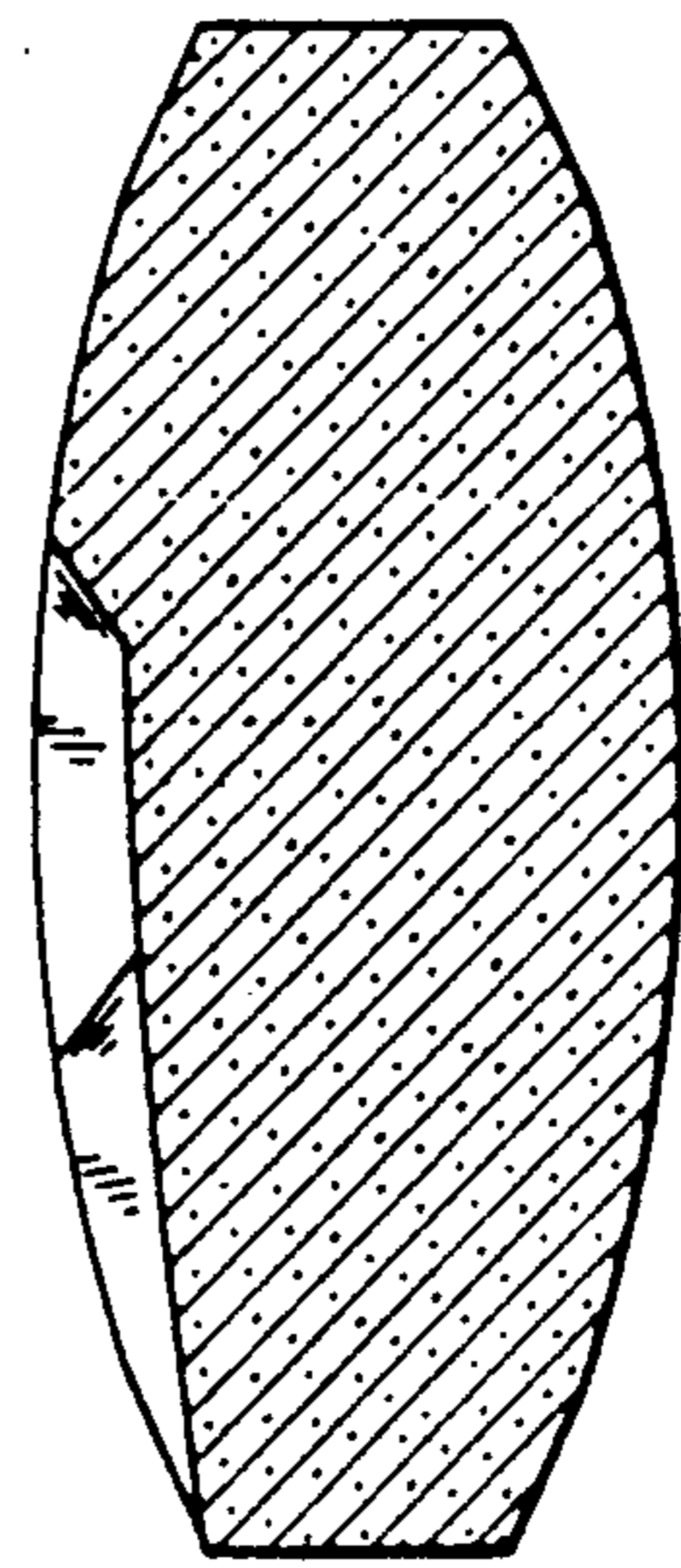

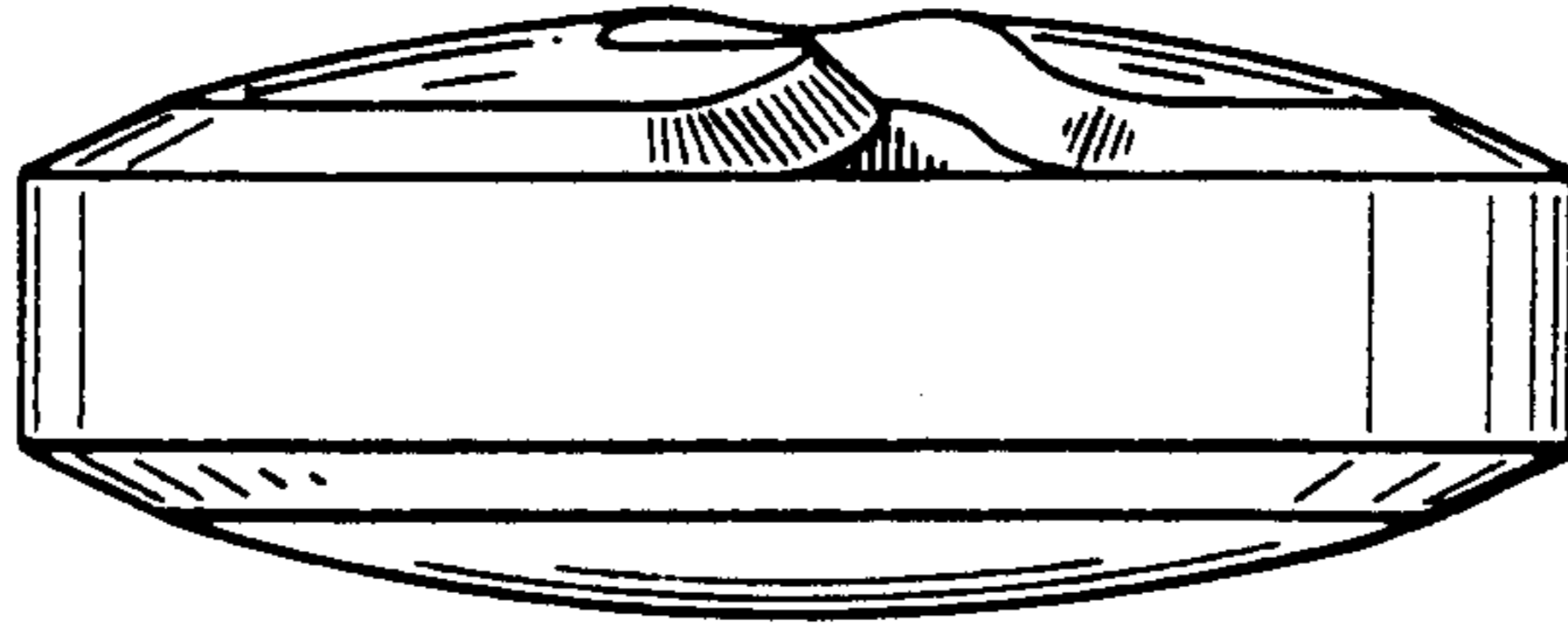

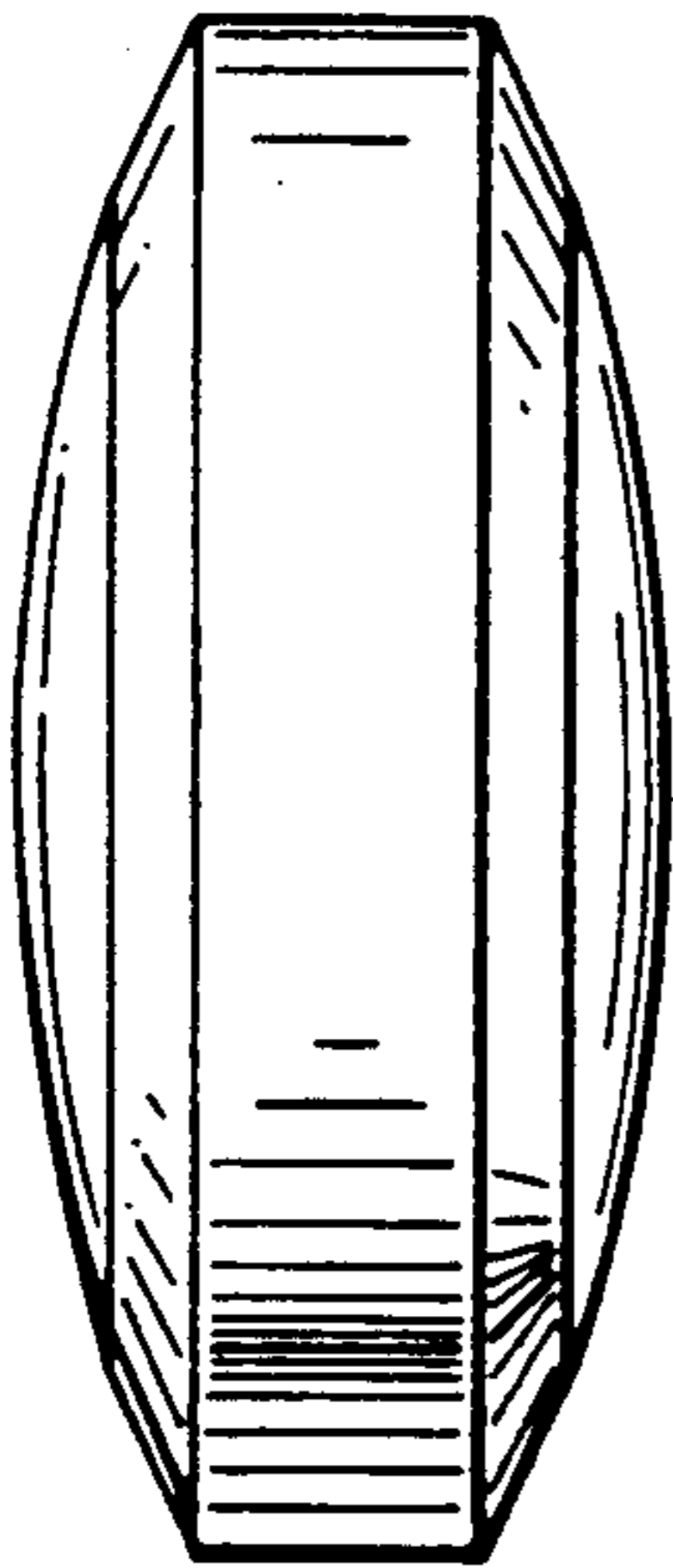

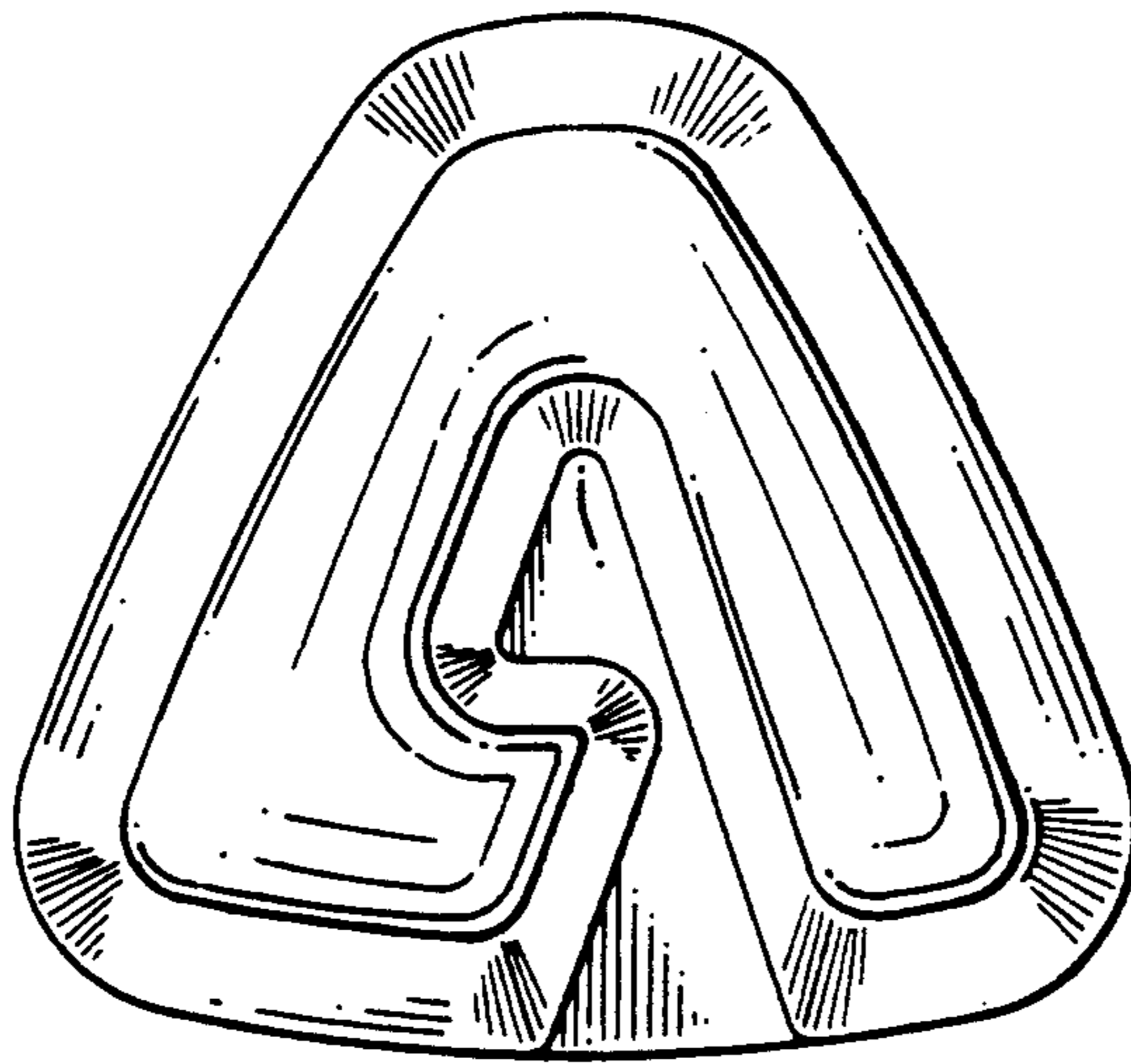

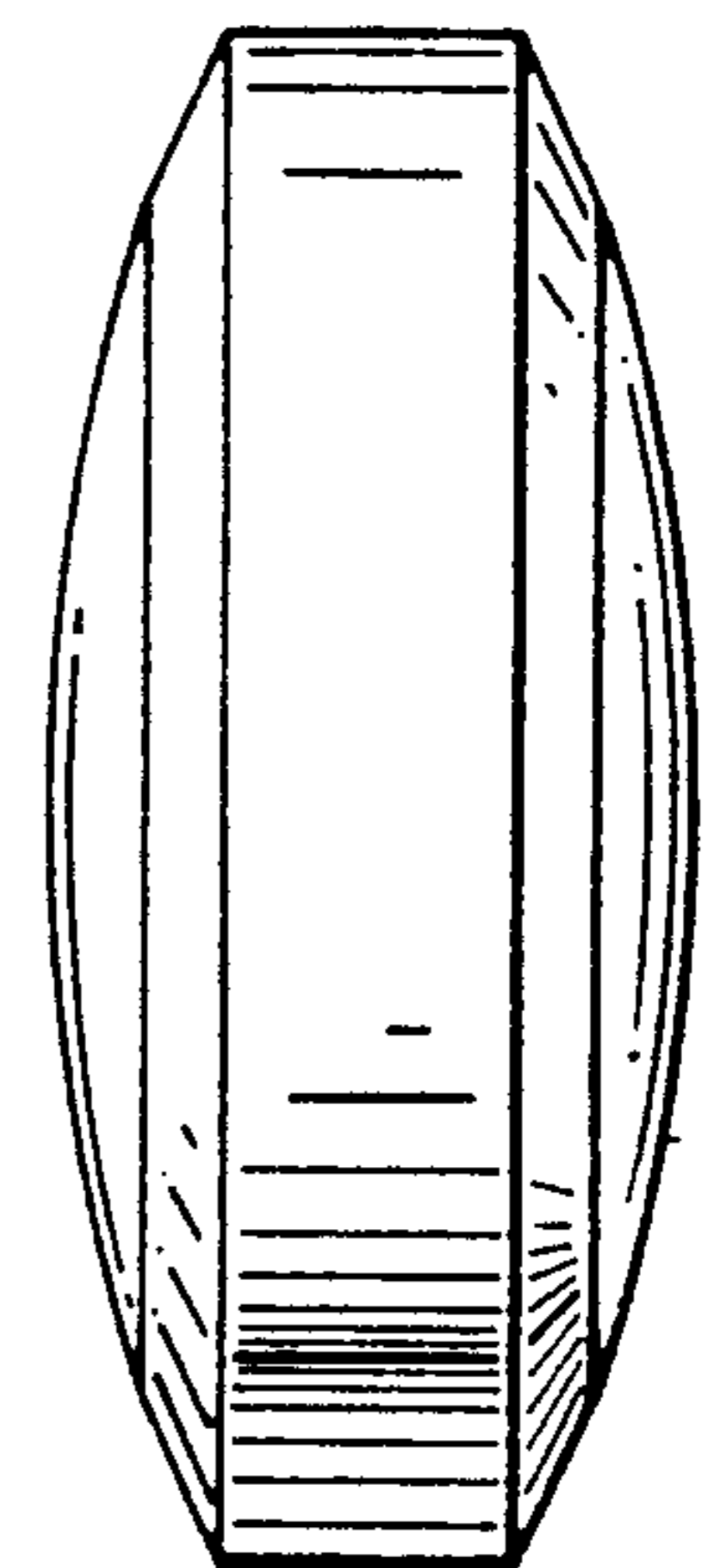

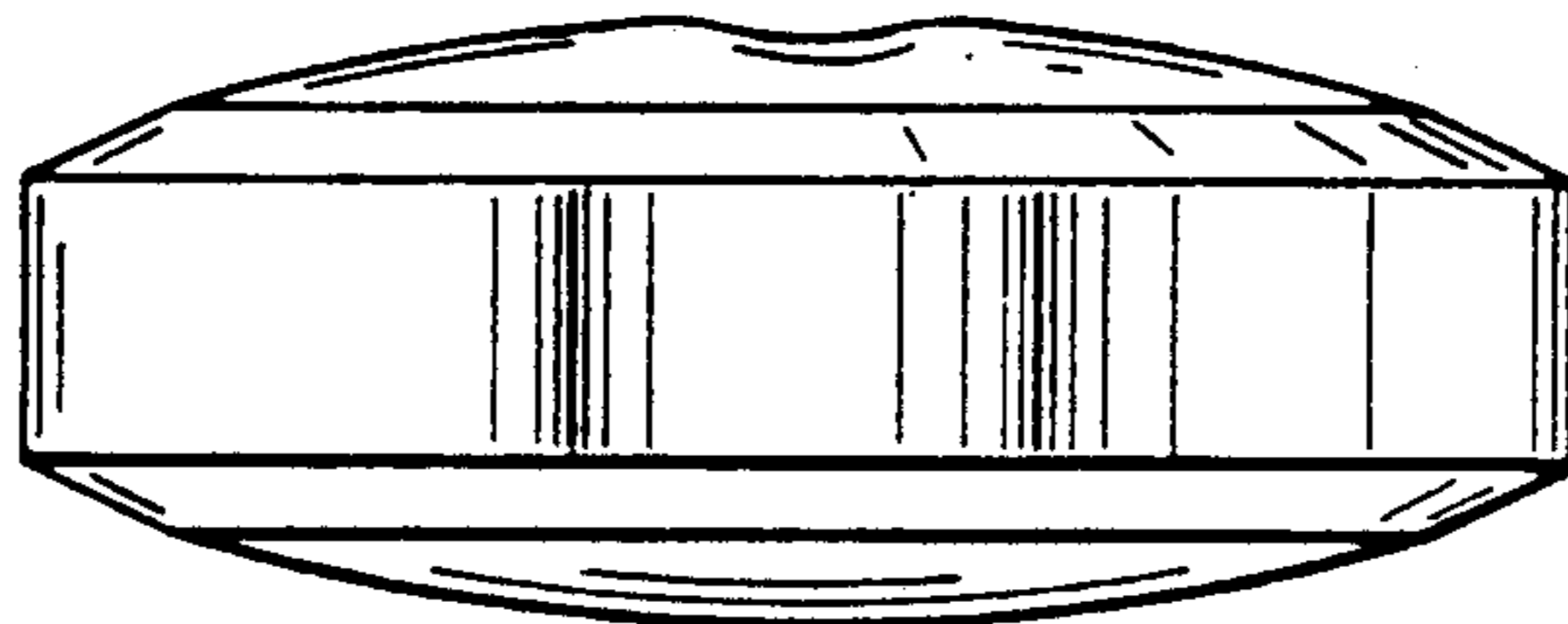

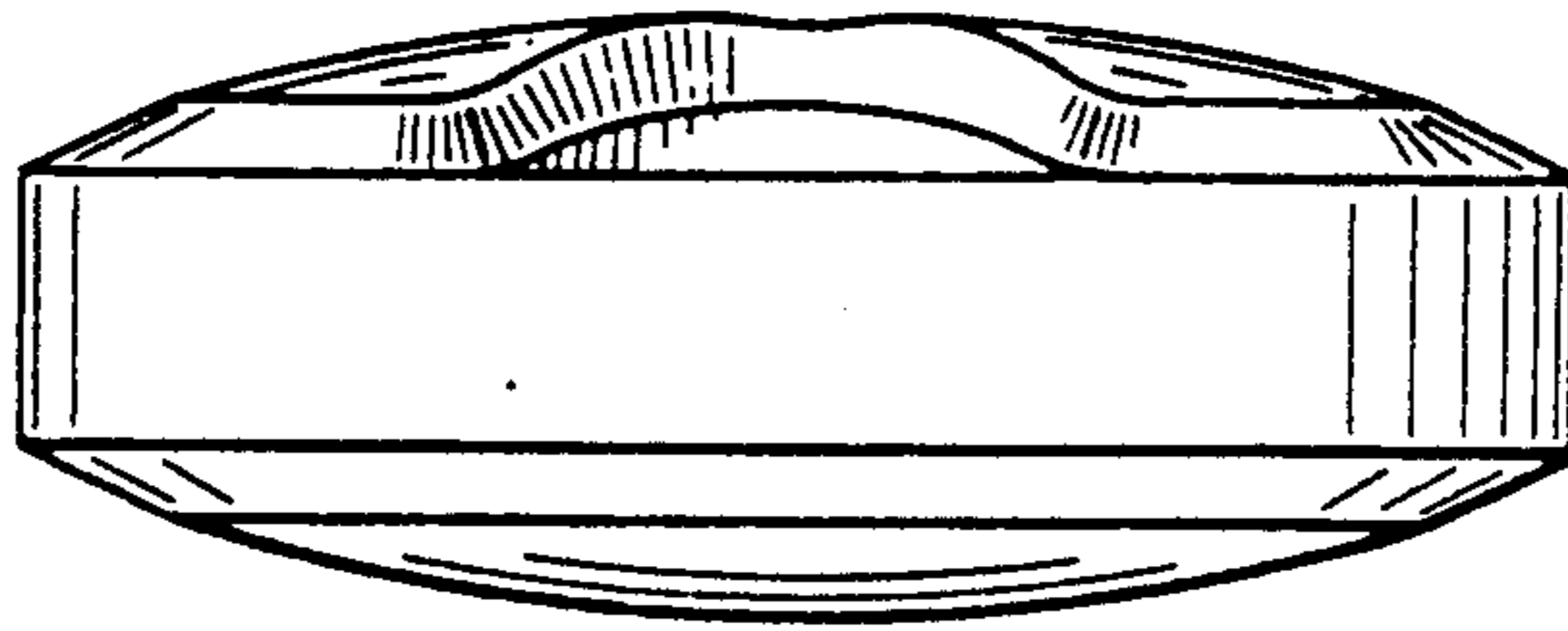

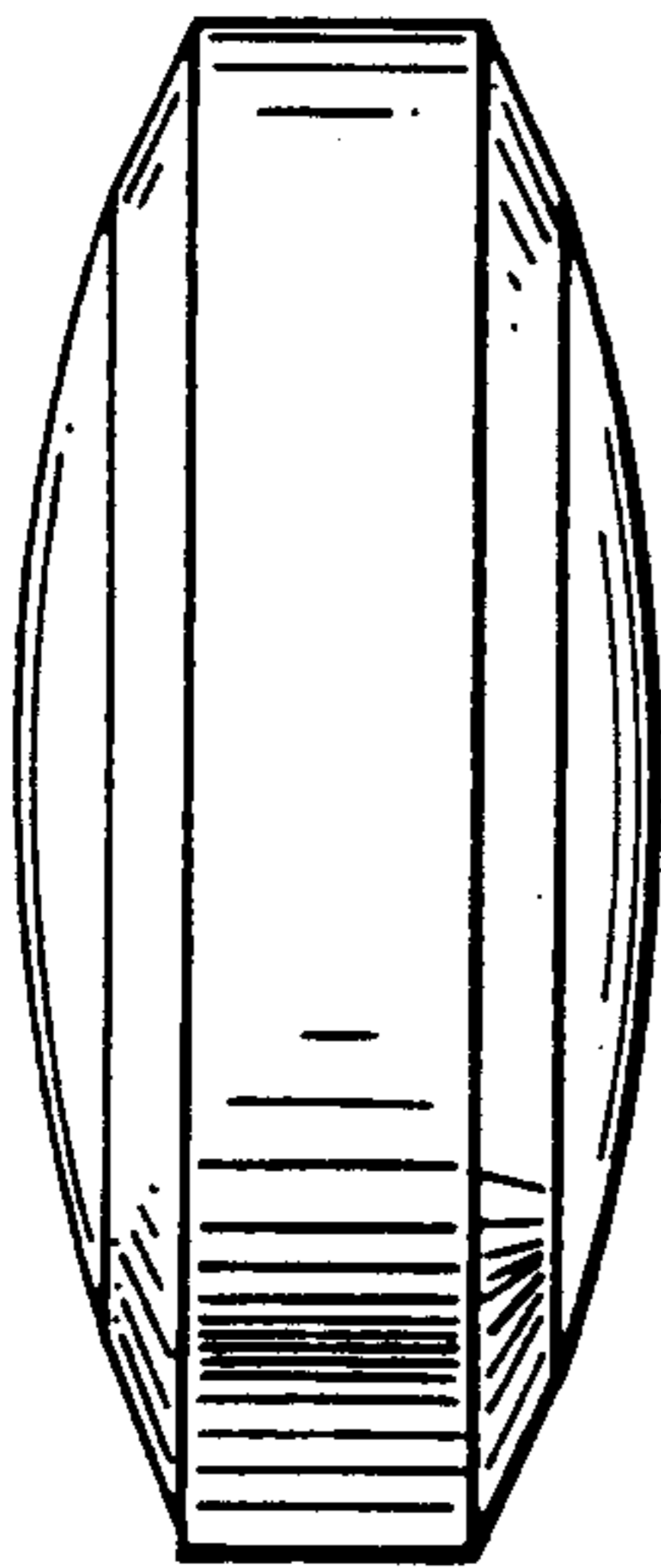

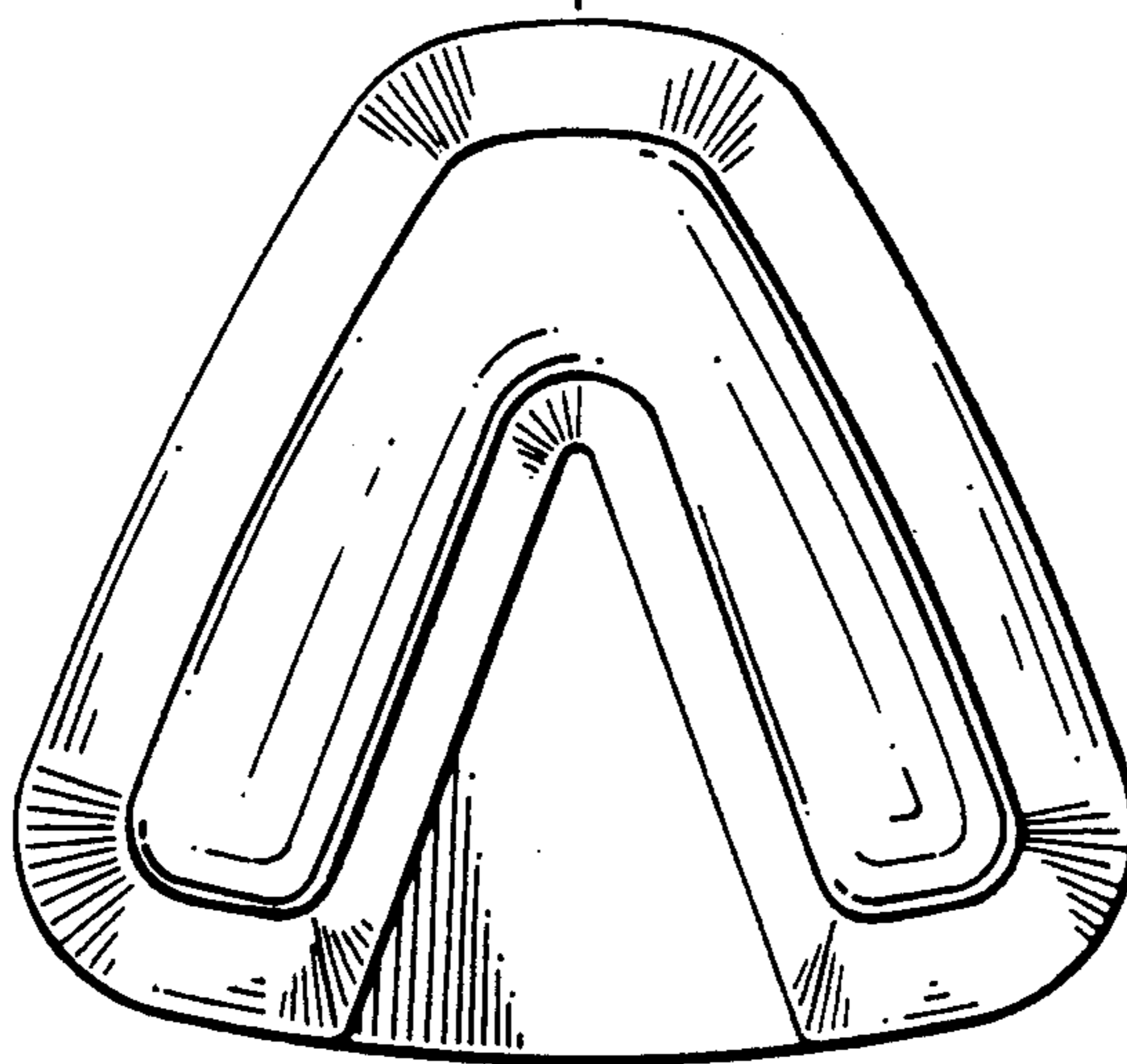


***Fig. 13***



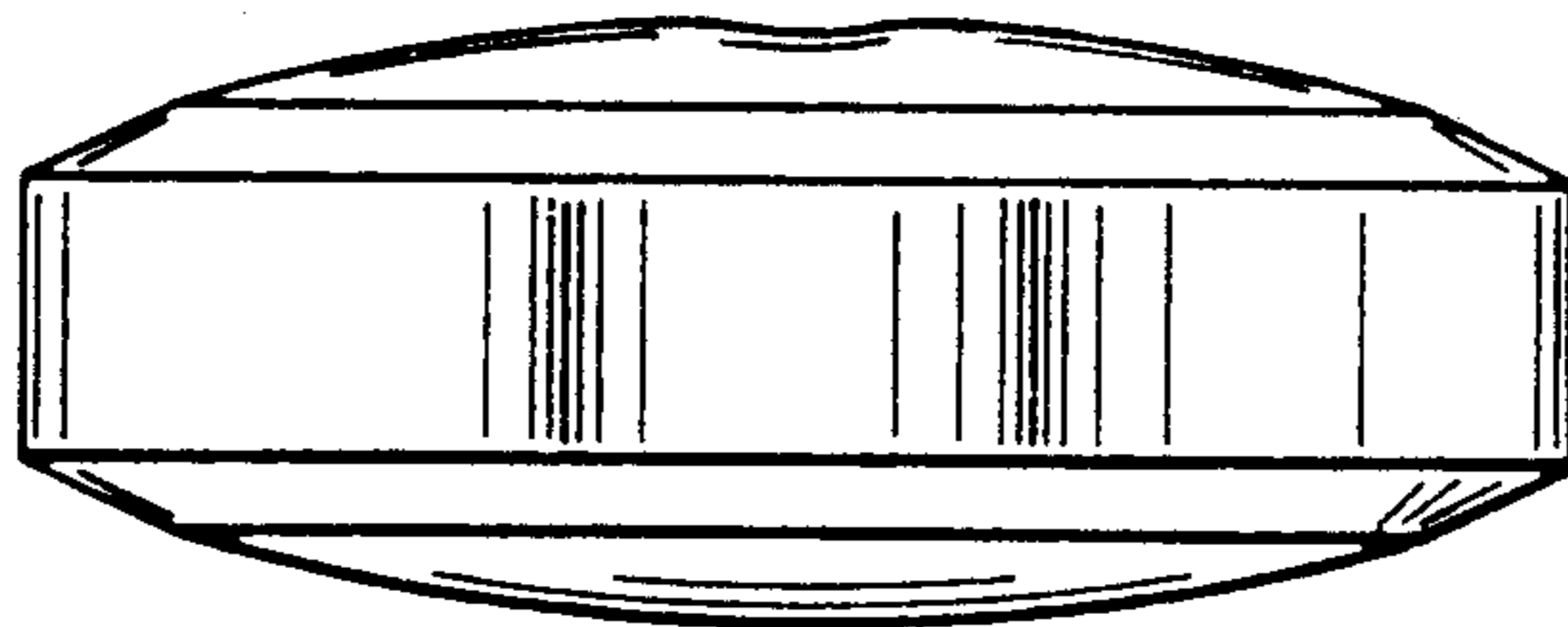
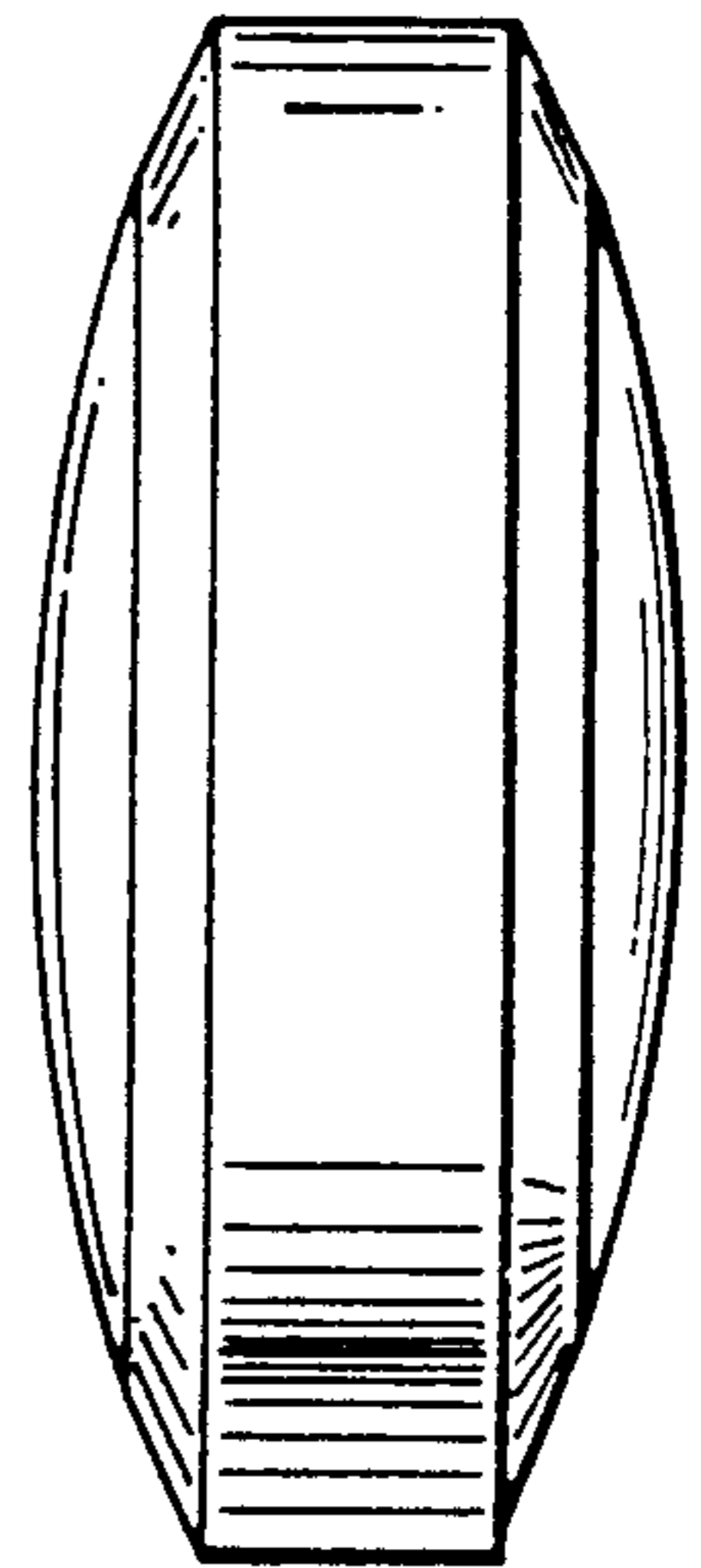

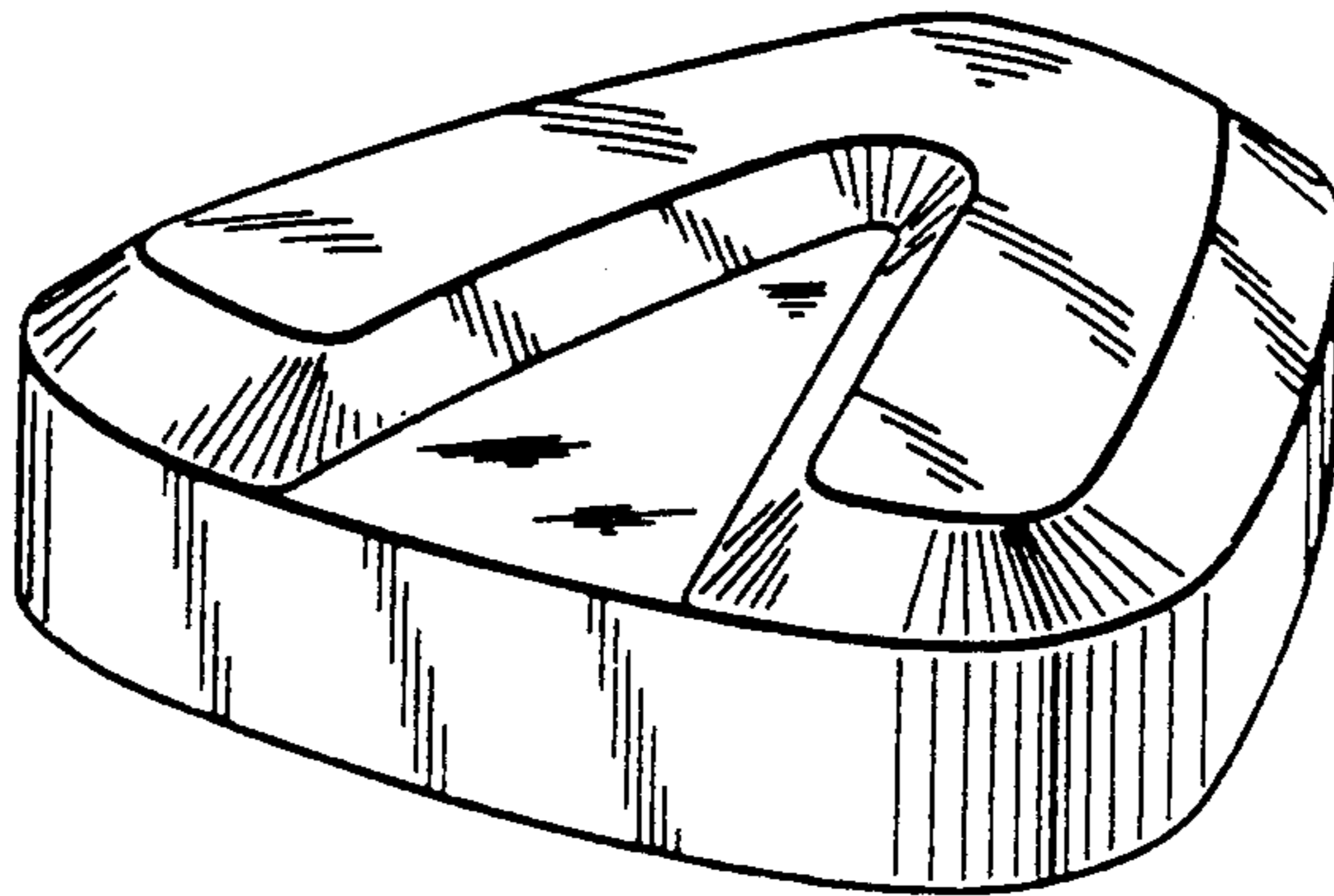

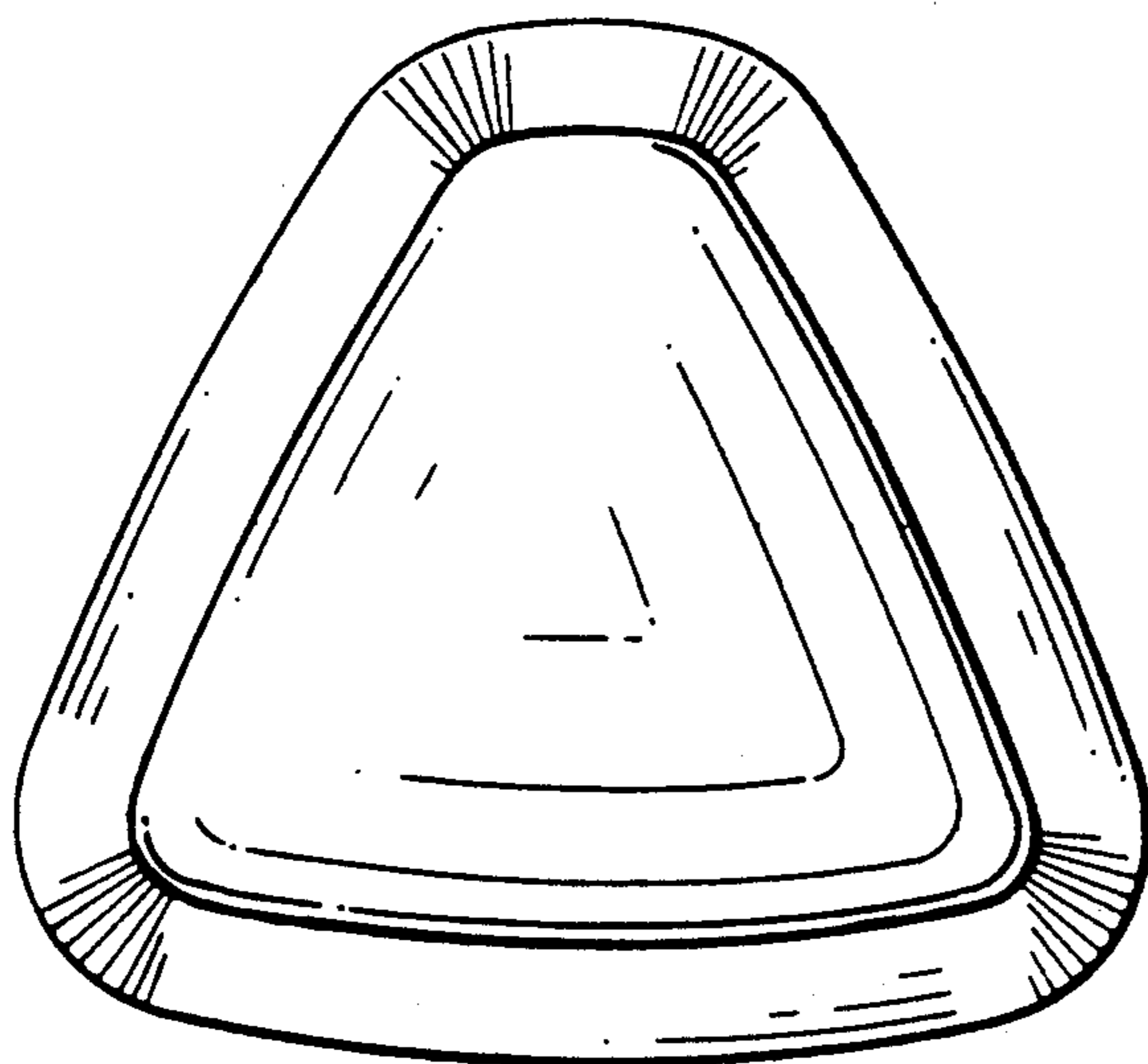


***Fig. 12***
