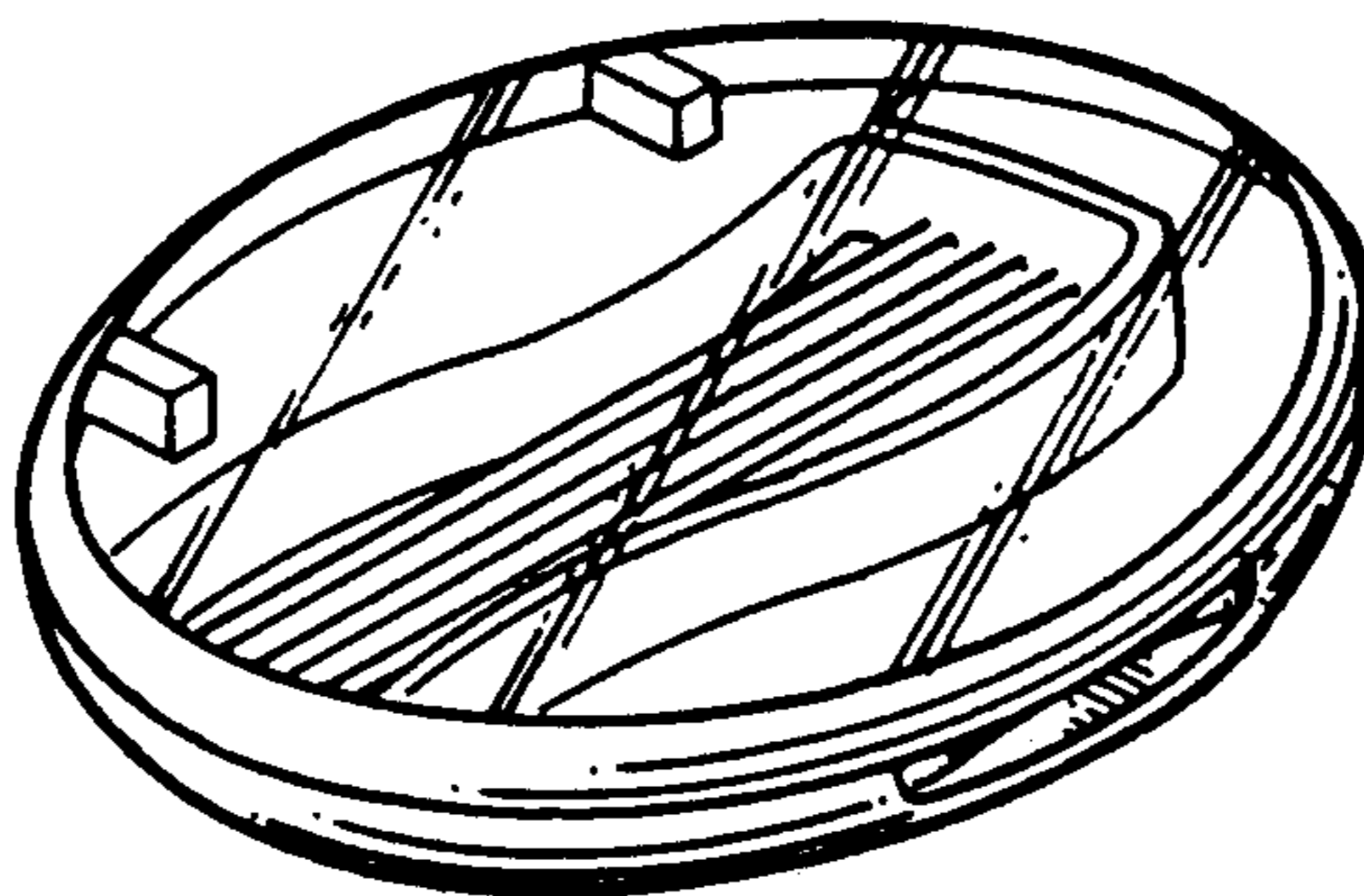
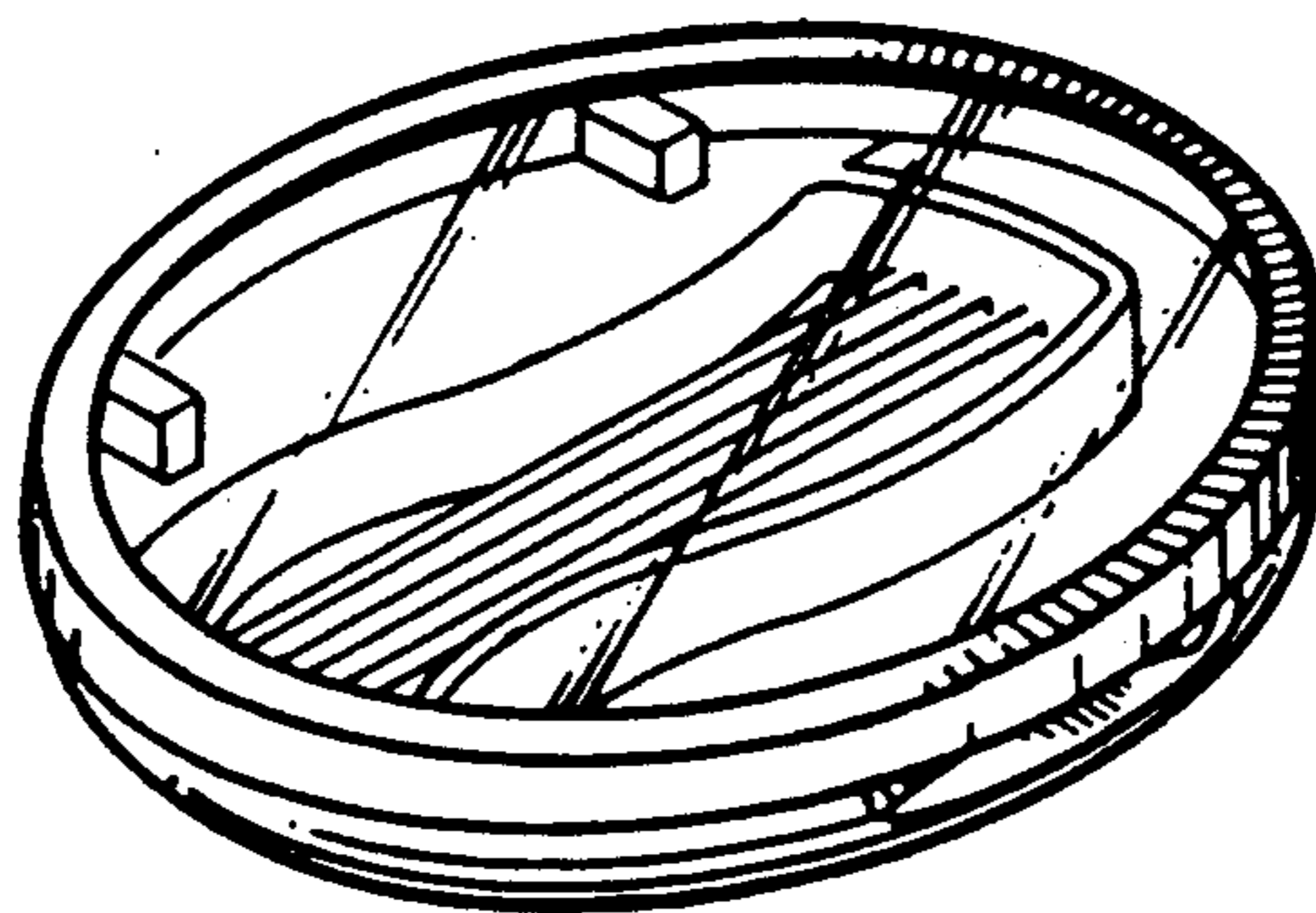

The ornamental design for cosmetic case, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a cosmetic case showing my new design;  
 FIG. 2 is a bottom perspective view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a right side elevational view thereof. The left side is a mirror image of the side shown;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a rear elevational view thereof;  
 FIG. 8 is a top perspective view of a second modified embodiment;  
 FIG. 9 is a bottom perspective view thereof;  
 FIG. 10 is a front elevational view thereof;  
 FIG. 11 is a right side elevational view thereof. The left side elevational view is a mirror image of the side shown;  
 FIG. 12 is a top plan view thereof;  
 FIG. 13 is a bottom plan view thereof; and  
 FIG. 14 is a rear elevational view thereof.



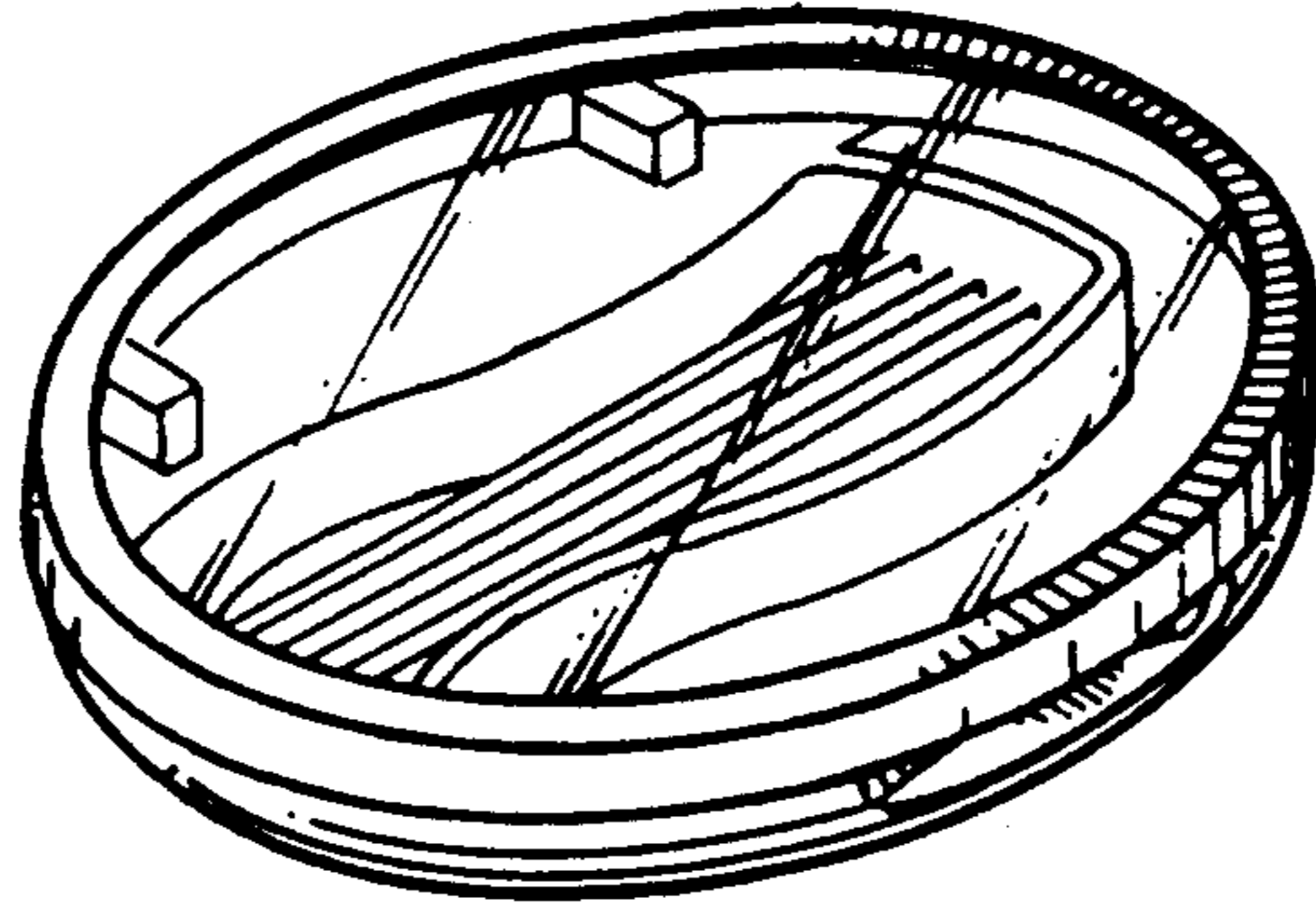

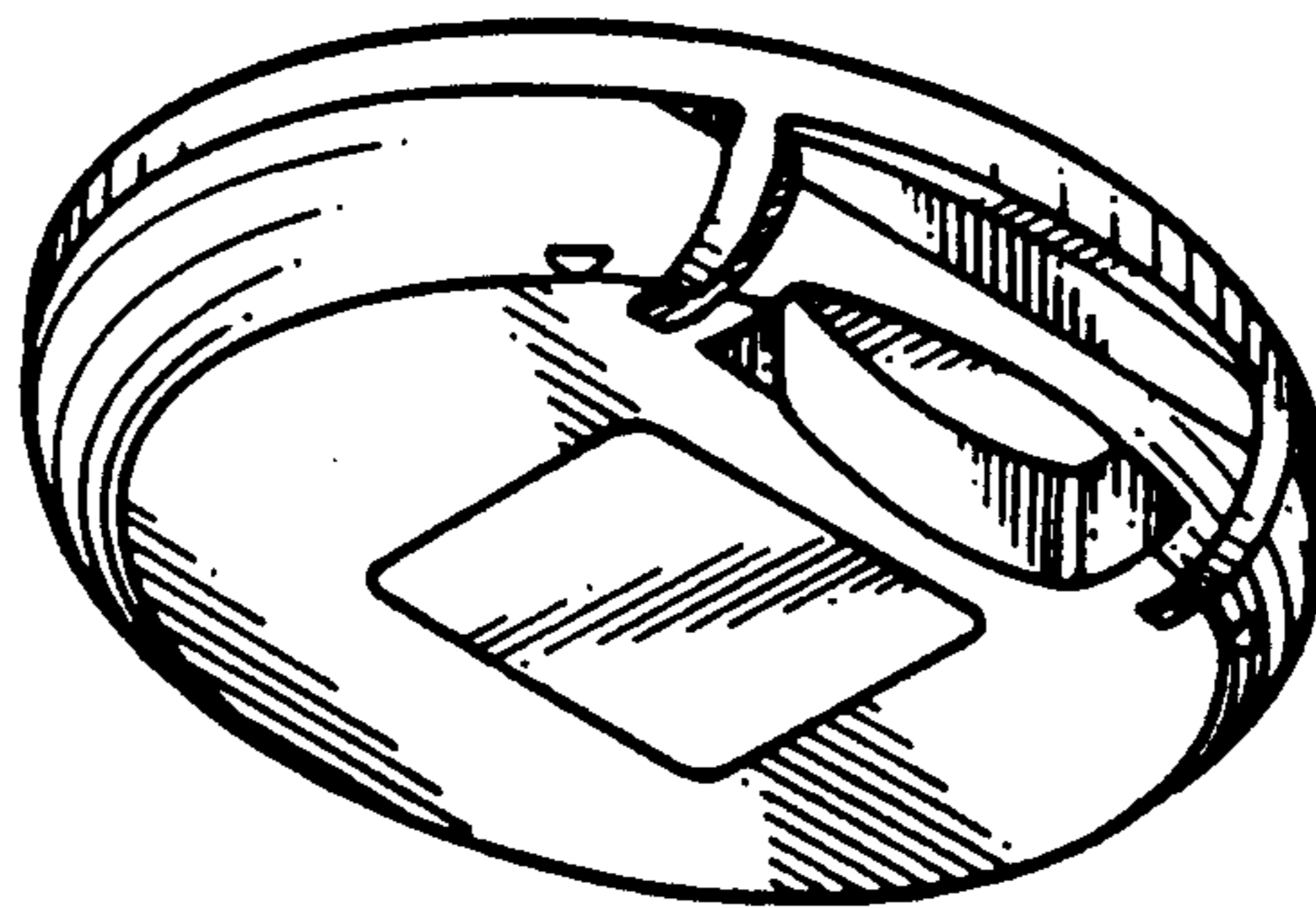

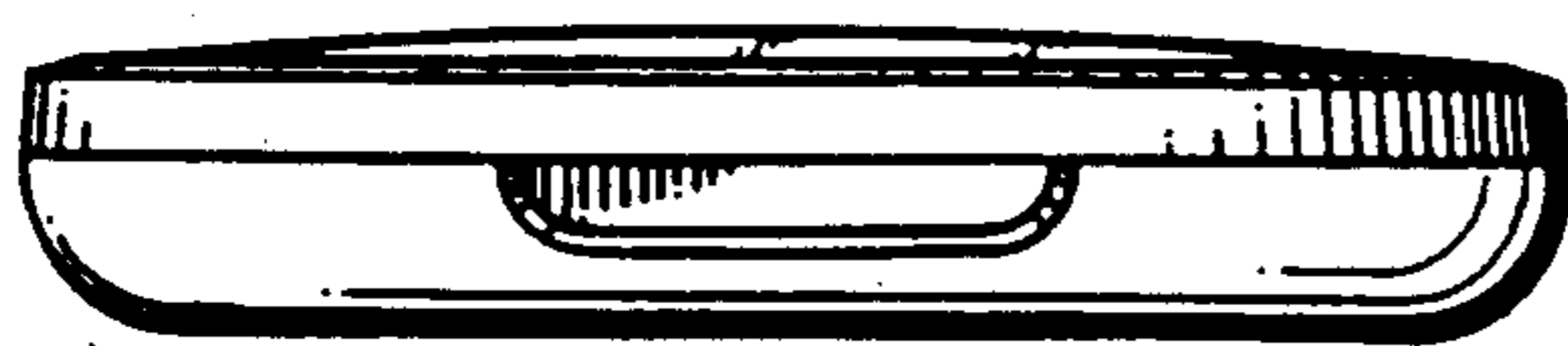

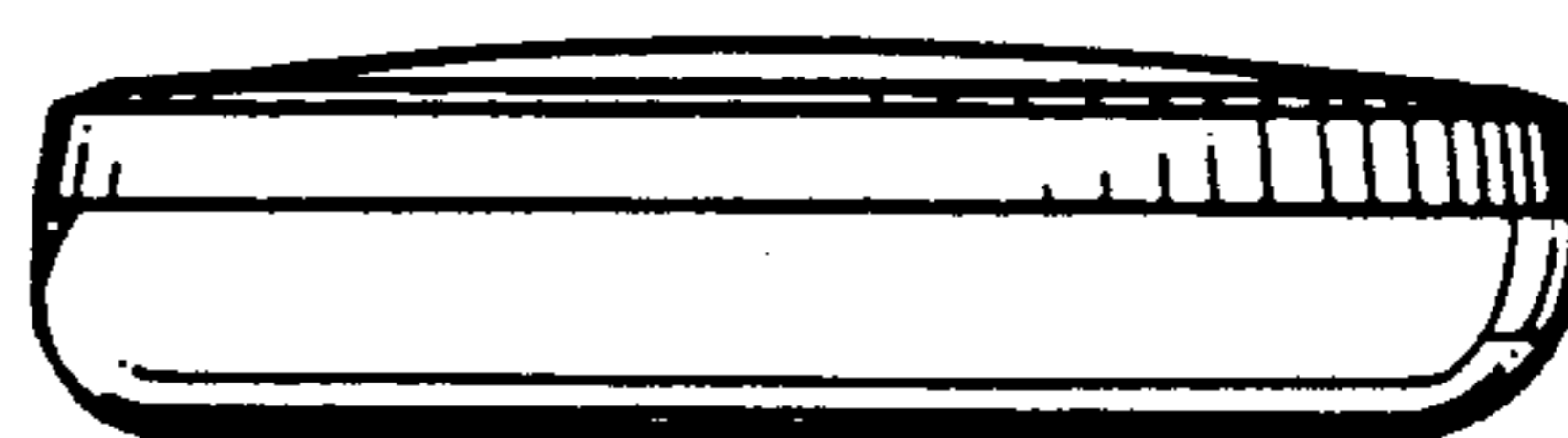

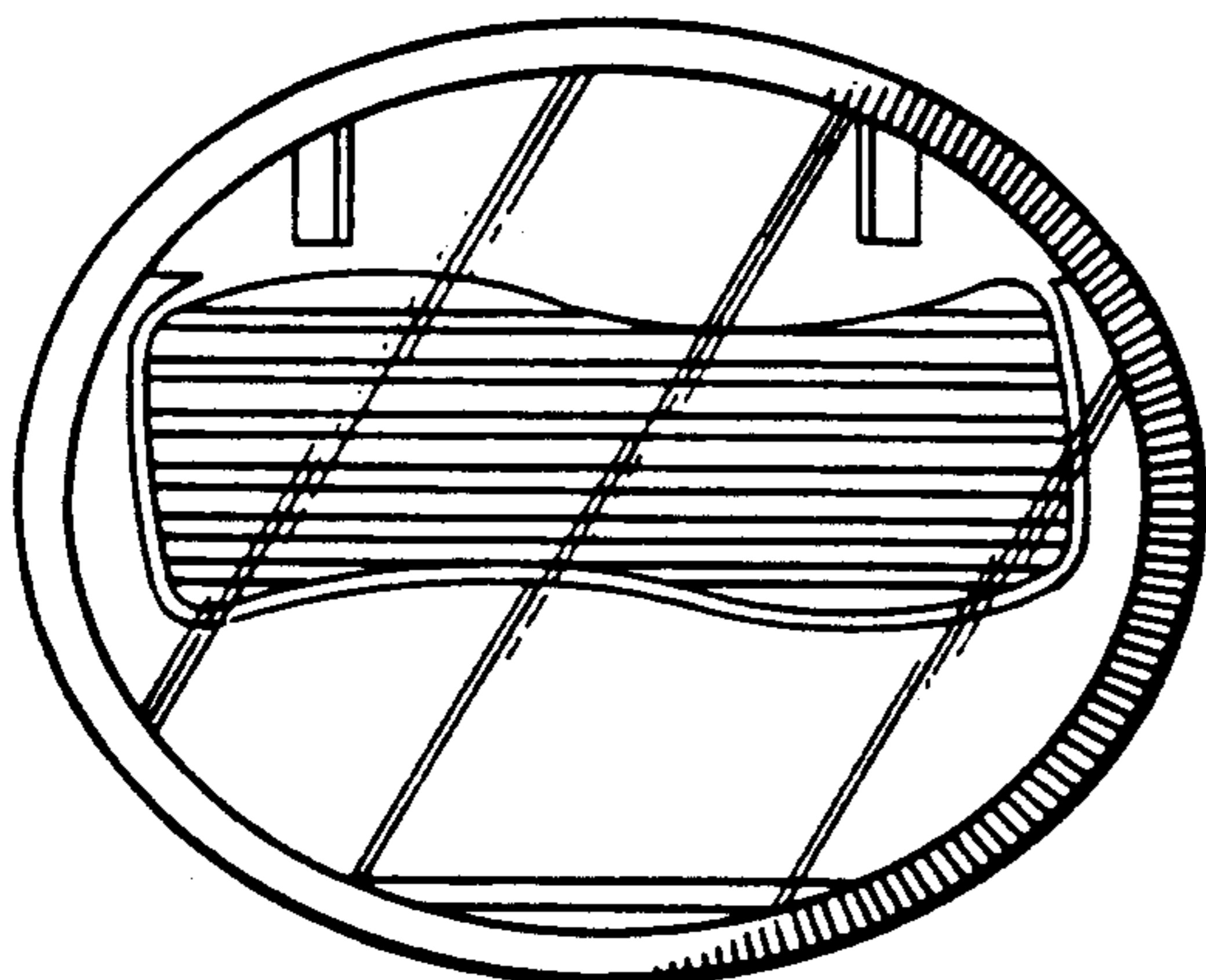

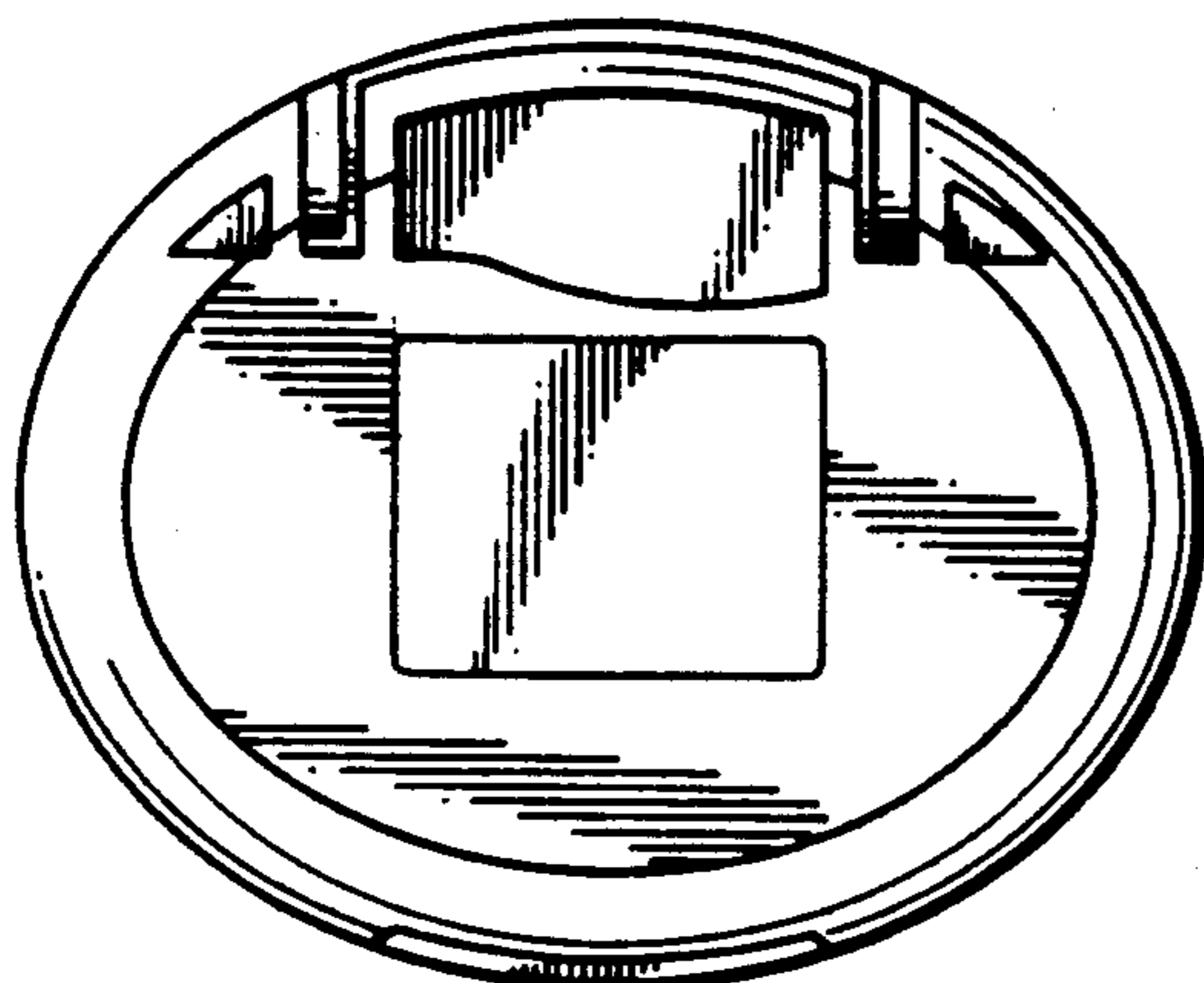

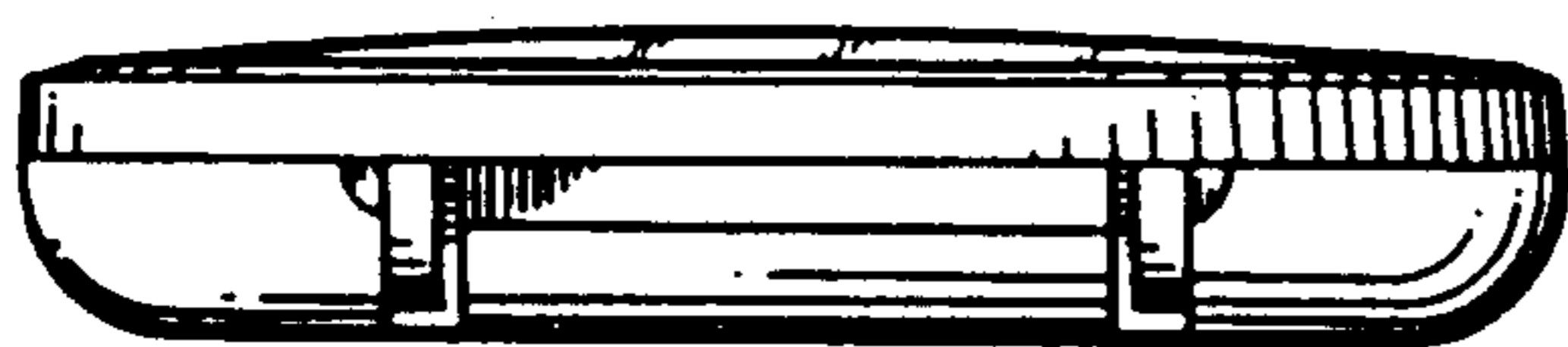
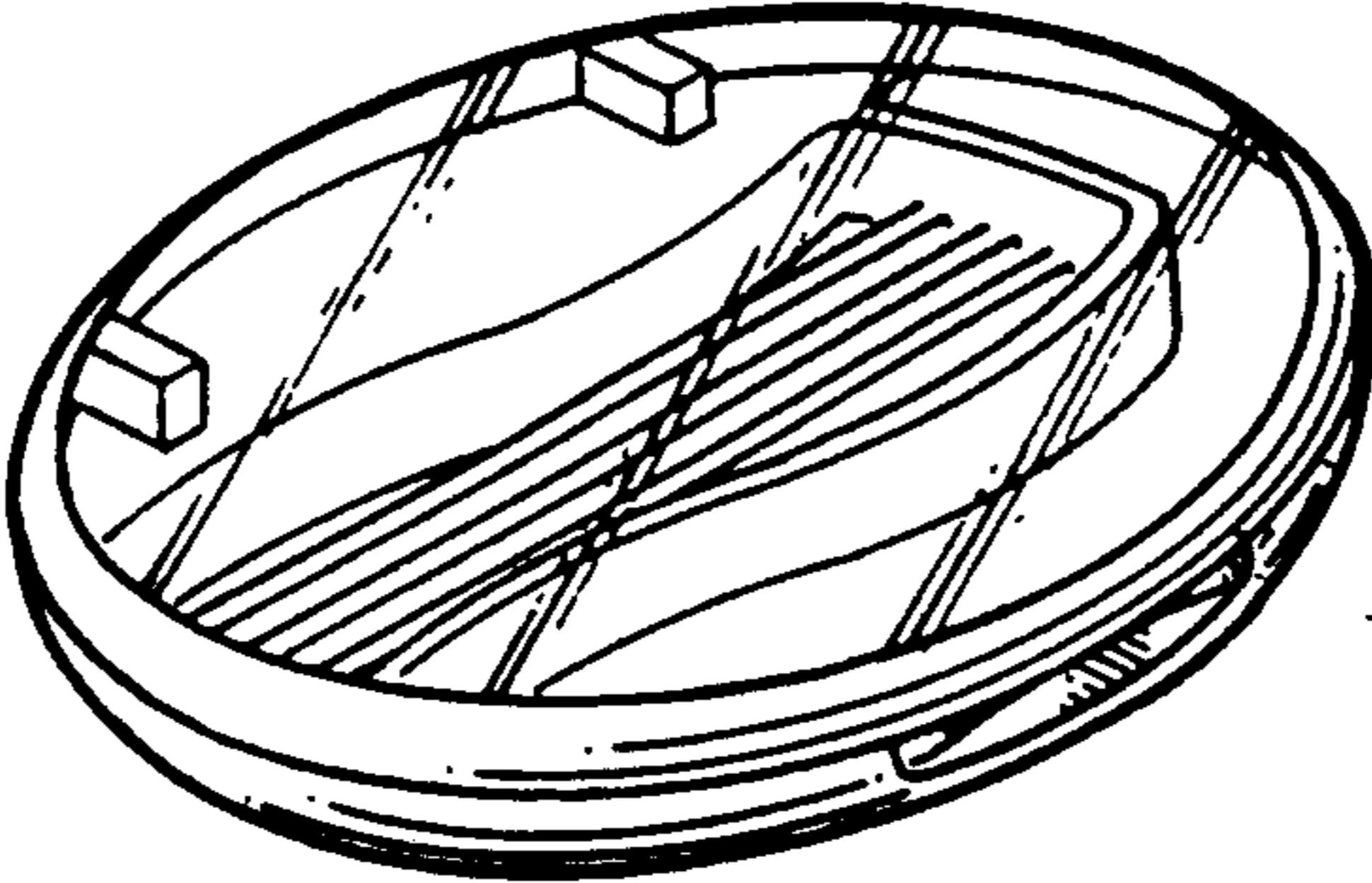
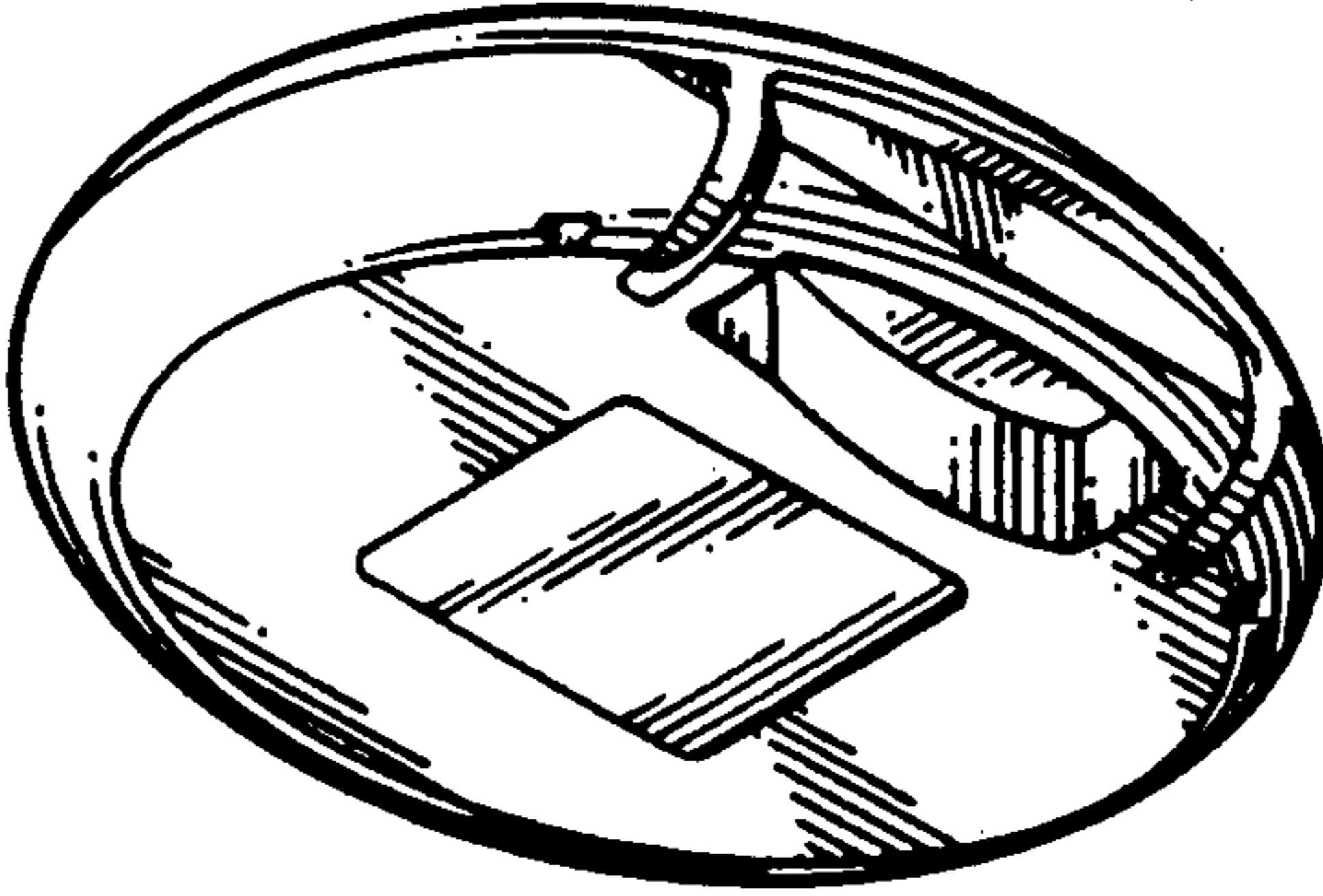

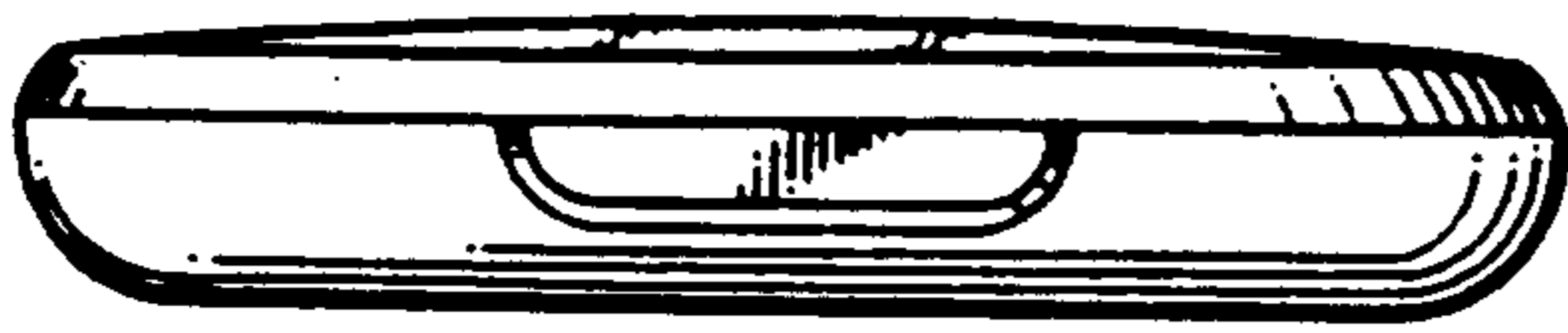

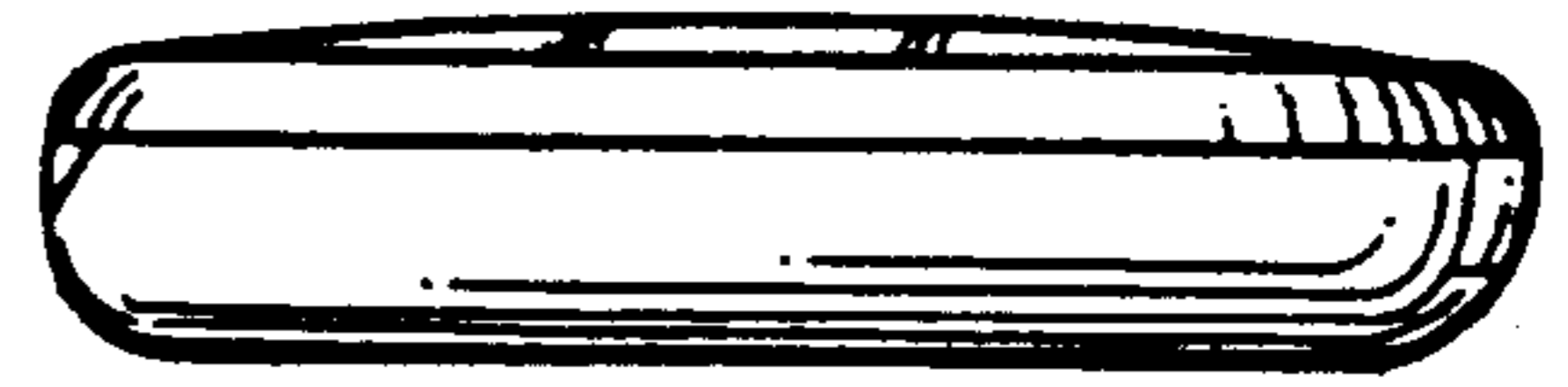

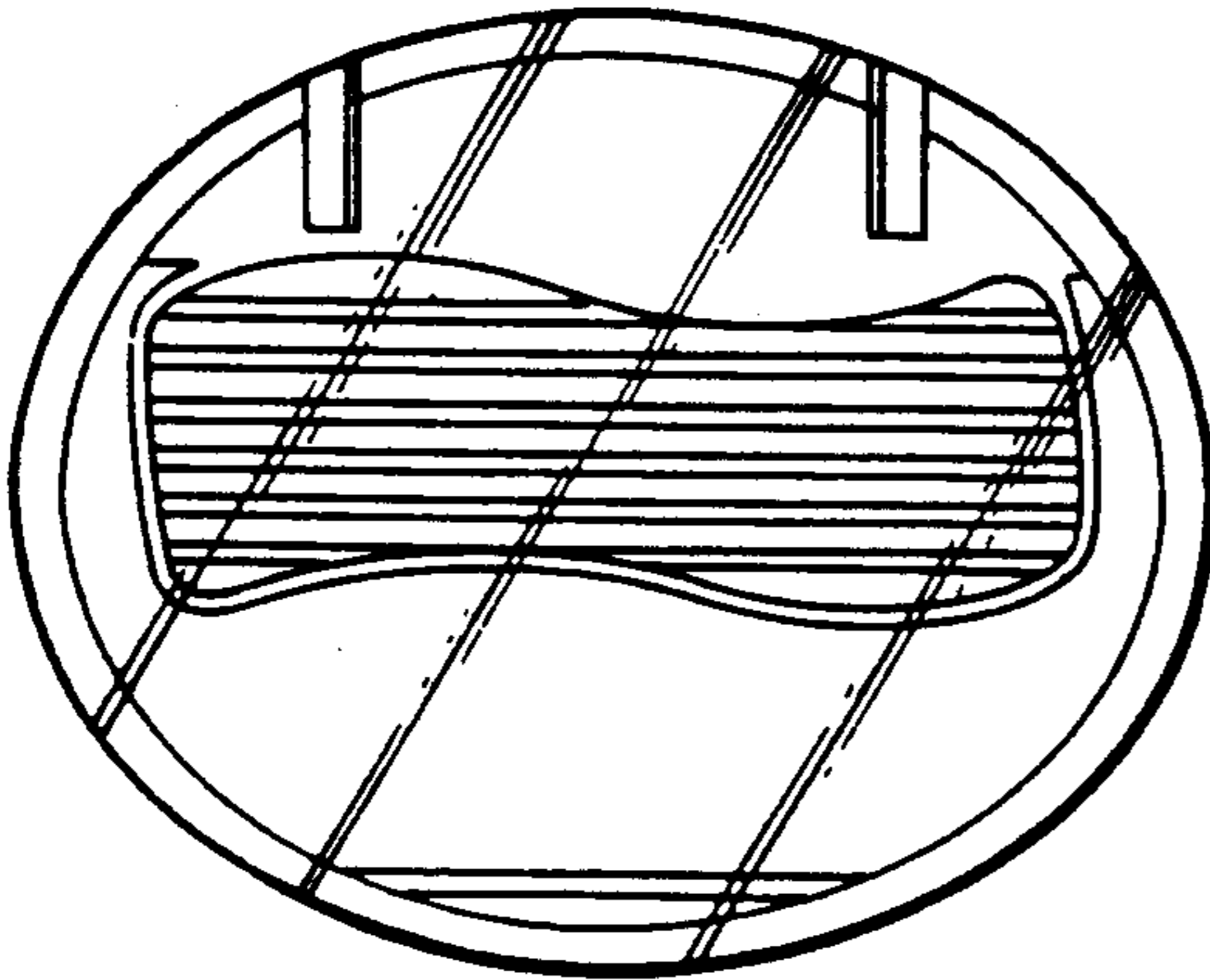

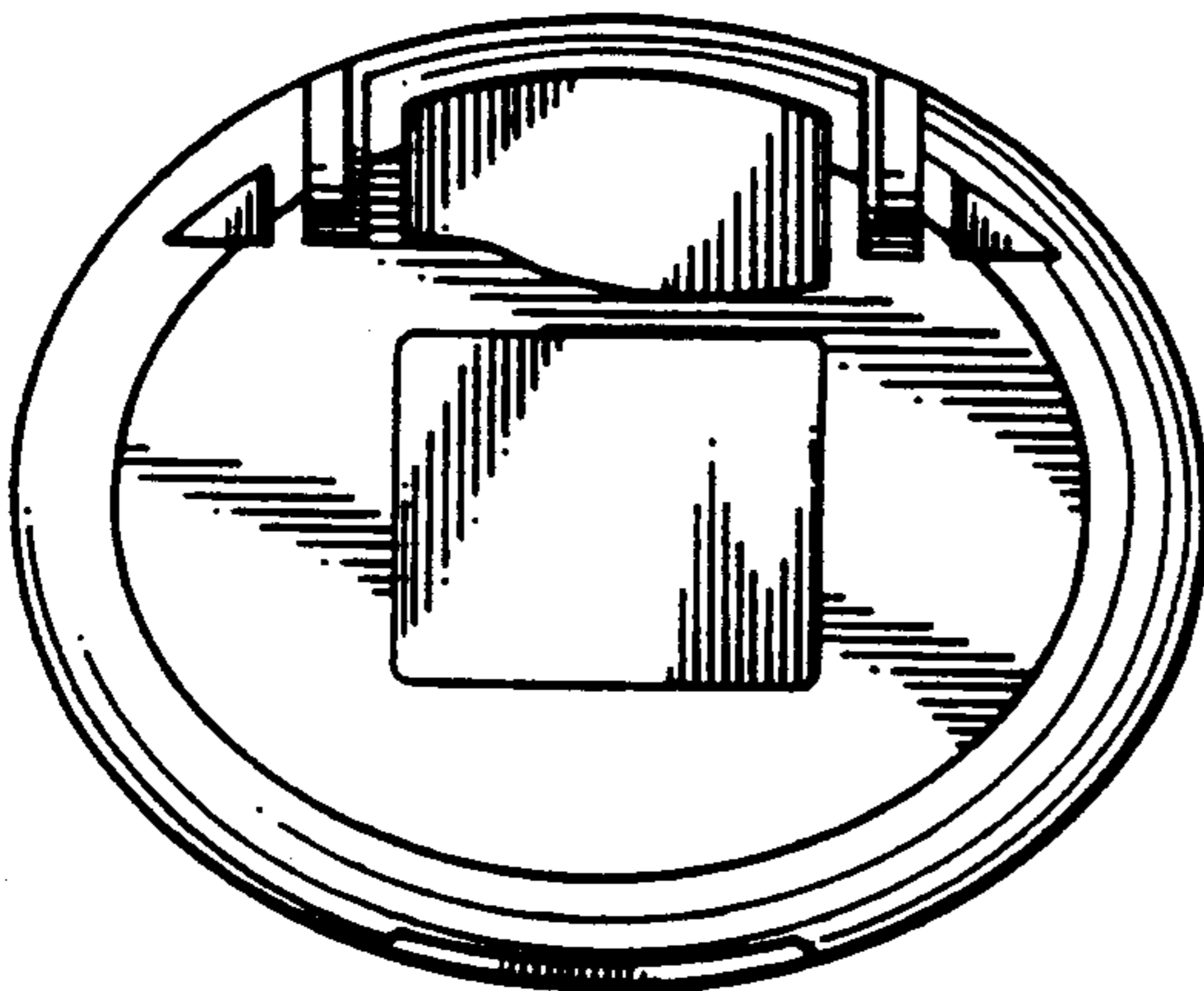

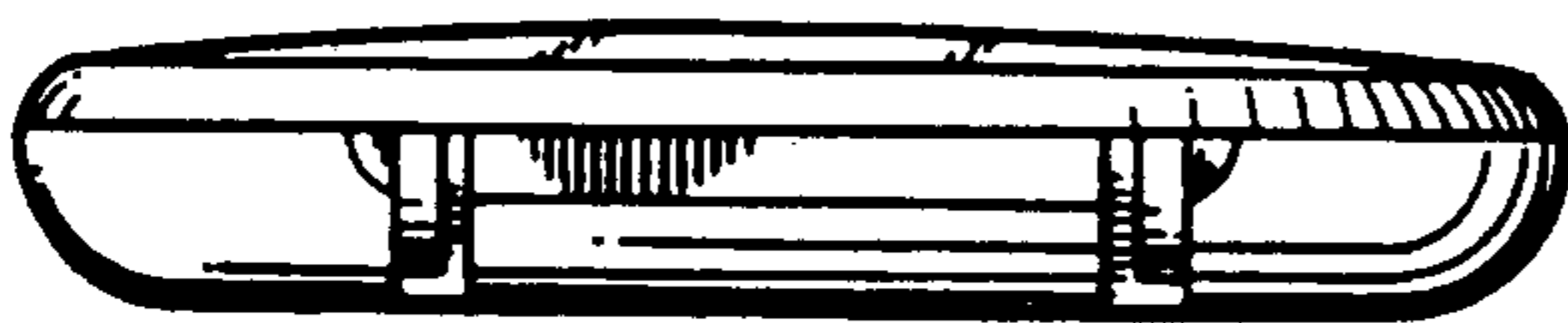
