DESCRIPTION

FIG. 1 is a bottom perspective view of a first embodiment of the container or the like showing our new design;

FIG. 15 is a cross-sectional view taken along line 15—15 of FIG. 14;

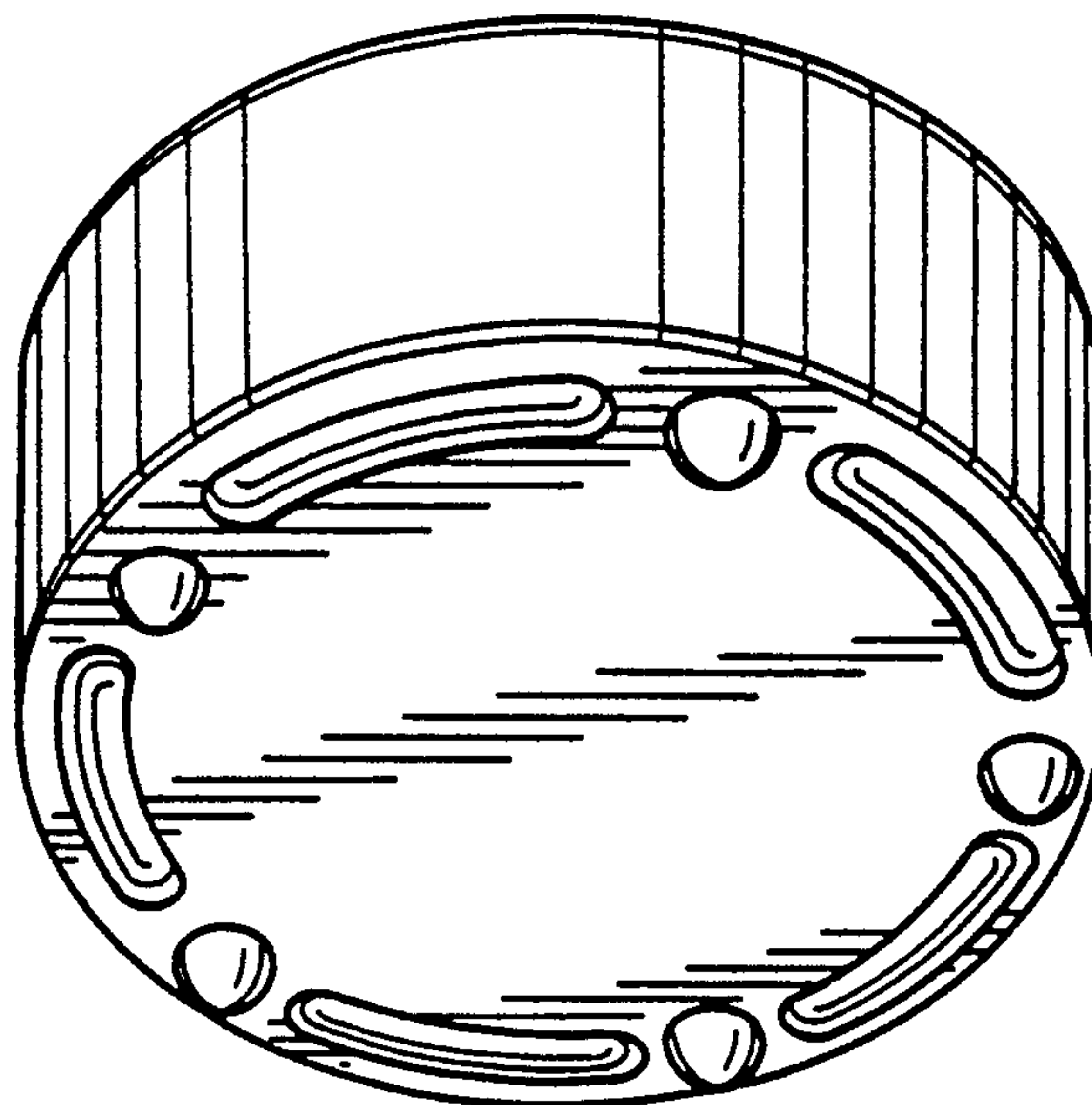
FIG. 16 bottom perspective view of a fourth embodiment of the container or the like;

FIG. 20 is cross-sectional view taken along line 20—20 of FIG. 19.



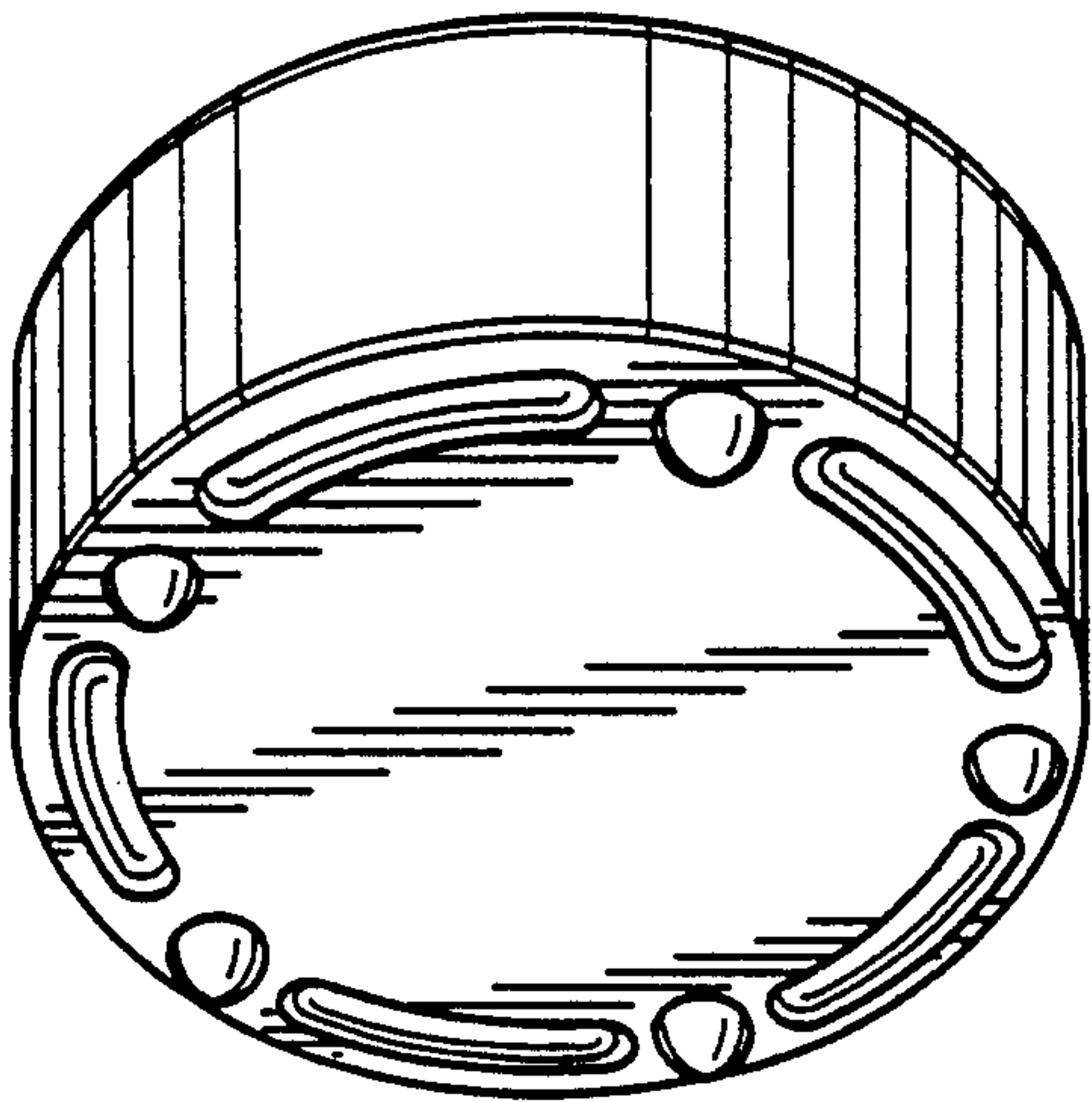

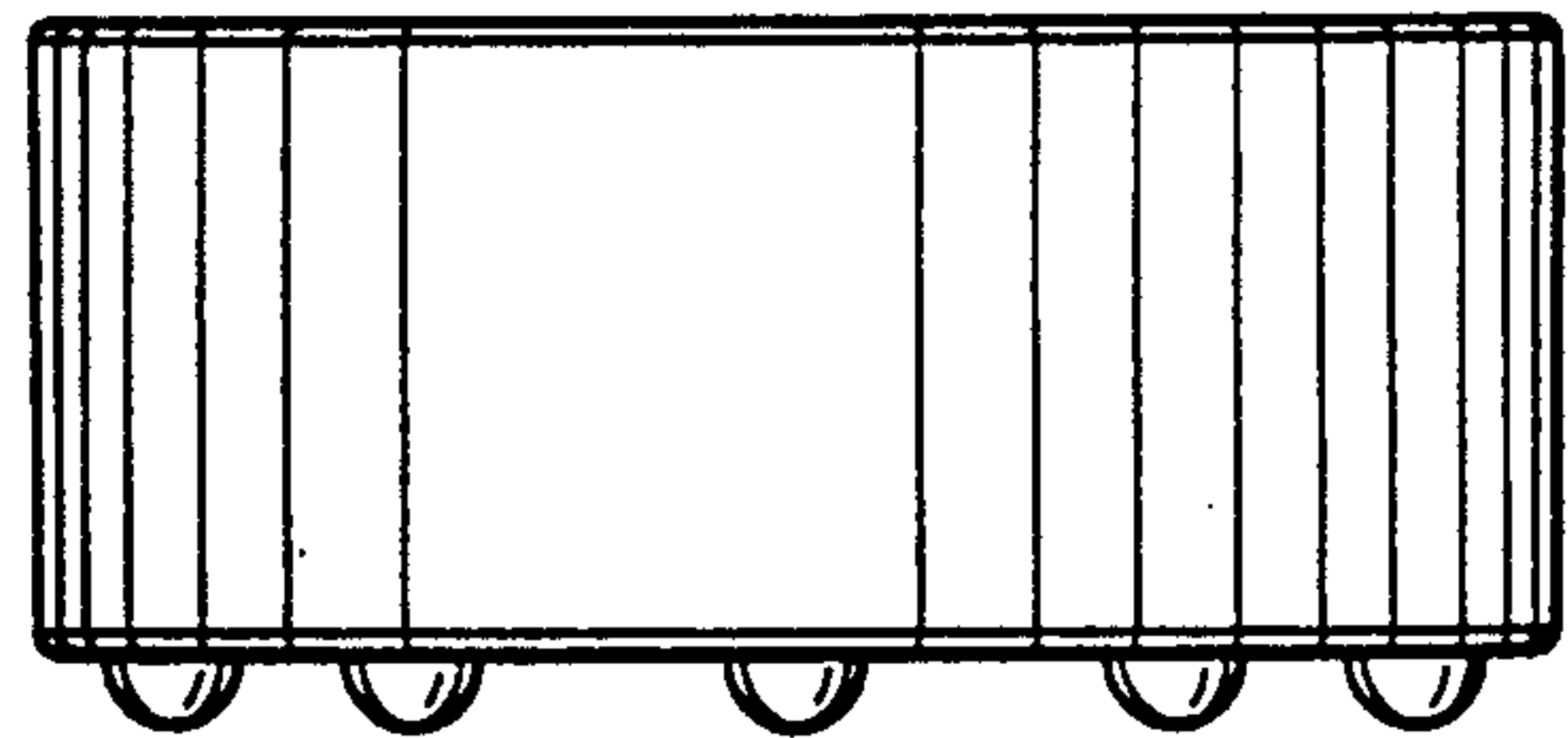

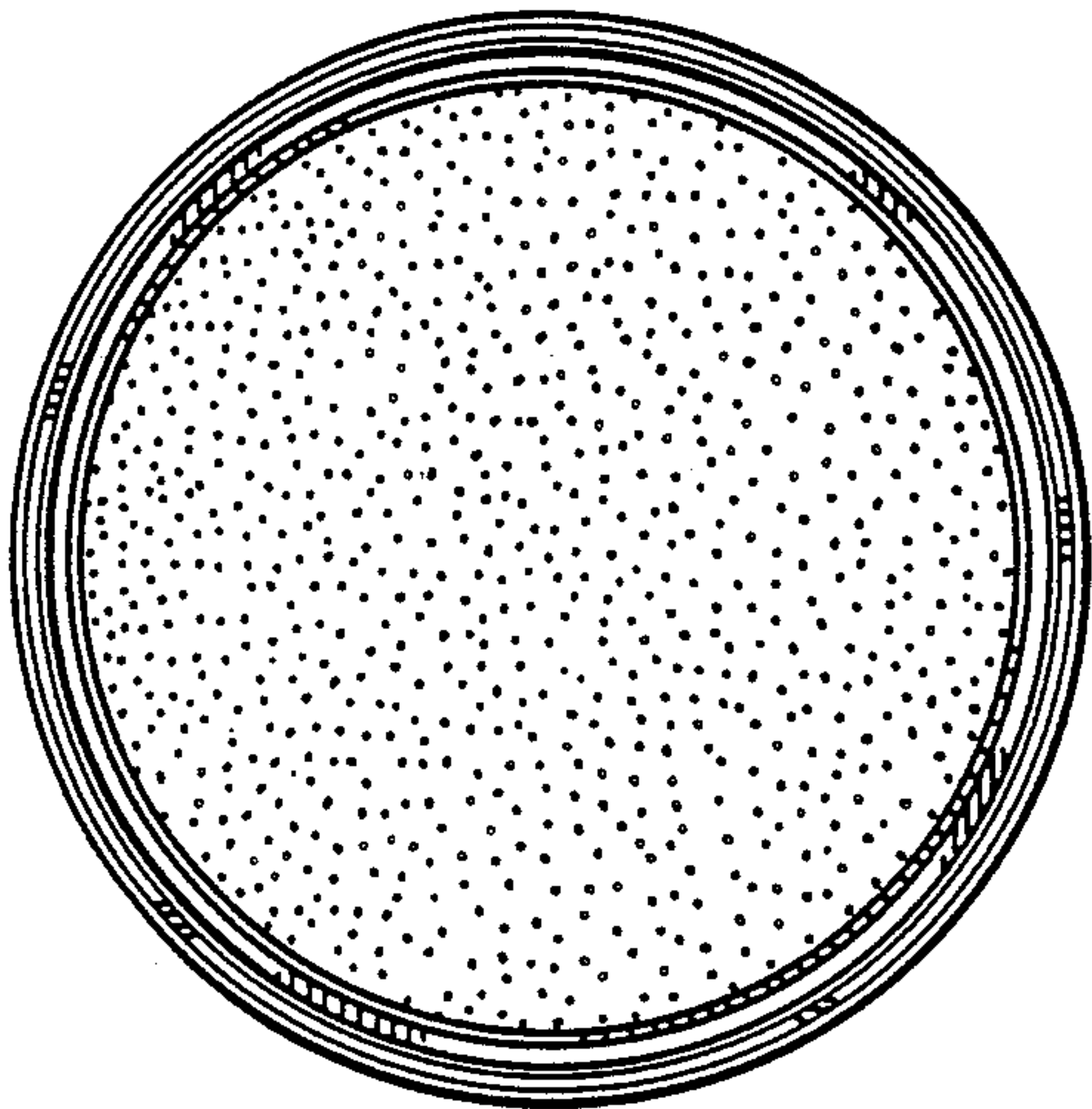

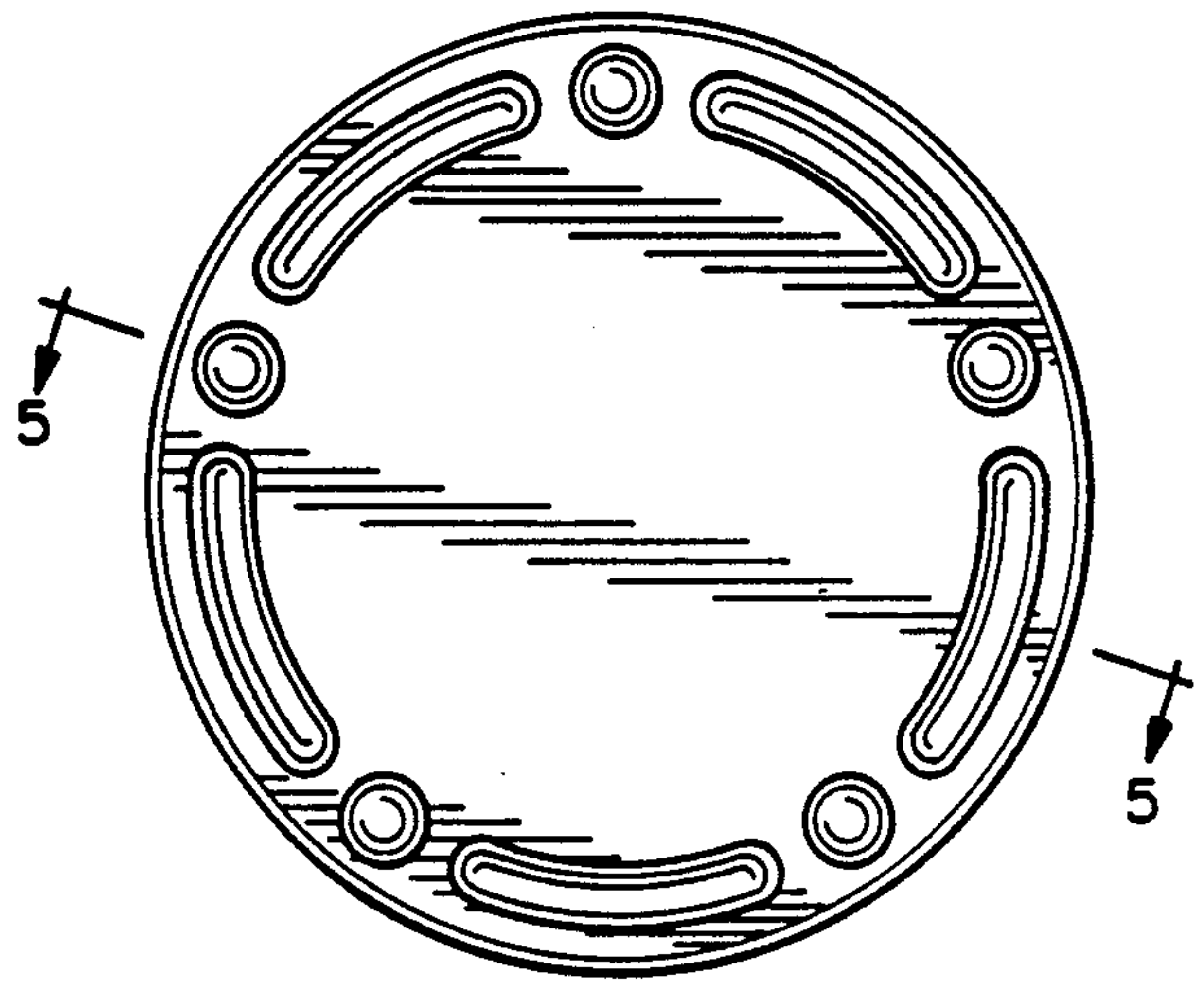

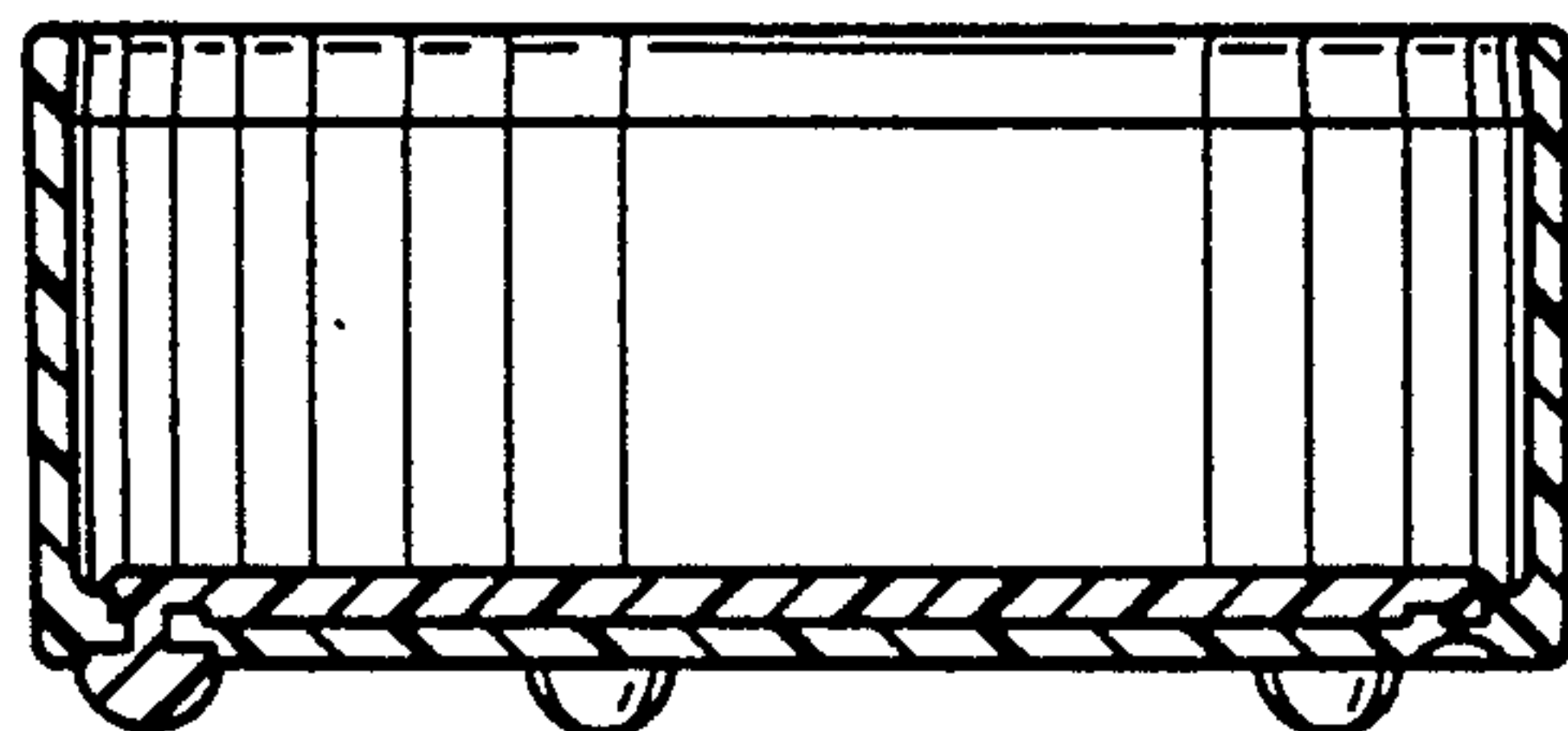

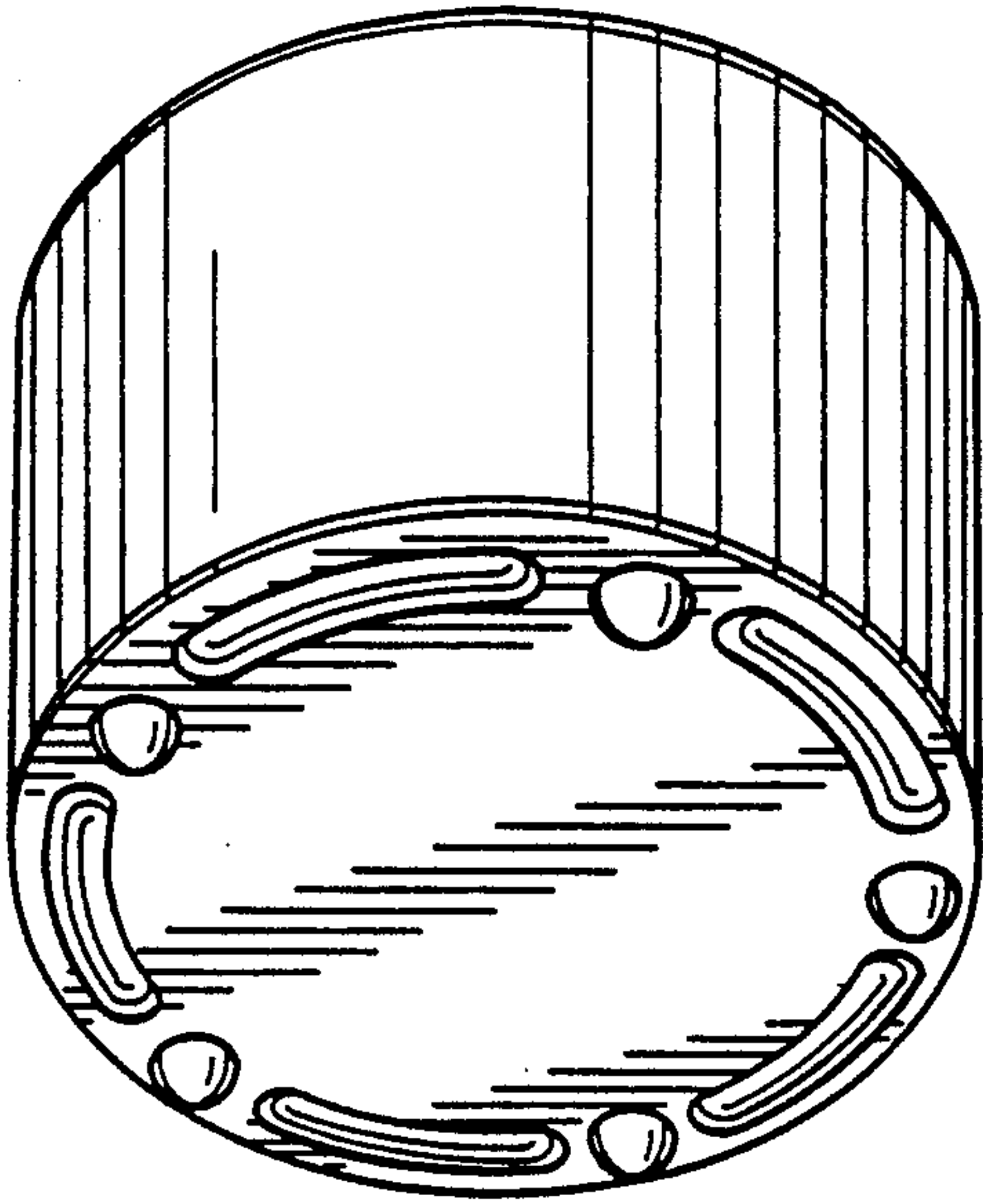

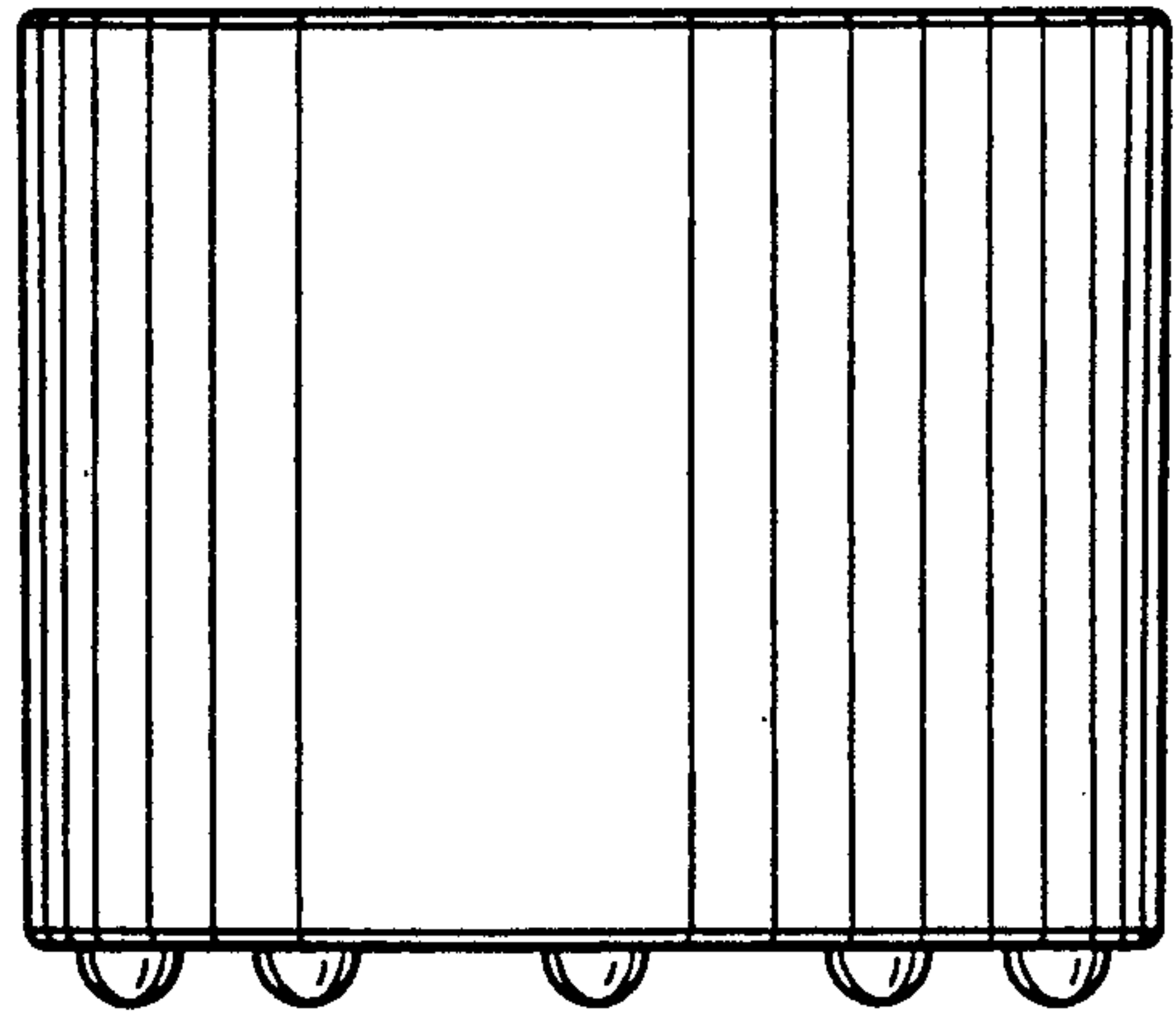

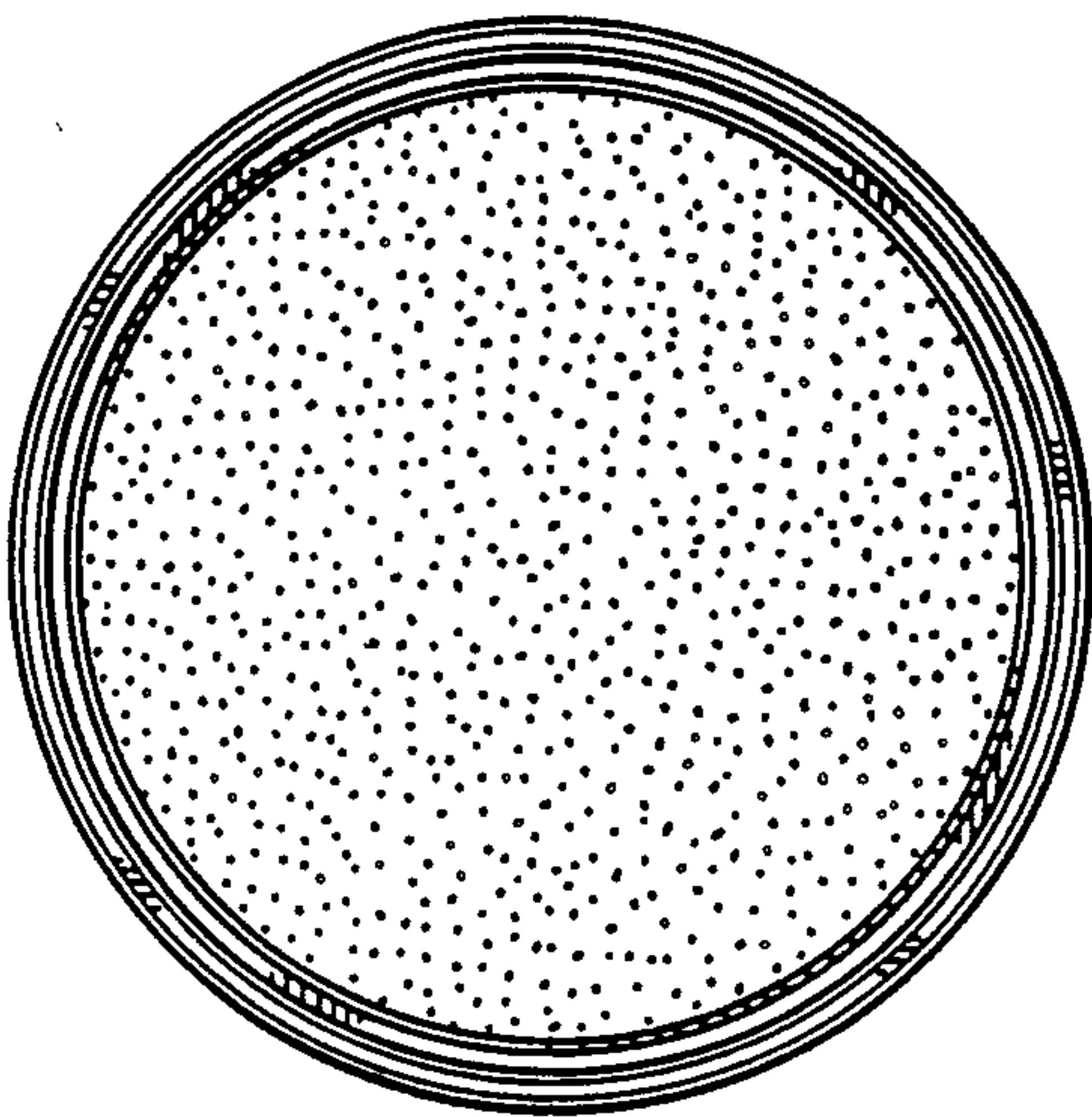

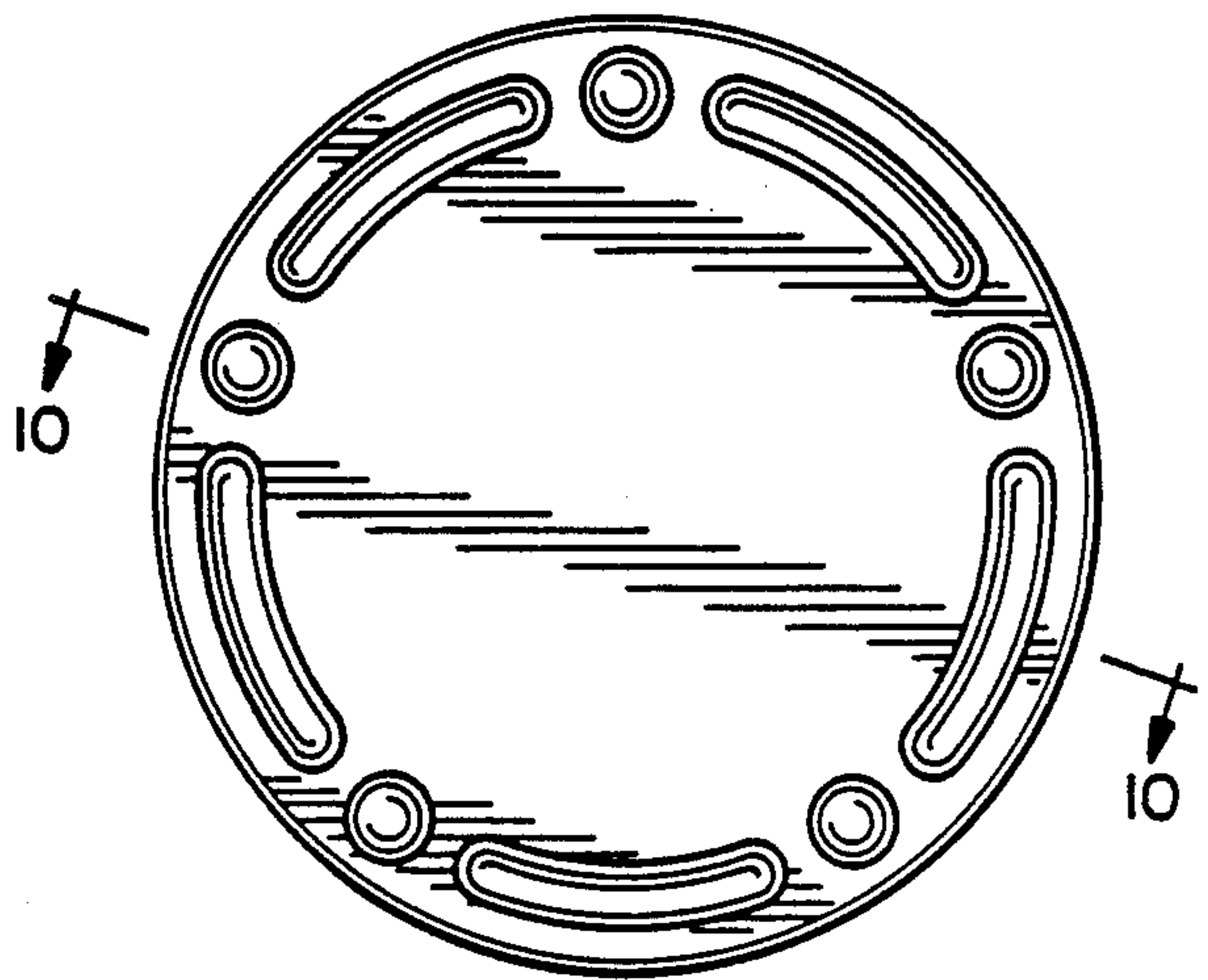

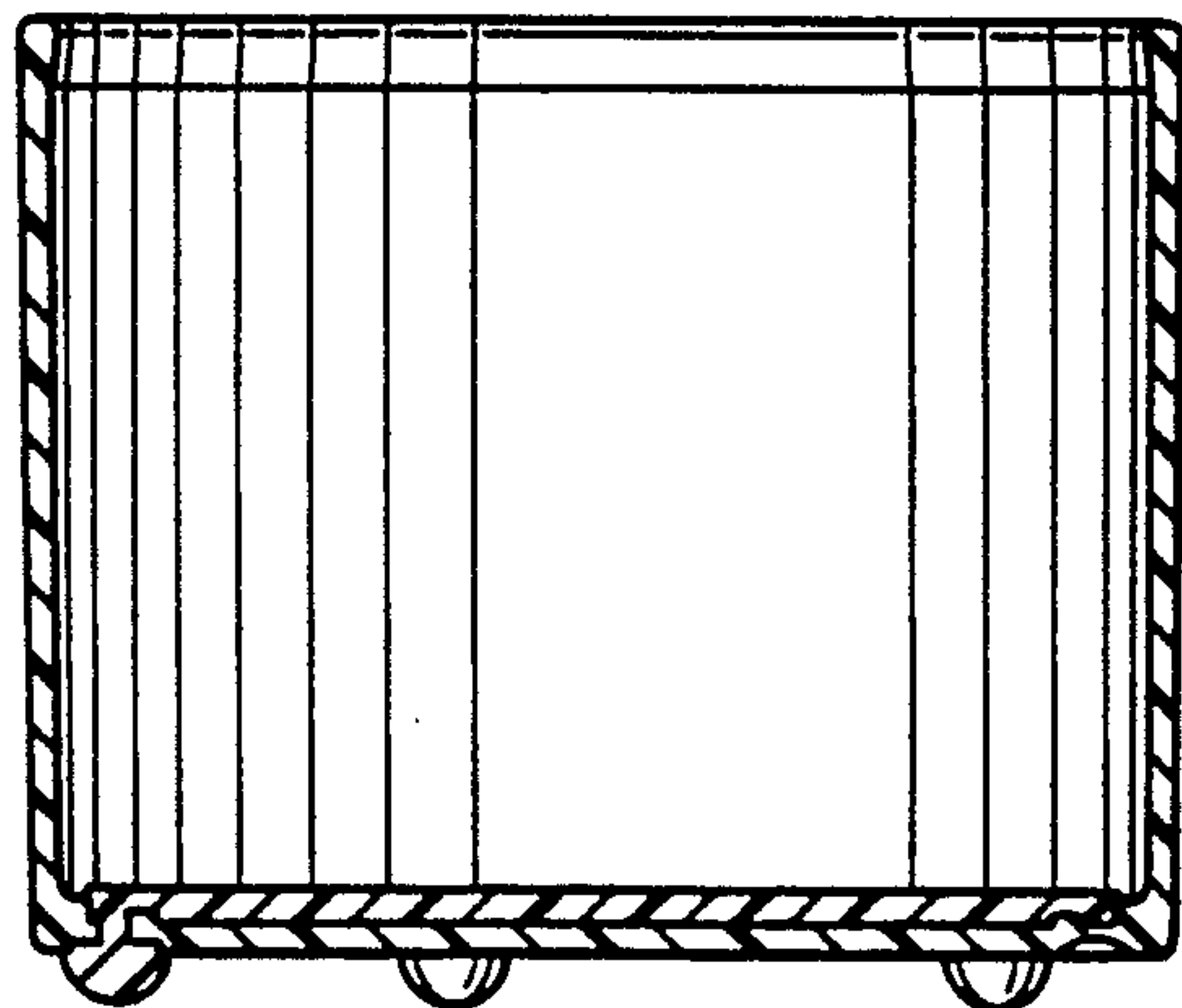

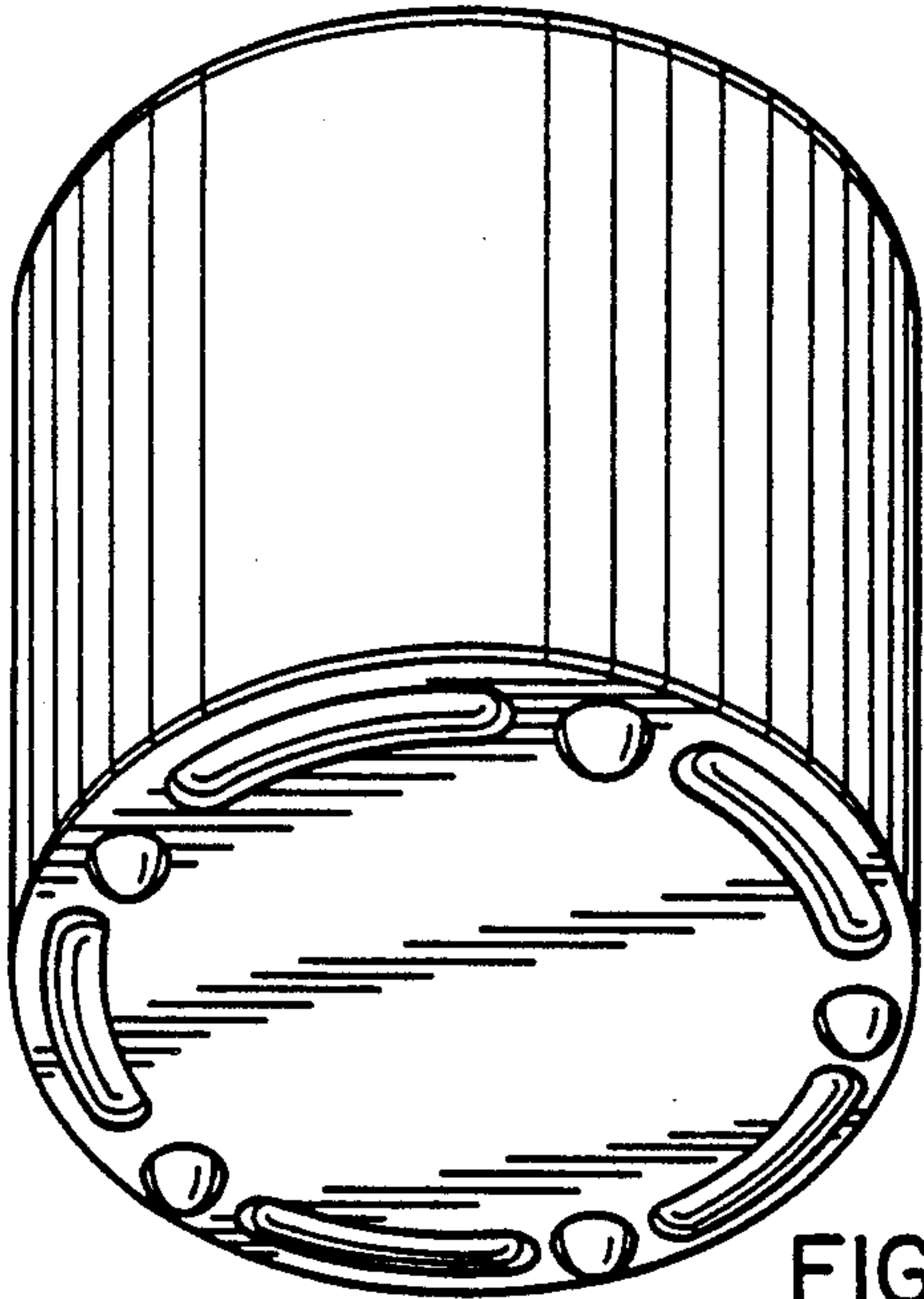

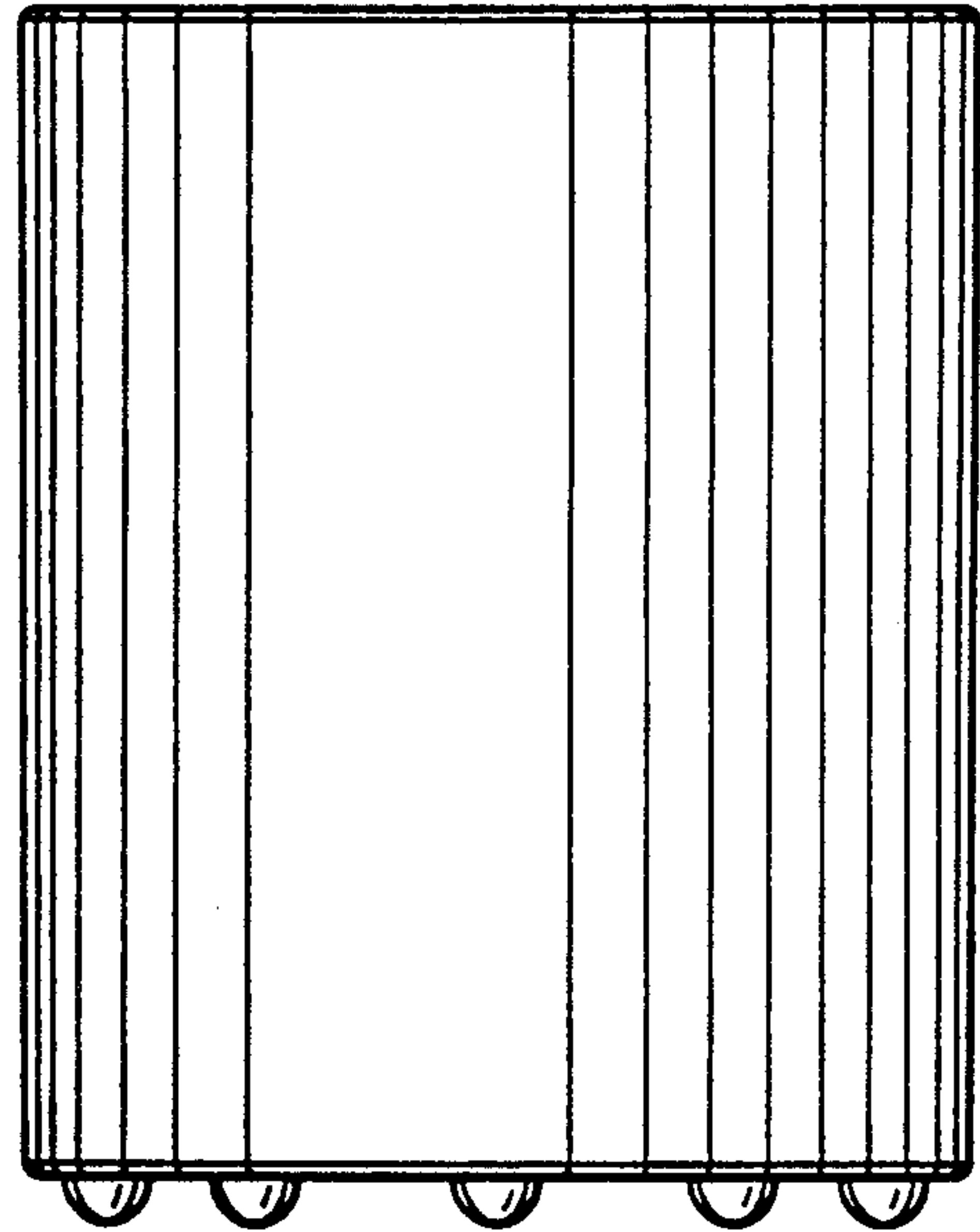

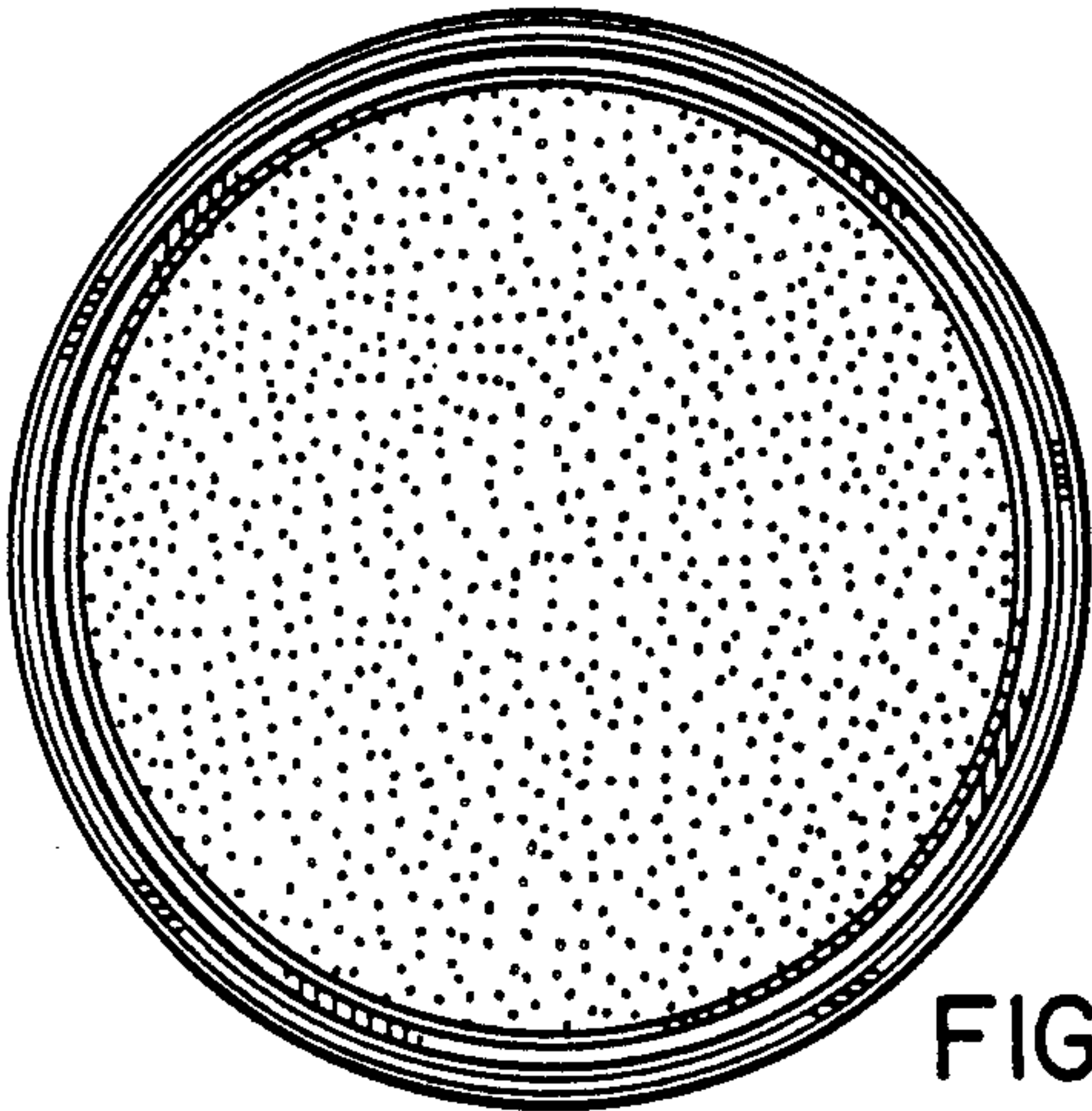

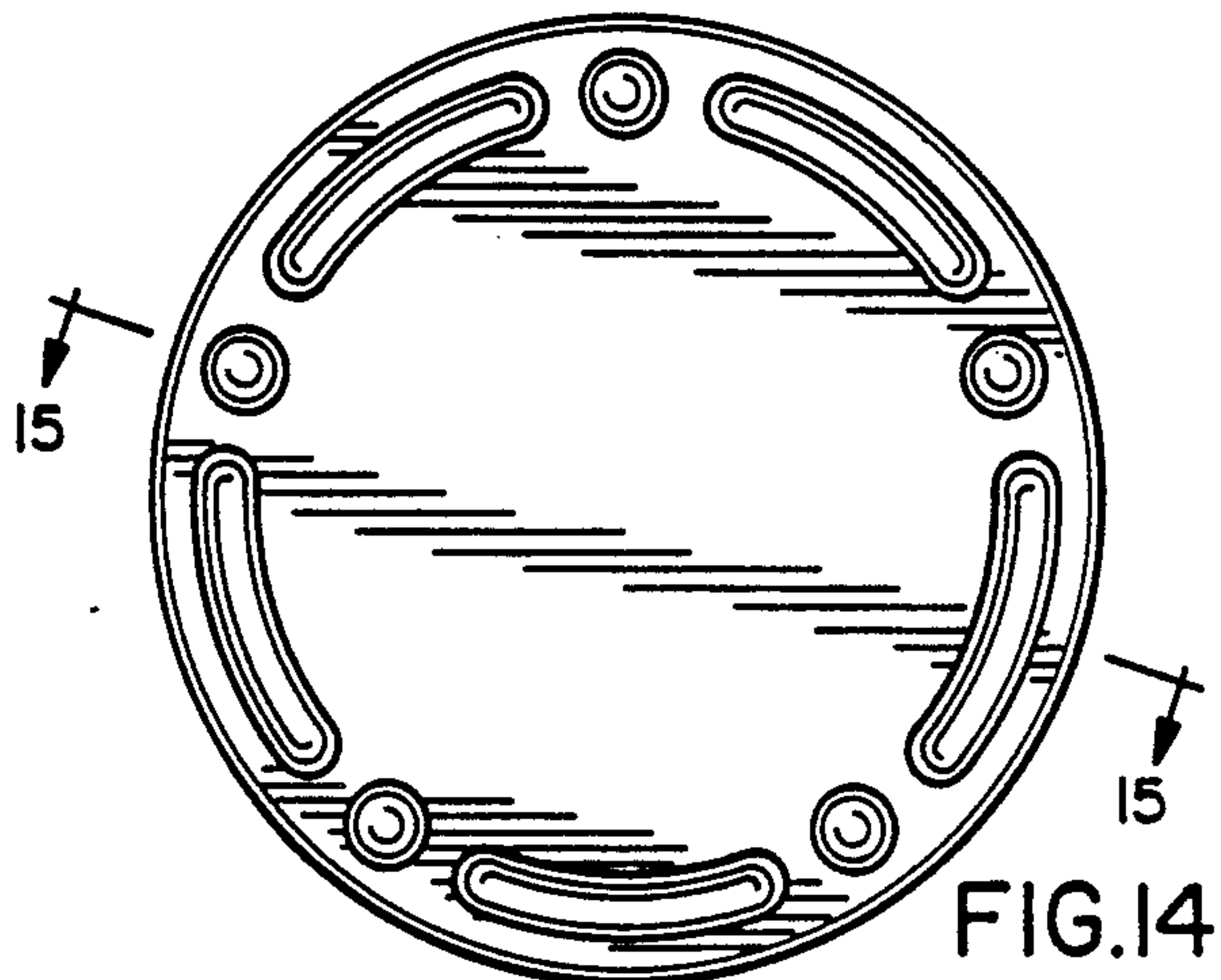

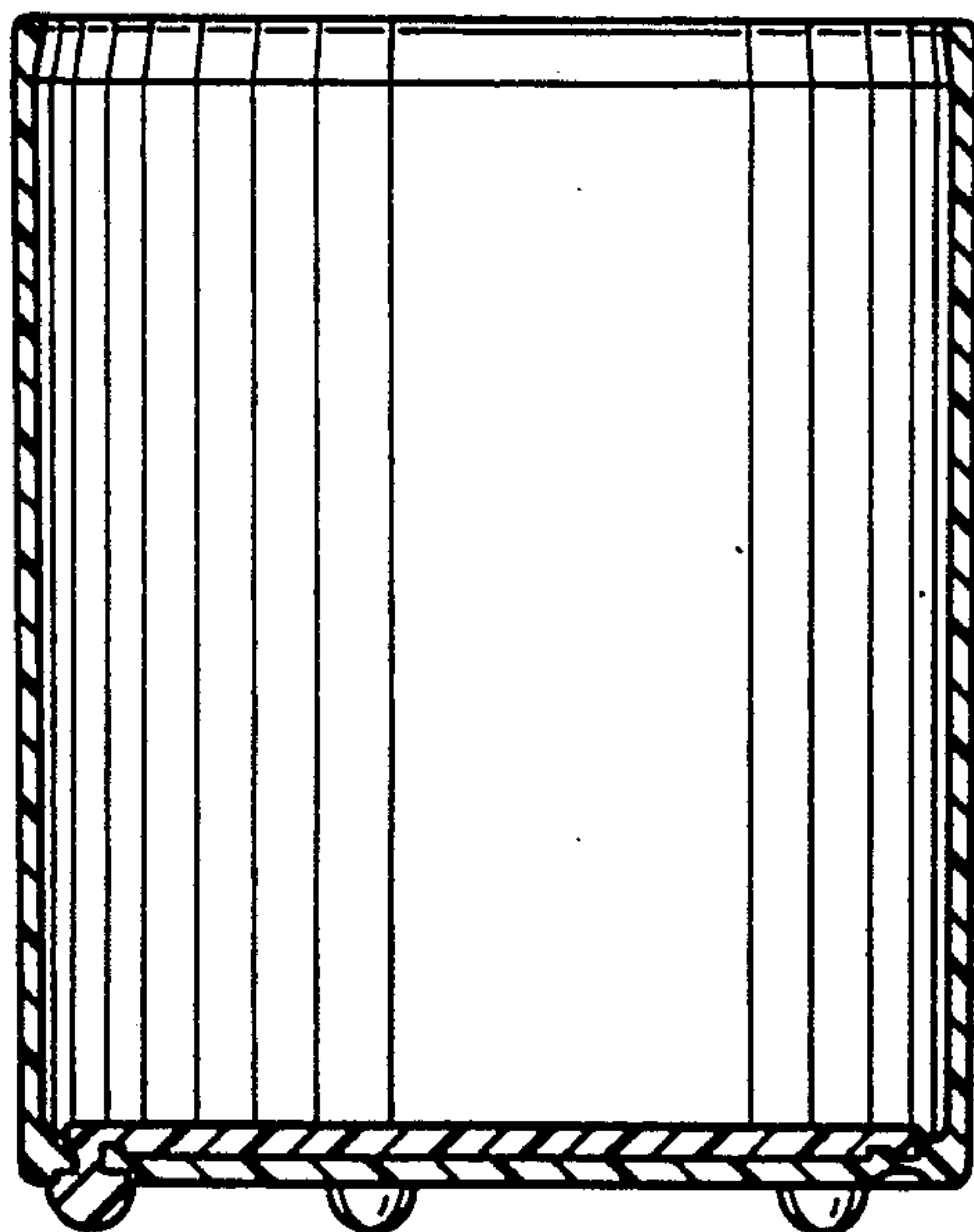

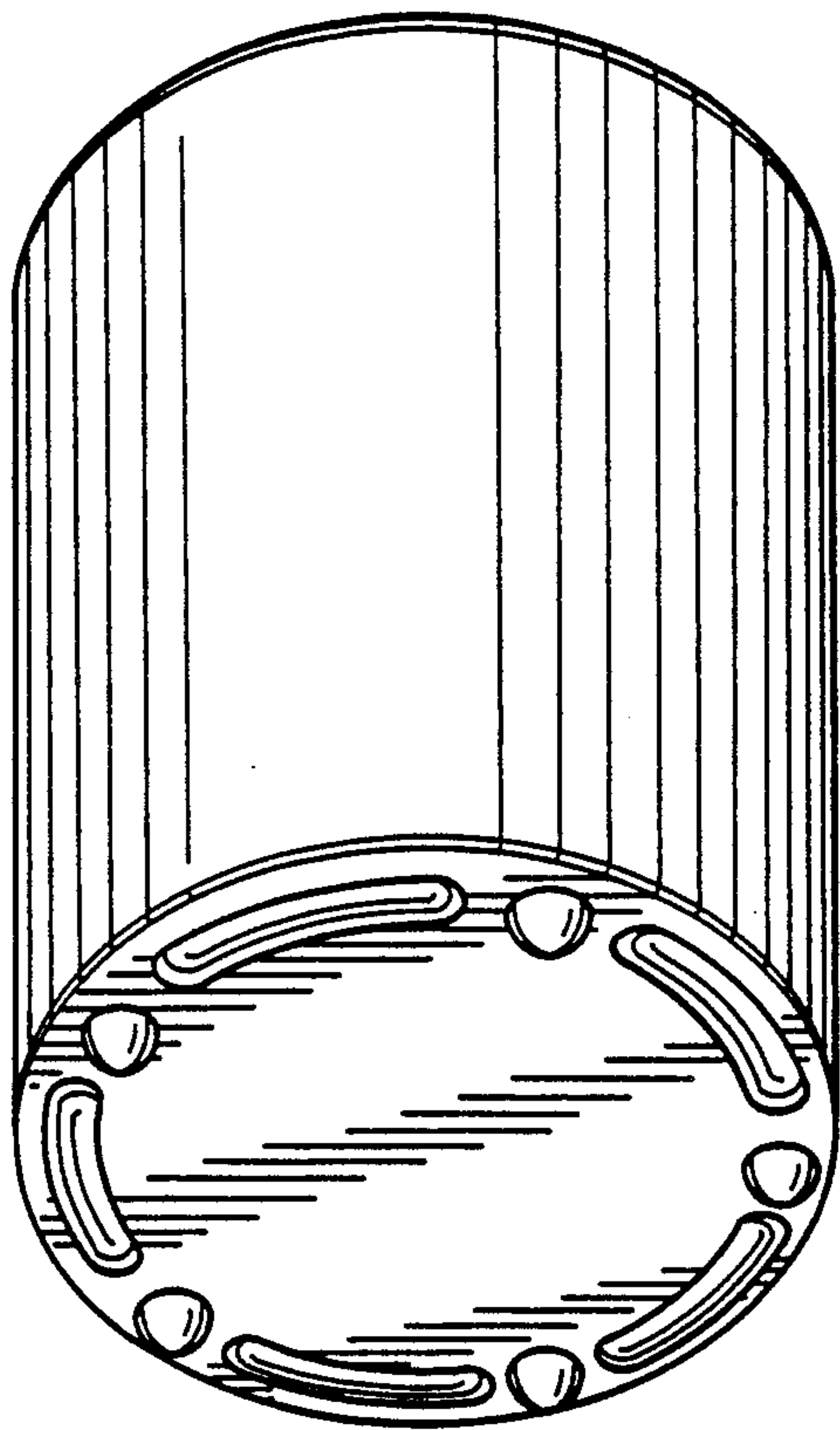

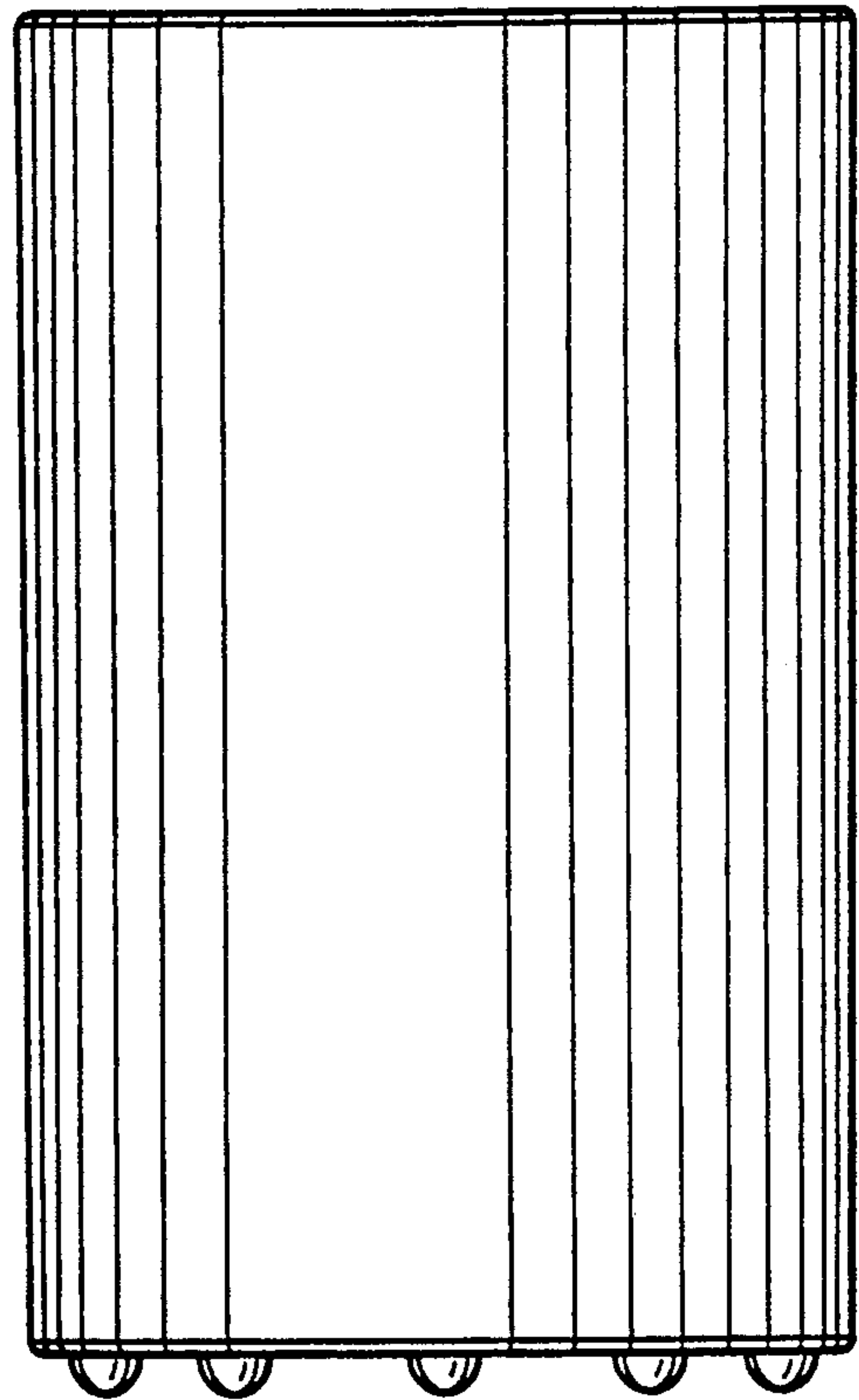

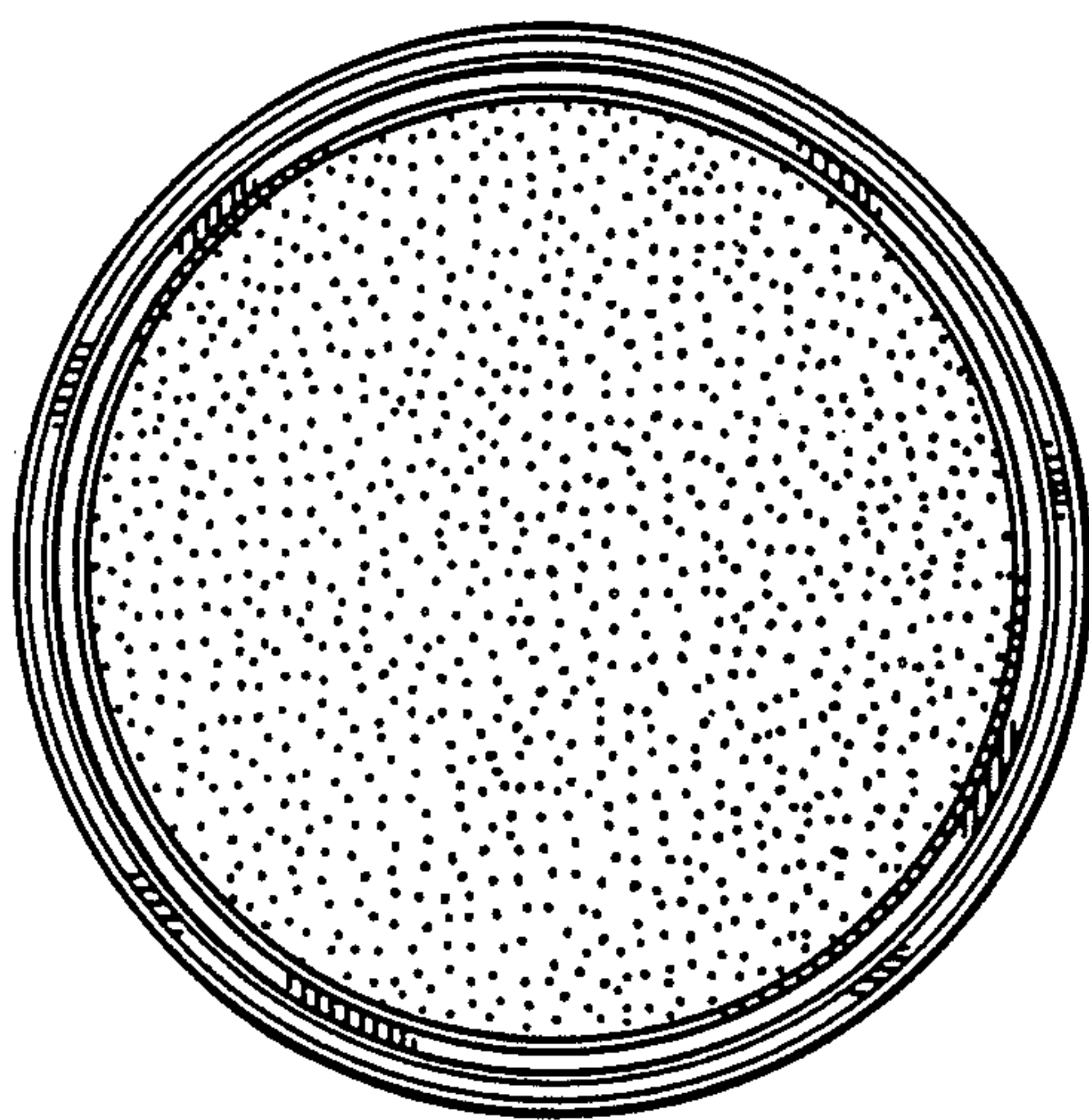

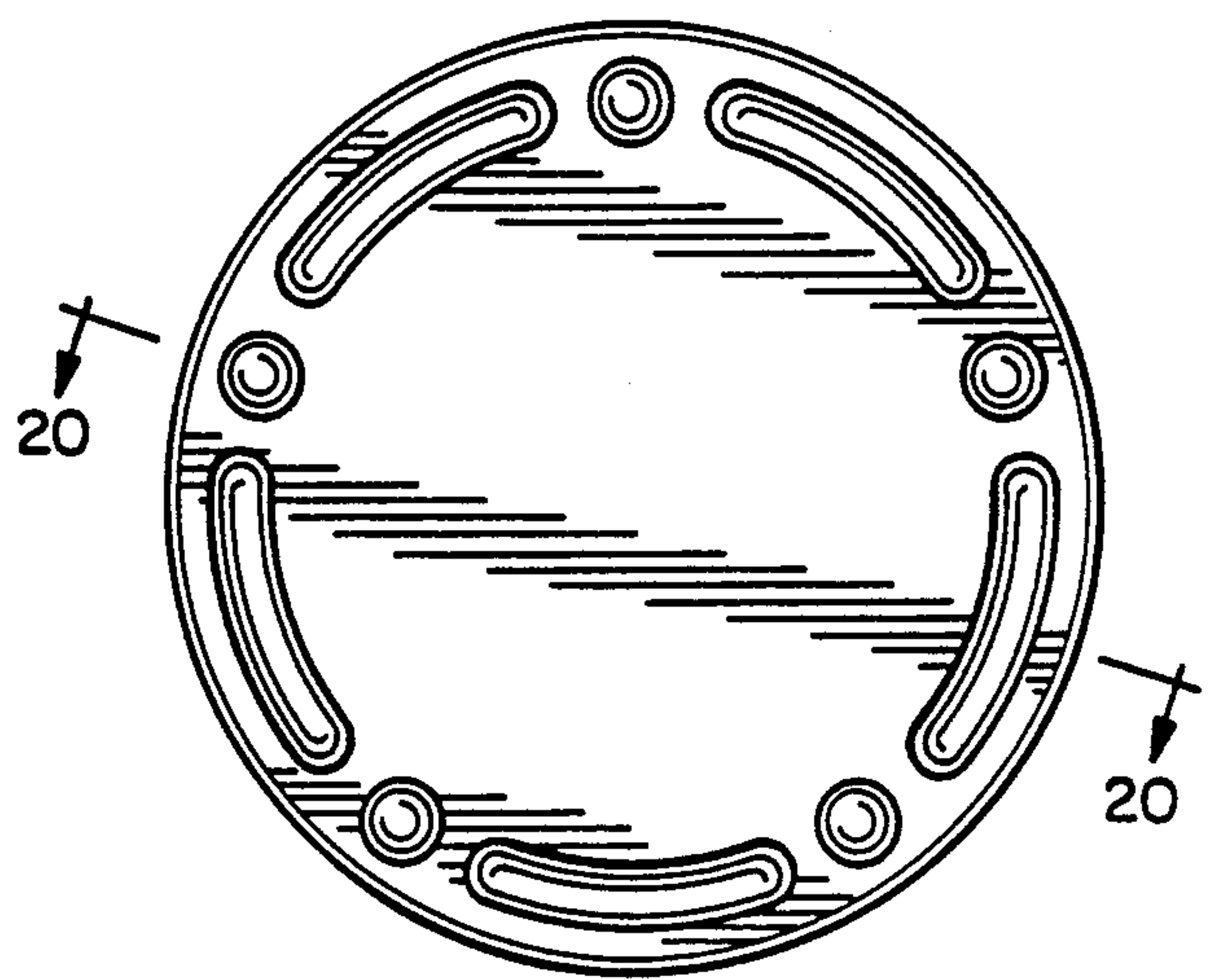

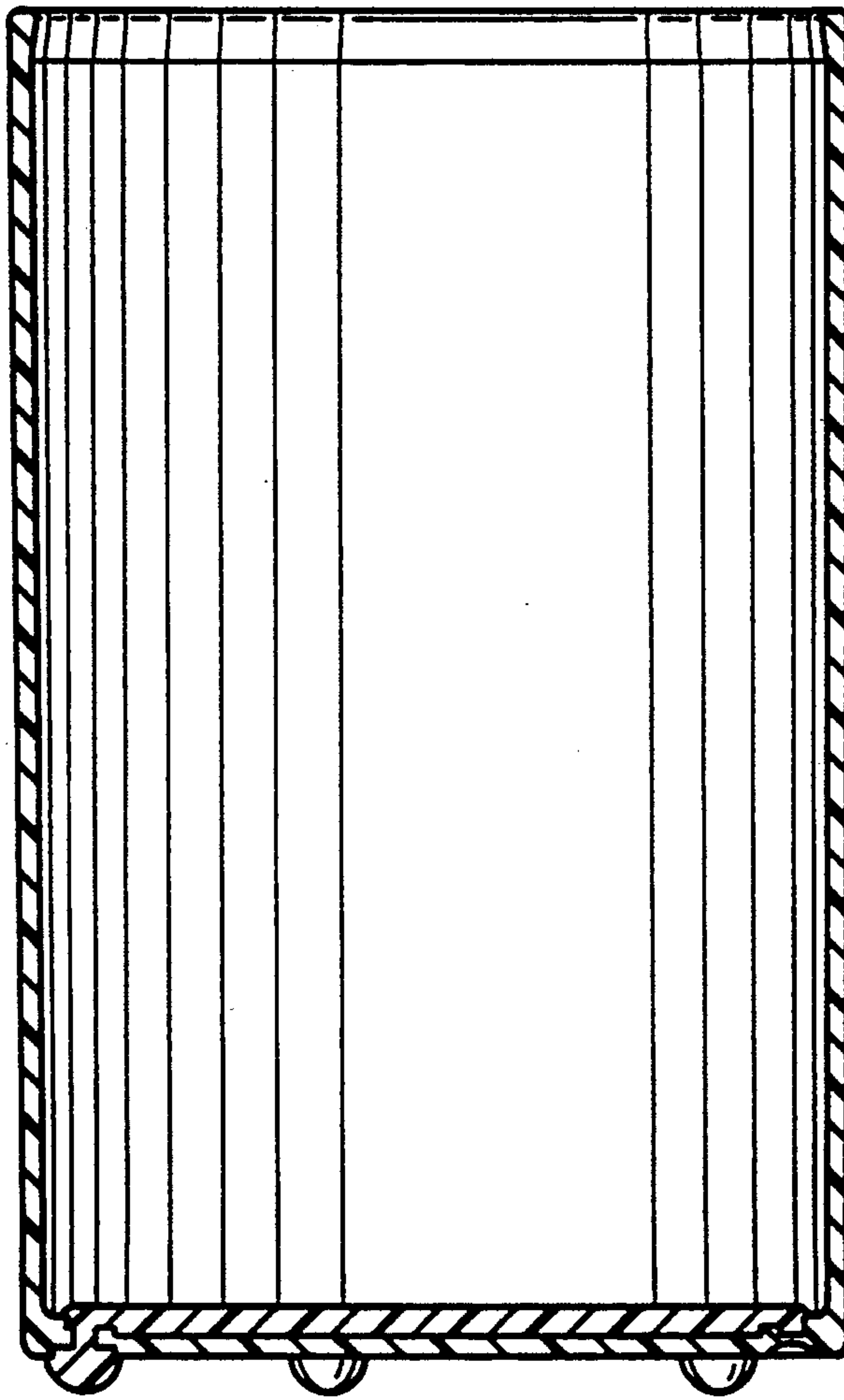
