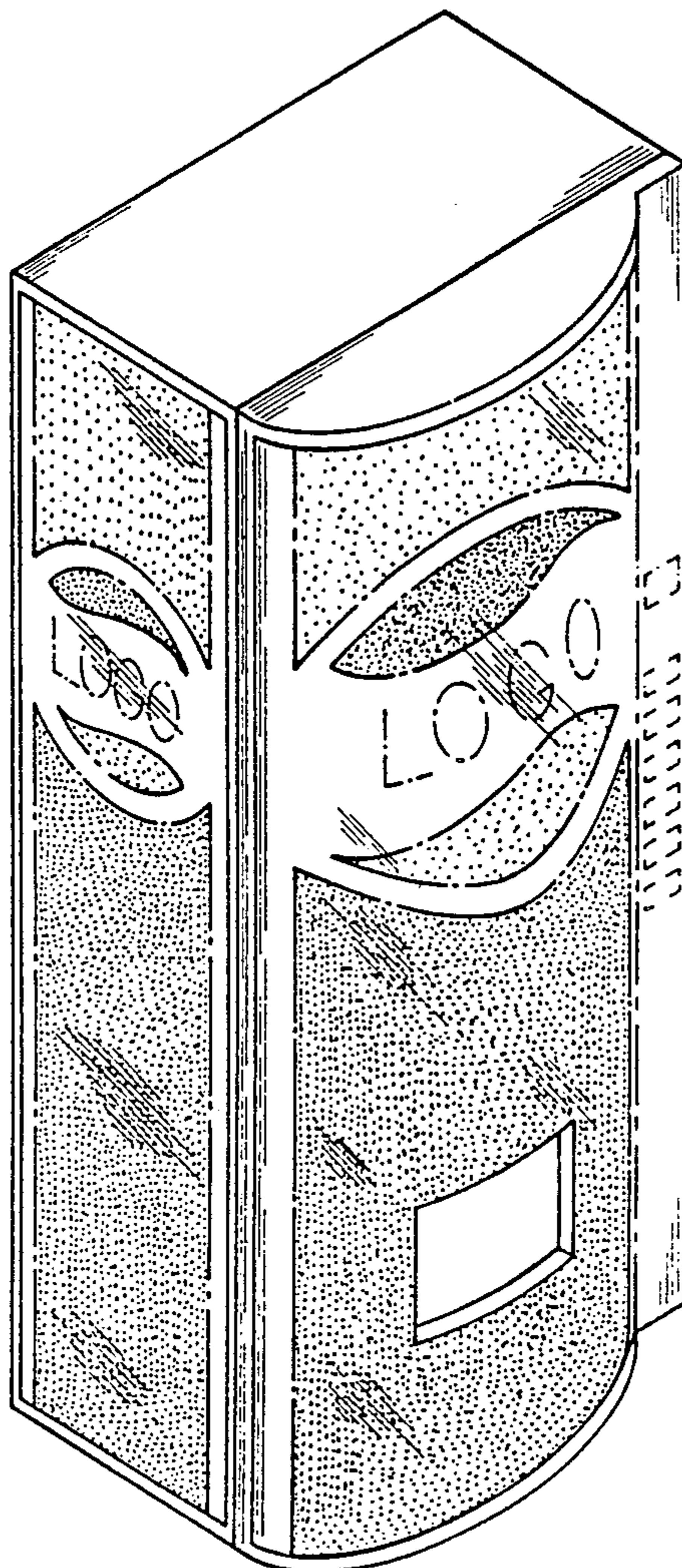

[57] **CLAIM**

The ornamental design for a vending machine for beverages, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of a vending machine for beverages showing my new design;  
 FIG. 2 is a left side elevational view thereof;  
 FIG. 3 is a right side elevational view thereof;  
 FIG. 4 is a top, front and left side perspective view of a second embodiment thereof;  
 FIG. 5 is a left side elevational view of FIG. 4;  
 FIG. 6 is a right side elevational view of FIG. 4;  
 FIG. 7 is a top, front and left side perspective view of a third embodiment thereof;  
 FIG. 8 is a left side elevational view of FIG. 7; and  
 FIG. 9 is a right side elevational view of FIG. 7.  
 The broken lines in FIGS. 1 through 9 indicating surface details and indicia are for illustrative purposes only and form no part of the claimed design.



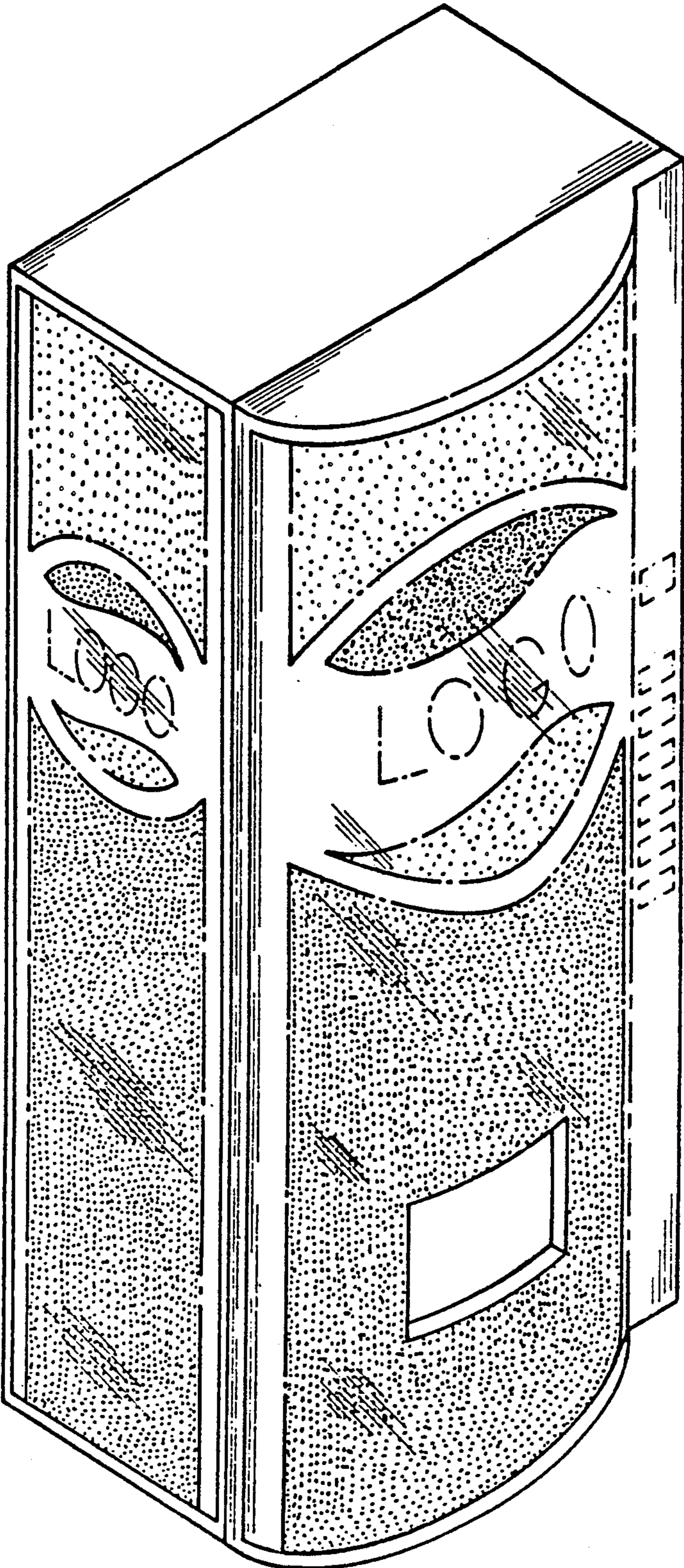

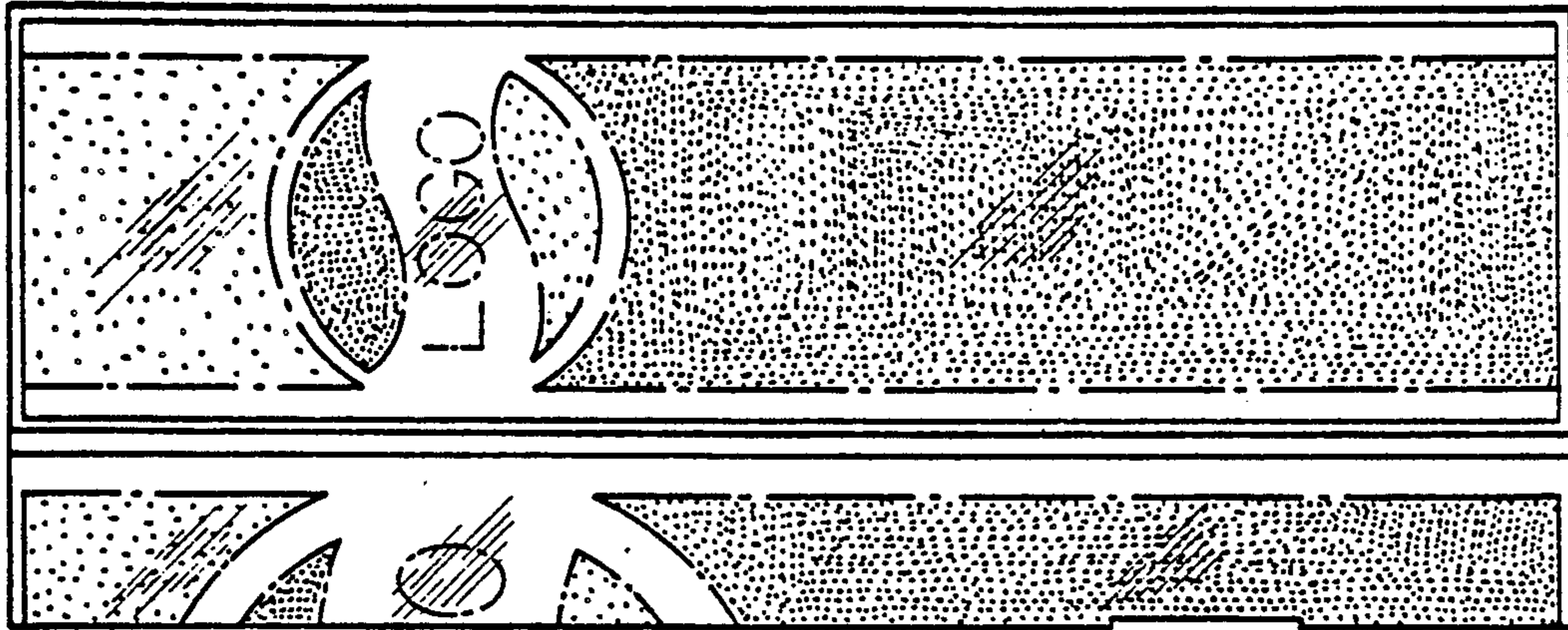

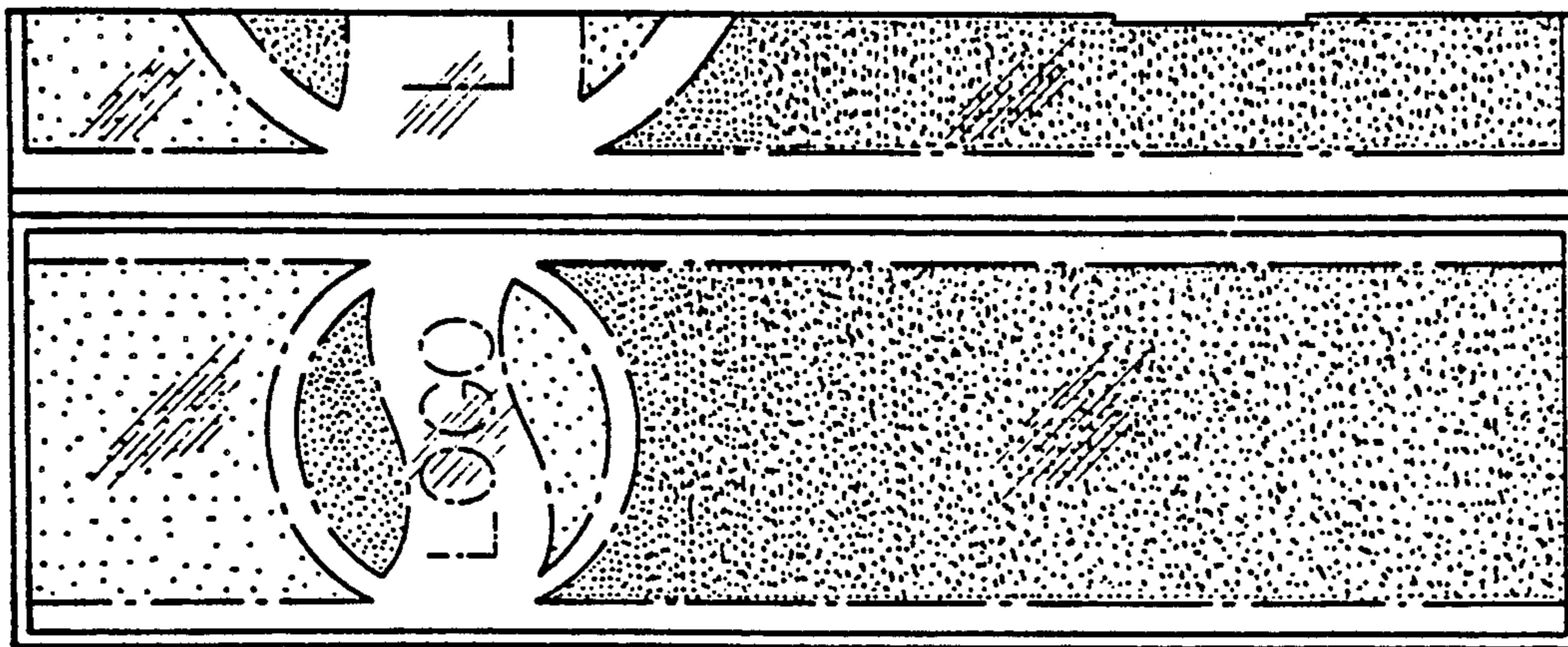

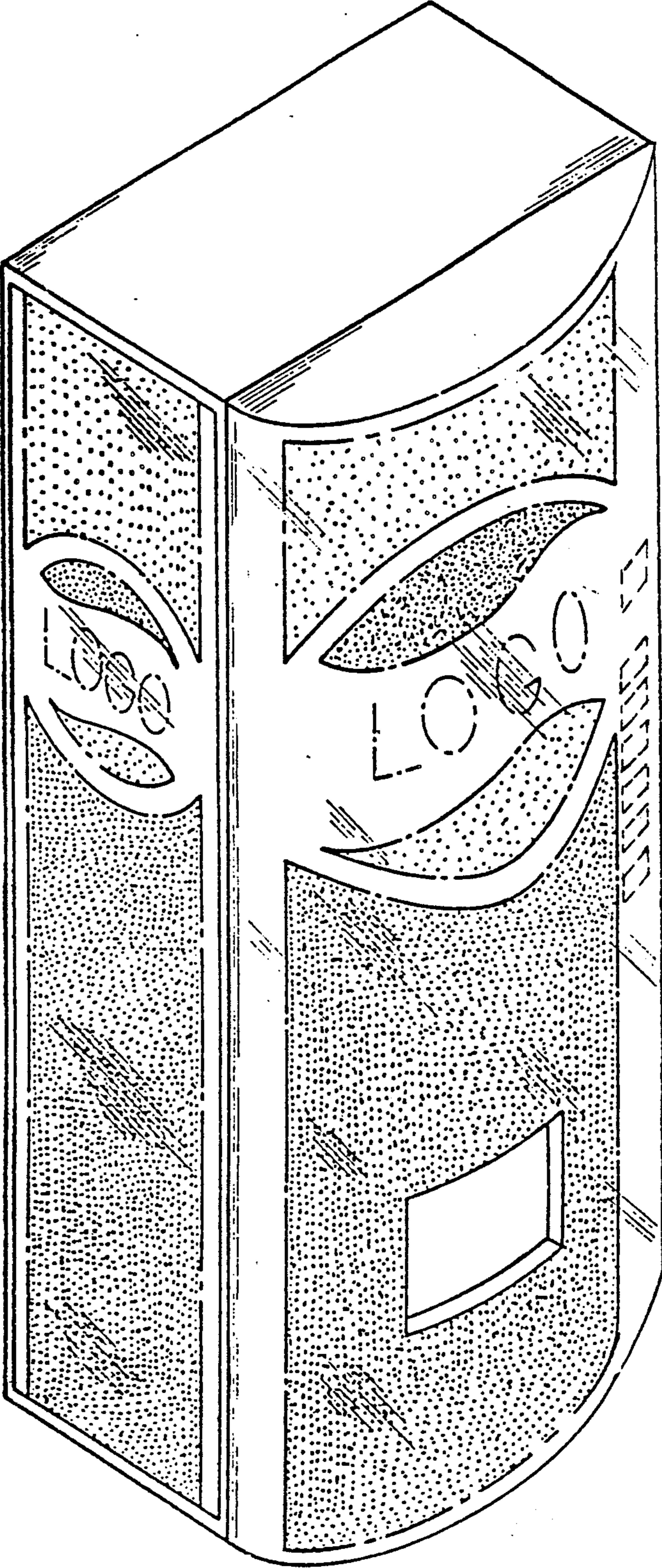

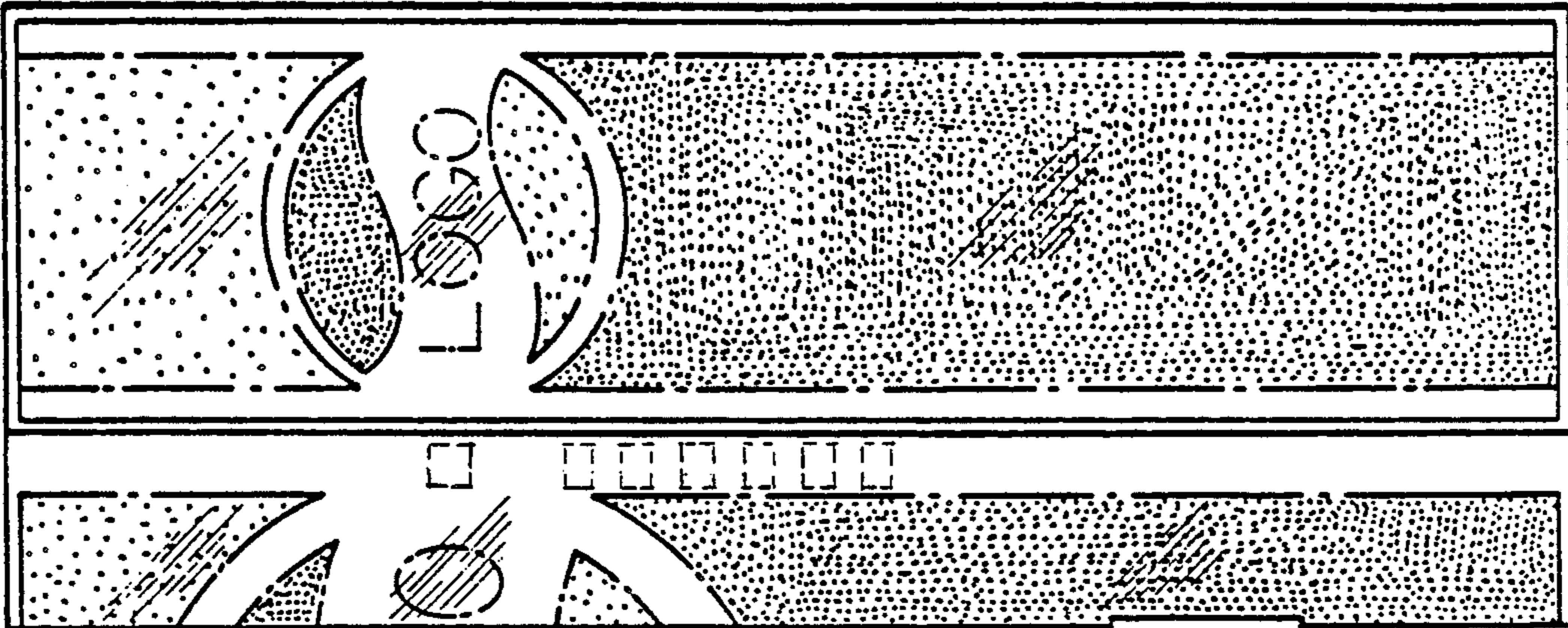

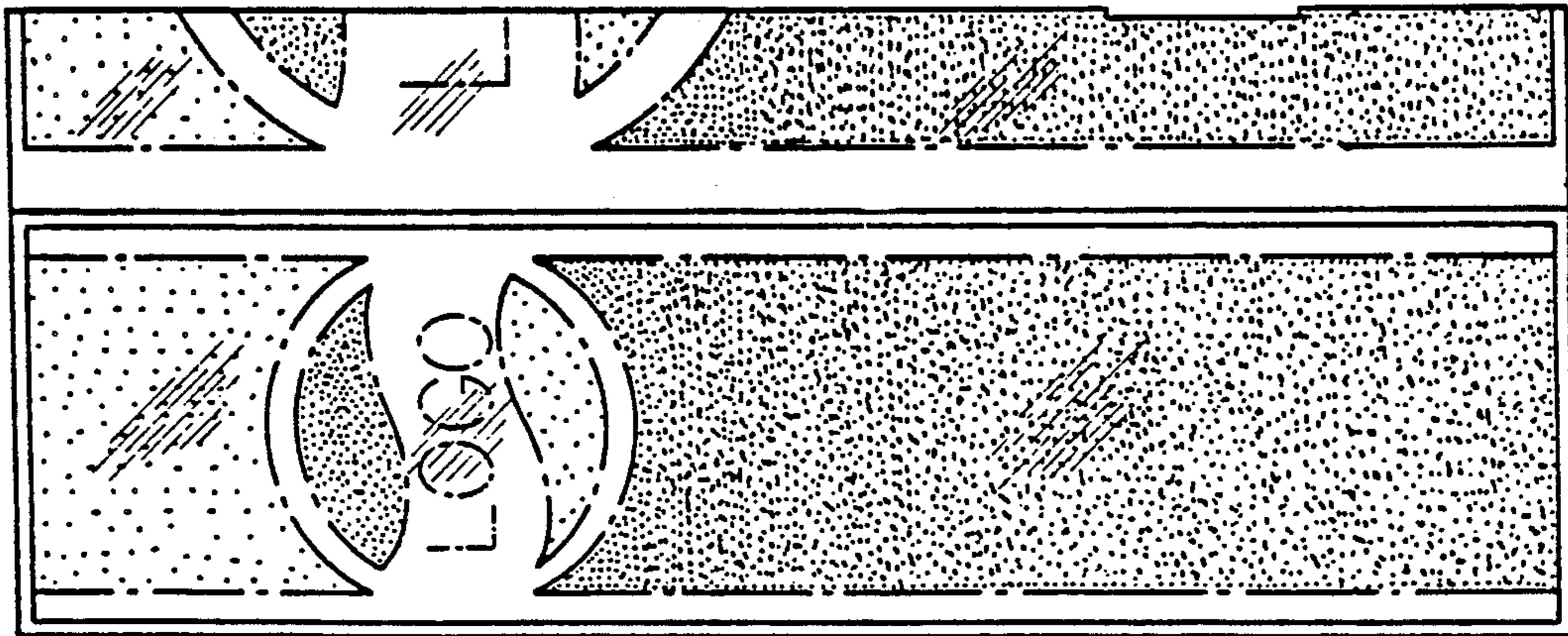

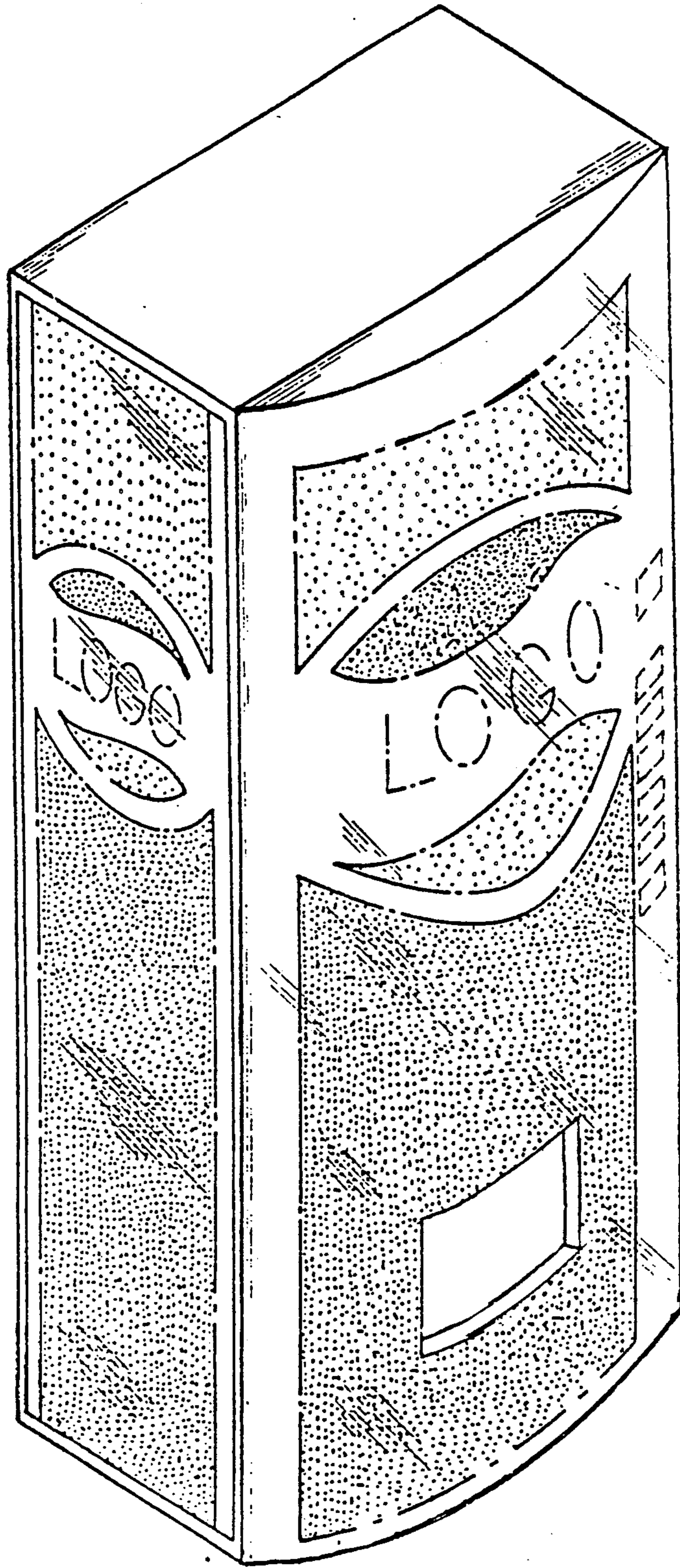

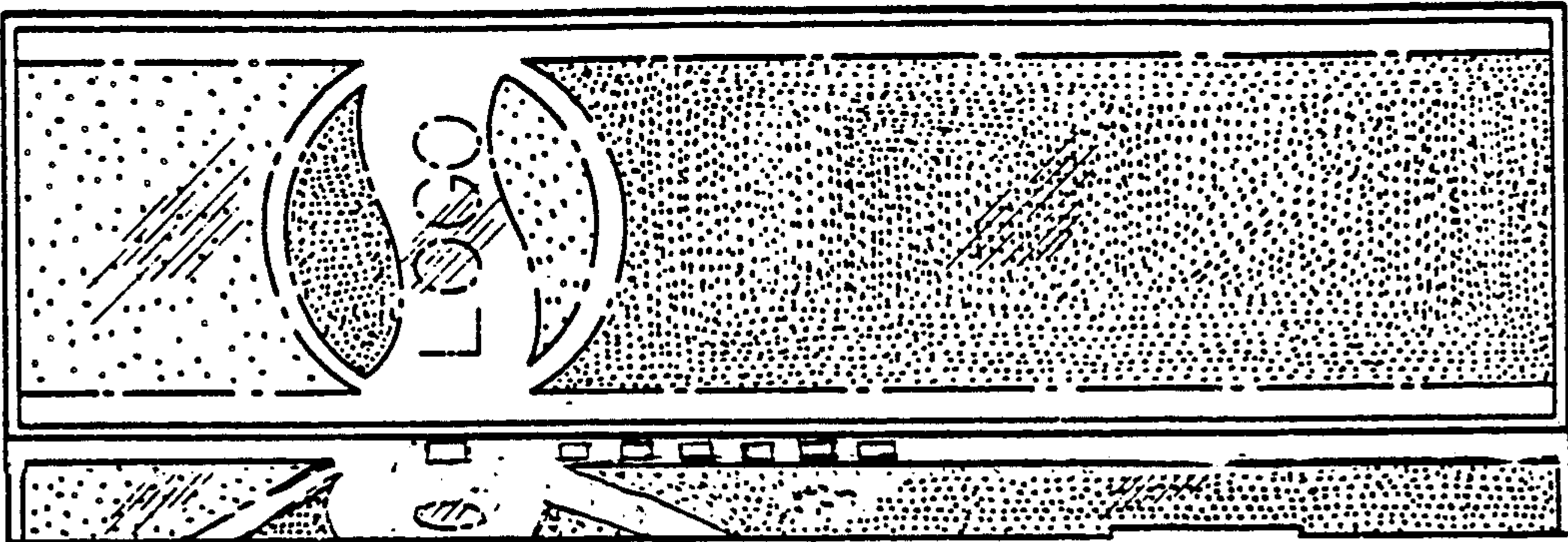

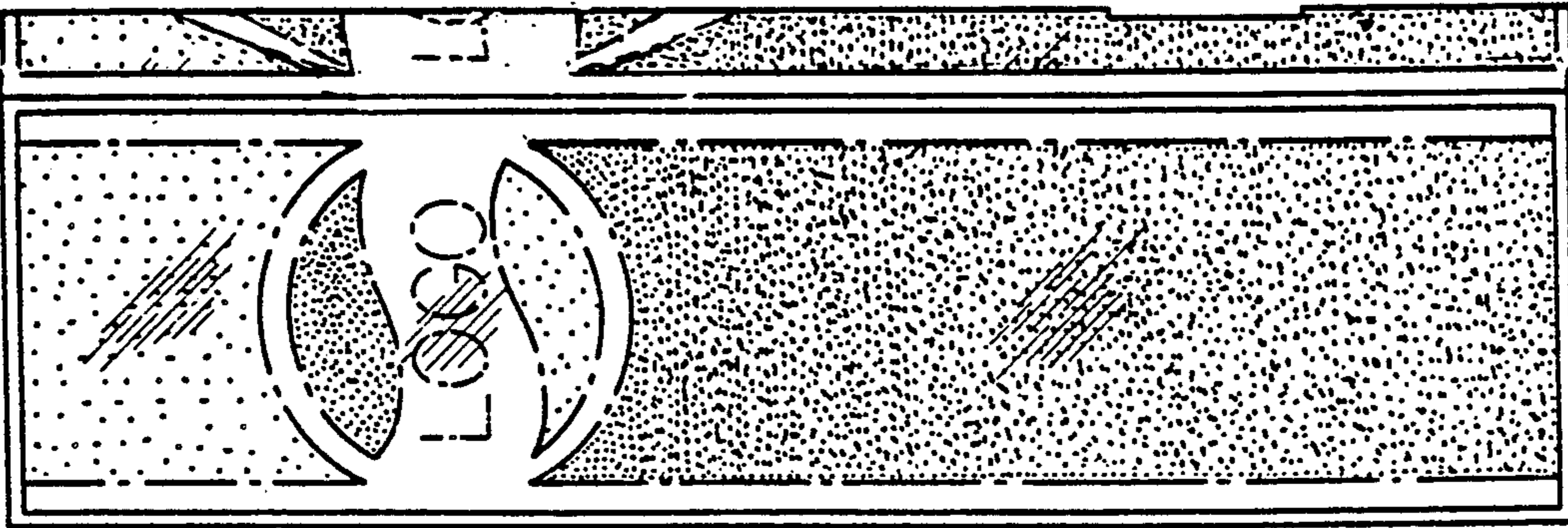
