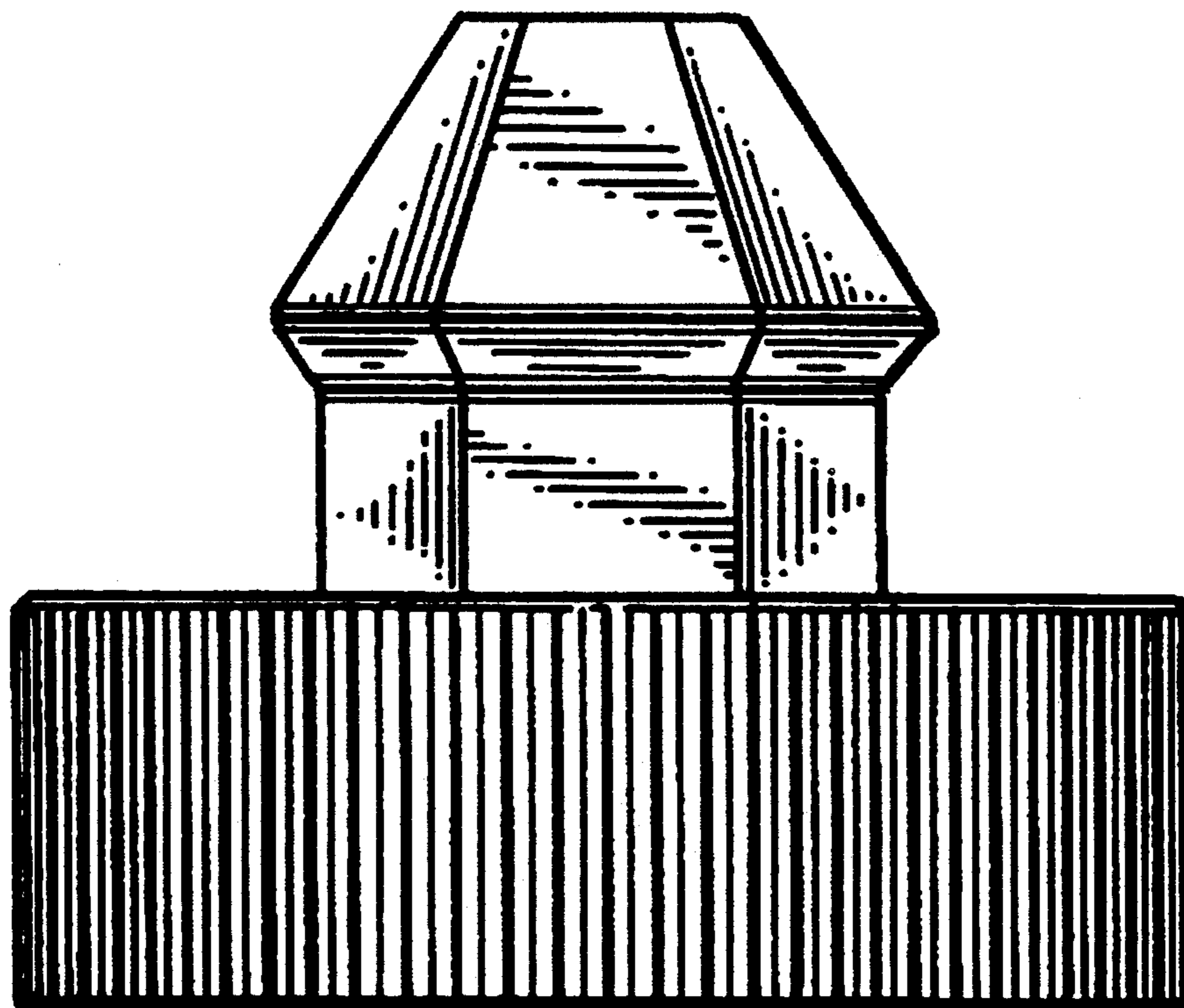

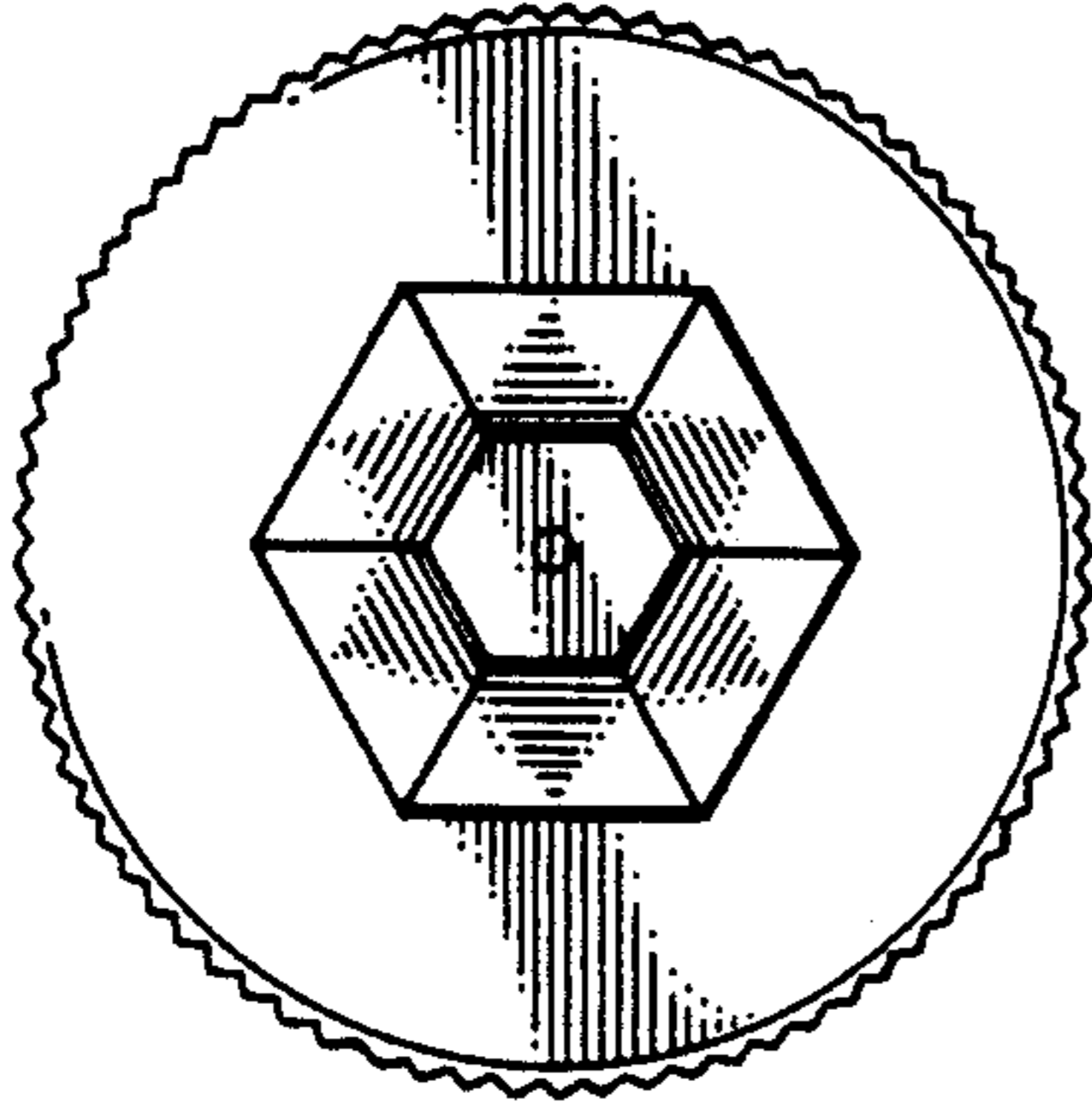
The ornamental design for bottle closure, as shown and described.

DESCRIPTION

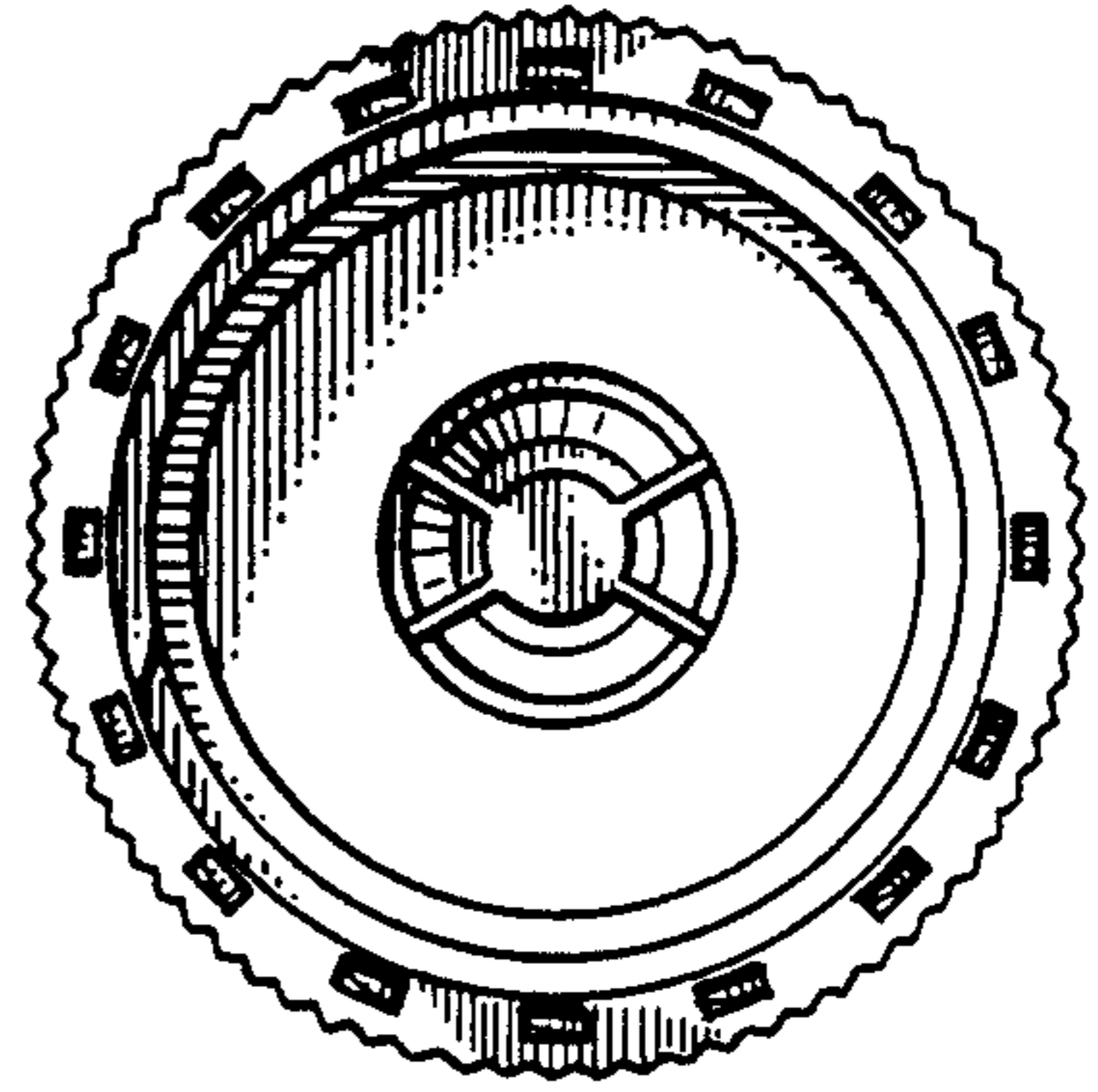
FIG. 1 is a top plan view of a bottle closure showing my new design;

FIG. 5 is a front elevation view thereof, in an open position.



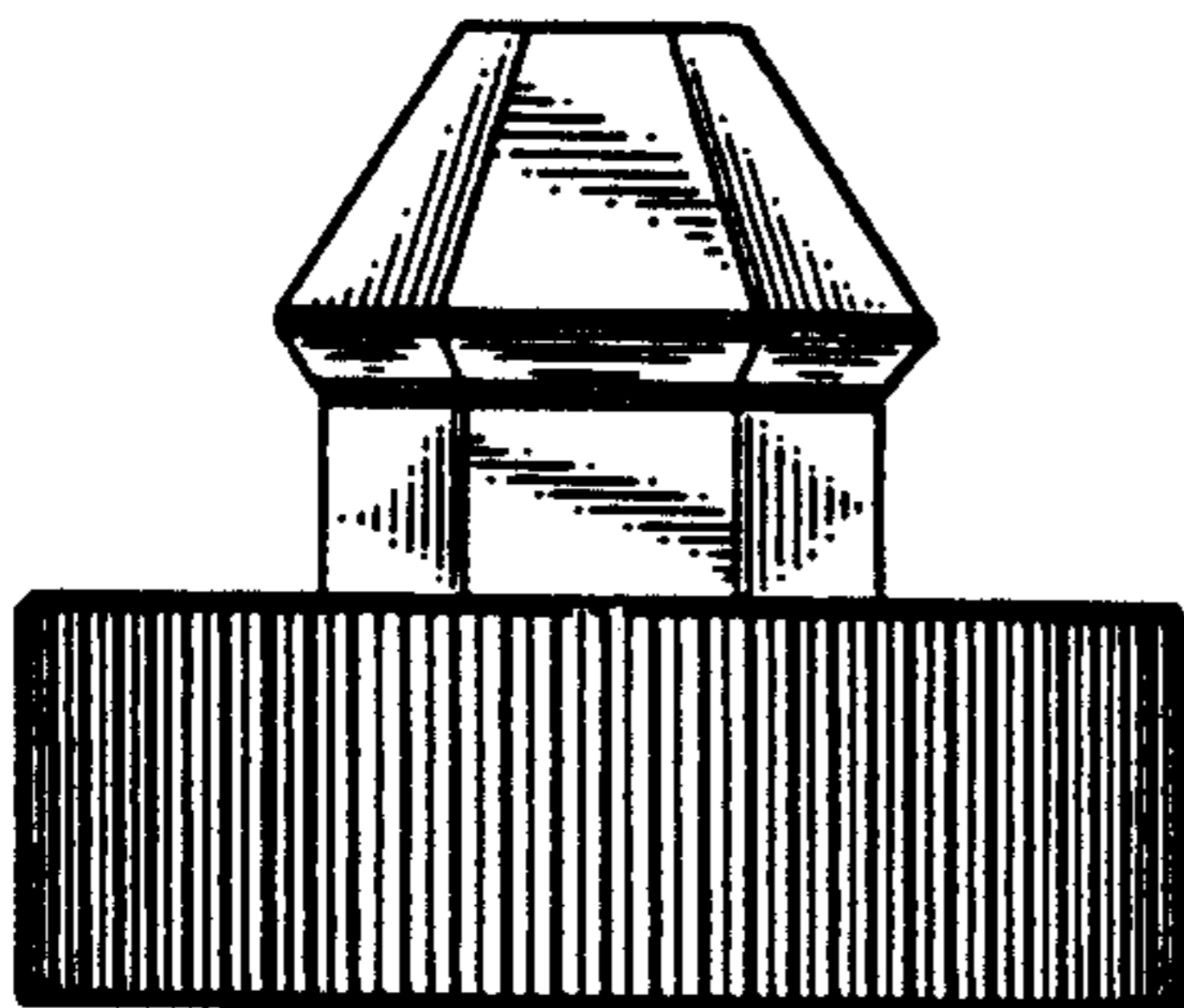

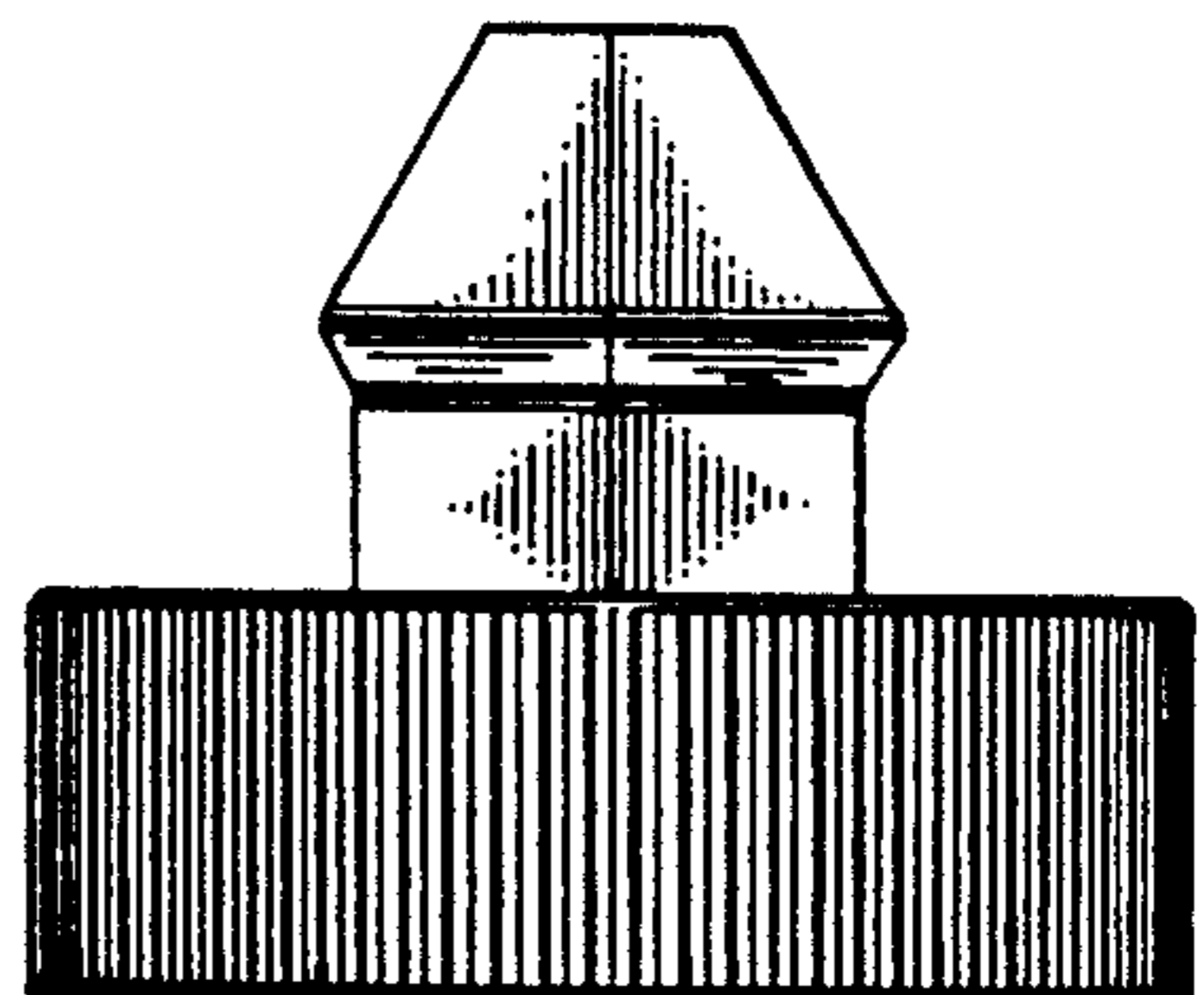
