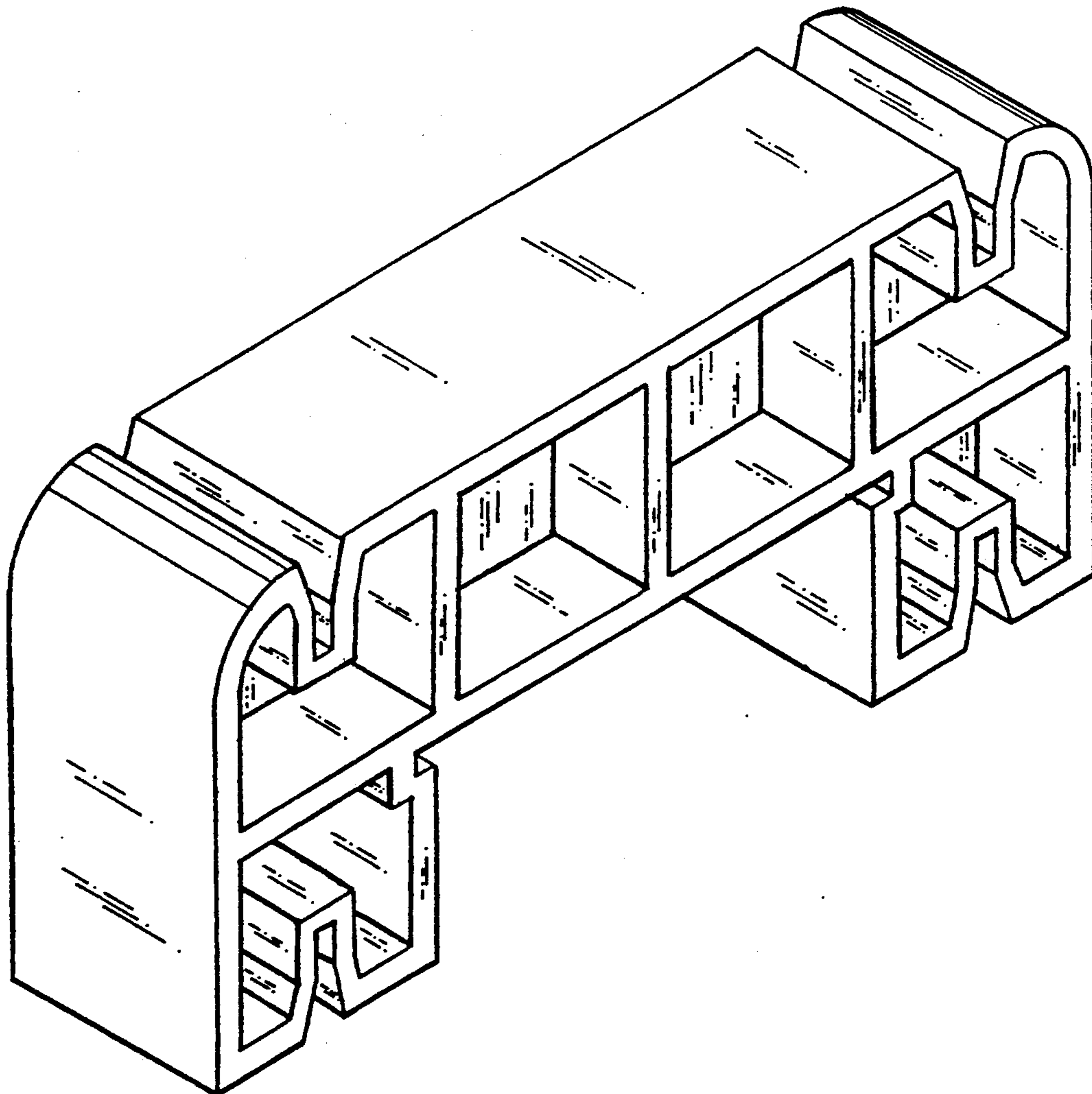

[57] **CLAIM**

The ornamental design for a masonry line block, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and left side perspective view of a masonry line block showing my new design;  
 FIG. 2 is a top plan view;  
 FIG. 3 is a bottom plan view;  
 FIG. 4 is a front elevational view, the rear elevational view being substantially flat, plain, and unornamented;  
 FIG. 5 is a right side elevational view;  
 FIG. 6 is a cross-sectional view as taken from line 6—6 of FIG. 4;  
 FIG. 7 is a cross-sectional view as taken from line 7—7 of FIG. 4;  
 FIG. 8 is a top, front, and left side perspective view of another embodiment of my new design of FIGS. 1-7;  
 FIG. 9 is a top plan view;  
 FIG. 10 is a bottom plan view;  
 FIG. 11 is a front elevational view, the rear elevational view being substantially flat, plain, and unornamented;  
 FIG. 12 is a right side elevational view;  
 FIG. 13 is a cross-sectional view as taken from line 13—13 of FIG. 11; and  
 FIG. 14 is a cross-sectional view as taken from line 14—14 of FIG. 12 thereof.



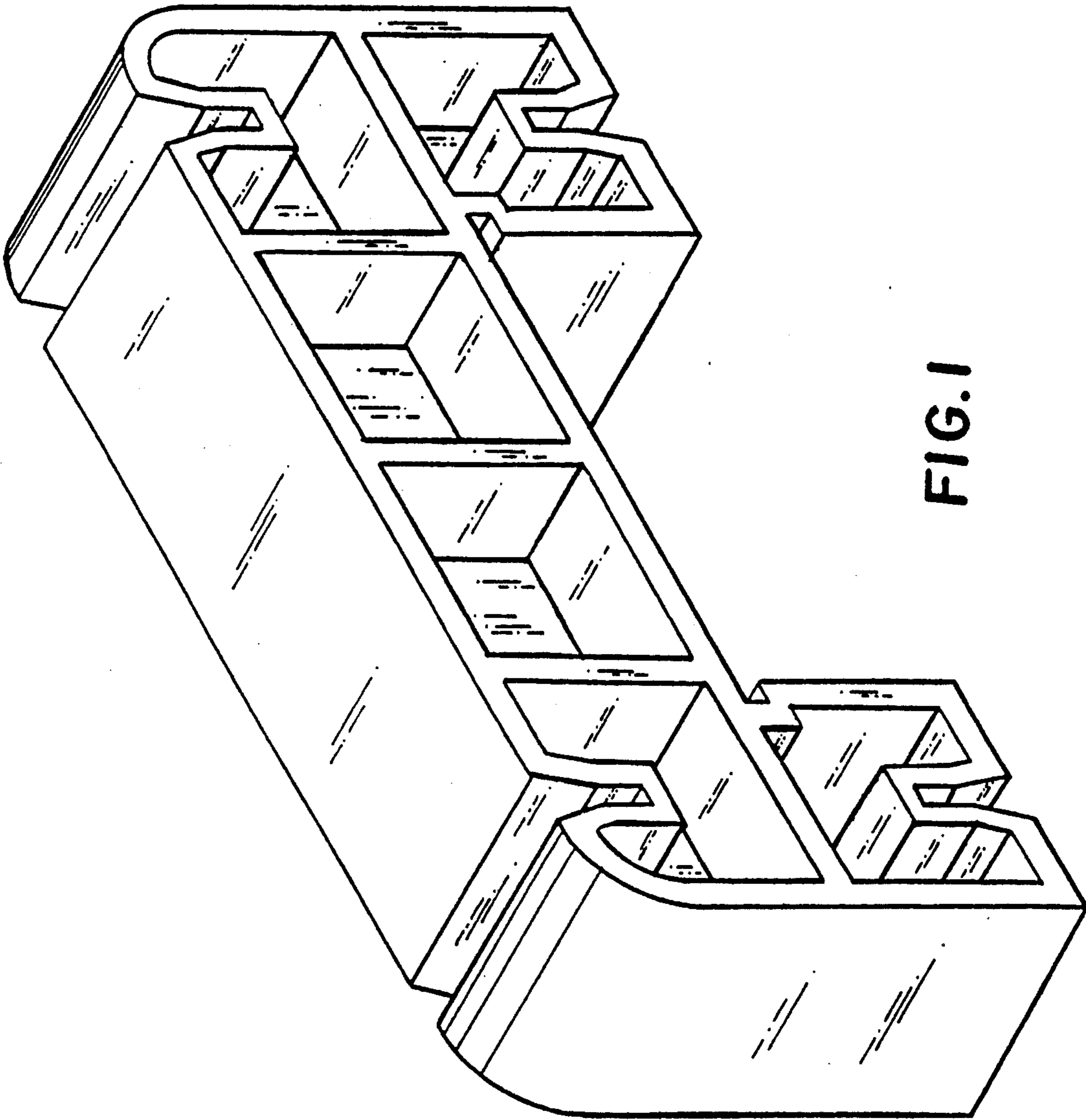

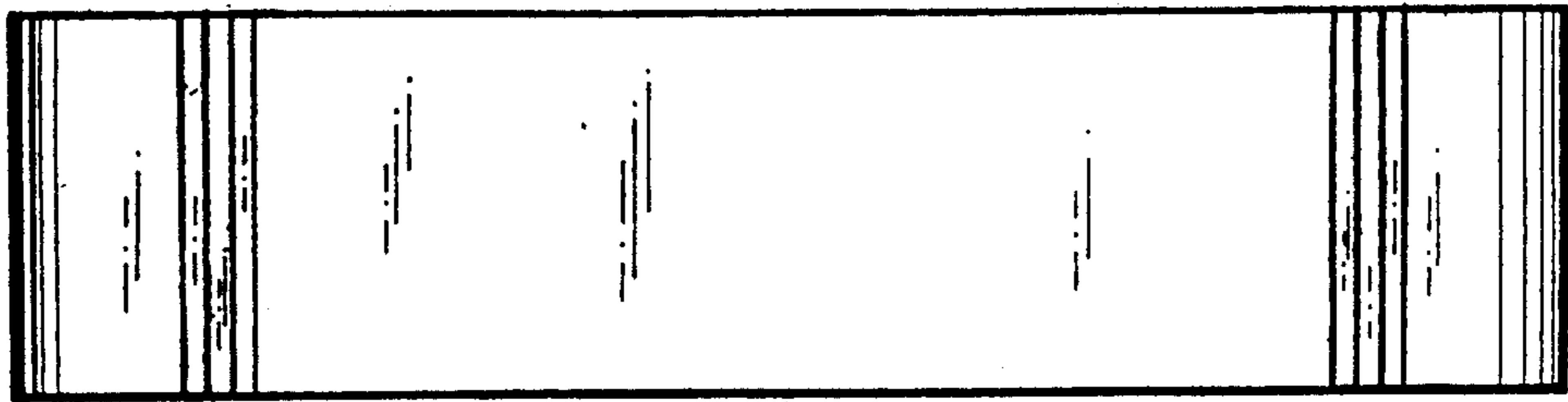

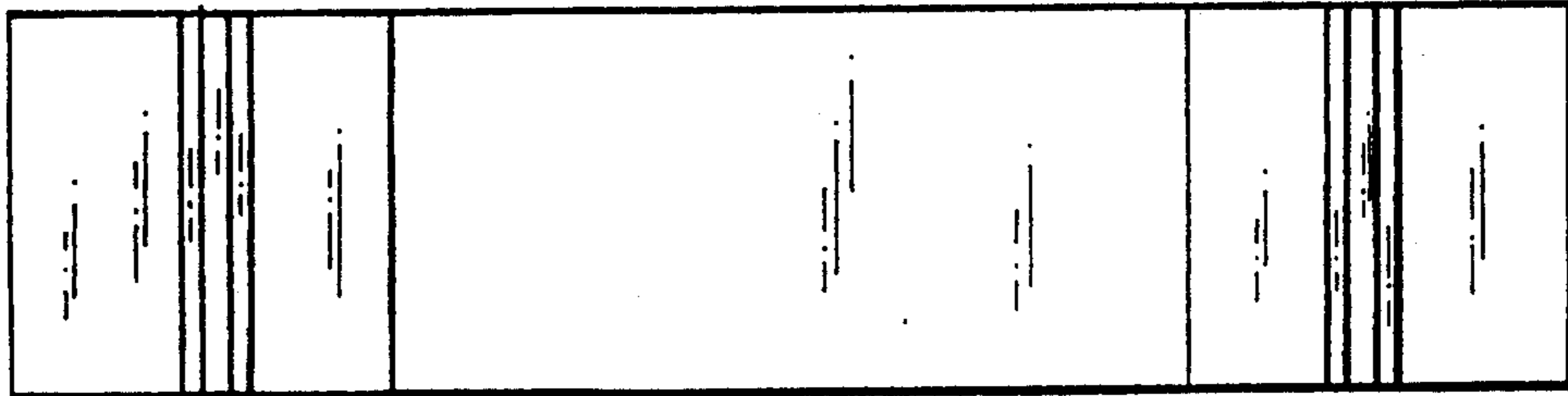

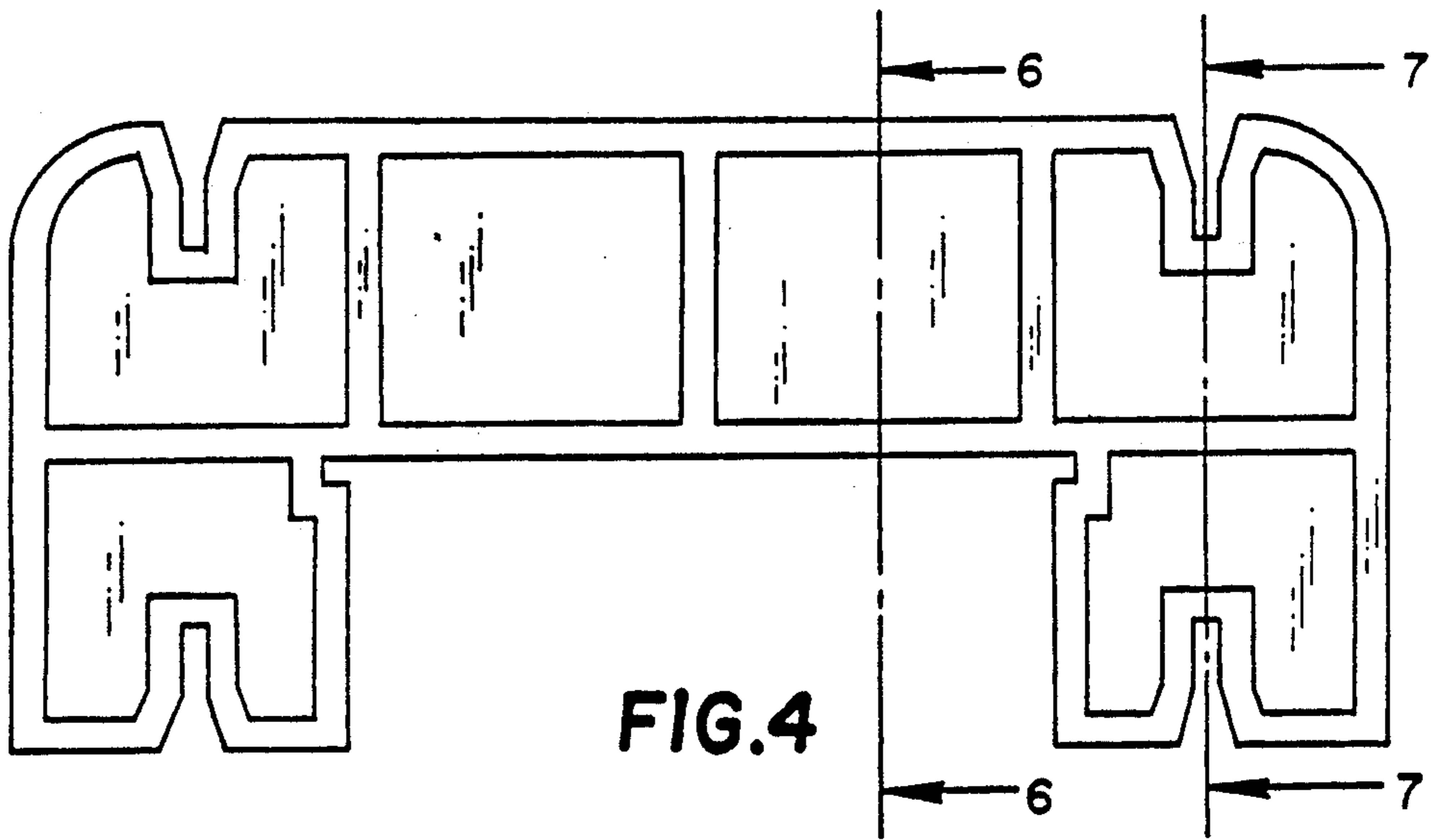

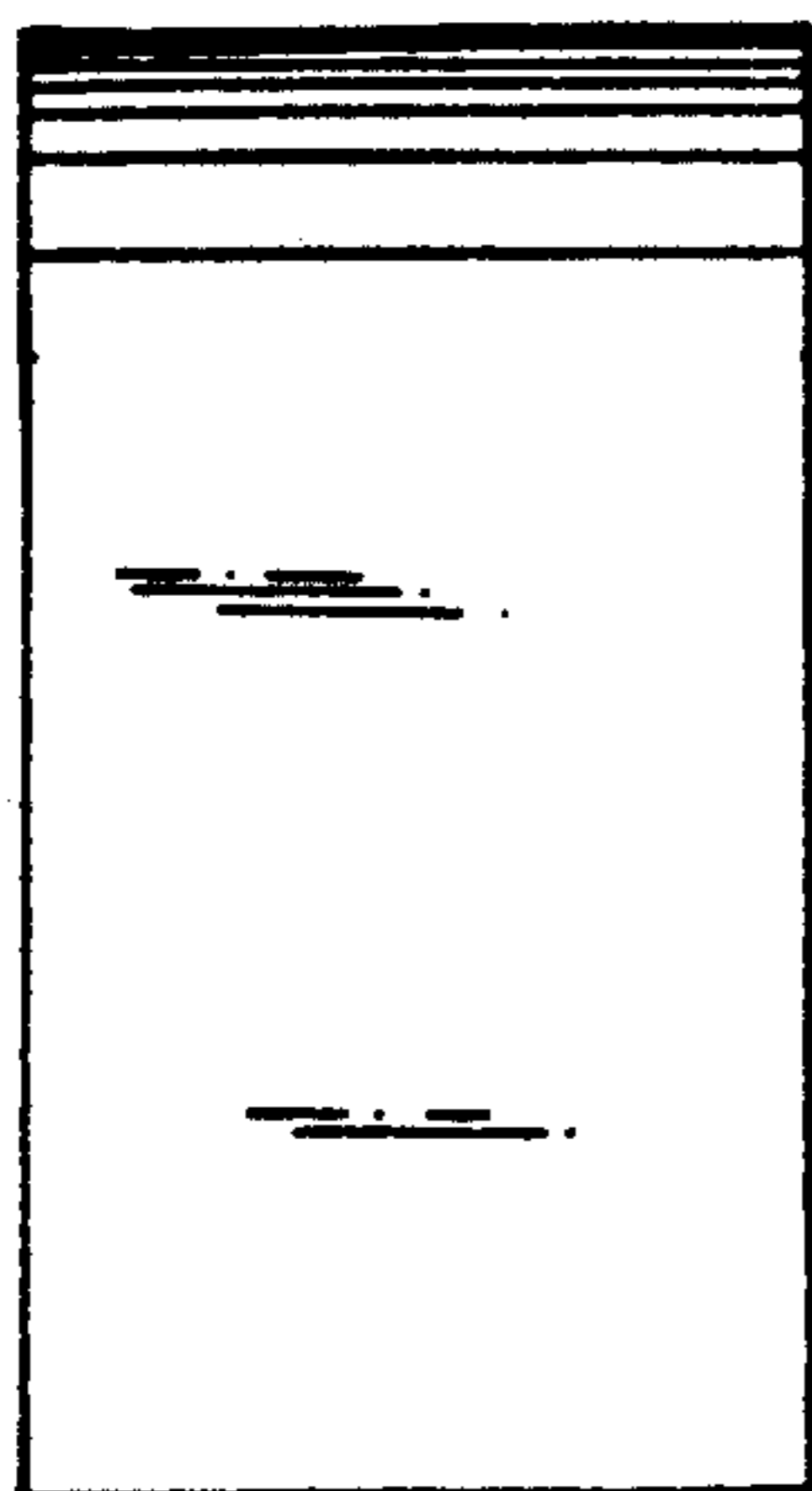

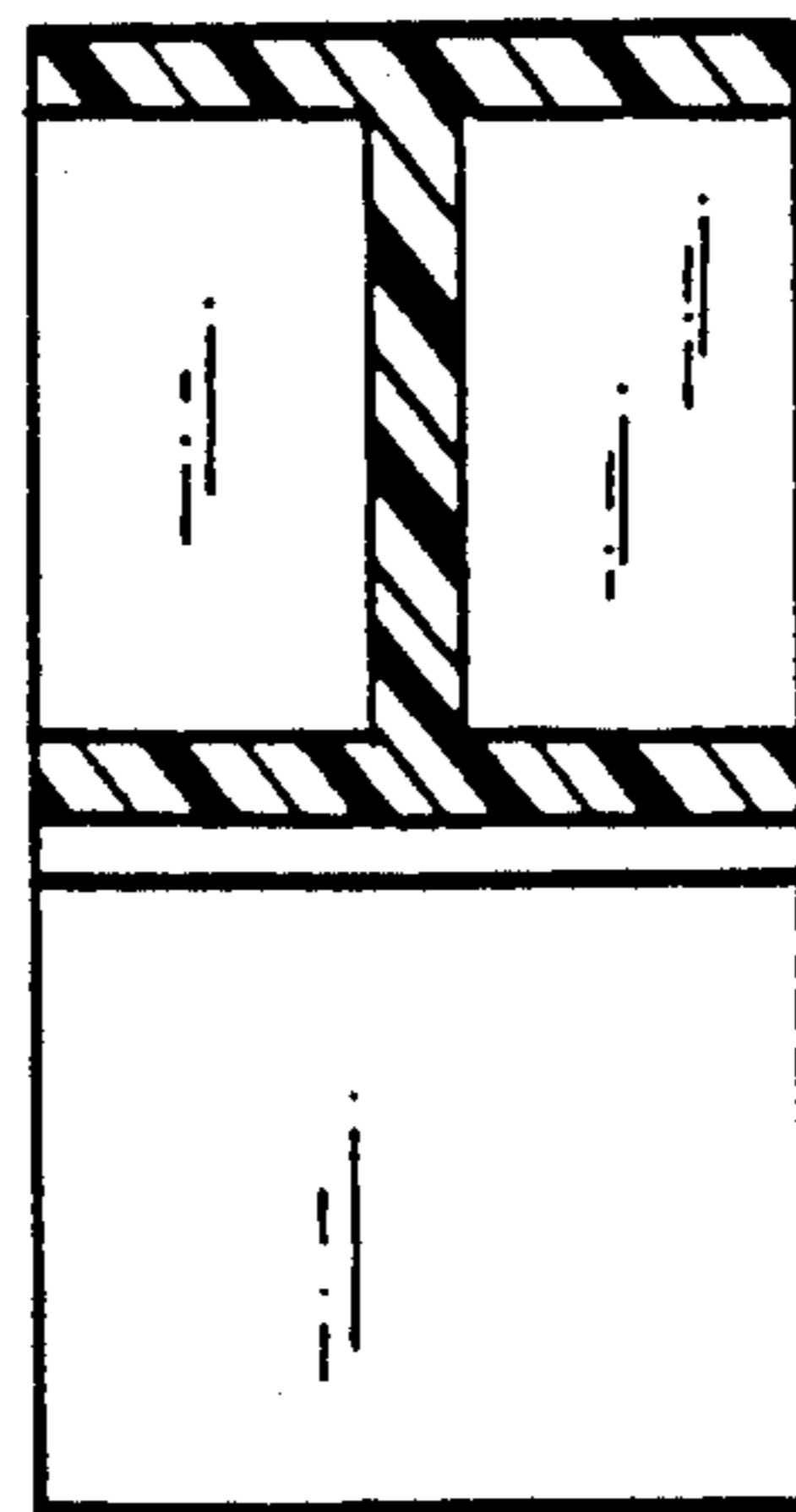

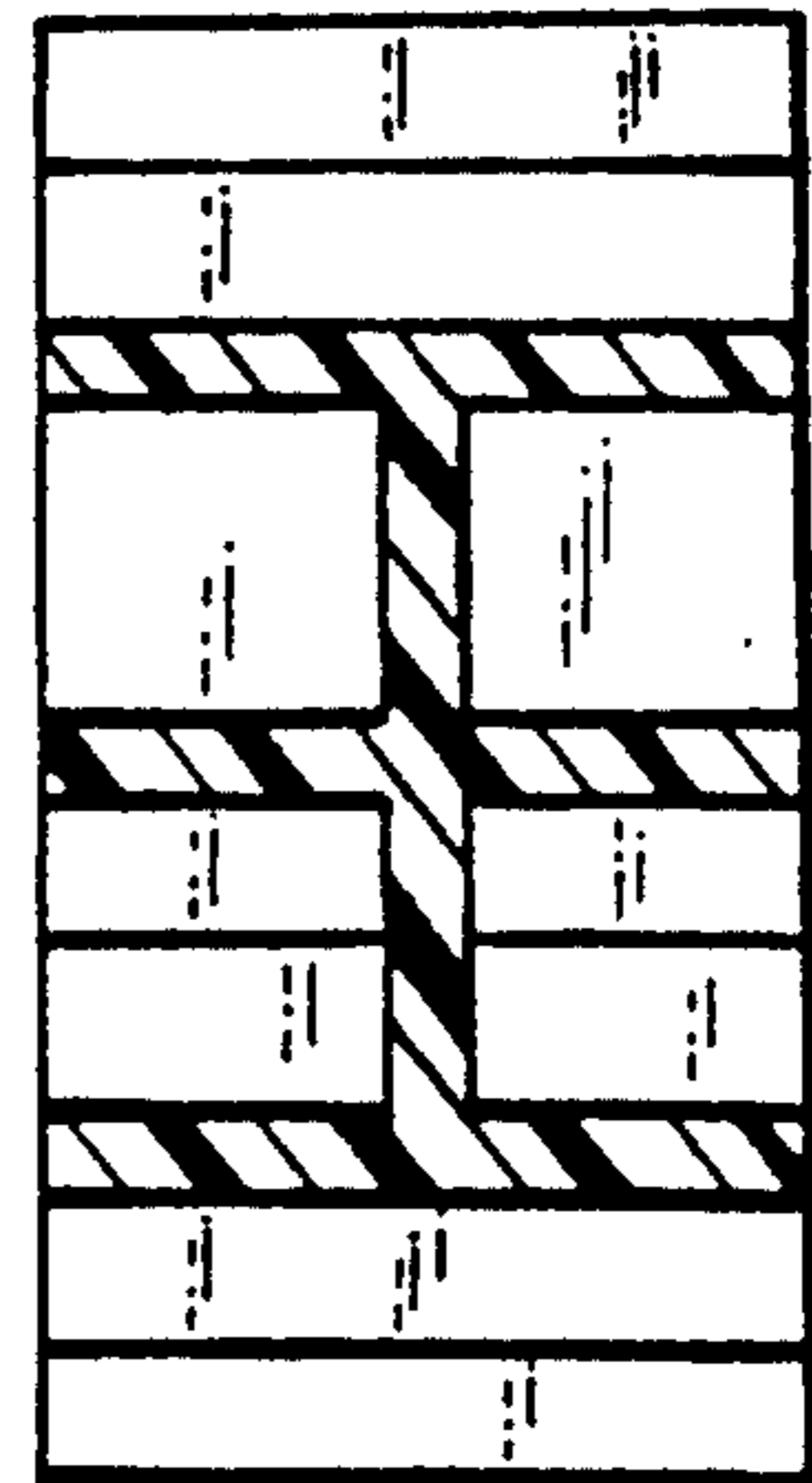

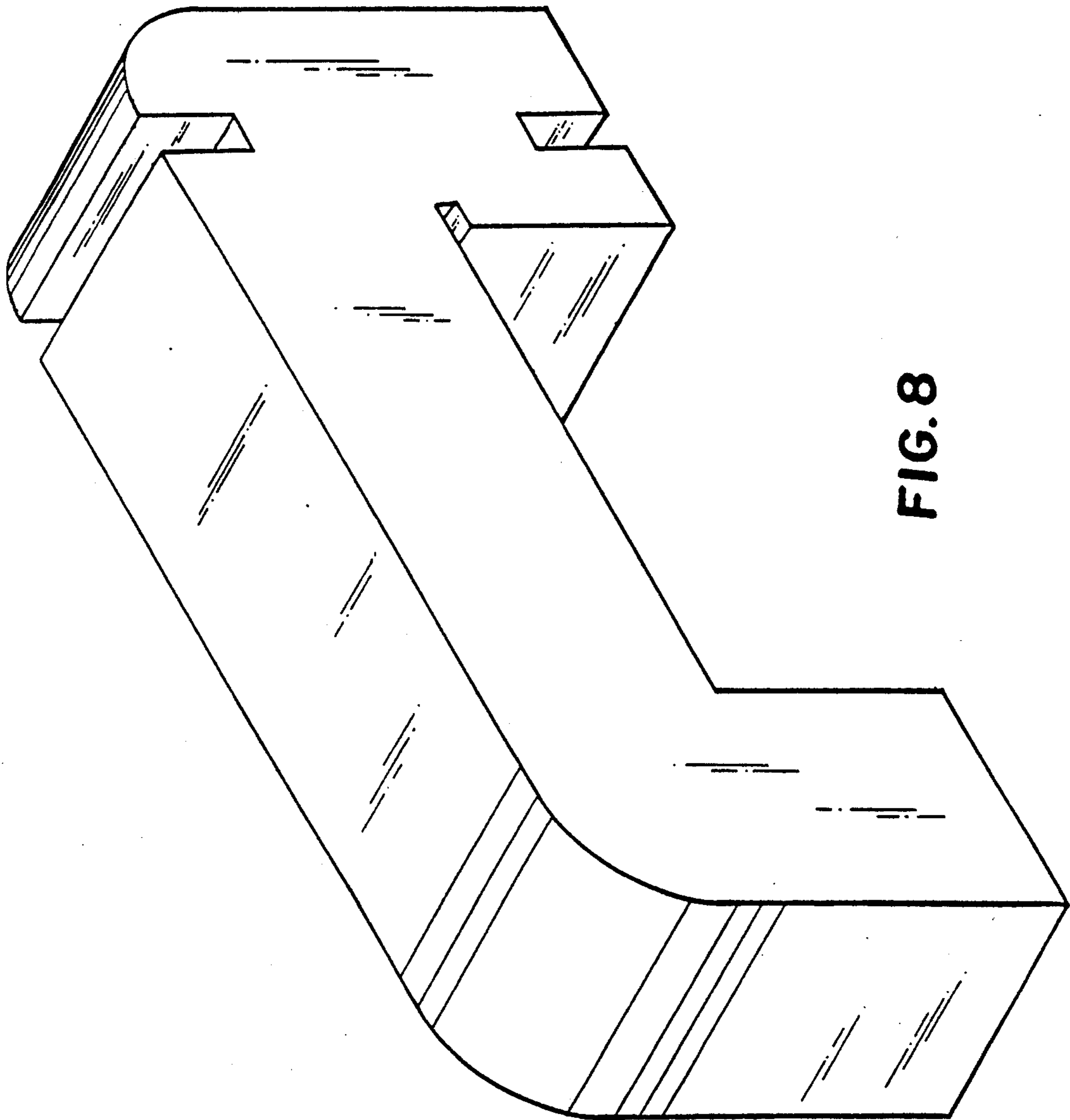

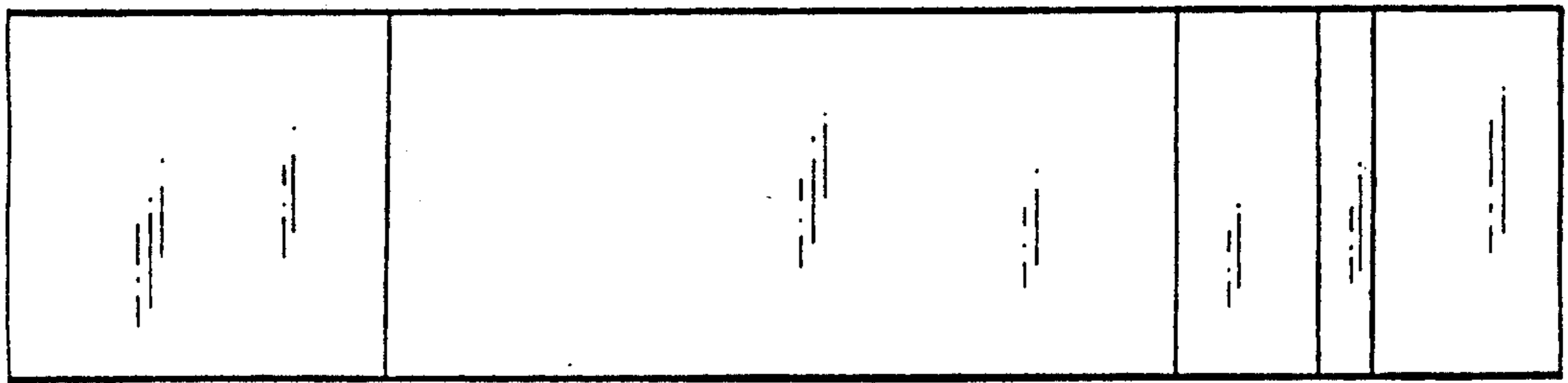

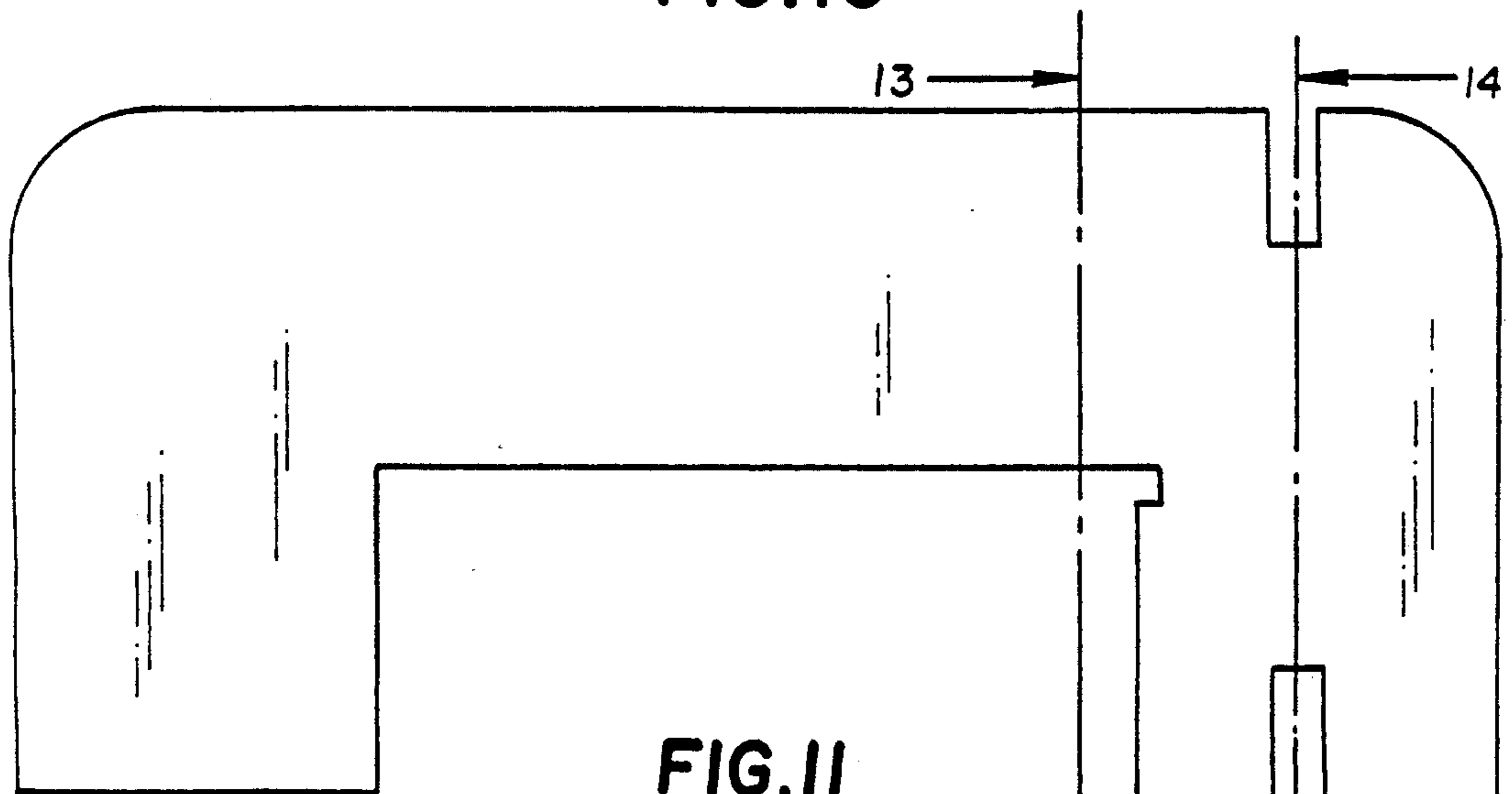

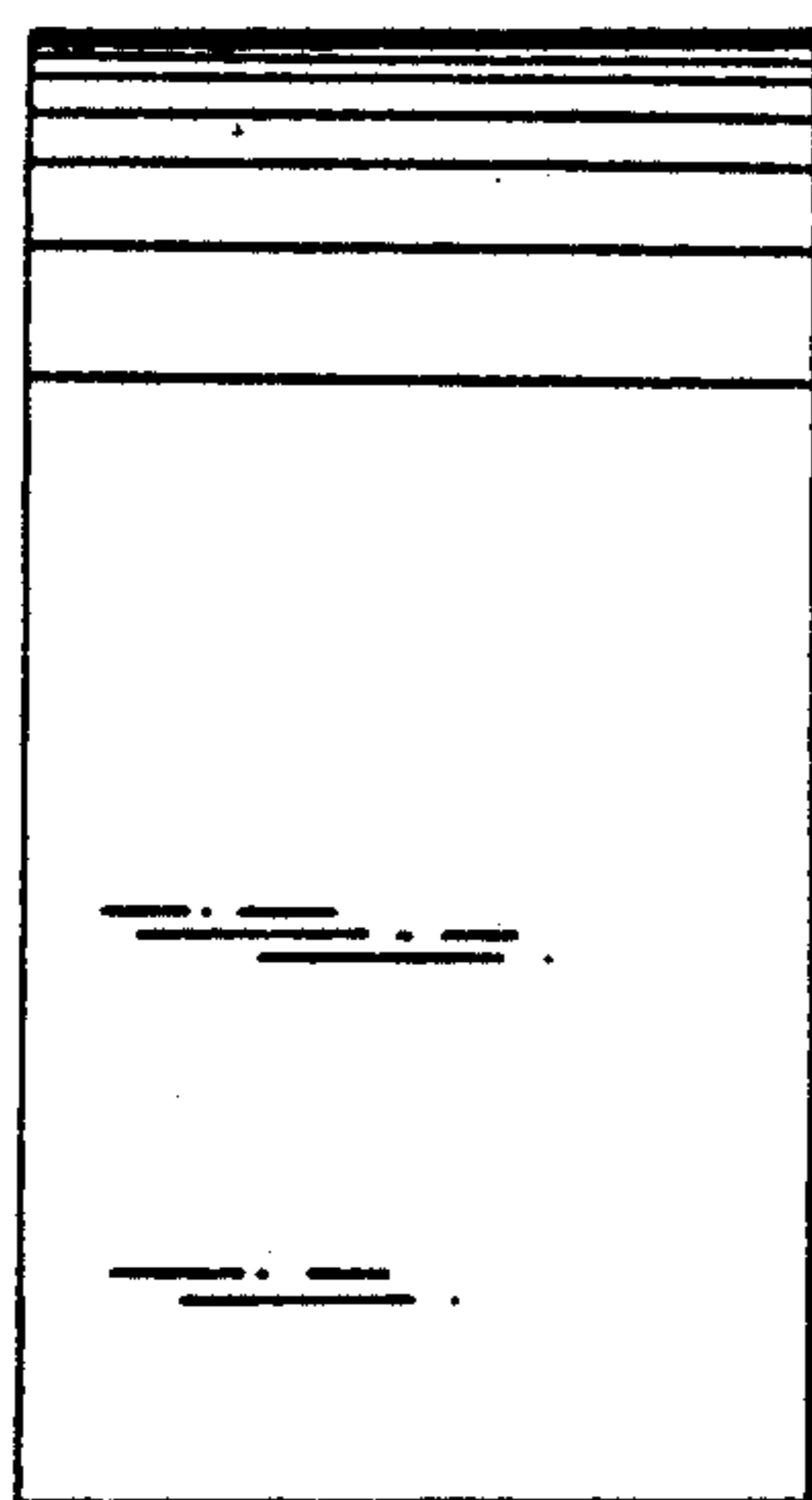

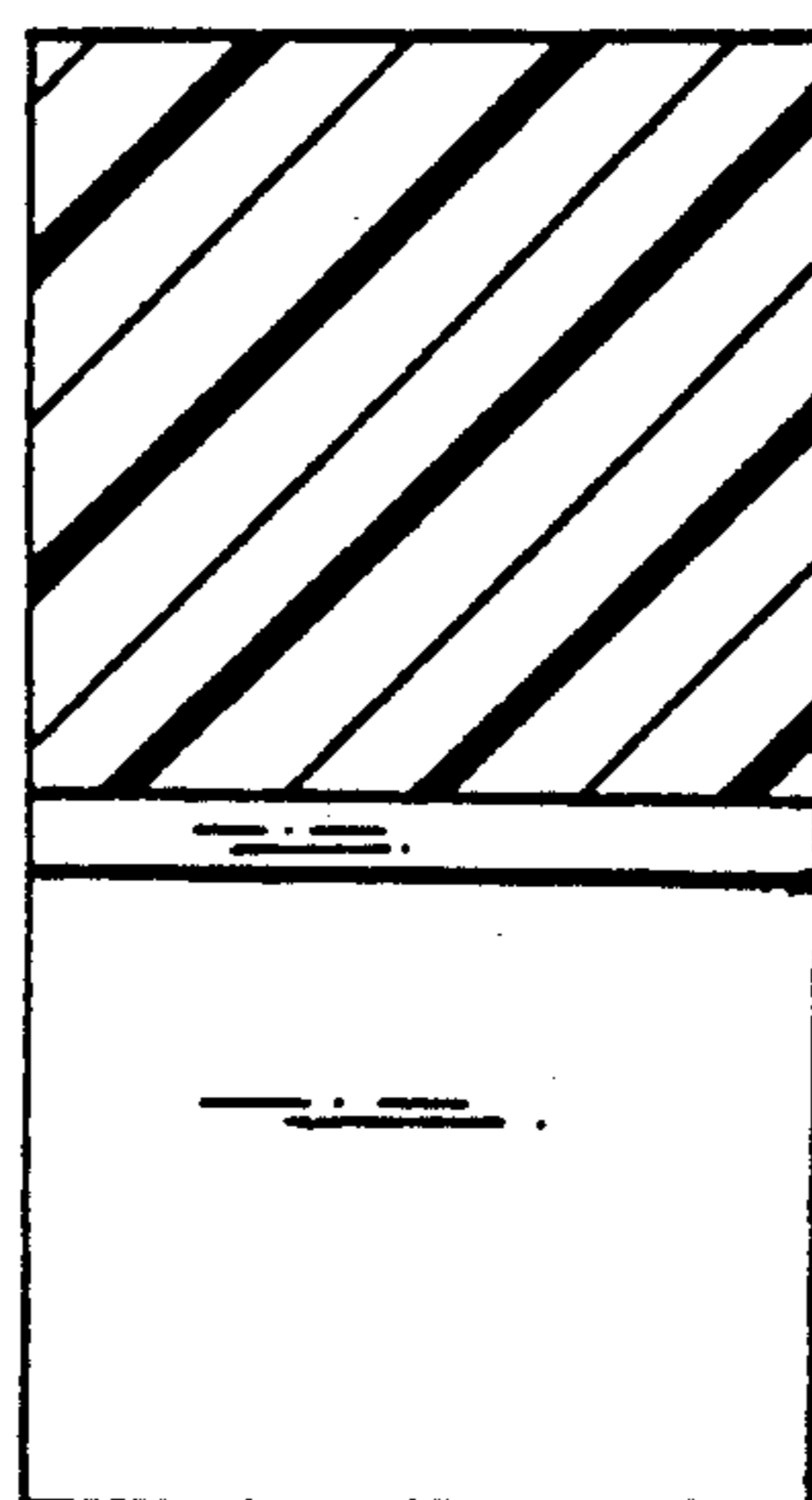

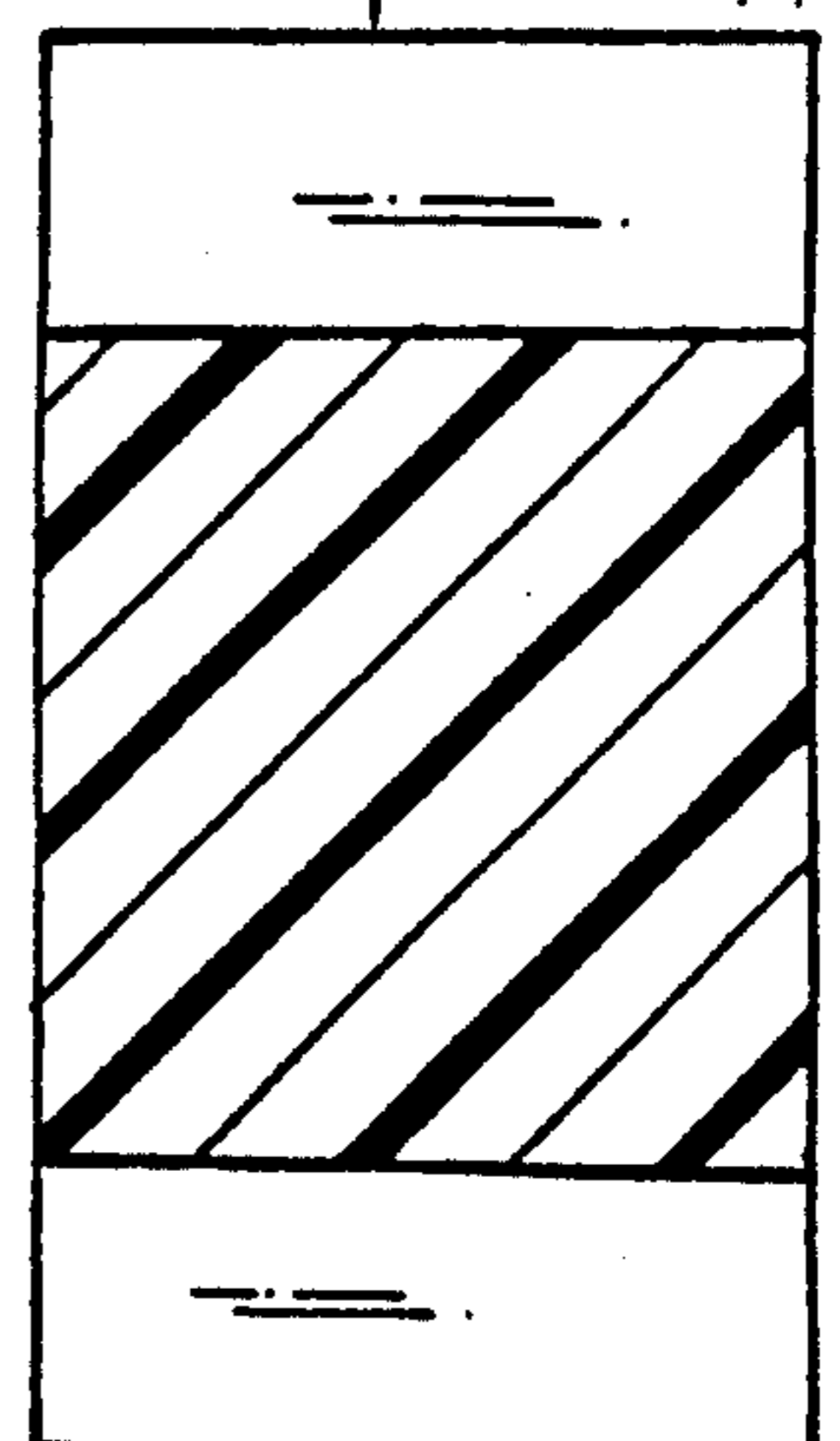
