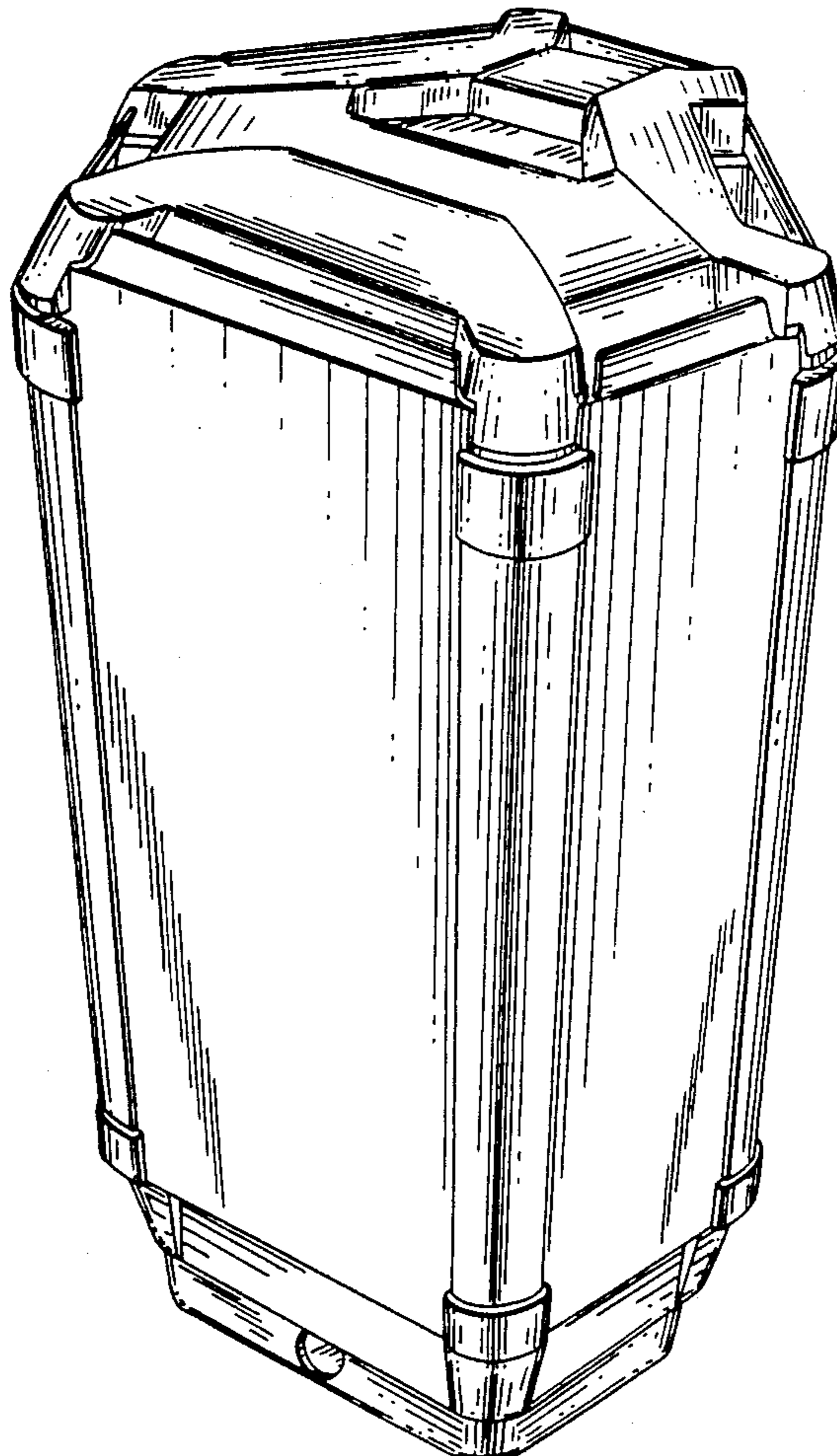

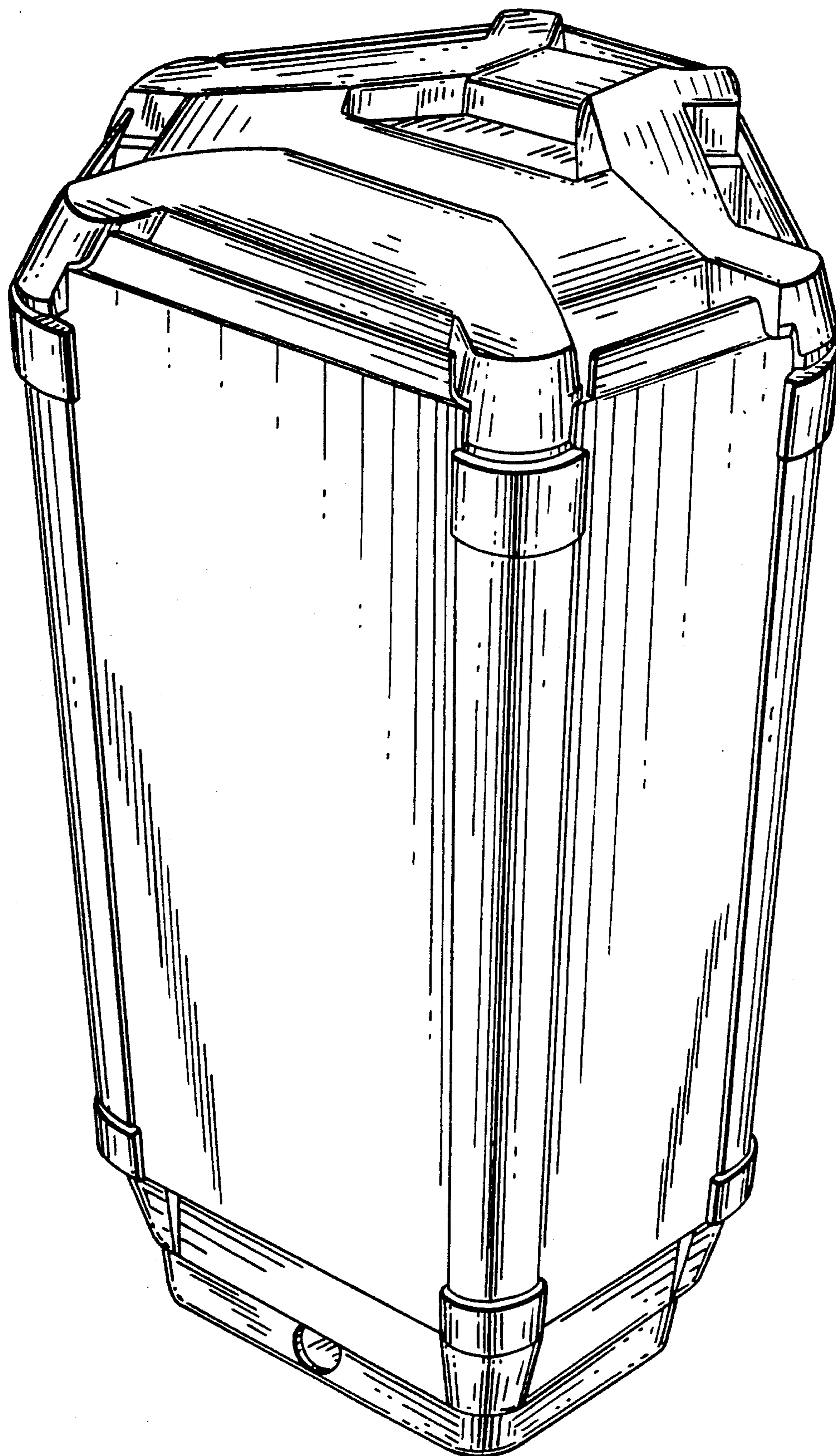
The ornamental design for an environmental chamber for stimulating plant growth, as shown and described.

**DESCRIPTION**

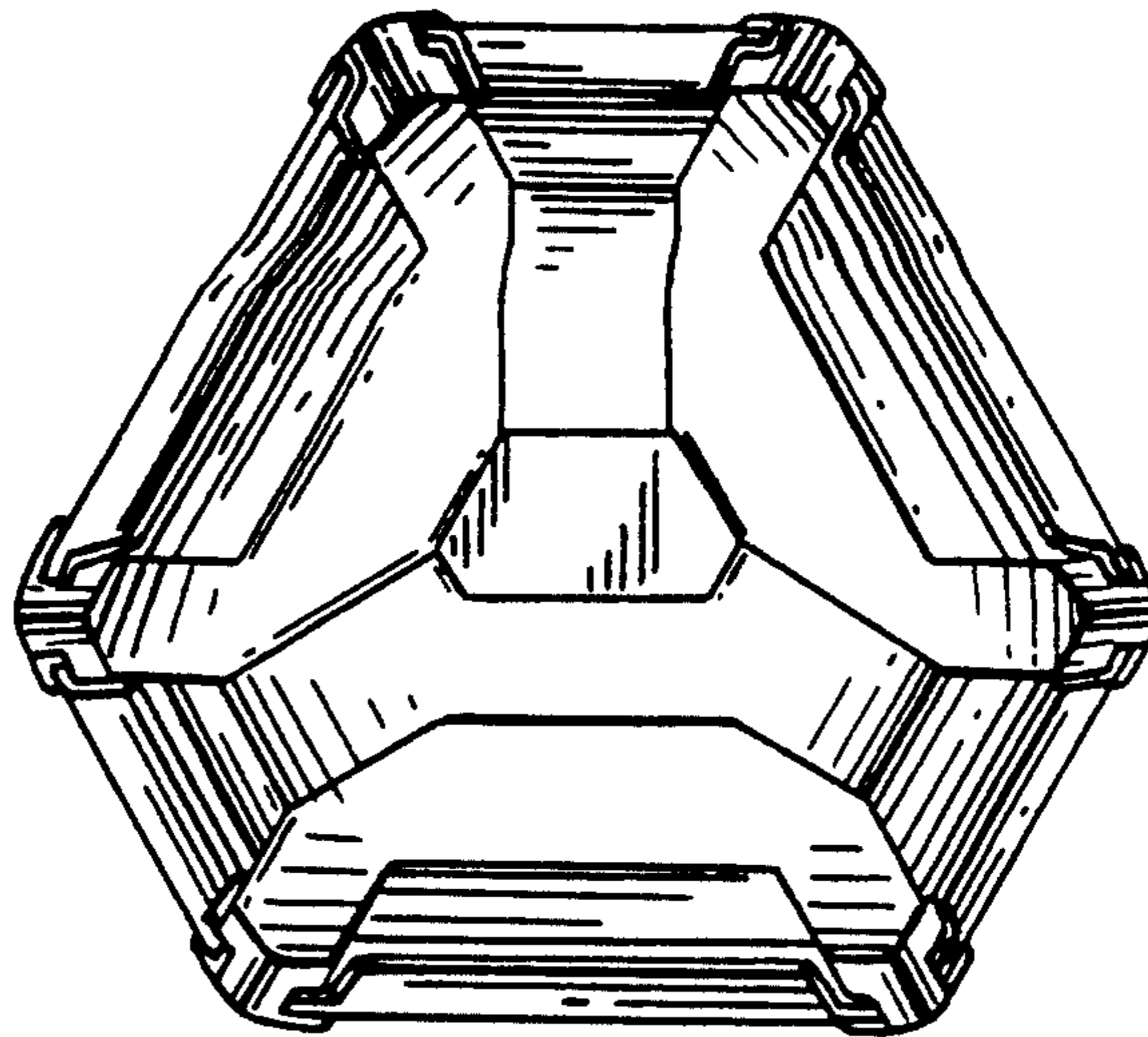
FIG. 1 is a perspective view of an environmental chamber for stimulating plant growth showing my new design;

 FIG. 5 is a reduced bottom plan view thereof.



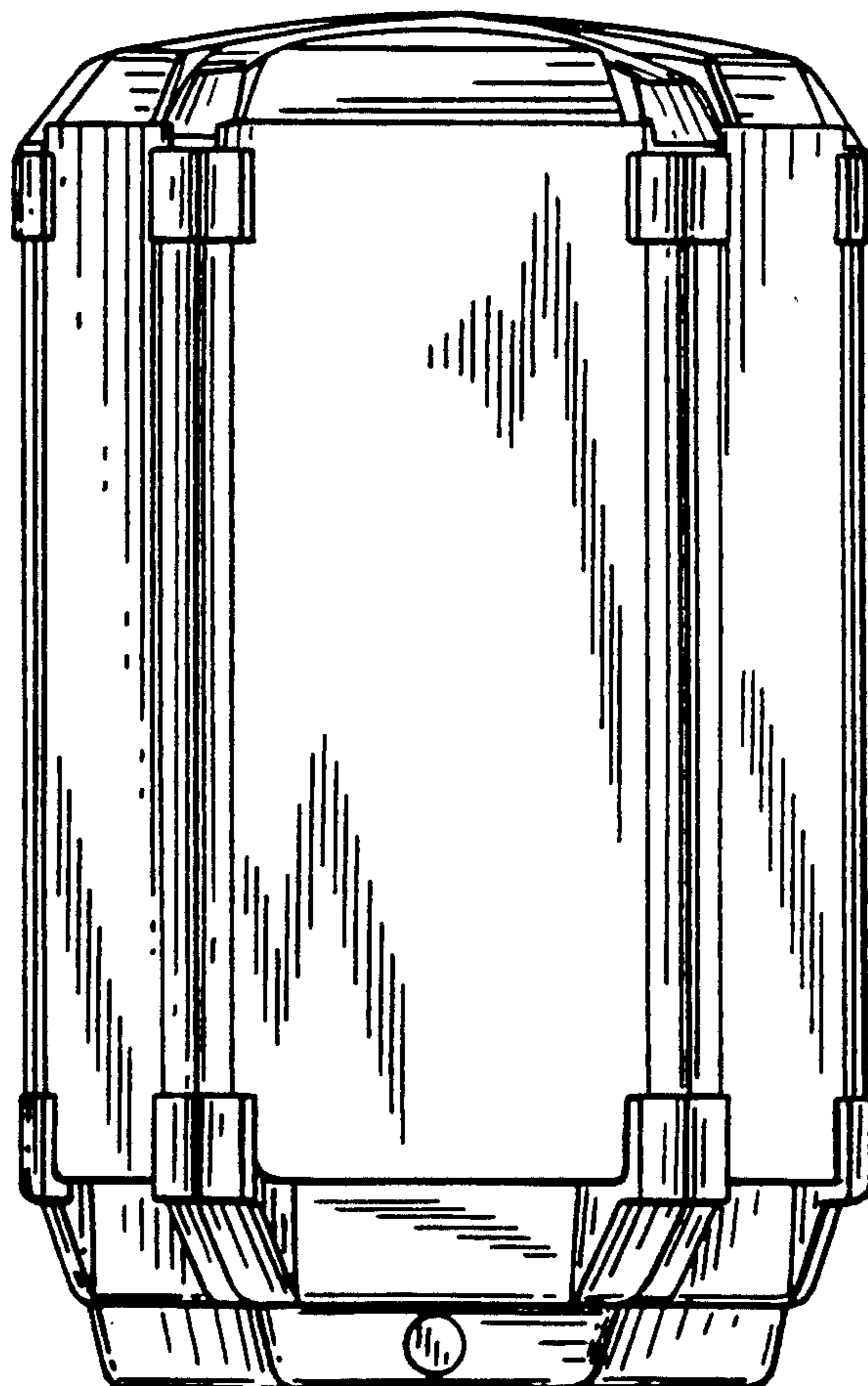

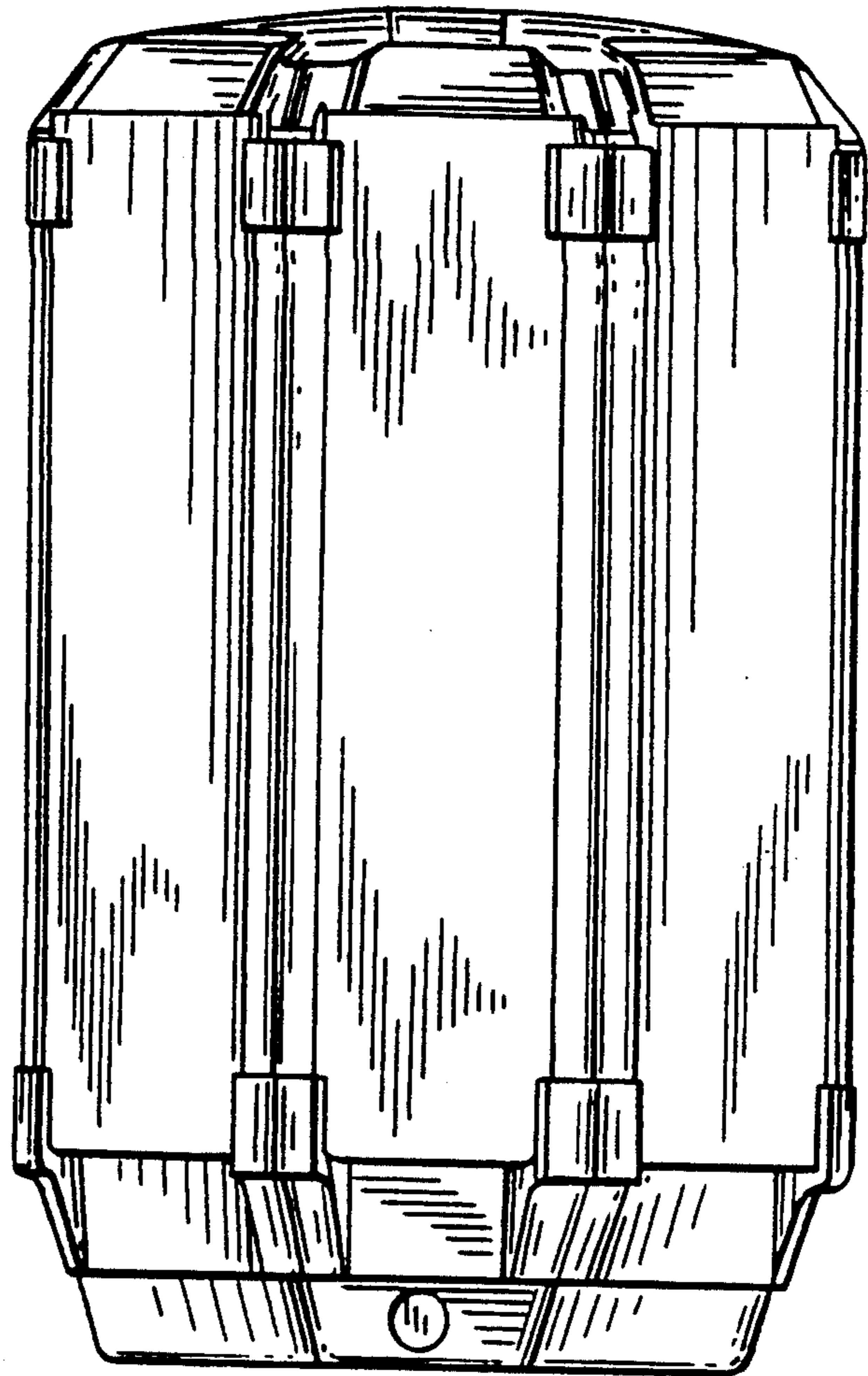
