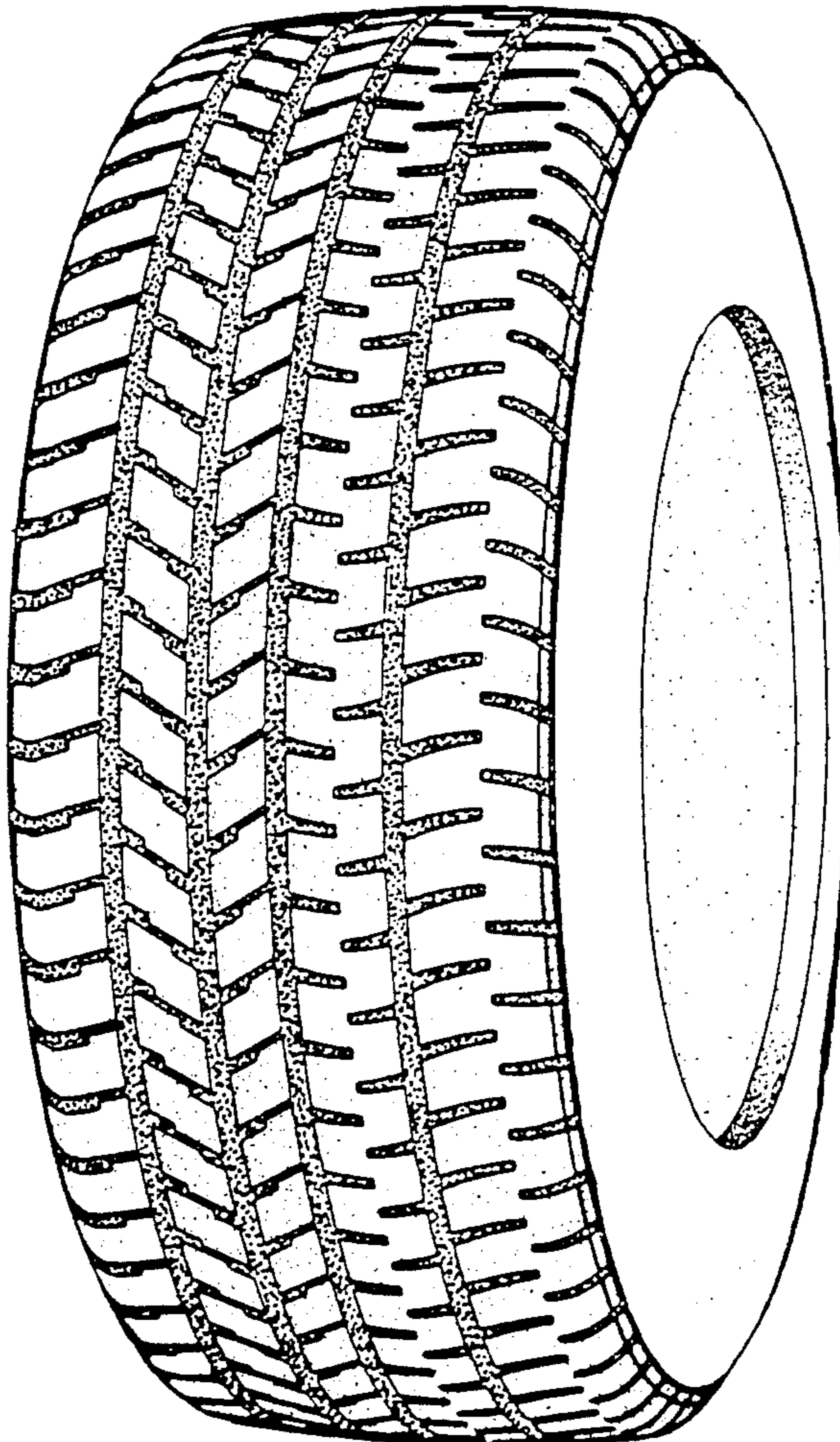

[57] **CLAIM**

The ornamental design for a tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tire showing our new design, it being understood that the tread pattern is repeated throughout the circumference of the tire, the opposite side being substantially the same as that shown; FIG. 2 is a front elevation view thereof; FIG. 3 is a side elevation view thereof on a reduced scale; FIG. 4 is an opposite side elevational view thereof on a reduced scale; and FIG. 5 is an enlarged fragmentary plan view thereof.



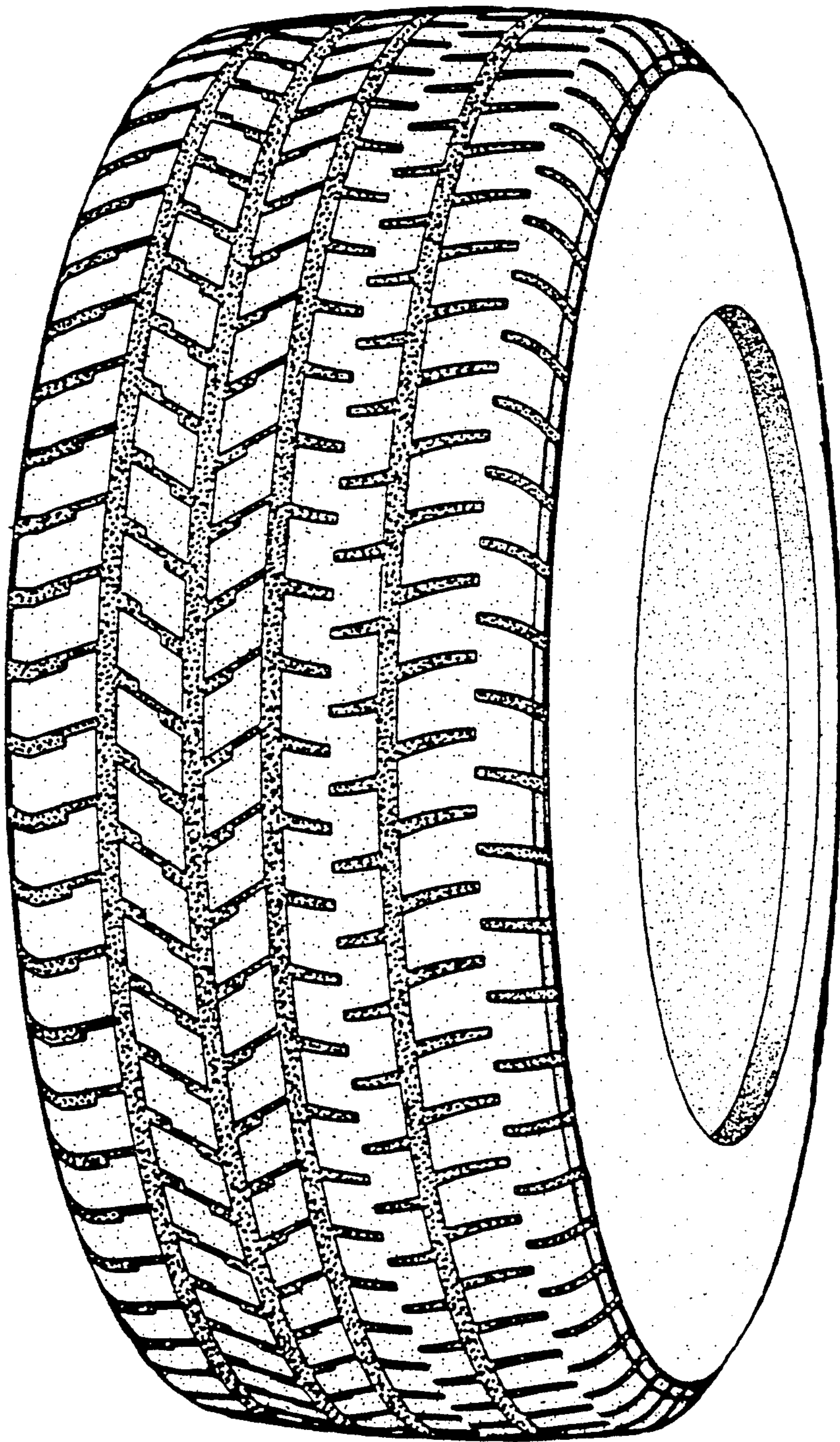

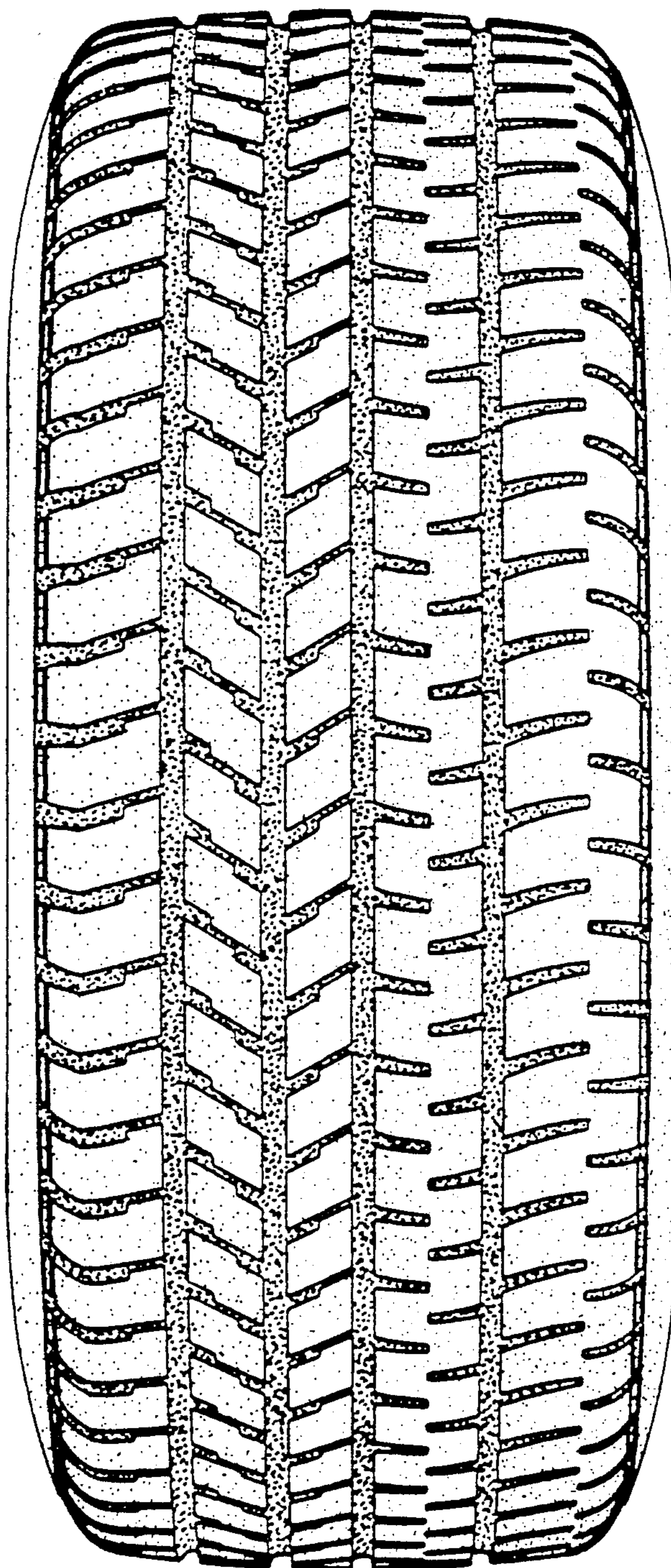

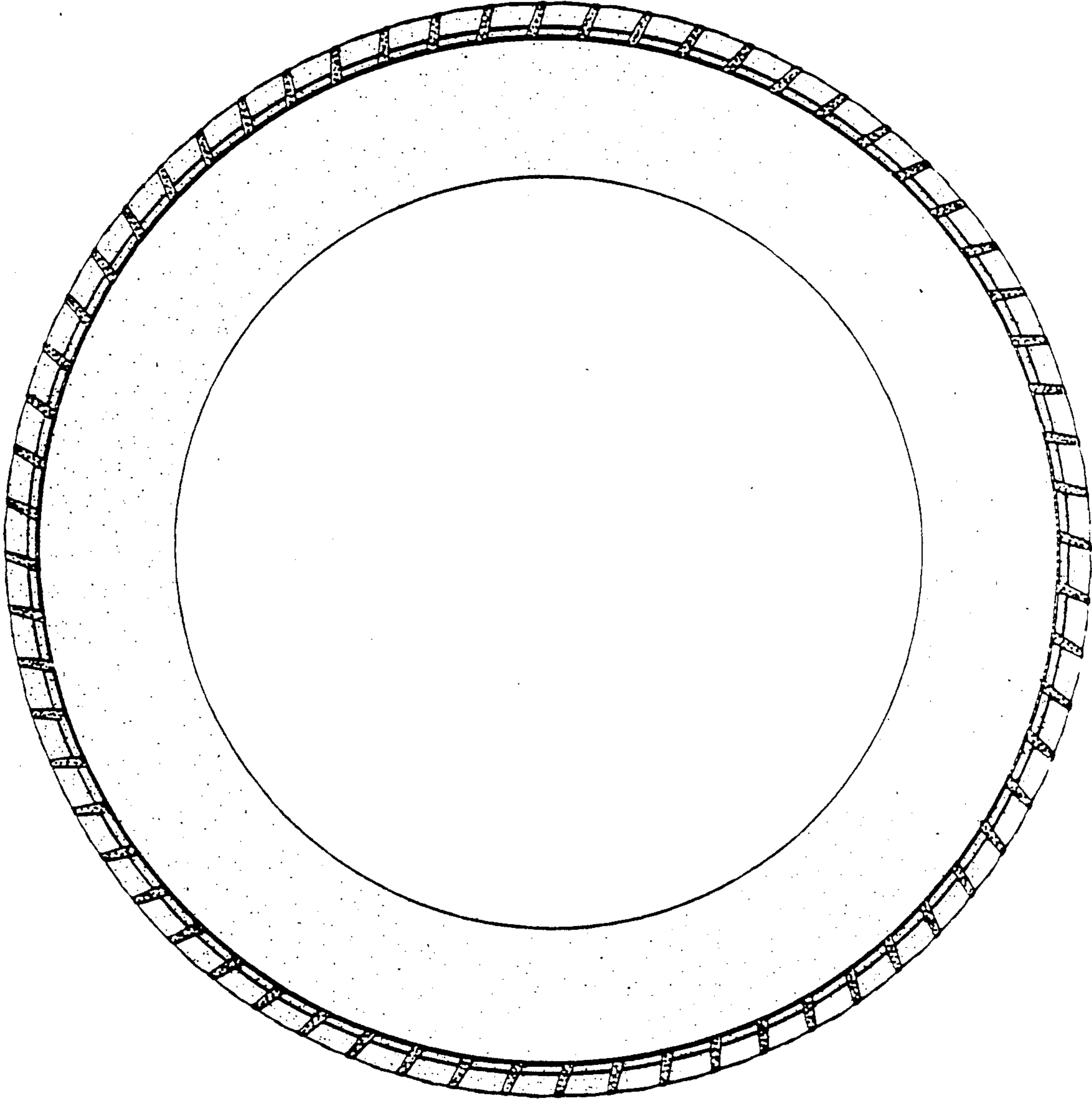

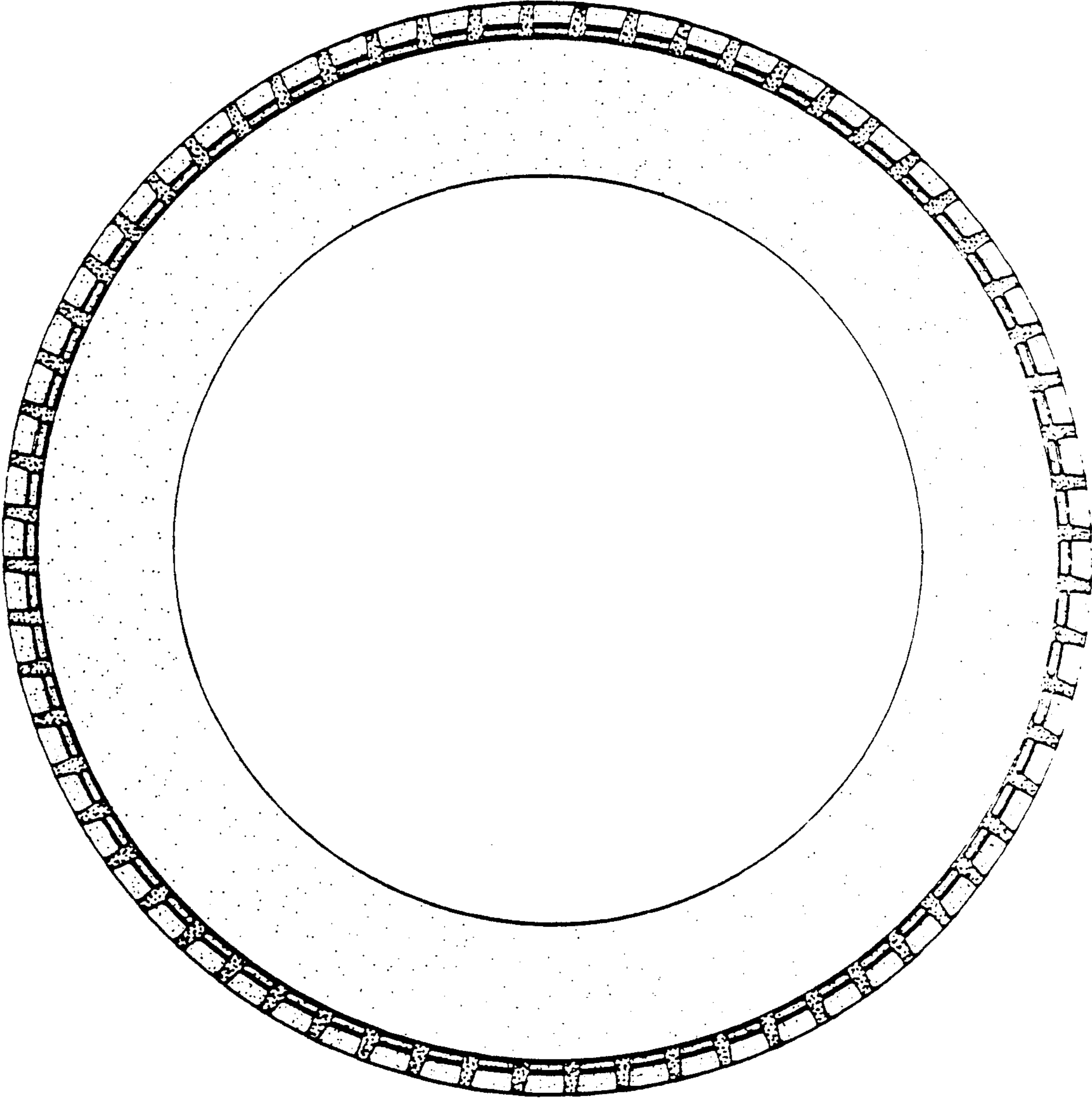

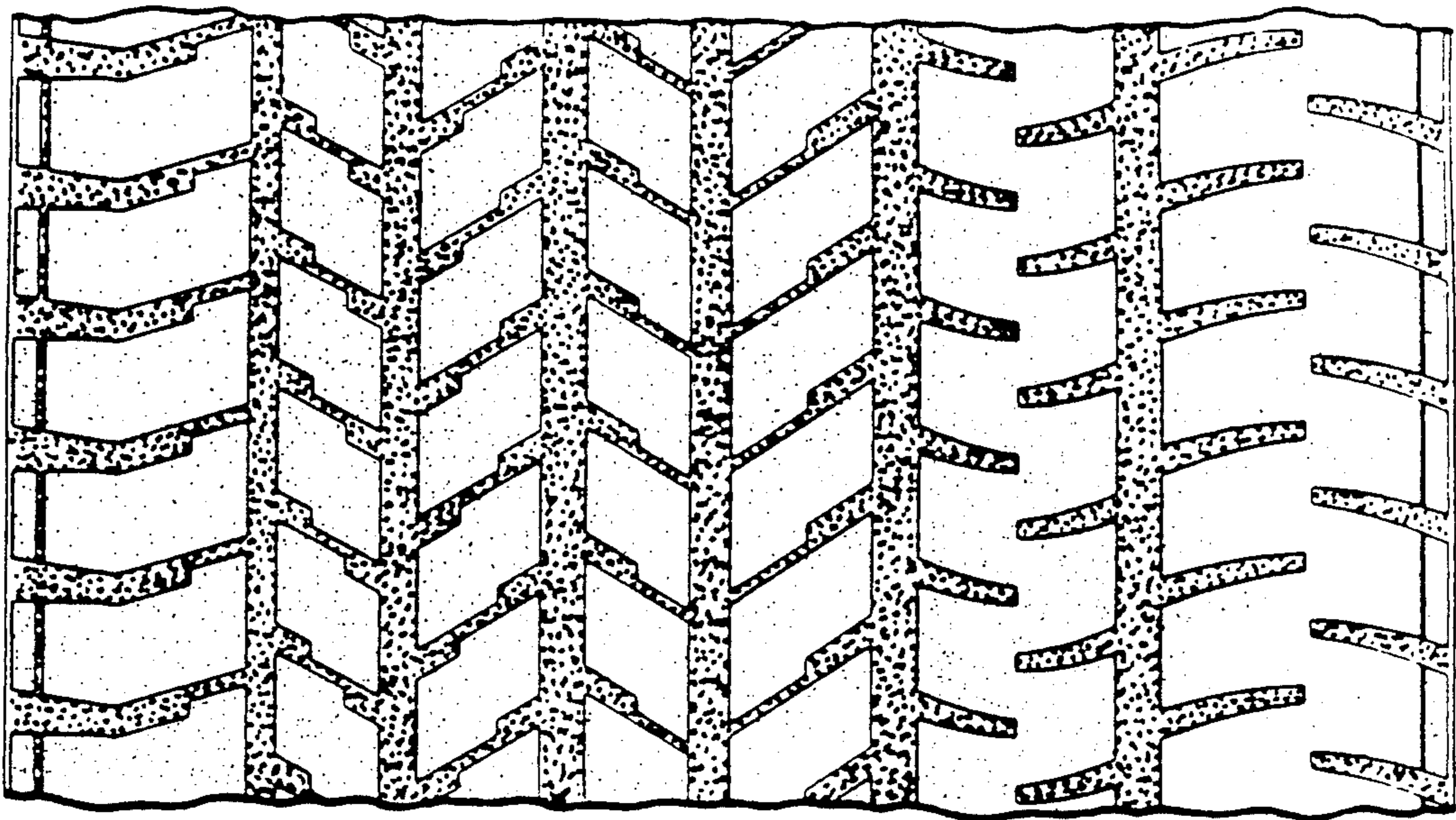

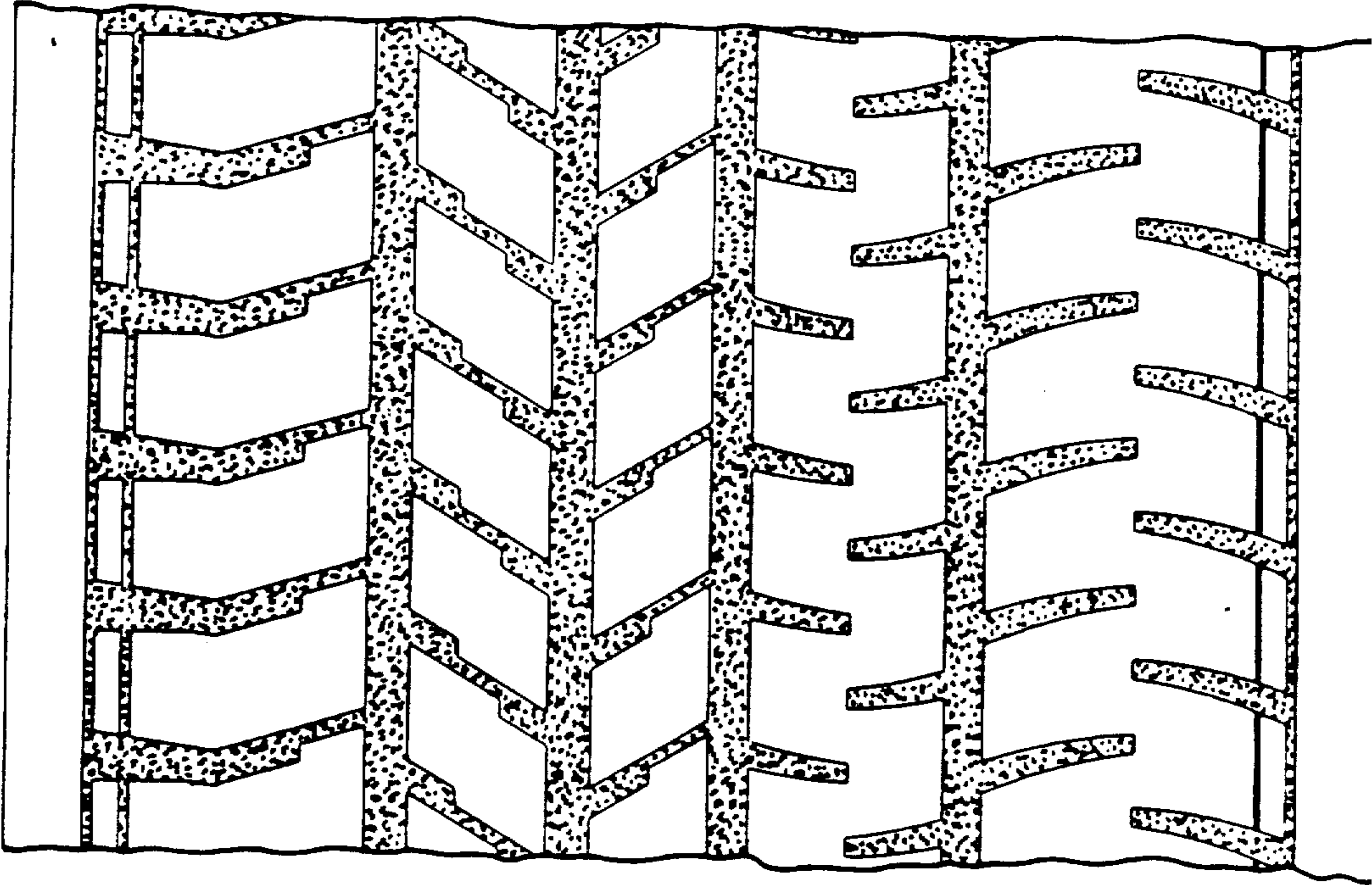


FIG. 5
