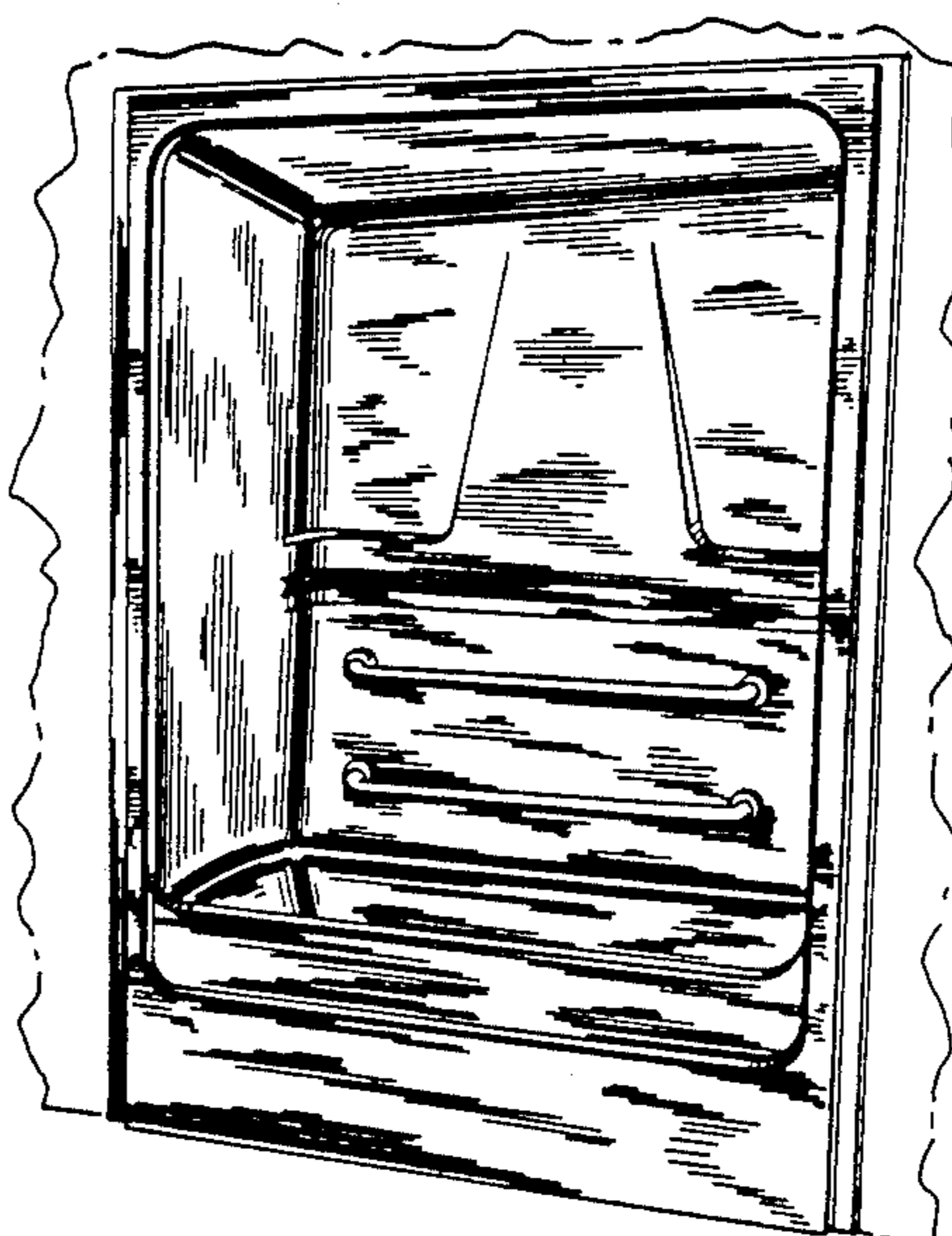

The ornamental design for a bathing enclosure or the like, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of a bathing enclosure or the like showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a left side elevational view thereof; and
 FIG. 6 is a rear elevational view thereof.
 The fragmentary broken line representation of a bathroom wall in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.



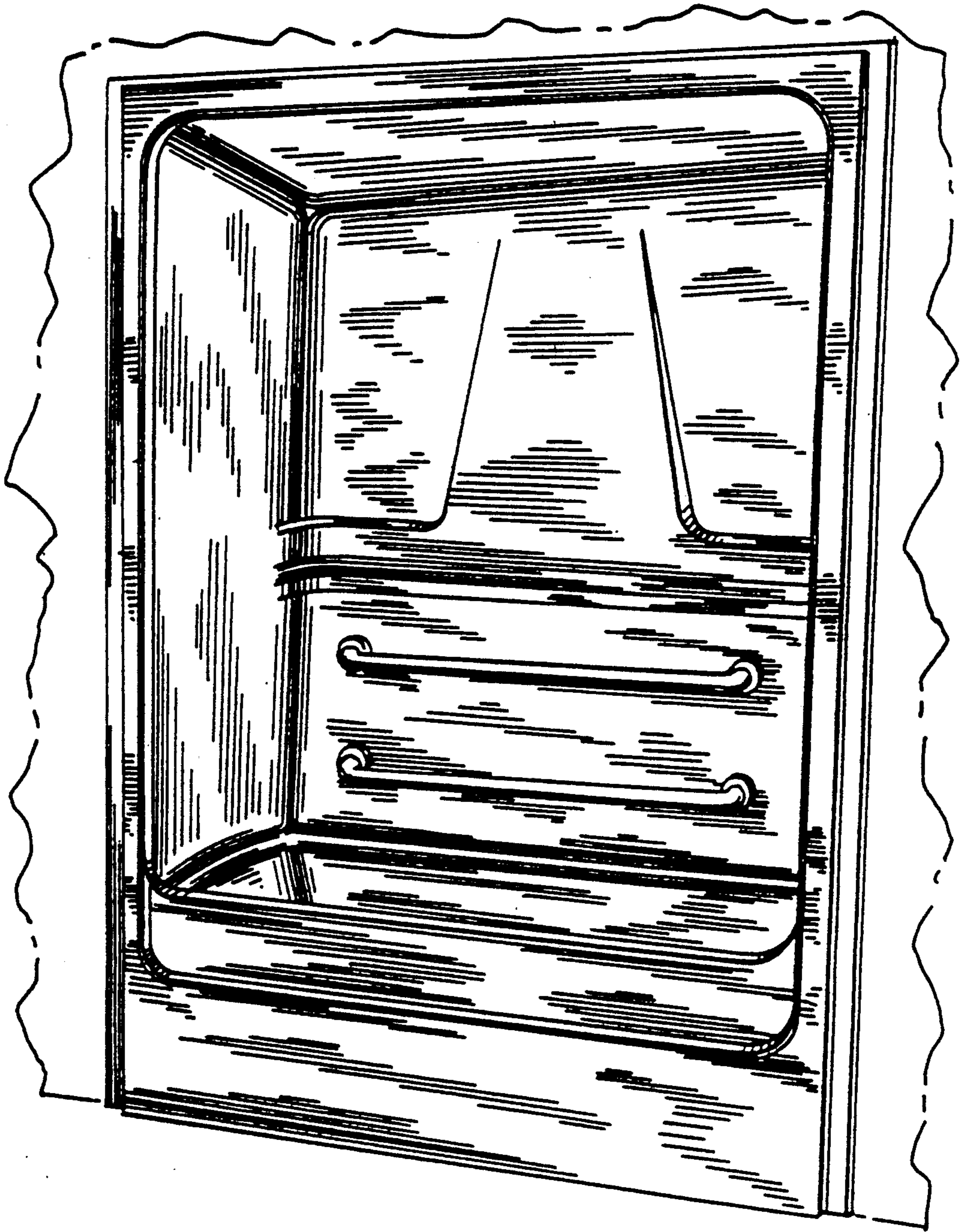

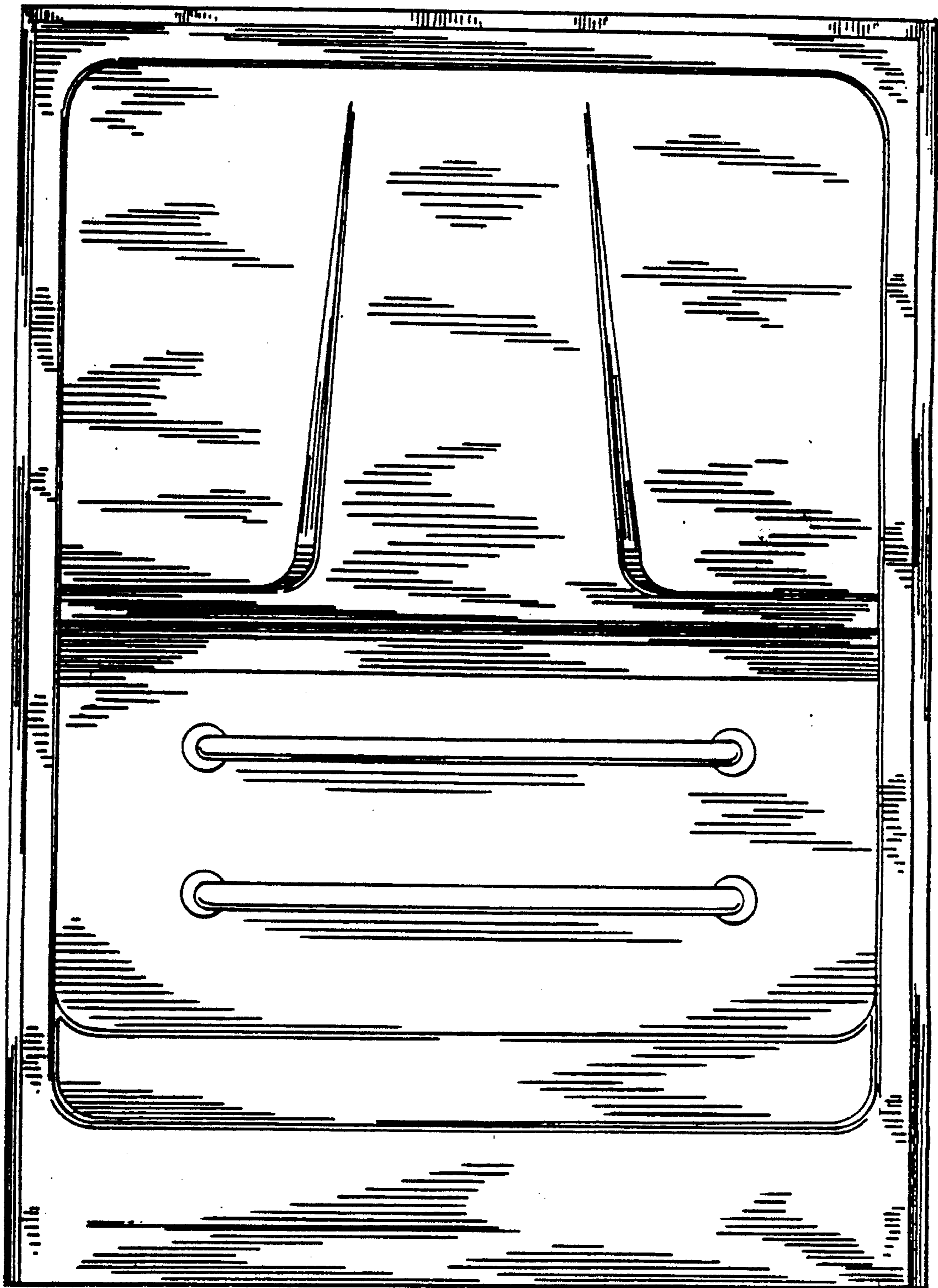

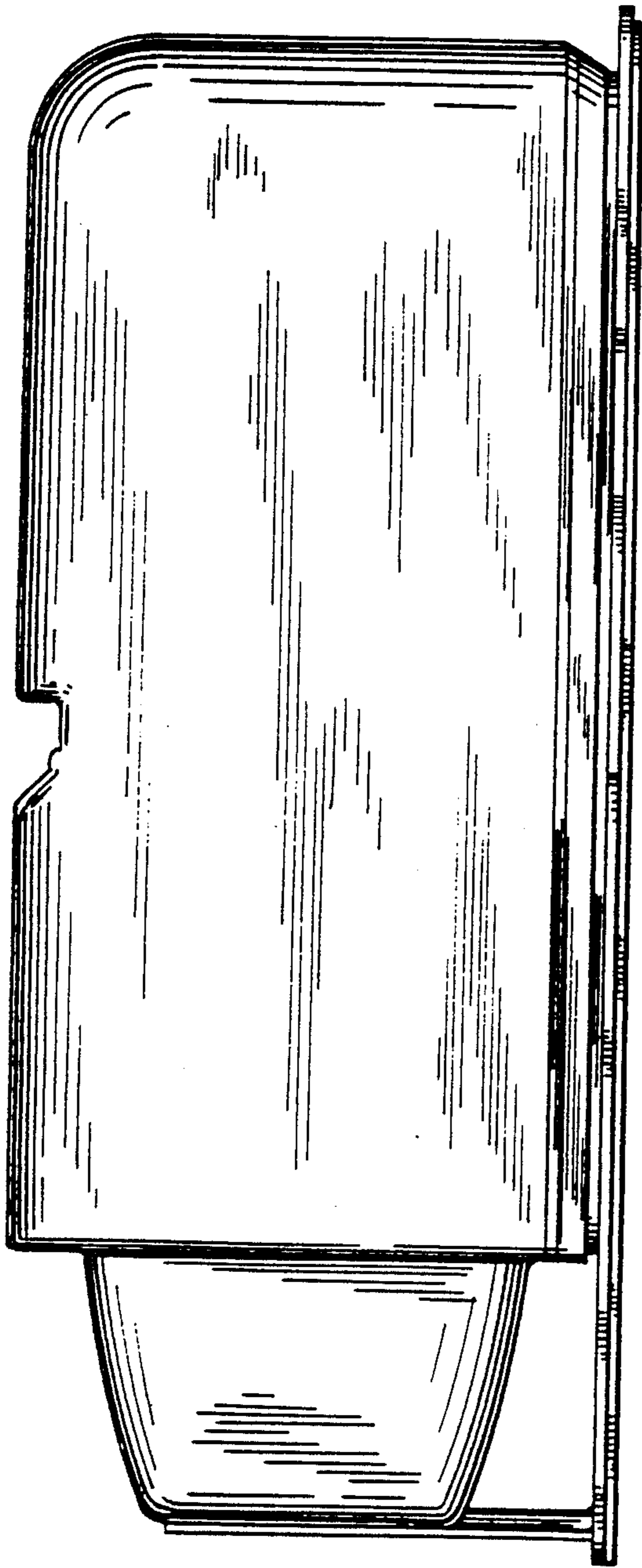

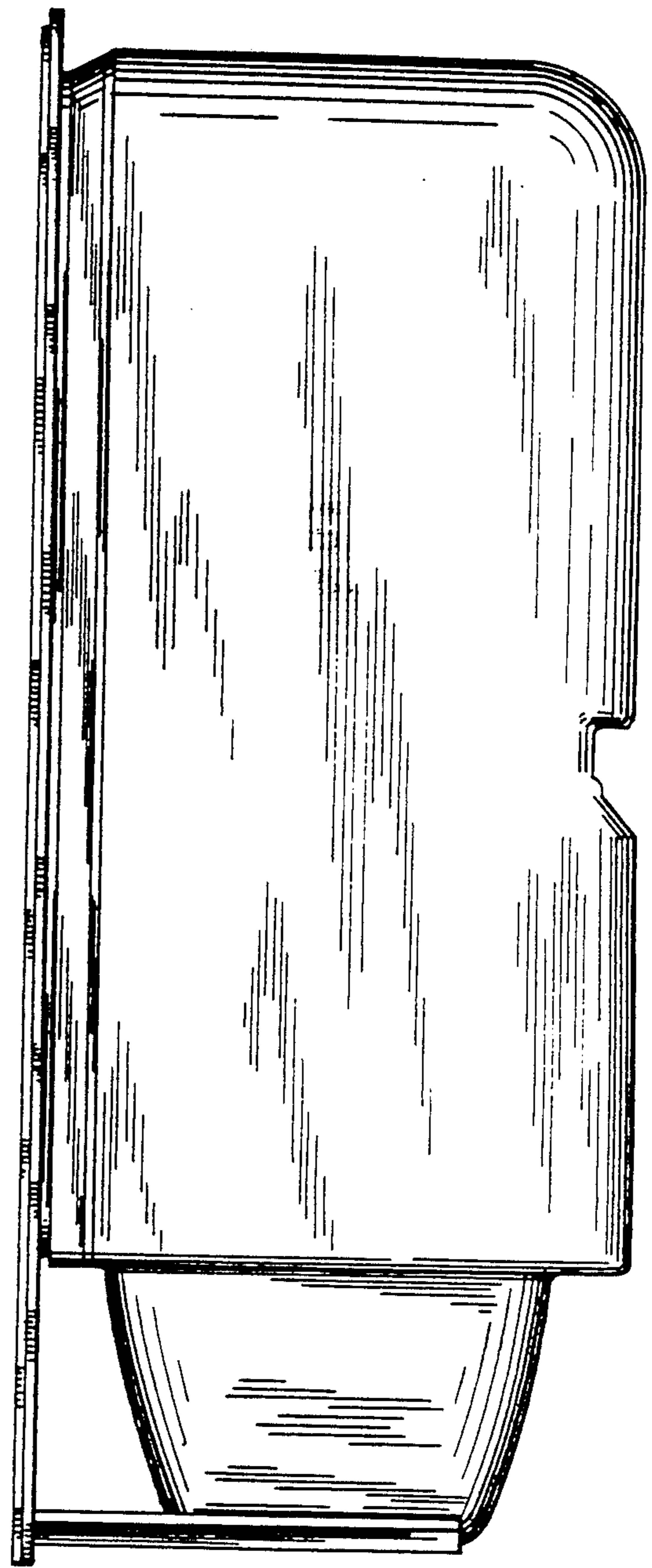

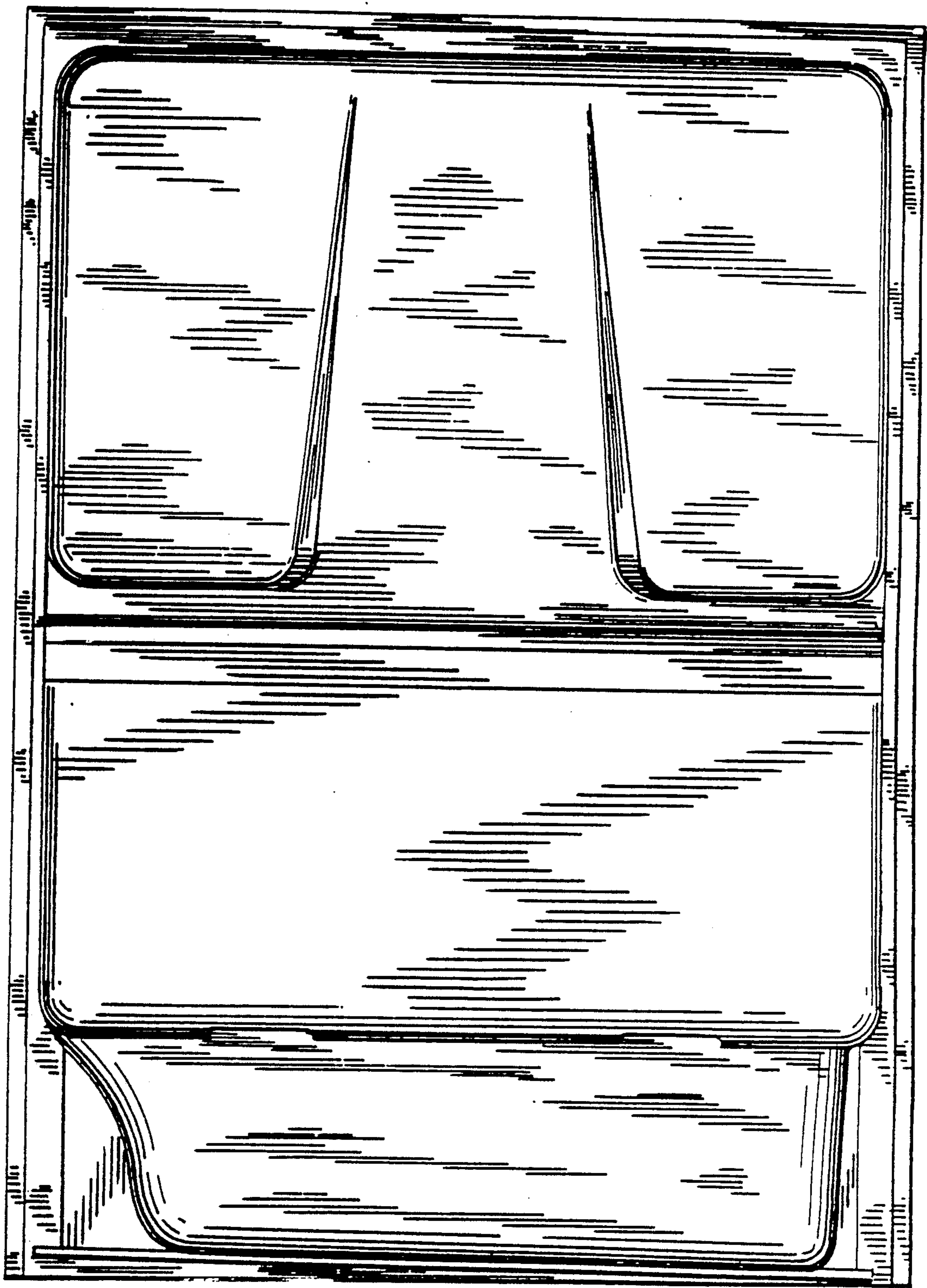
