The ornamental design for a plate joiner, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of a plate joiner showing our new design;

FIG. 2 is a front elevational view thereof on a reduced scale;

FIG. 3 is a rear elevational view thereof on a reduced scale;

FIG. 4 is a left side elevational view thereof on a reduced scale;

FIG. 5 is a right side elevational view thereof on a reduced scale;

FIG. 6 is a top plan view thereof on a reduced scale; and

FIG. 7 is a bottom plan view thereof on a reduced scale.

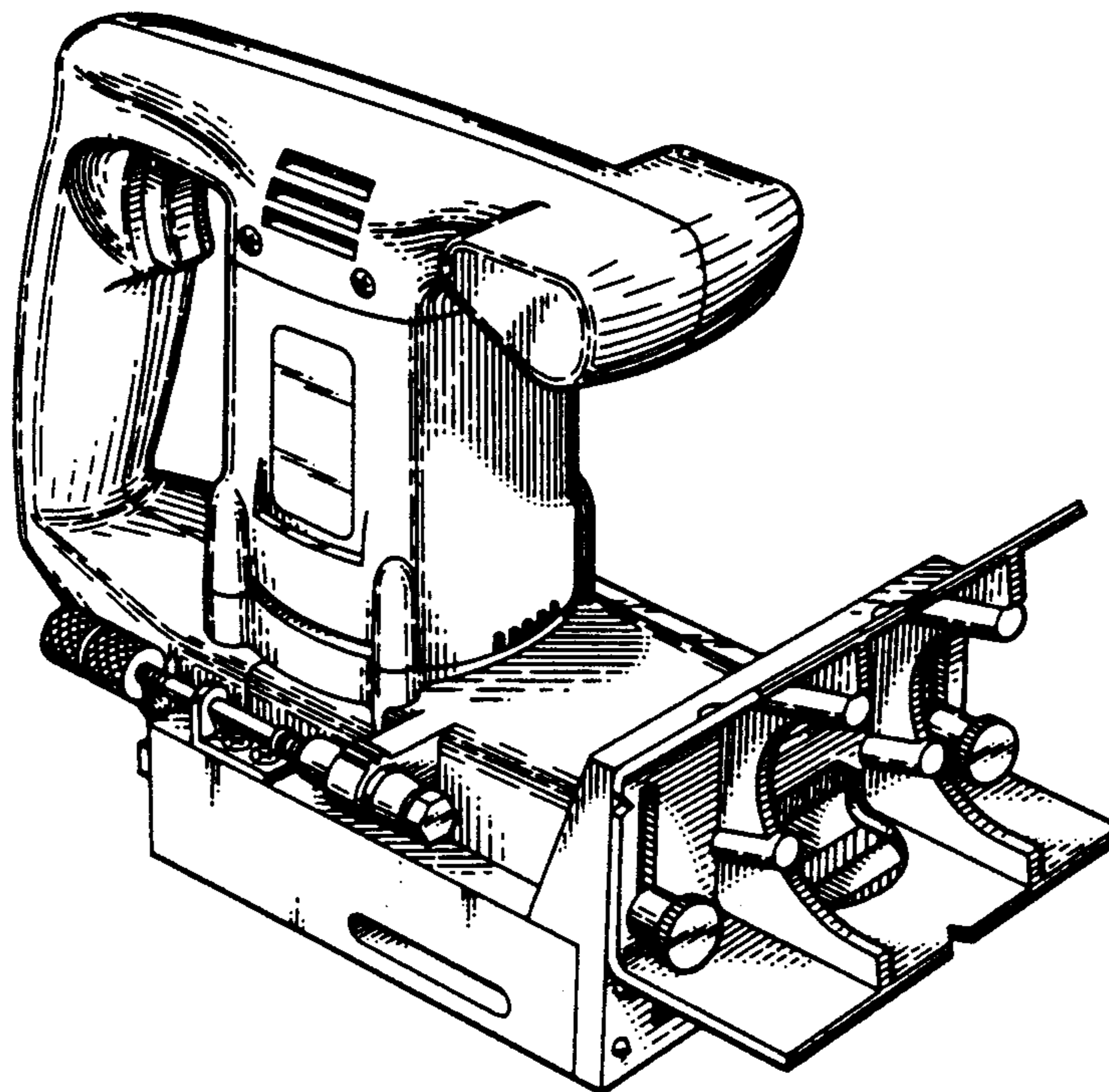

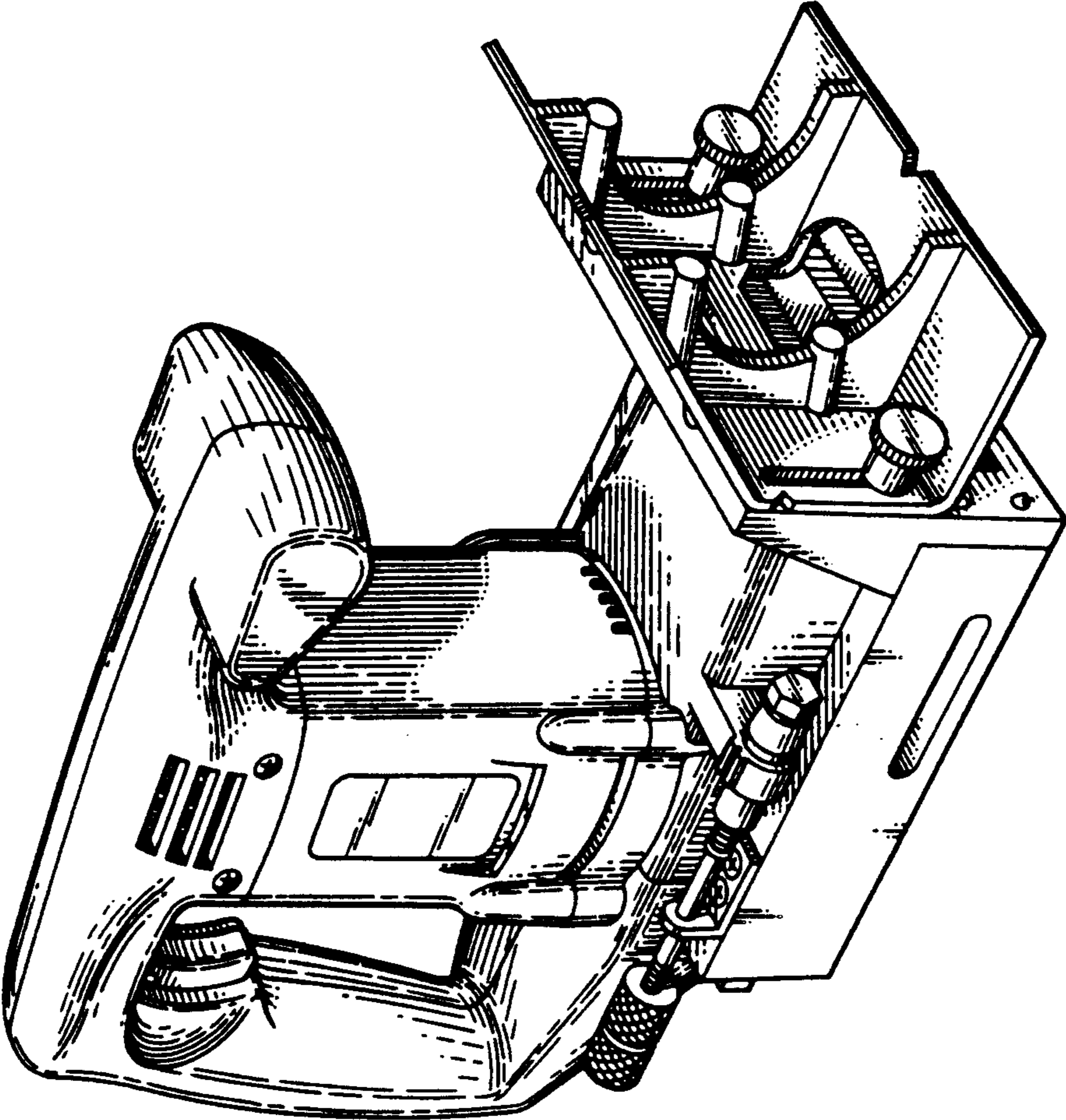

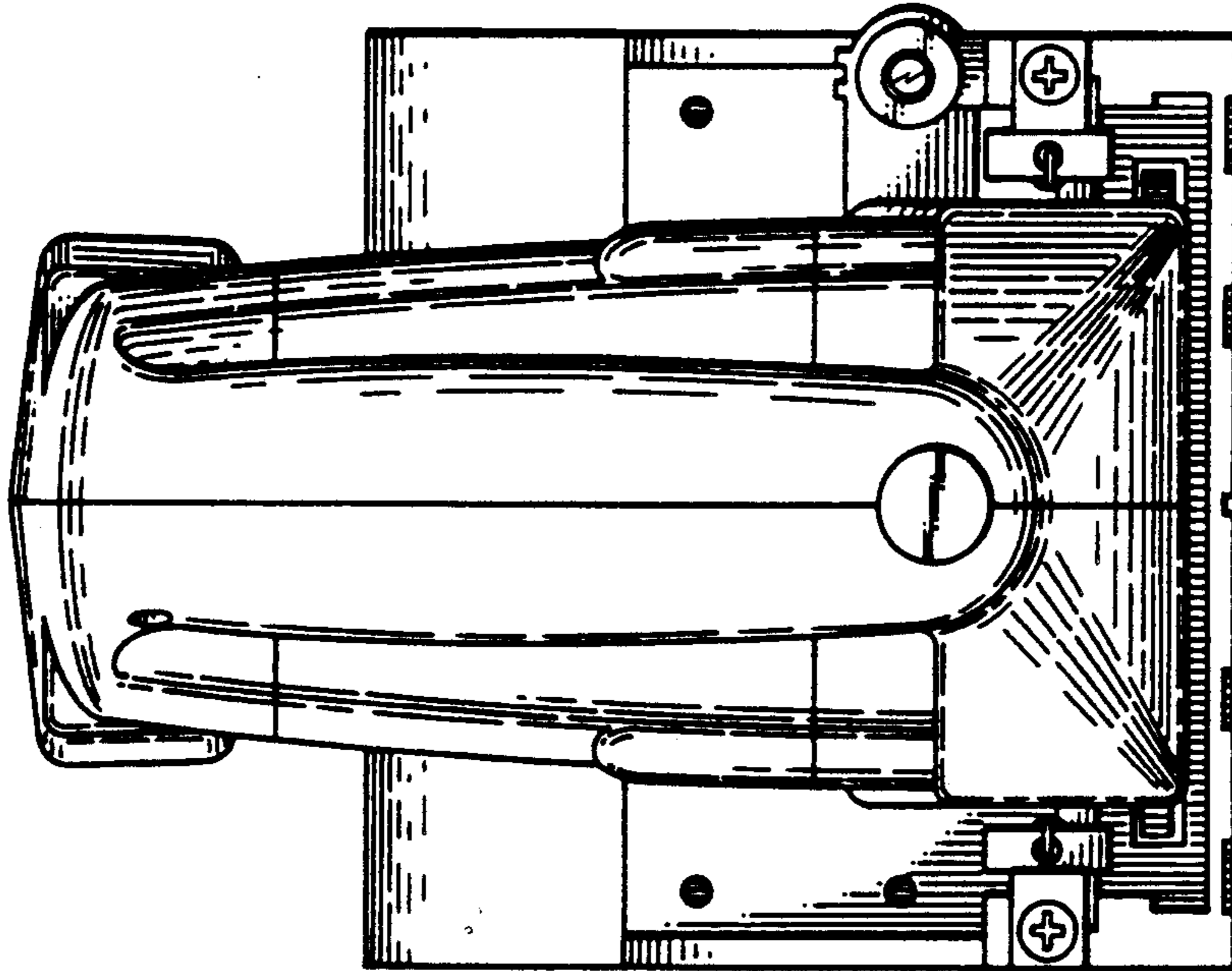

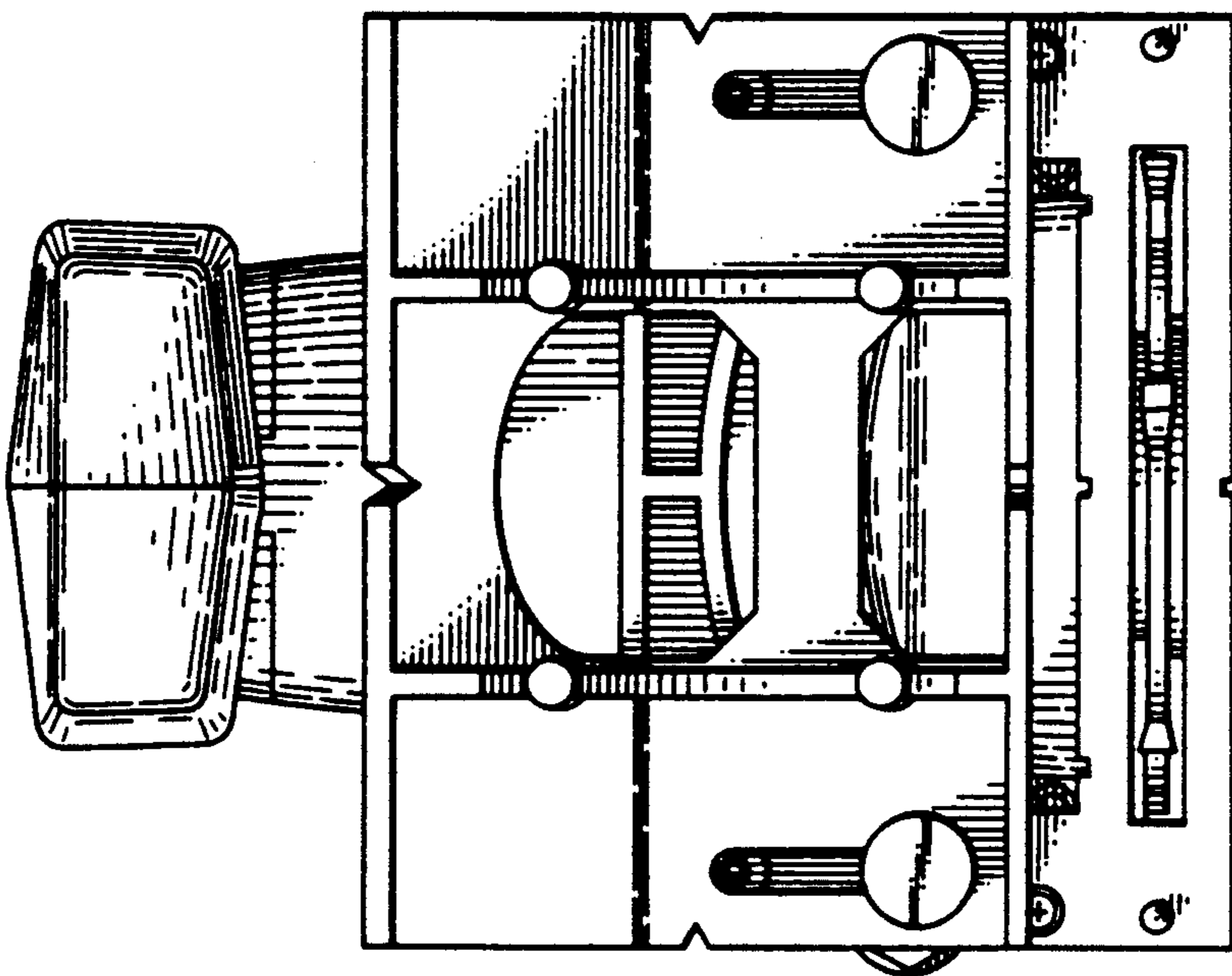

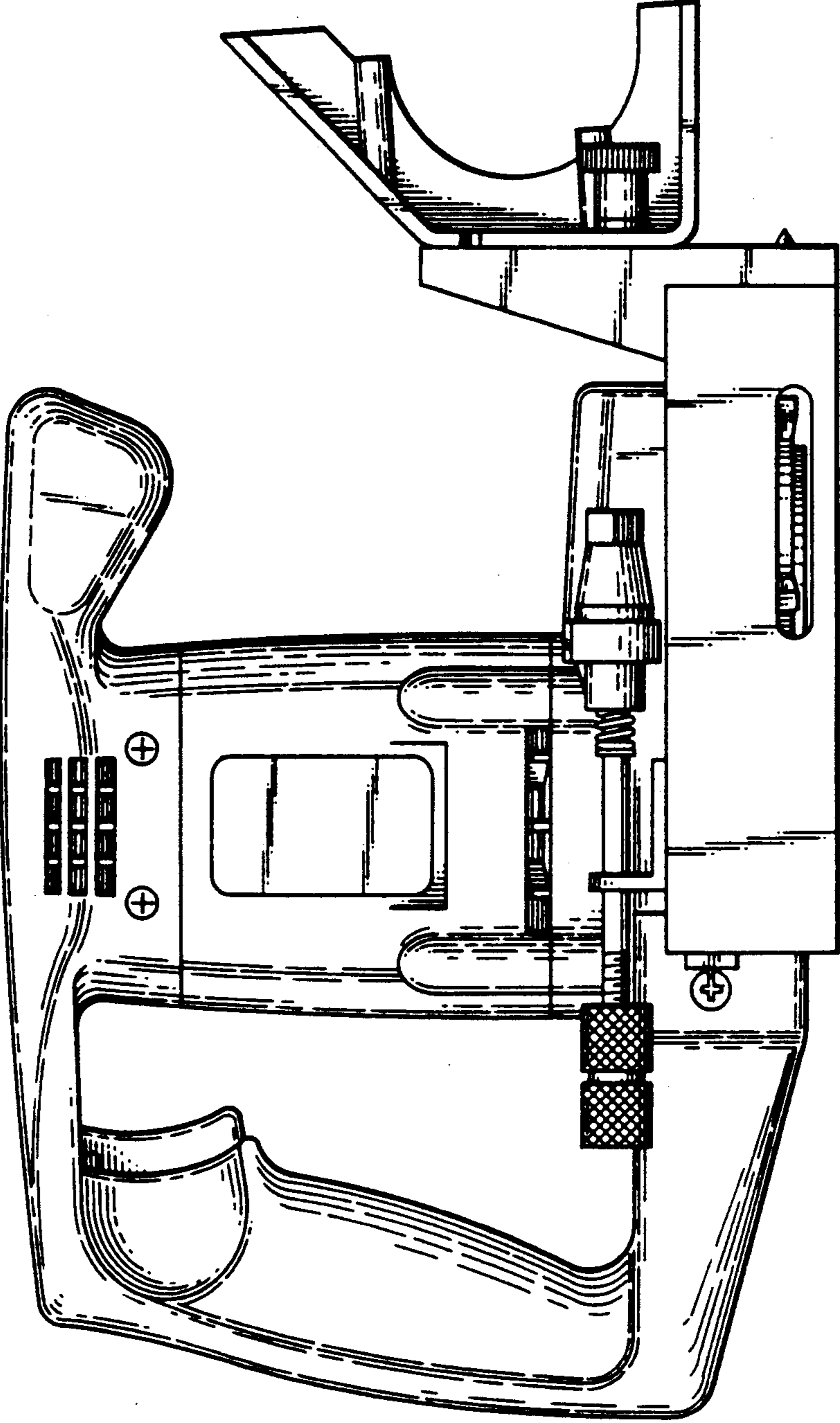

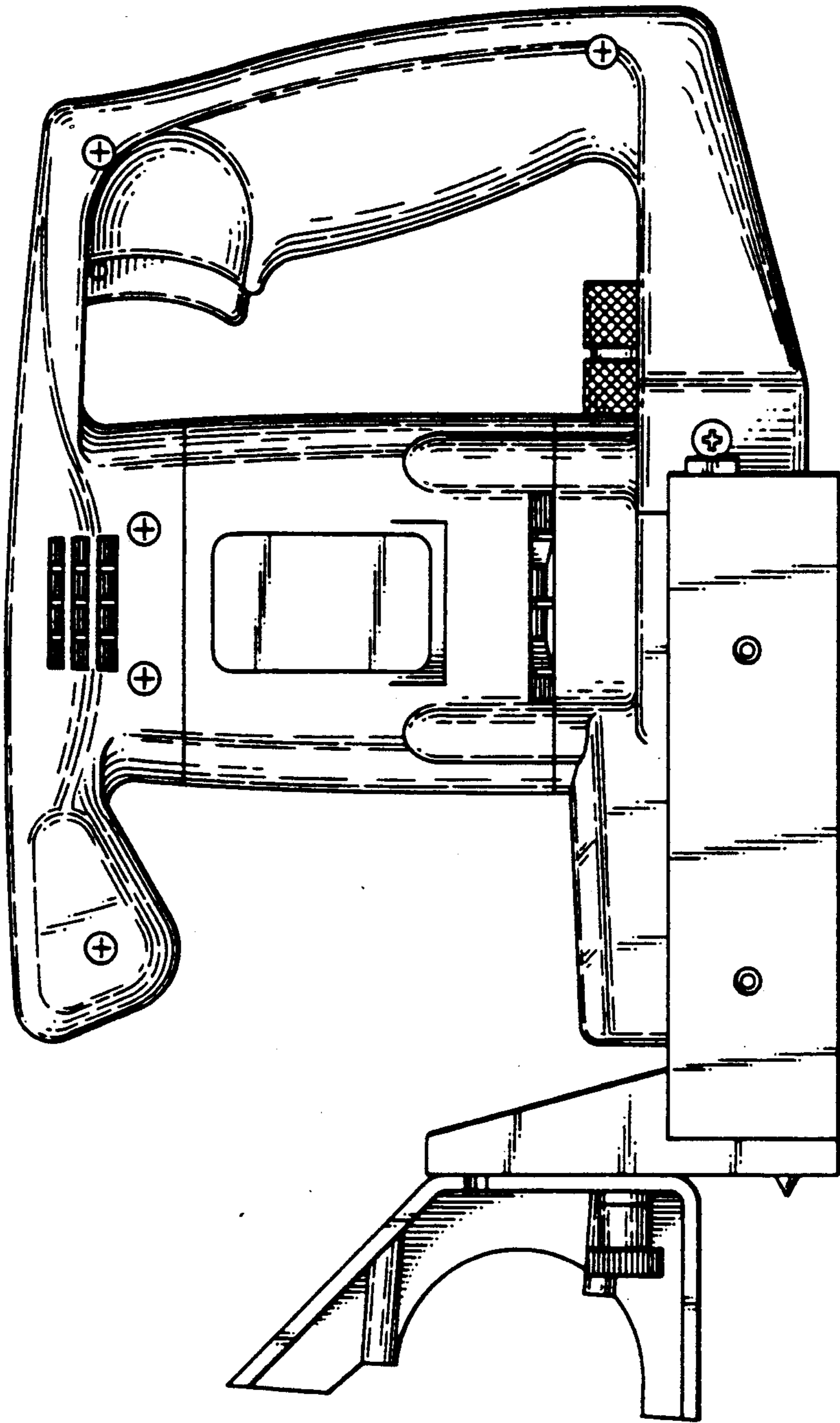

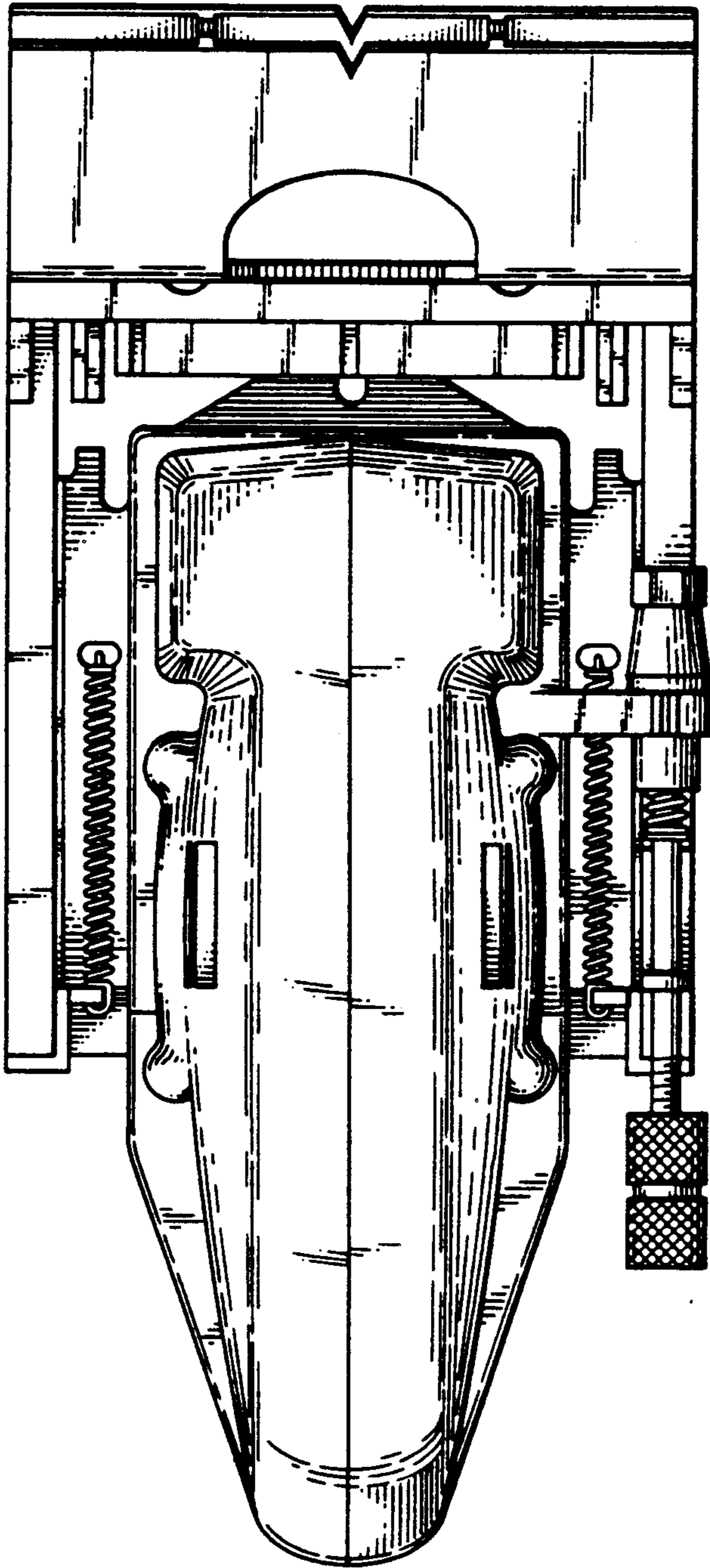
