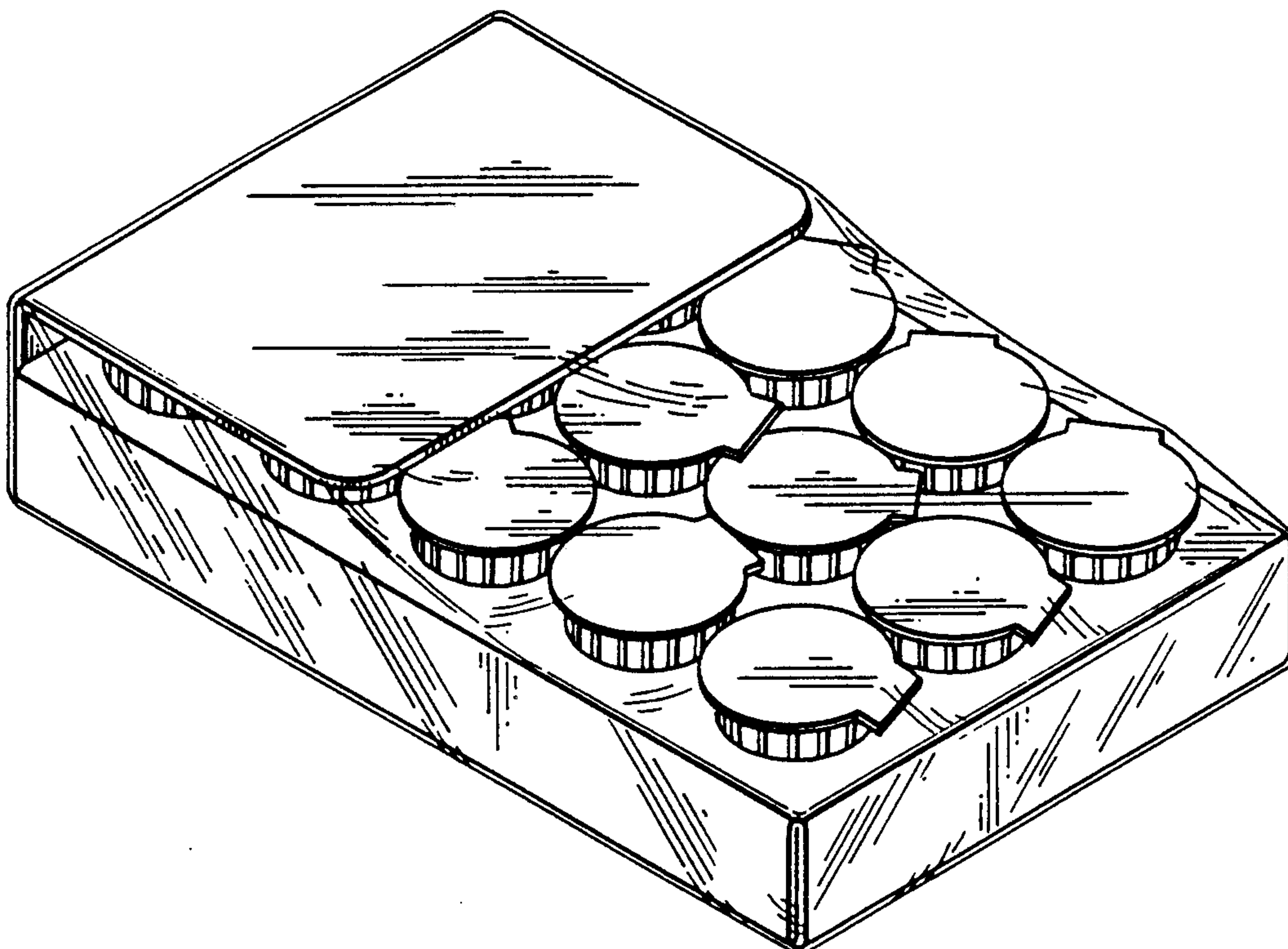

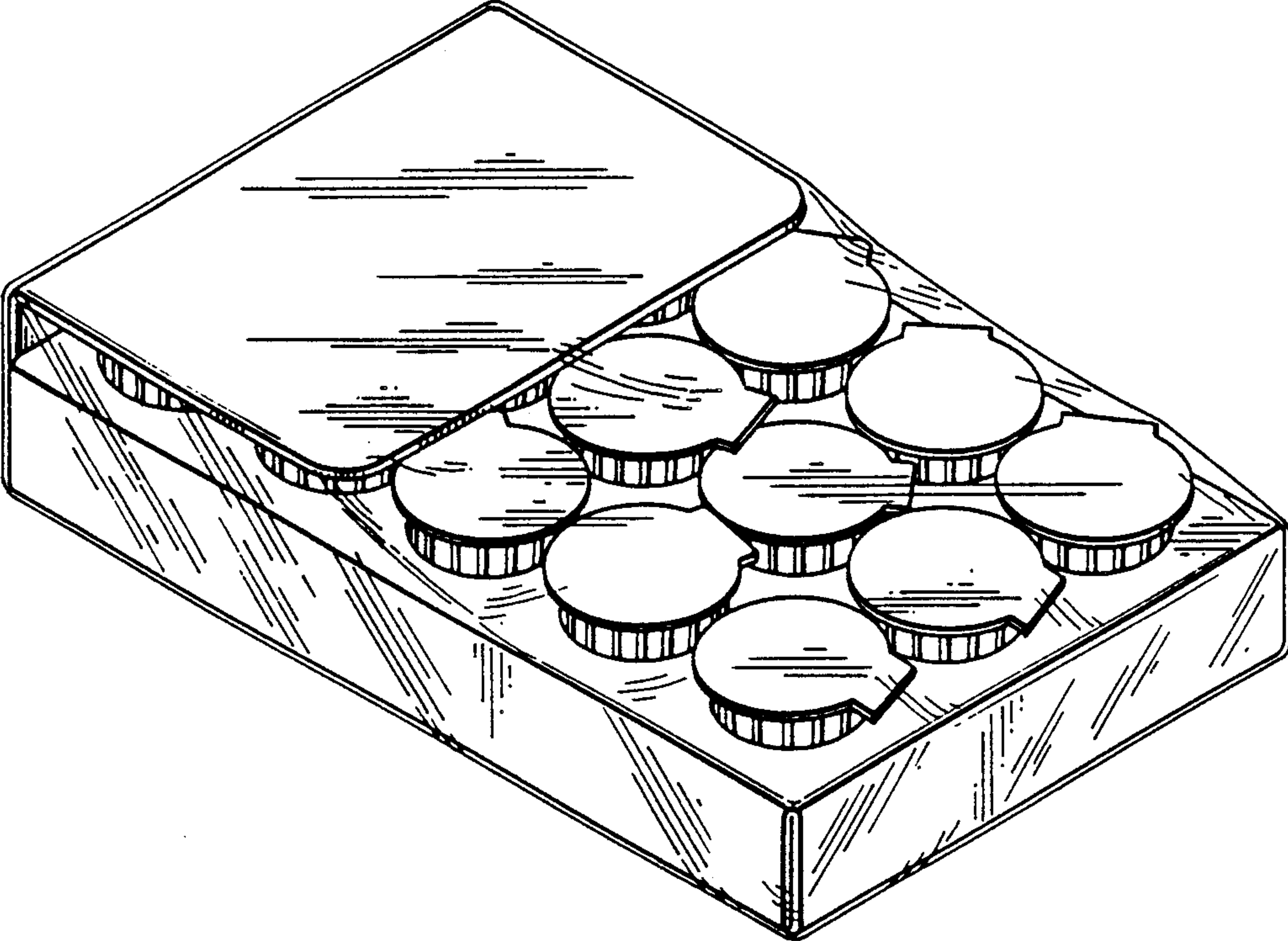
The ornamental design for package for dairy products, as shown and described.
