The ornamental design for a magnetic tape unit, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a magnetic tape unit showing our new design;

FIG. 2 is a rear elevational view thereof;

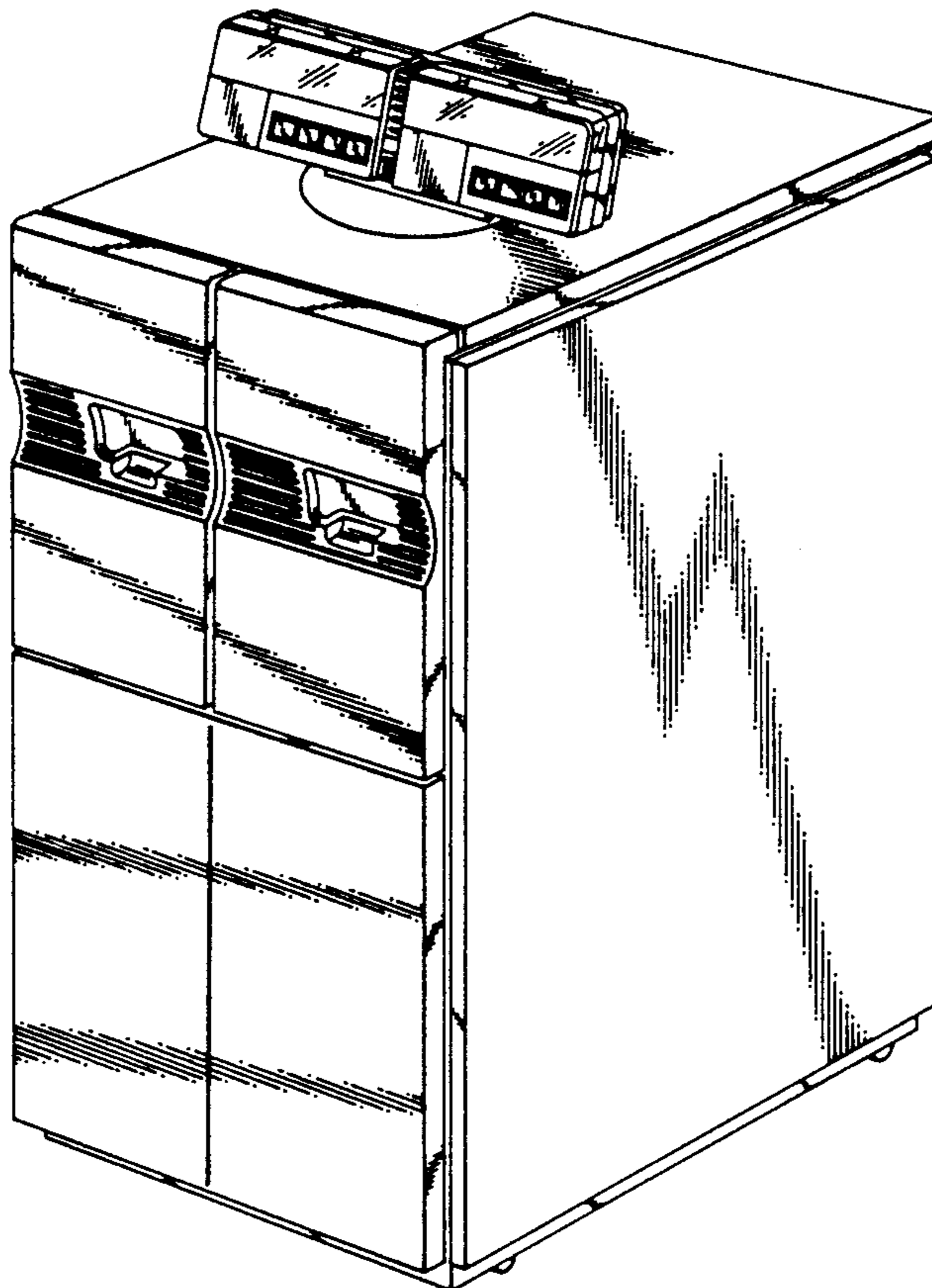
FIG. 3 is a right-side elevational view thereof;

FIG. 5 is a top plan view thereof.

FIG. 6 is a top, front, right side perspective view thereof.

The bottom of the magnetic tape unit is plain and without ornamentation.



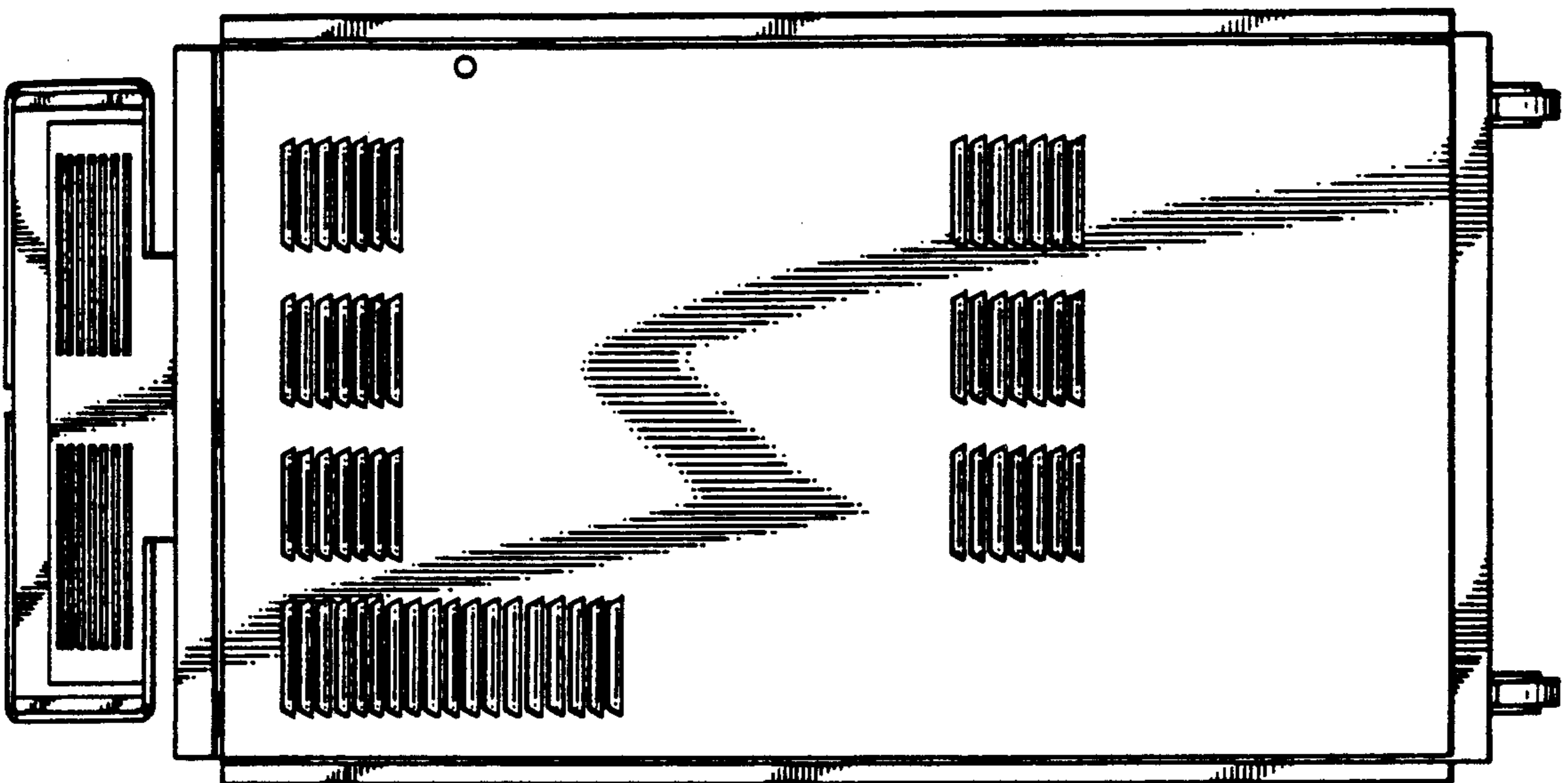

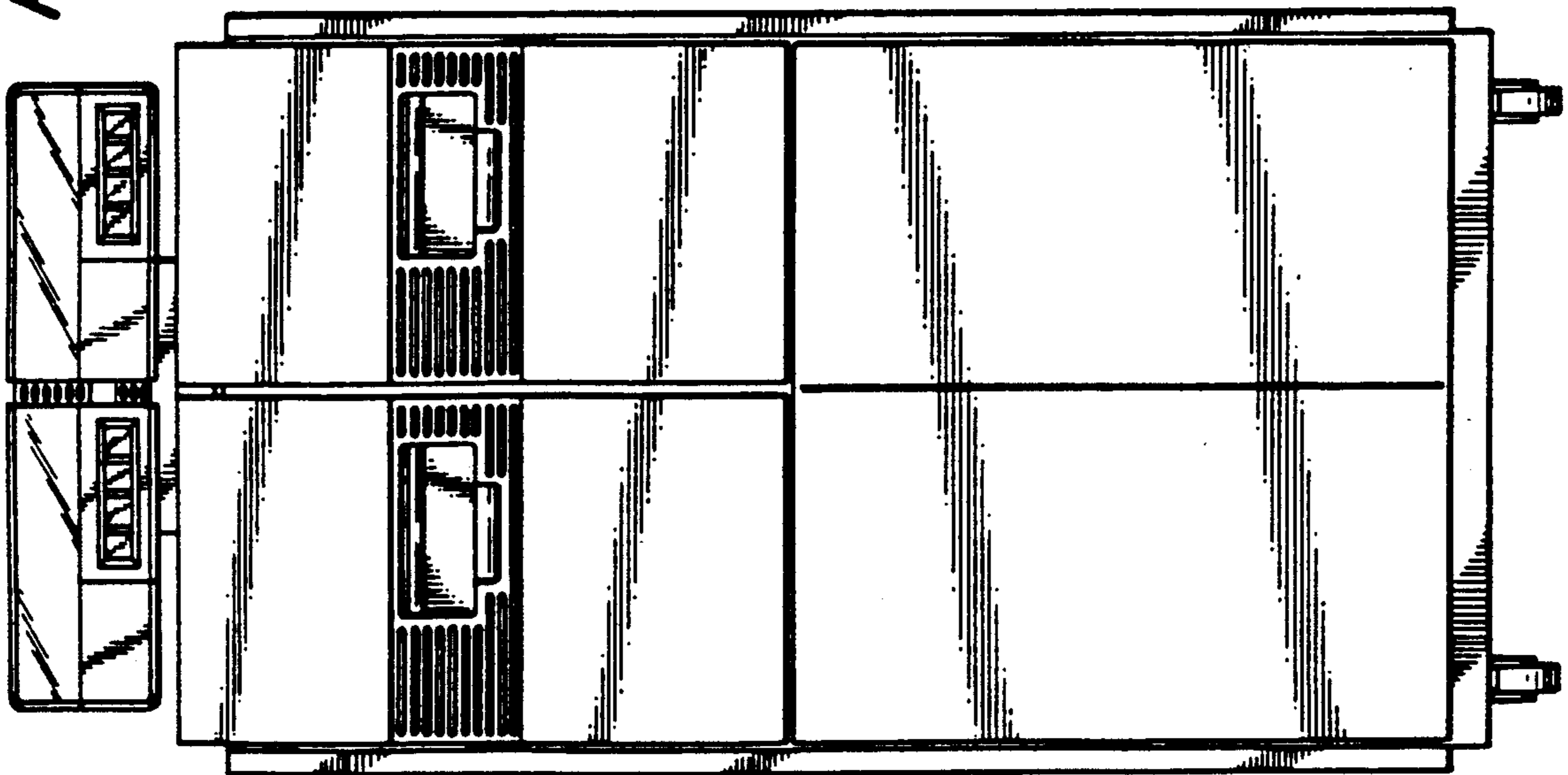

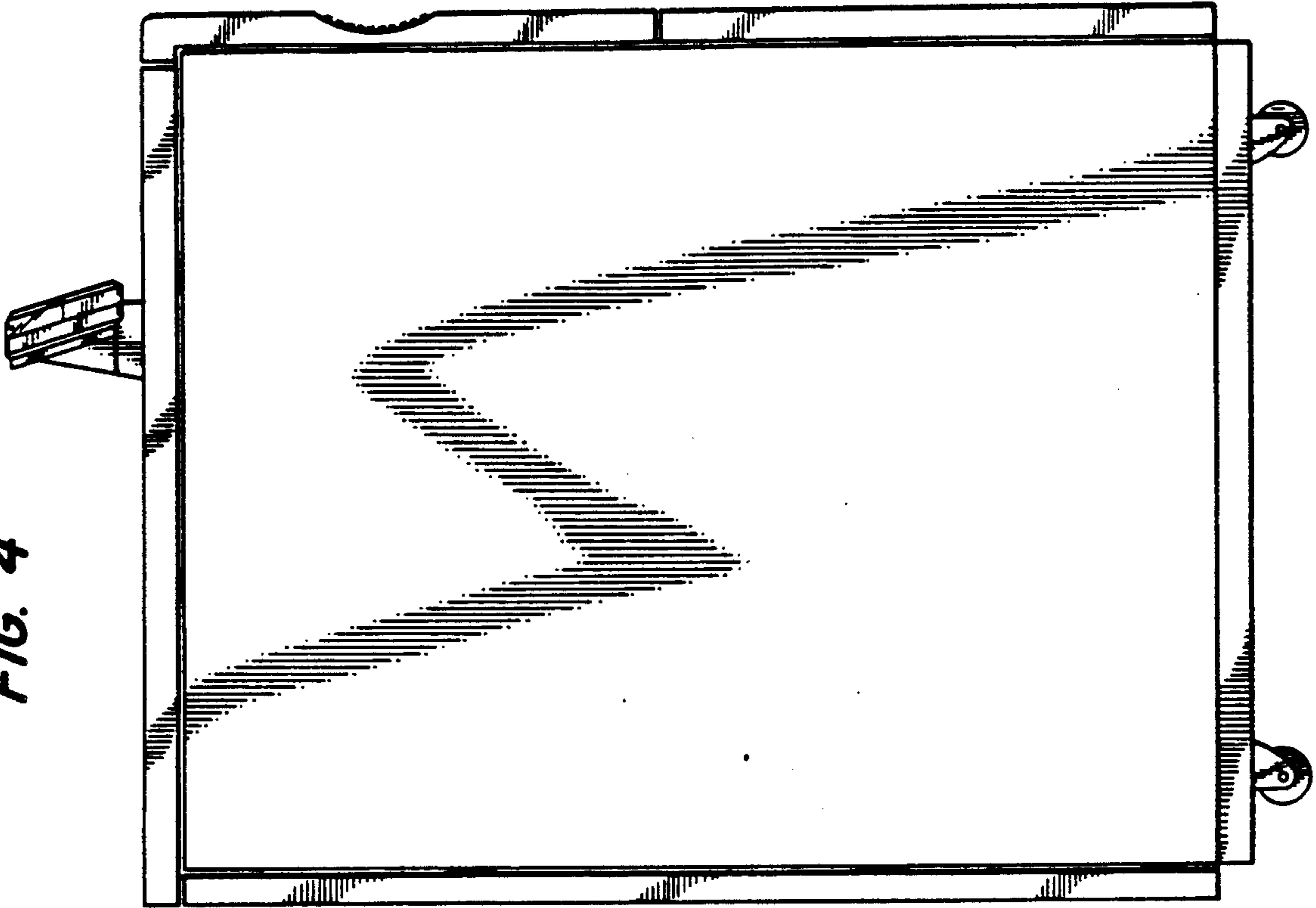

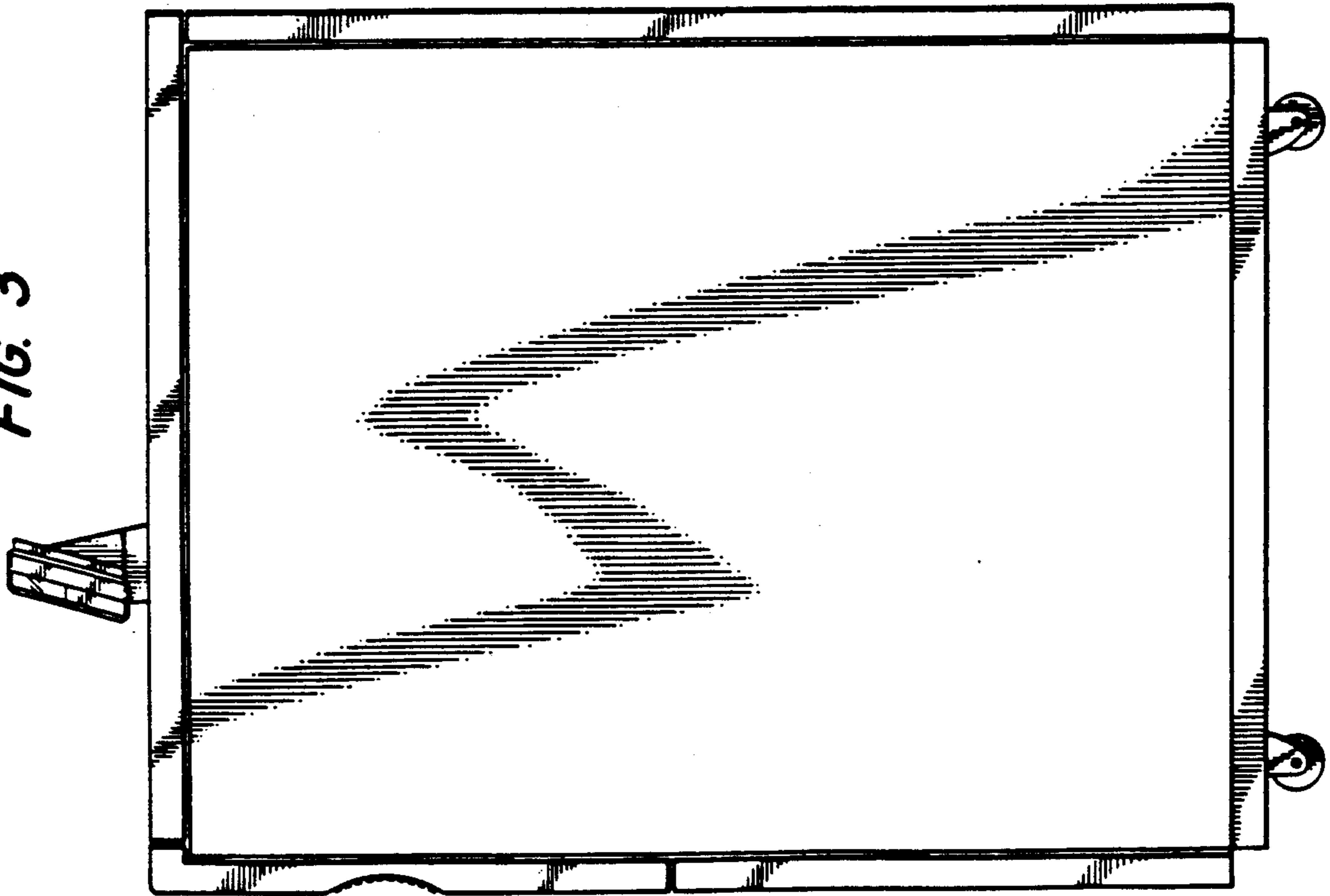

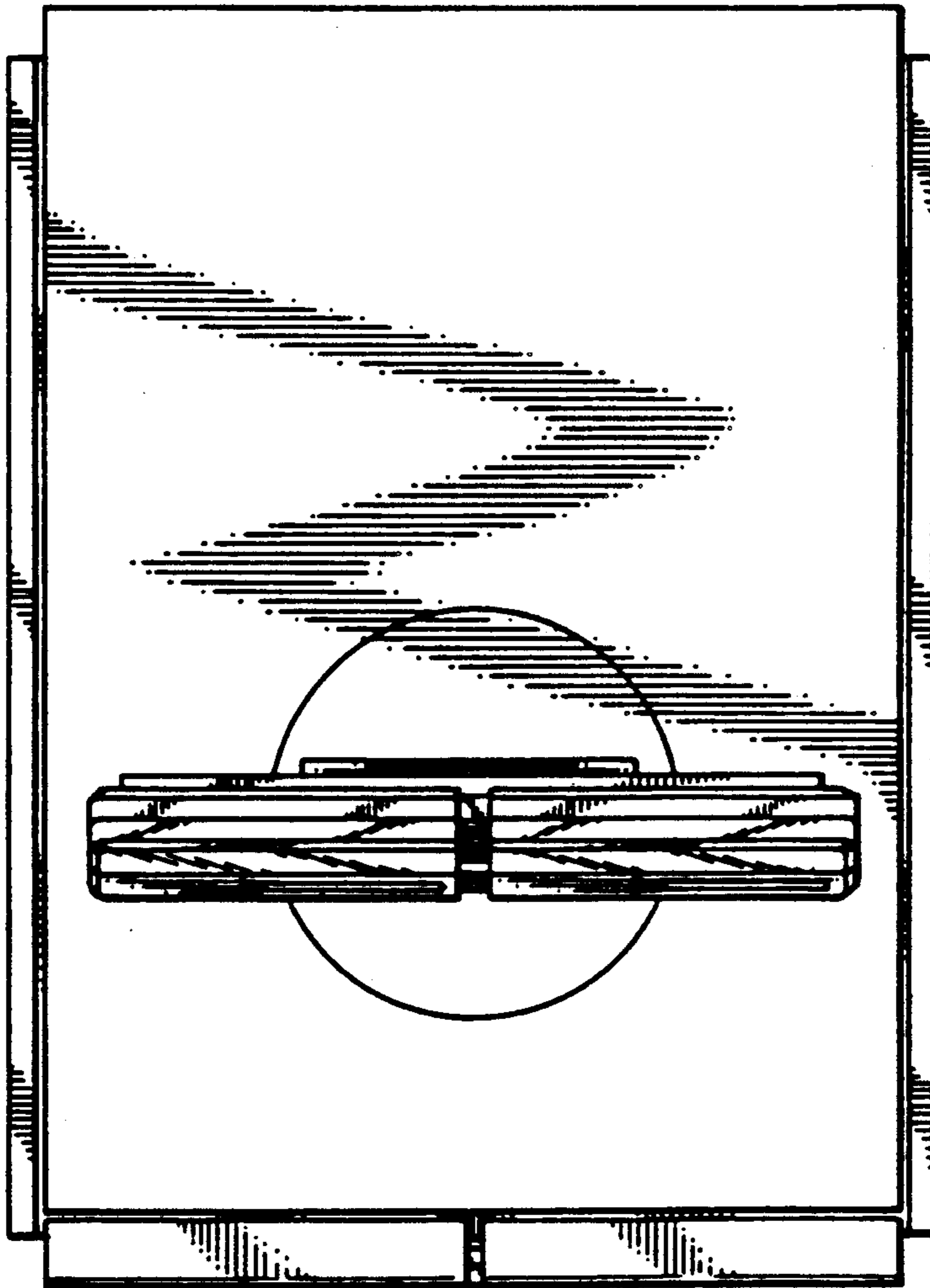
