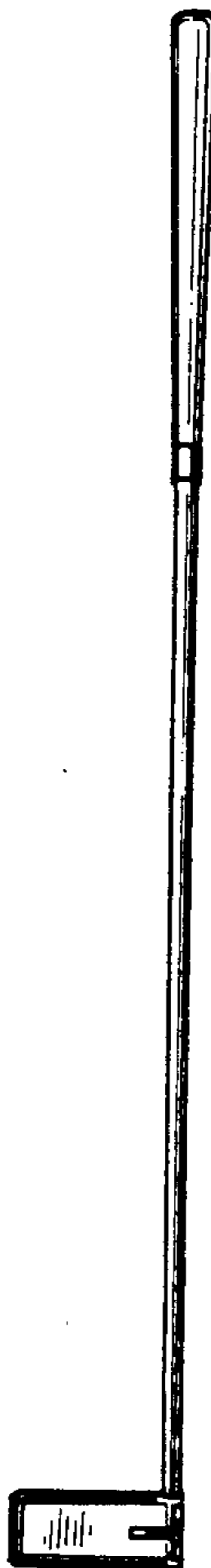

FIG. 14 is an enlarged fragmentary rear elevational view of the putter head of FIG. 10.



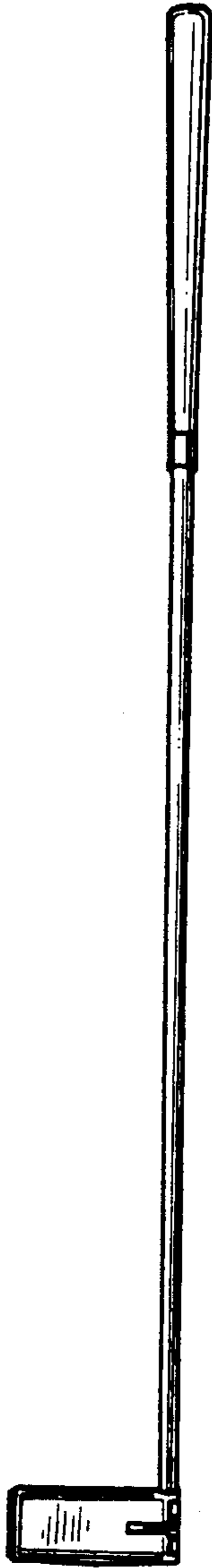

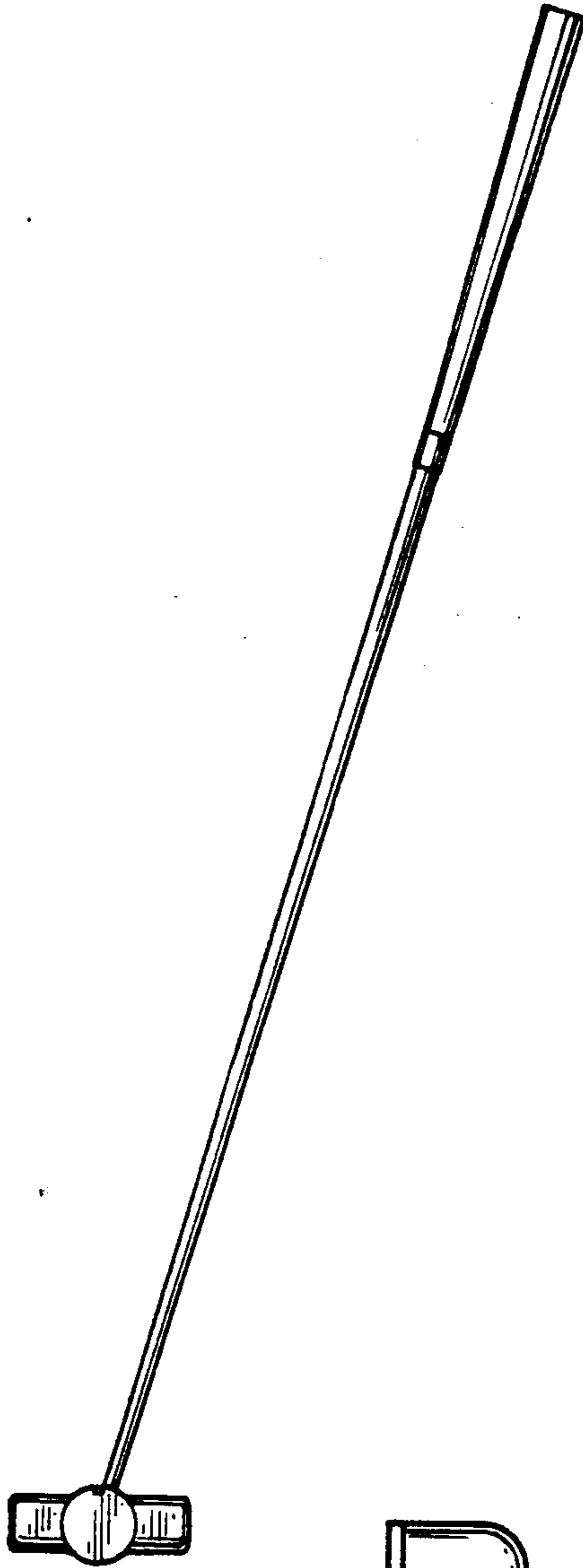

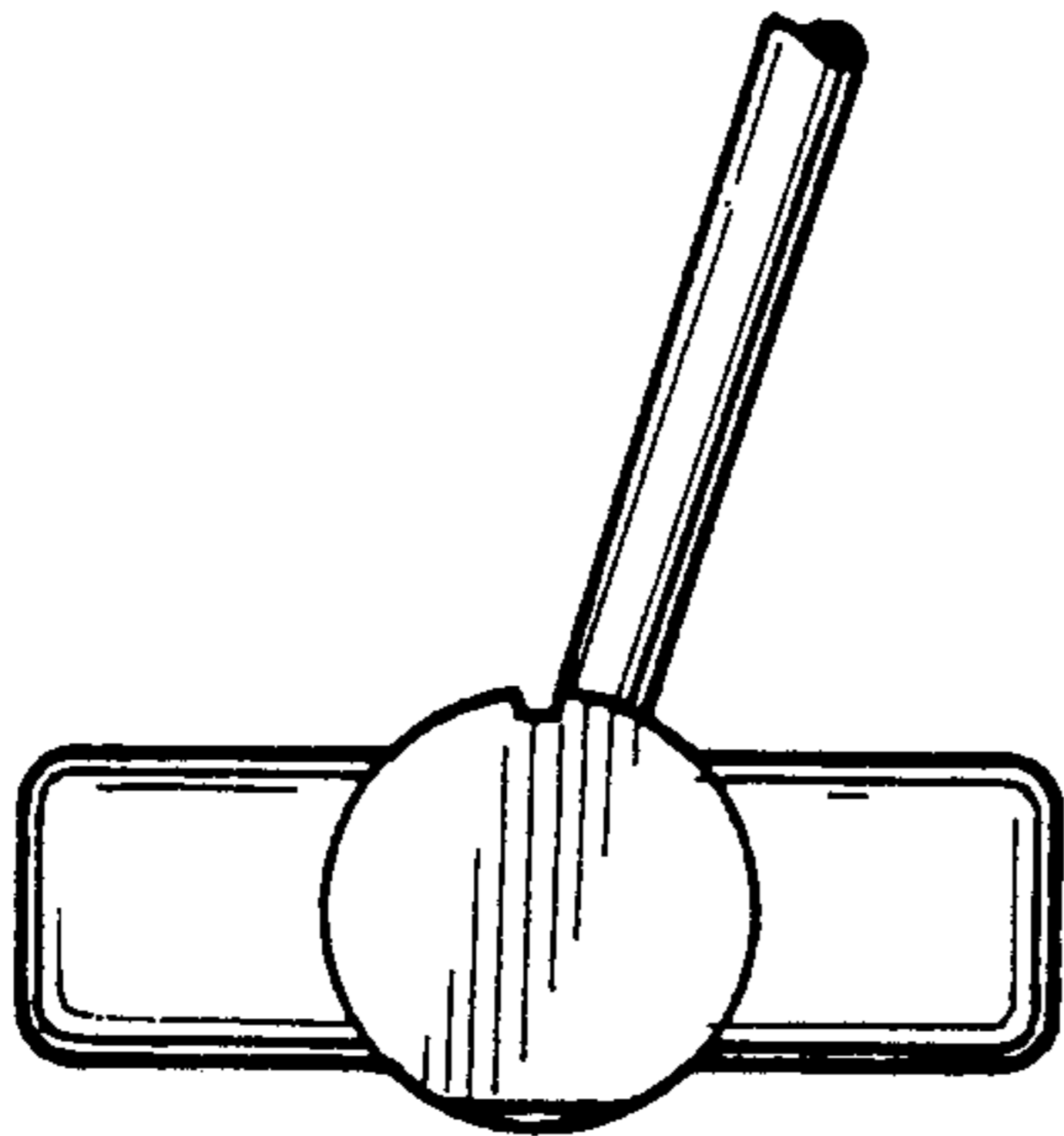

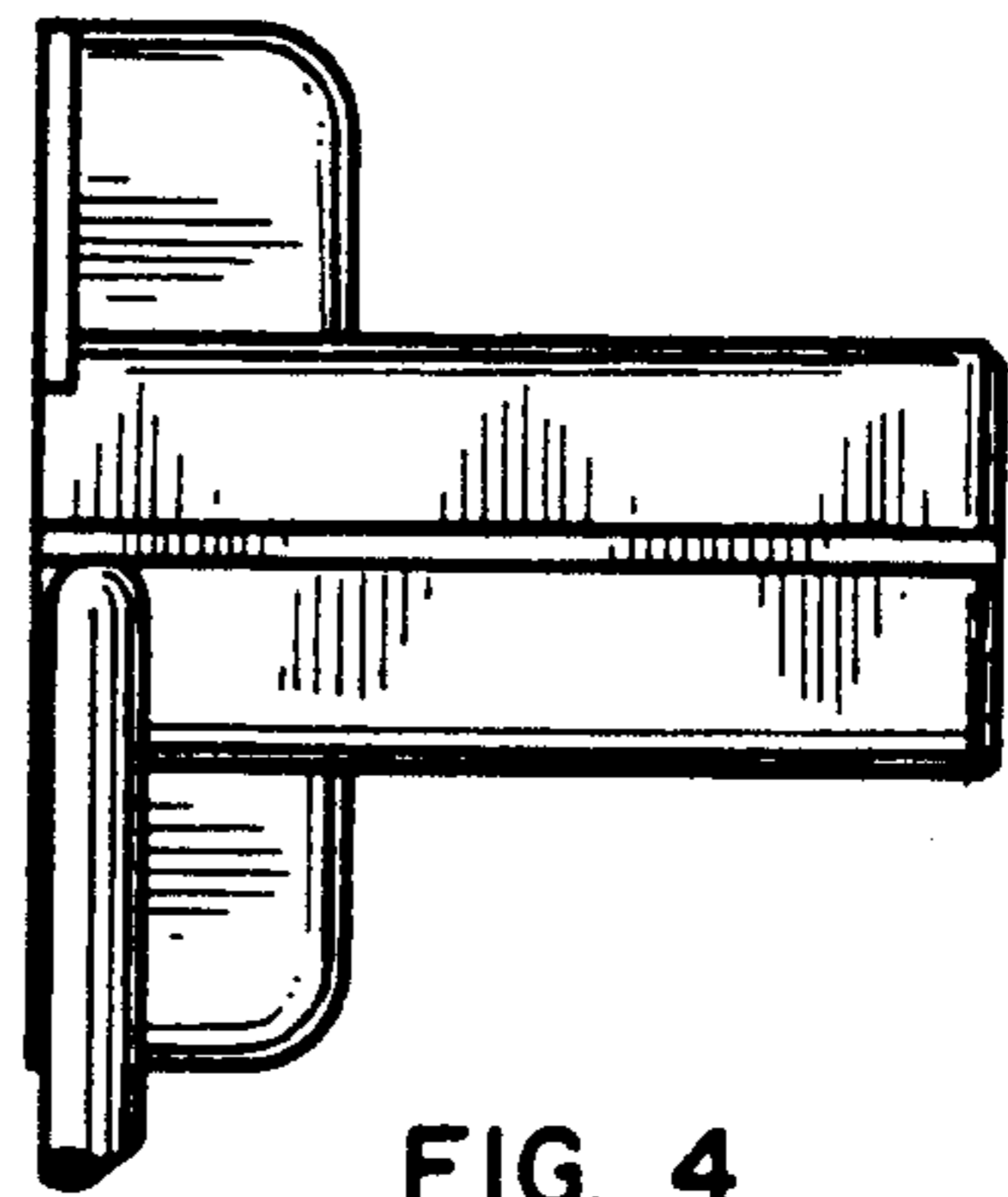

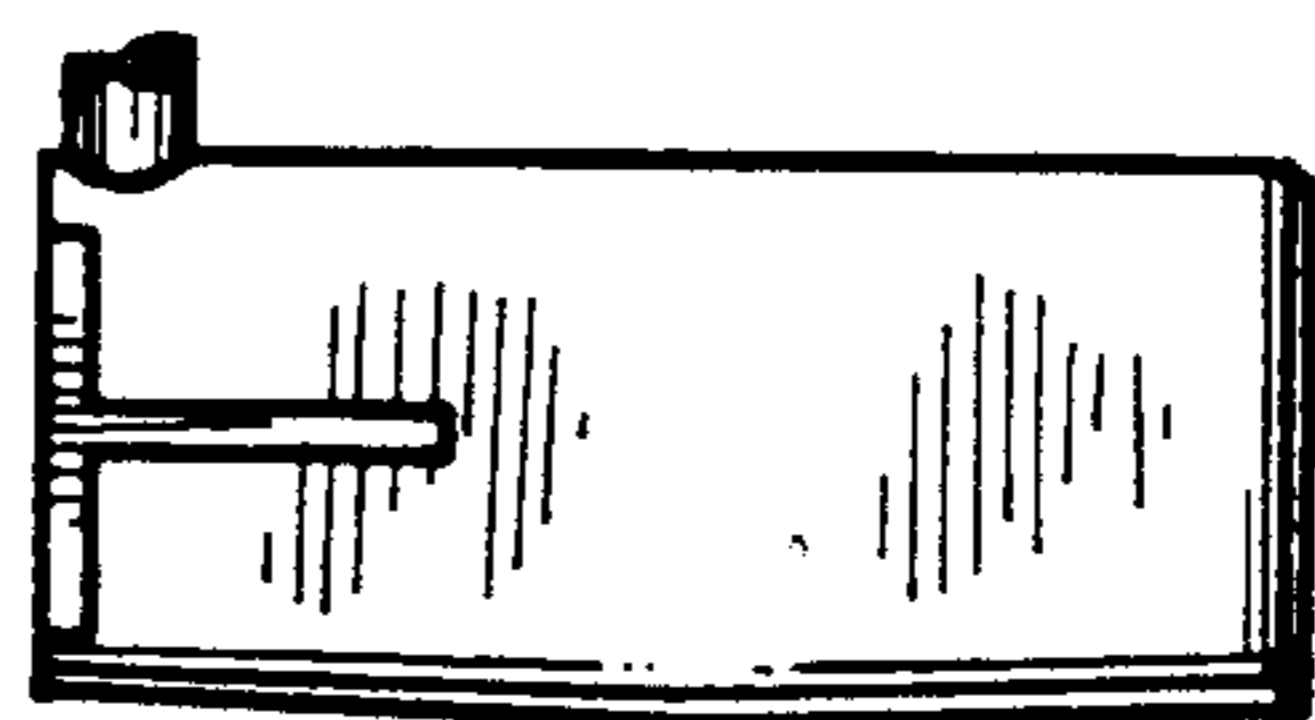

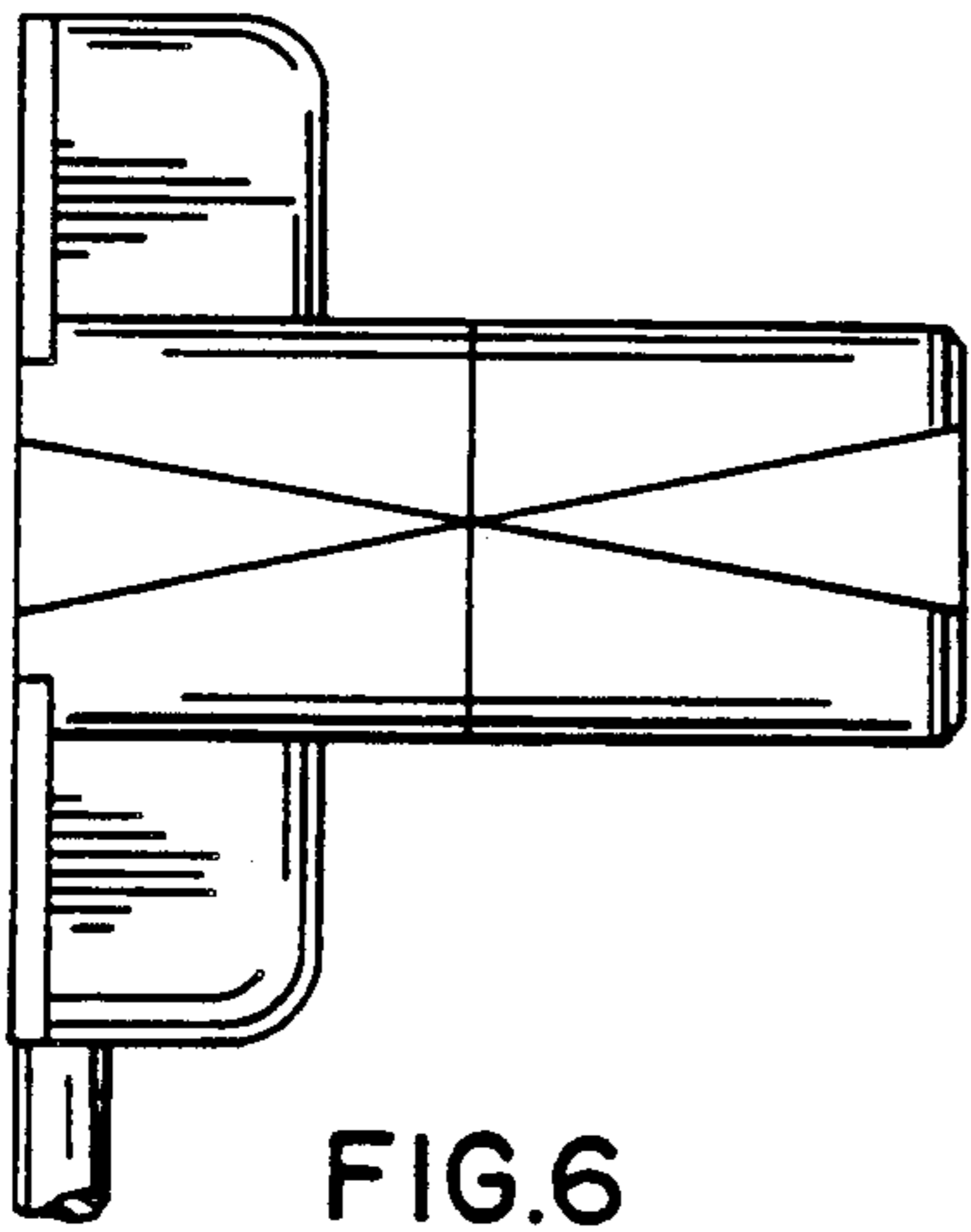

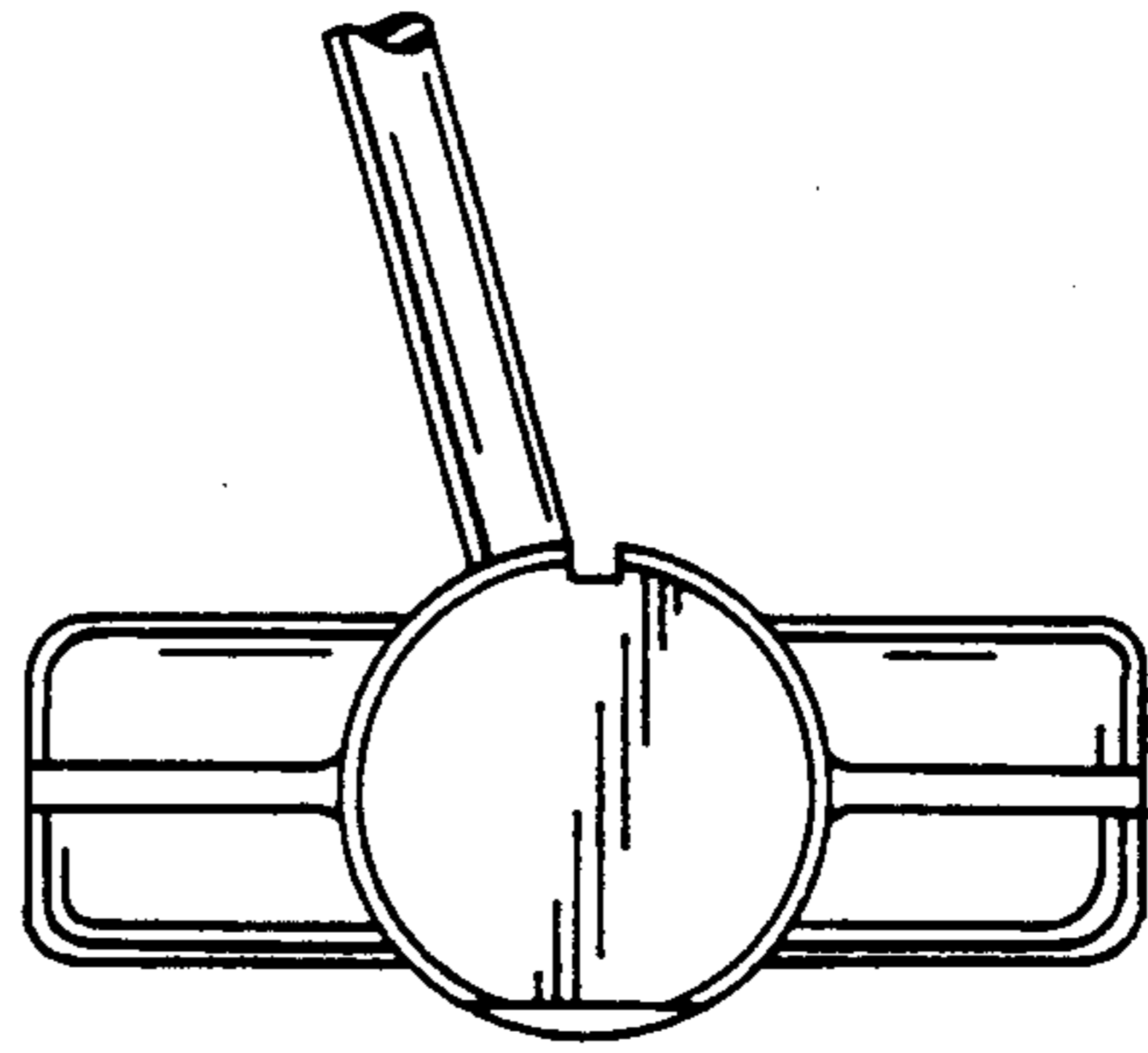

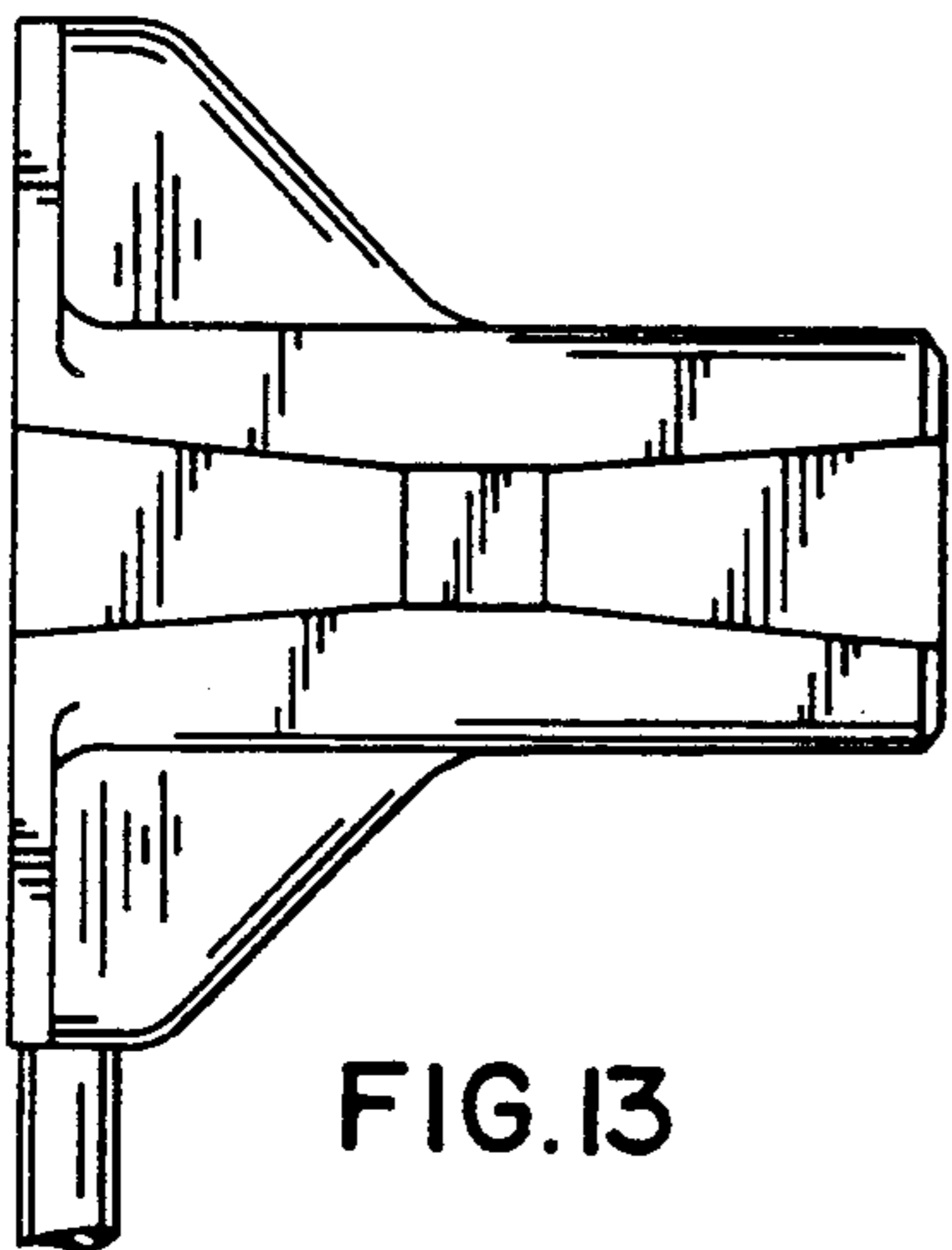

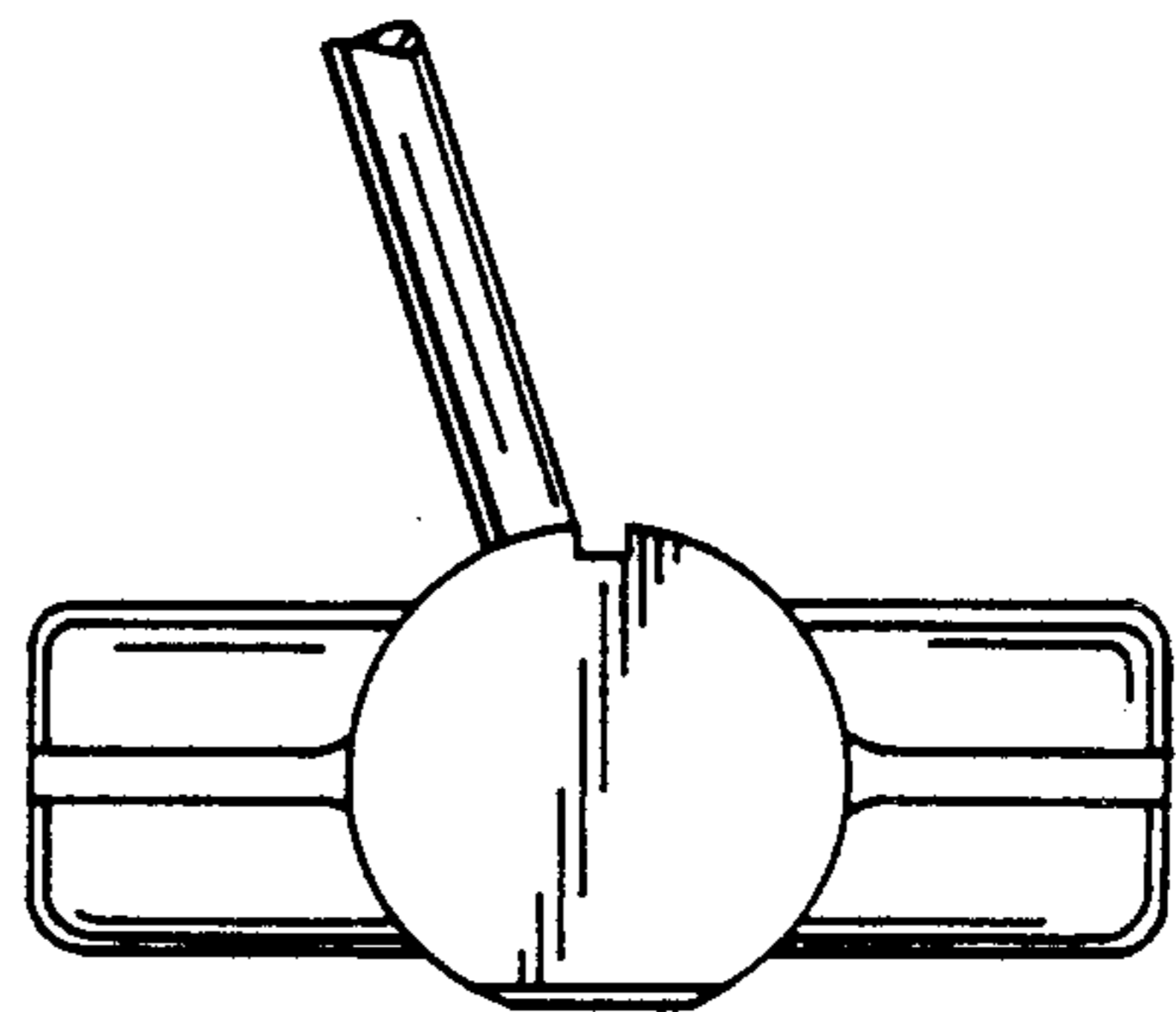

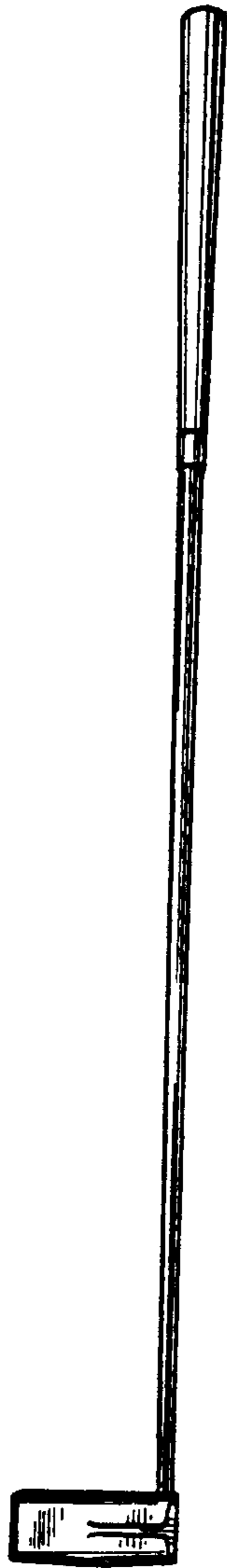

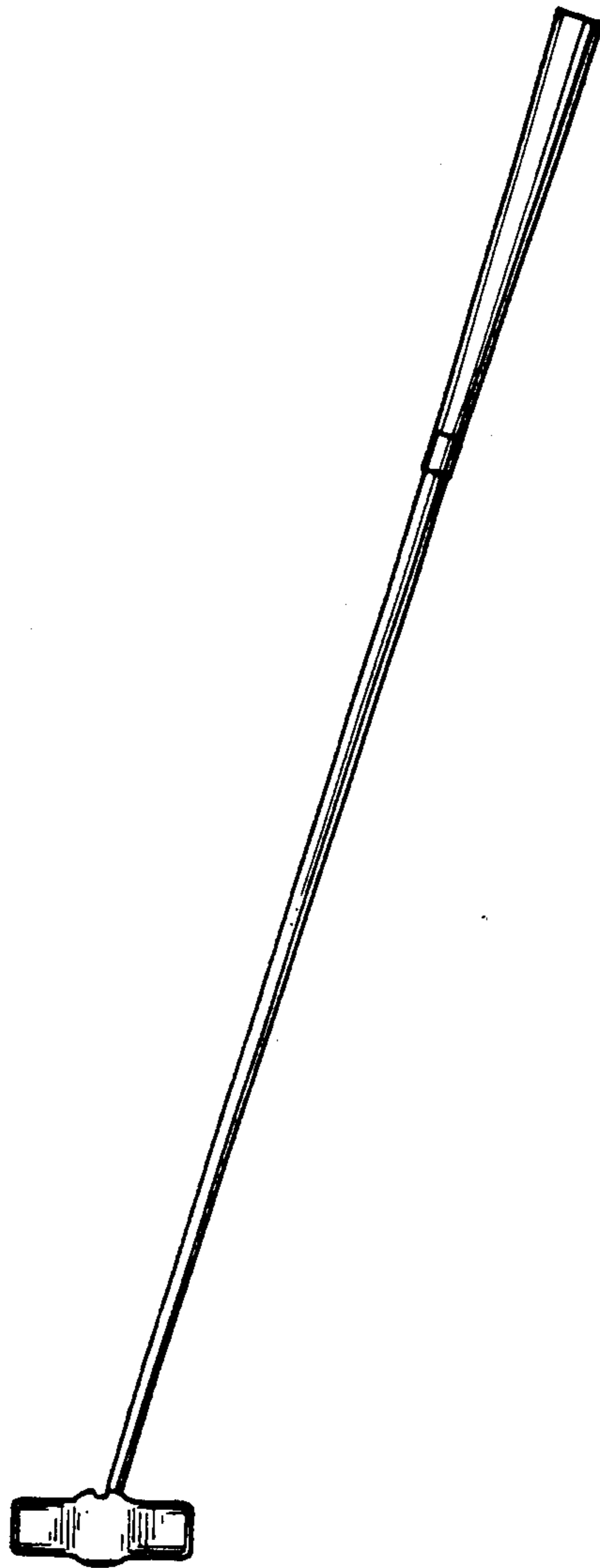

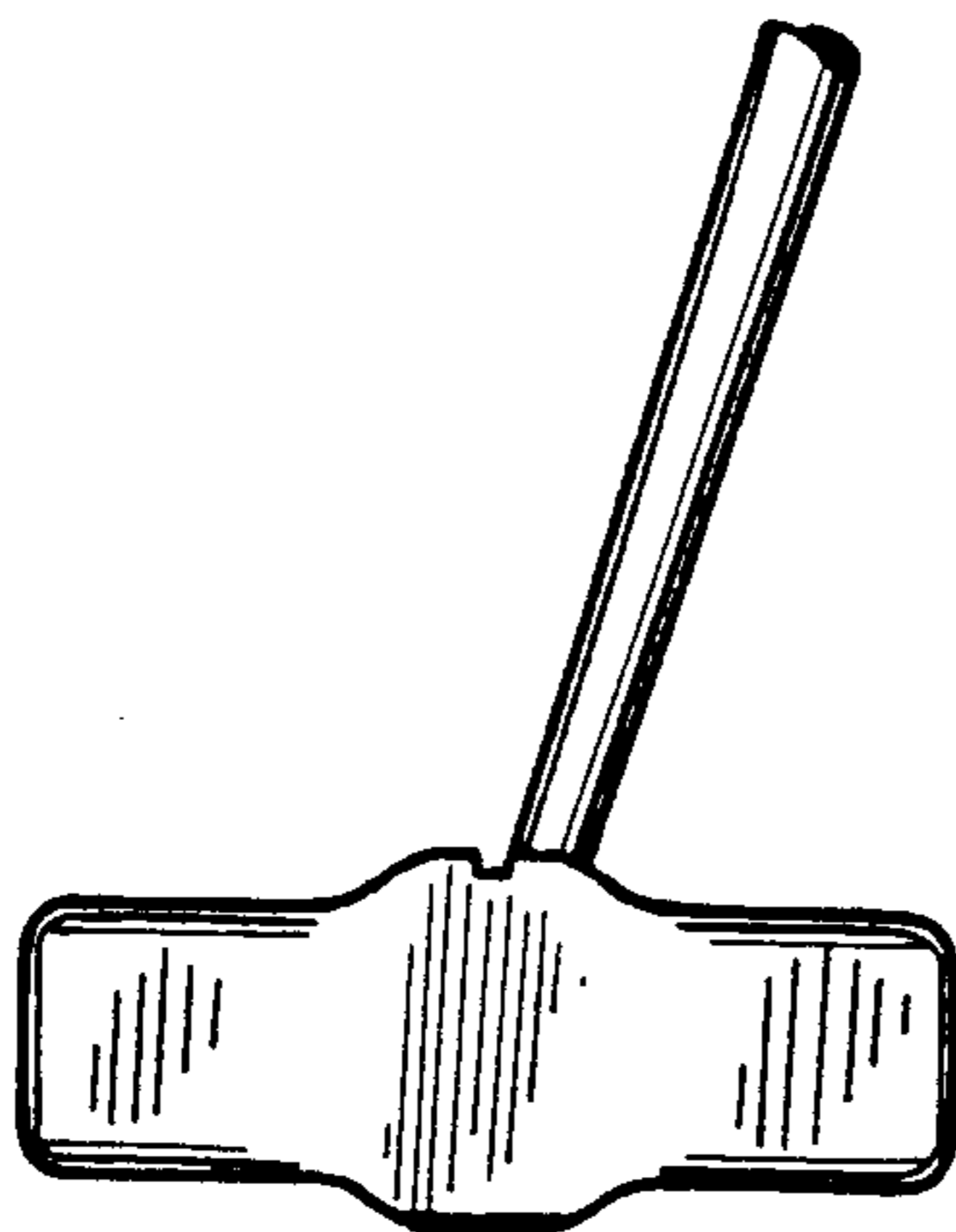

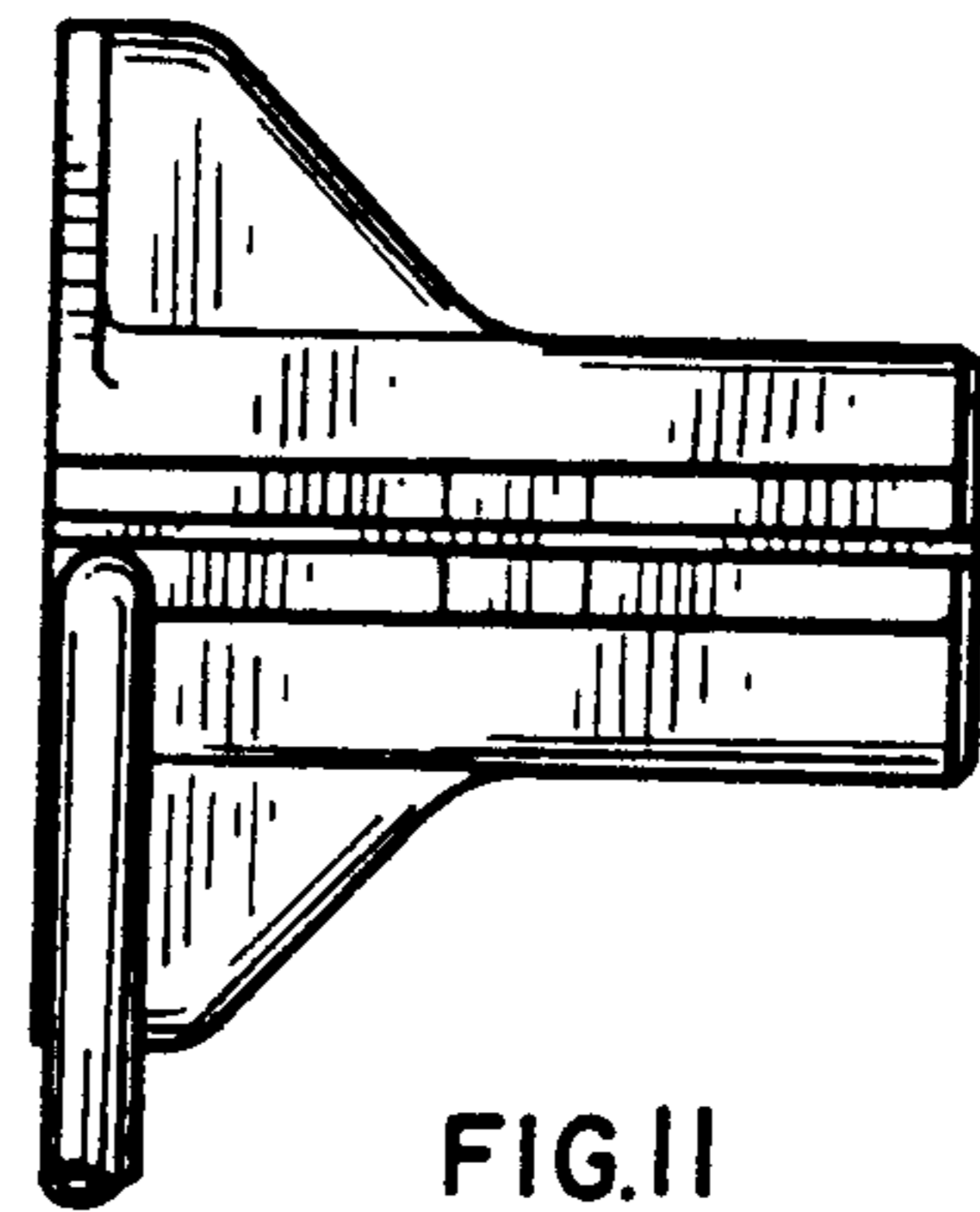

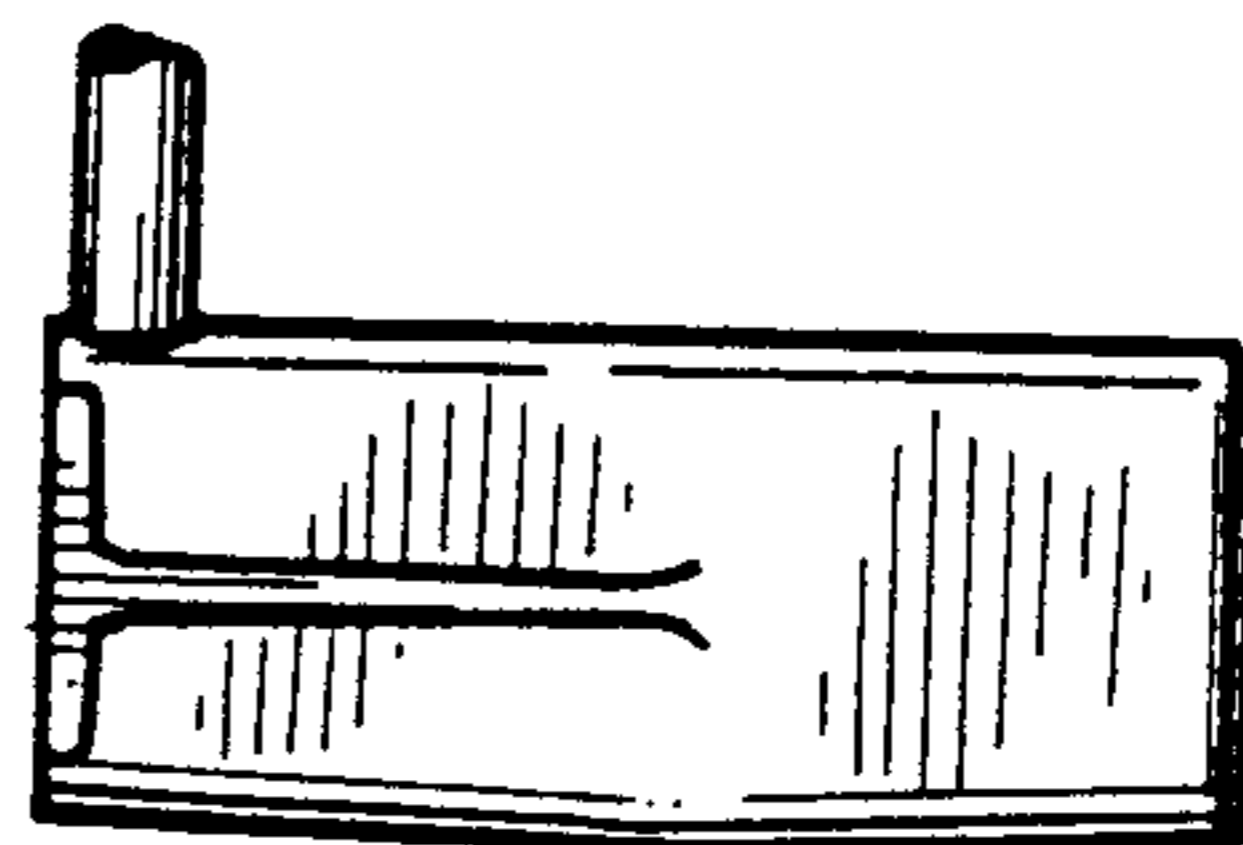
