DESCRIPTION

FIG. 1 is a perspective view of a faucet handle showing my new design;

FIG. 7 is a rear elevational view thereof.

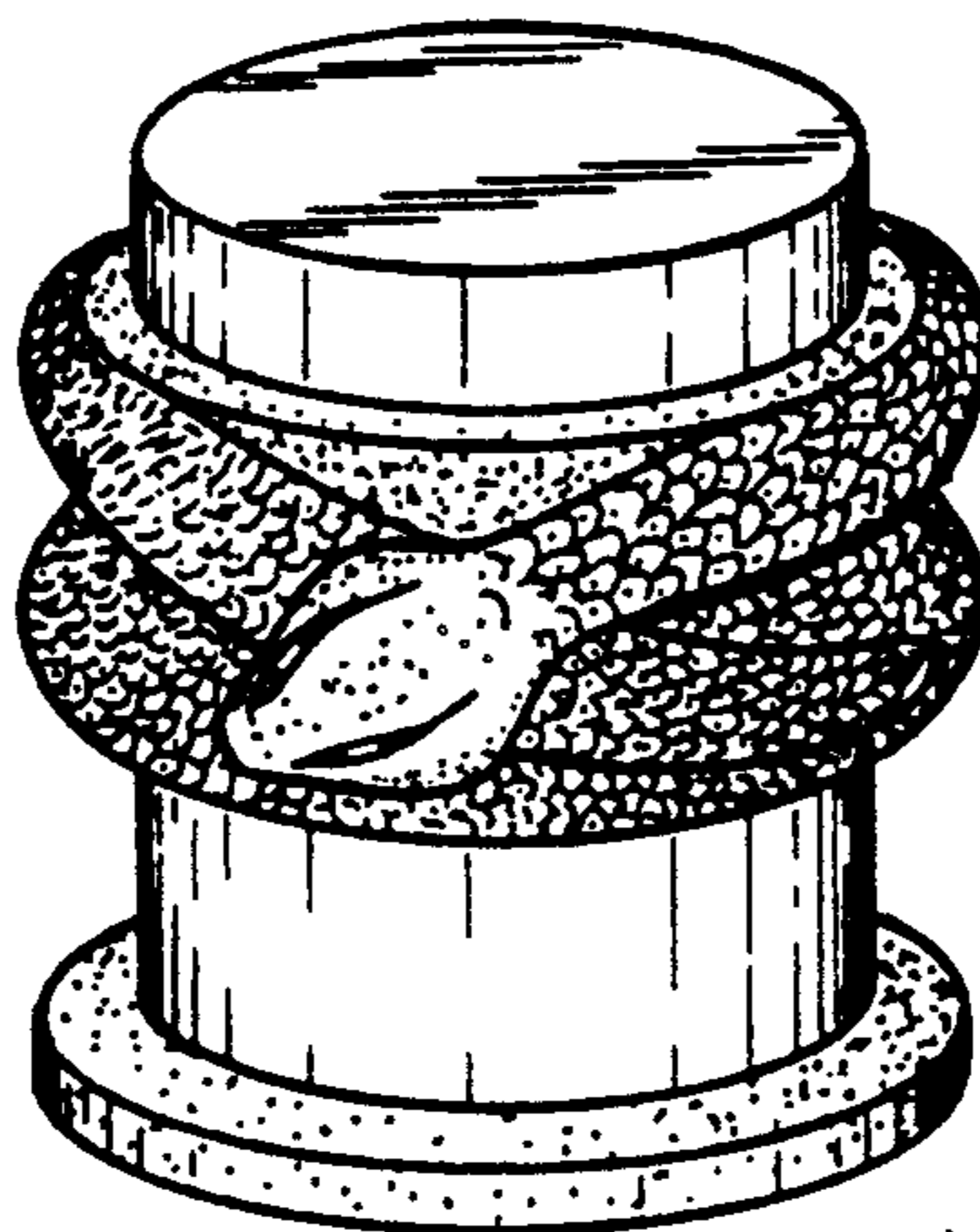

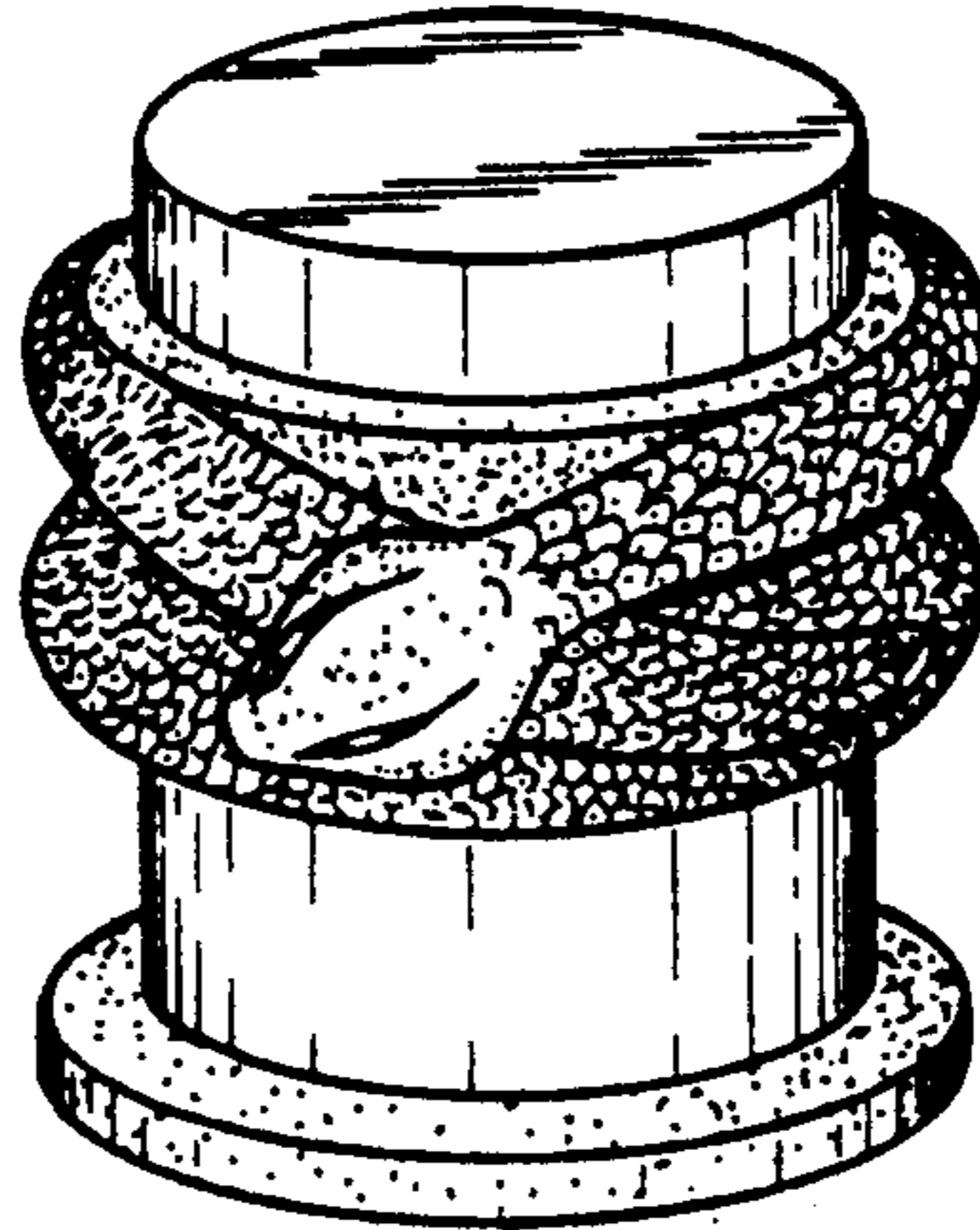

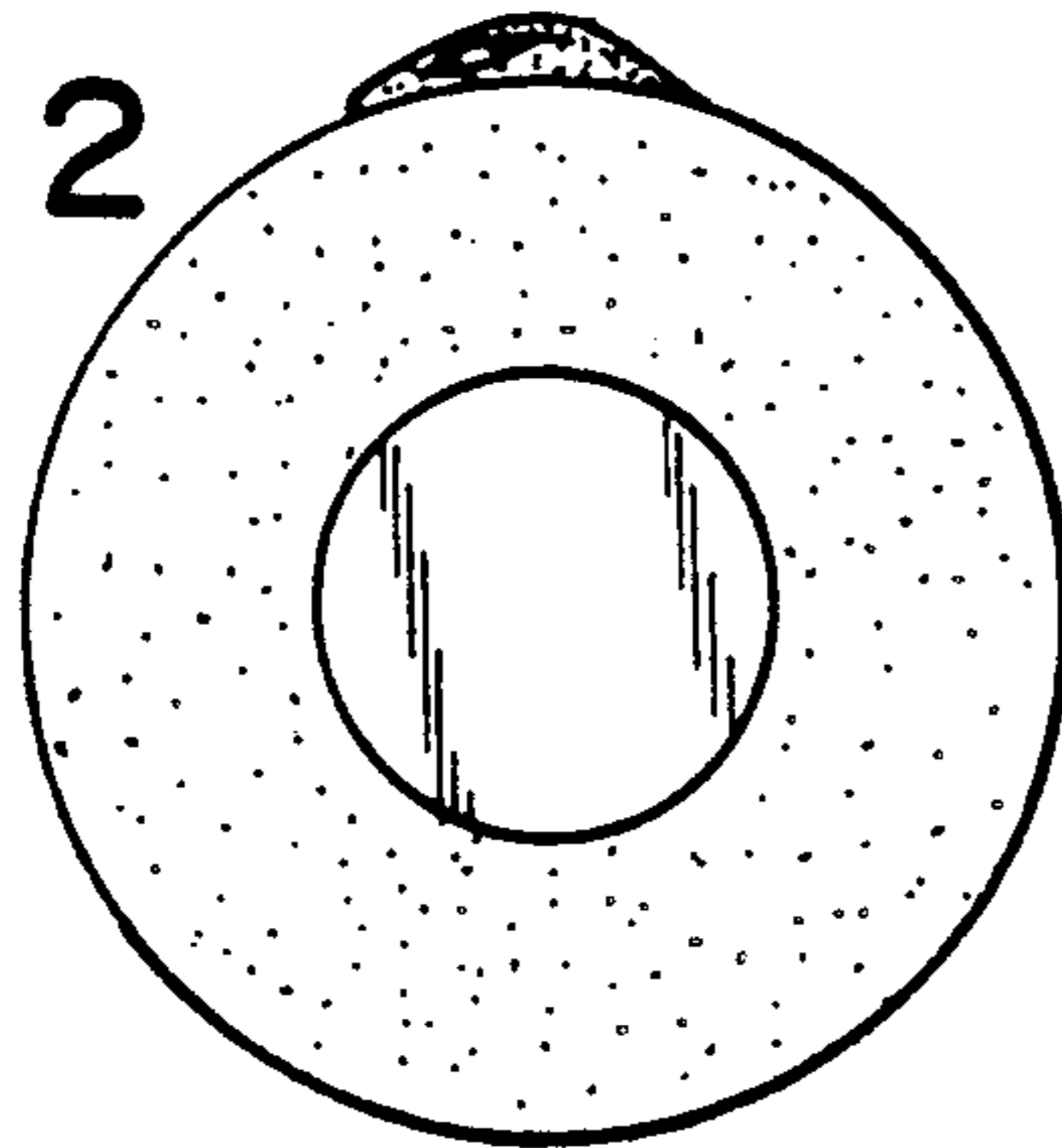

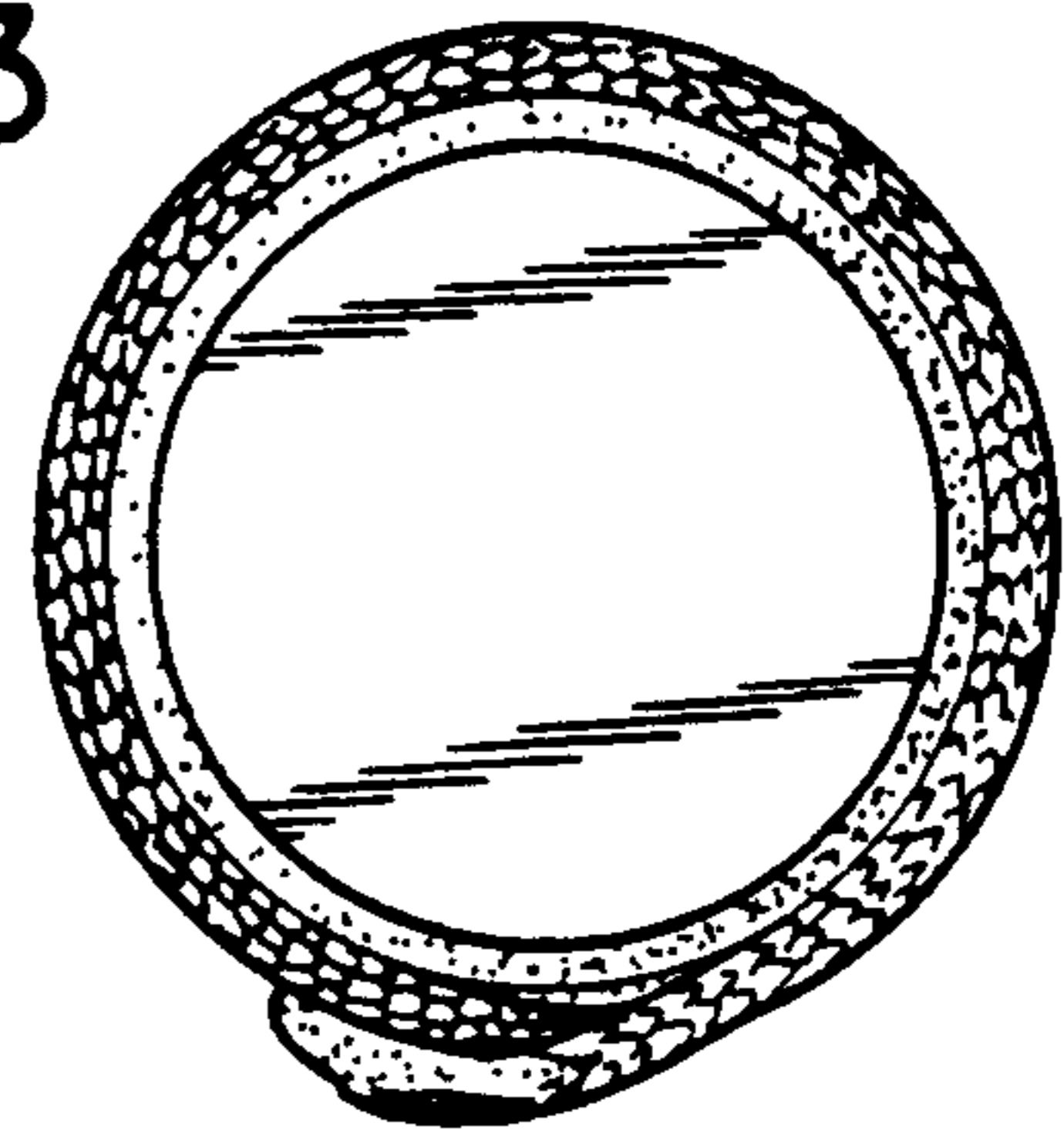

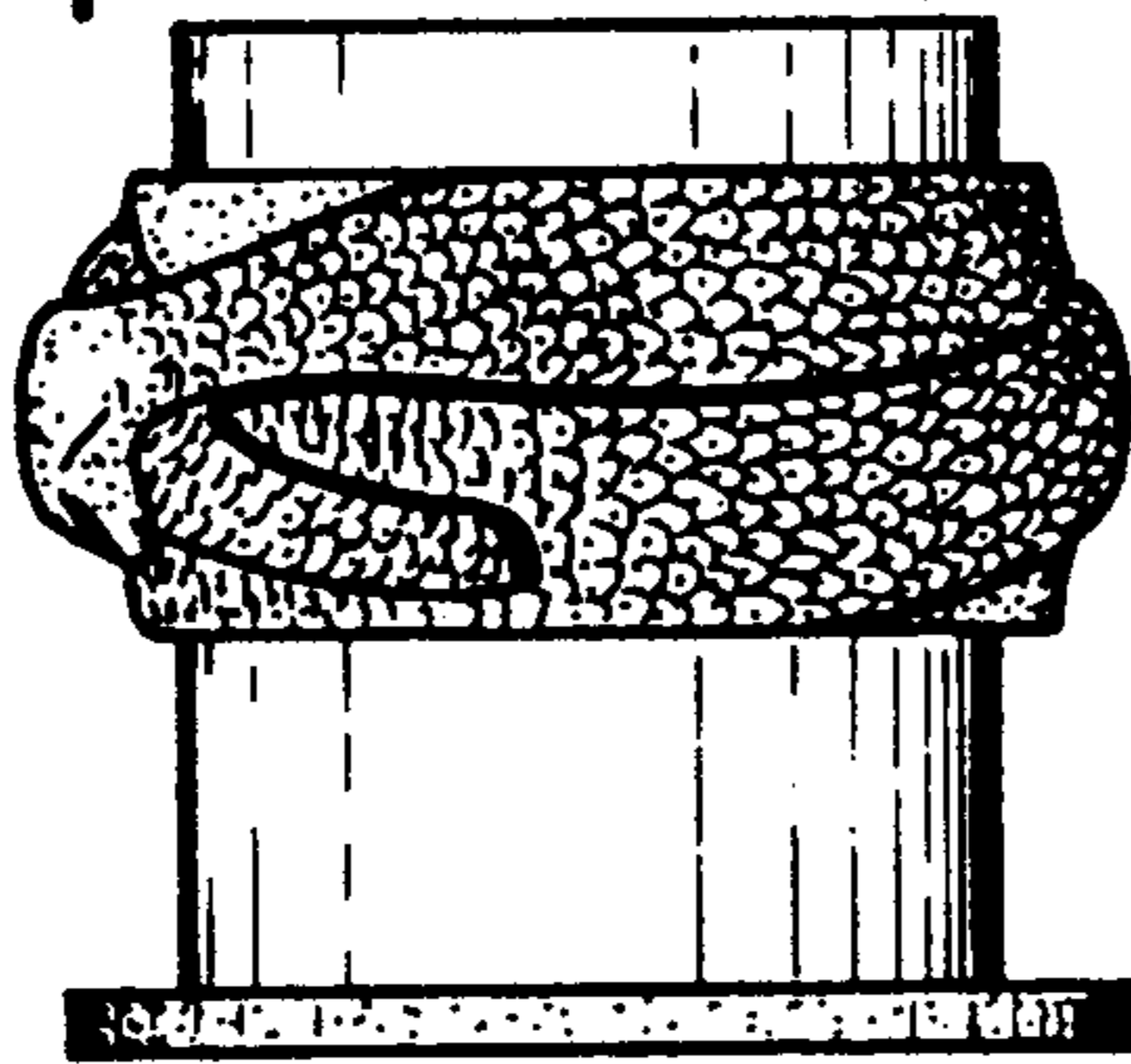

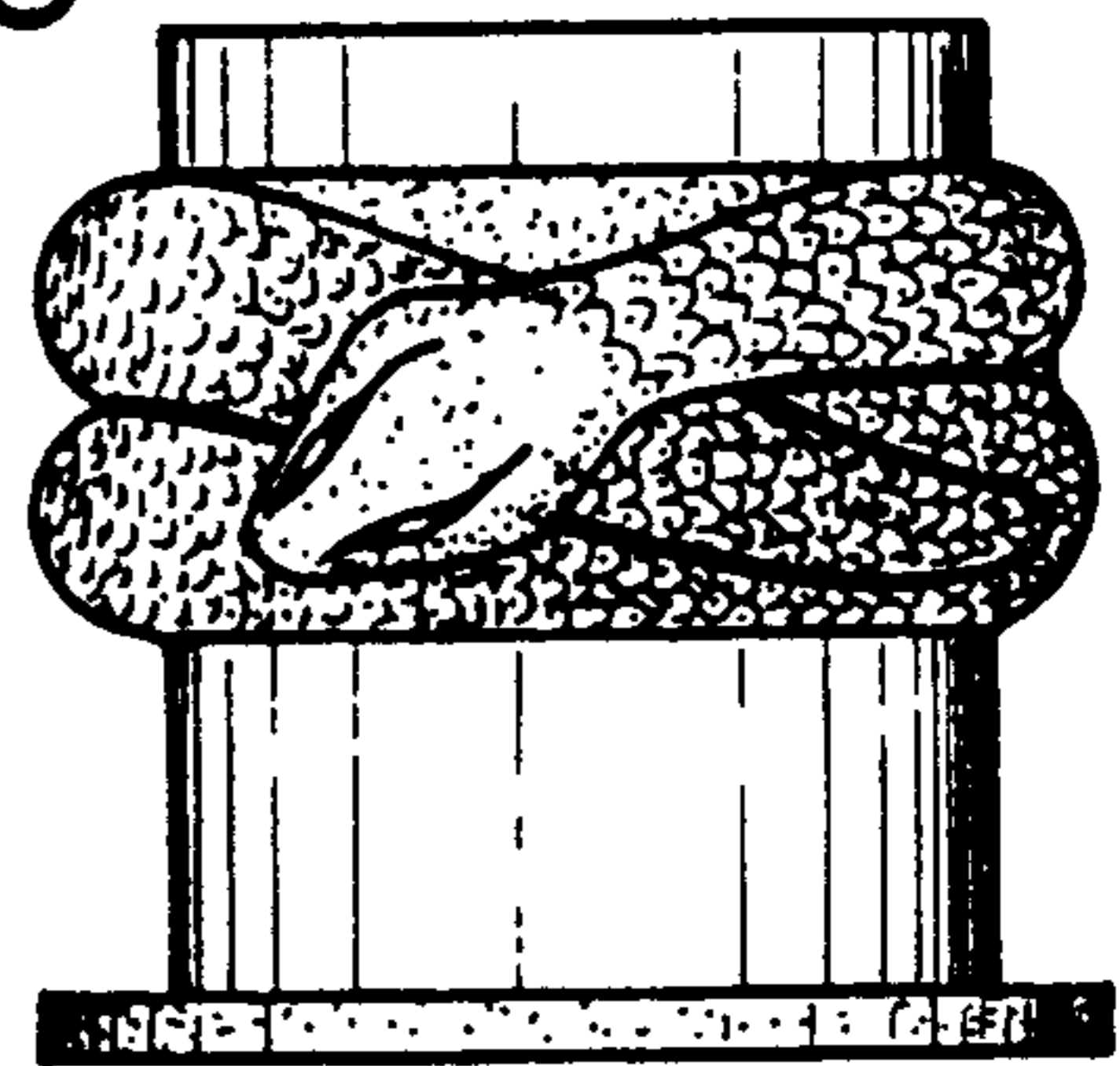

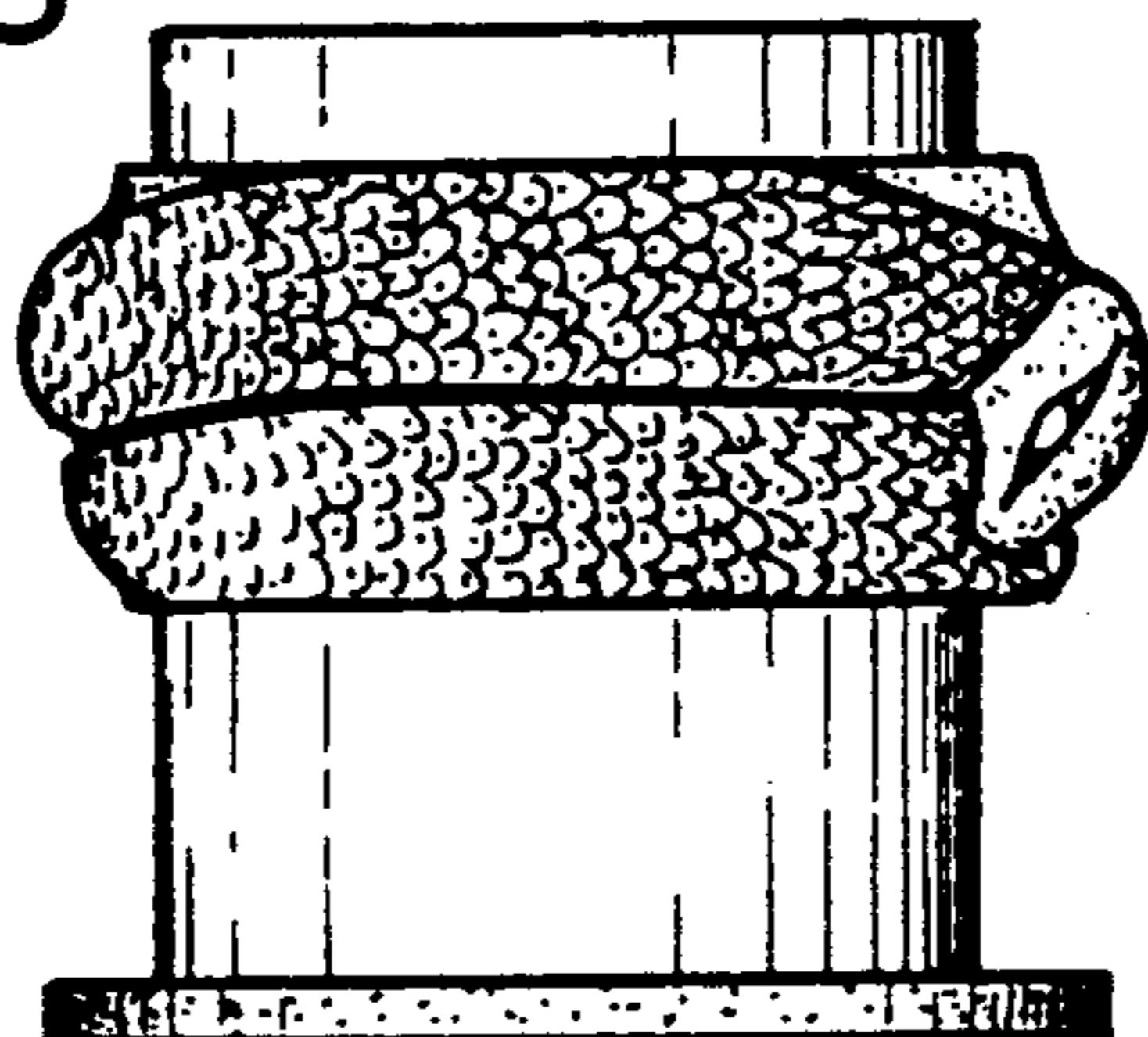
