DESCRIPTION

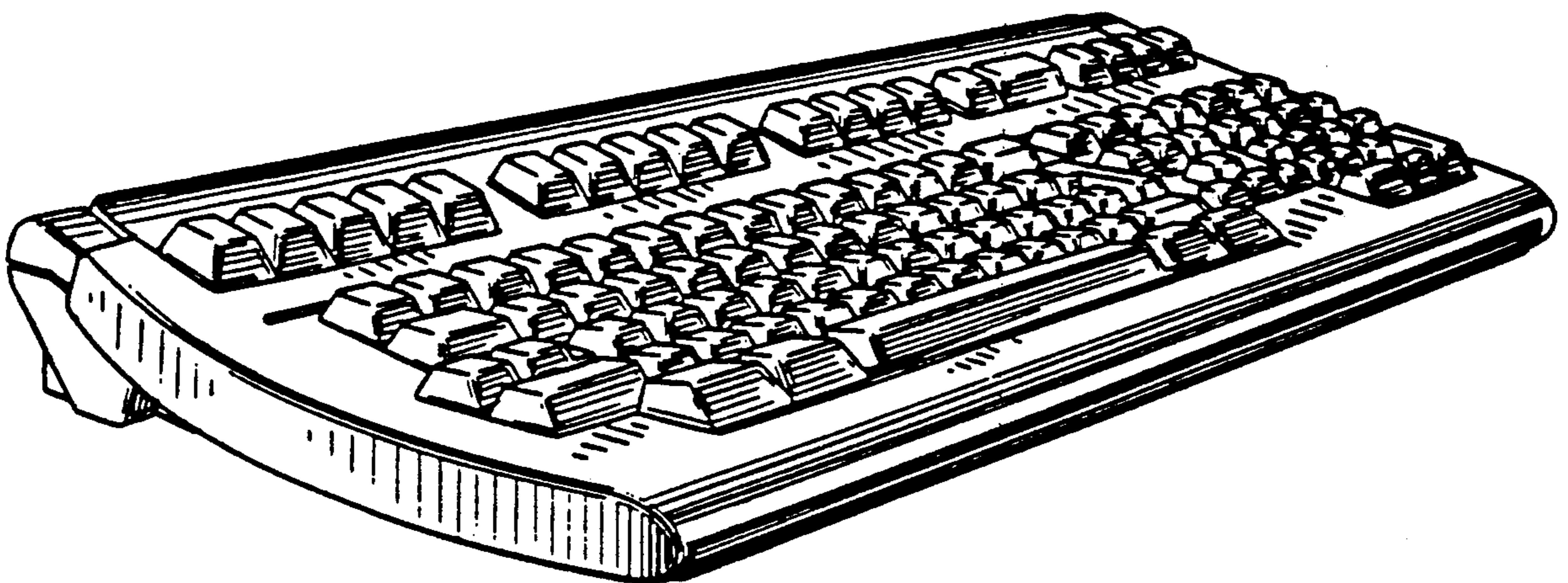
FIG. 1 is a top front left side perspective view of the

FIG. 5 is a bottom plan view thereof.



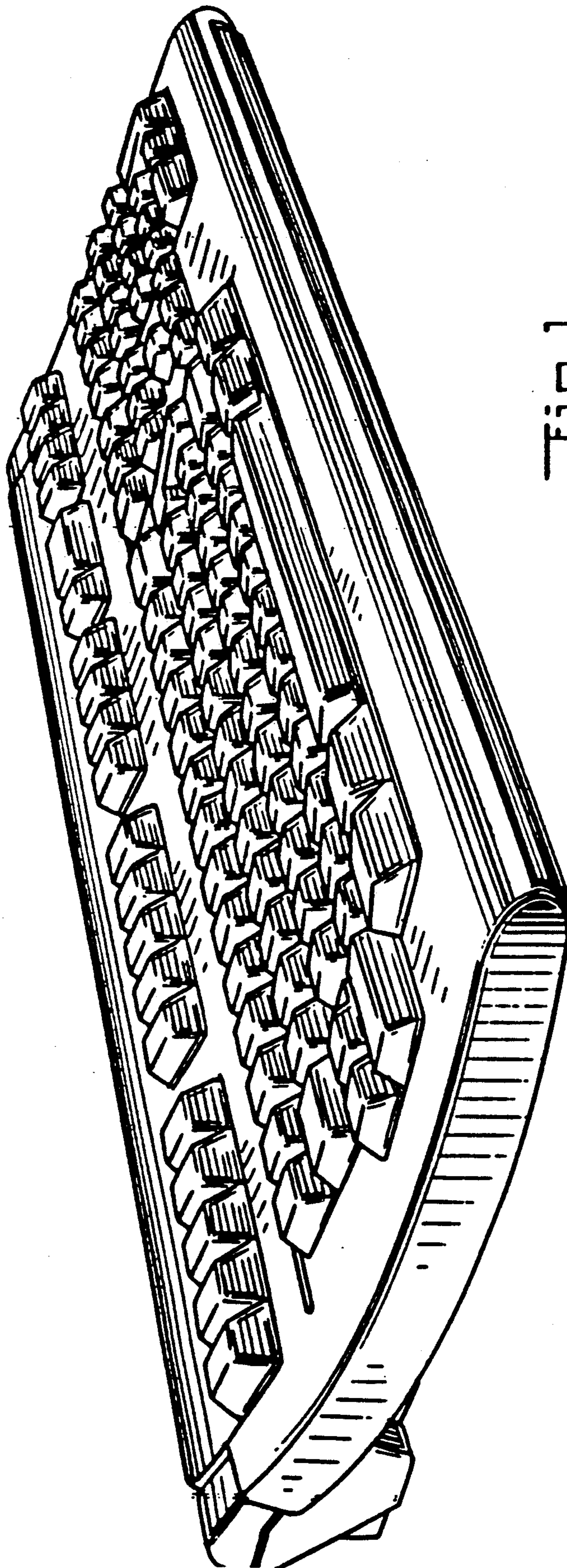

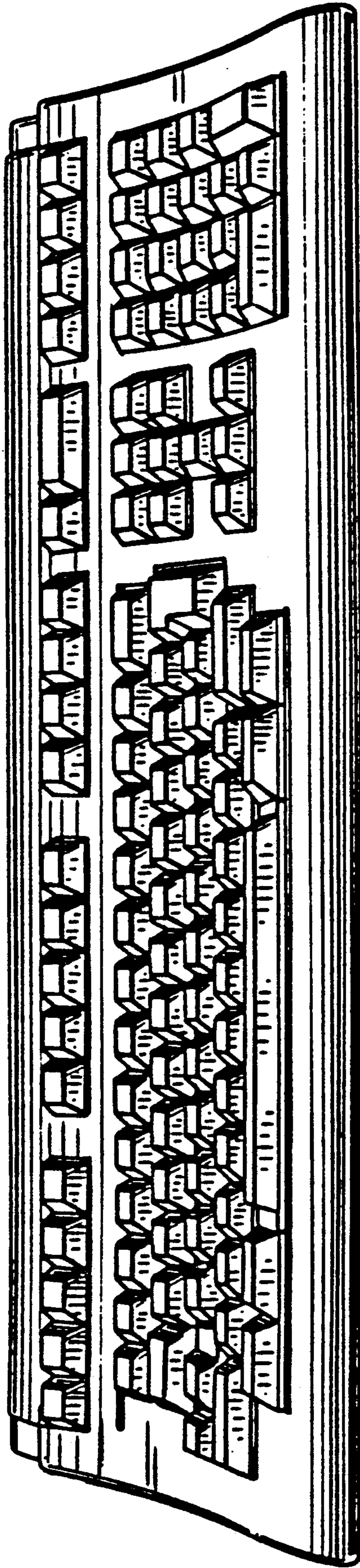

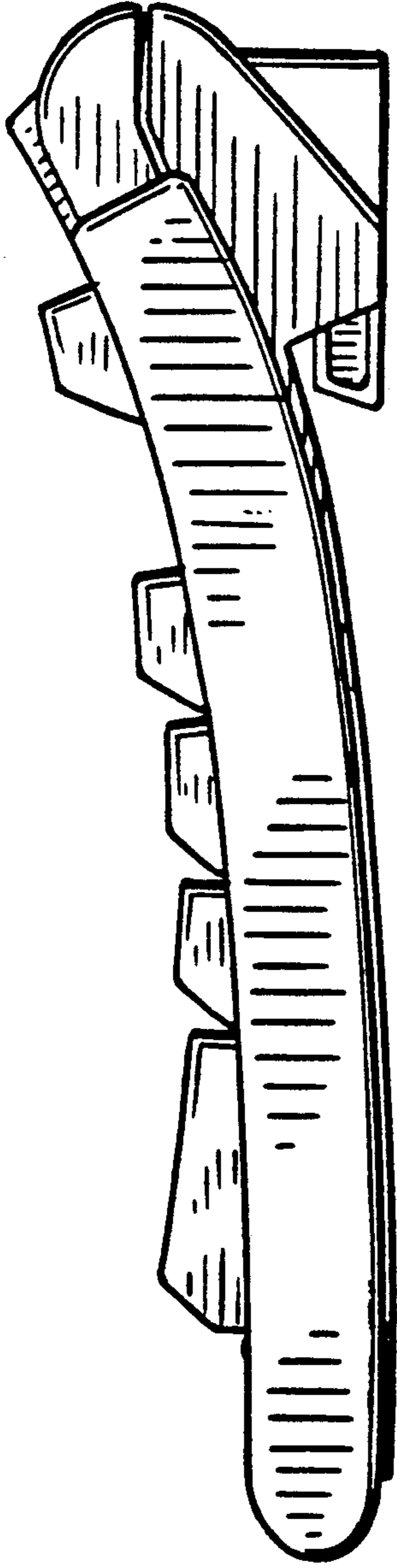

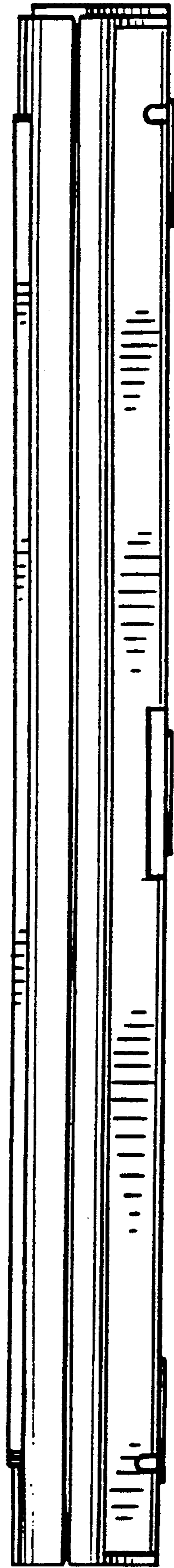
