[57] **CLAIM**

The ornamental design for the telephone dialing-key cover, as shown and described.

DESCRIPTION

FIG. 1 is a top, left, front perspective view of a telephone dialing key cover showing my new design; FIG. 2 is a front elevational view thereof; FIGS. 3 and 4 are respectively top and bottom plan views thereof; FIG. 5 is a rear elevational view thereof and FIGS. 6 and 7 are respectively left and right side elevational views thereof;
