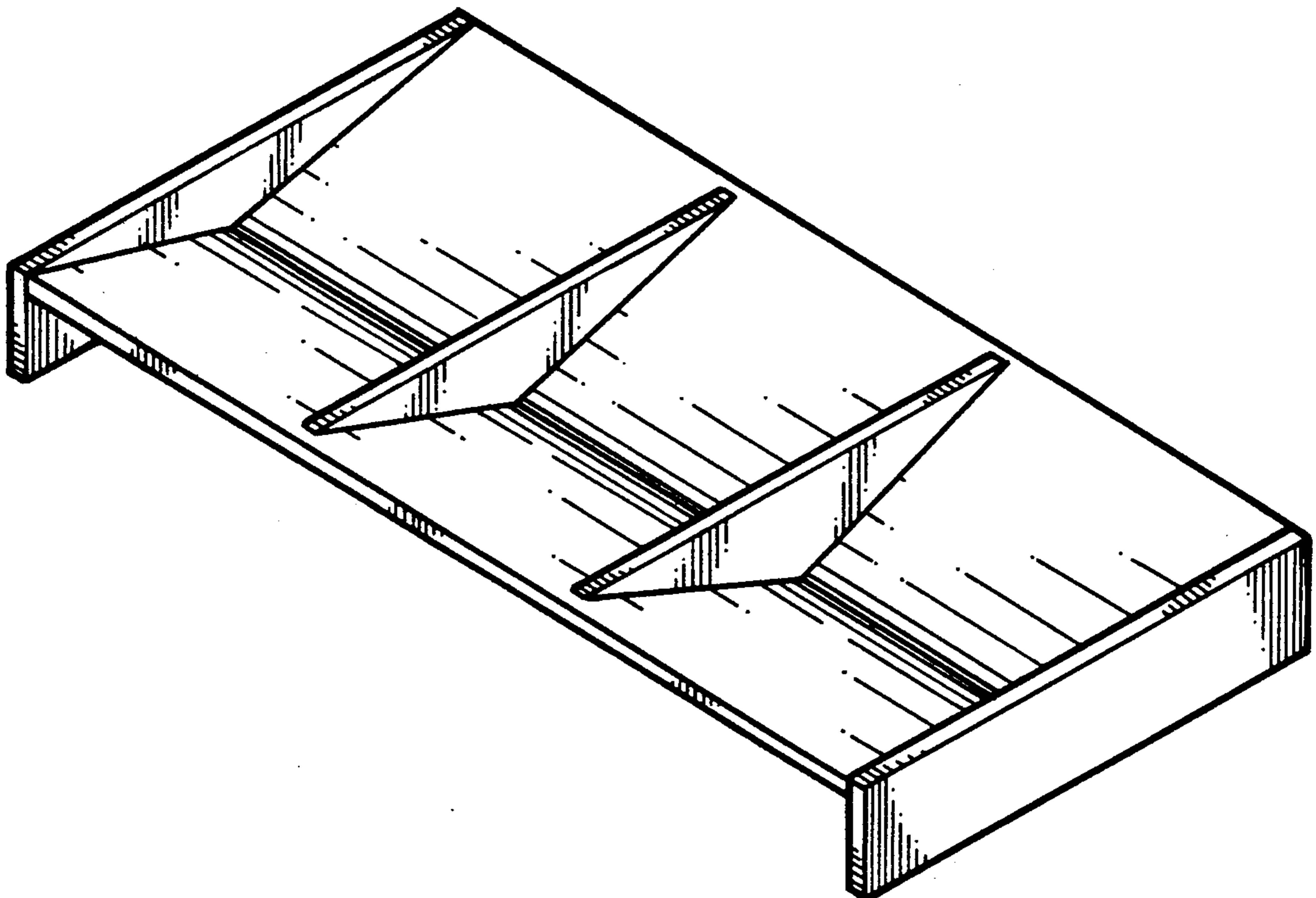

[57] **CLAIM**

The ornamental design for a compartmented serving tray, as shown and described.

DESCRIPTION

FIG. 1 is a top and side perspective view of a compartmented serving tray showing my new design; FIG. 2 is a top plane view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevational view thereof, the rear being identical to the front view shown; and FIG. 5 is a side elevational view thereof, the opposite side being identical to the side shown.



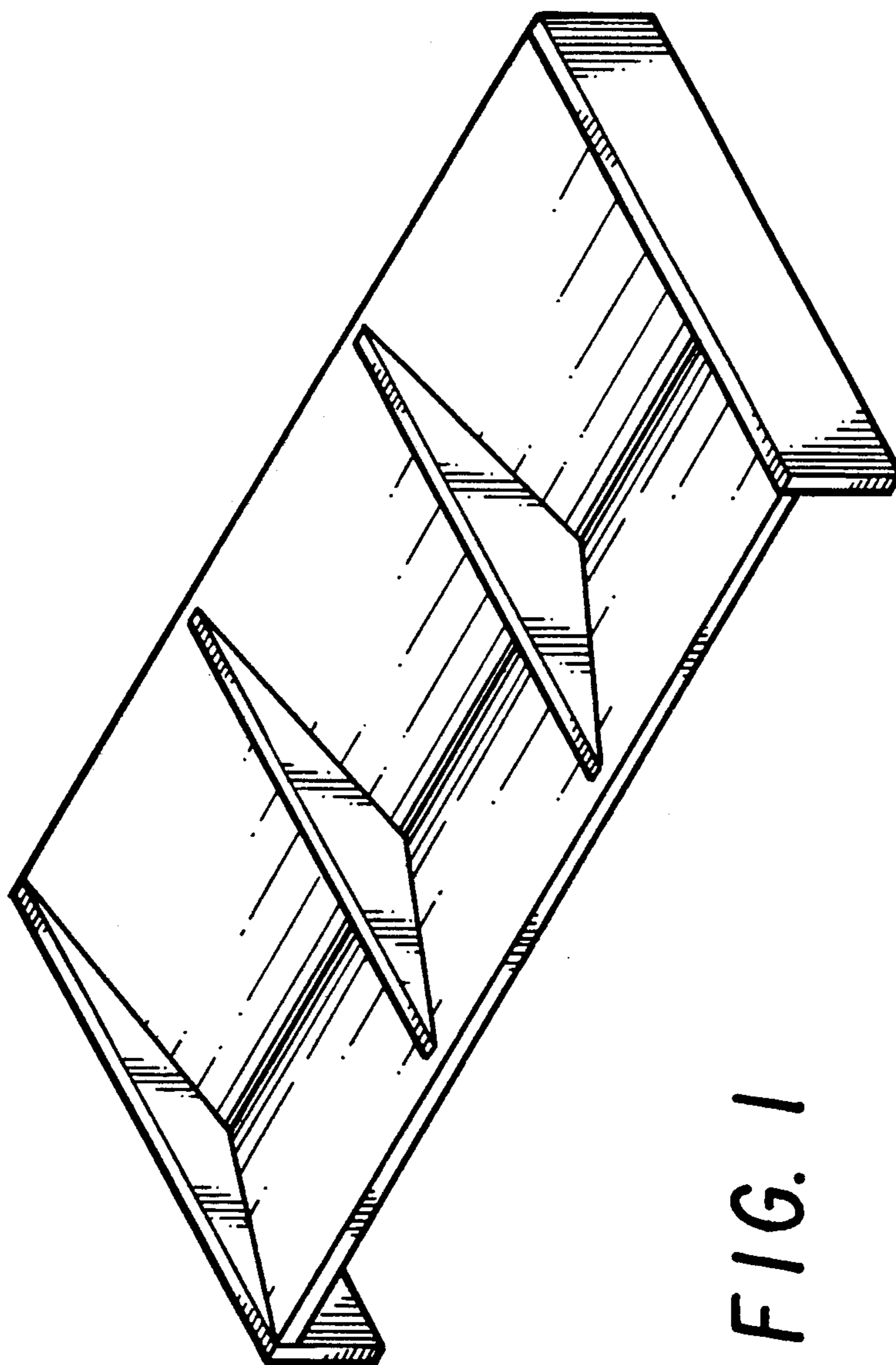

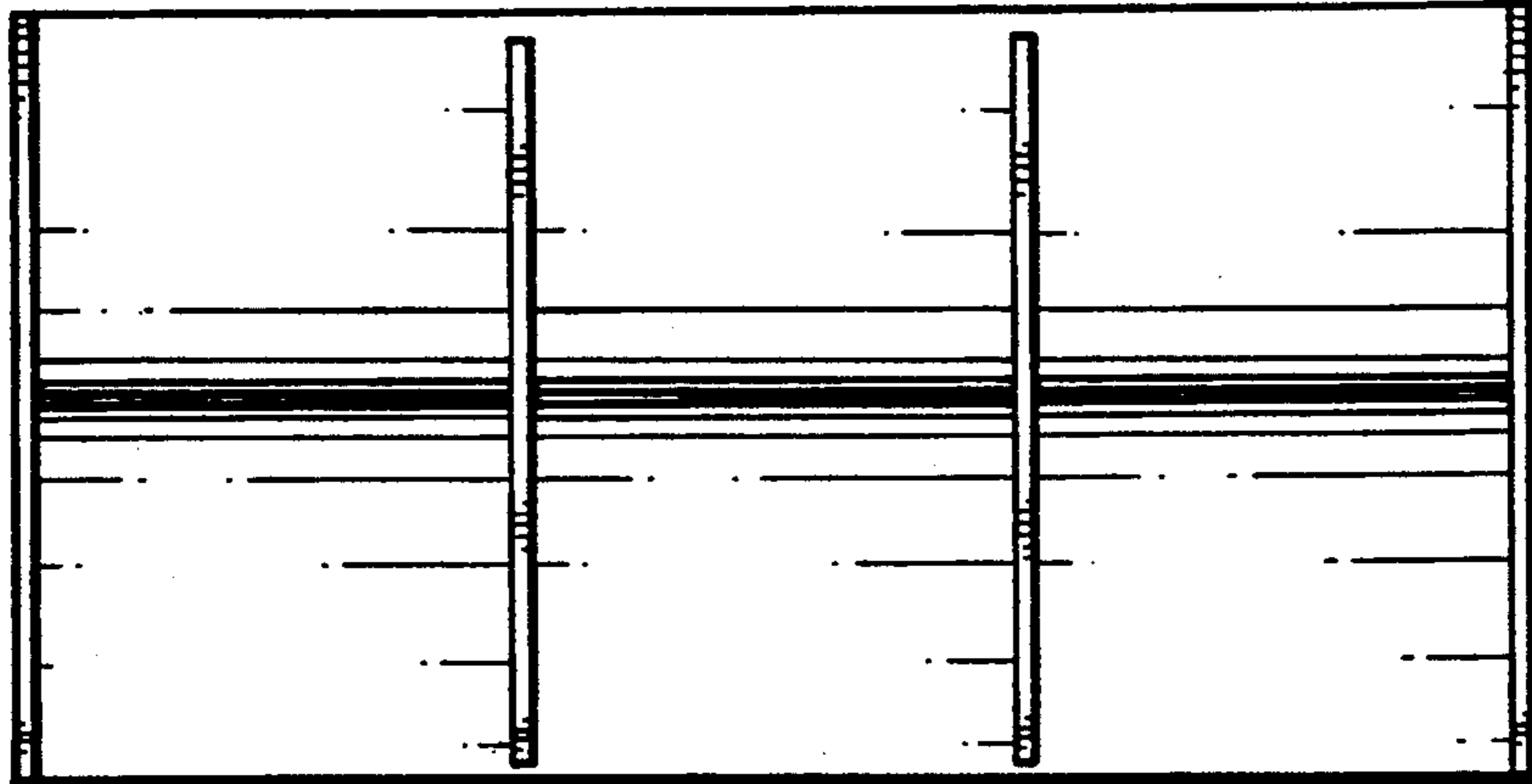

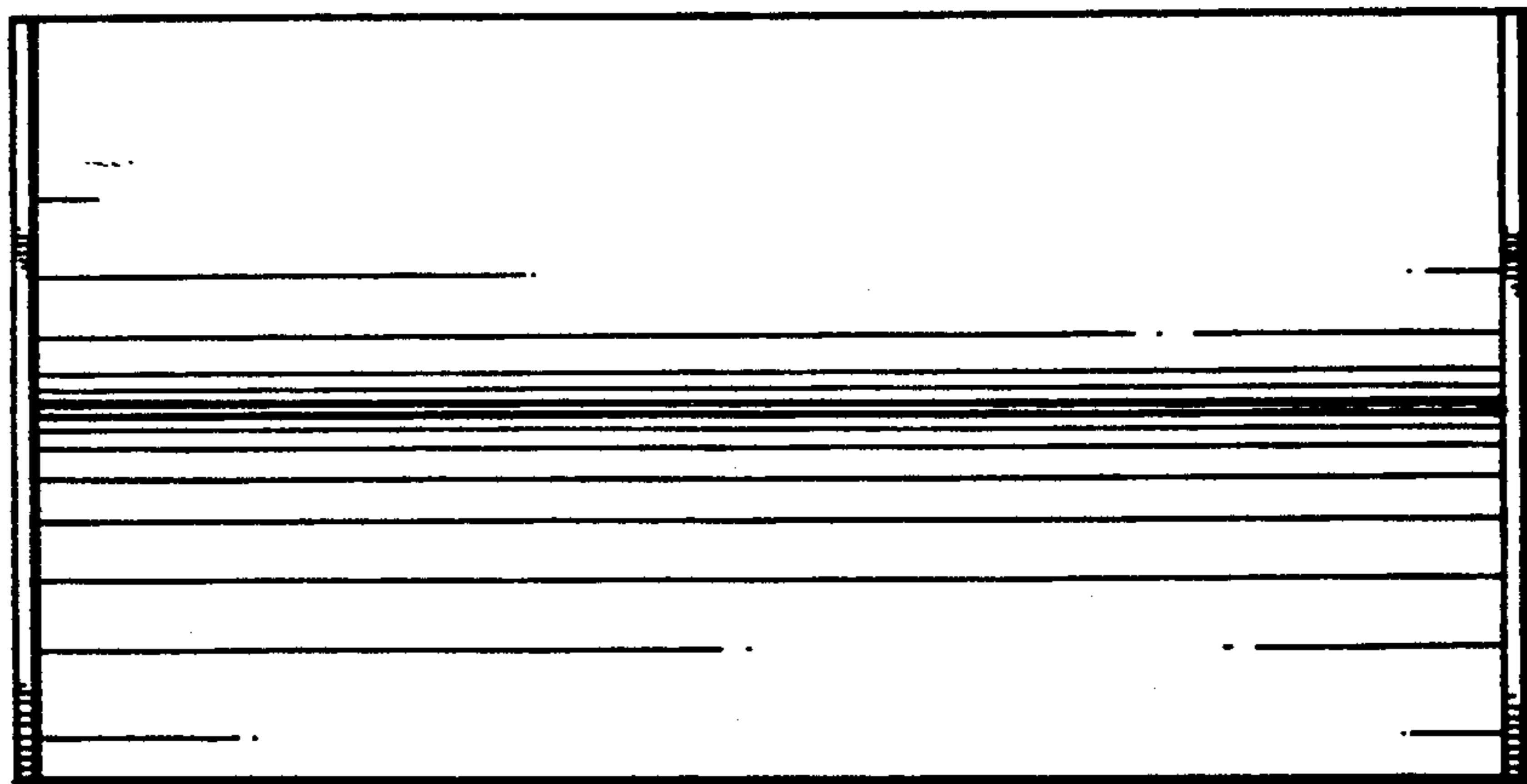

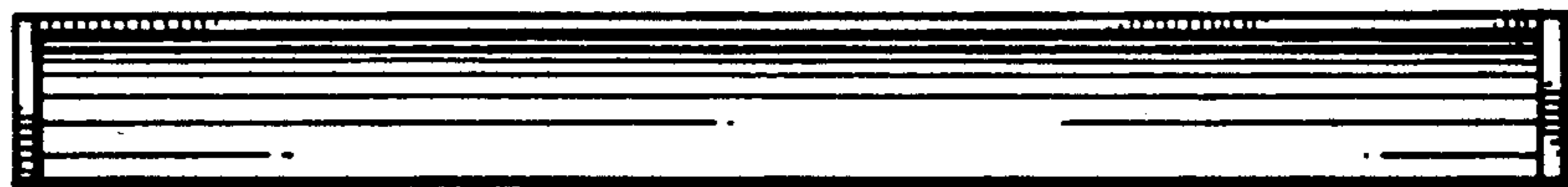
