and described.

DESCRIPTION

FIG. 29 is a front elevational view thereof.

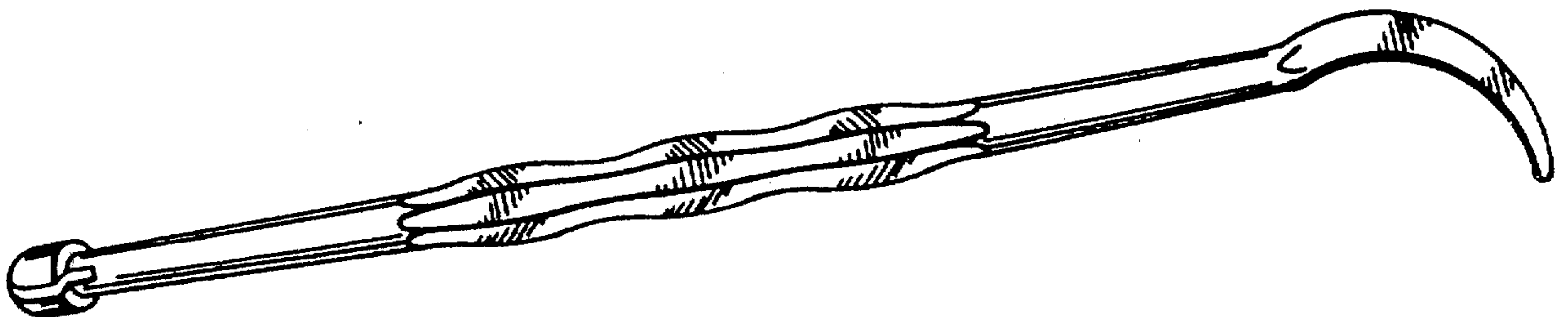

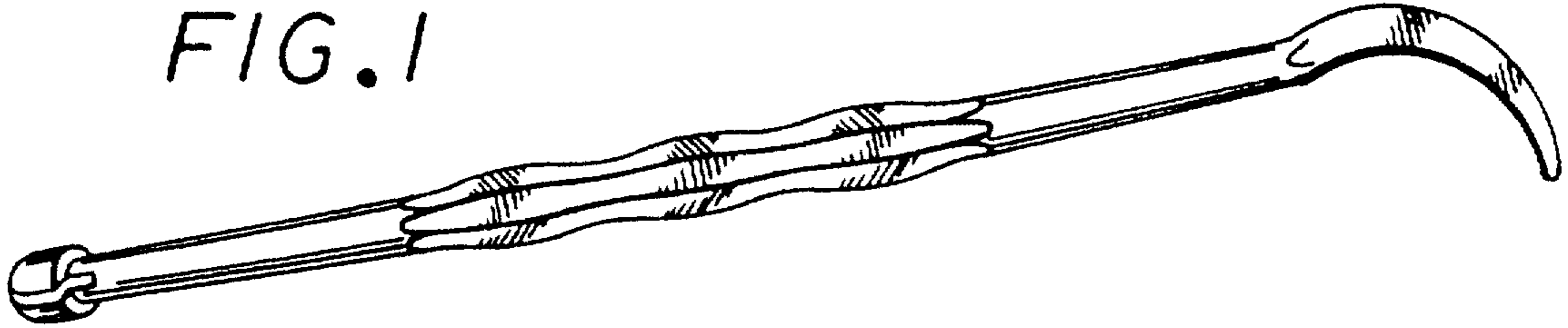

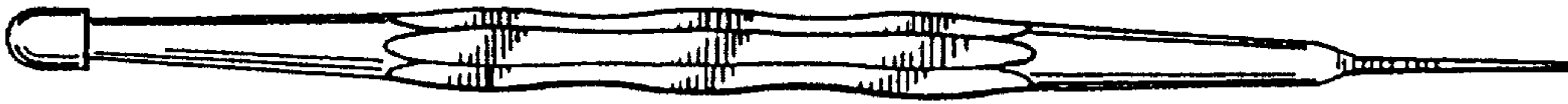

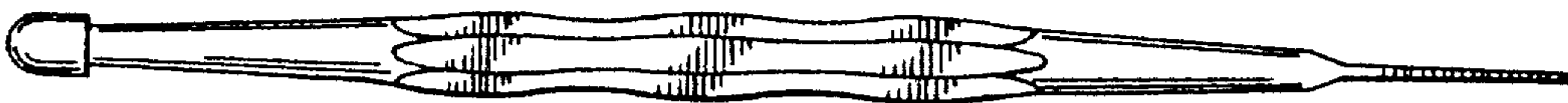

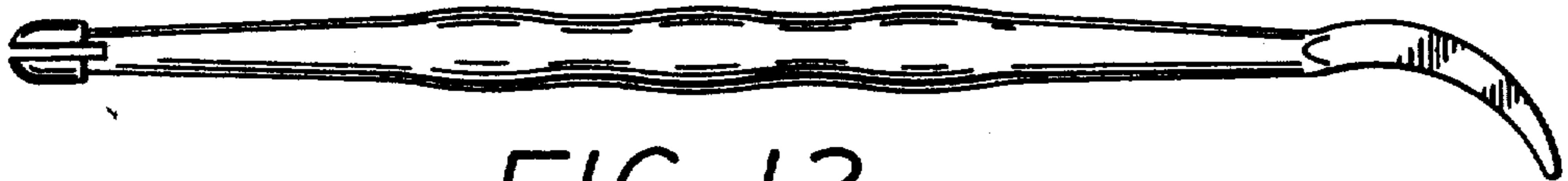

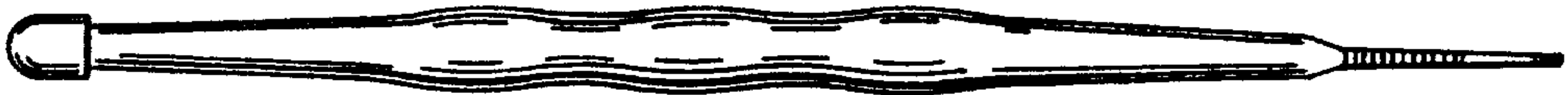

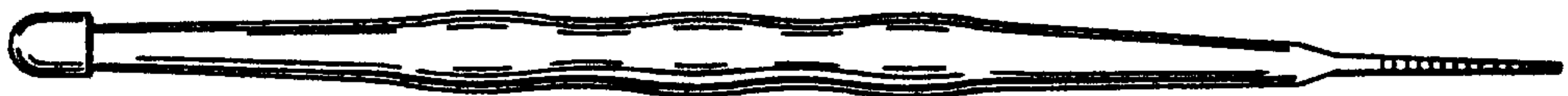

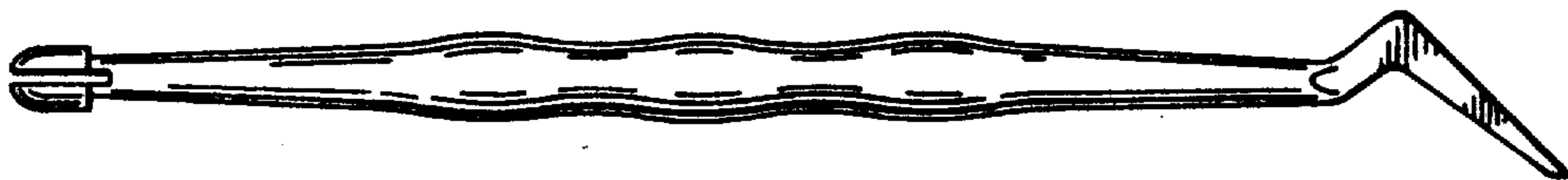

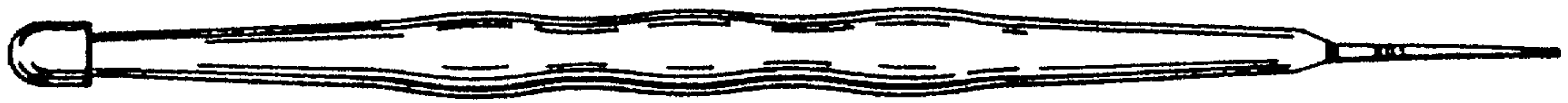

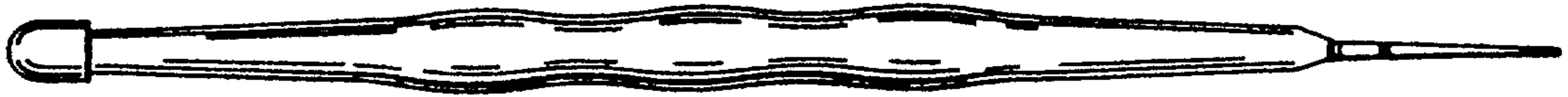

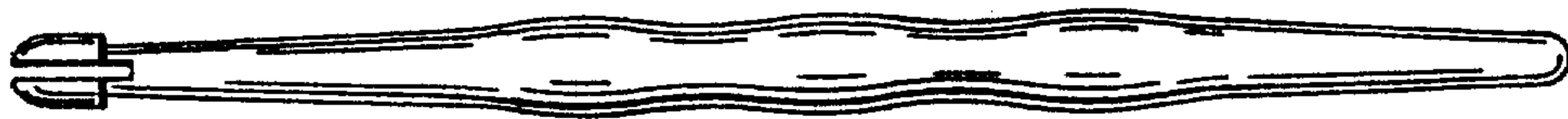

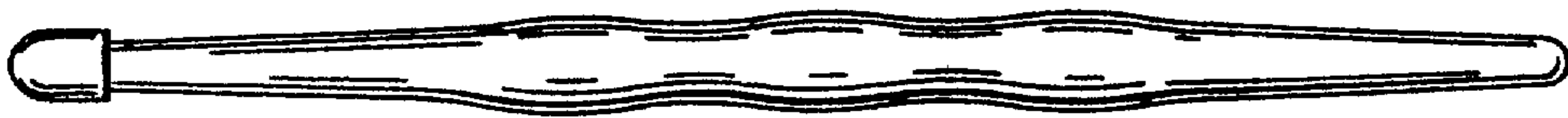
