DESCRIPTION

 FIG. 24 is a front elevational view of the shelf unit of FIG. 22.

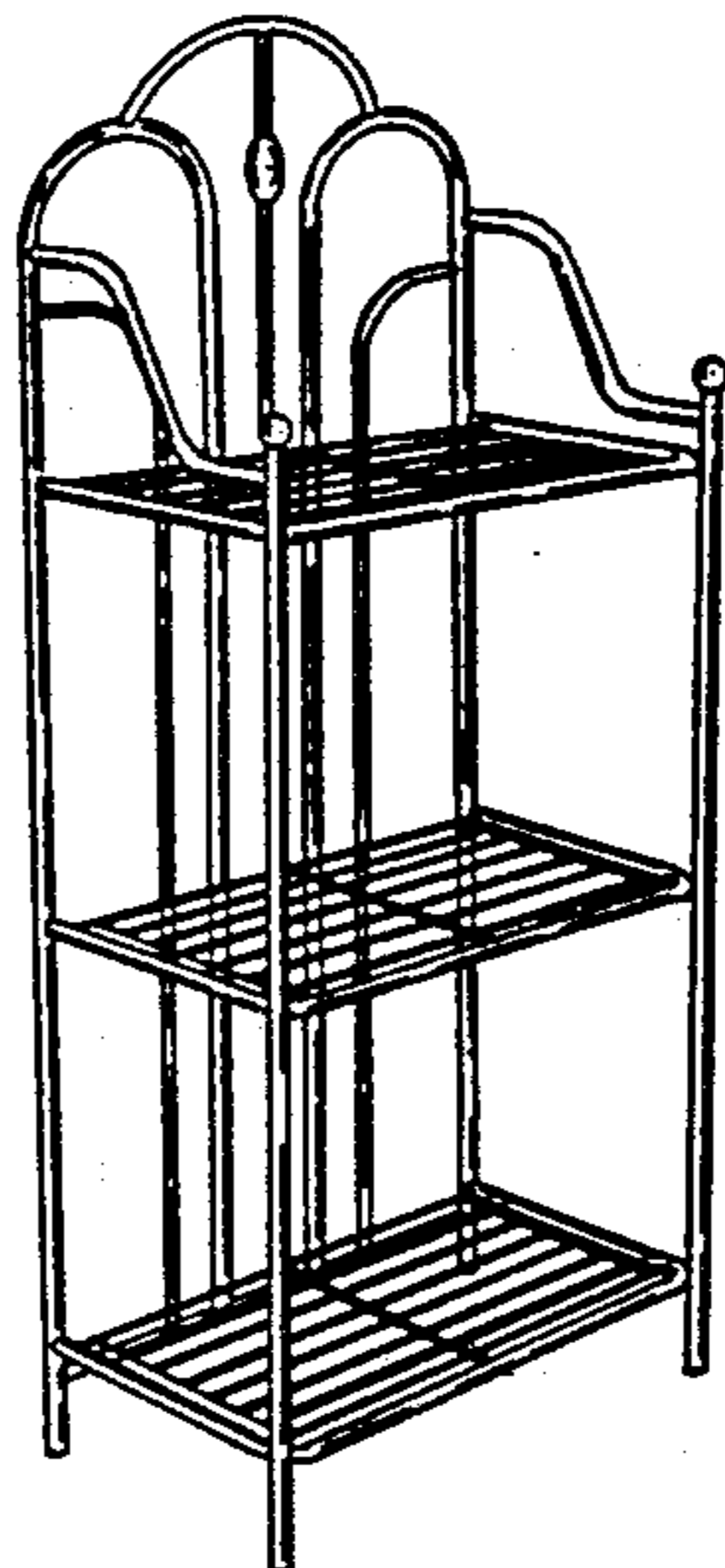

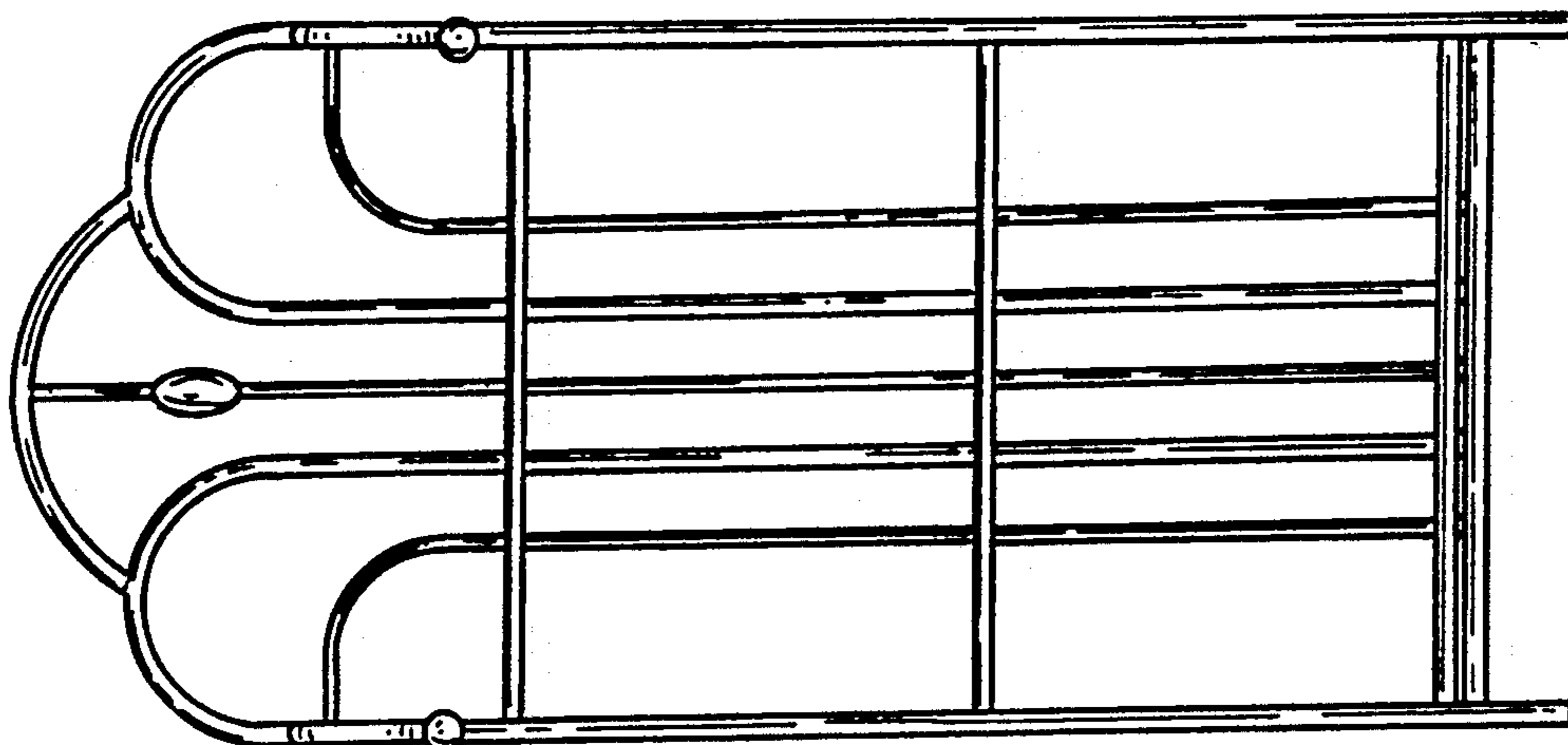

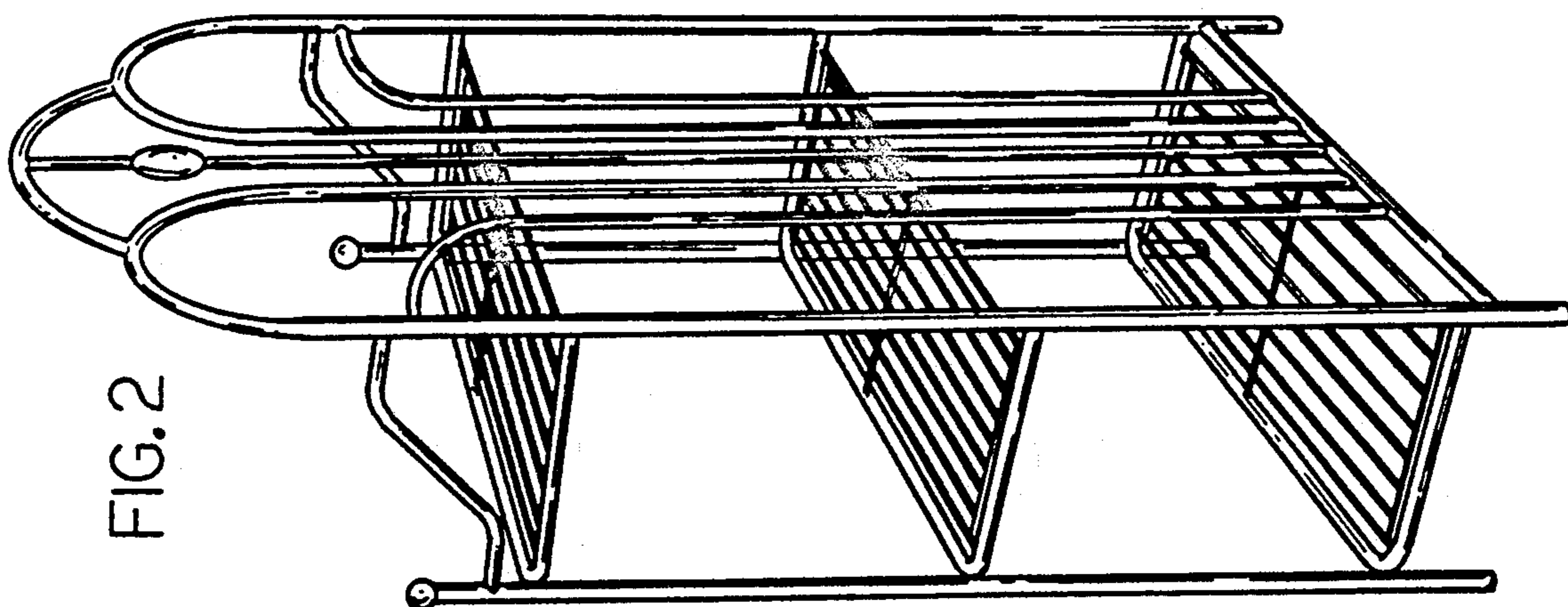
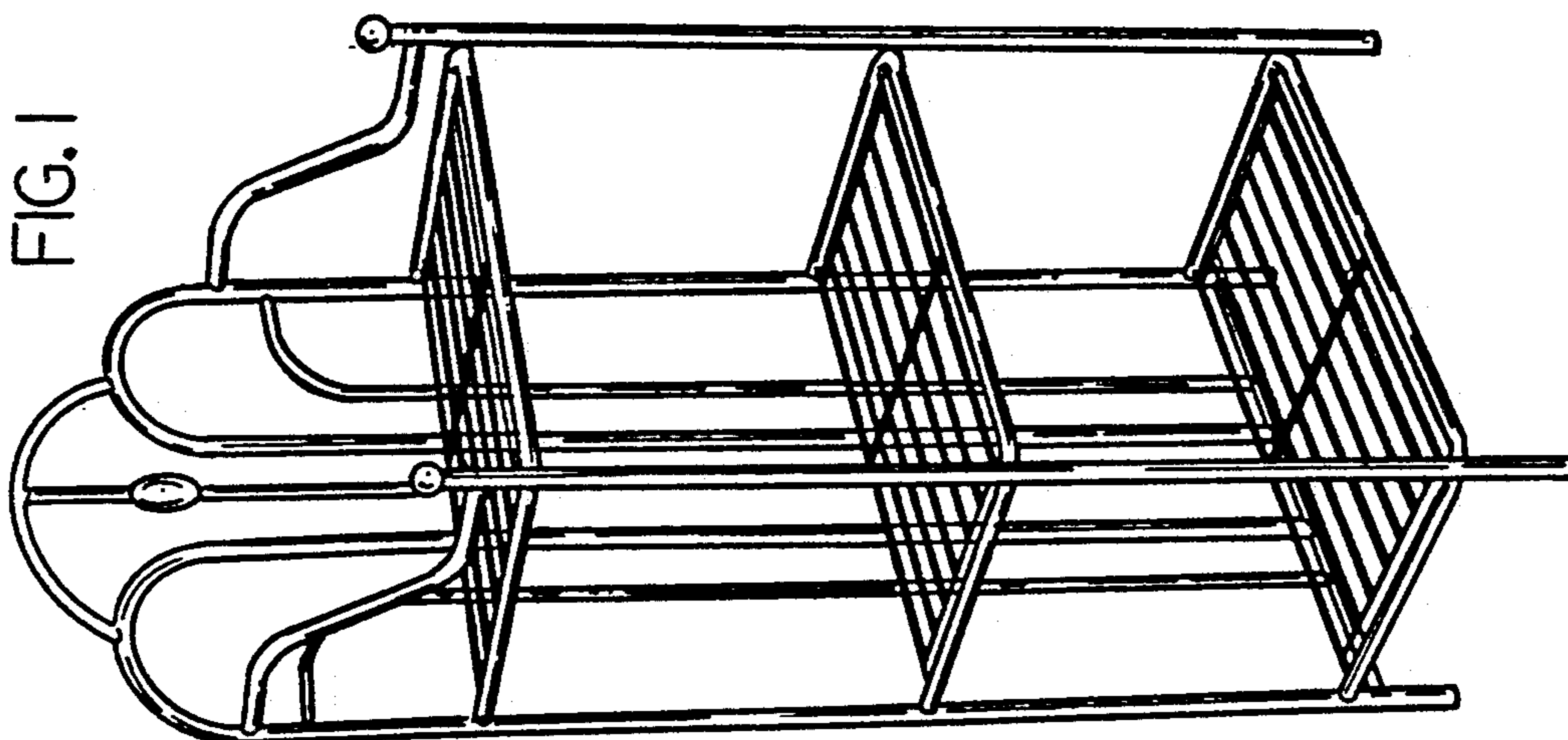

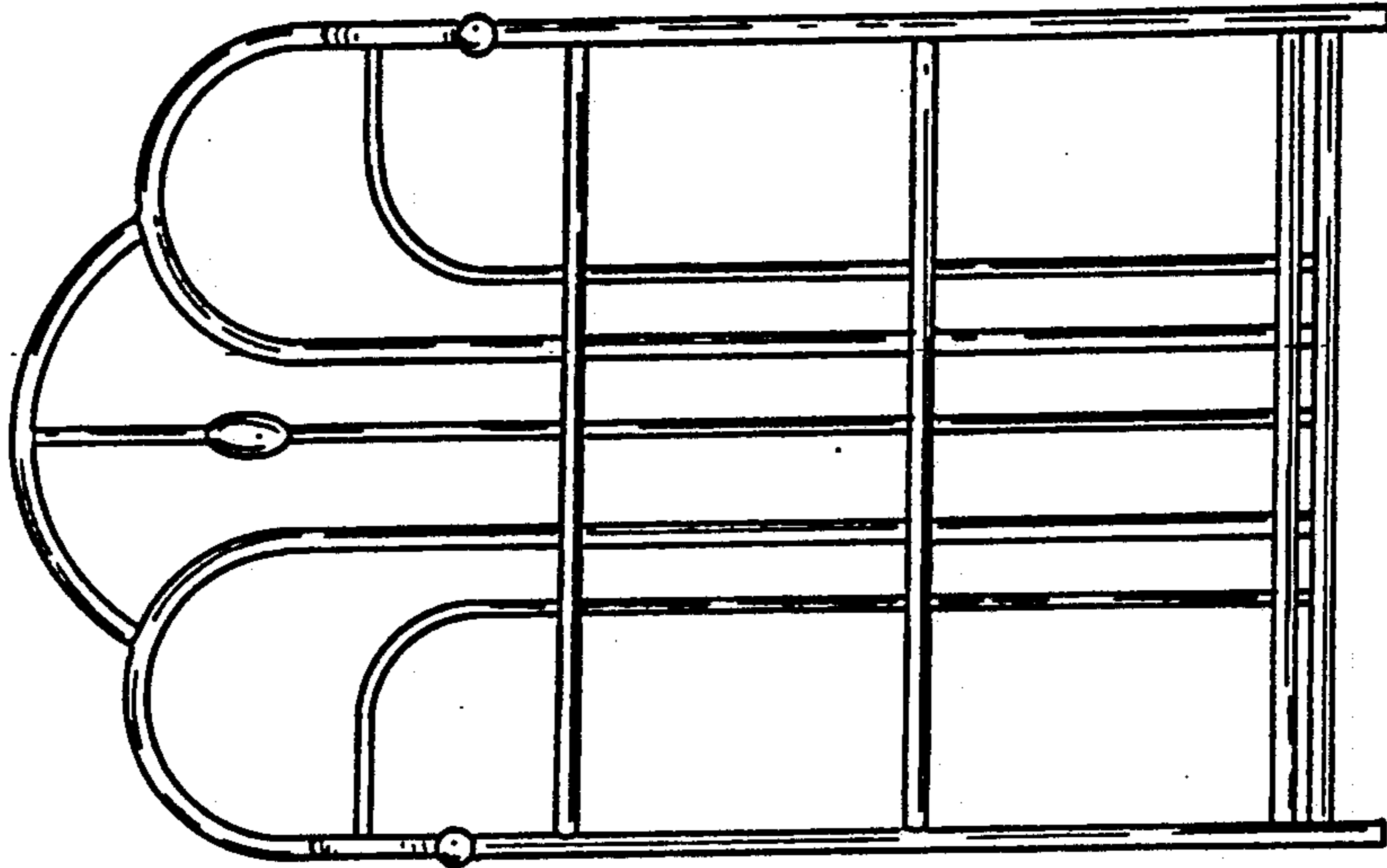

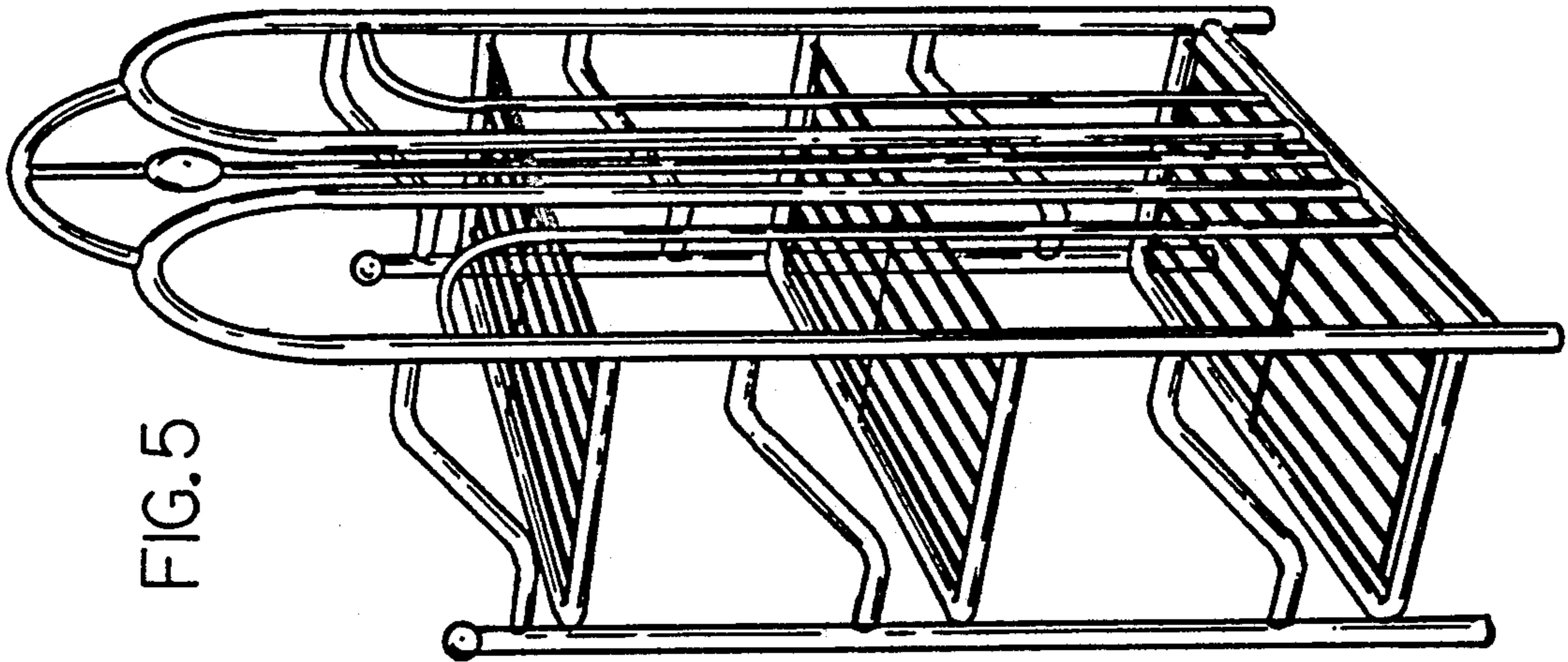

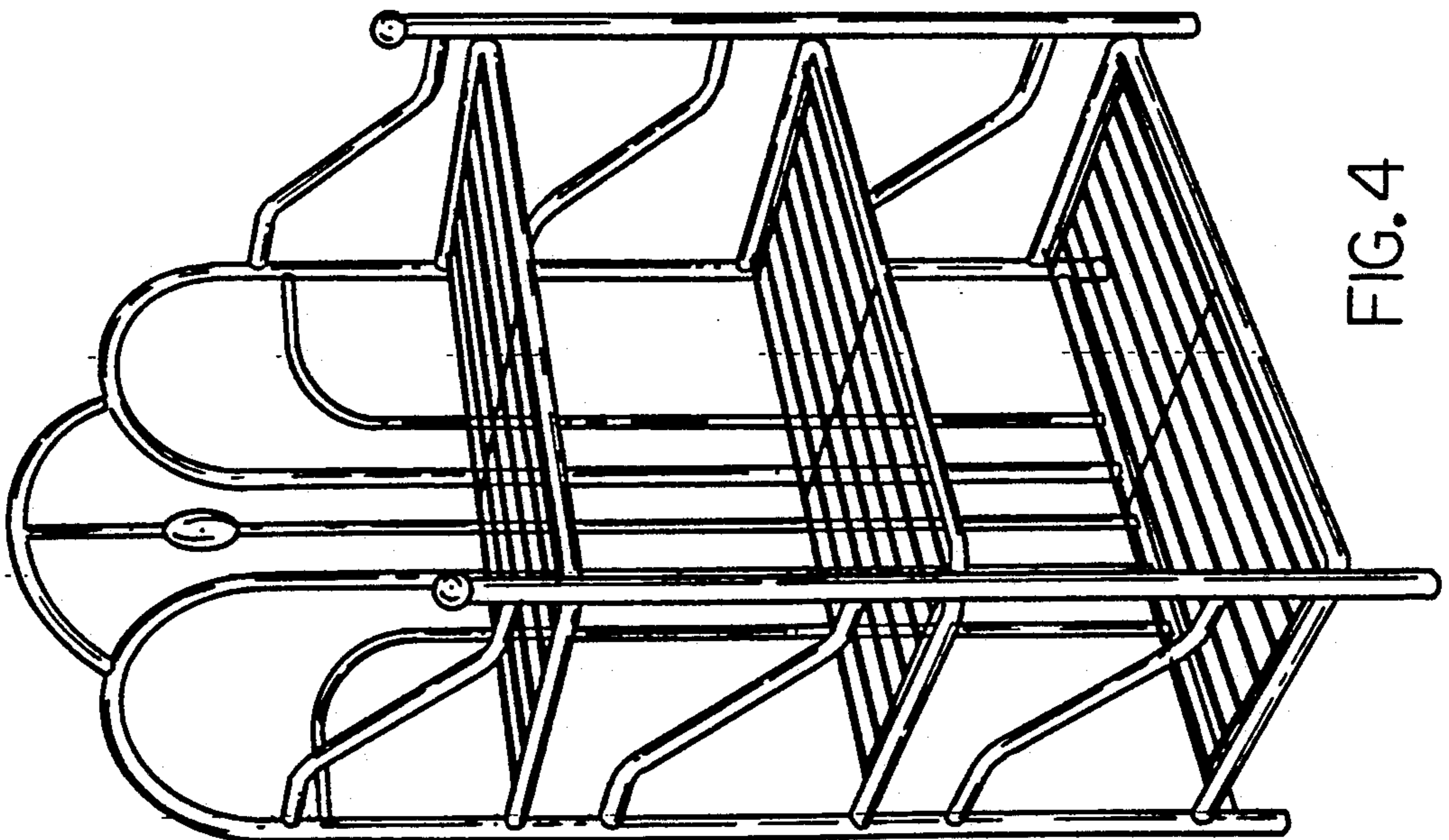

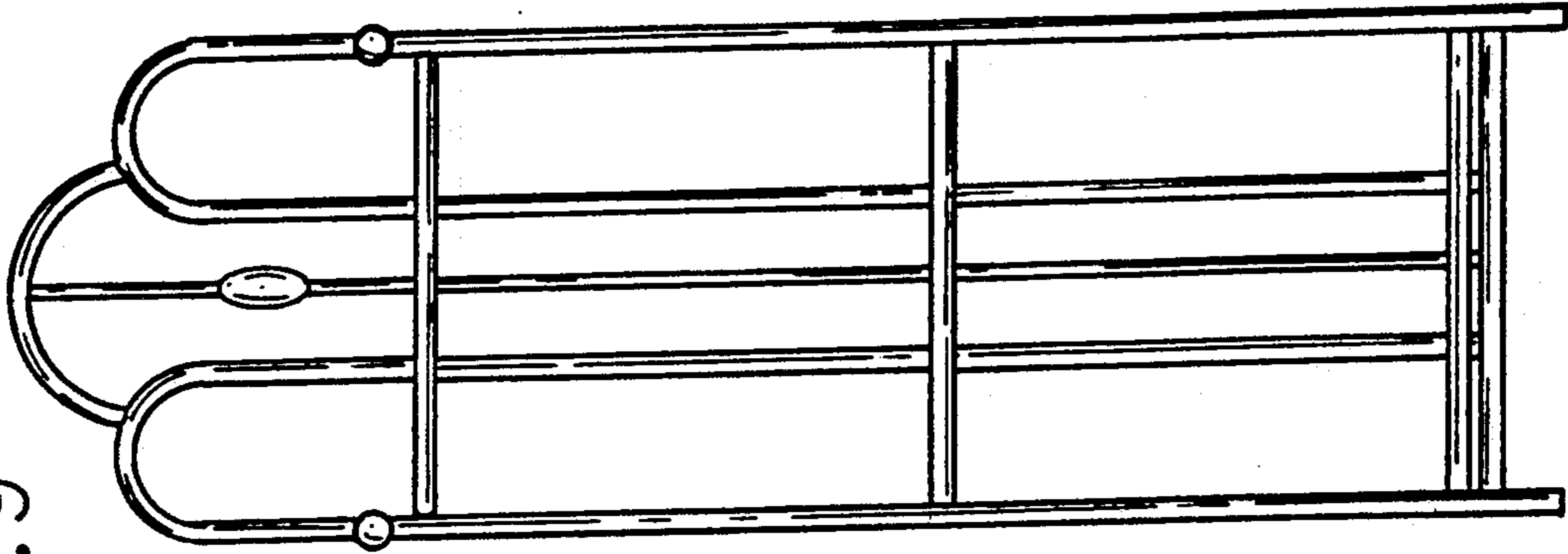

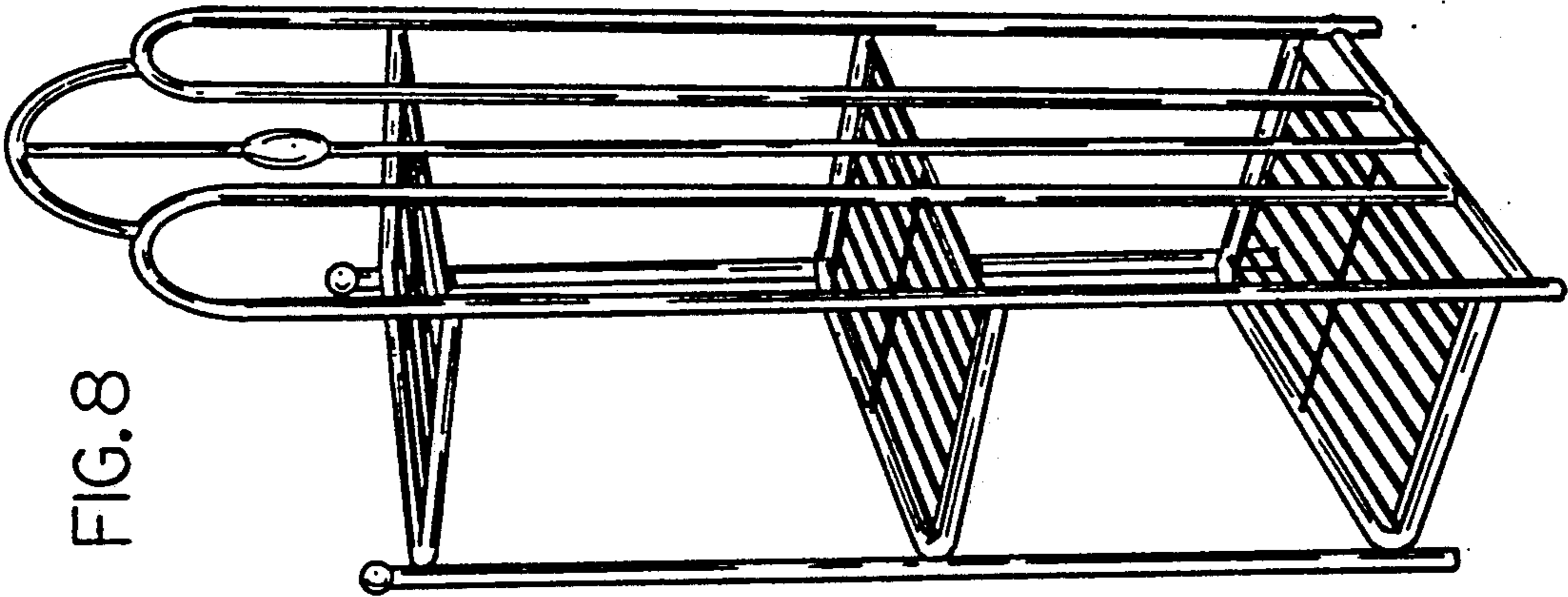

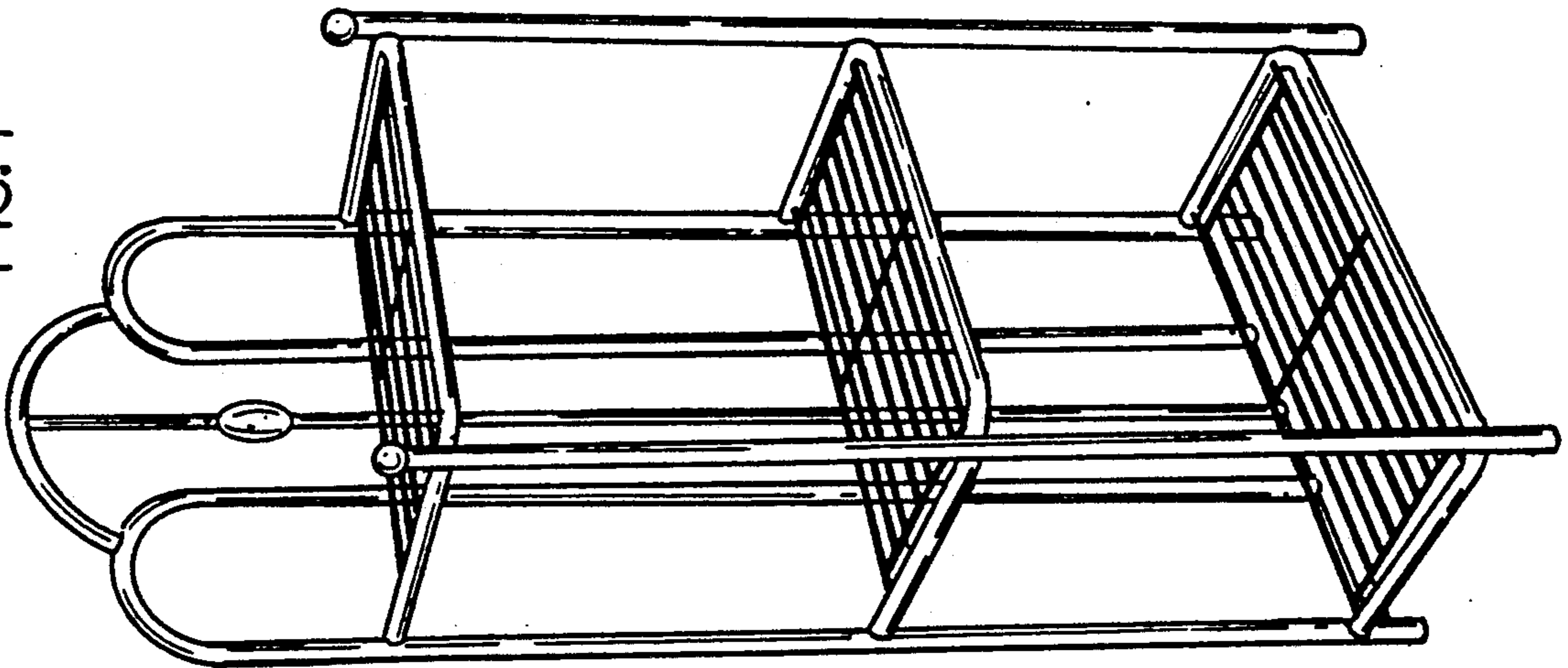

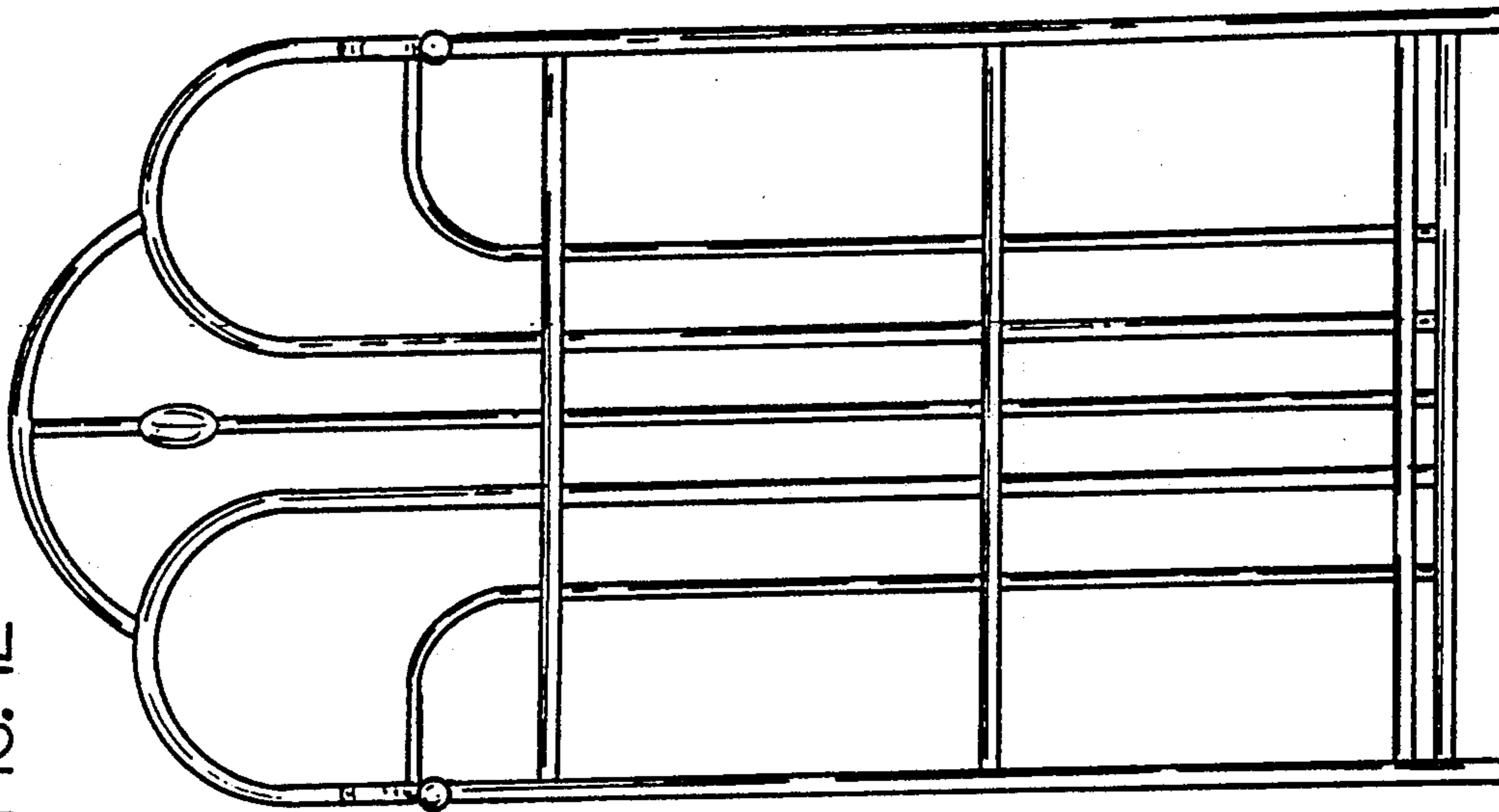

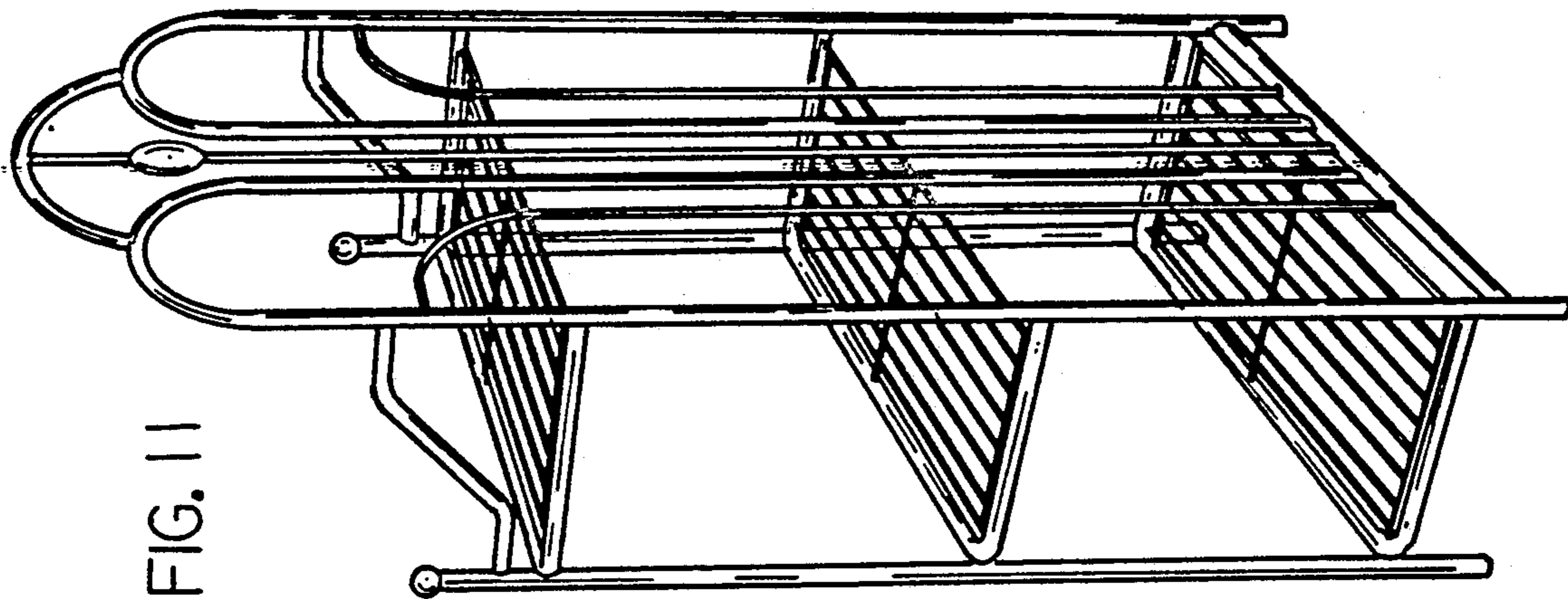

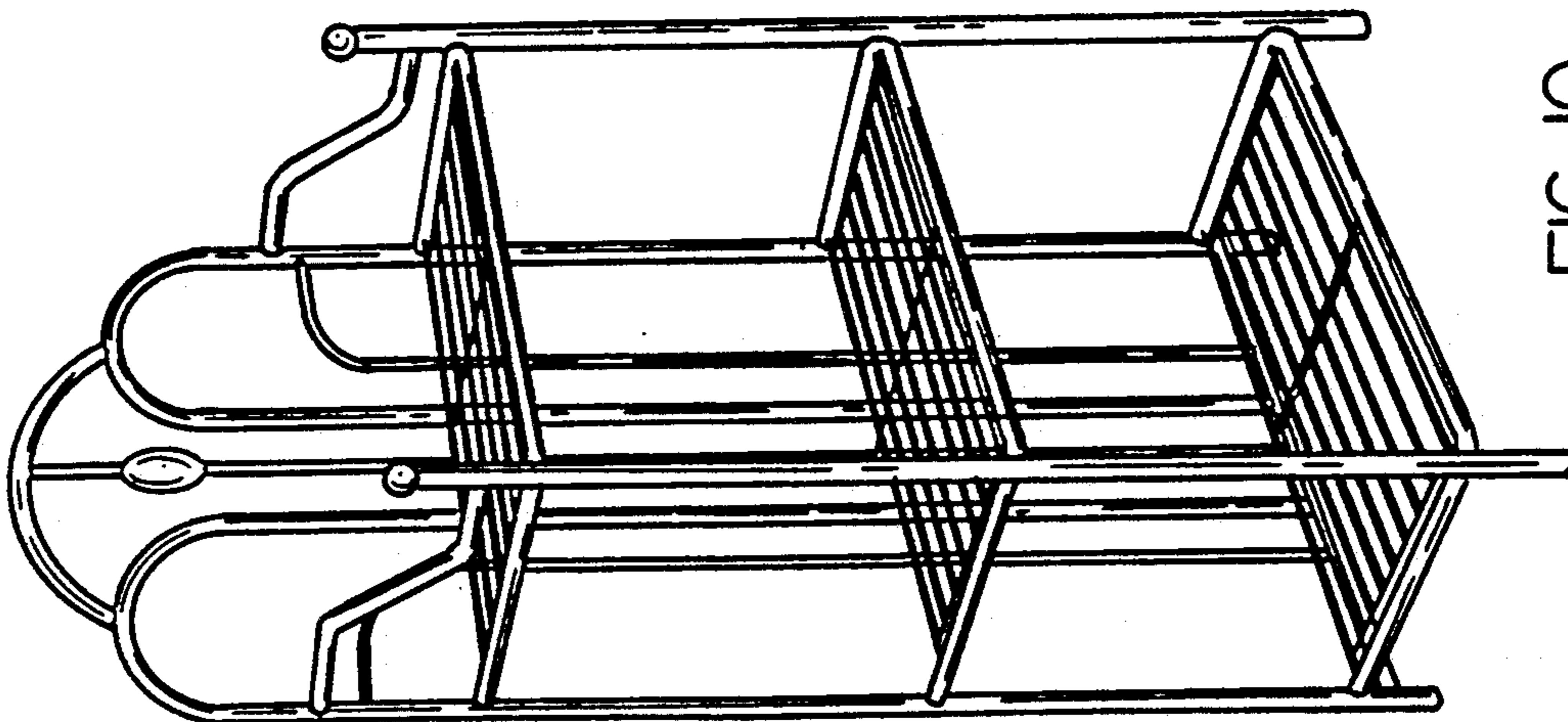

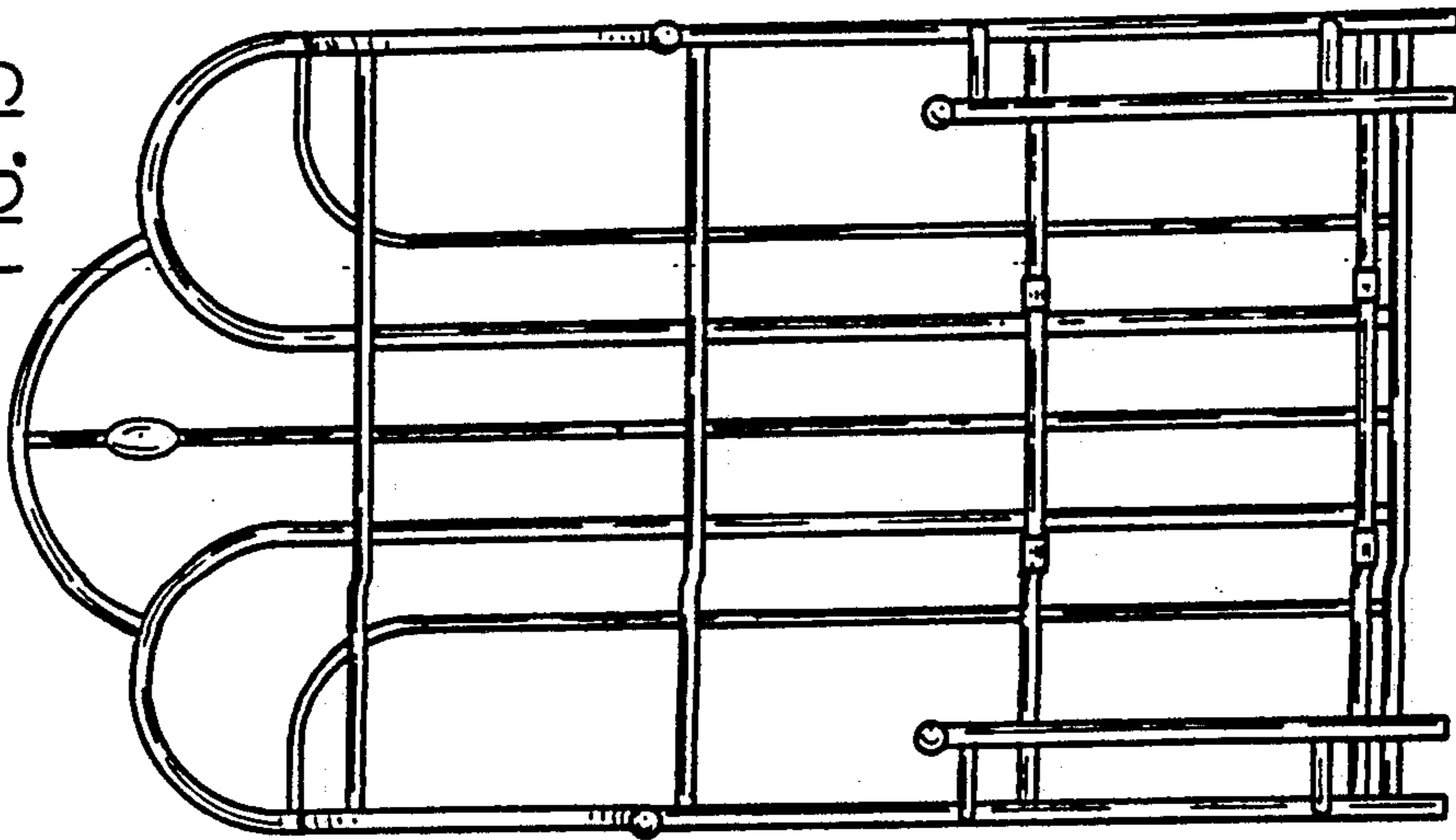

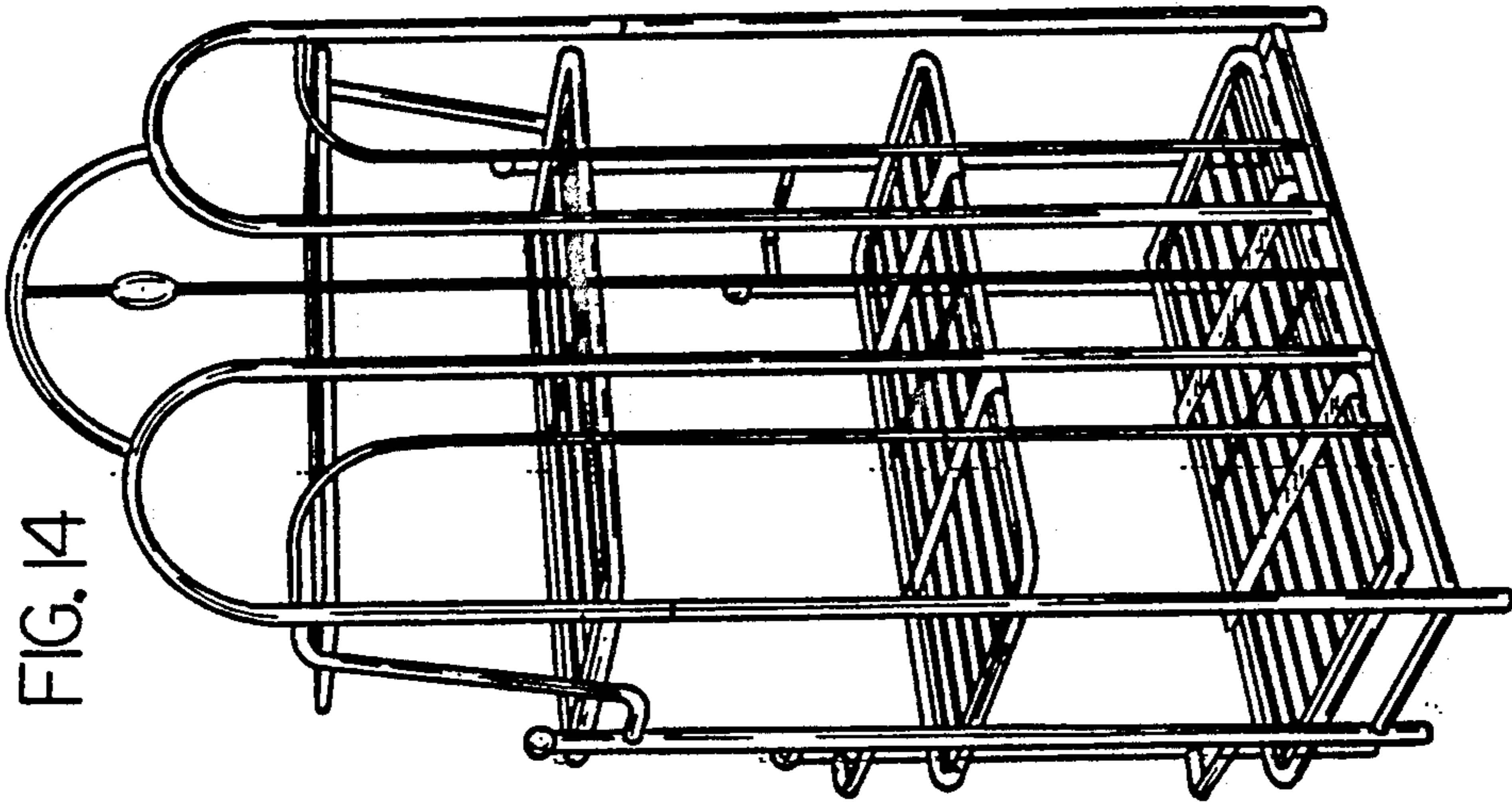

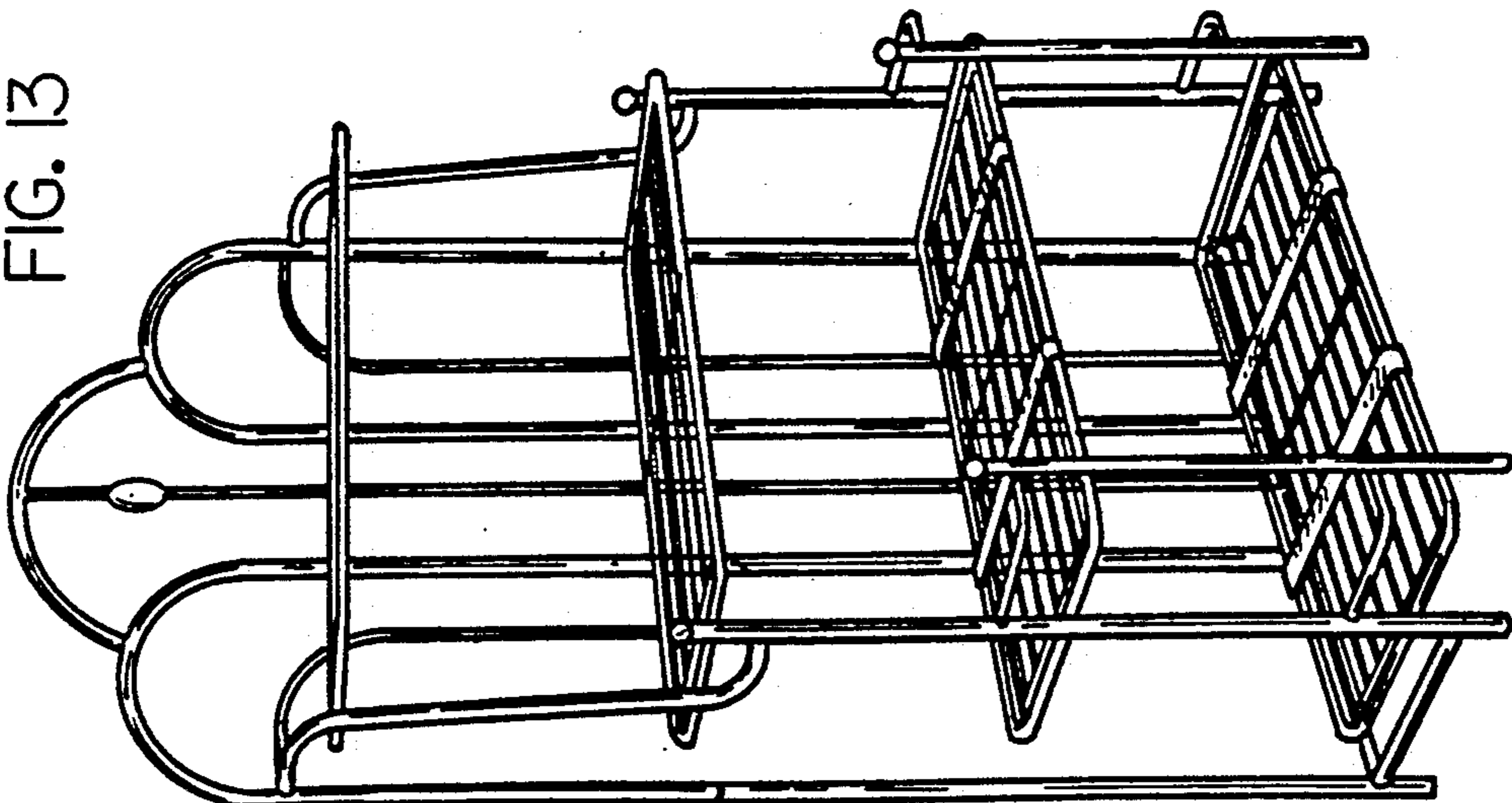

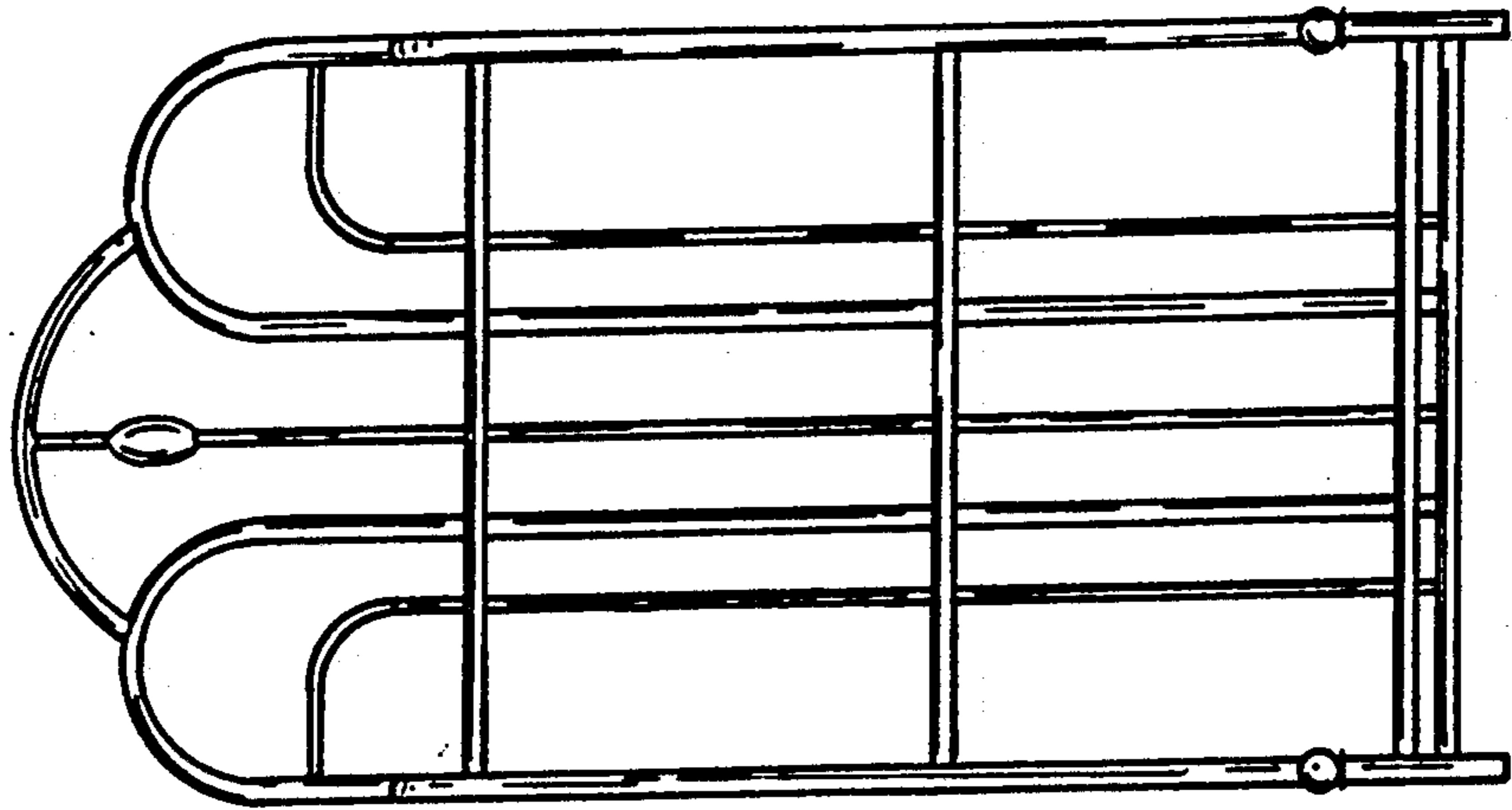

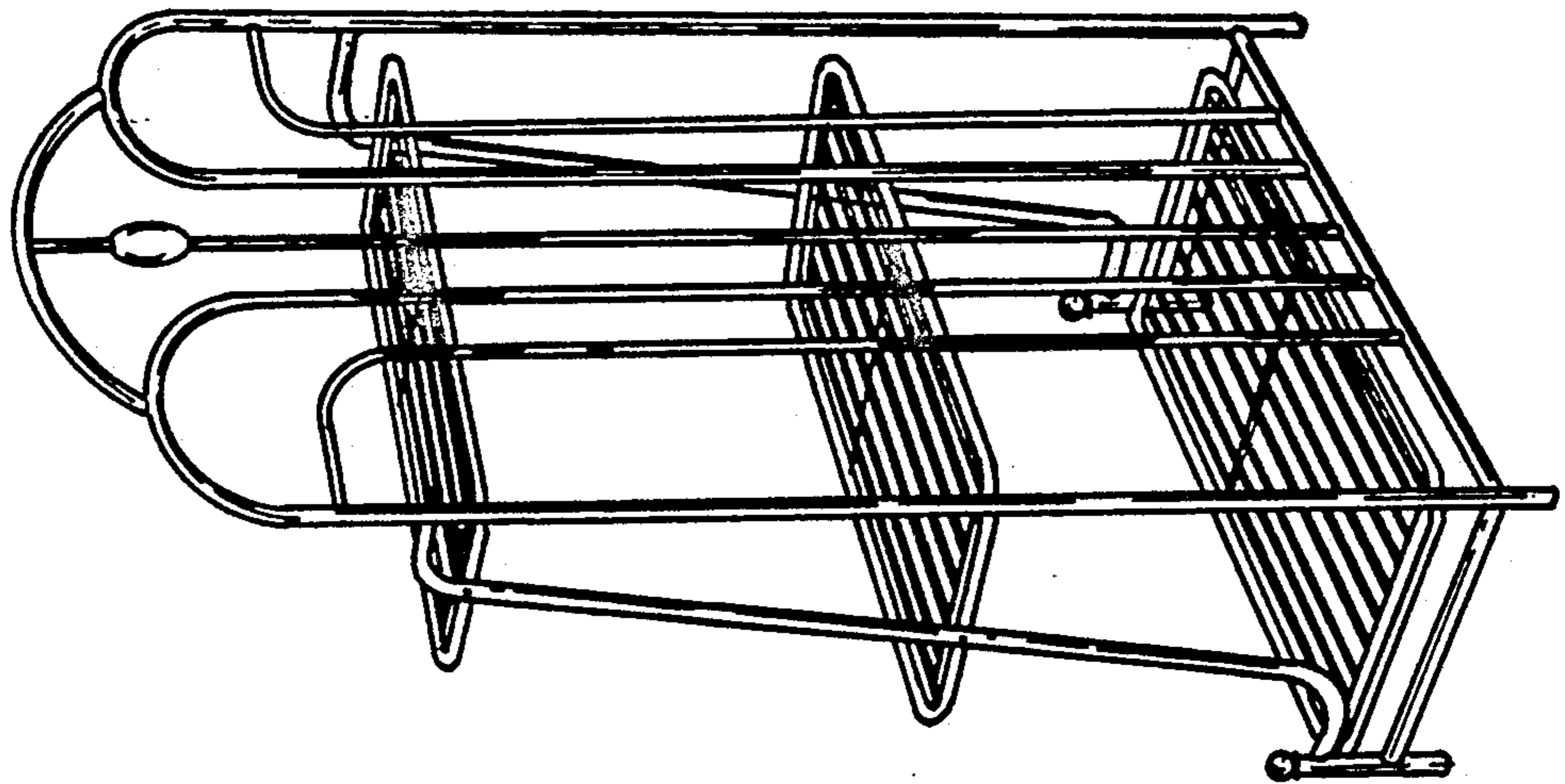
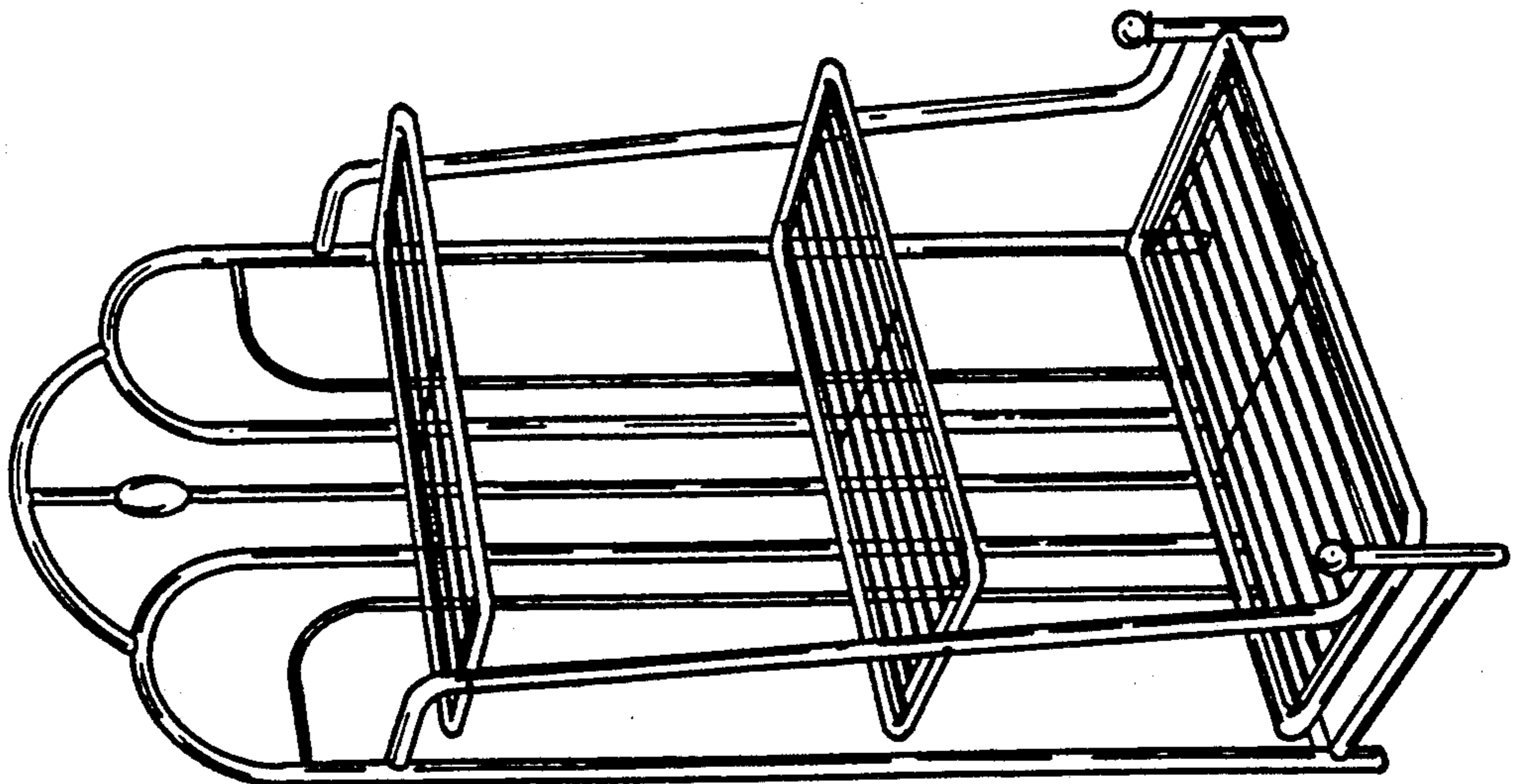

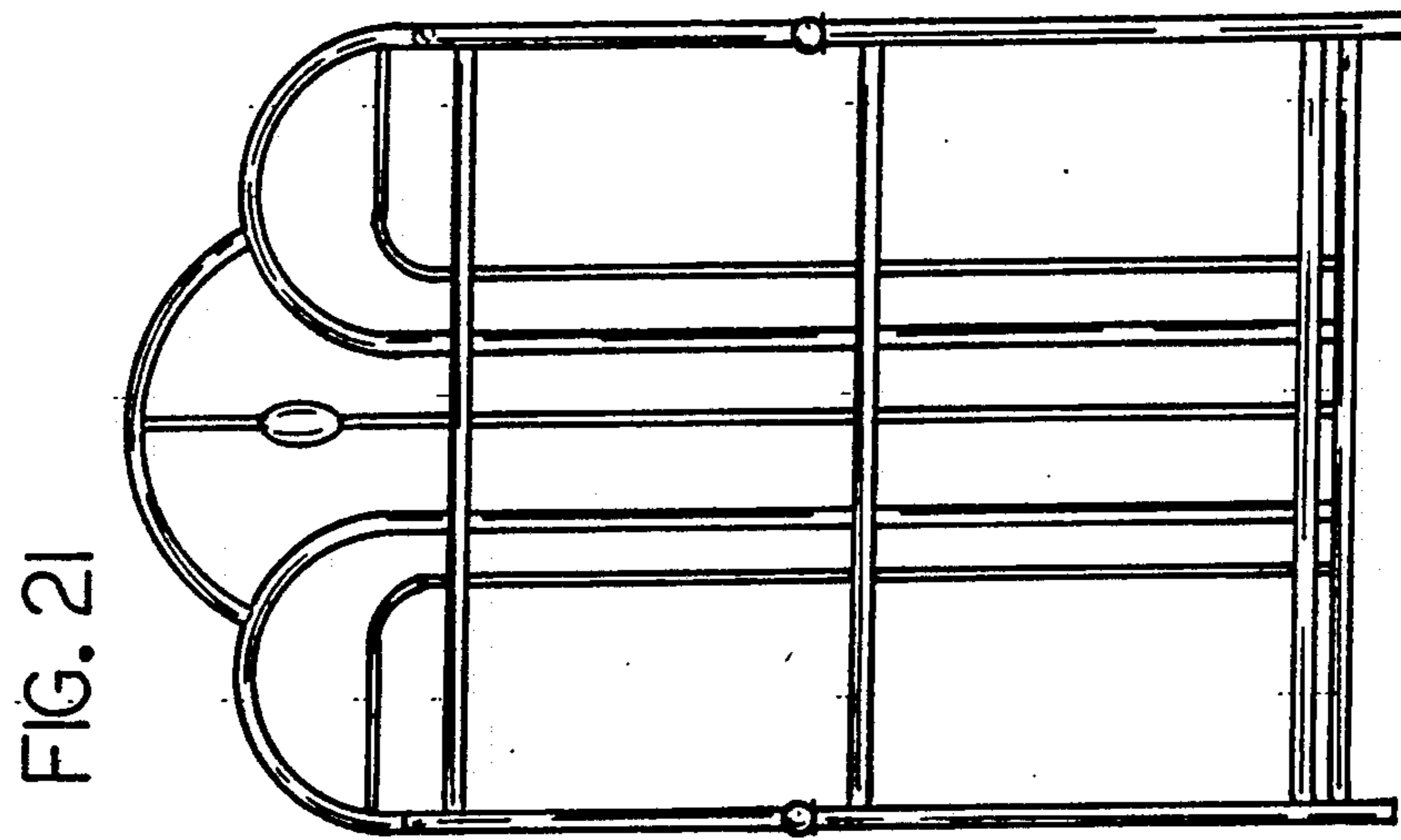

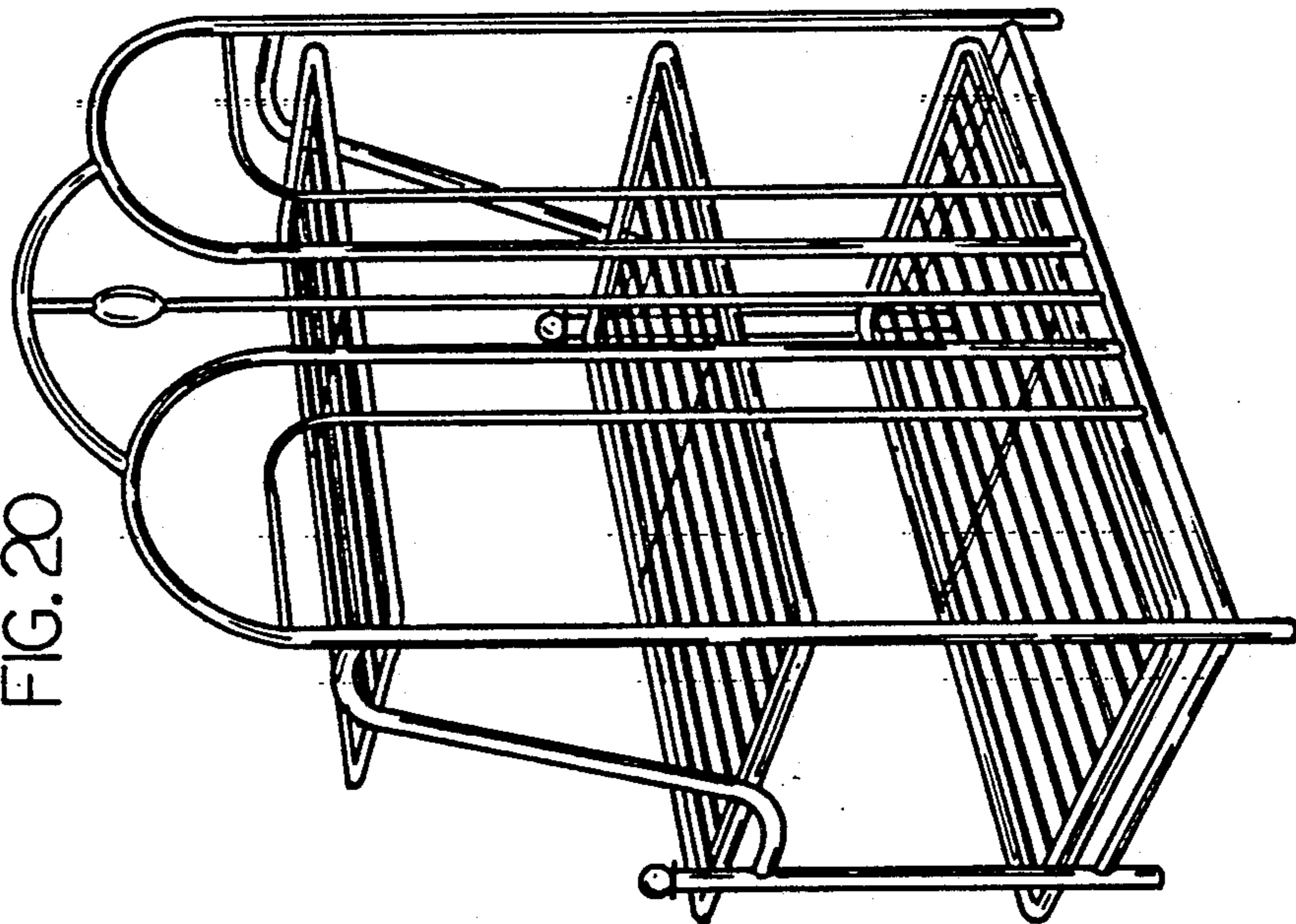

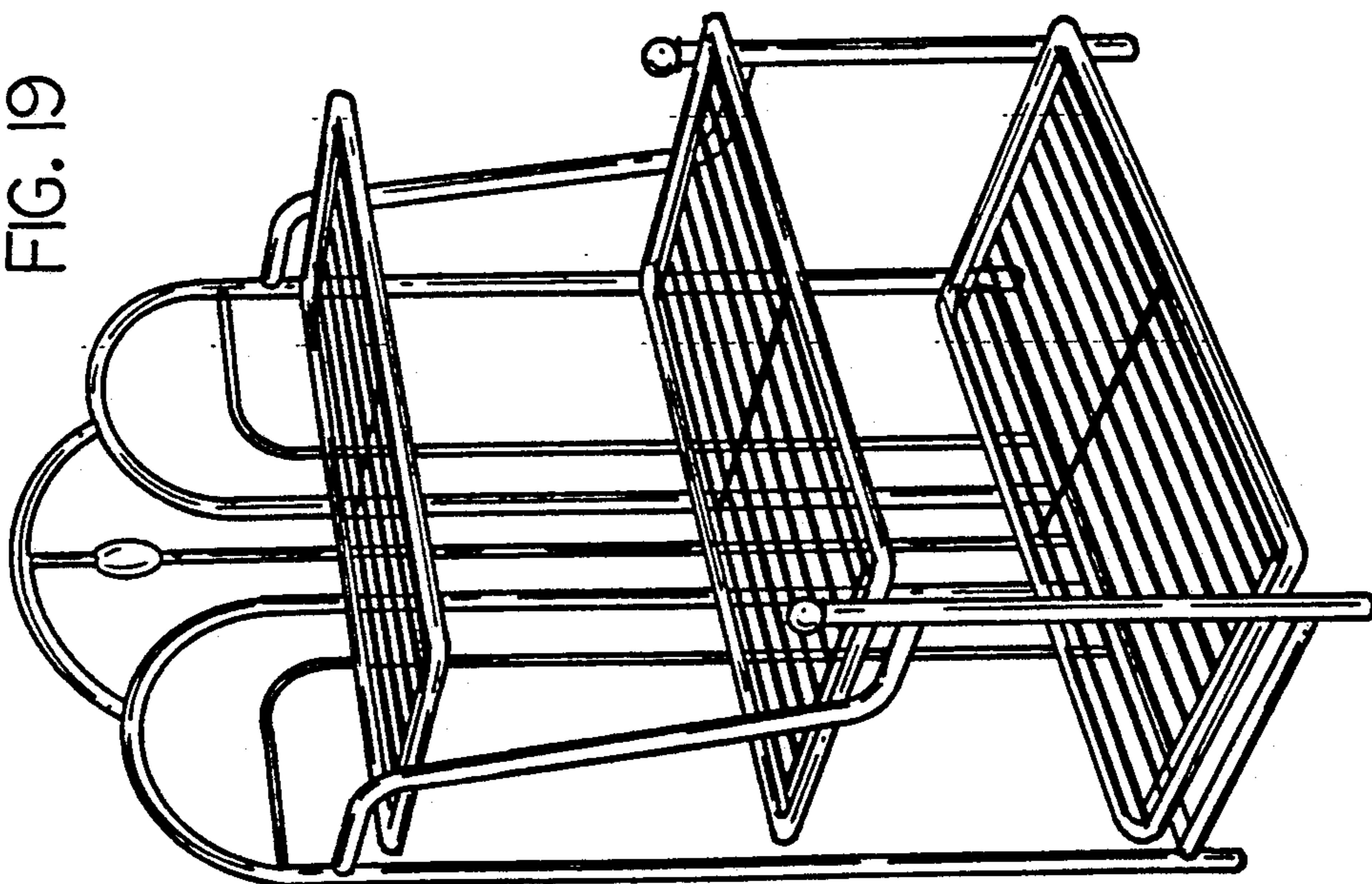
