DESCRIPTION

FIG. 1 is a front elevational view of a fishing rod and reel holder showing a first embodiment of my new design;

FIG. 12 is a left end elevational view;

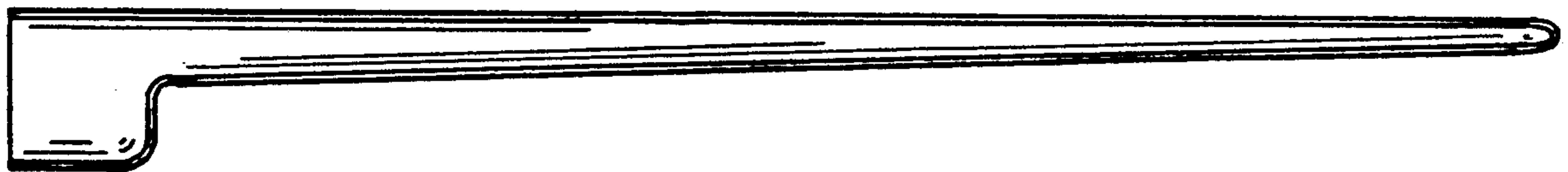
FIG. 13 is a right end elevational view;

The broken line showing of a casting rod and reel in FIGS. 14 and 7 is for illustrative purposes only and forms no part of the claimed design.



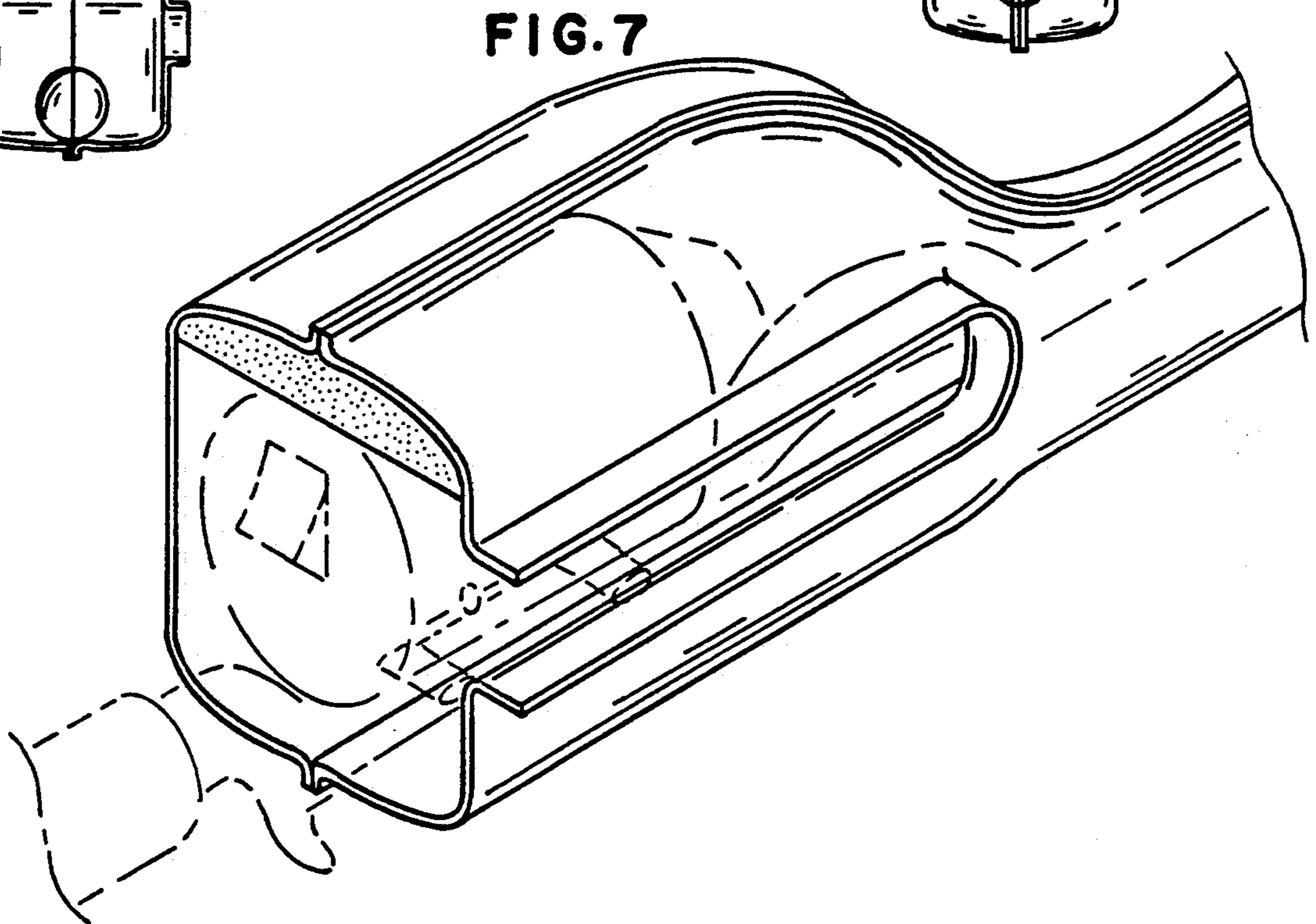
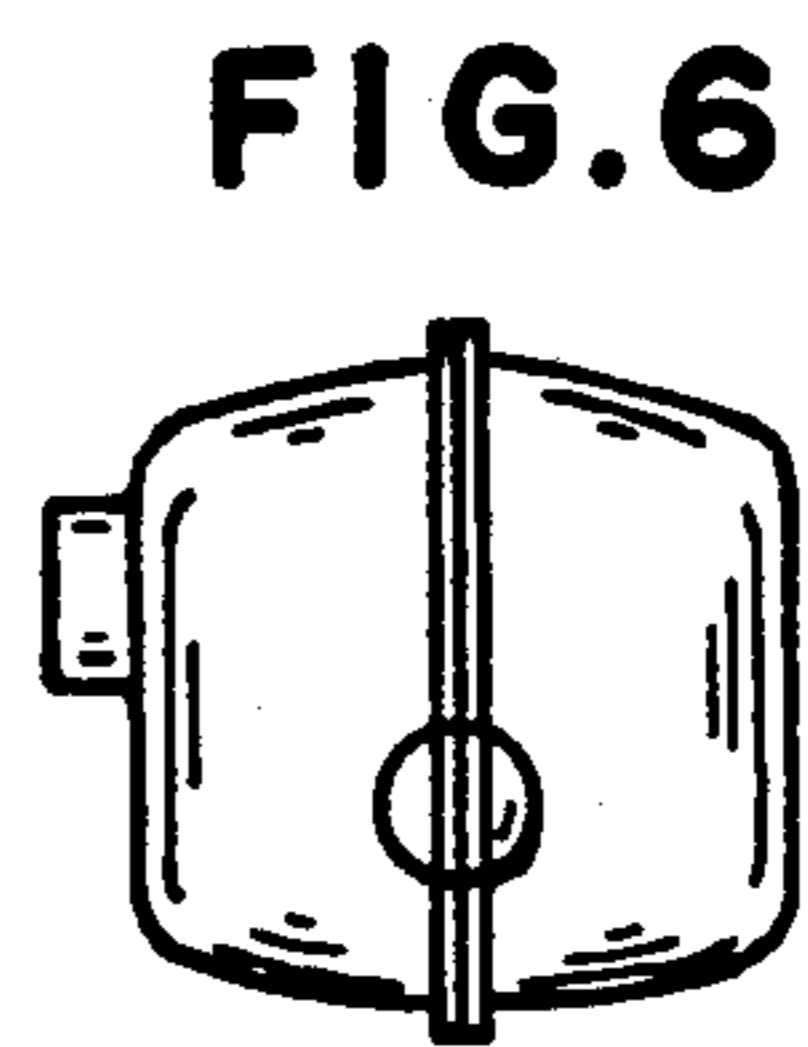
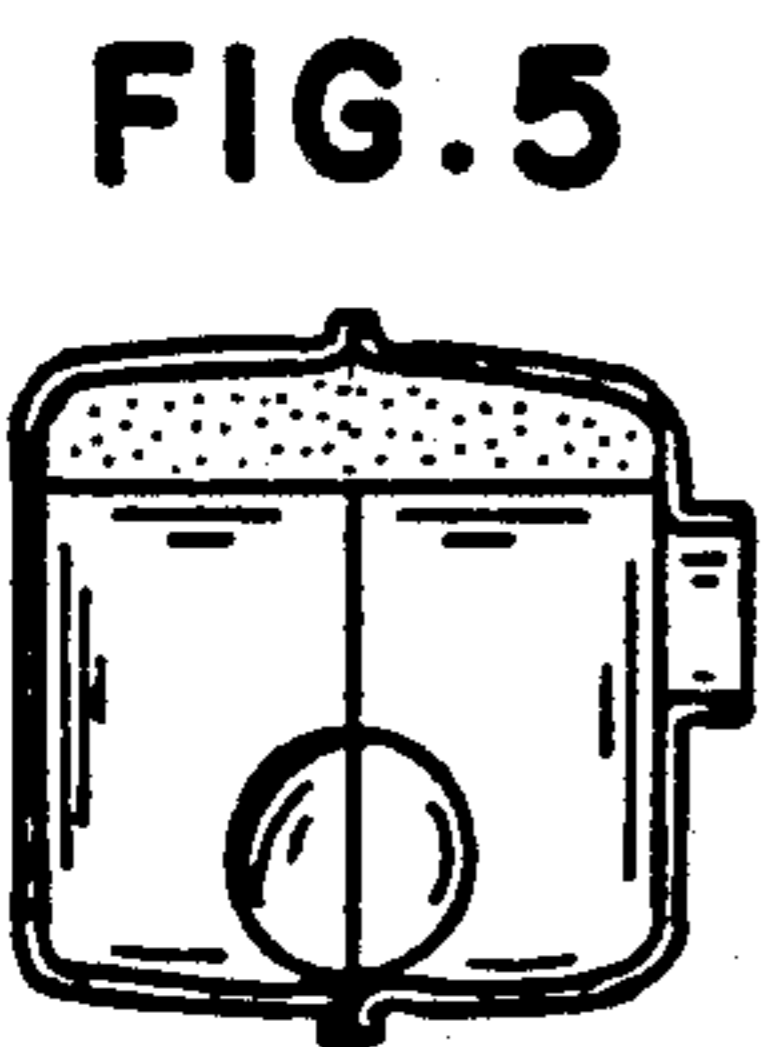
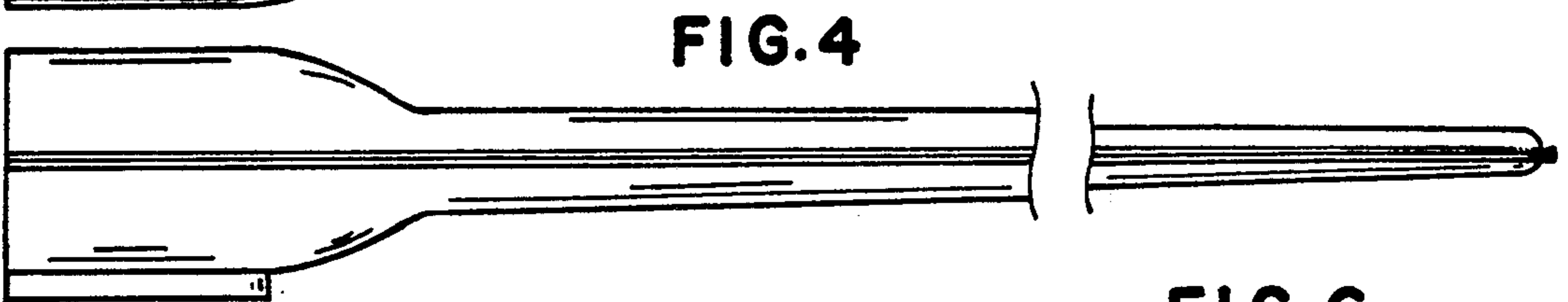
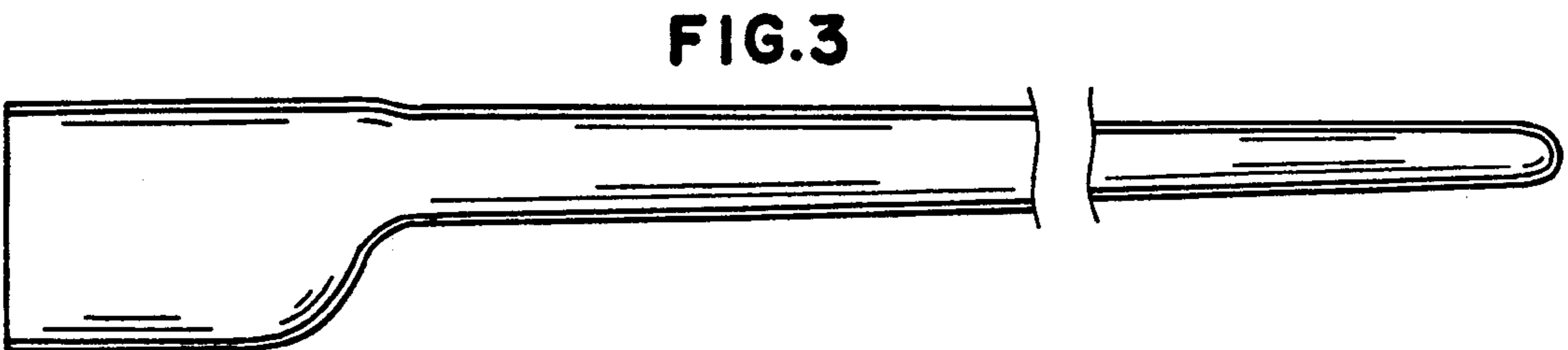
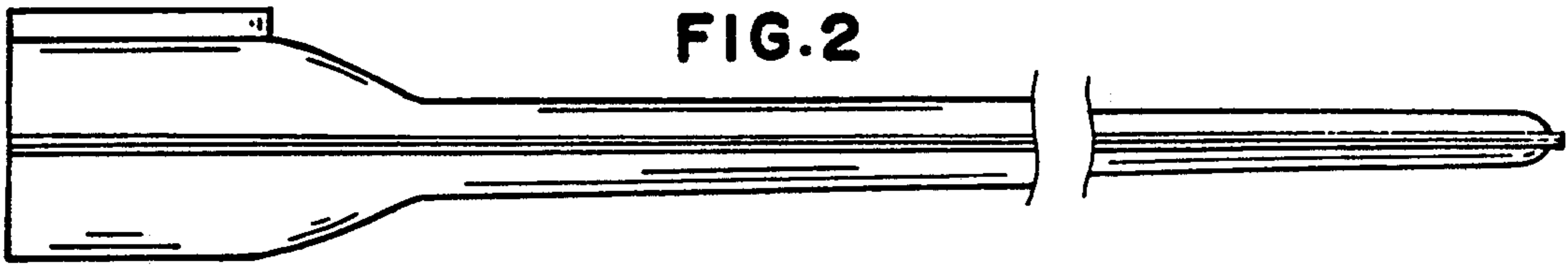
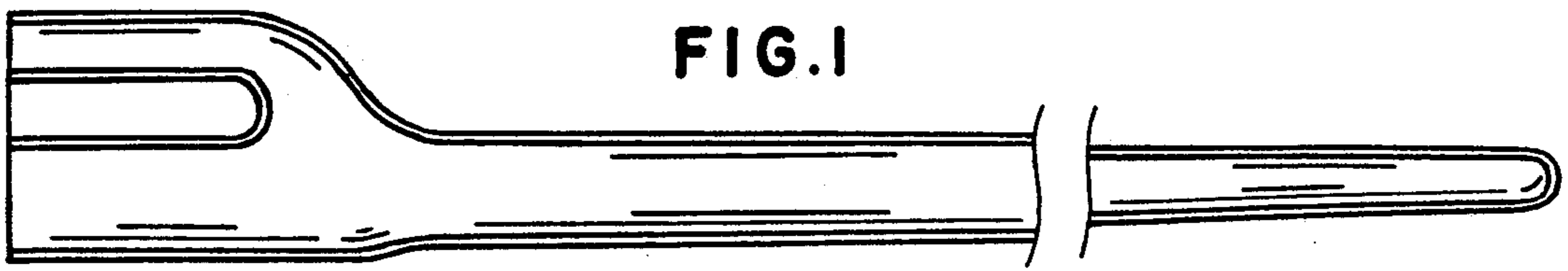

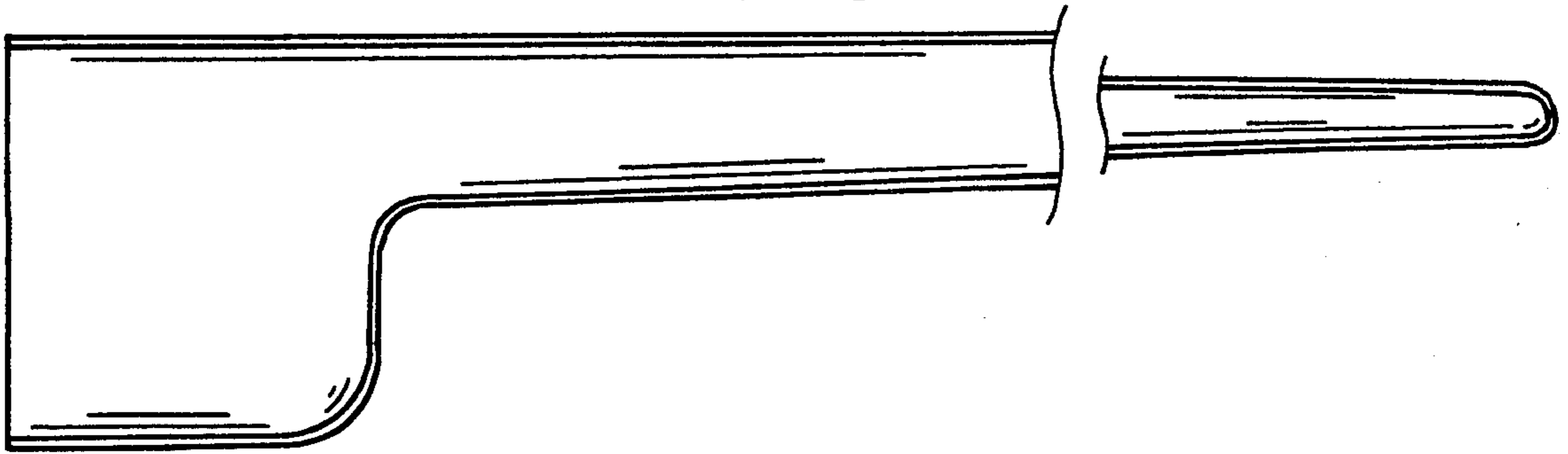

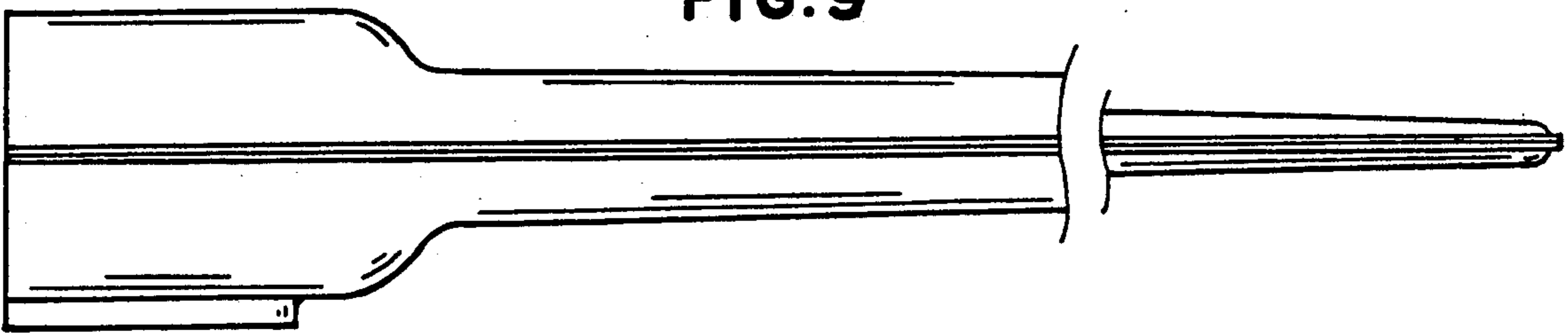

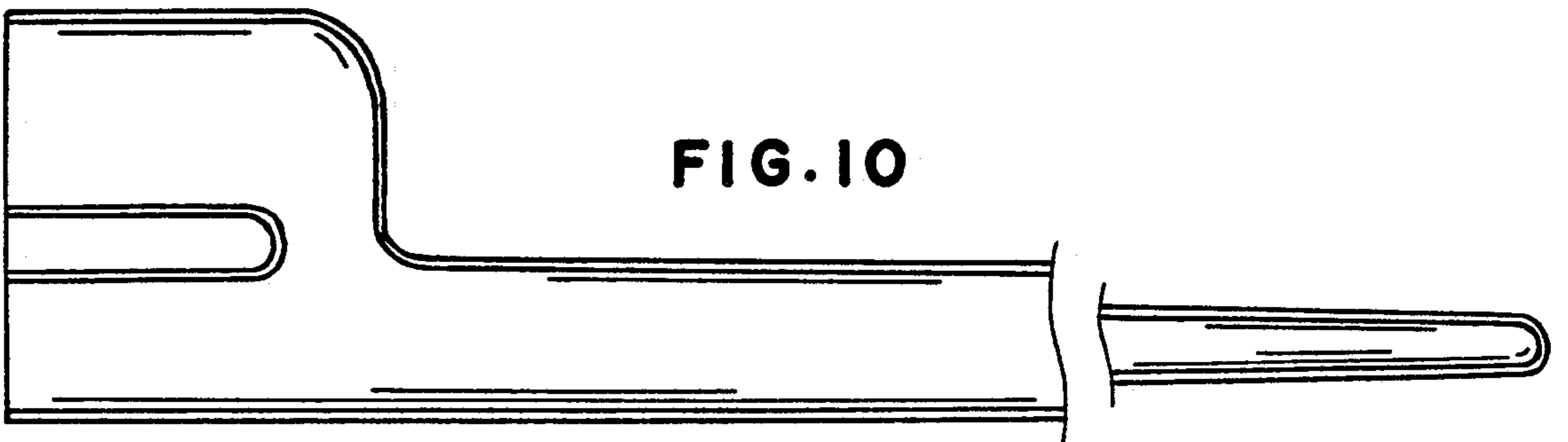

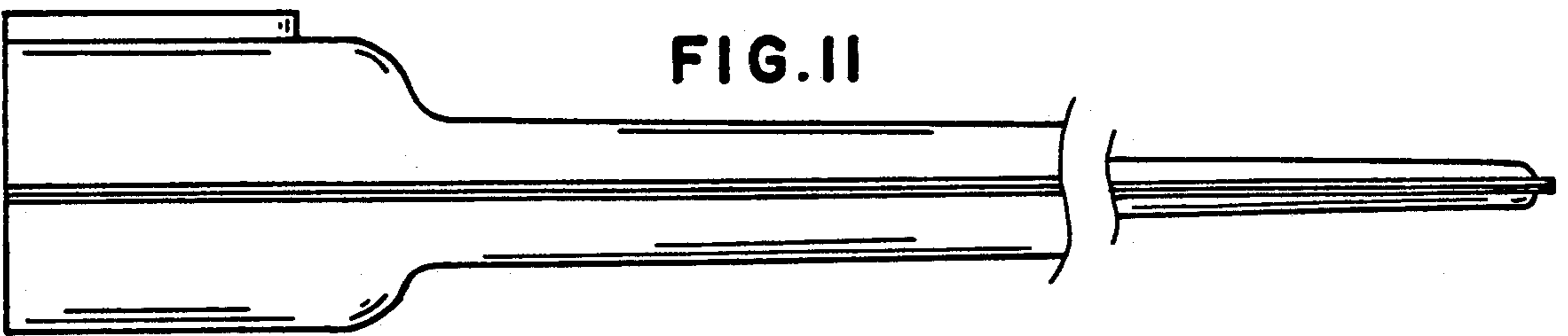

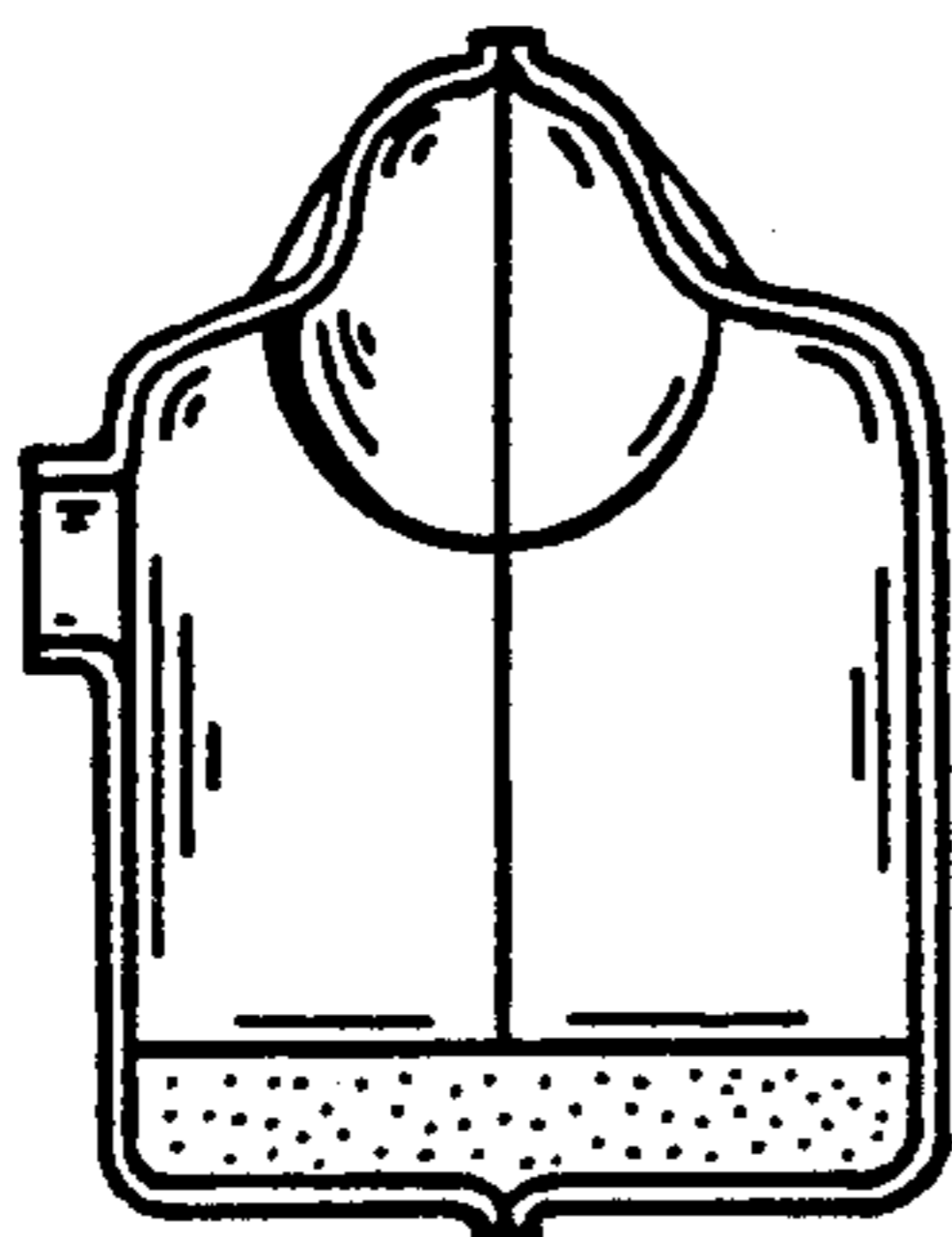

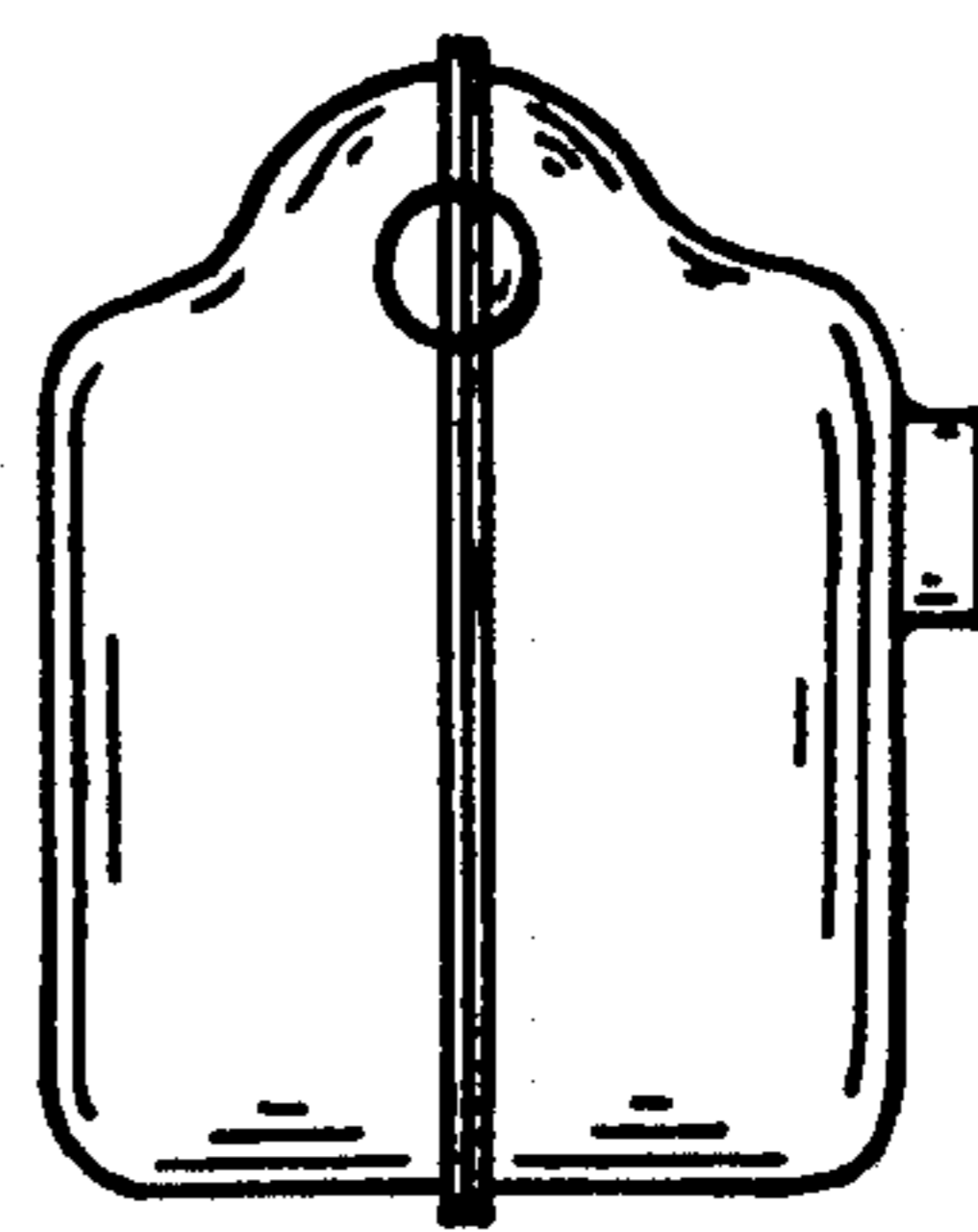

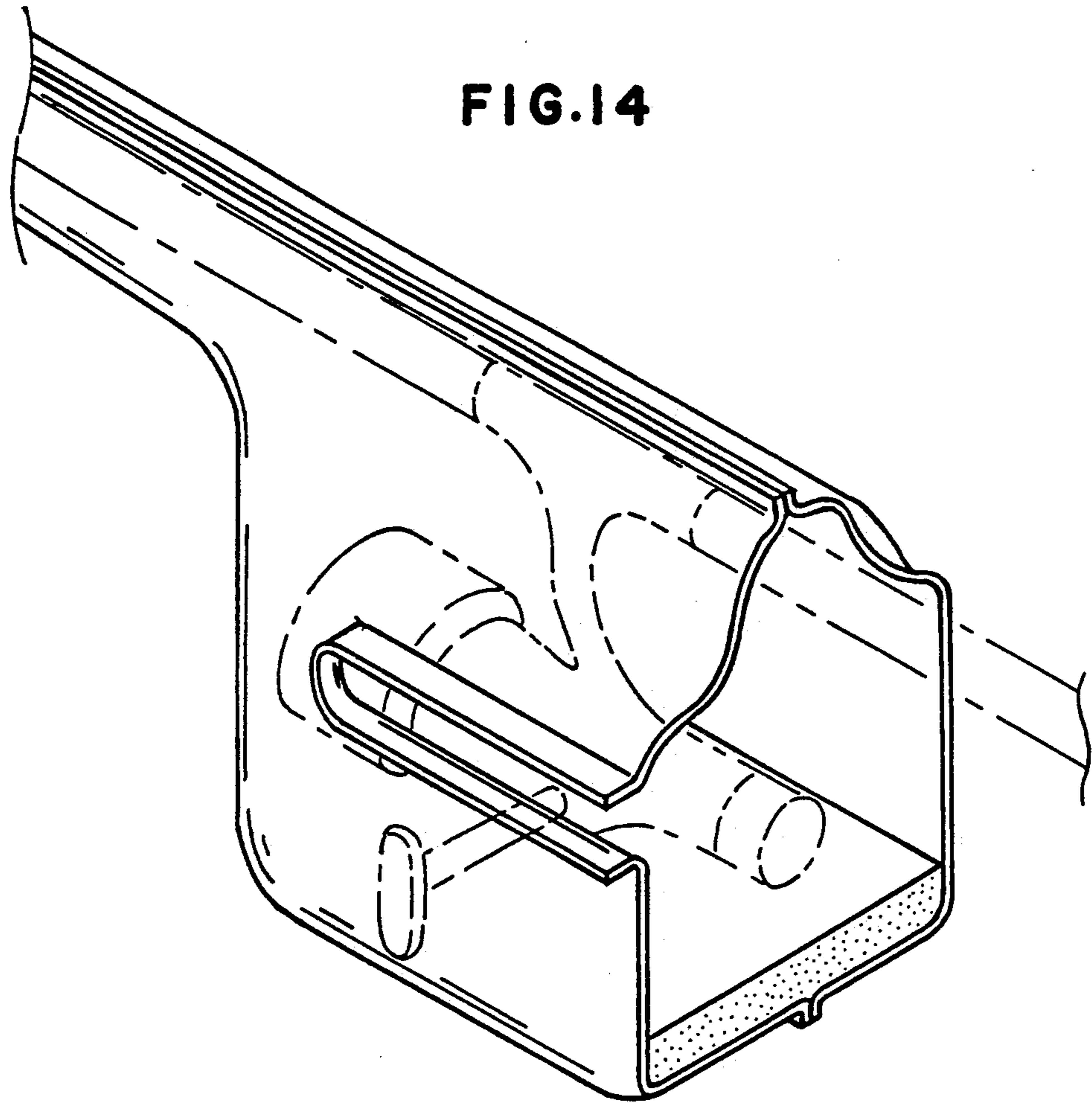

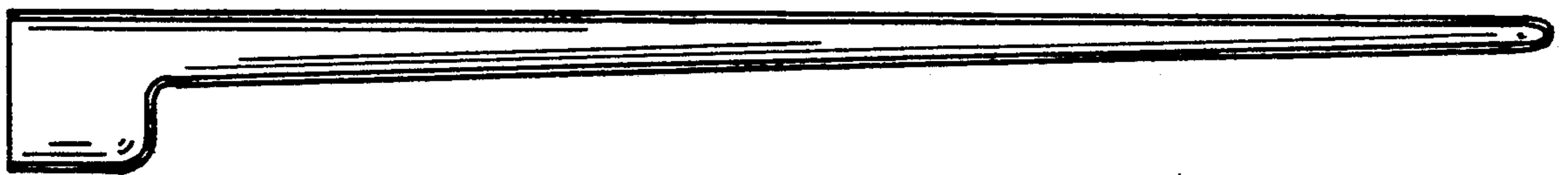
