The ornamental design for storage box blank, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a storage box blank showing my new design; the bottom being a mirror image thereof;

FIG. 2 is a top plan view of a second embodiment of FIG. 1; the bottom being a mirror image thereof;

FIG. 3 is a top plan view of third embodiment of FIG. 1, the bottom being a mirror image thereof;

FIG. 4 is a top view of a fourth embodiment of FIG. 1, the bottom being a mirror image thereof;

FIG. 5 is a top view of a fifth embodiment of FIG. 1, the bottom being a mirror image thereof;

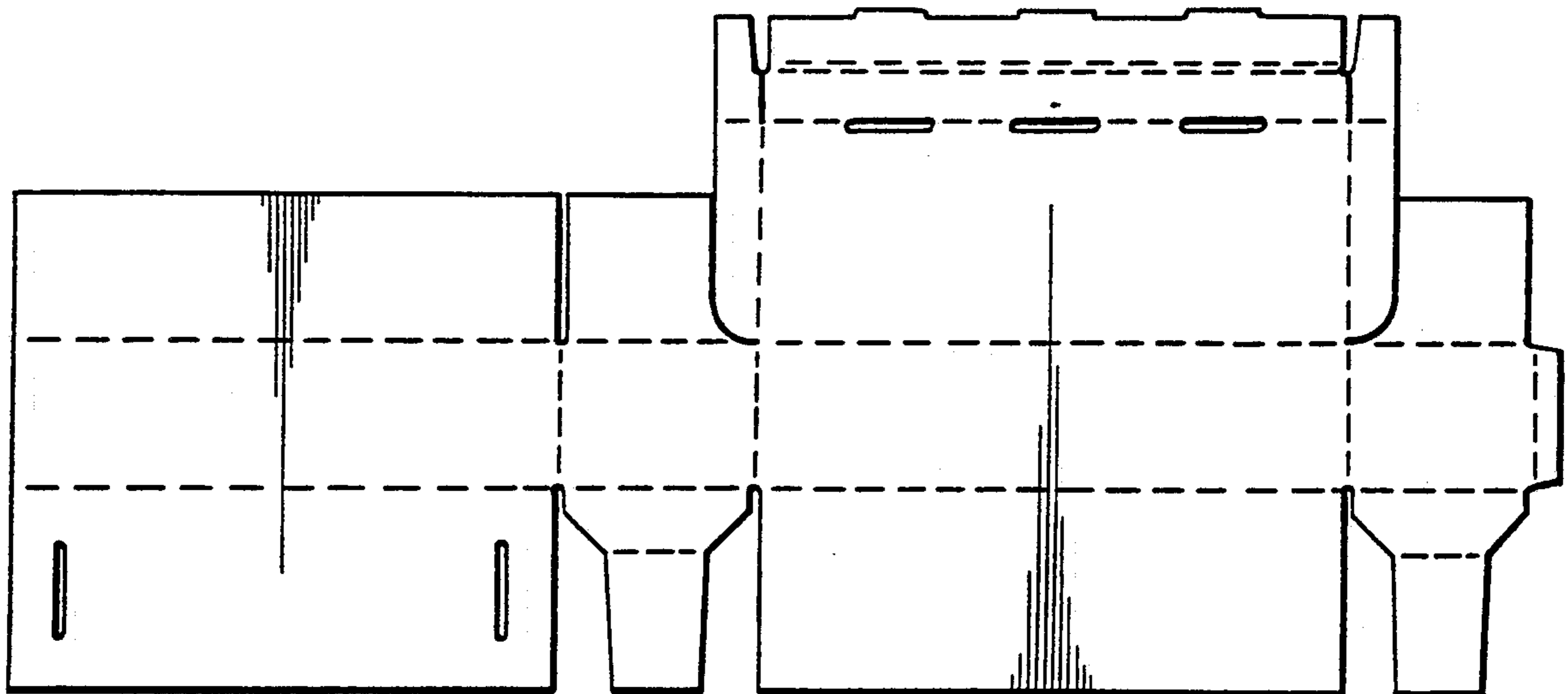
FIG. 6 is a top view of a sixth embodiment of FIG. 1, the bottom being a mirror image thereof;

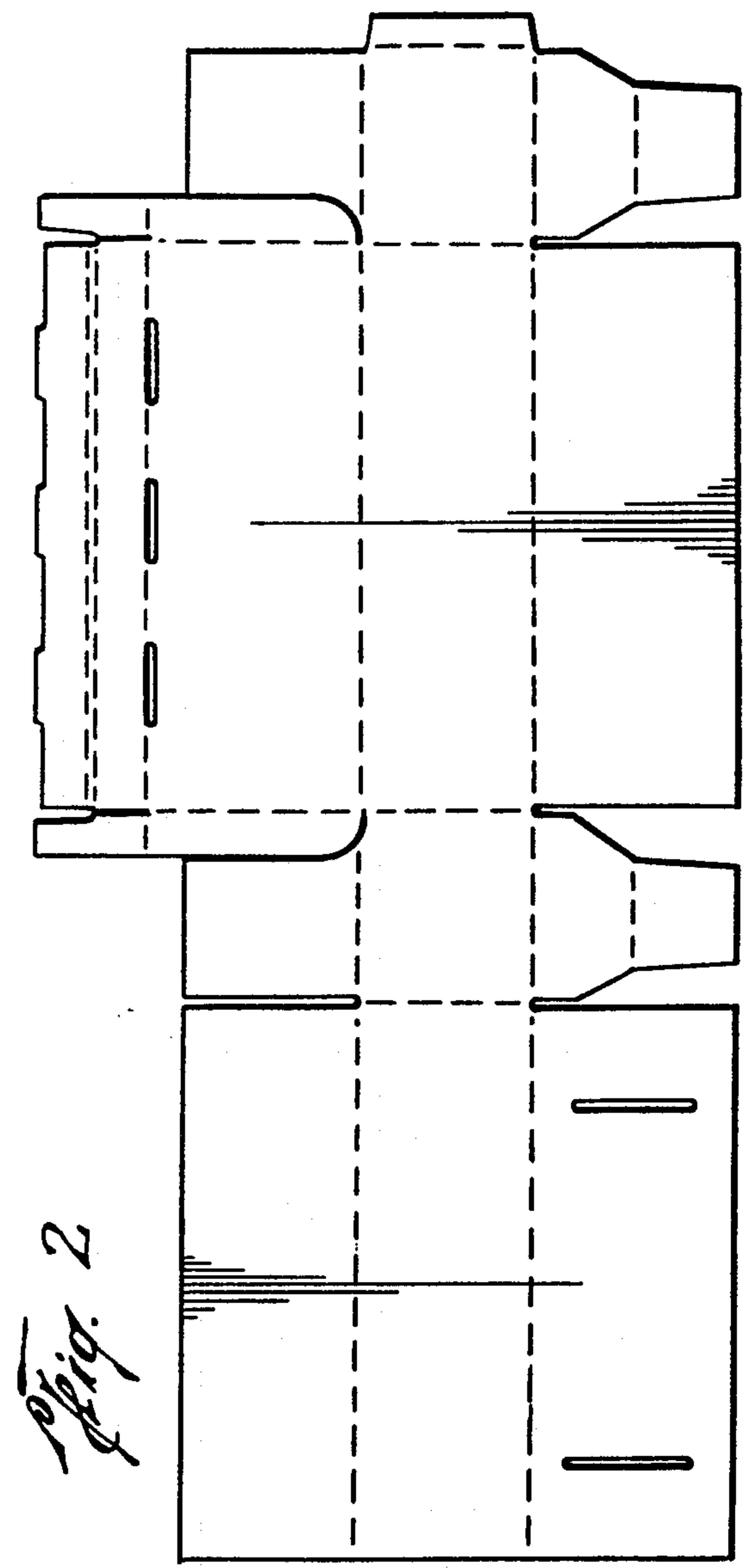
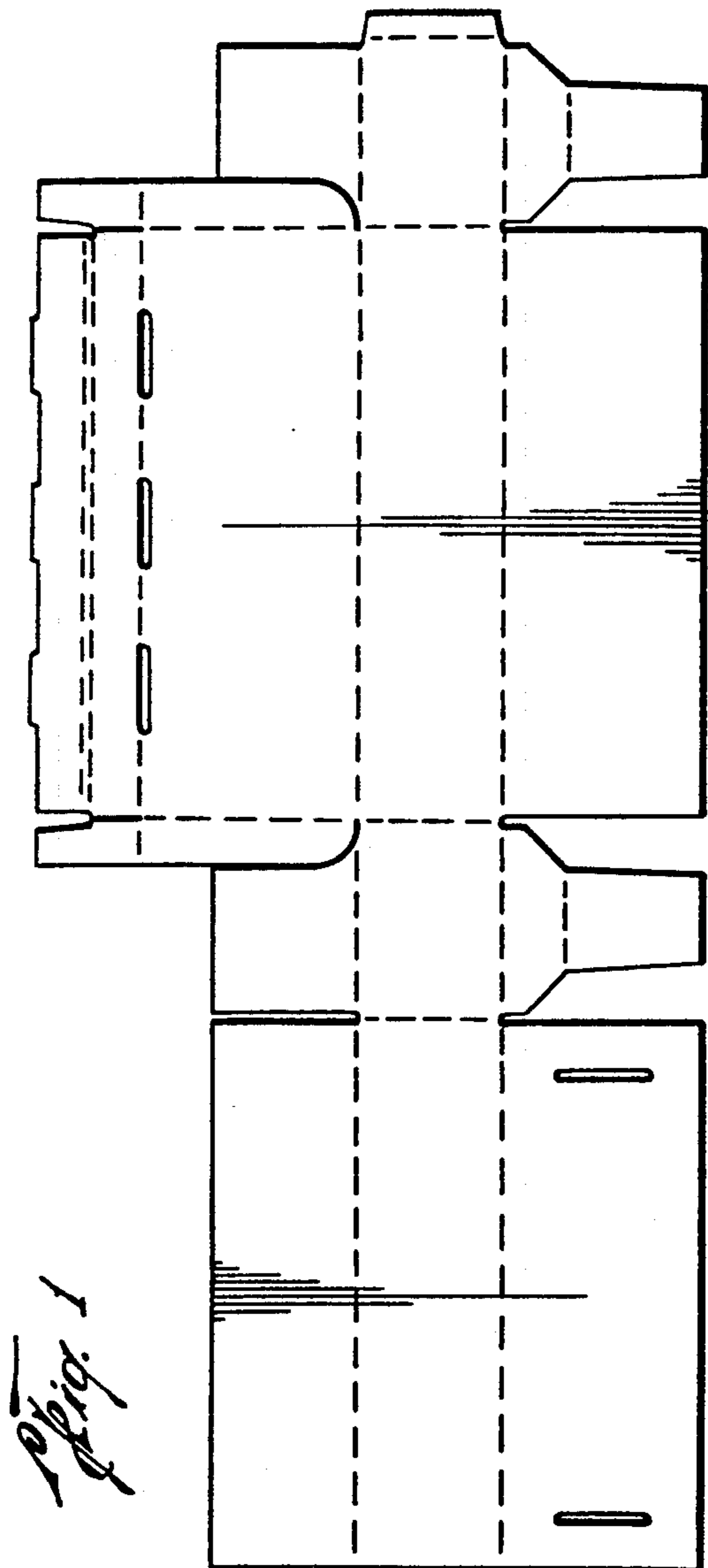
FIG. 7 is a top view of a seventh embodiment of FIG. 1, the bottom being a mirror image thereof;

The dash lines represent score and fold lines. The carton blank is of conventional thickness.





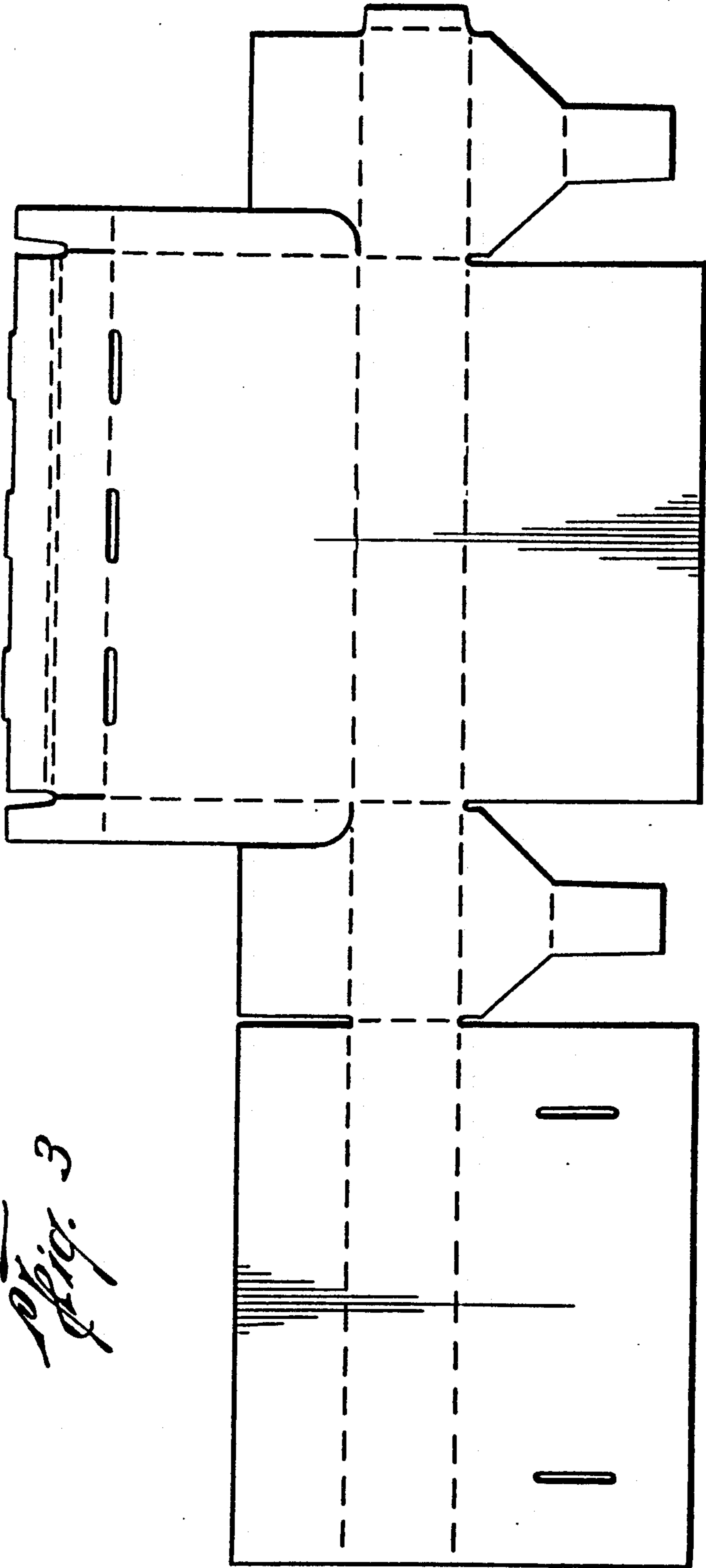

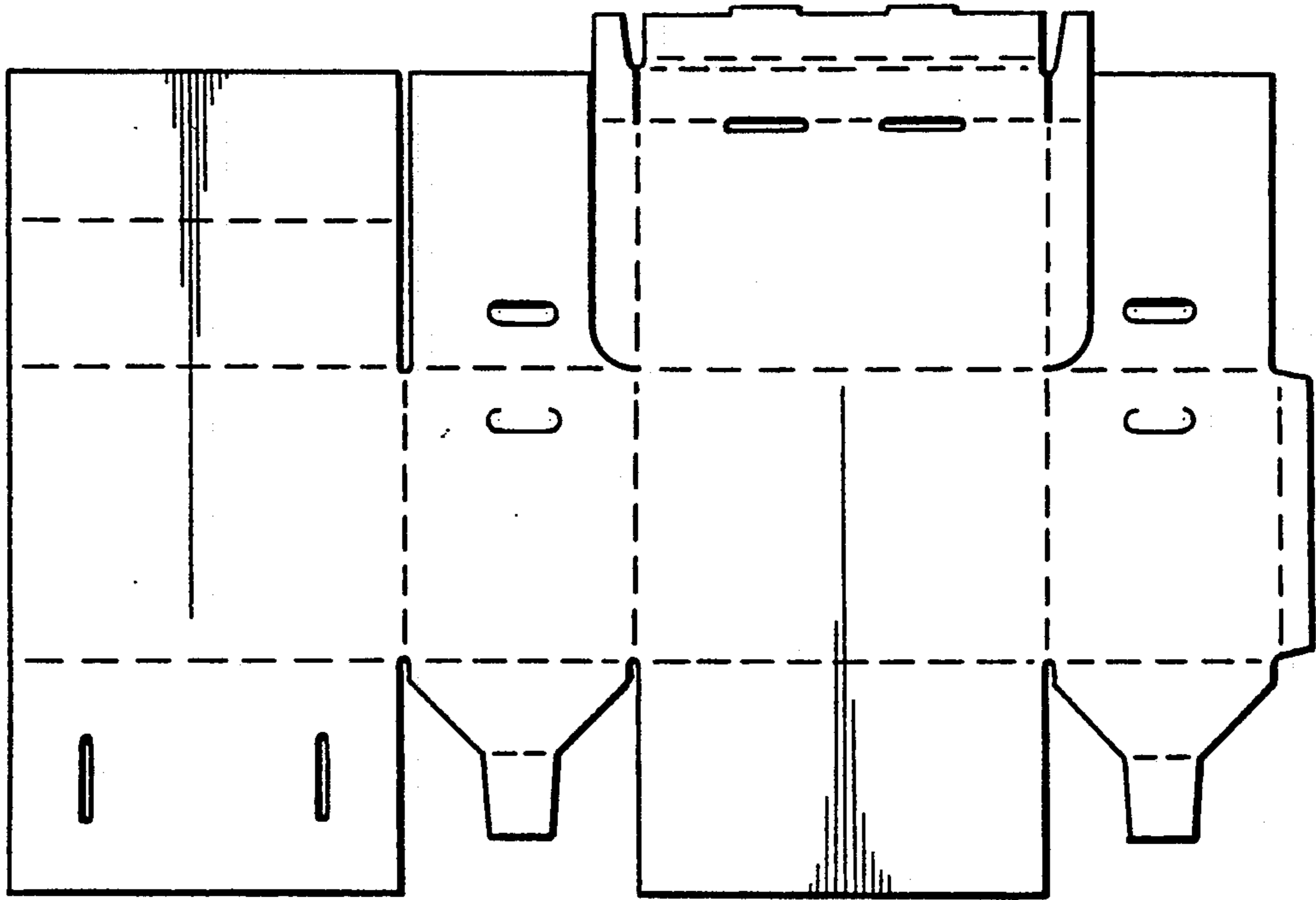

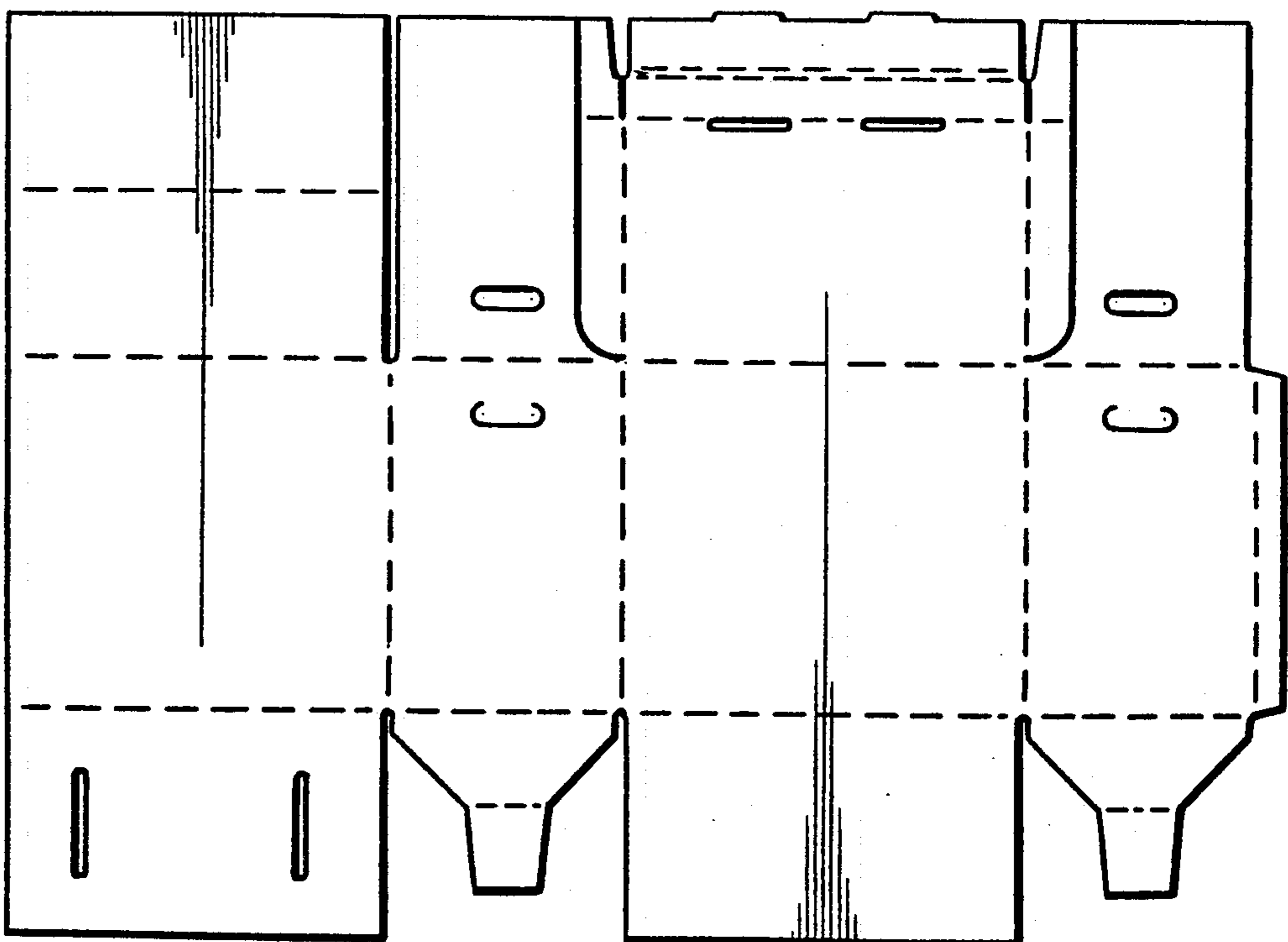

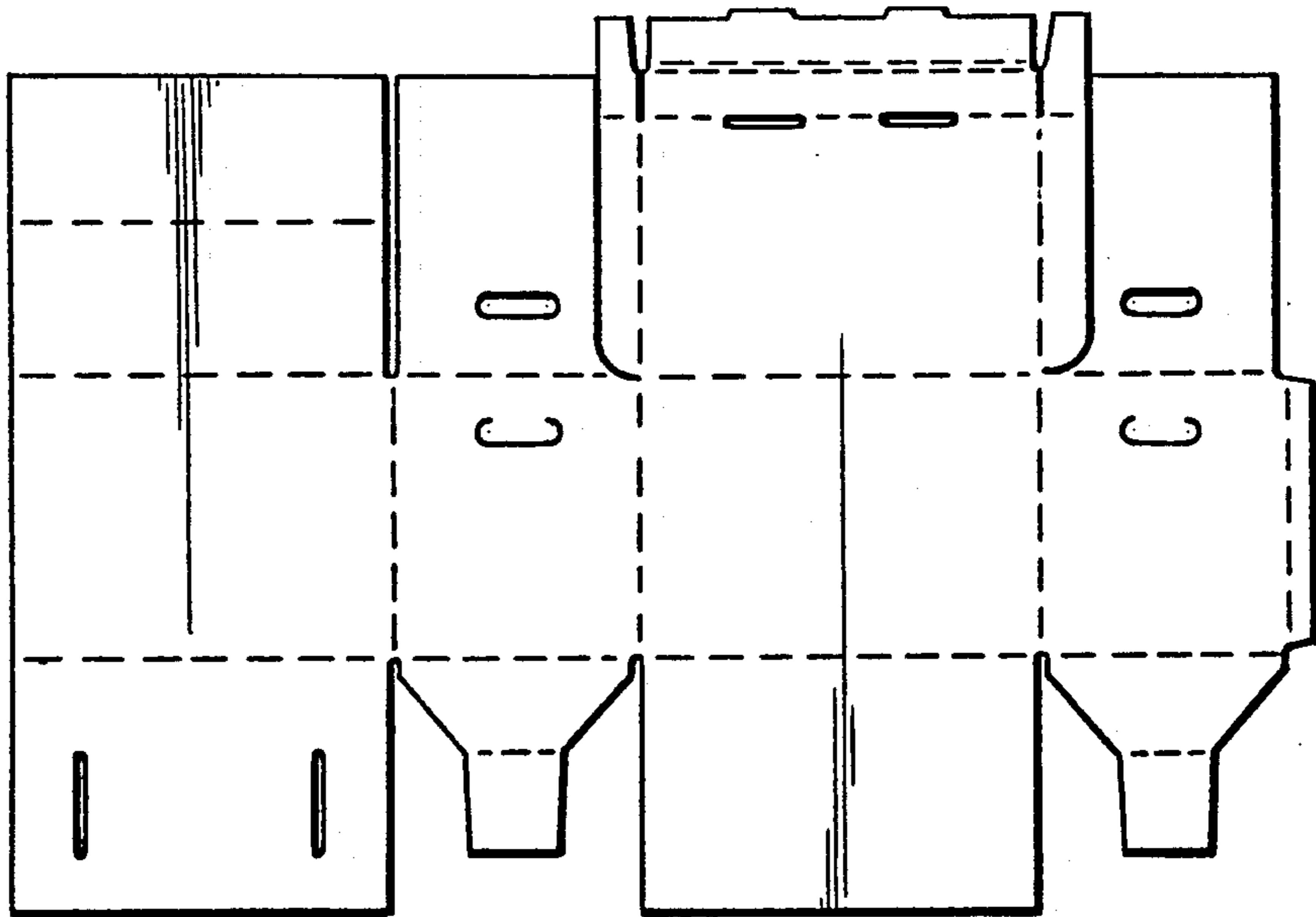

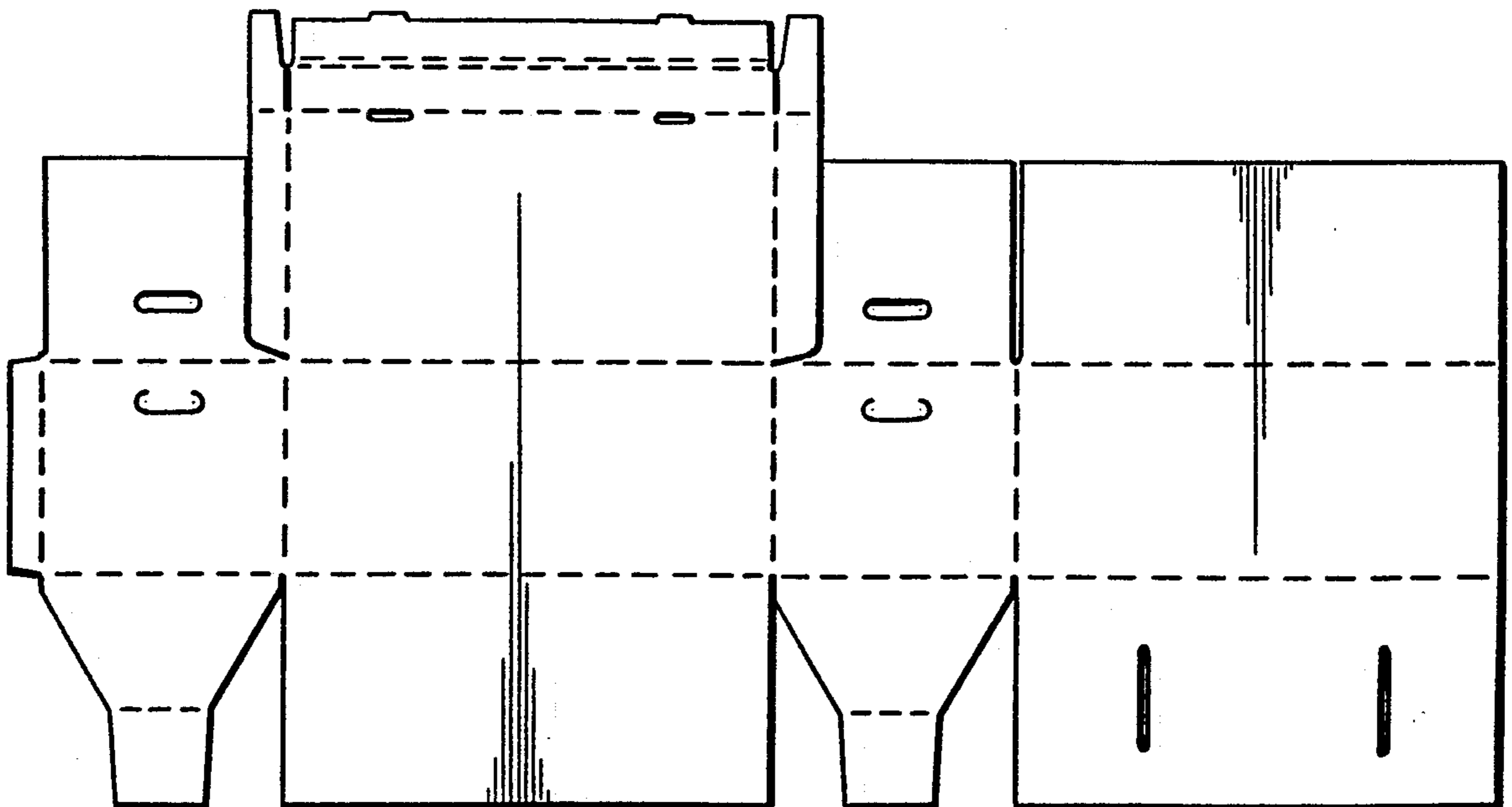

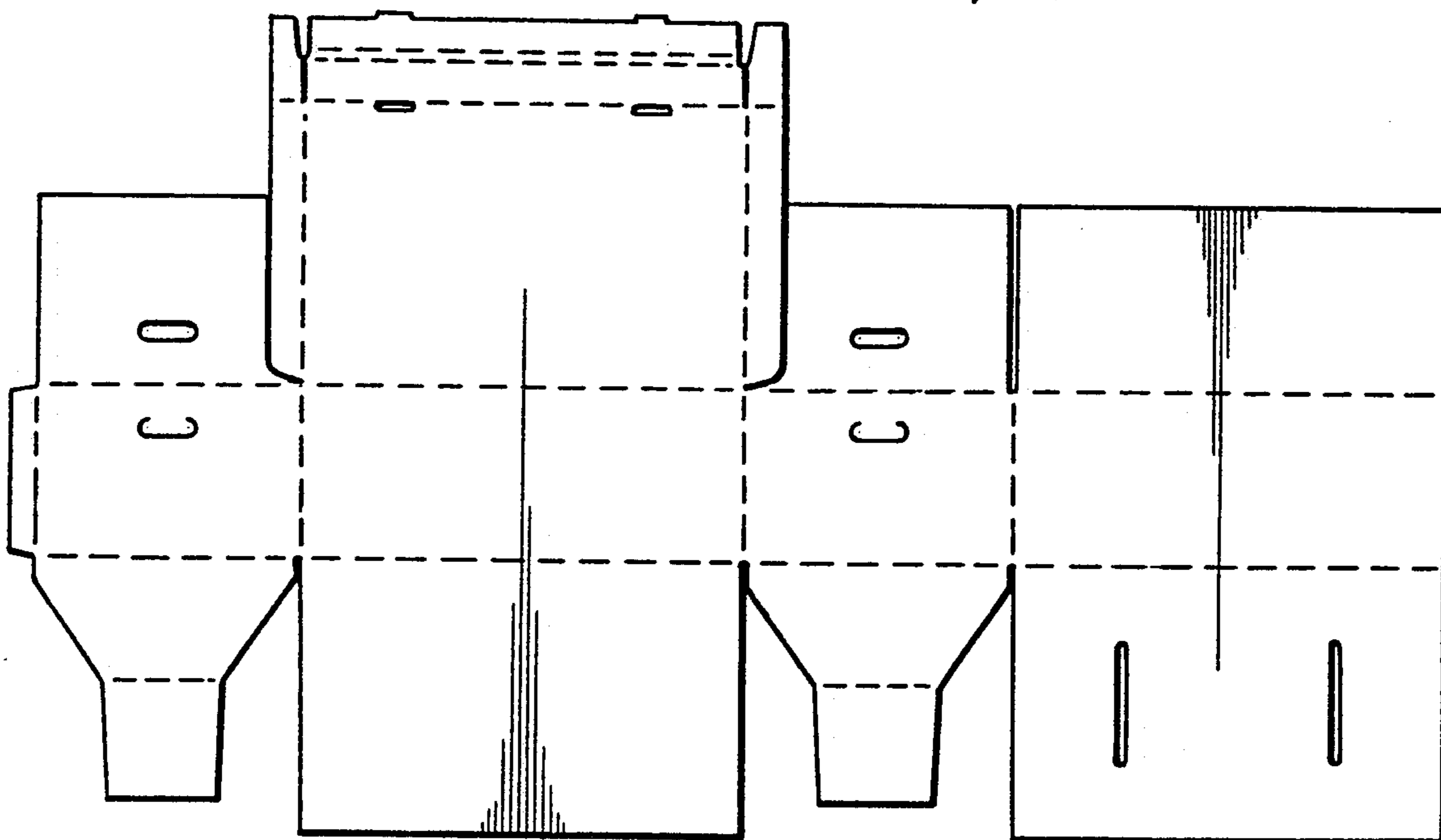
