The ornamental design for a combined telephone, digital clock and radio, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a combined telephone, digital clock and radio in cradled relationship showing my new design;
 FIG. 2 is a rear and bottom perspective view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof; and
 FIG. 6 is a front and top perspective view of the base and a left side and bottom perspective view of the spaced apart inverted handset.

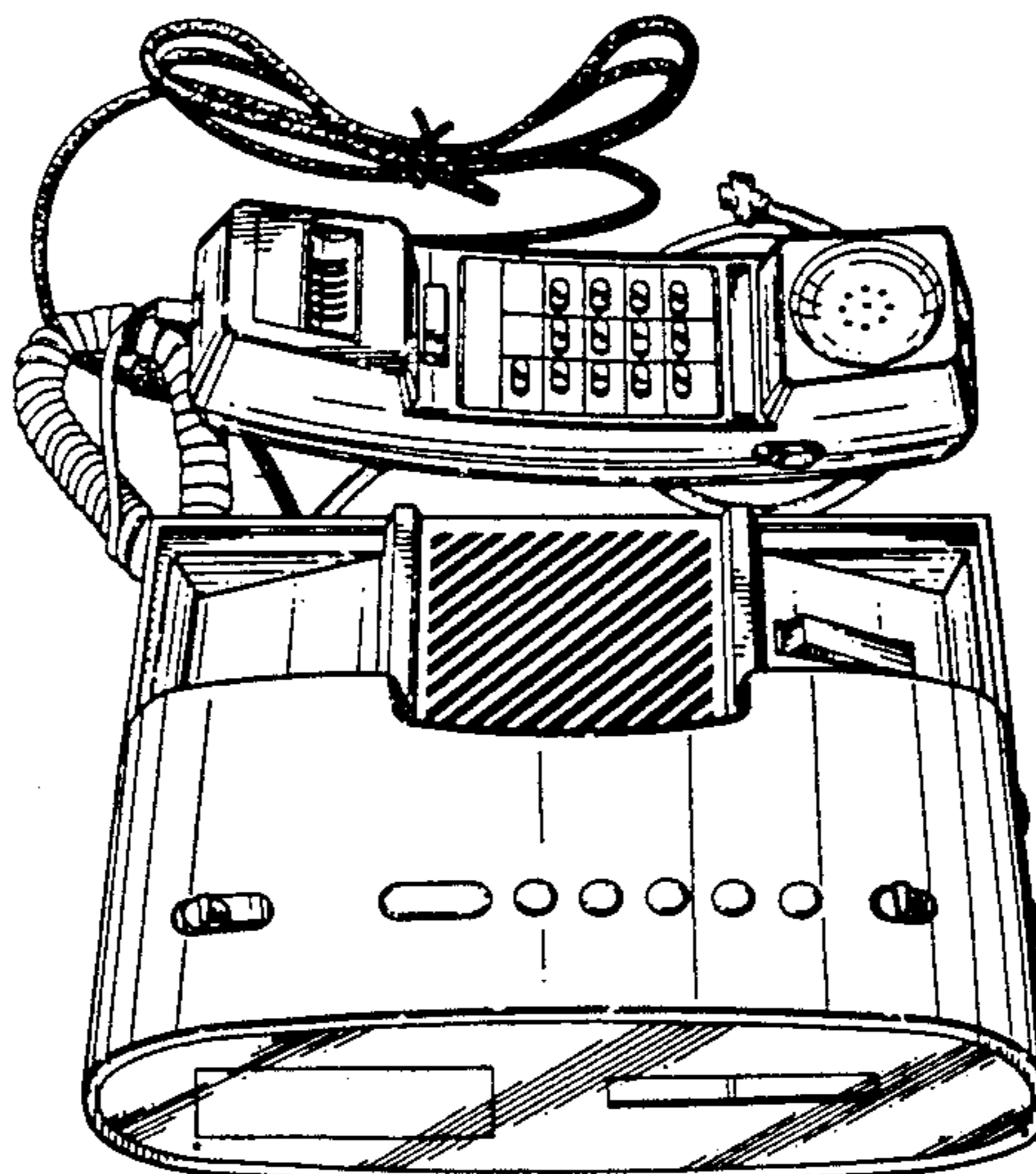
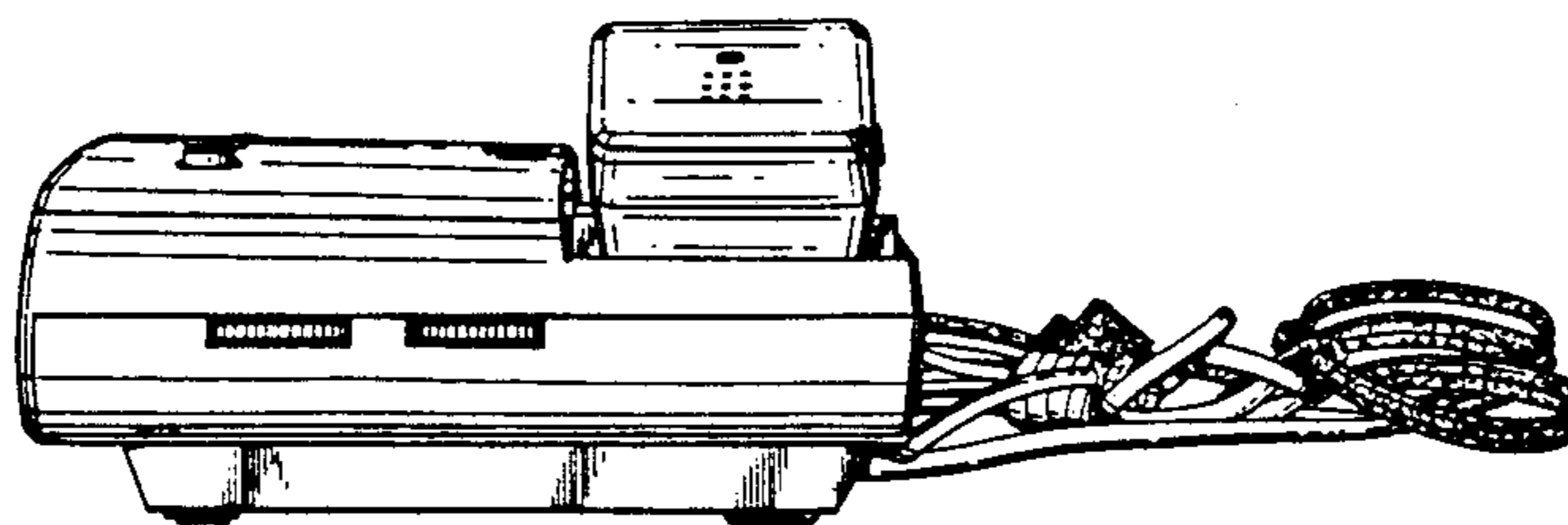

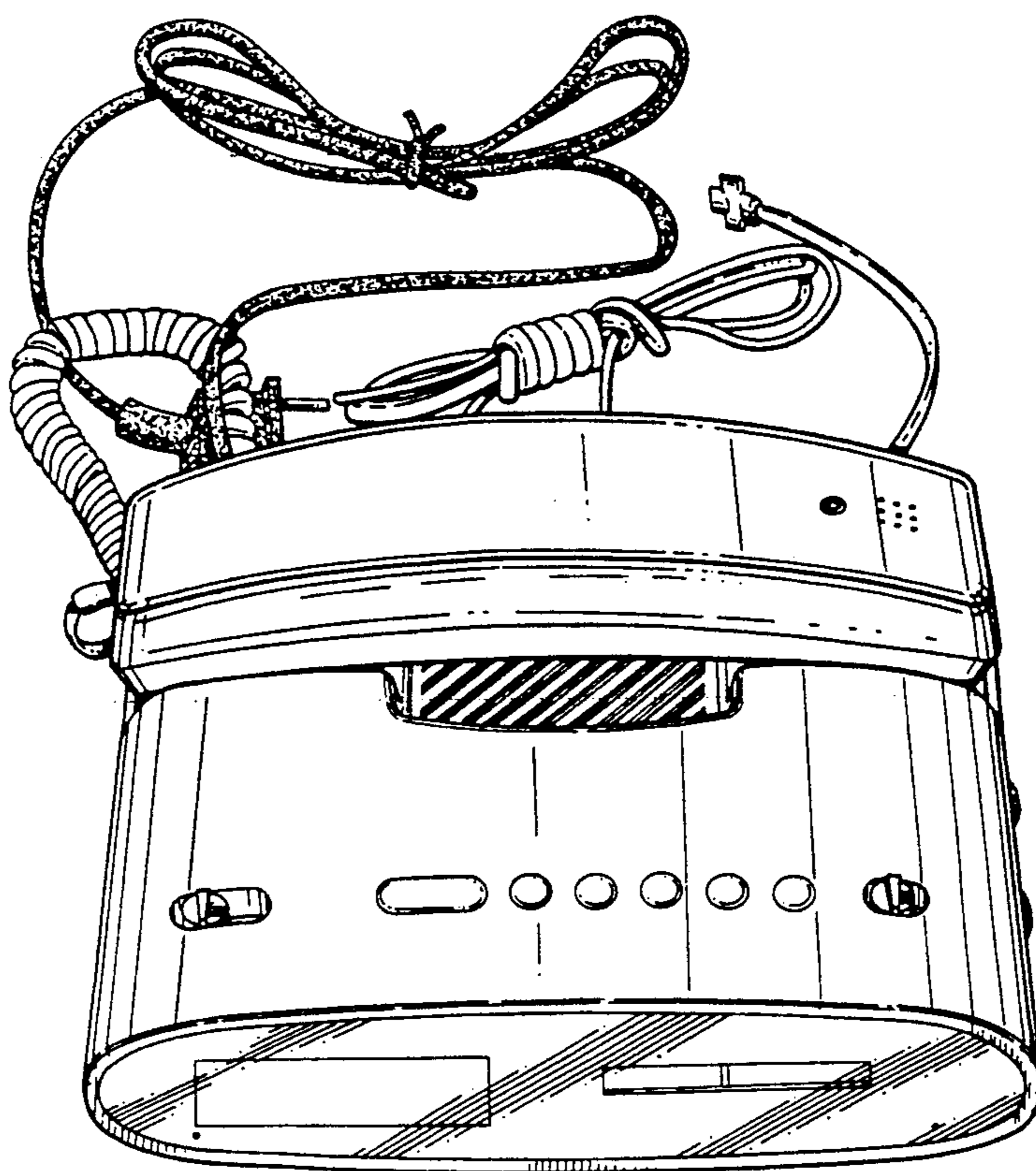

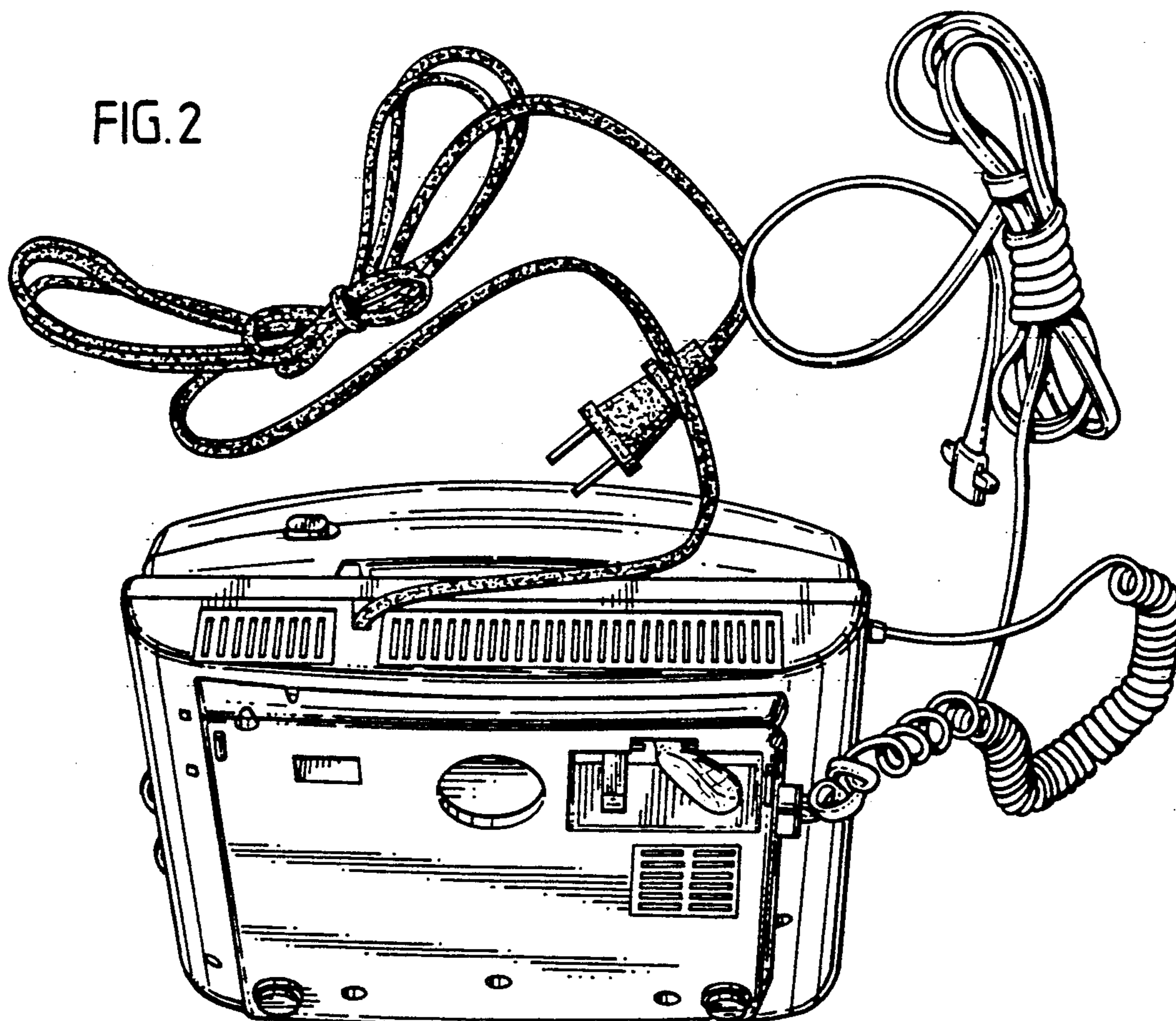

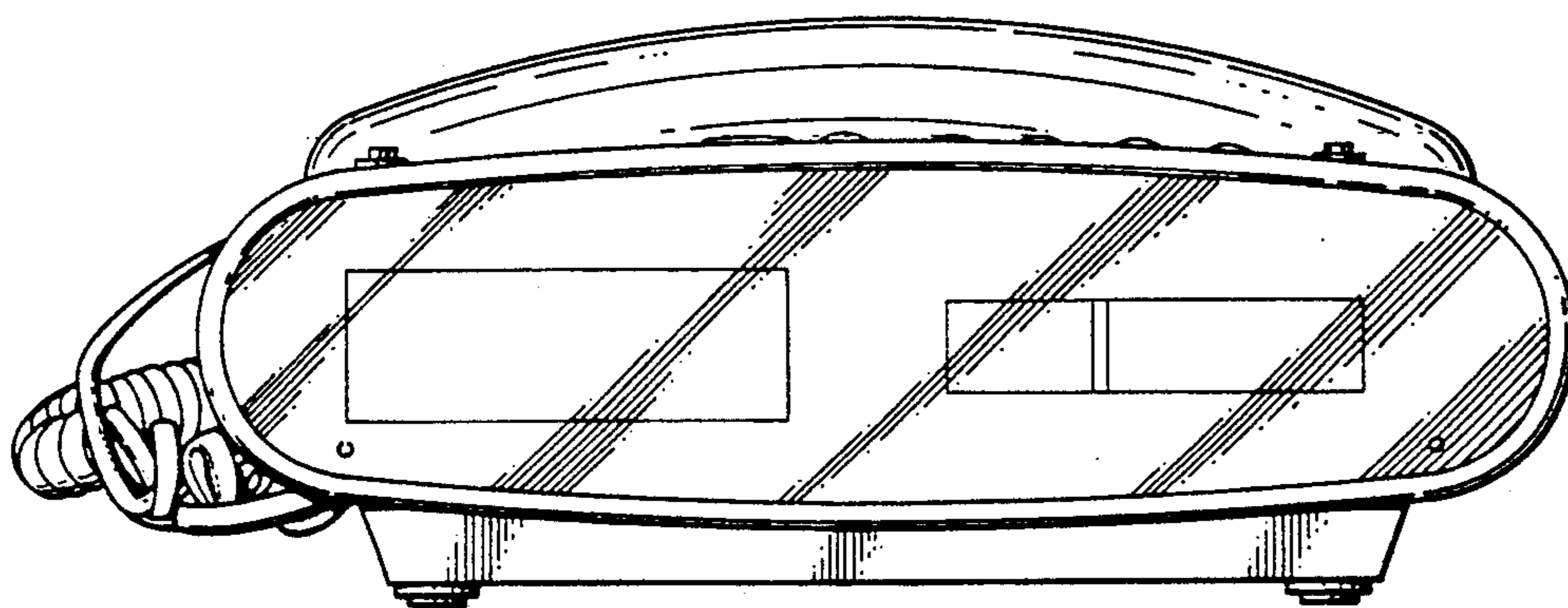

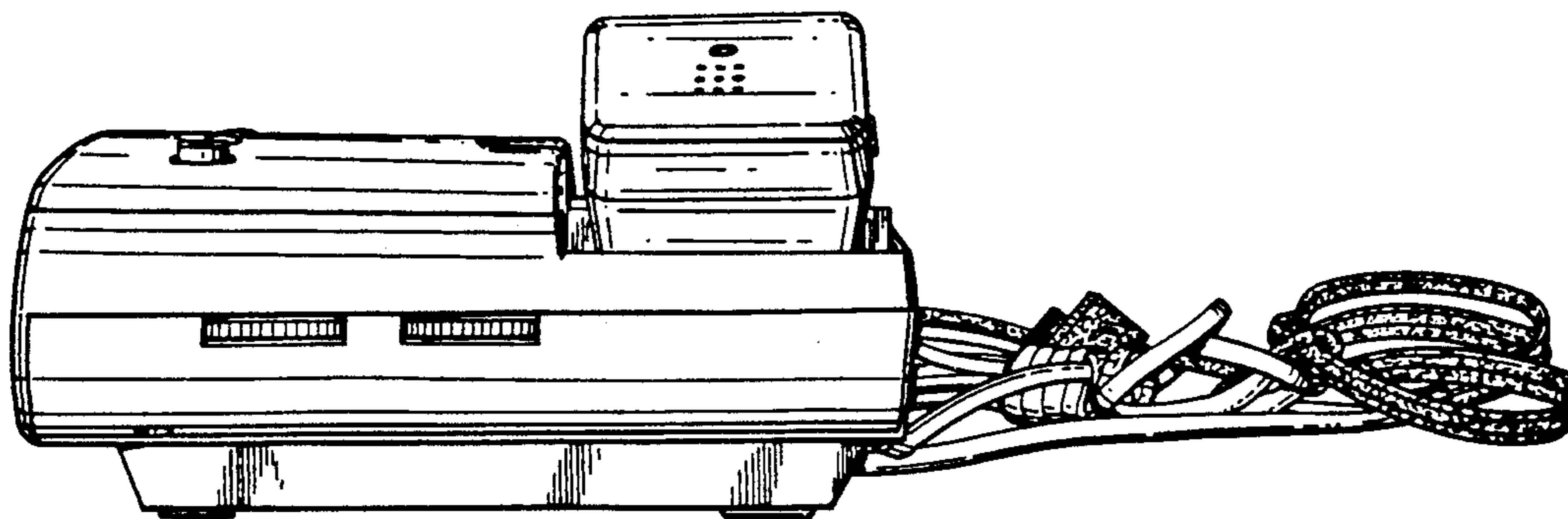

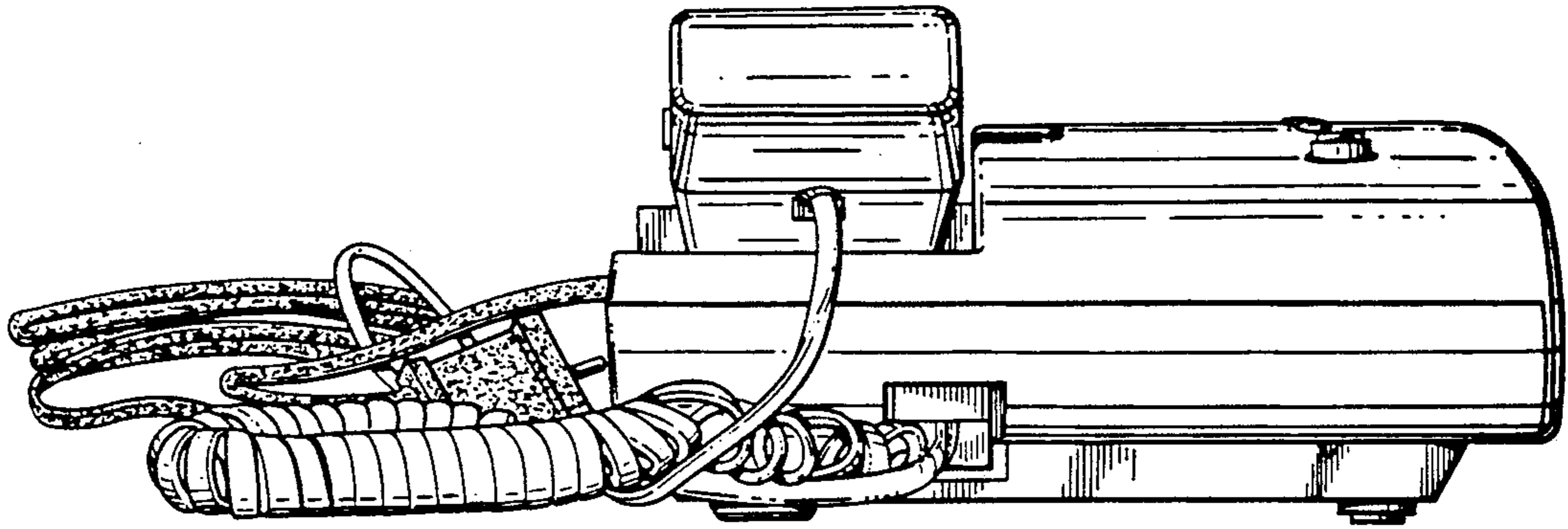
