DESCRIPTION

FIG. 14 is a sectional view taken along line 14—14 of FIG. 8.

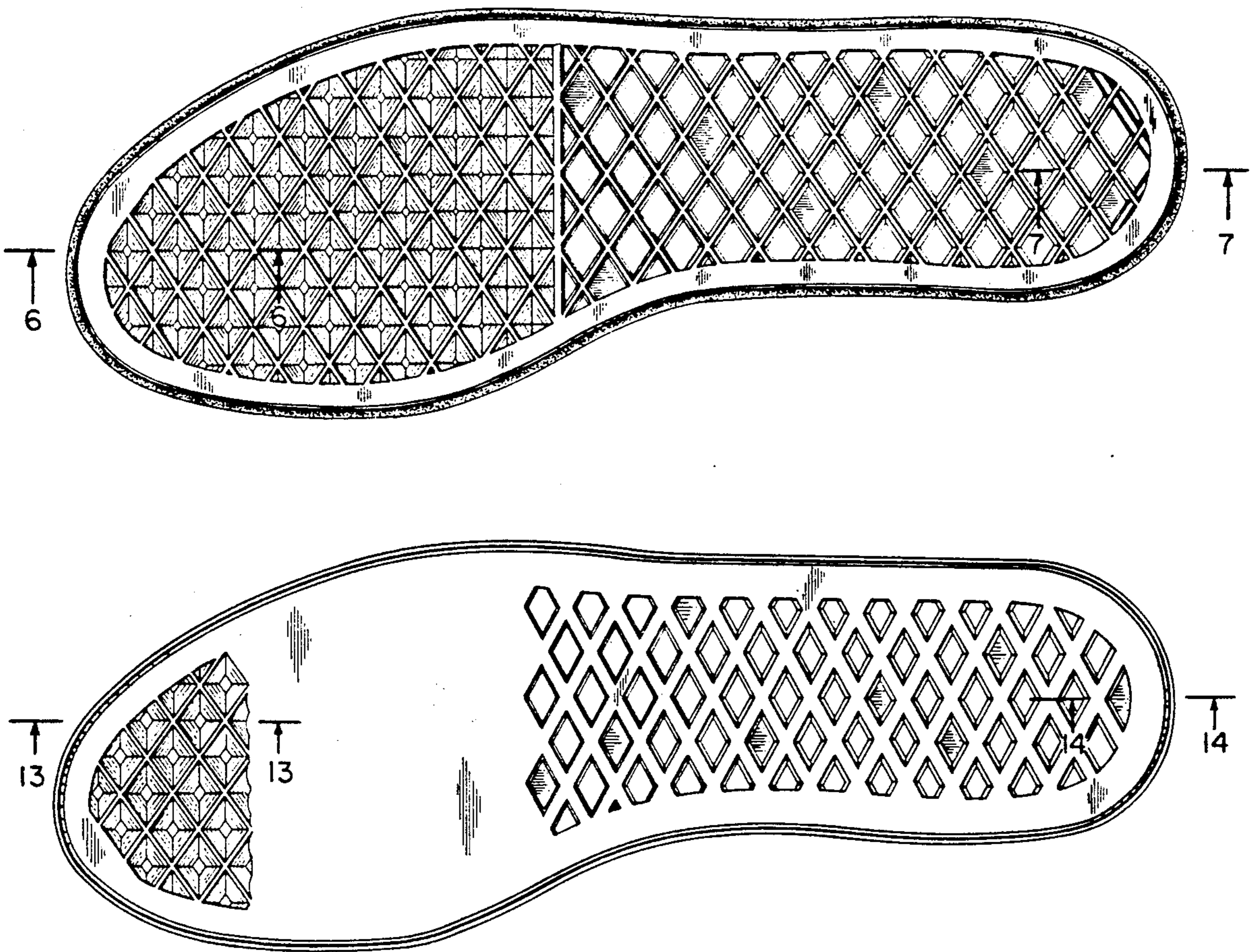

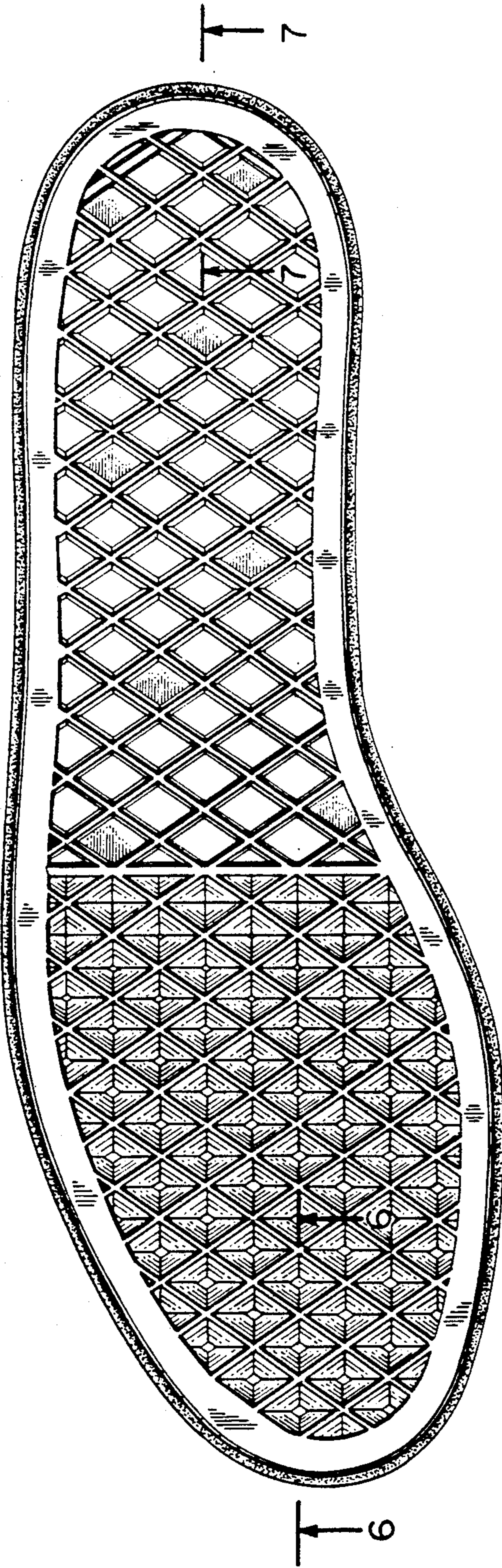

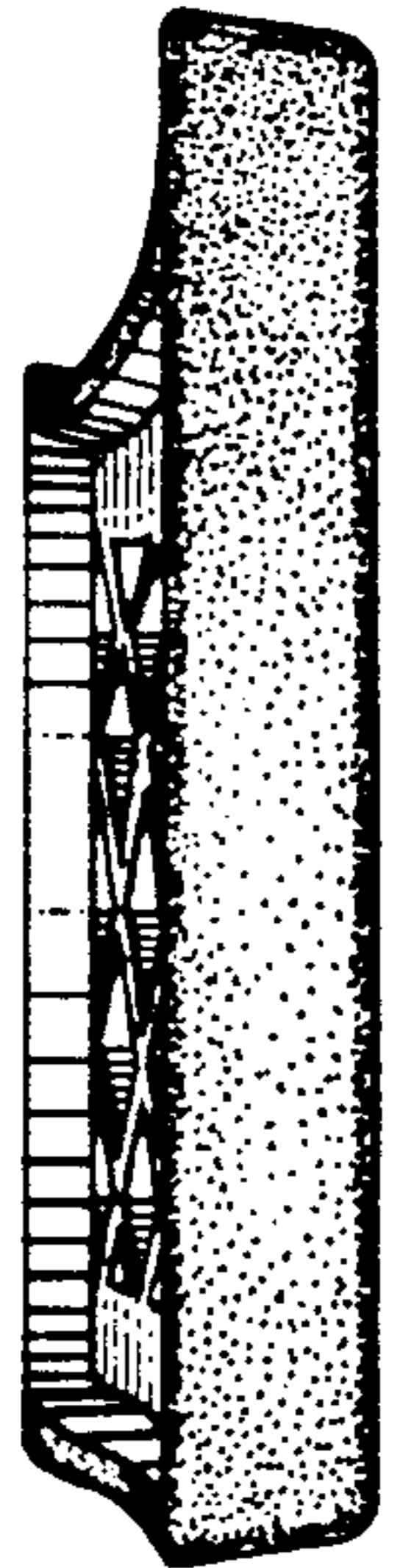

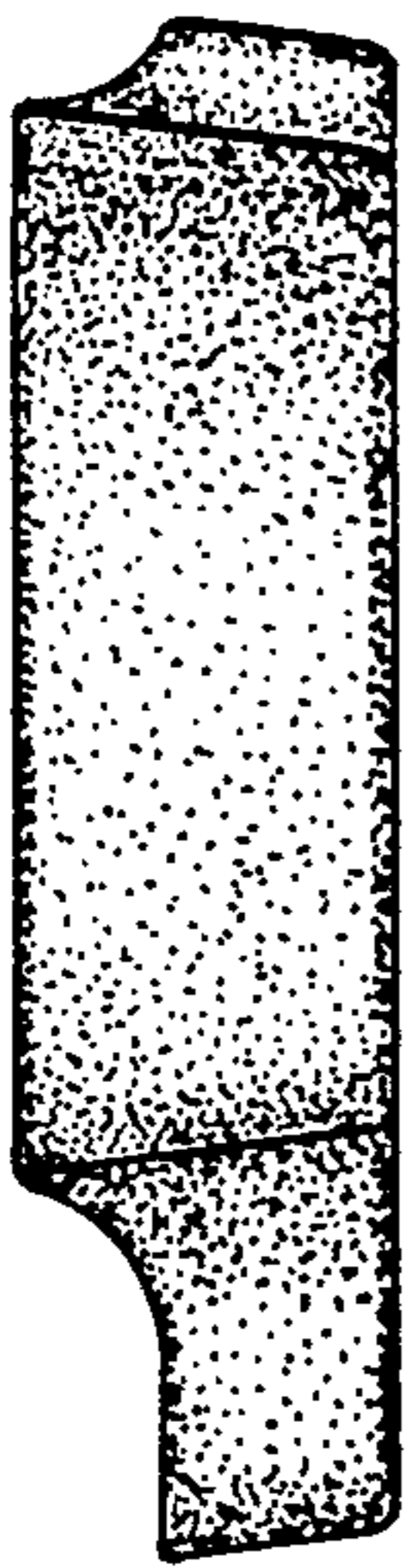

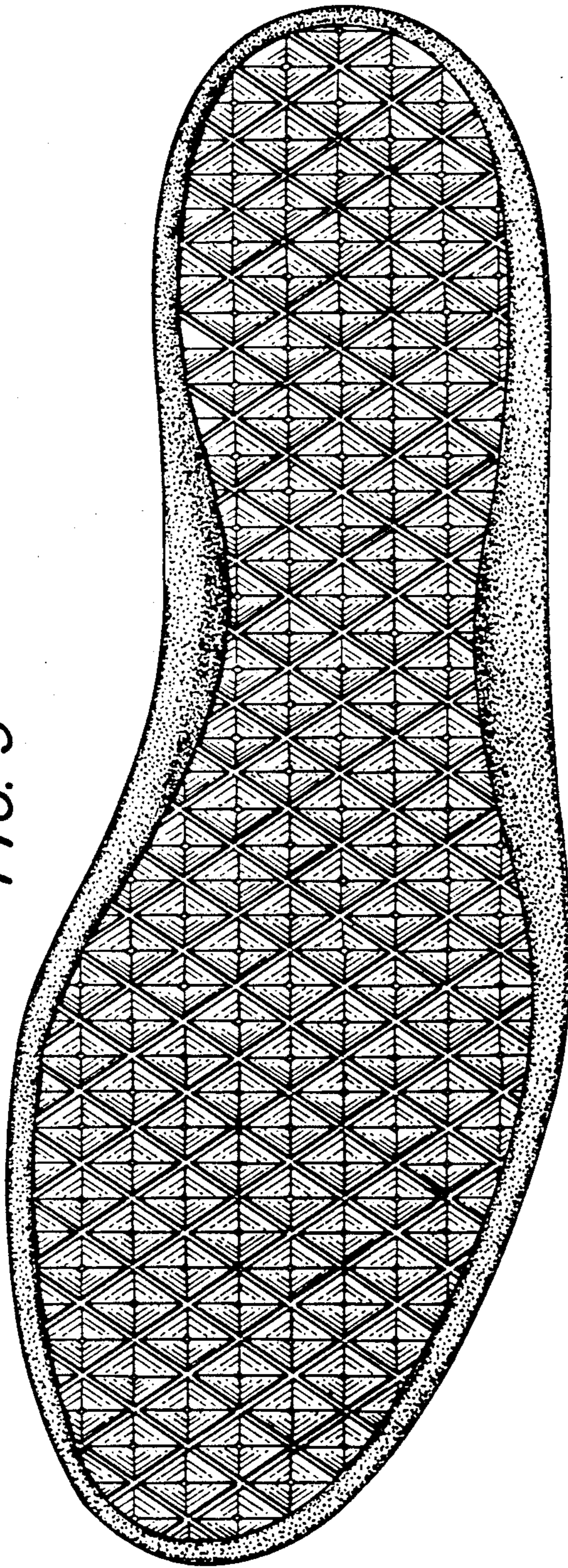

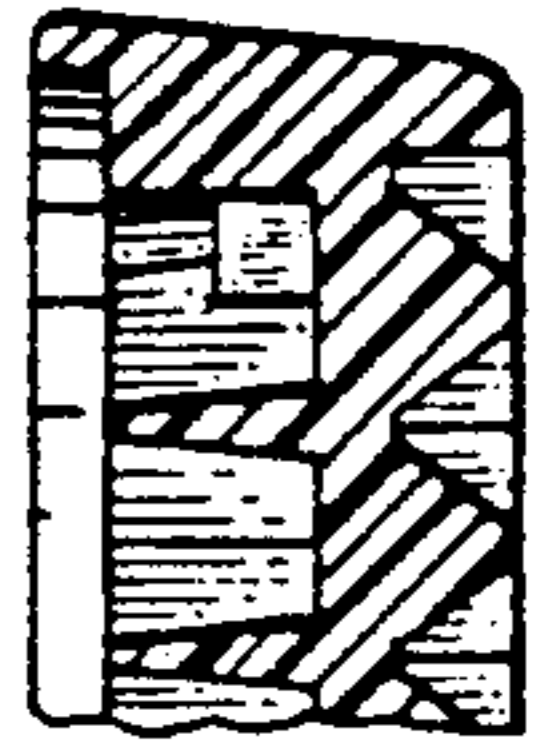

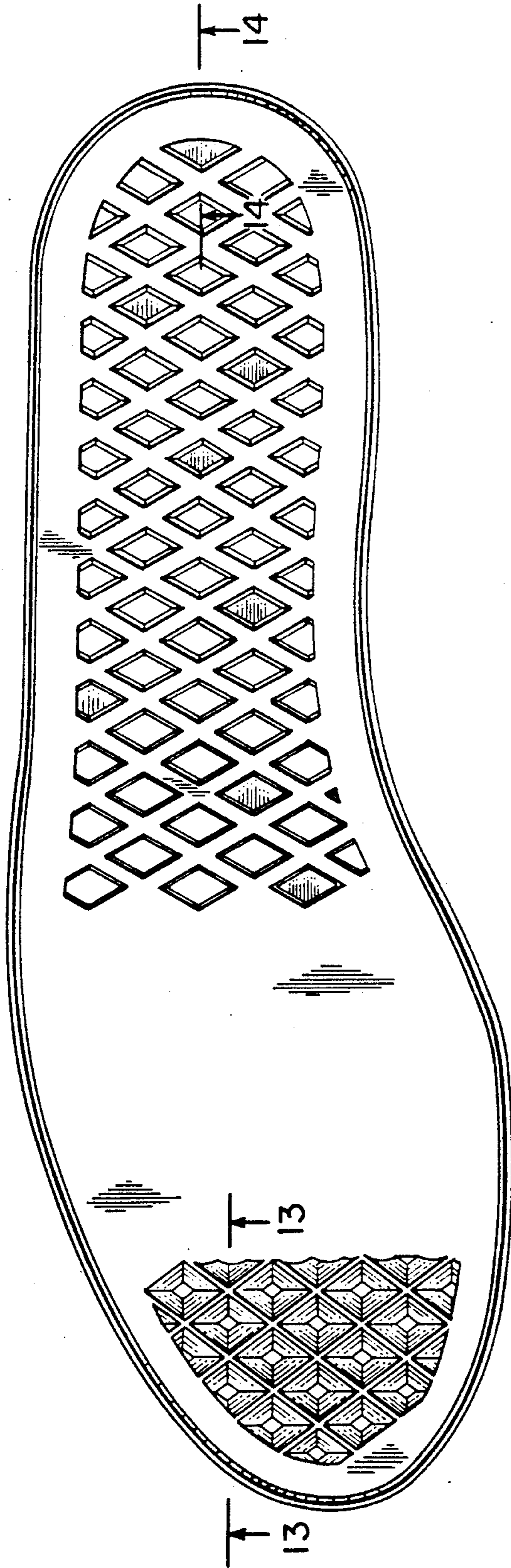

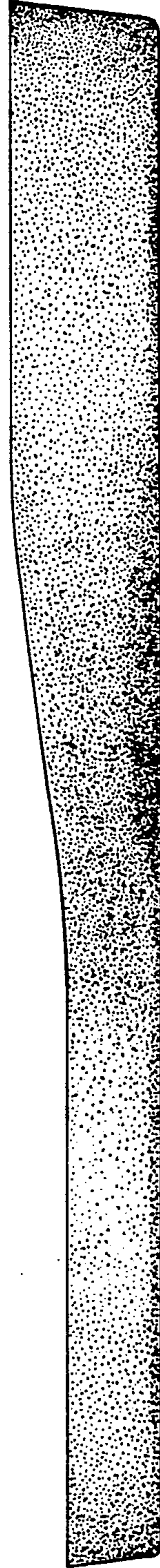

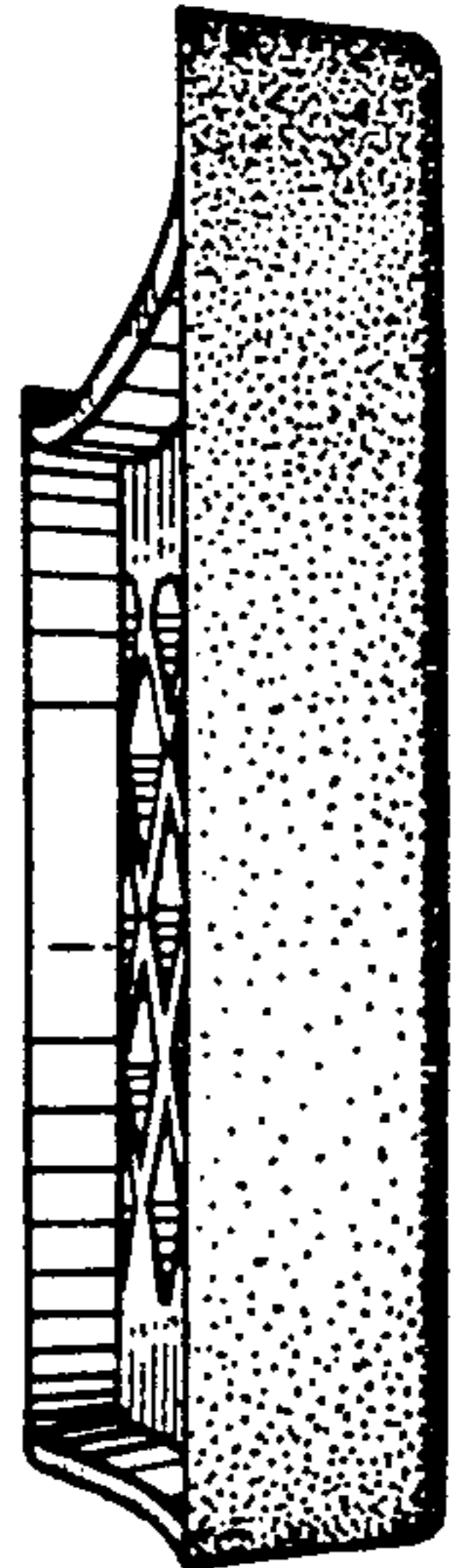

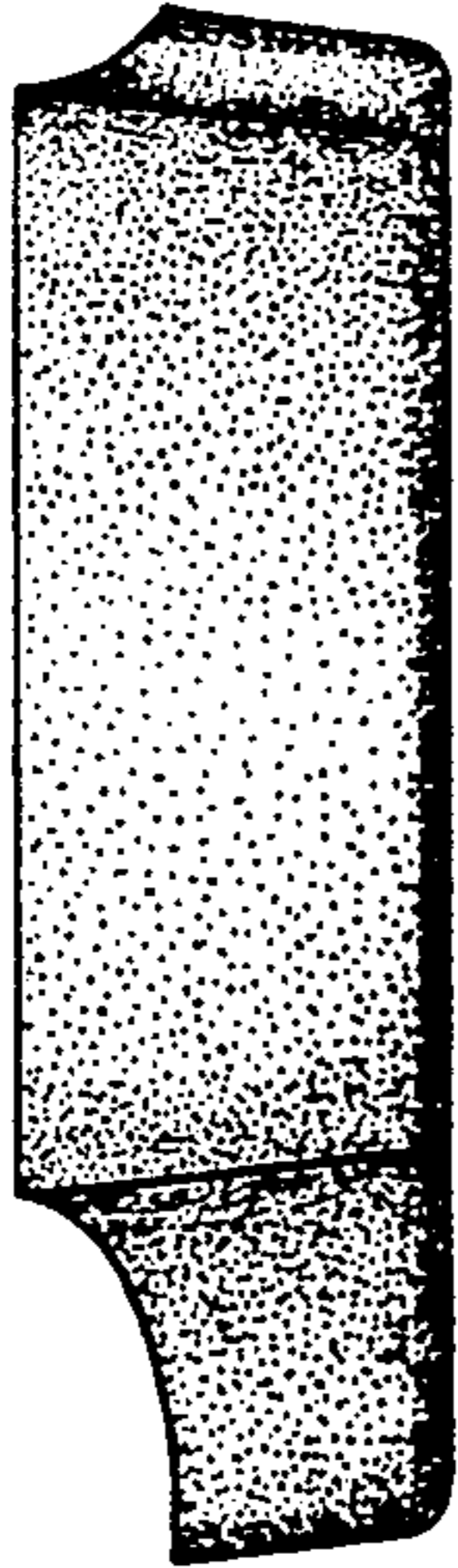

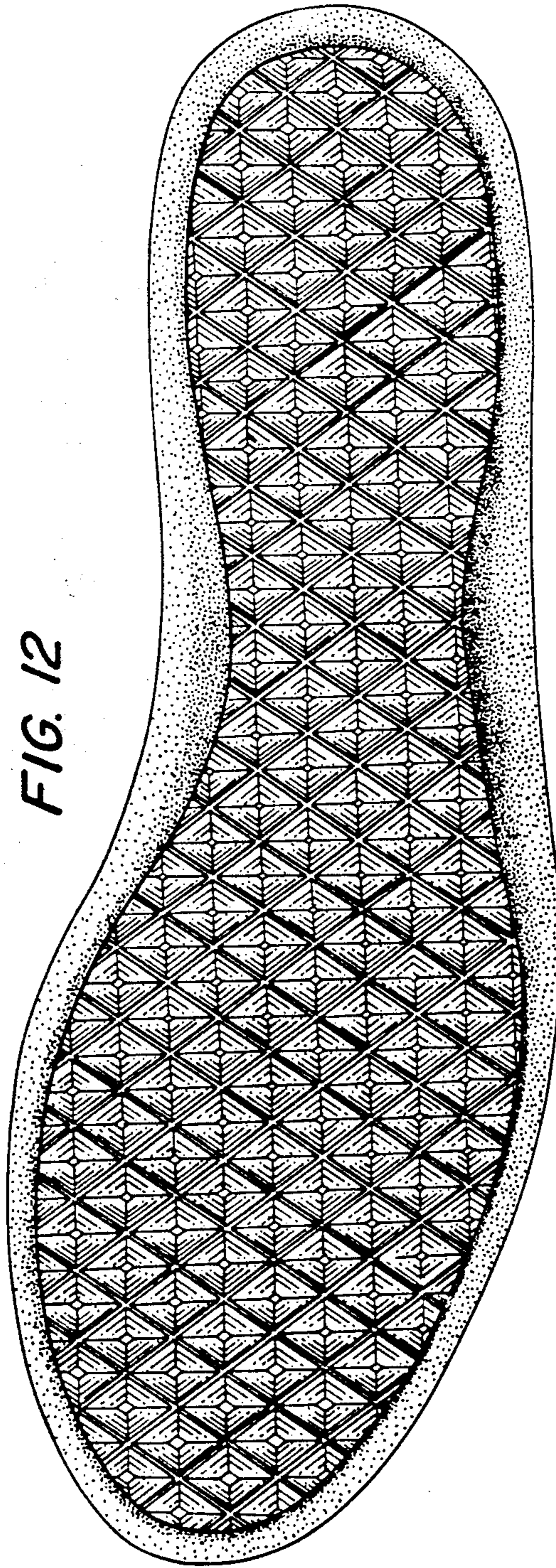

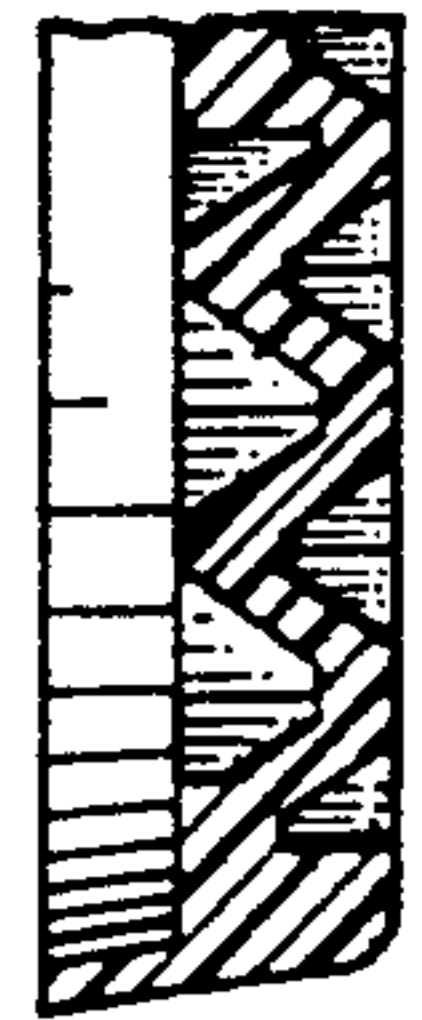
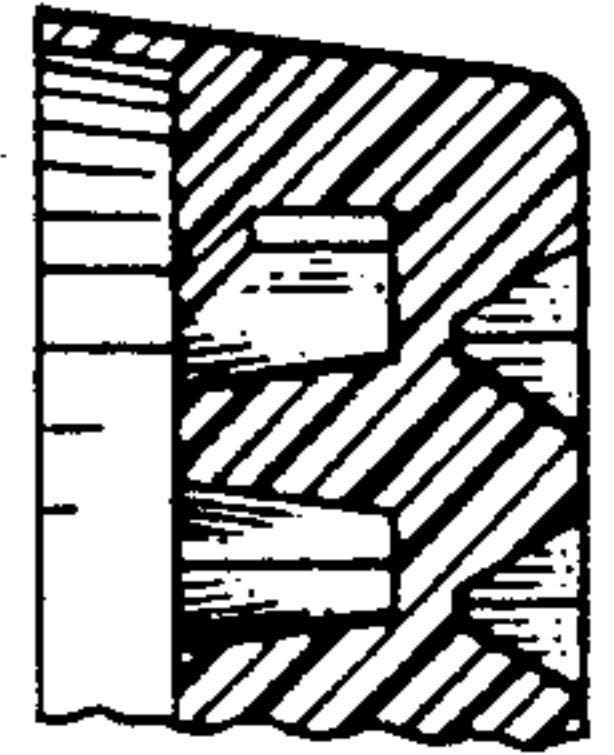
