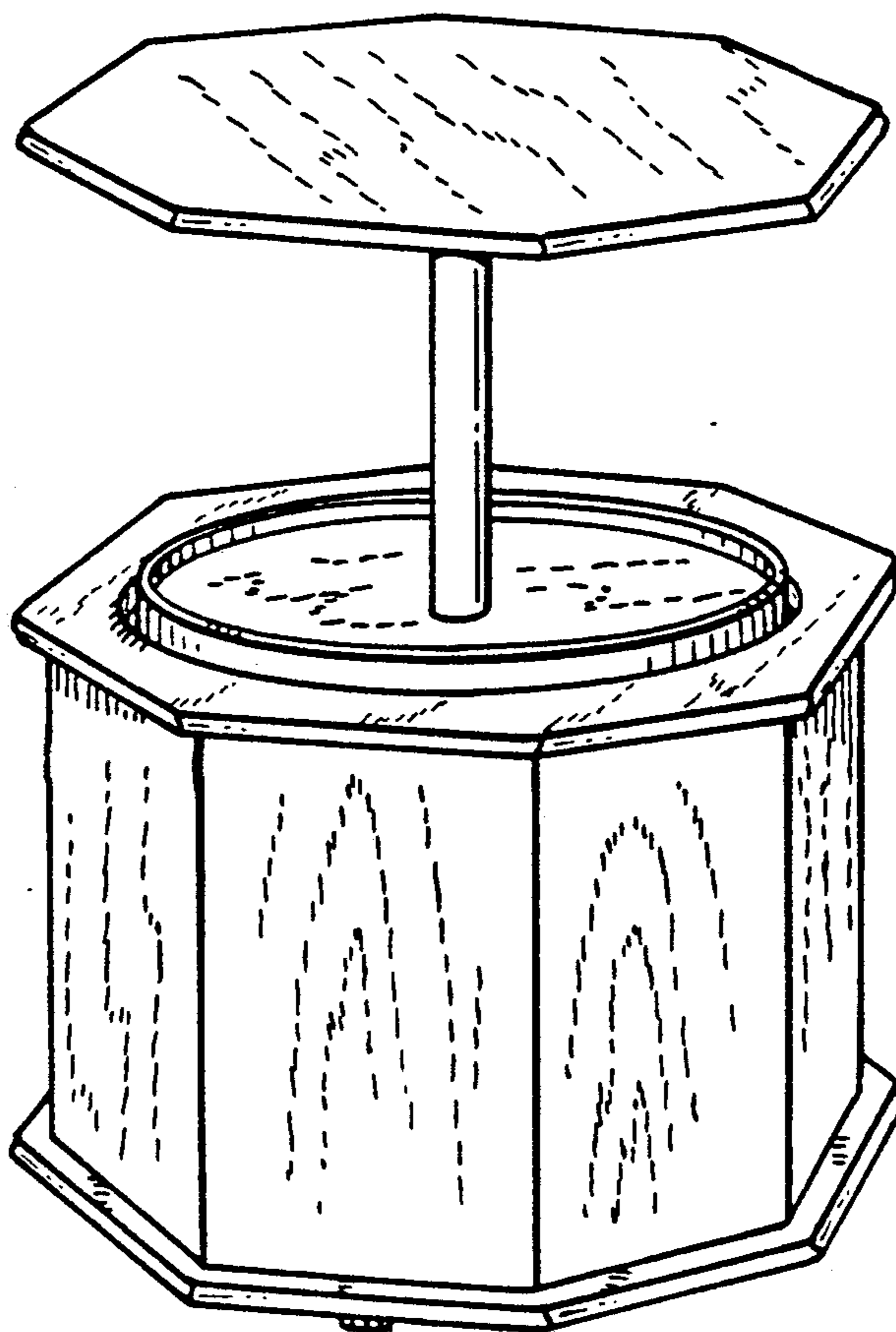

The ornamental design for an adjustable table, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an adjustable table showing my new design;
 FIG. 2 is a top plan view;
 FIG. 3 is a side elevational view;
 FIG. 4 is a bottom plan view;
 FIG. 5 is a perspective view of an adjustable table with the top in a raised position;
 FIG. 6 is a side elevational view of the table as shown in FIG. 5;
 FIG. 7 is a perspective view of an adjustable table showing a second embodiment of my new design;
 FIG. 8 is a top plan view of the second embodiment;
 FIG. 9 is a perspective view of an adjustable table showing a third embodiment of my new design;
 FIG. 10 is a top plan view of the third embodiment;
 FIG. 11 is a perspective view of an adjustable table showing a fourth embodiment of my new design; and
 FIG. 12 is a top plan view of the fourth embodiment.
 The appearances of the undisclosed side portions are the same in appearance as the respective side portions shown.



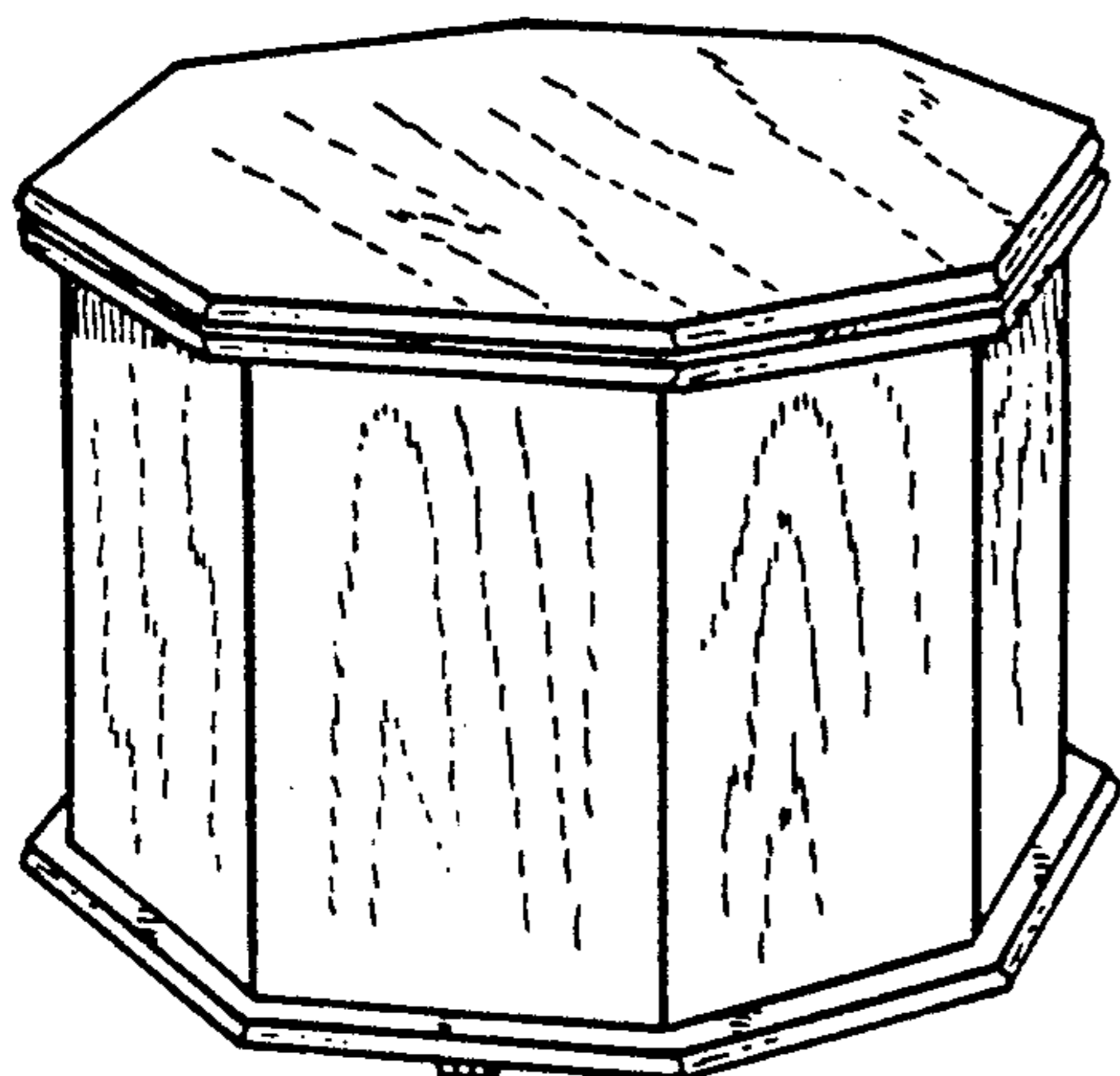

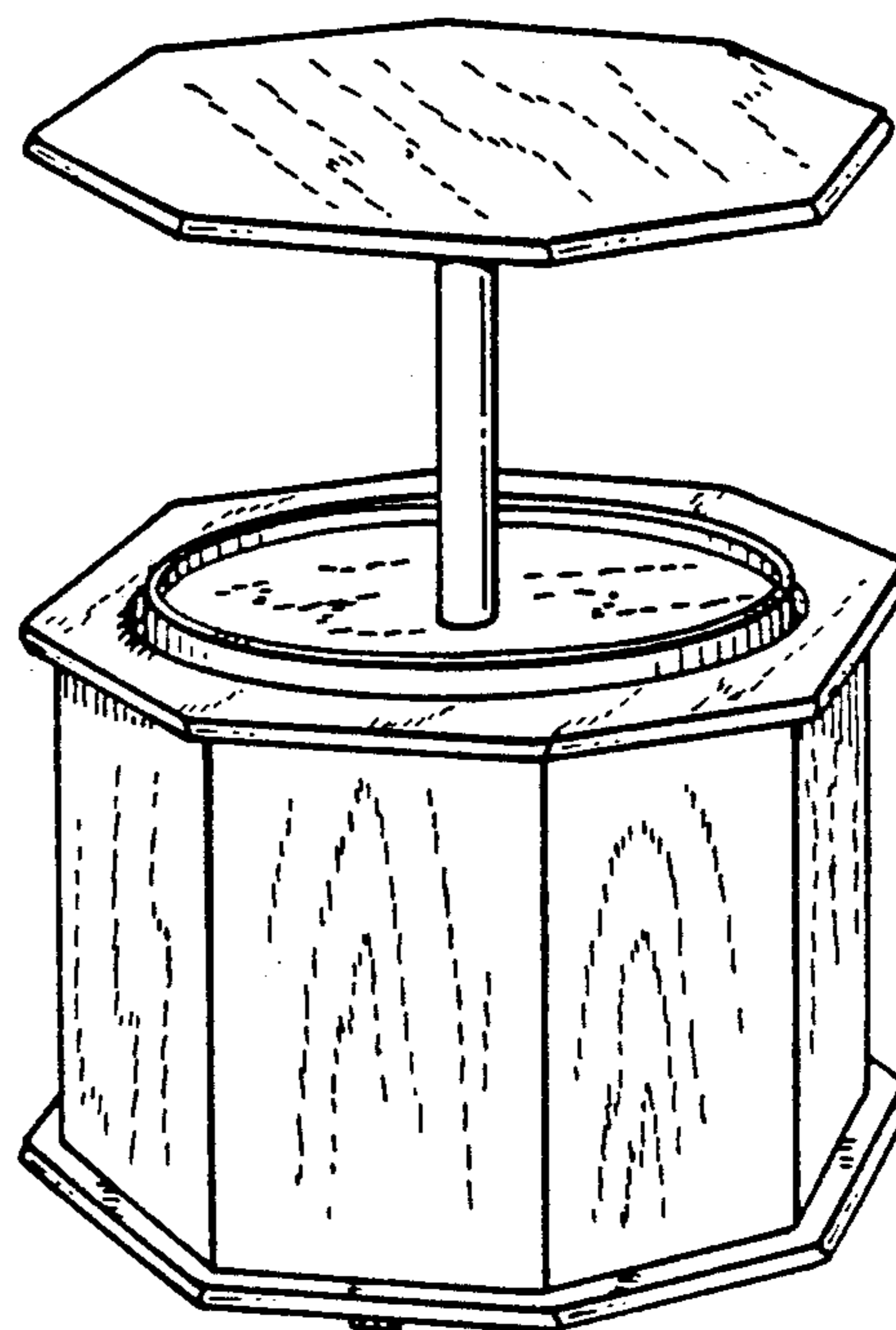

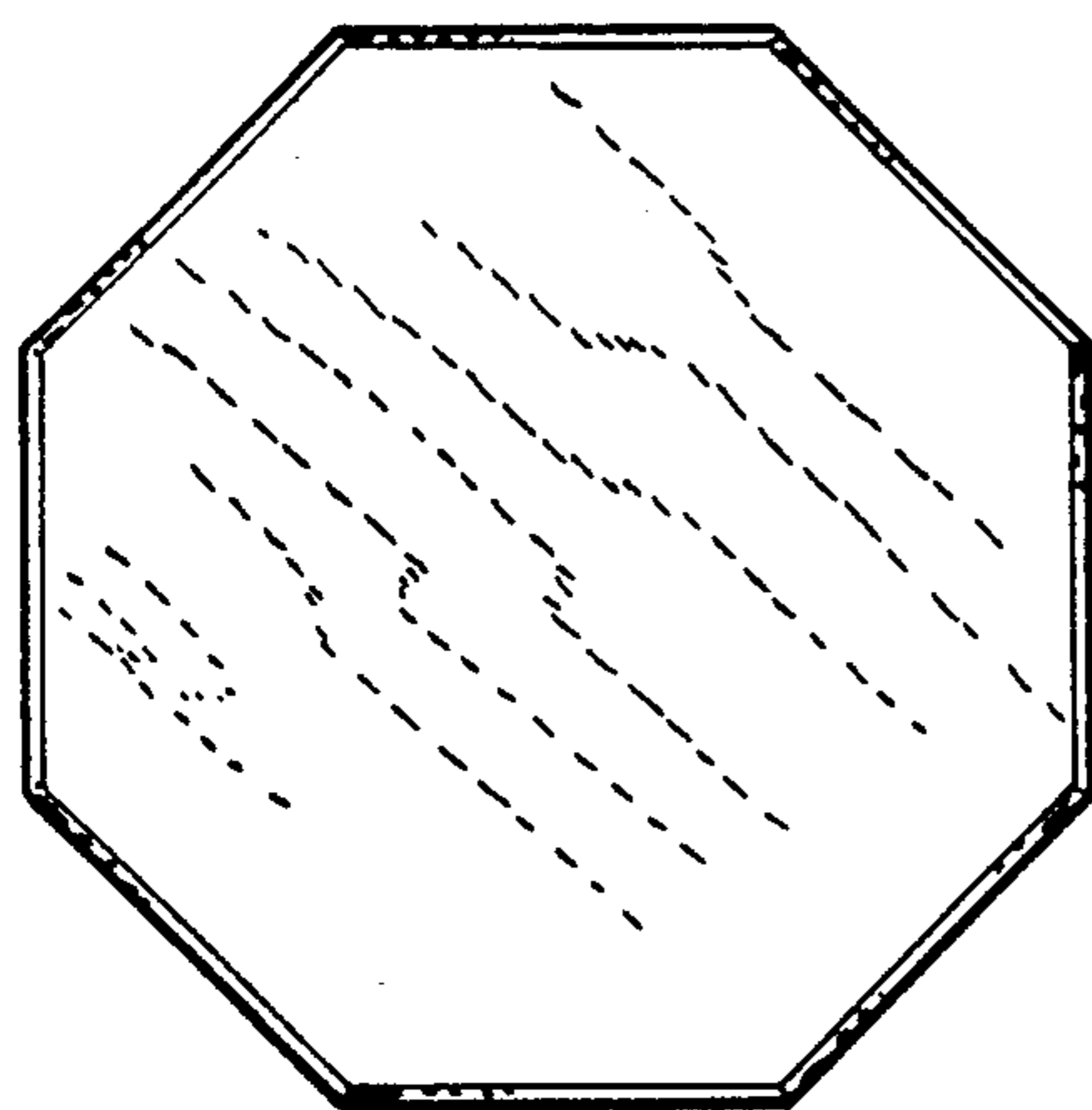

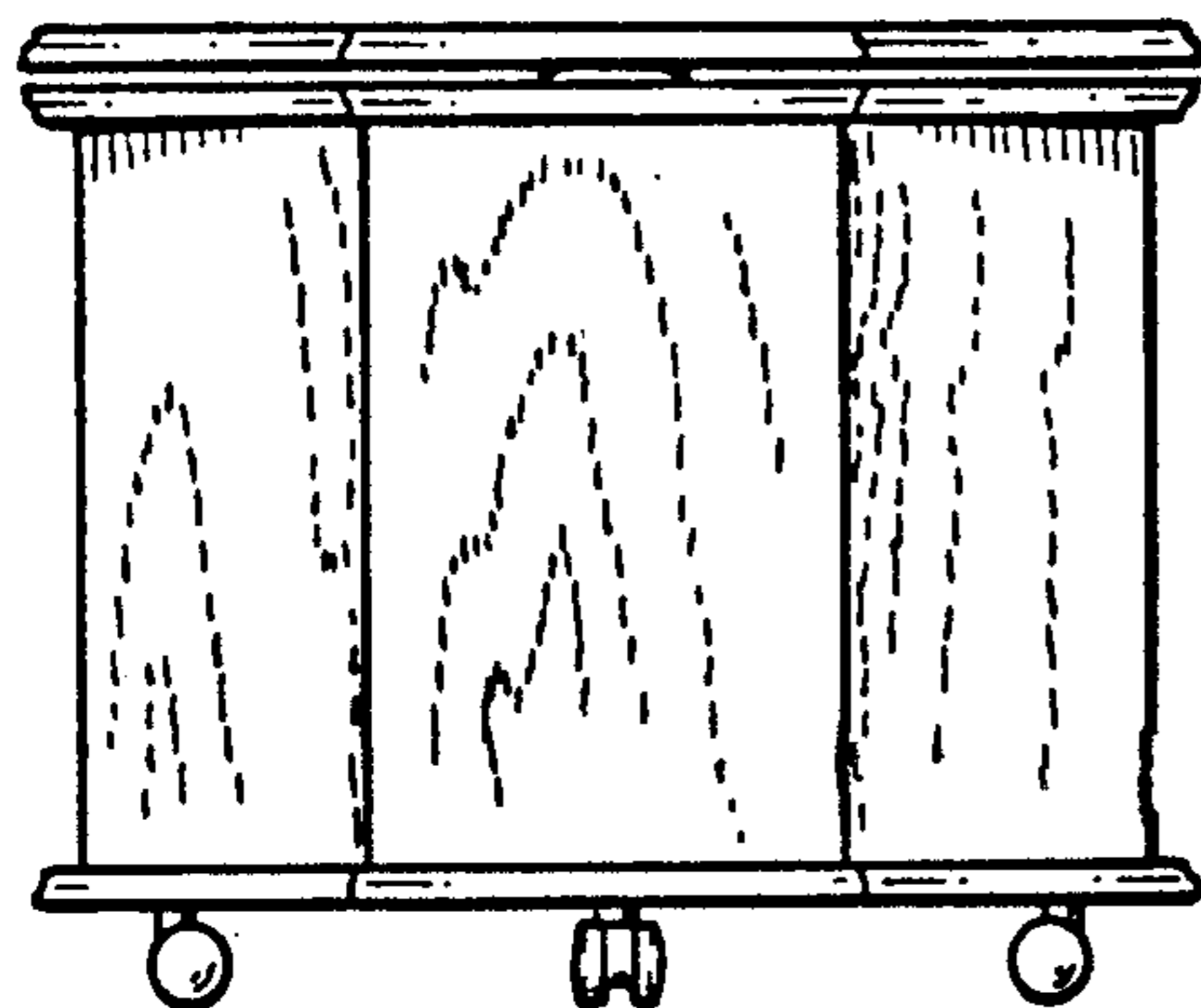

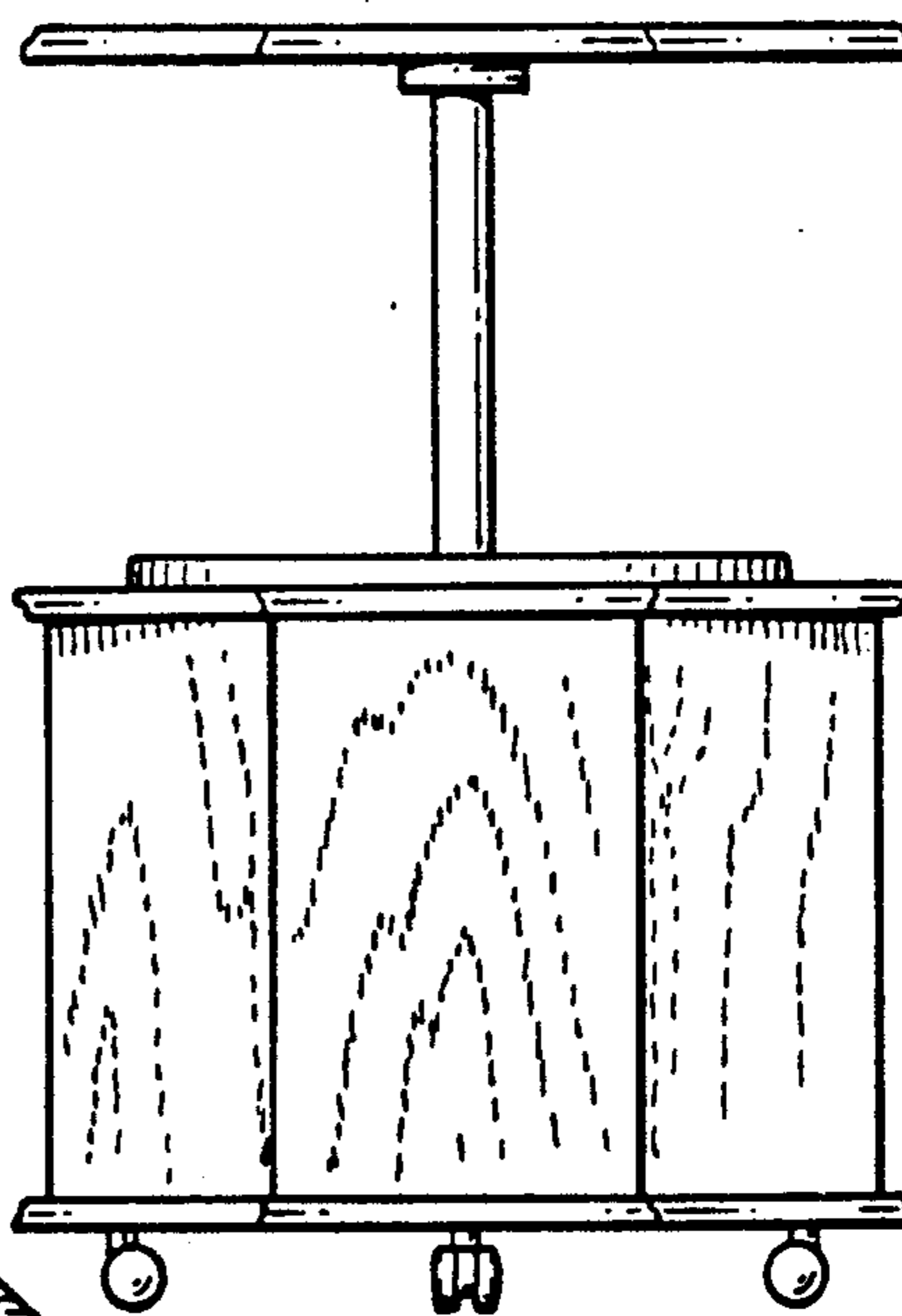

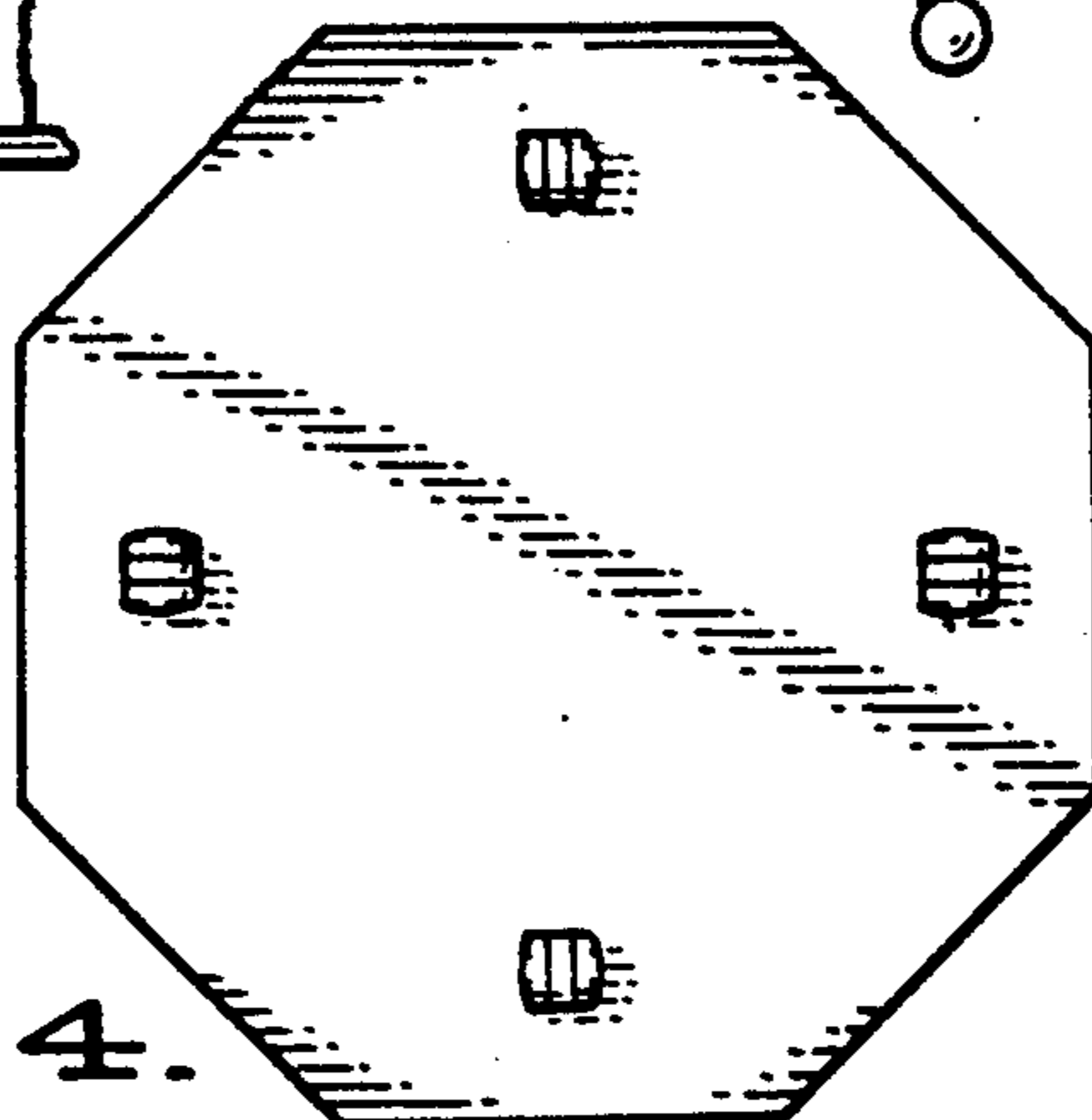

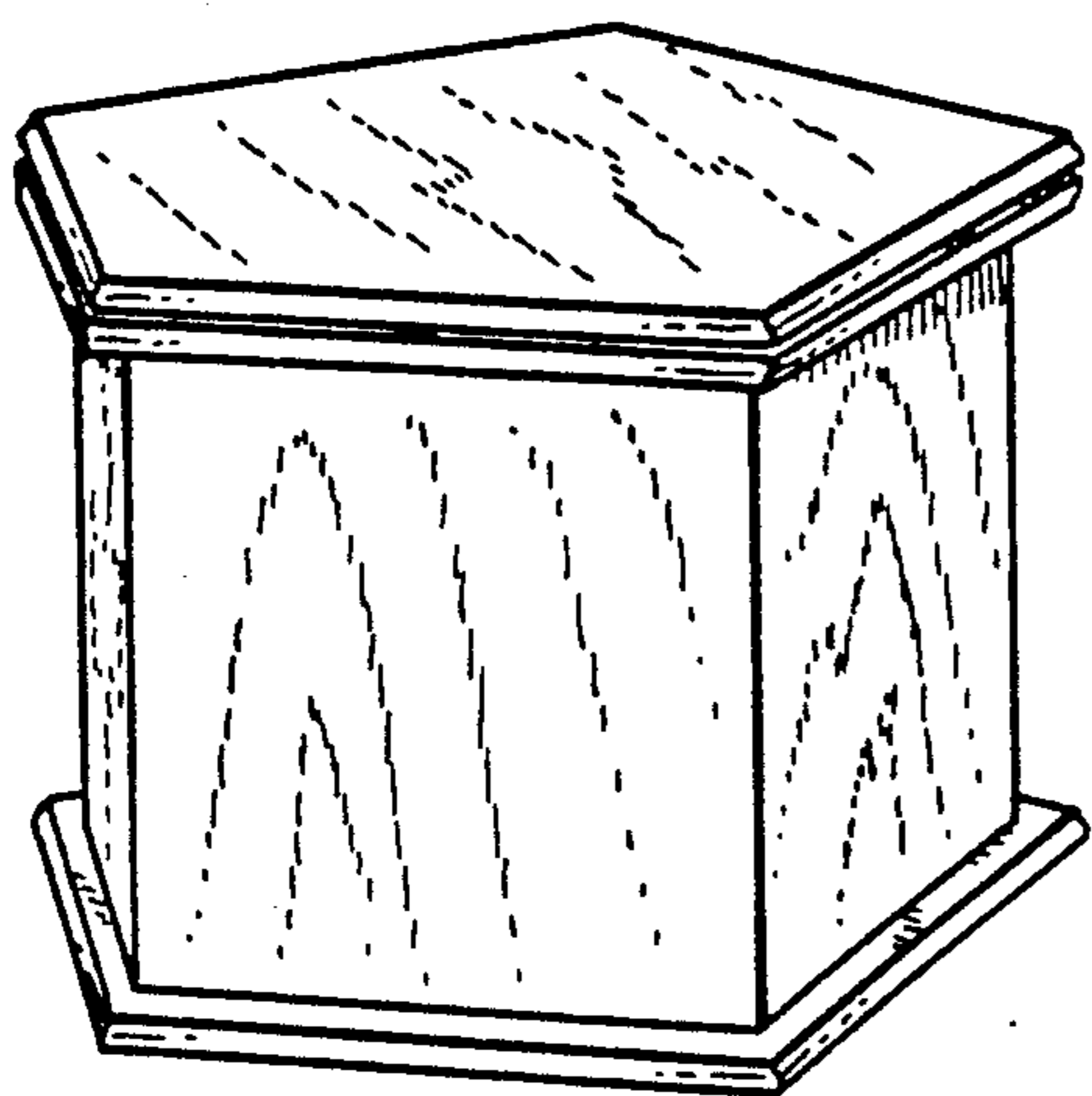

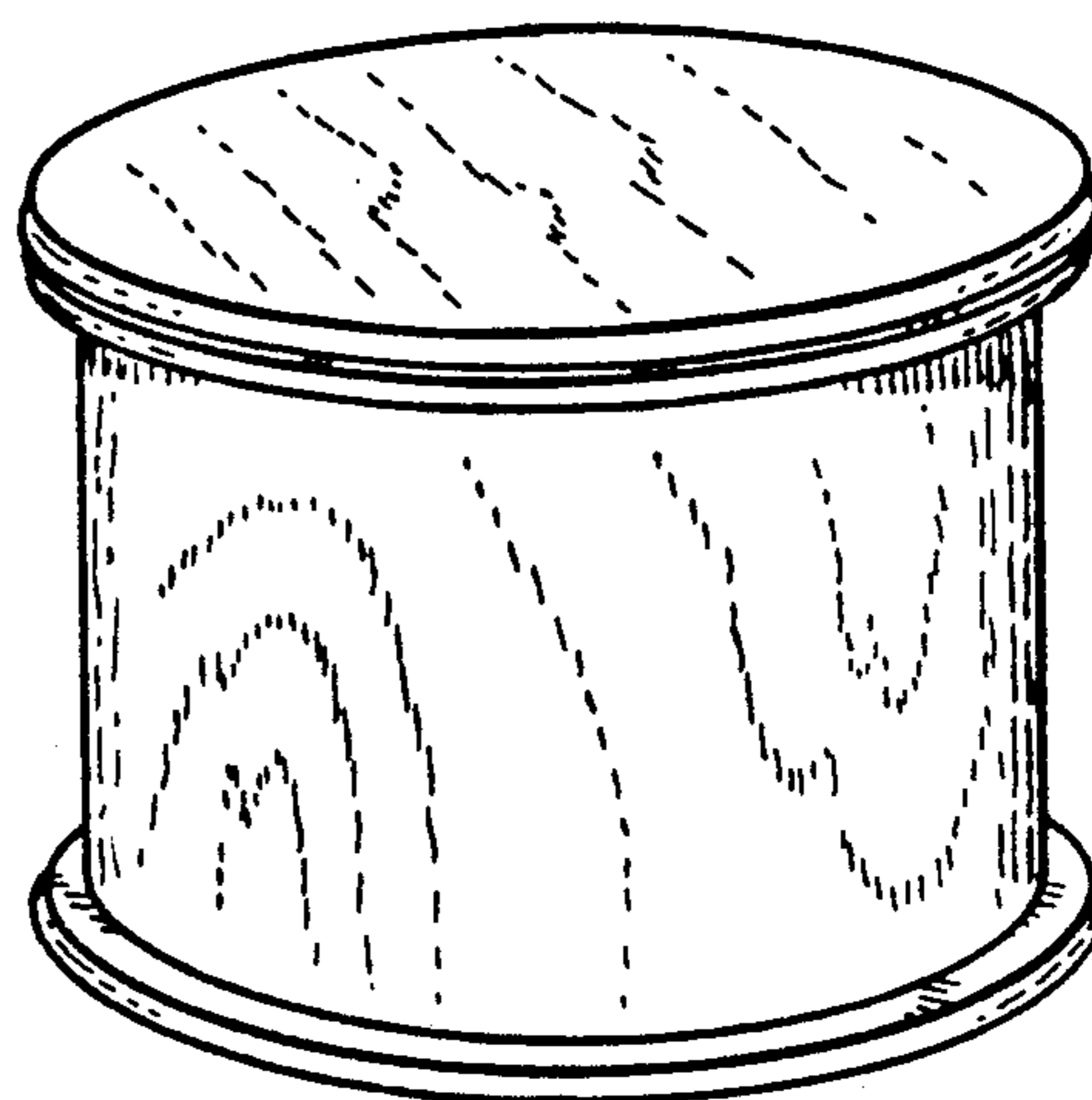

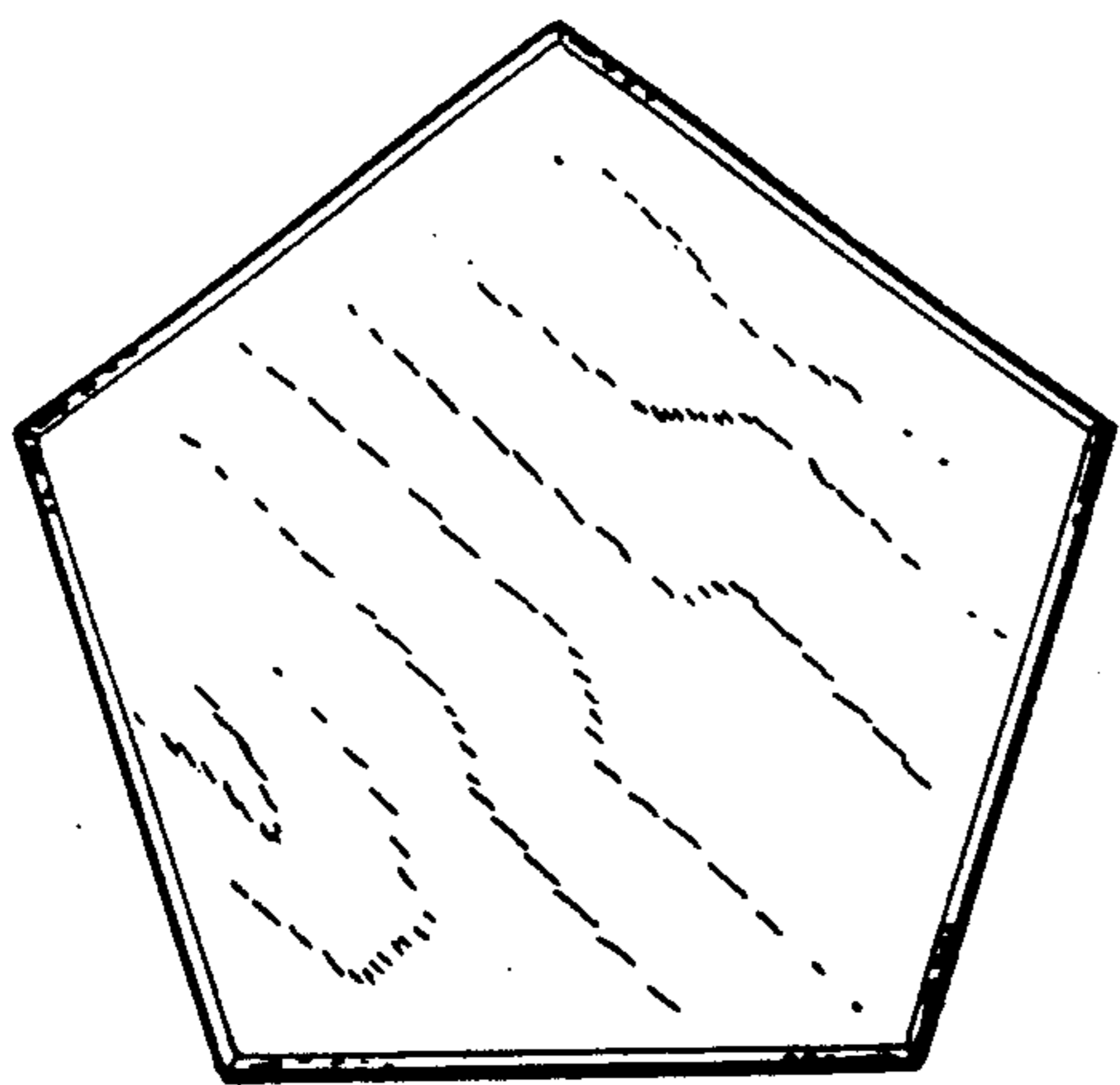

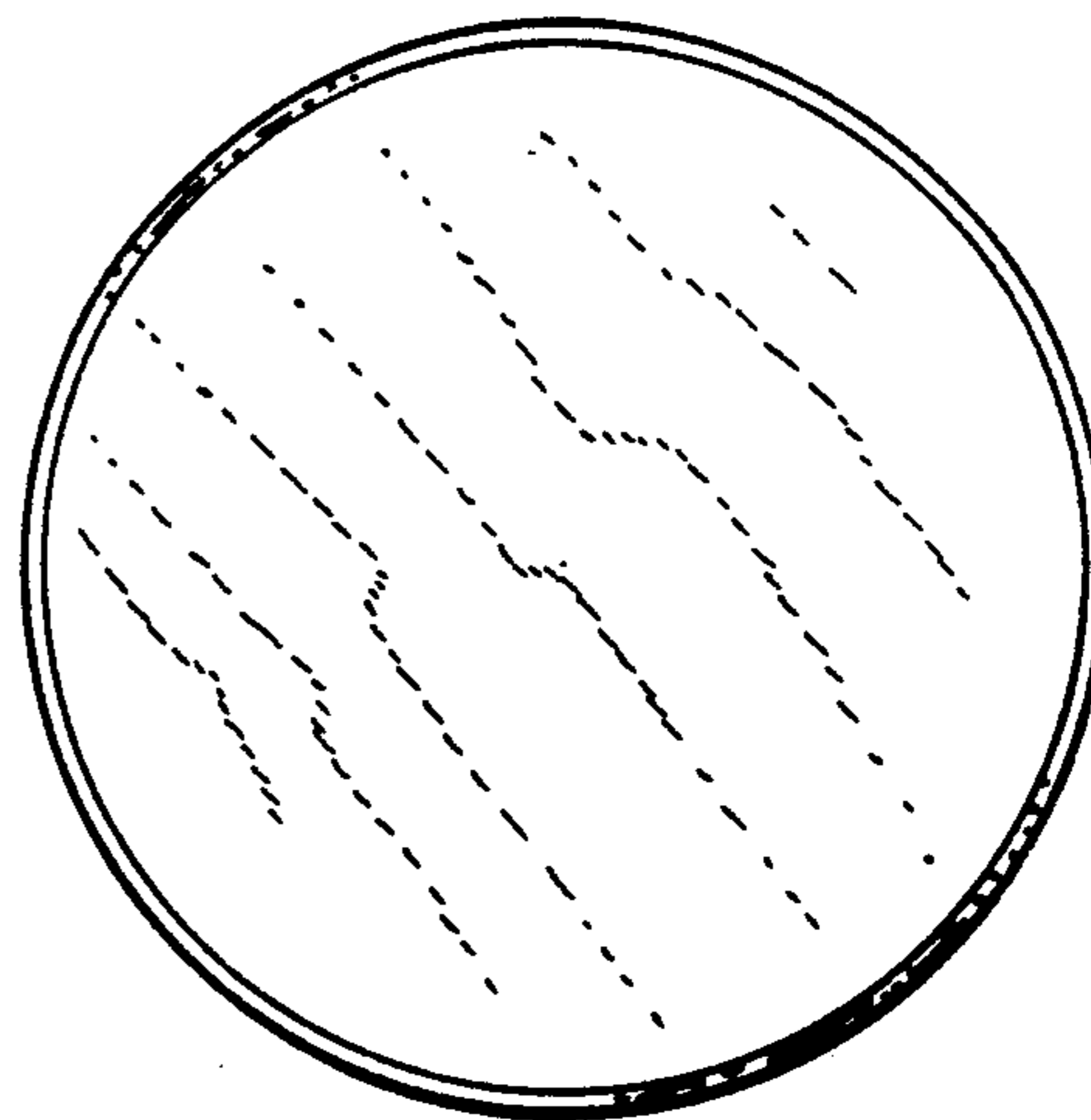

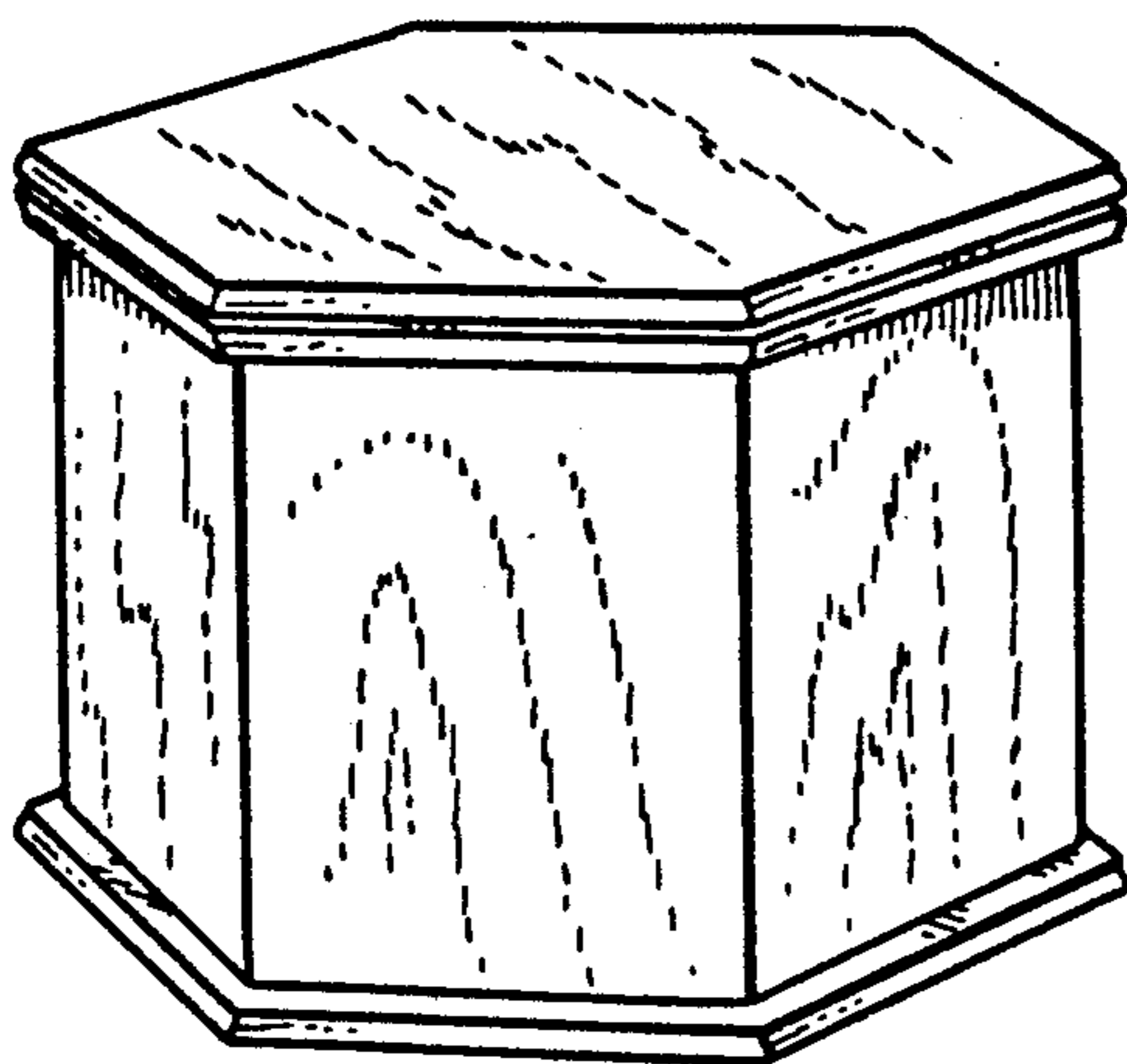

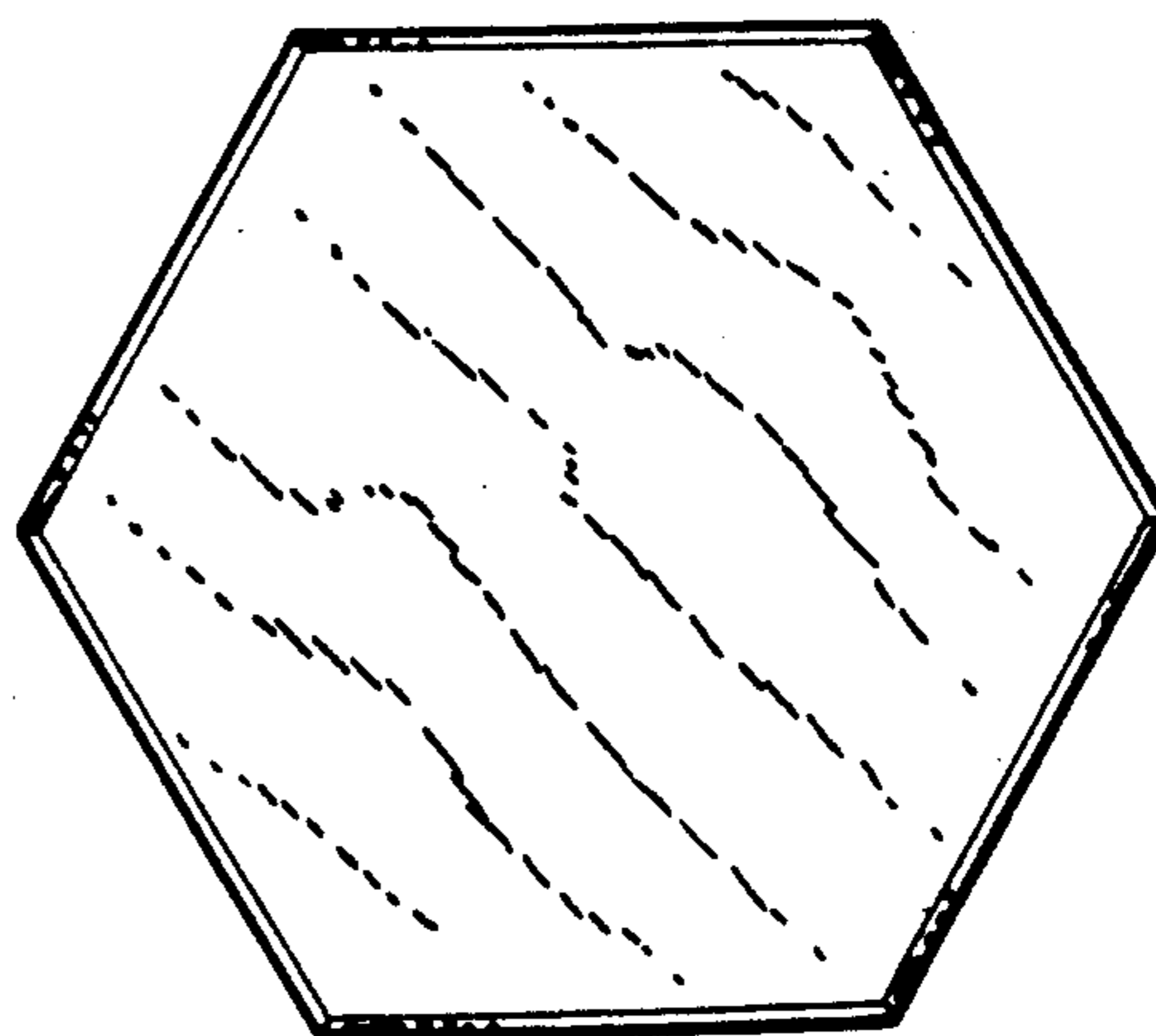
