DESCRIPTION

FIG. 8 is a perspective view thereof on a slightly reduced scale.

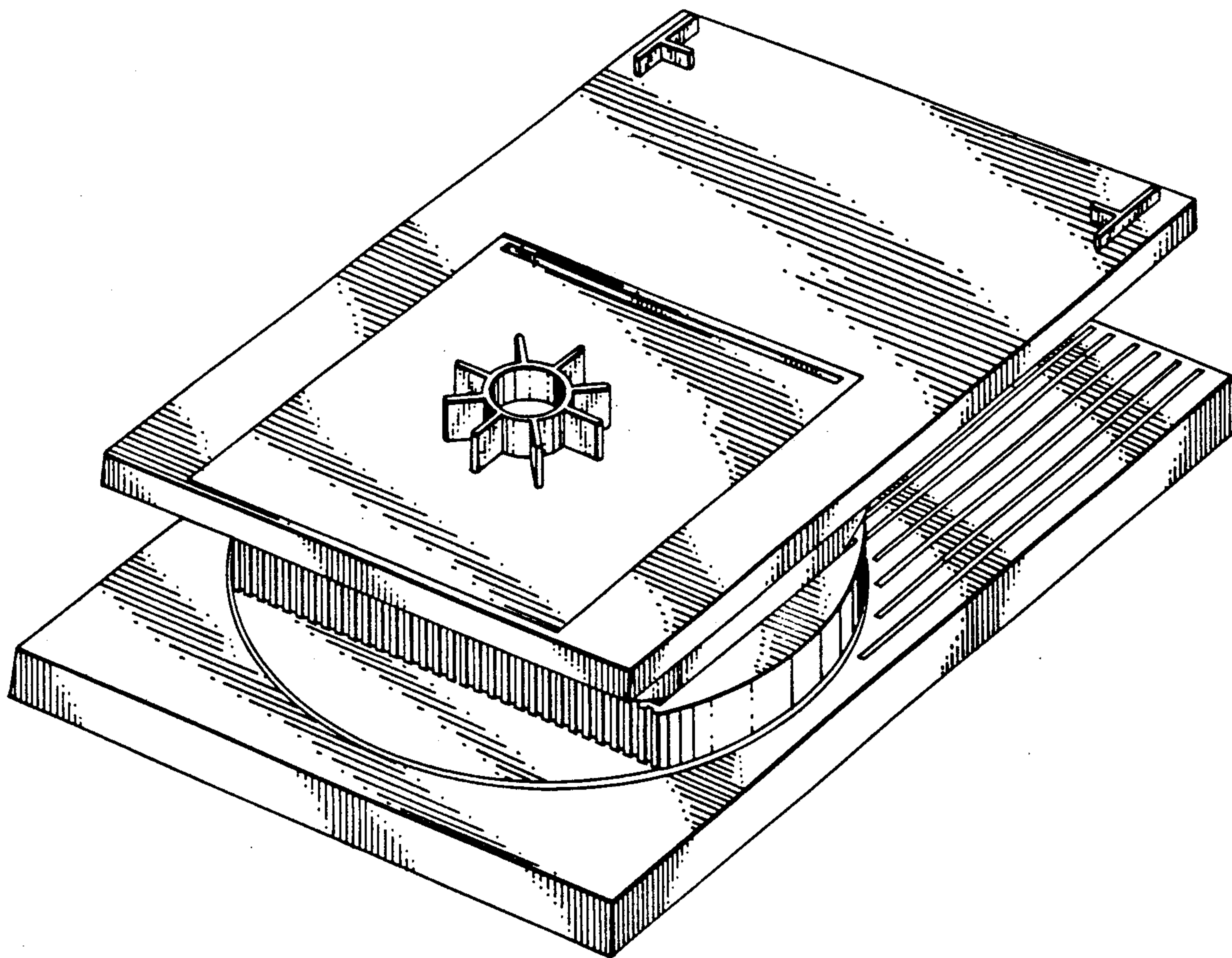

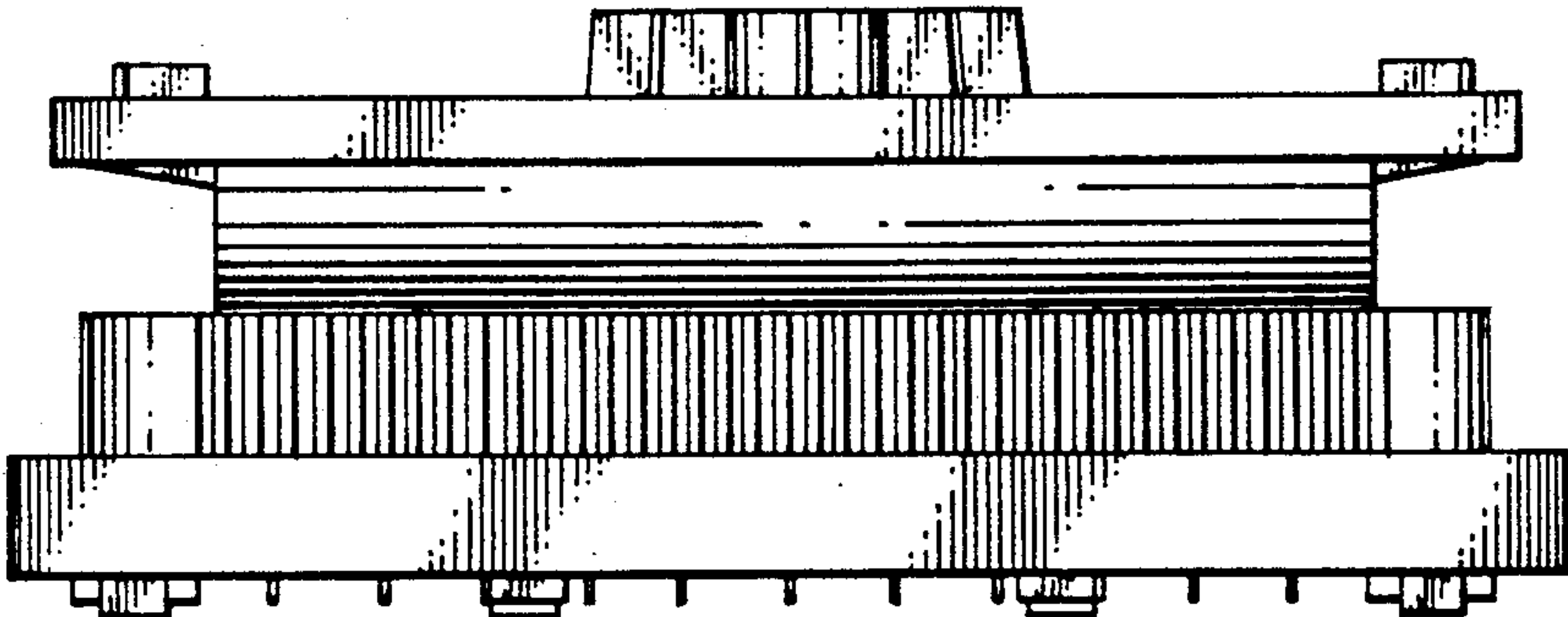

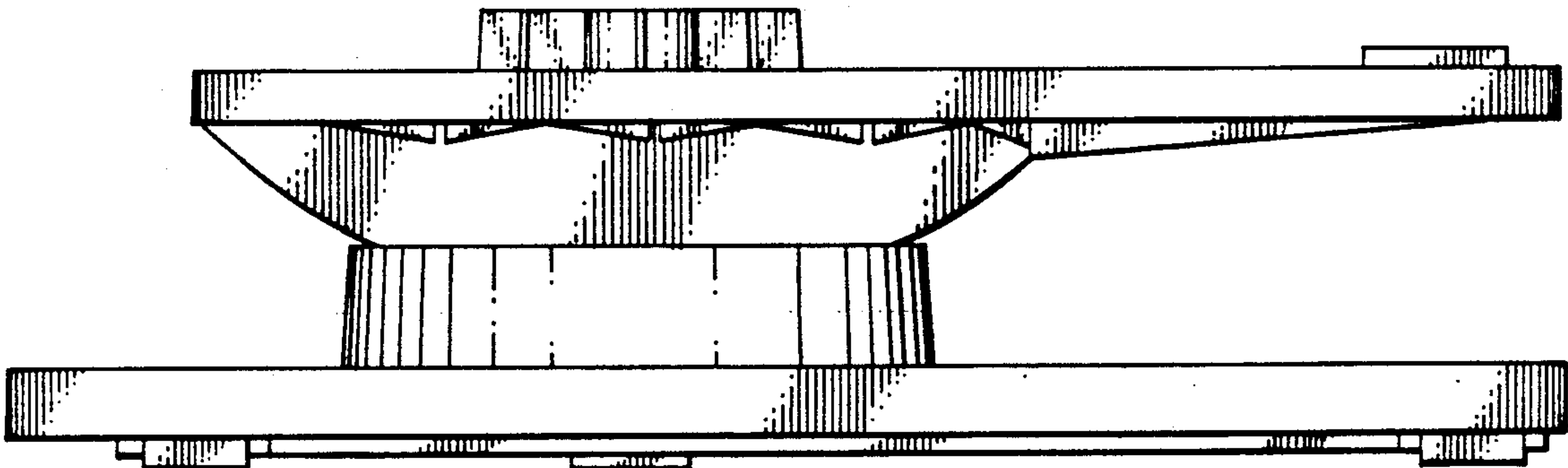

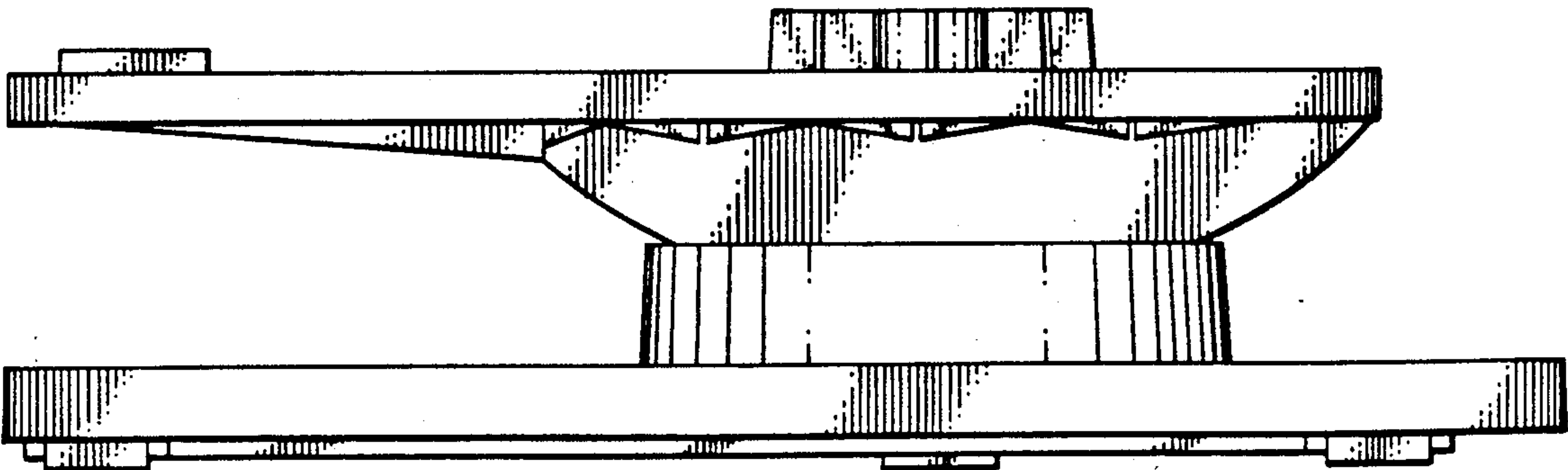

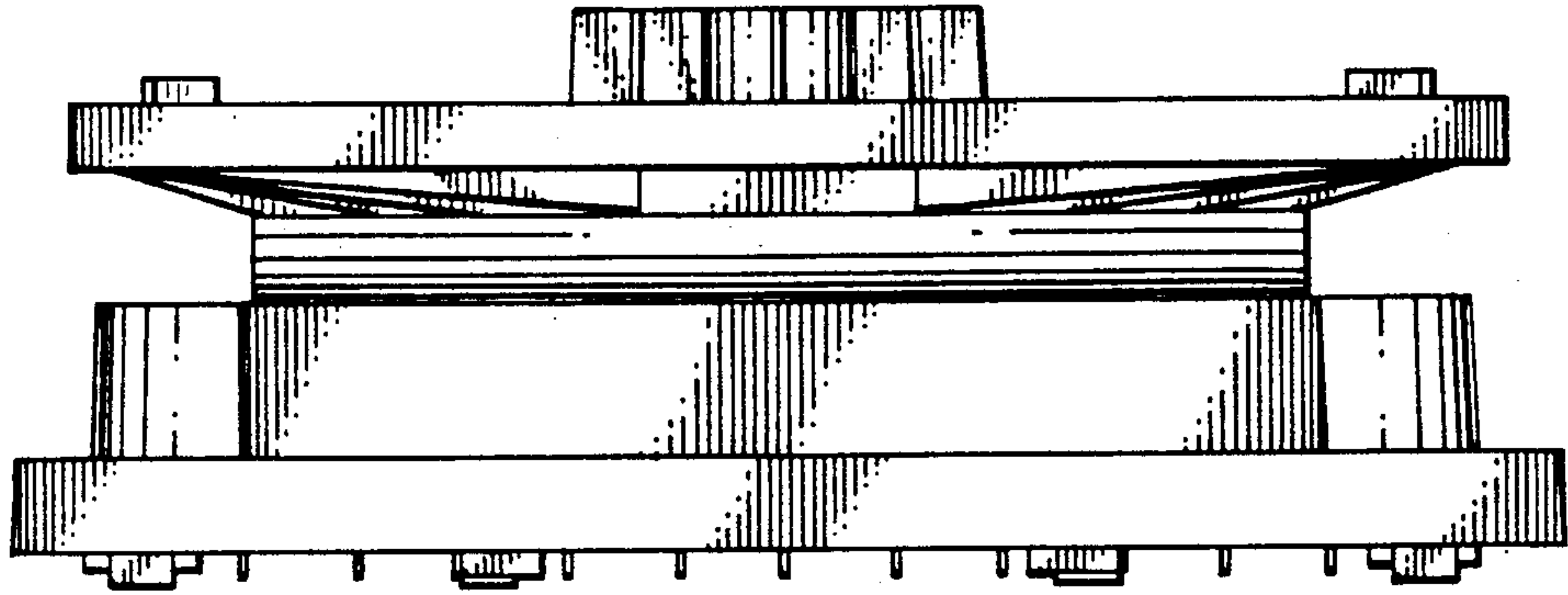

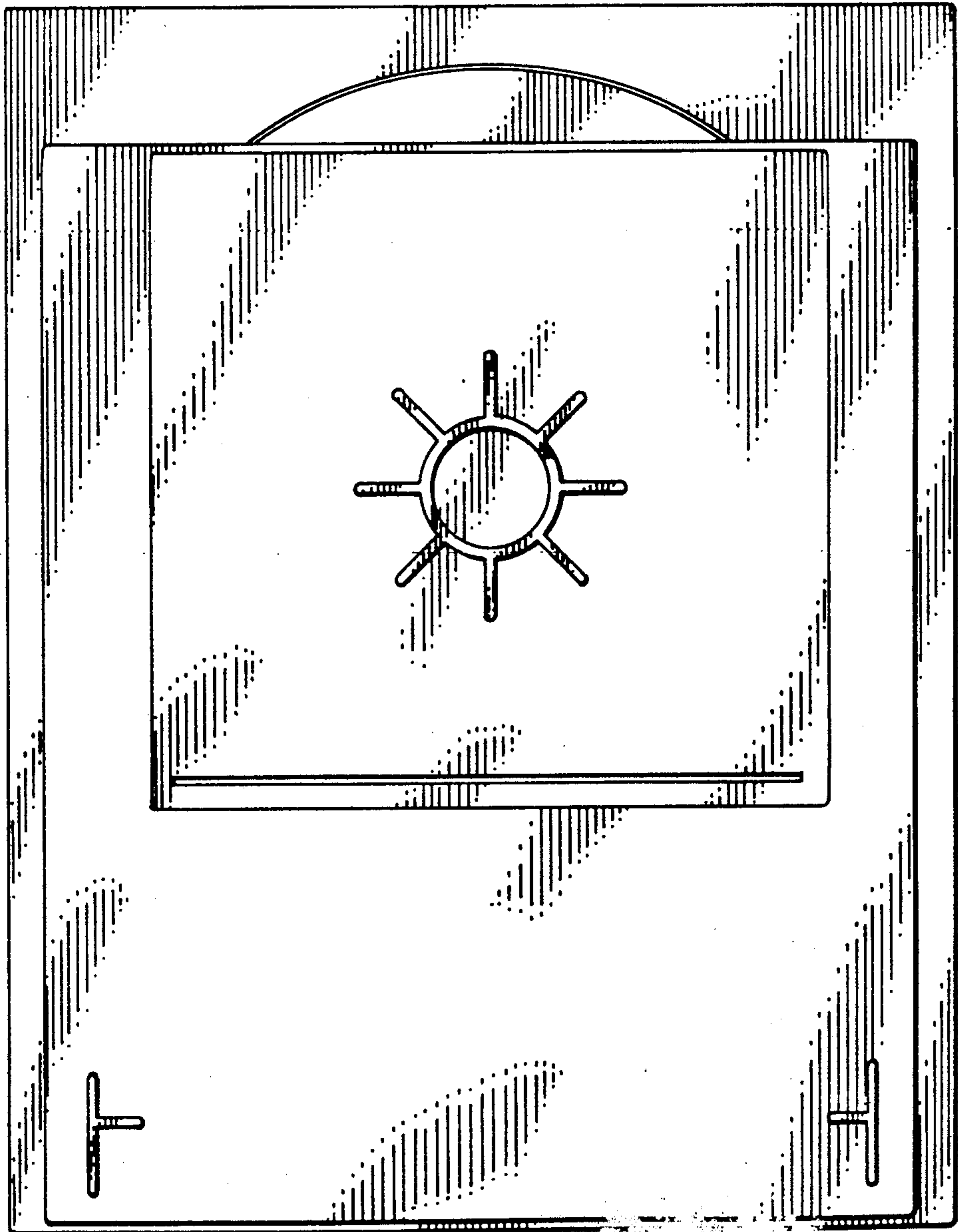

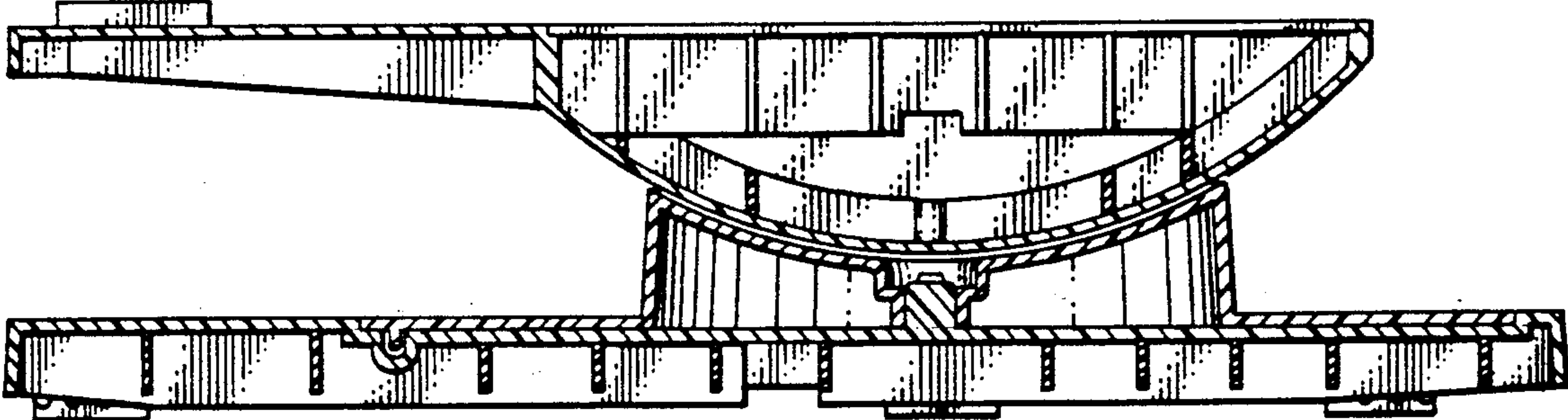

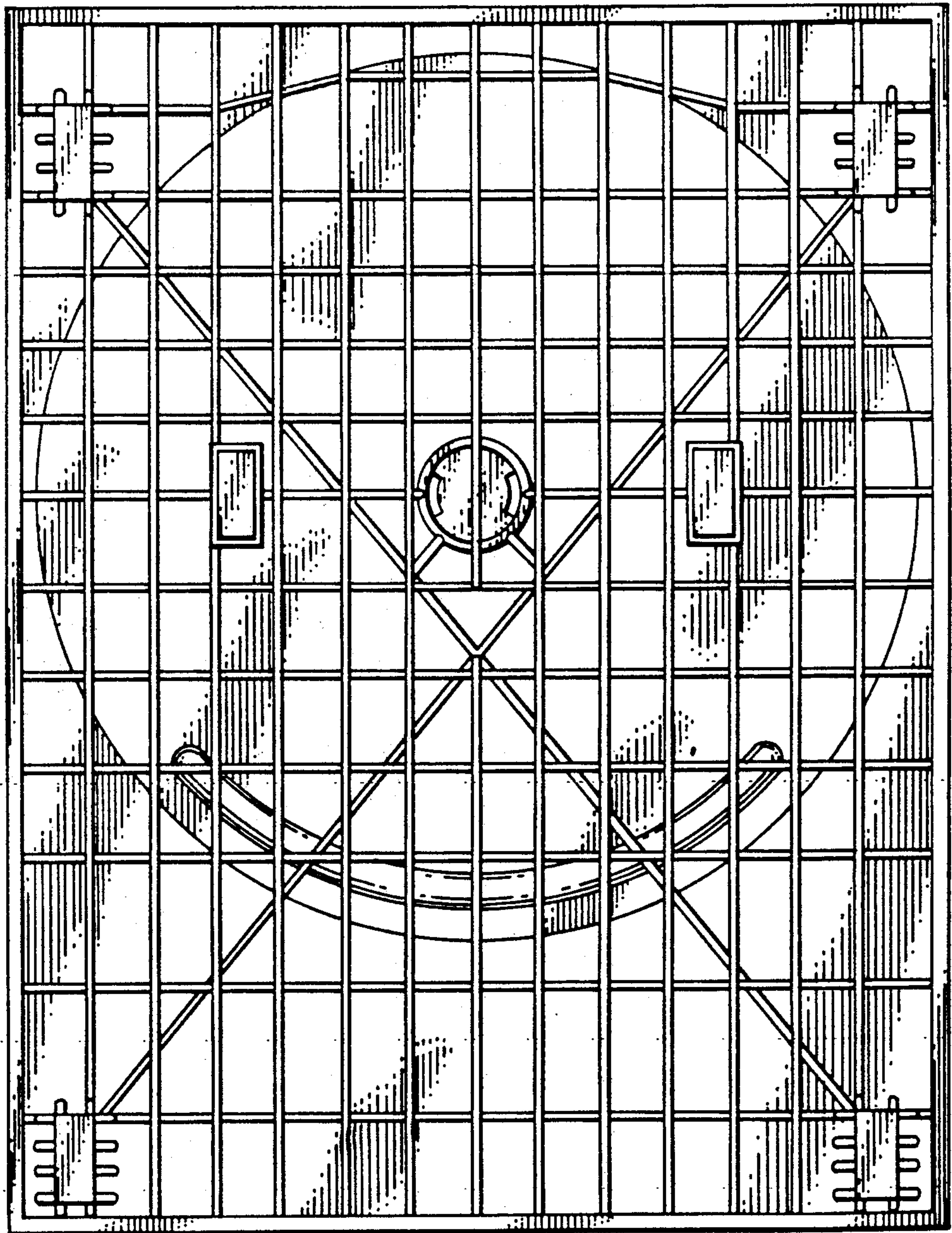
