The ornamental design for an aquarium, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an aquarium showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a right side elevational view thereof, the left side being a mirror image of the right side shown;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is bottom plan view thereof;
 FIG. 6 is another top plan view thereof, showing the cover in open position;
 FIG. 7 is a right side elevational view of FIG. 6;
 FIG. 8 is a front elevational view of a second embodiment of FIG. 1;
 FIG. 9 is a rear elevational view of FIG. 8;
 FIG. 10 is a bottom plan view of FIG. 8; and
 FIG. 11 is a right side elevational view of FIG. 8, the left side being a mirror image of the right side shown.

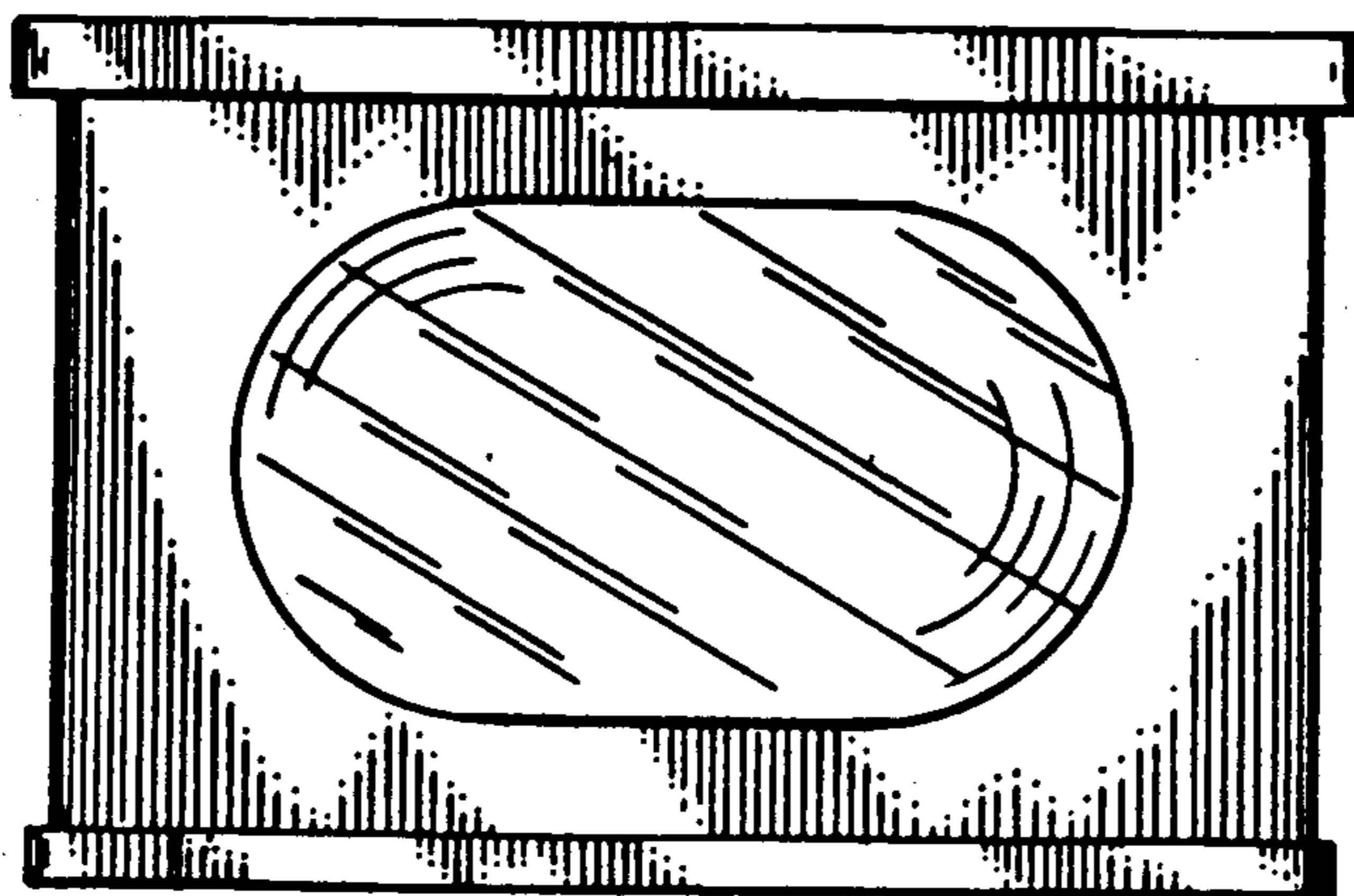
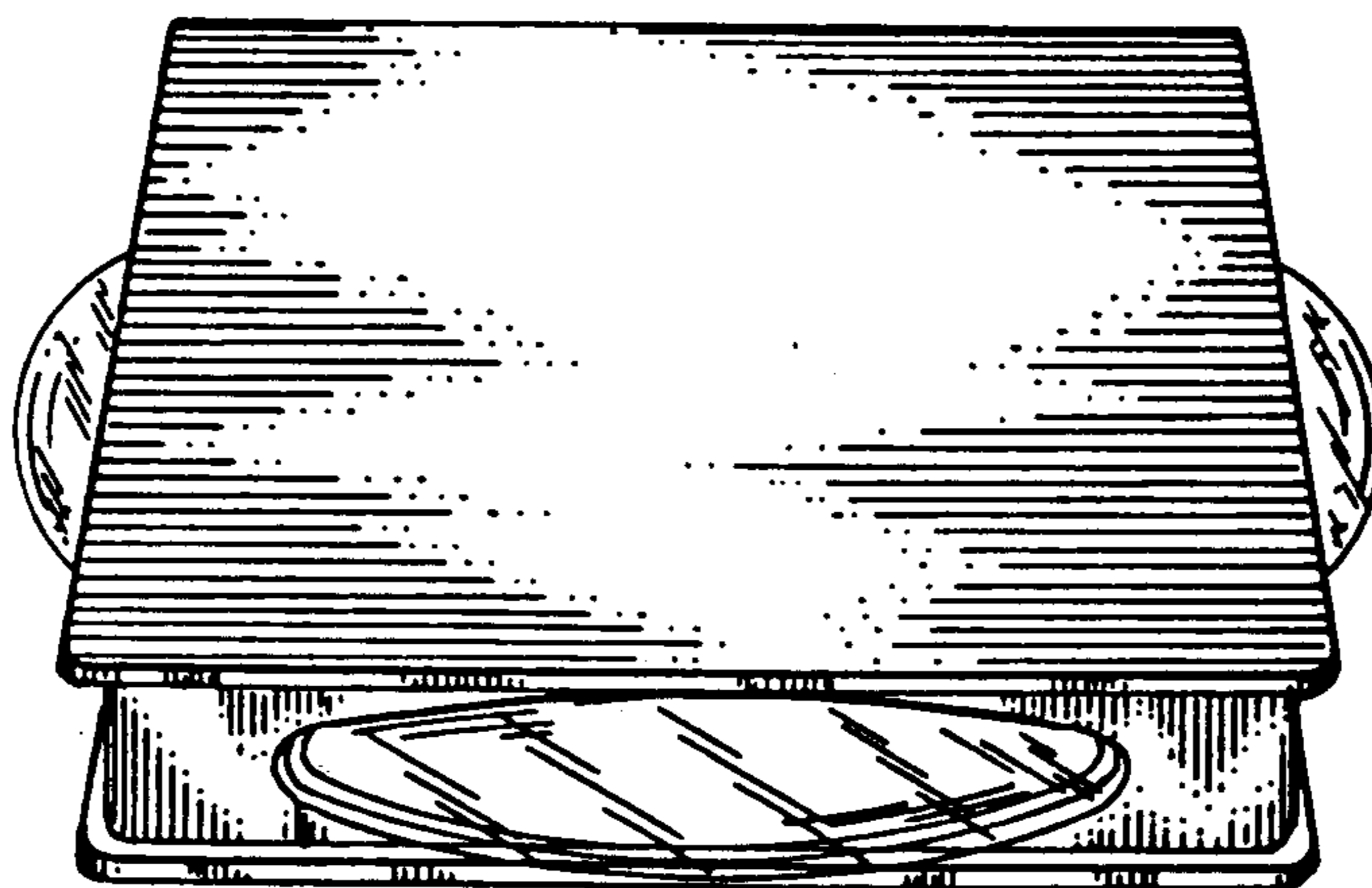

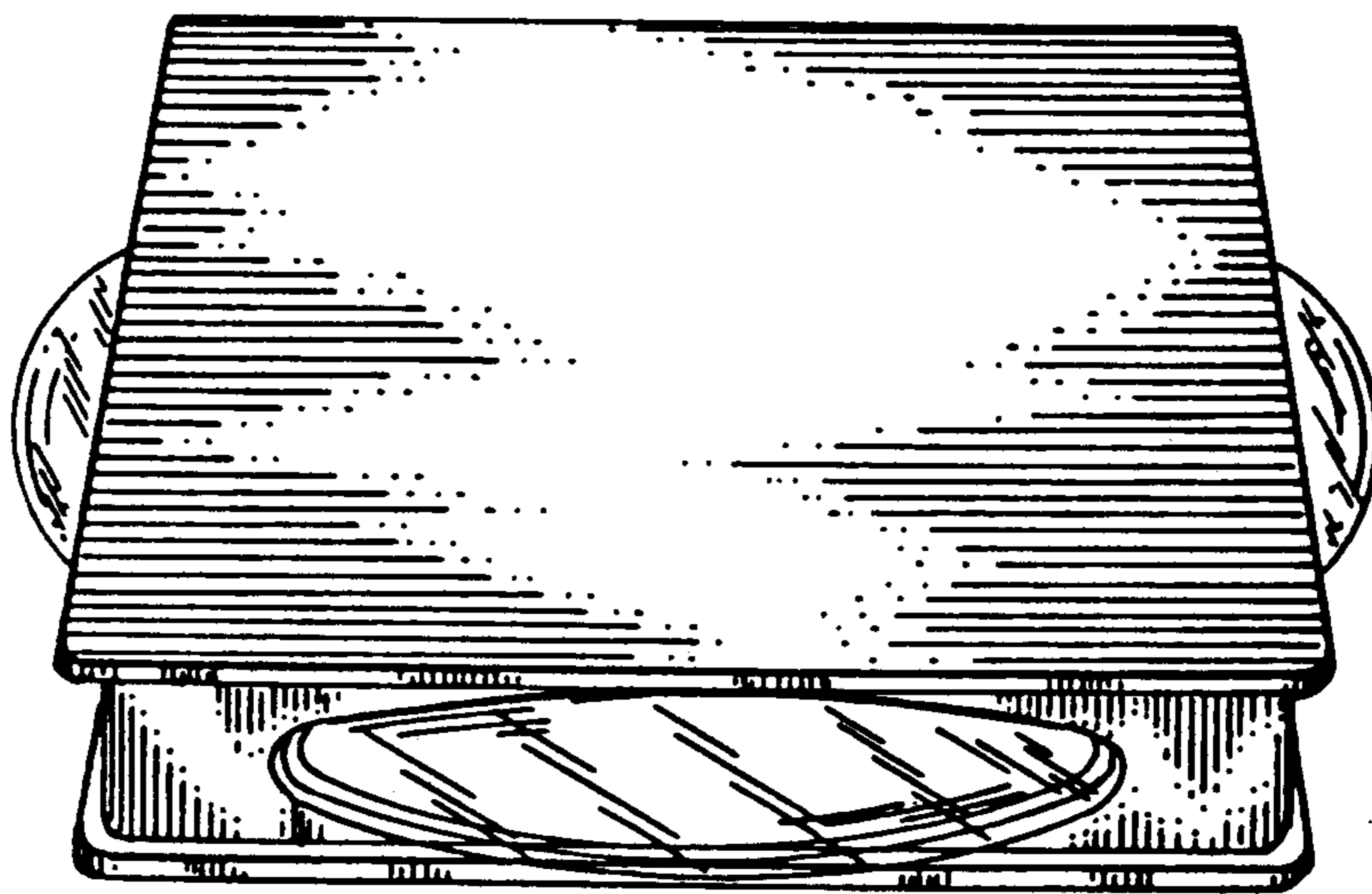
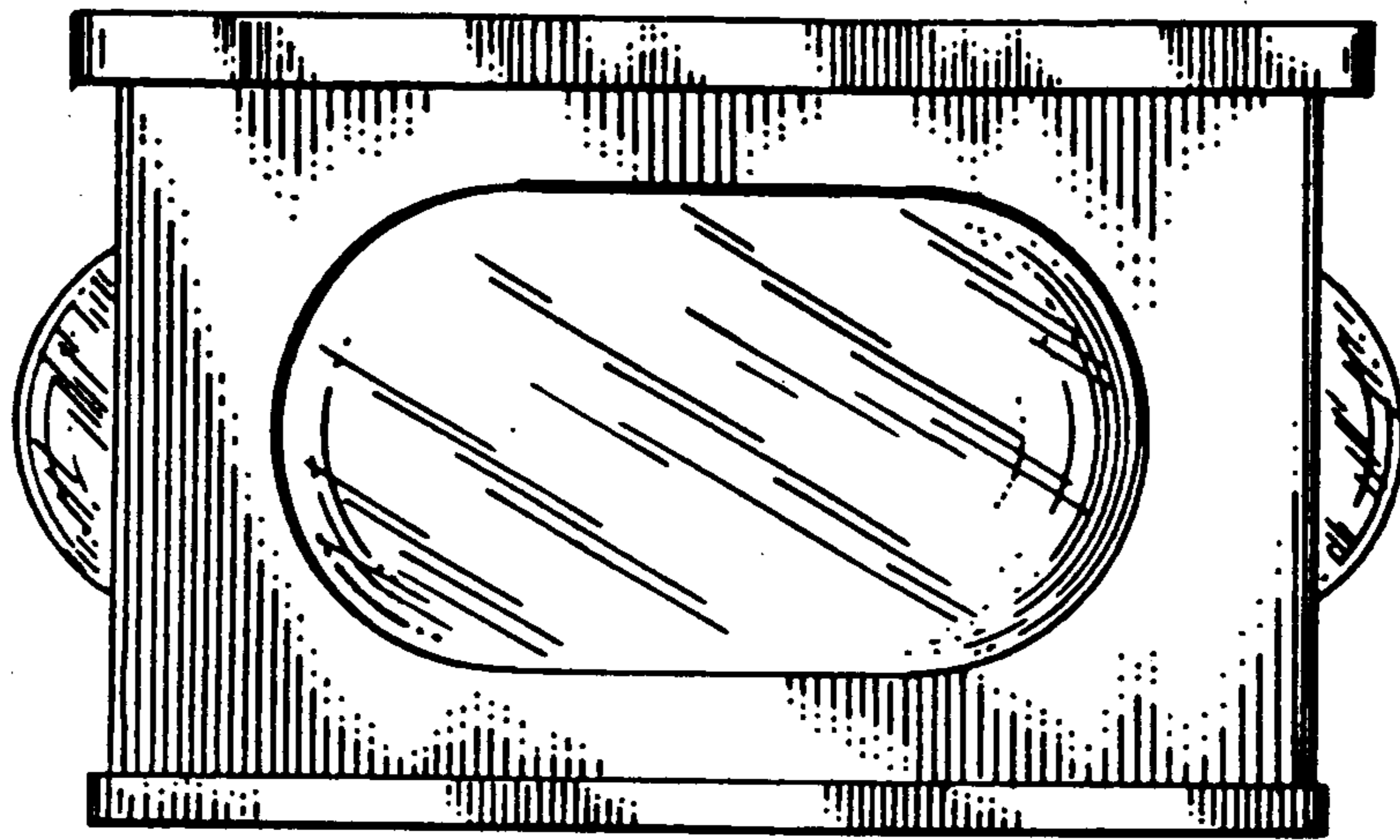
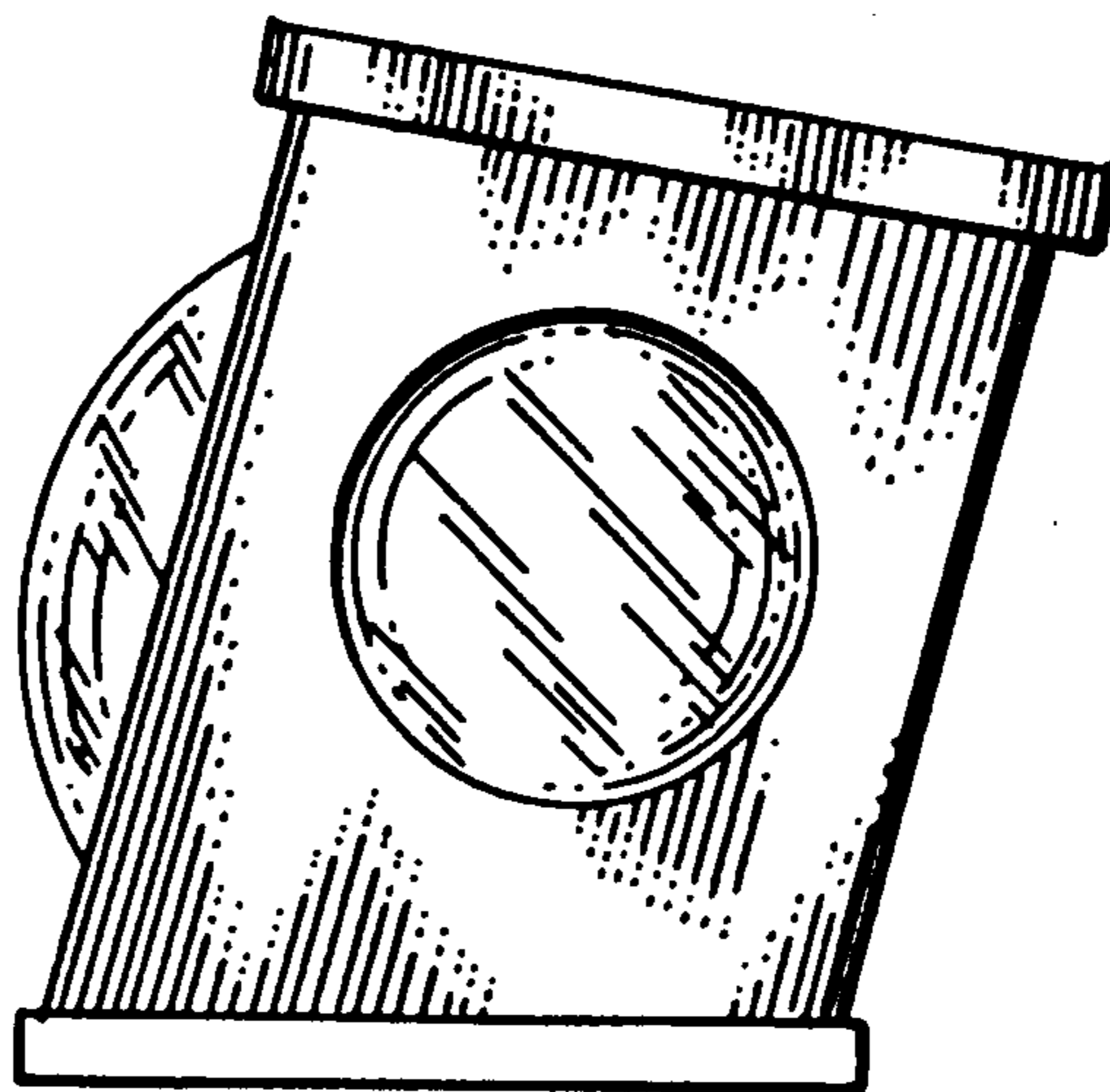

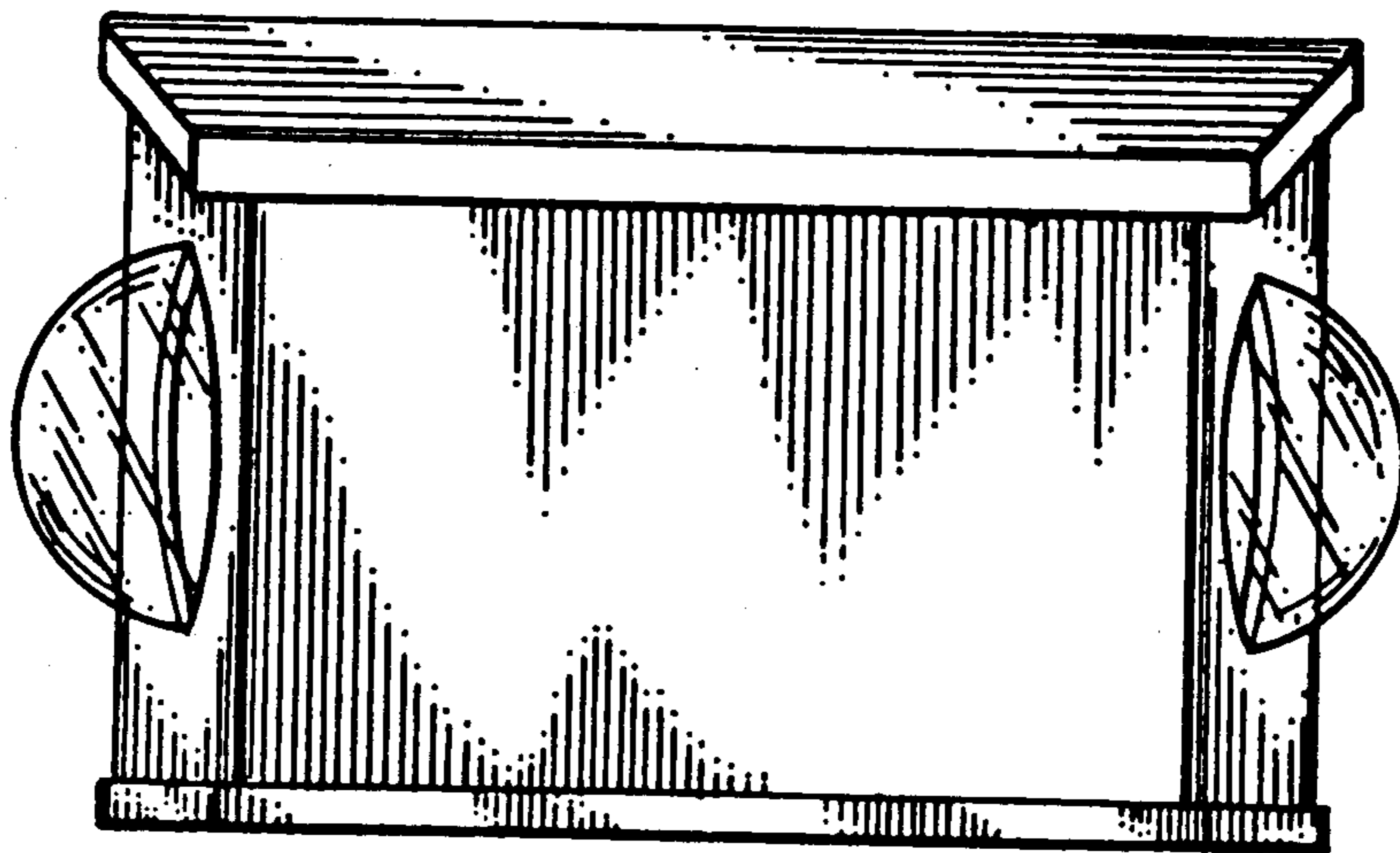

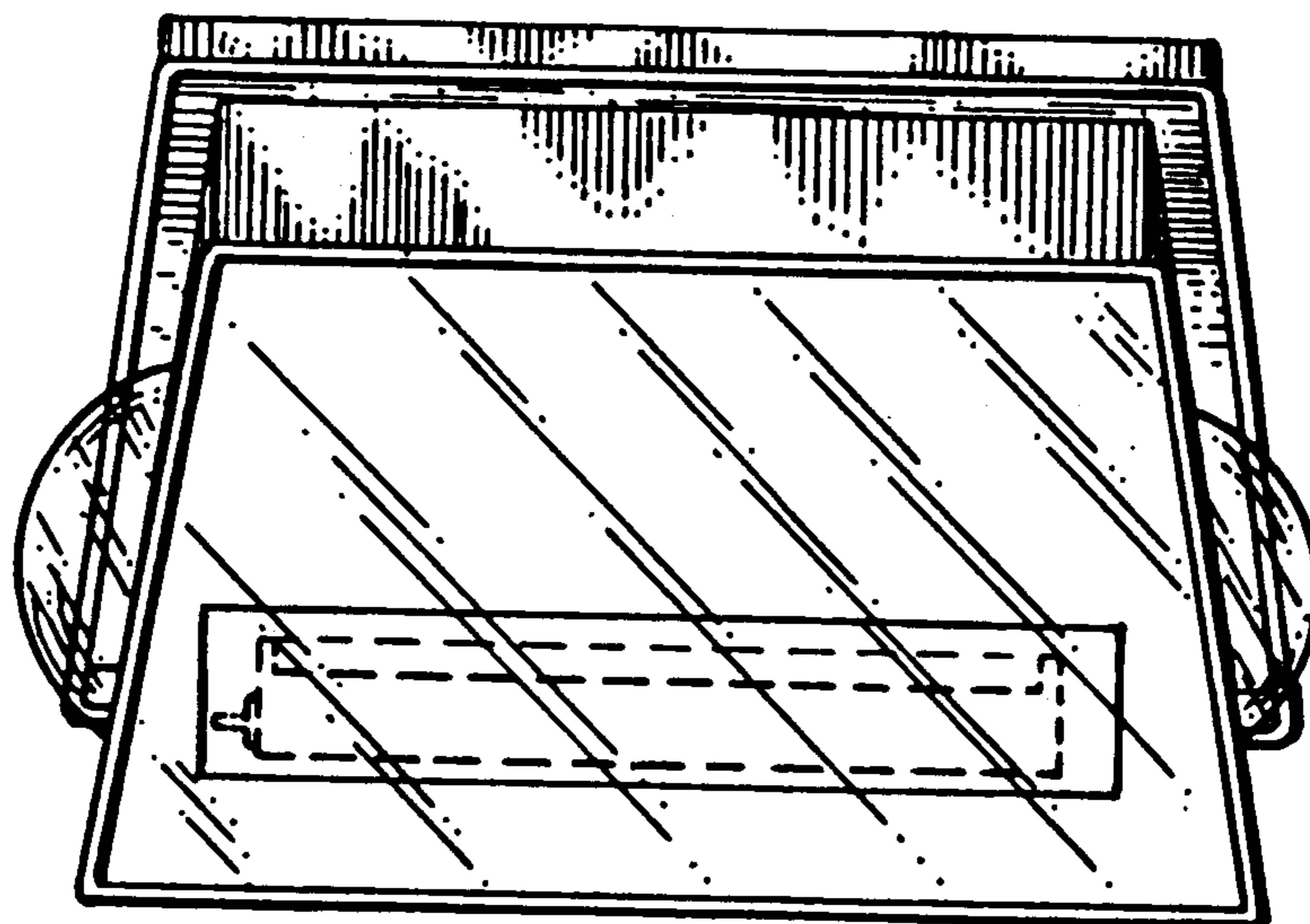

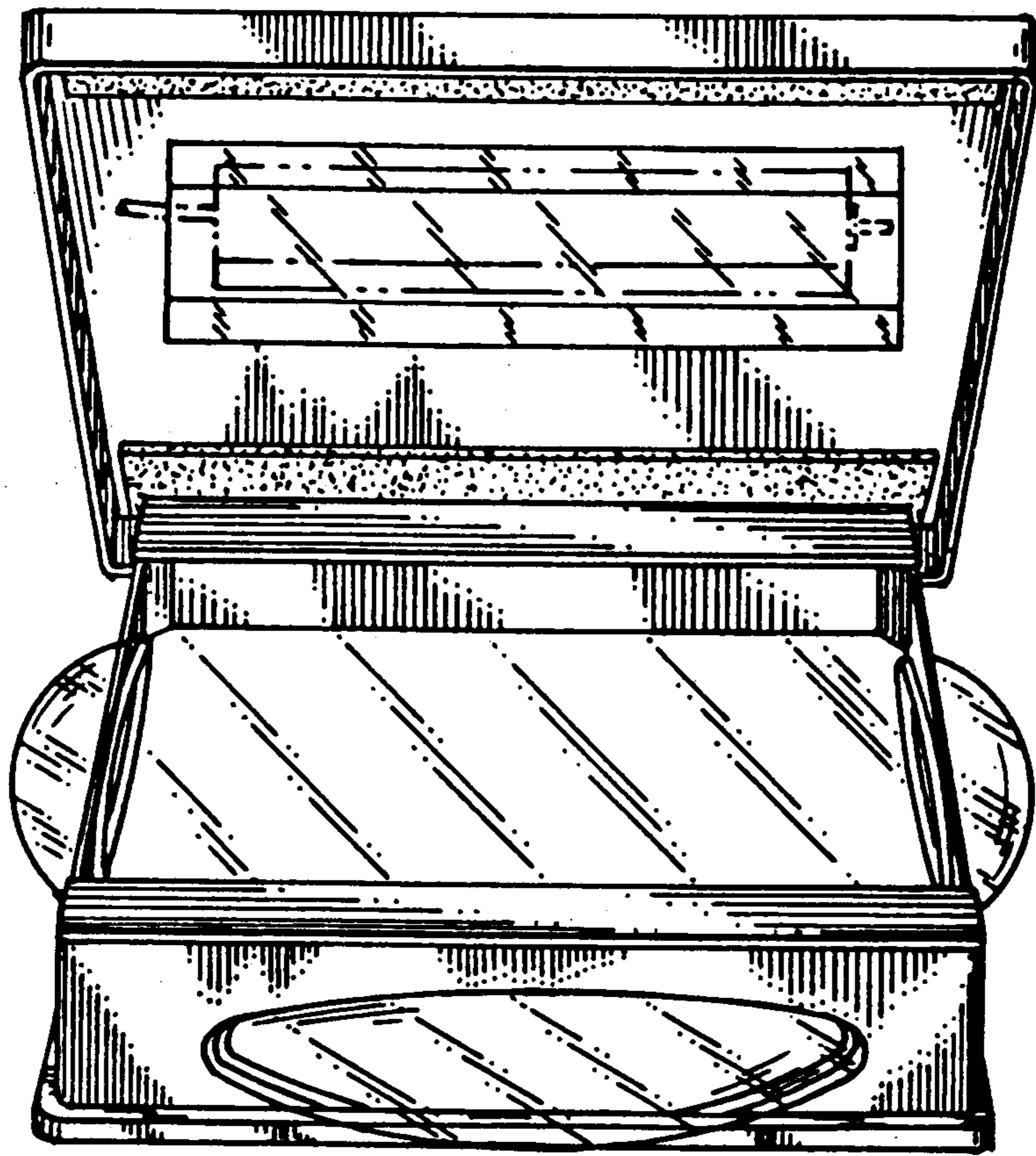

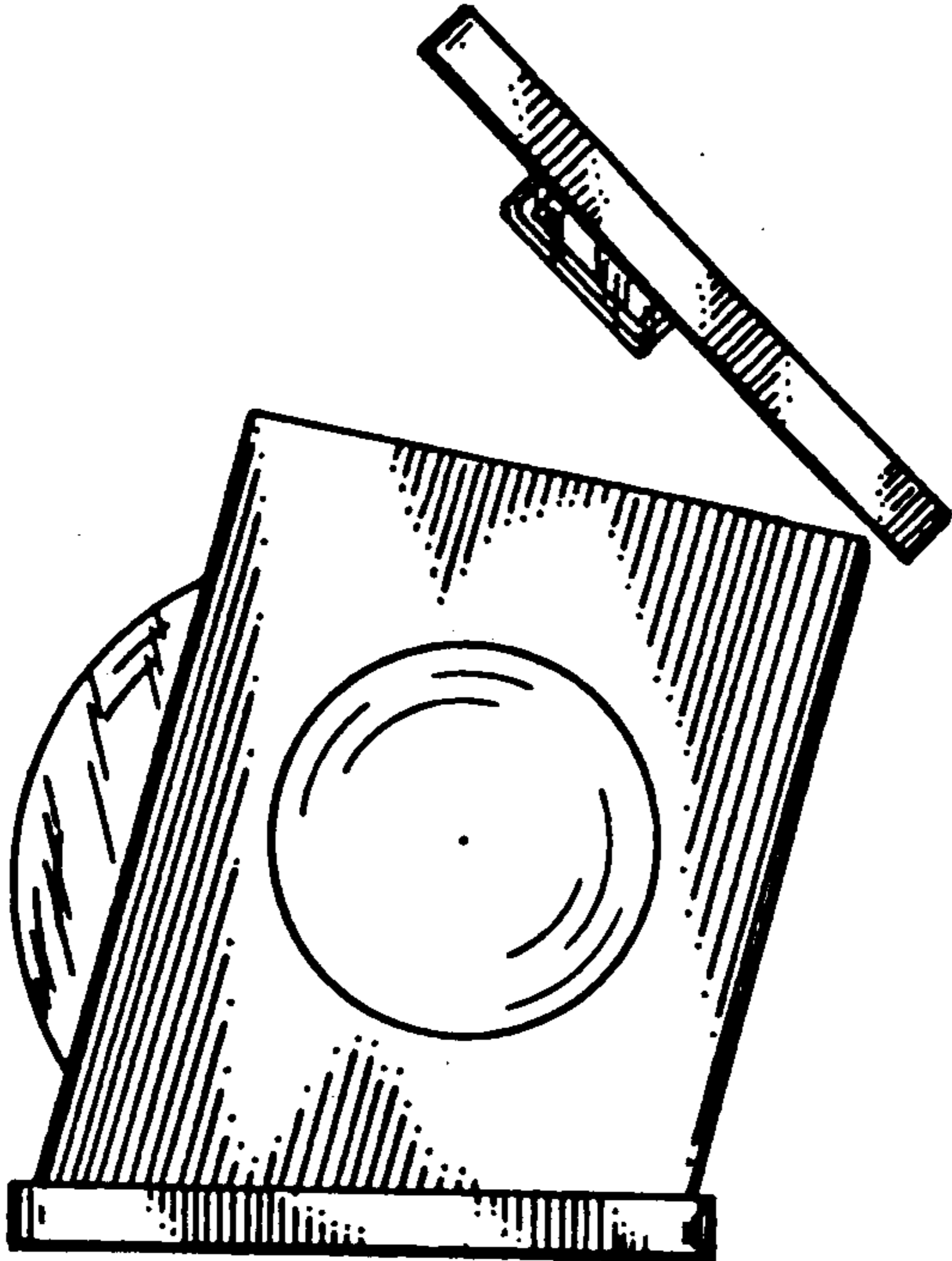

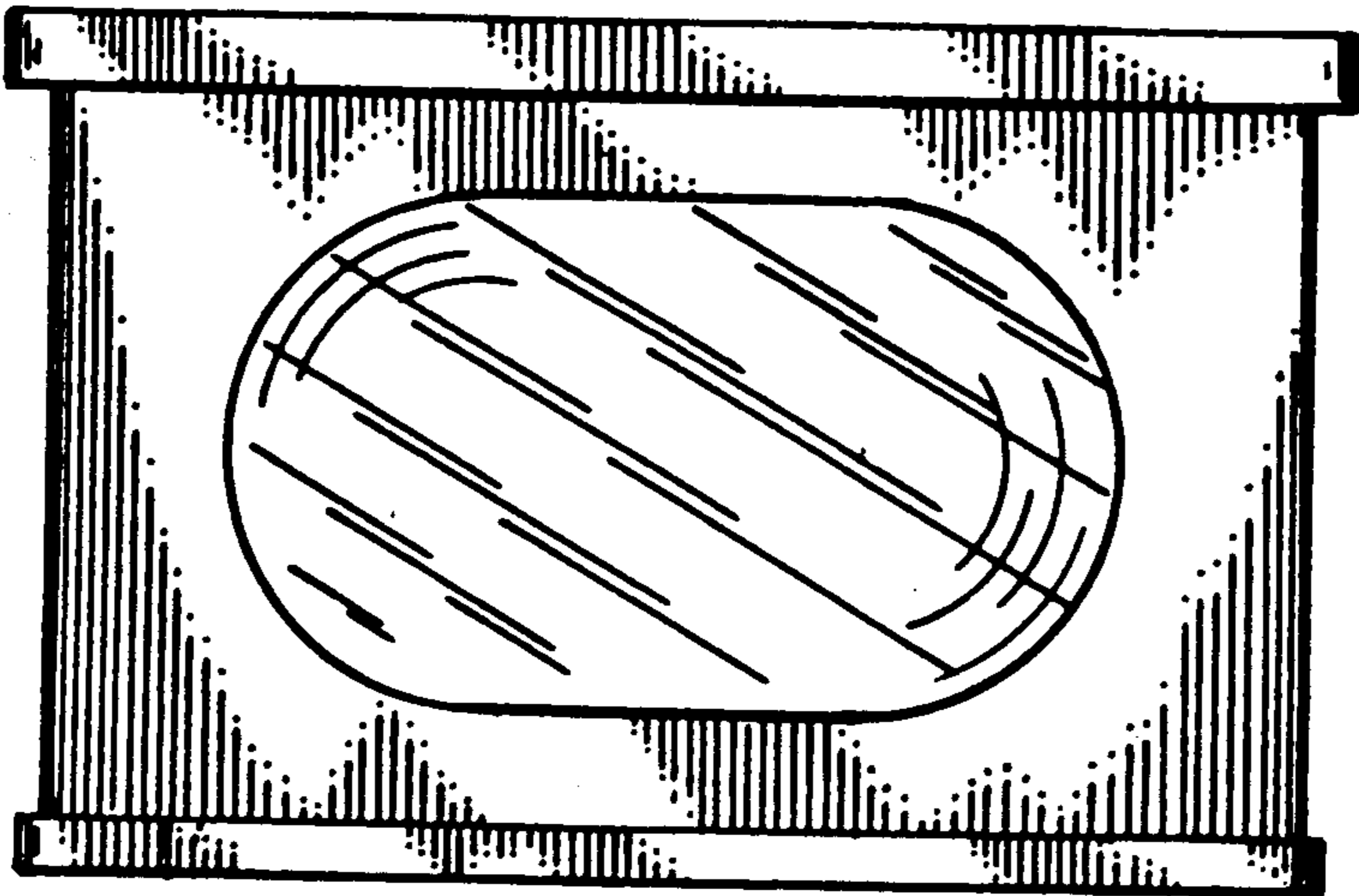

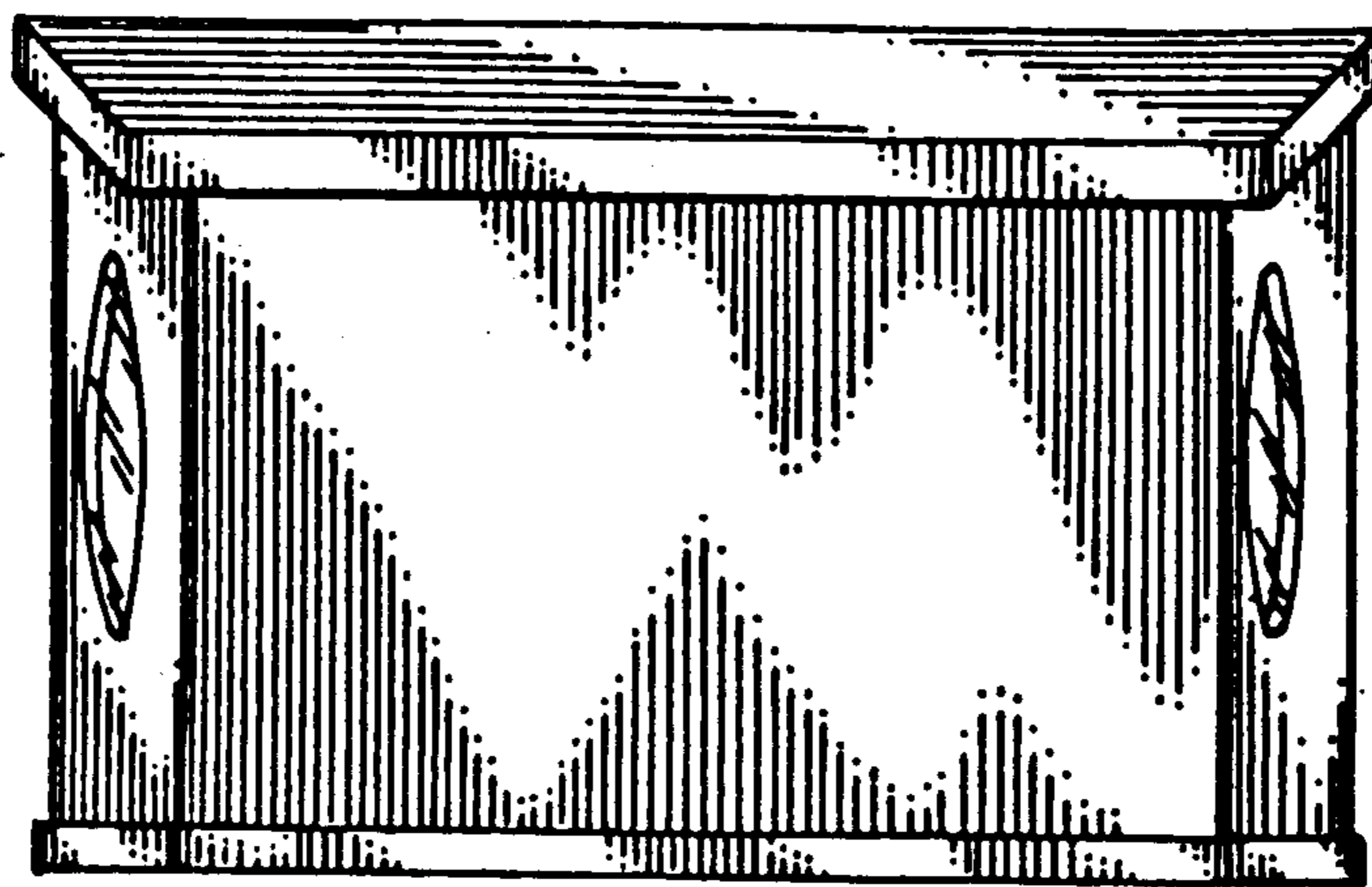

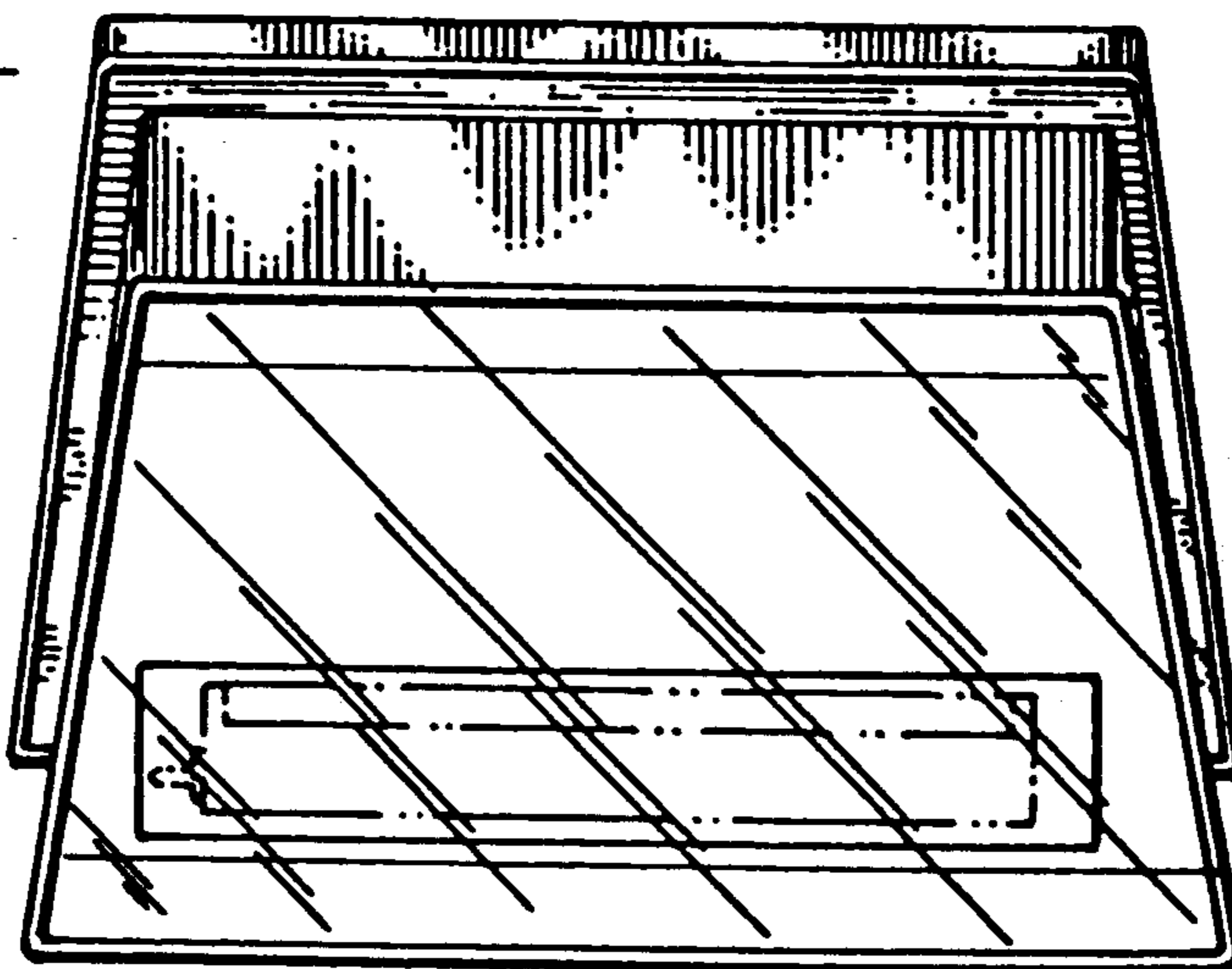

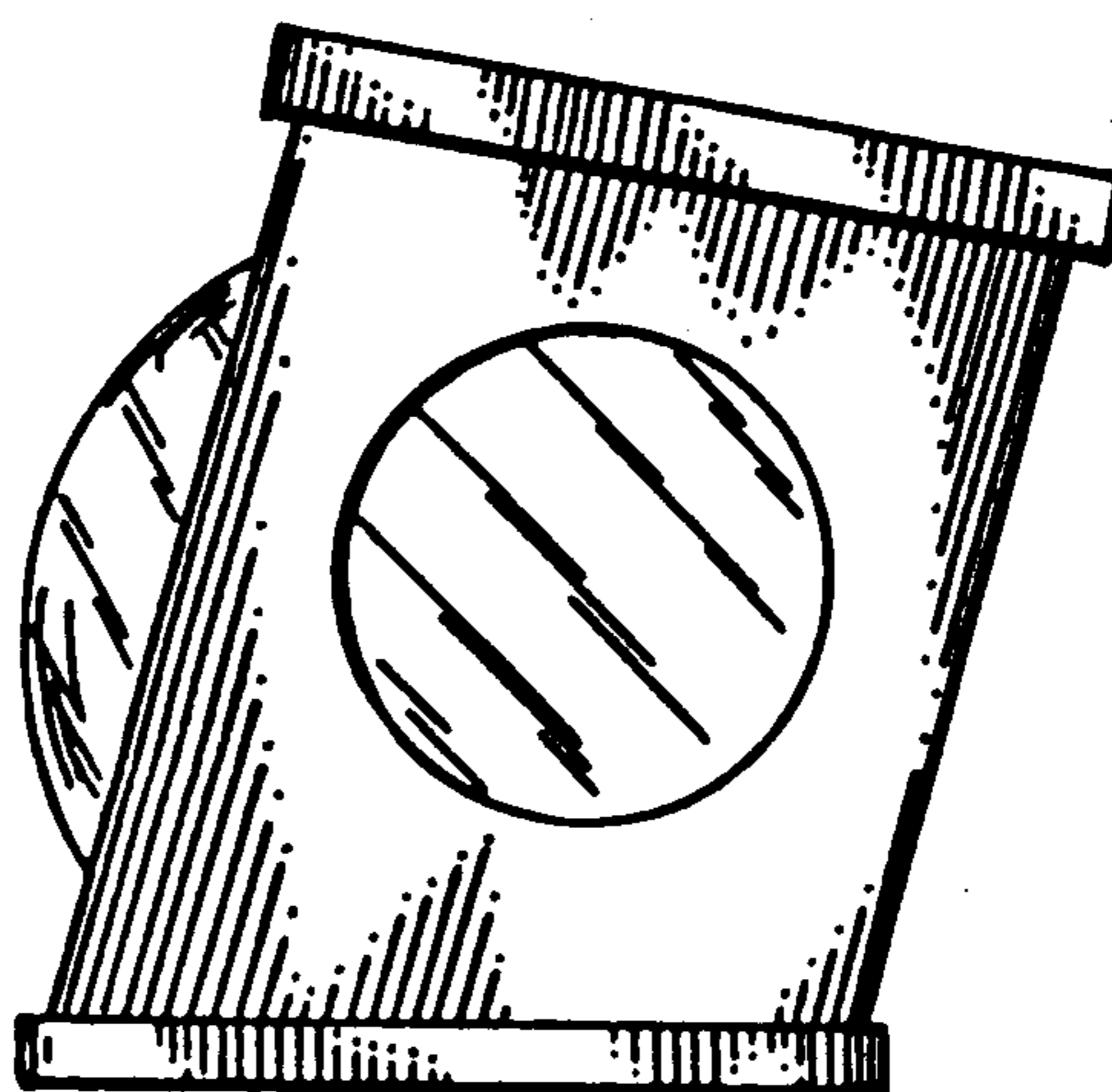
