The ornamental design for a type font, substantially as shown and described.

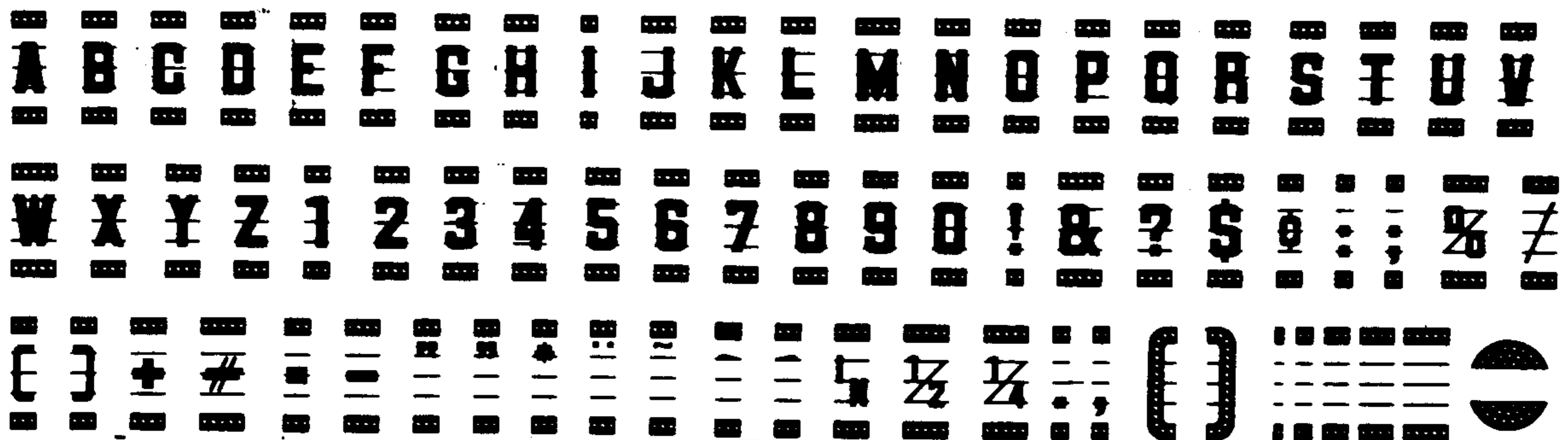
DESCRIPTION

FIG. 4 is a face view of a fourth embodiment thereof.



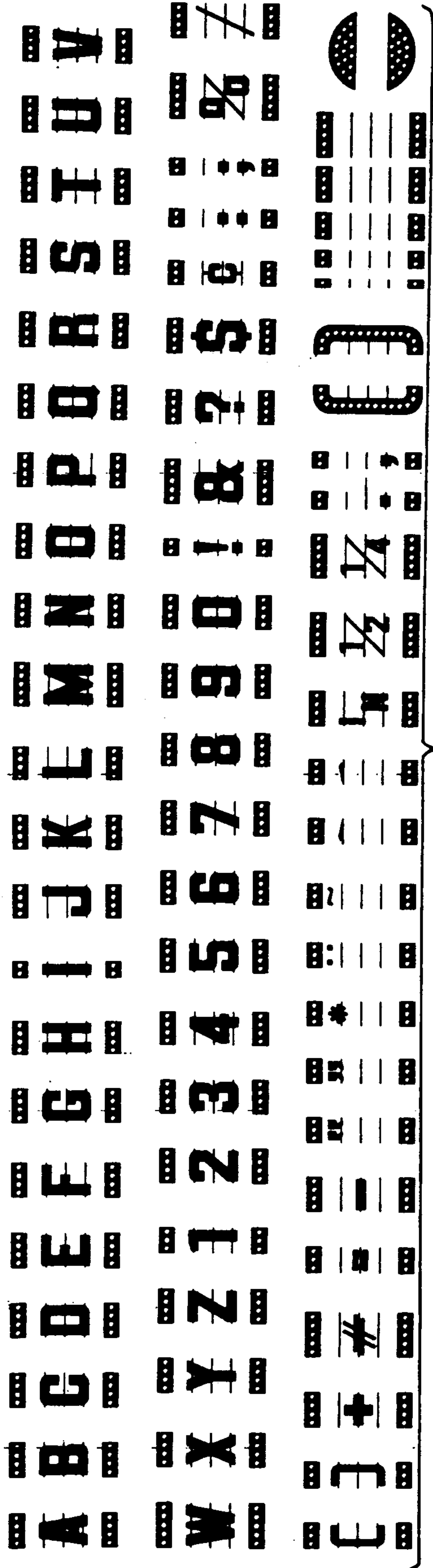

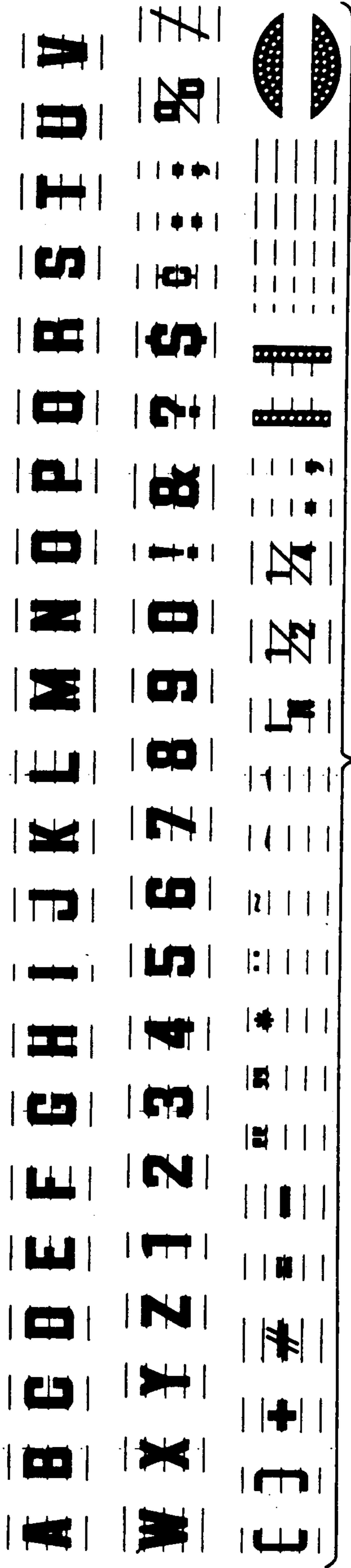

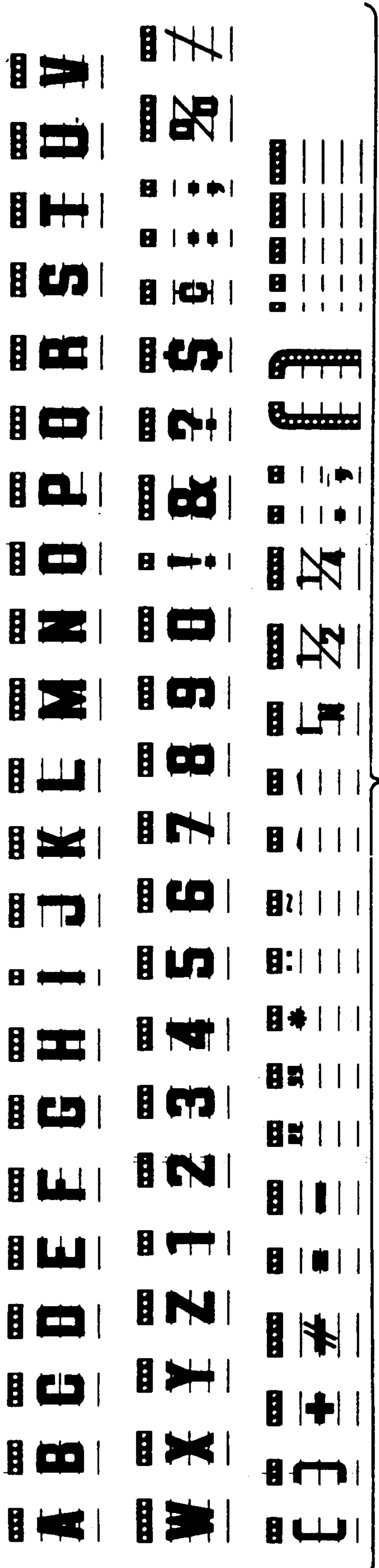

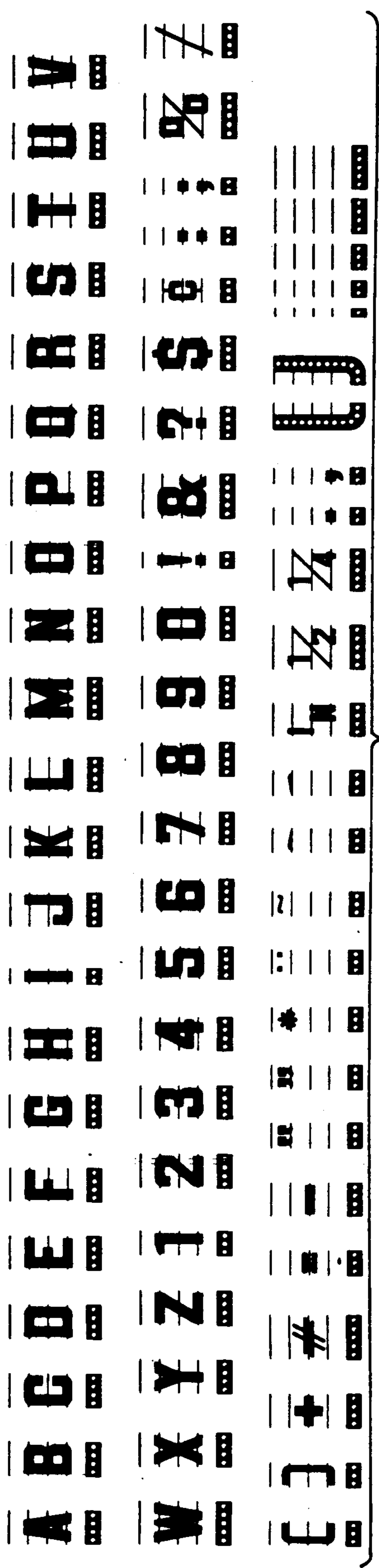
