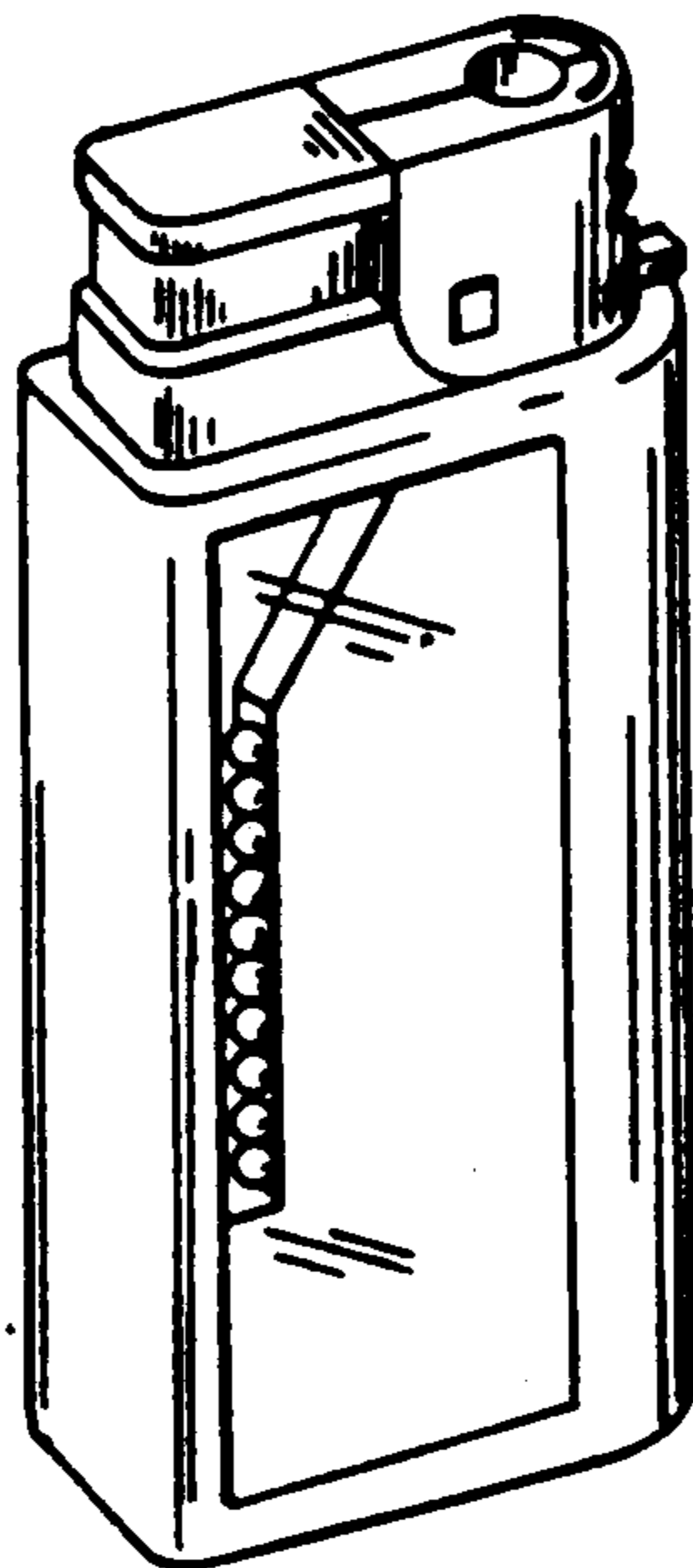

The ornamental design for a cigarette lighter, as shown  
and described.

DESCRIPTION

FIG. 1 is a perspective view of a cigarette lighter em-  
bodying our new design;  
FIG. 2 is a side elevational view thereof;  
FIG. 3 is an elevational view thereof, as seen from the  
opposite side of FIG. 2;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a front elevational view;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof.



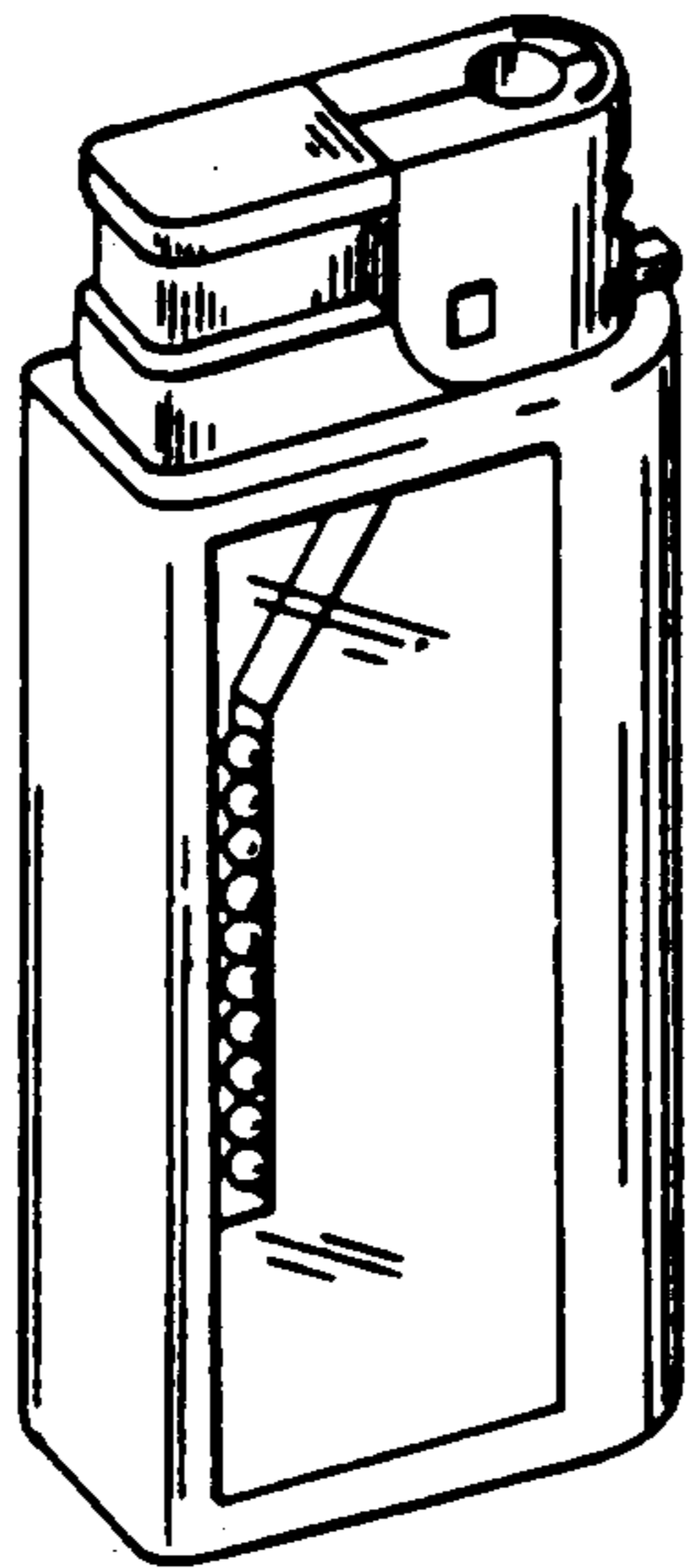

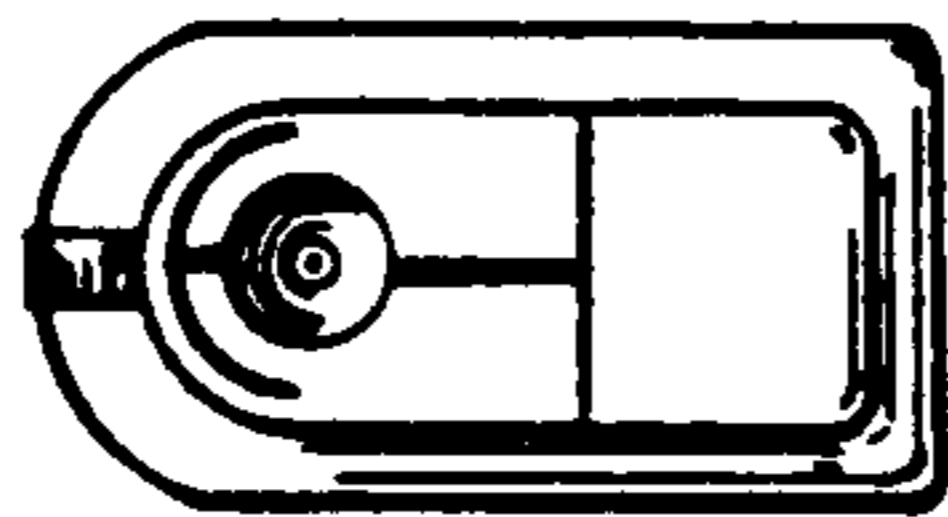

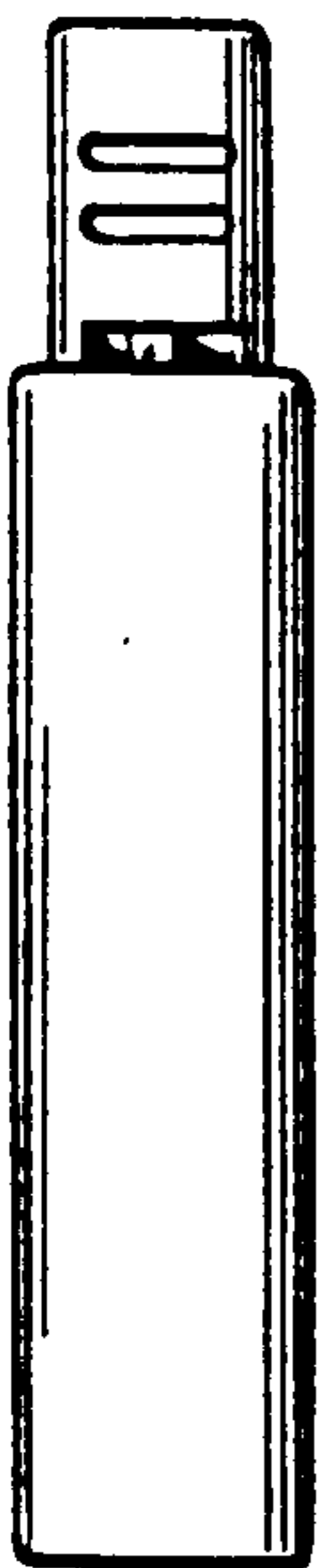

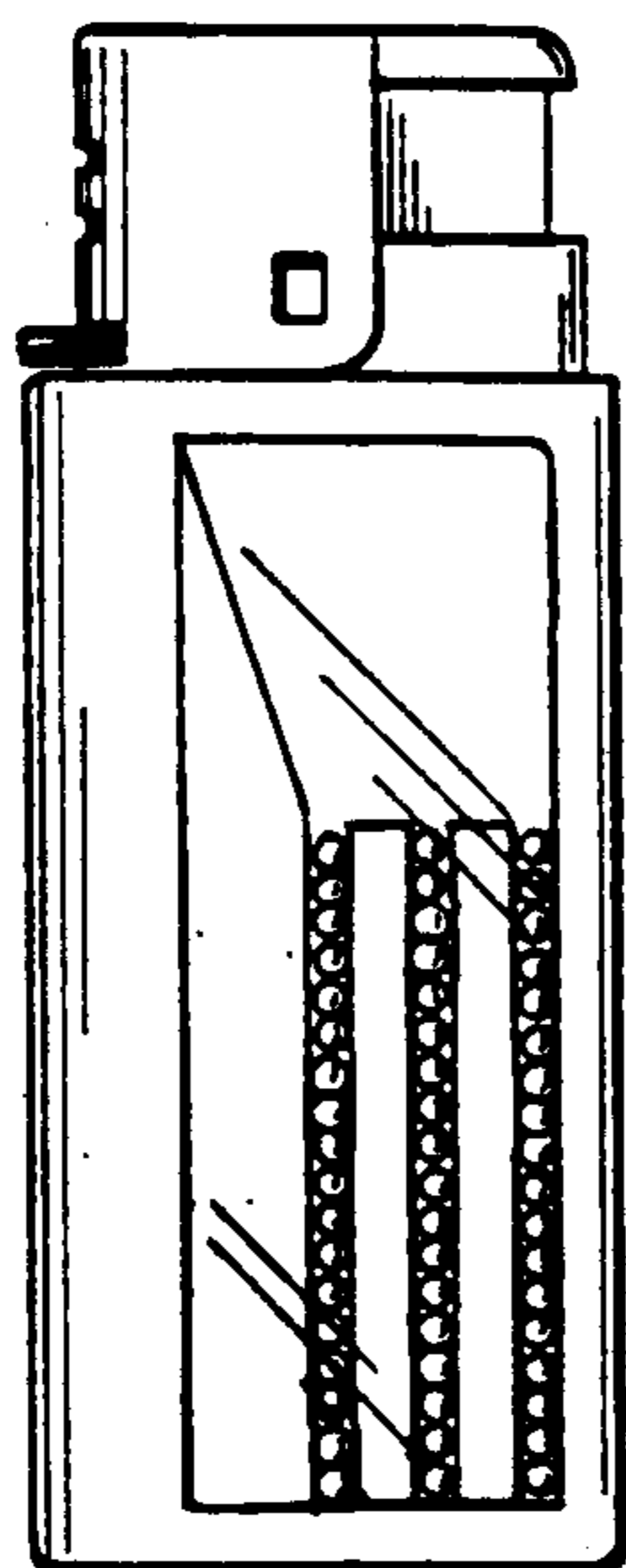

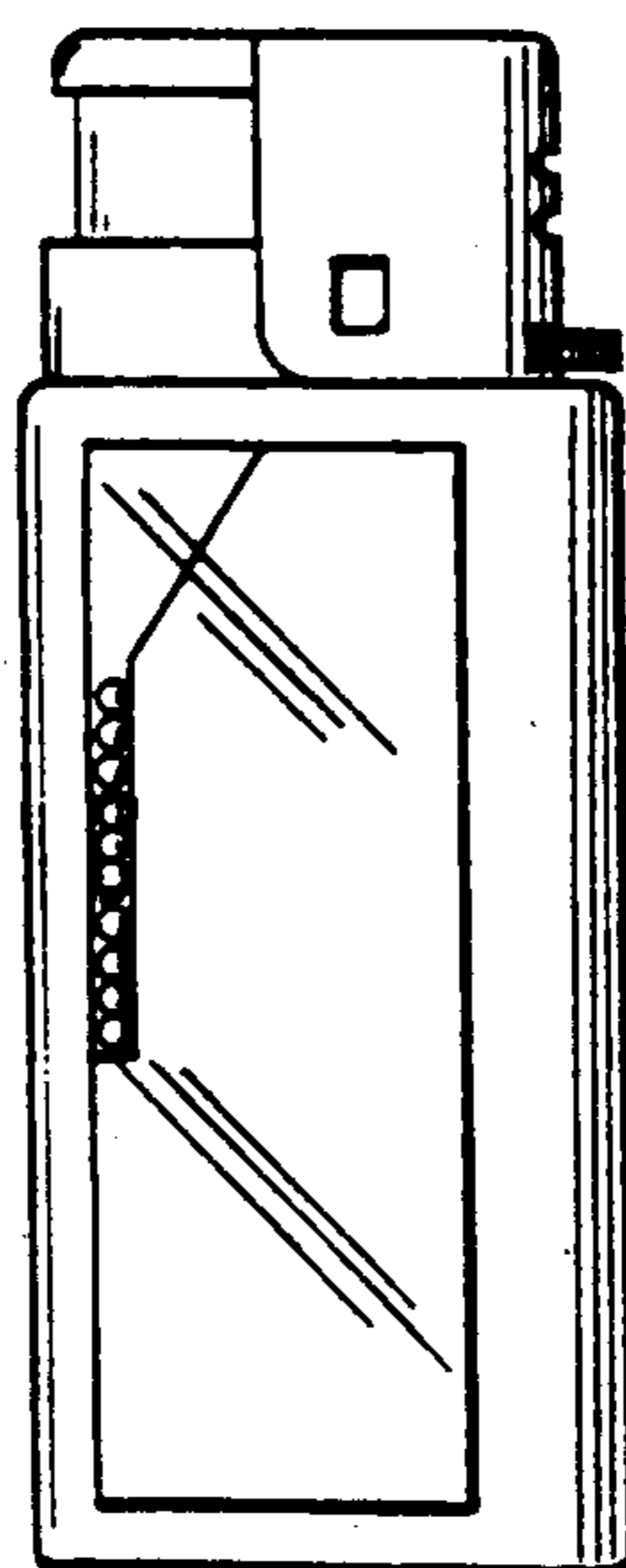

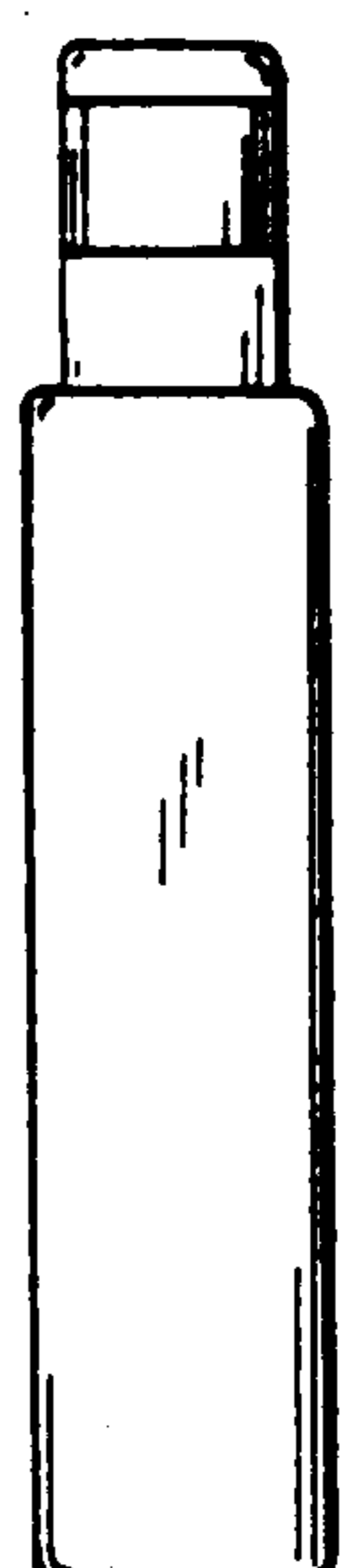

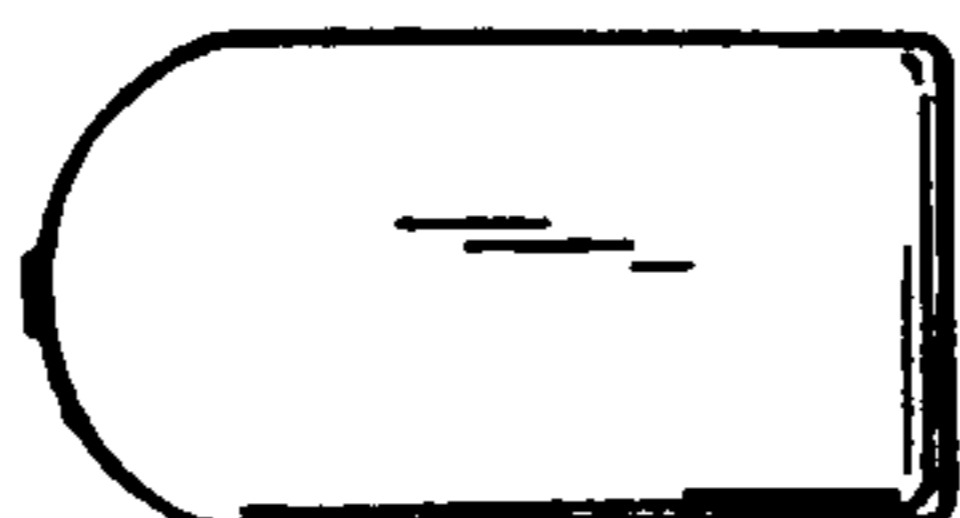
