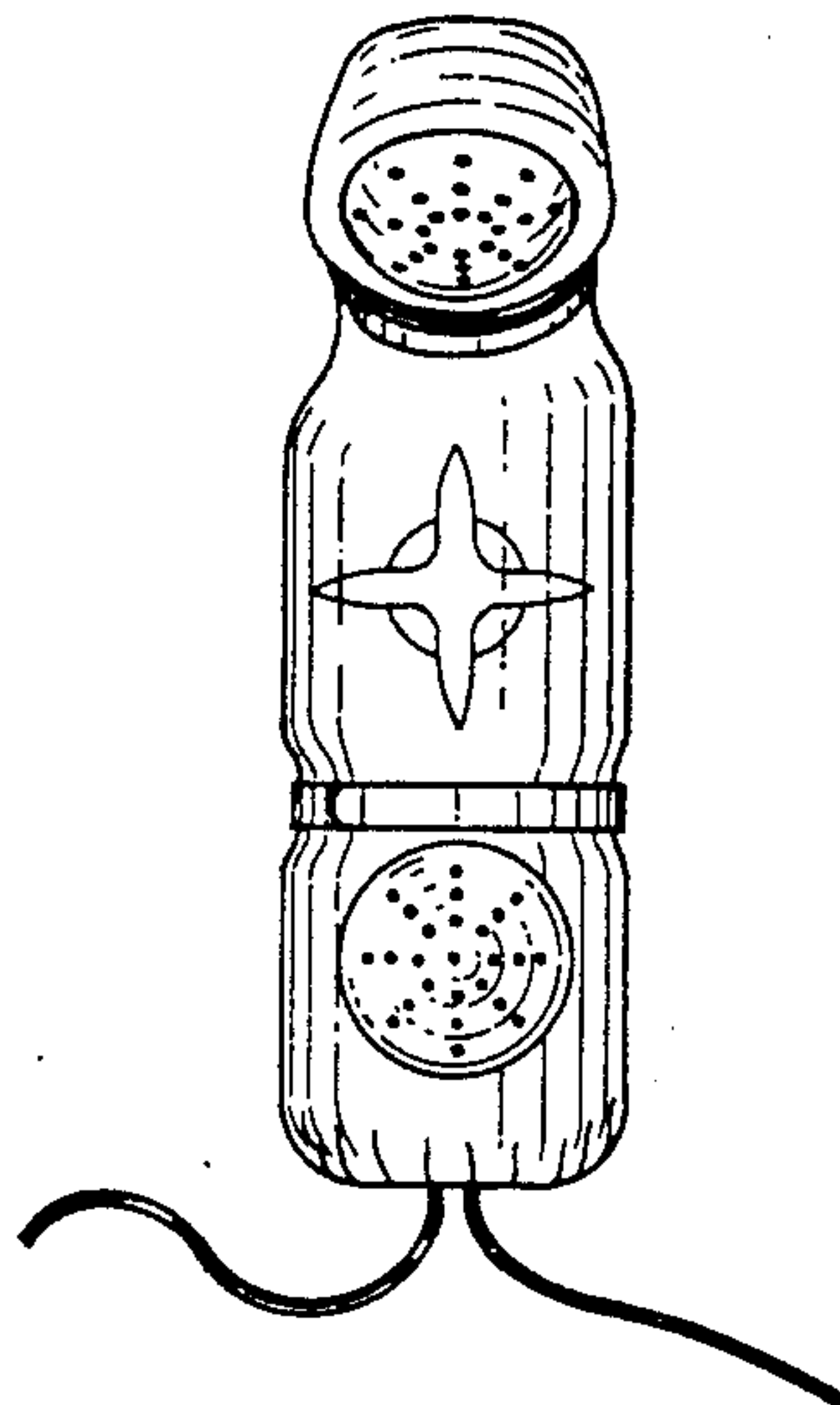
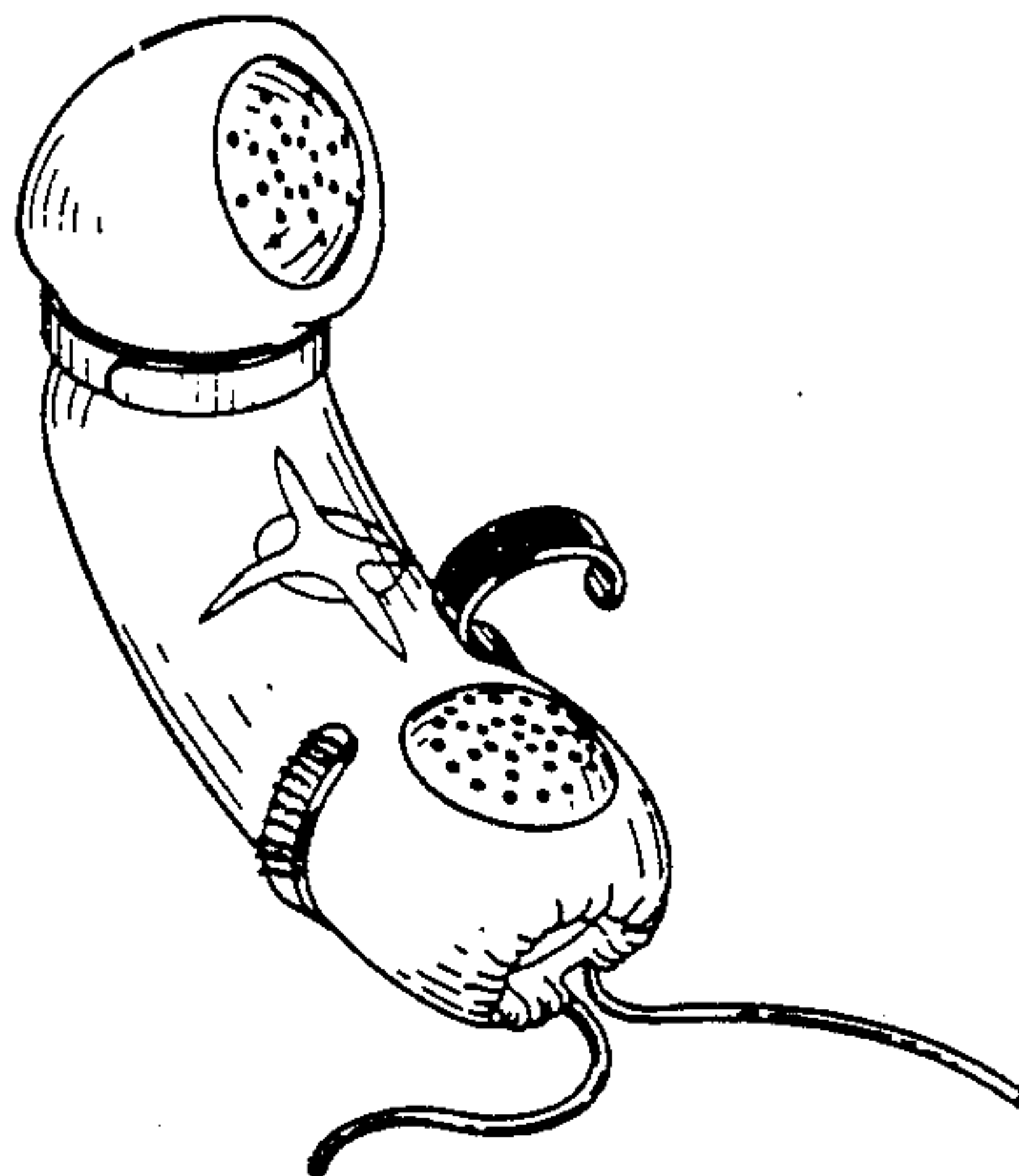

The ornamental design for a telephone cover, as shown and described.

DESCRIPTION

FIG. 1 is a left side, front and bottom perspective view of a telephone cover showing my new design; FIGS. 2 and 3 are respectively front and rear elevational views thereof; FIG. 4 is a left side elevational view thereof; and FIGS. 5 and 6 are respectively top and bottom plan views thereof.



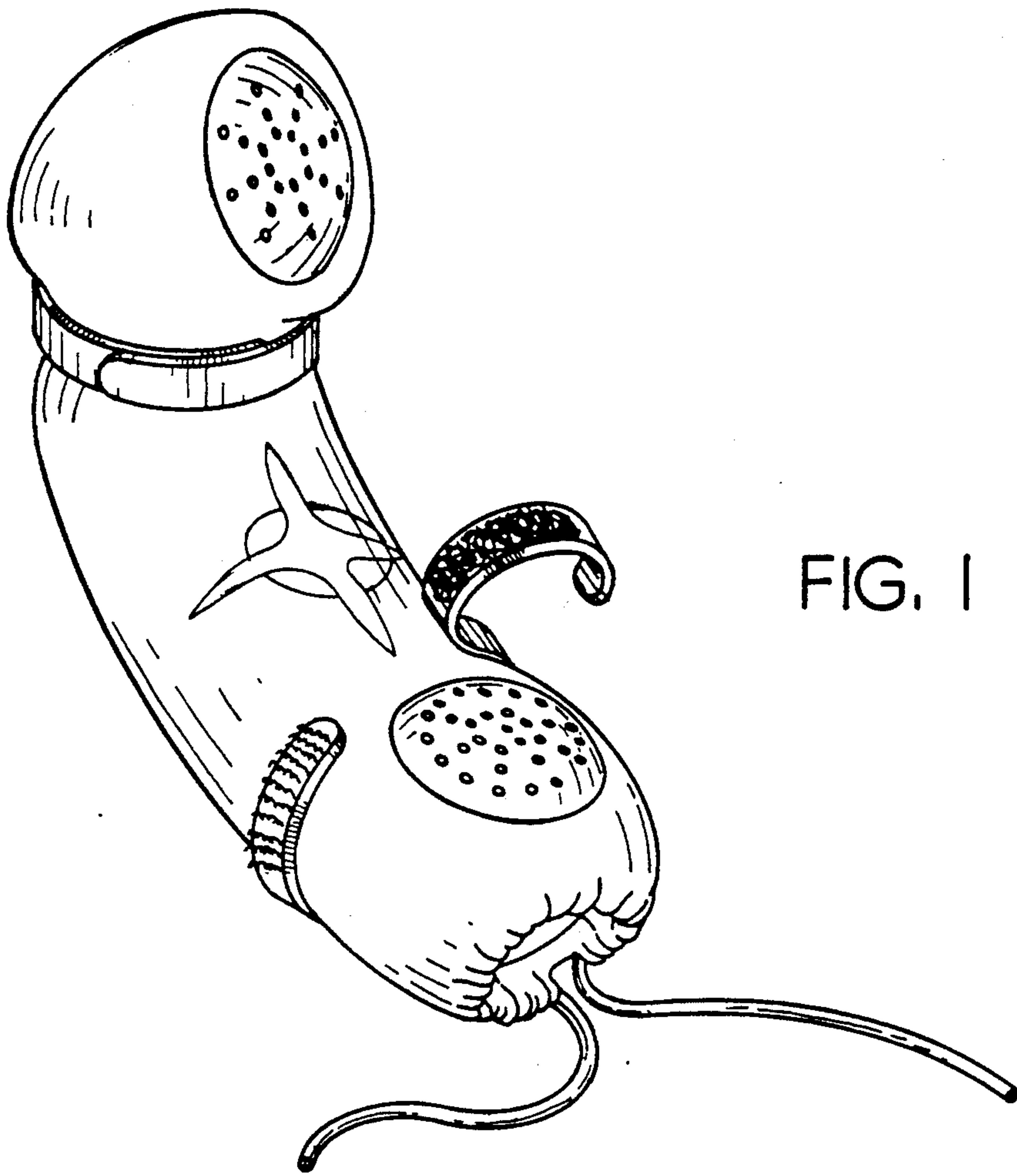

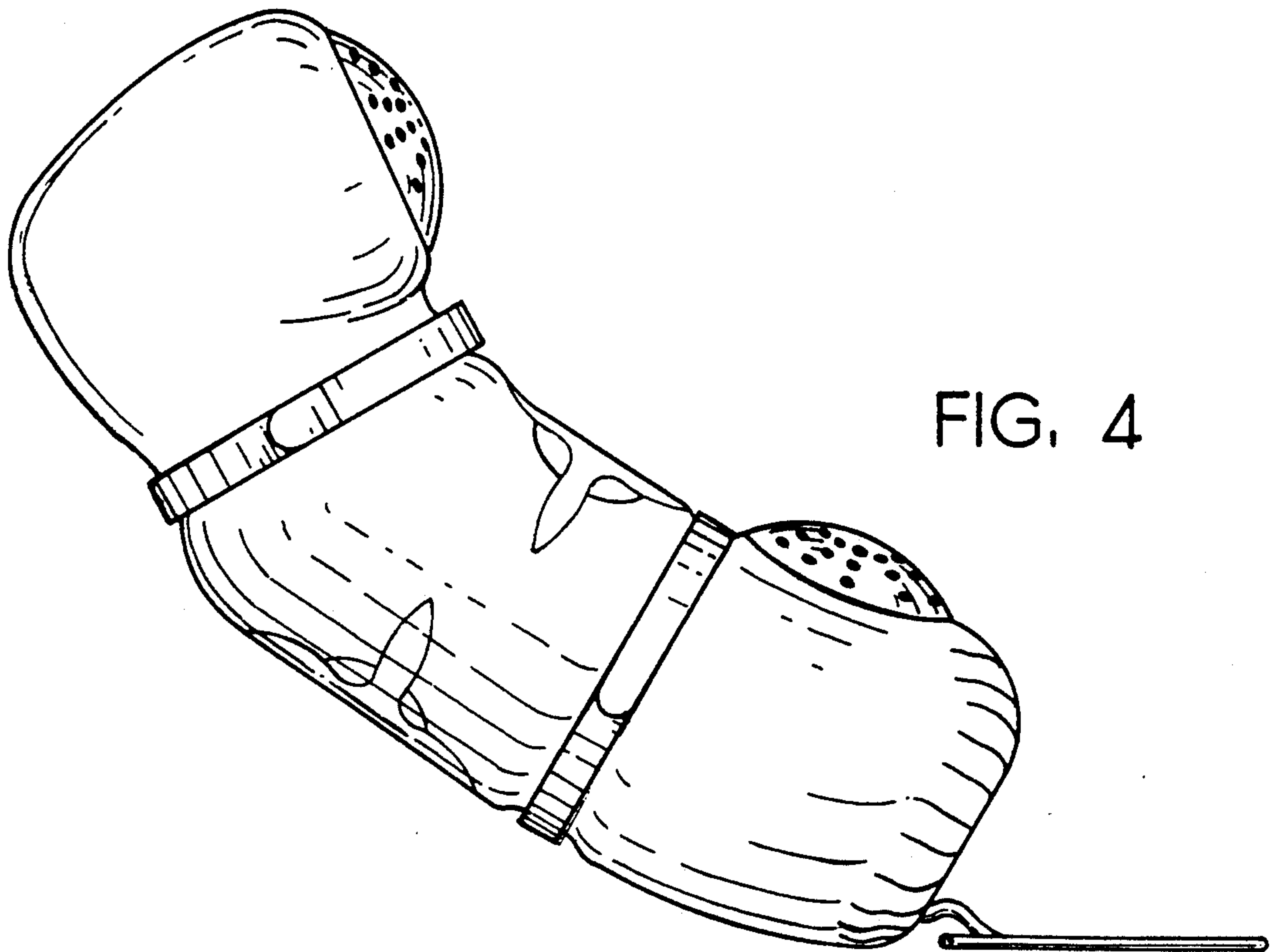

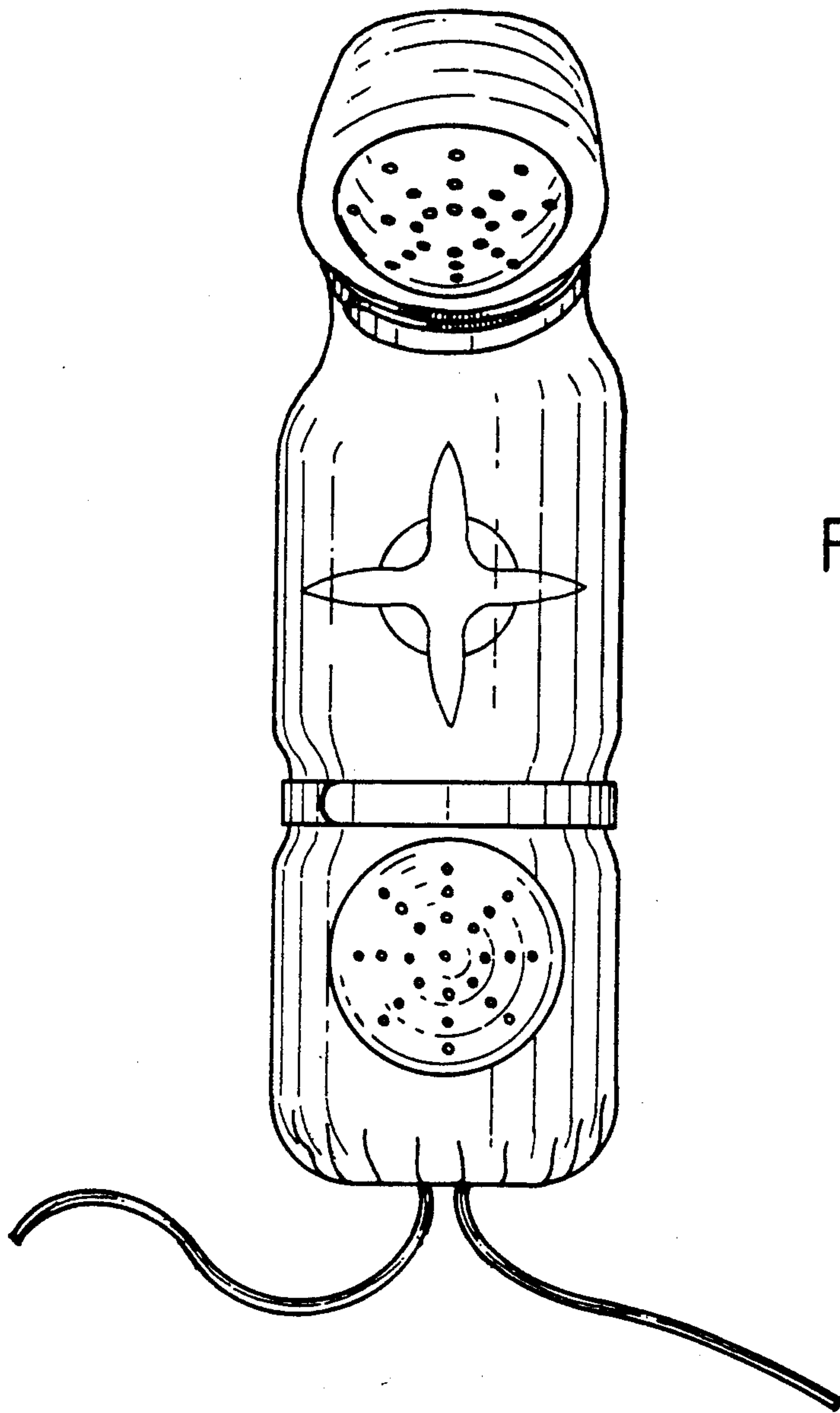

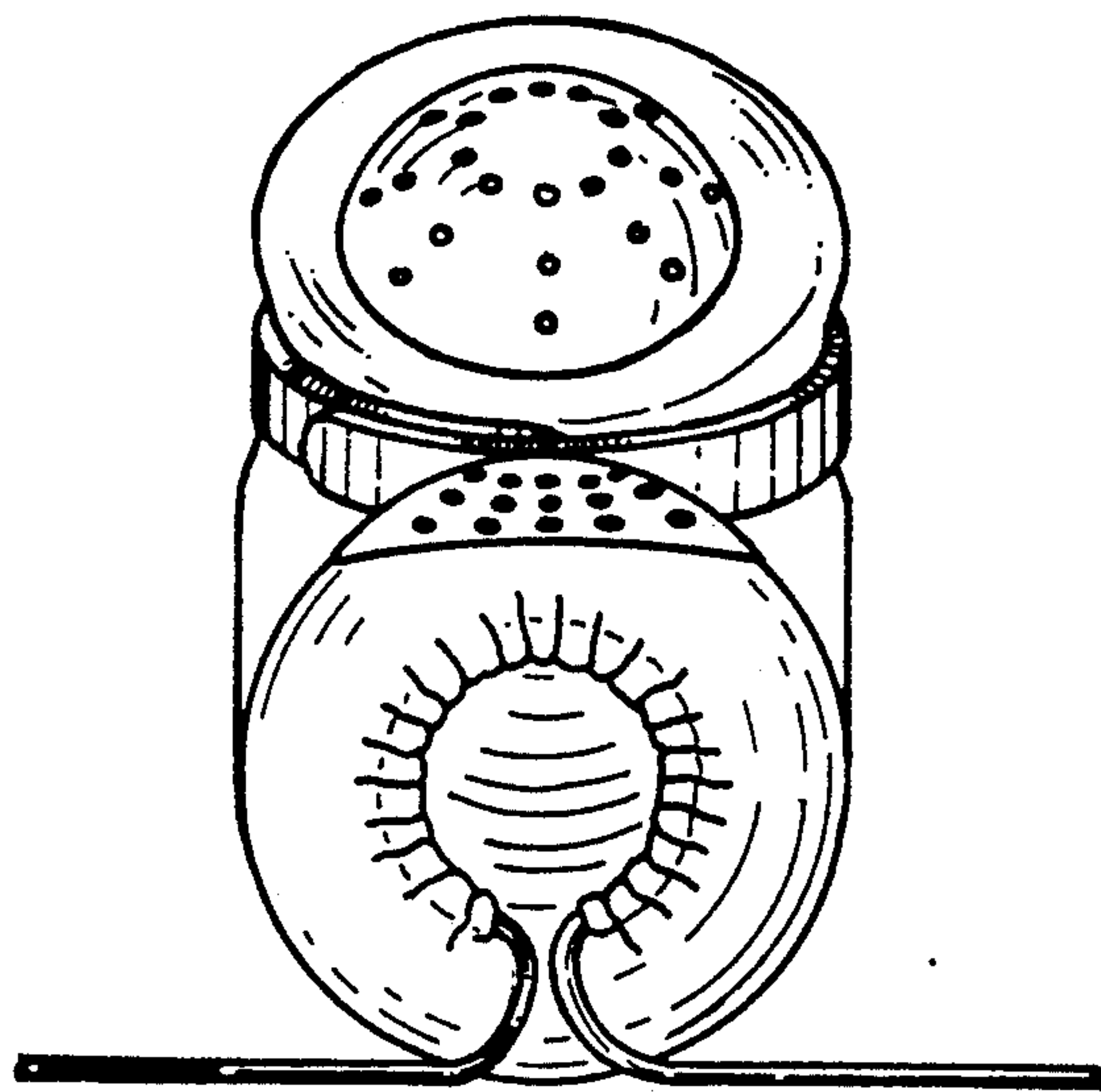

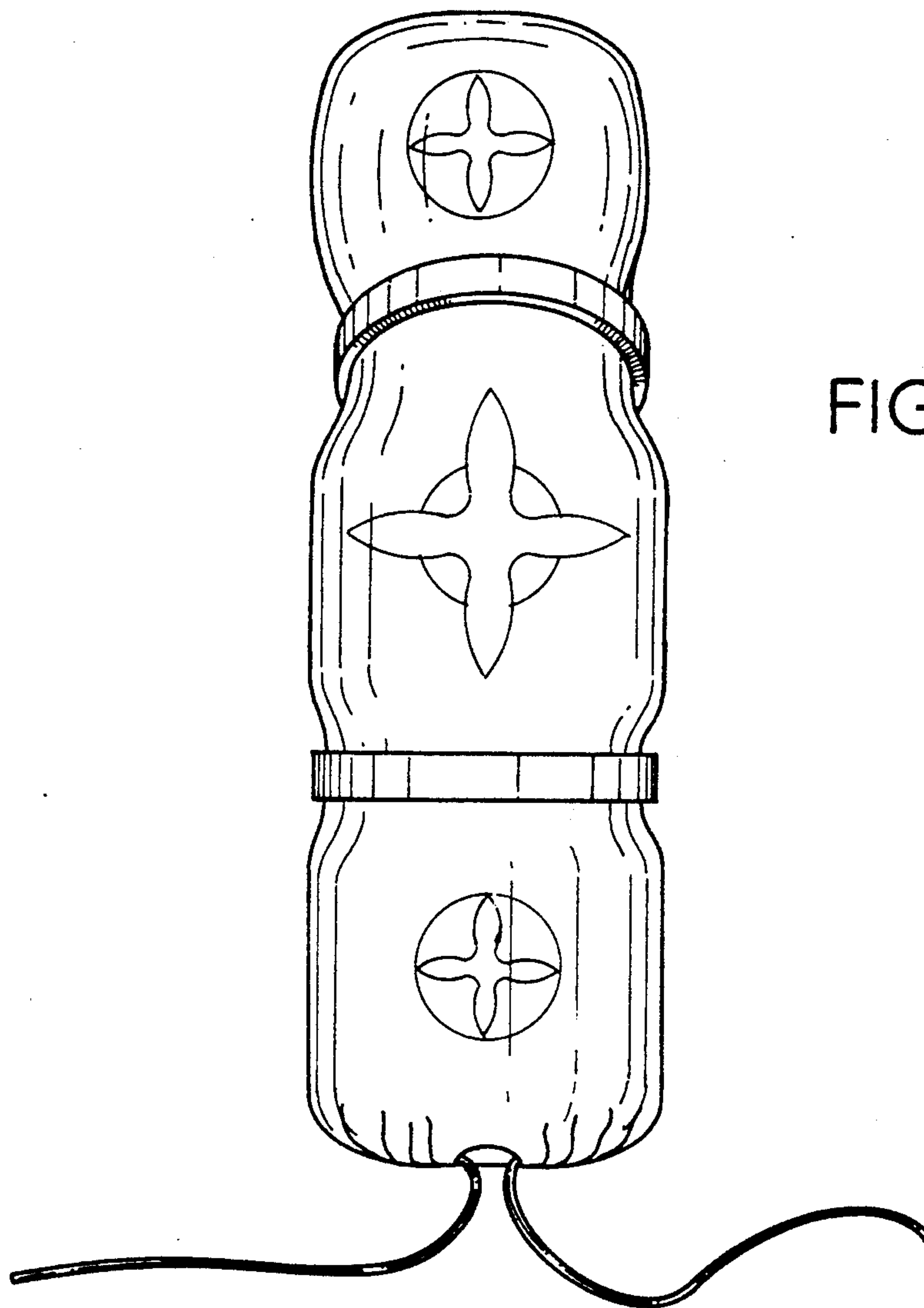

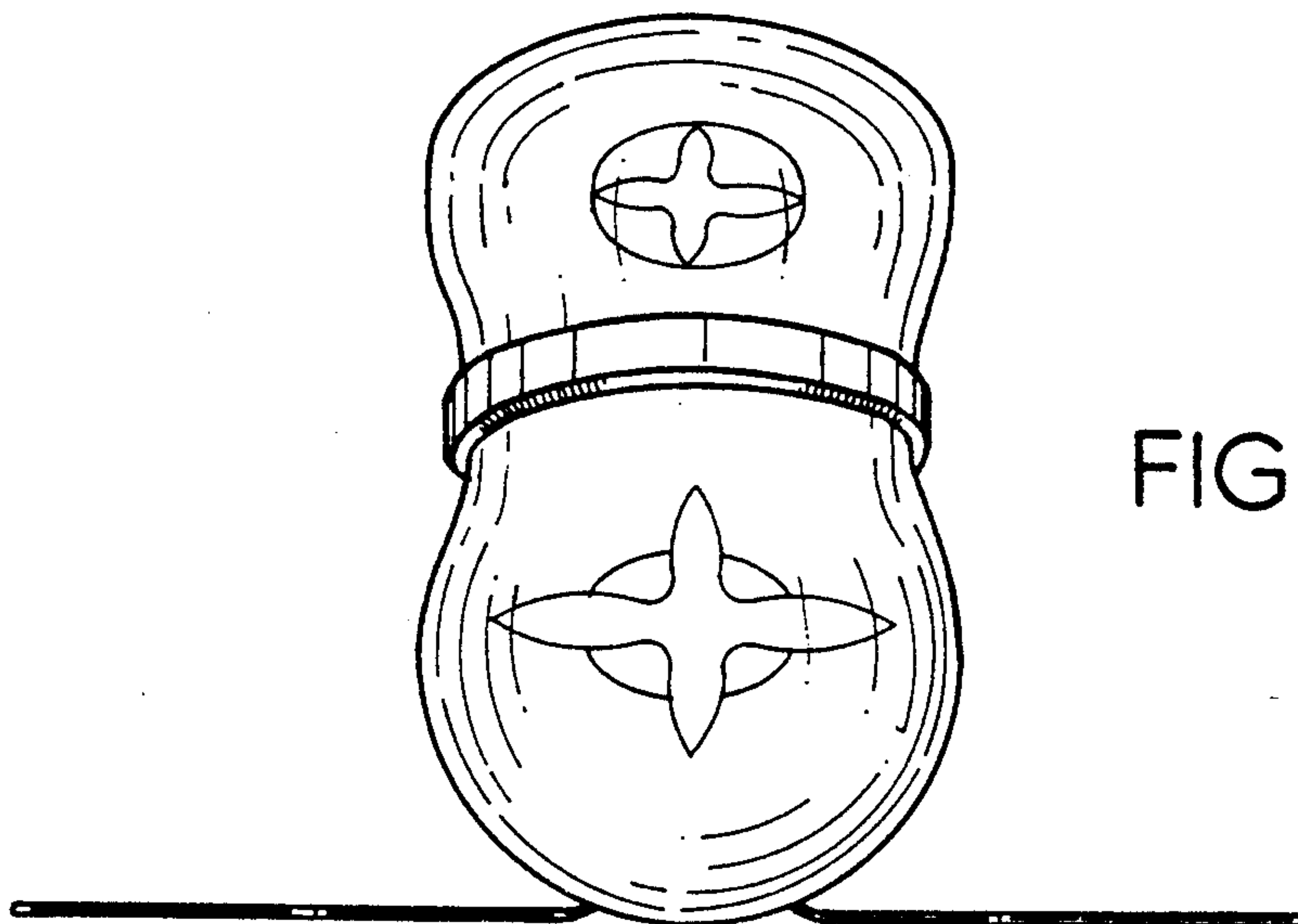
