[57] **CLAIM**

The ornamental design for a smock, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a smock showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a perspective view of an alternate embodiment of the design of FIG. 1 shown in the position of use;
 FIG. 5 is a rear elevational view of FIG. 4;
 FIG. 6 is a right rear perspective view of a second embodiment of the design of FIG. 1 shown in the position of use;
 FIG. 7 is a front elevational view of FIG. 6; and
 FIG. 8 is a rear elevational view of FIG. 6.

The fabric patterns shown in part on the figures is understood to cover the entire area of the garment where indicated.

The broken line showings of a bear, teething keys and pacifier in FIG. 4 are for illustrative purposes only, and form no part of the claimed design.

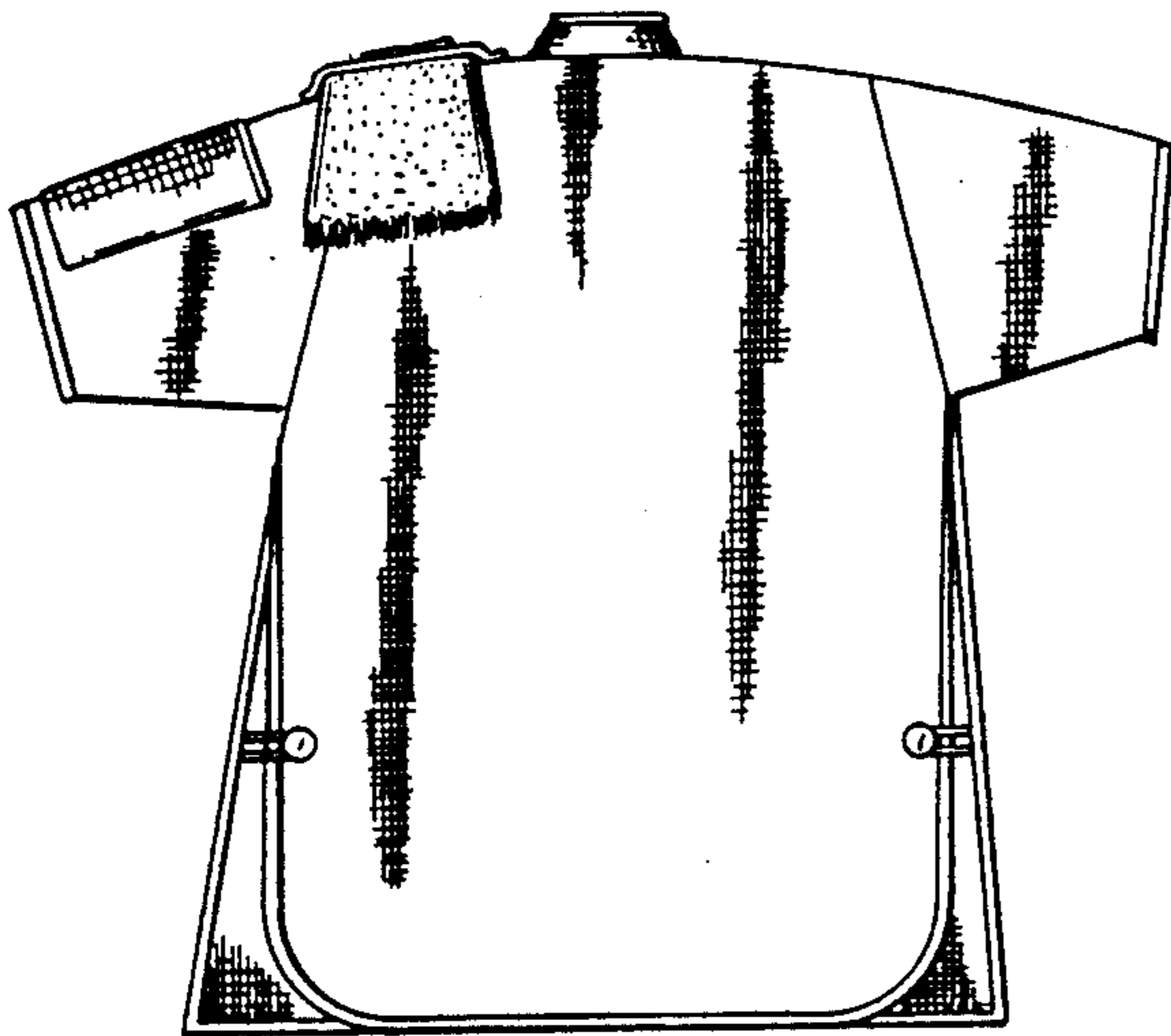
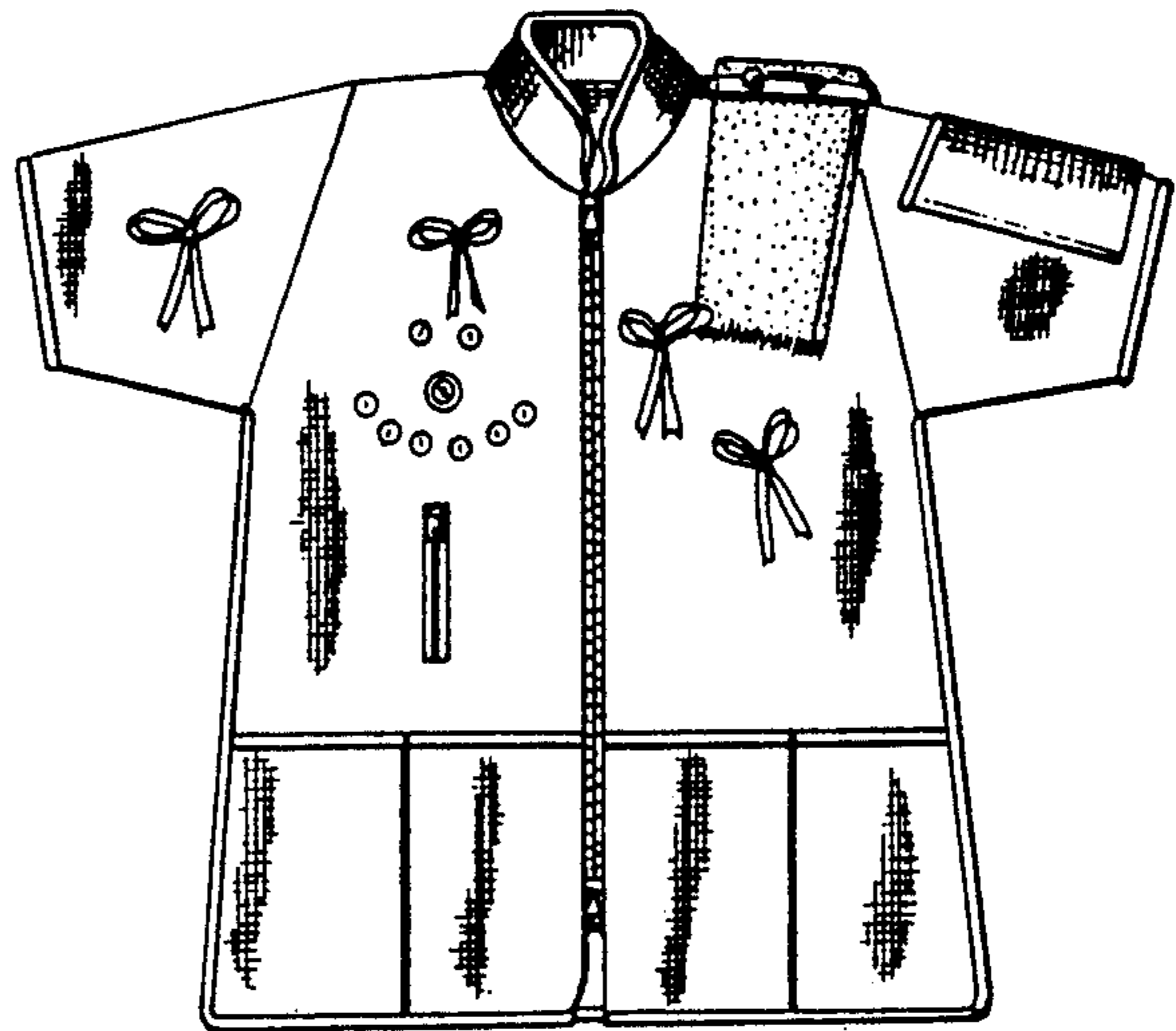

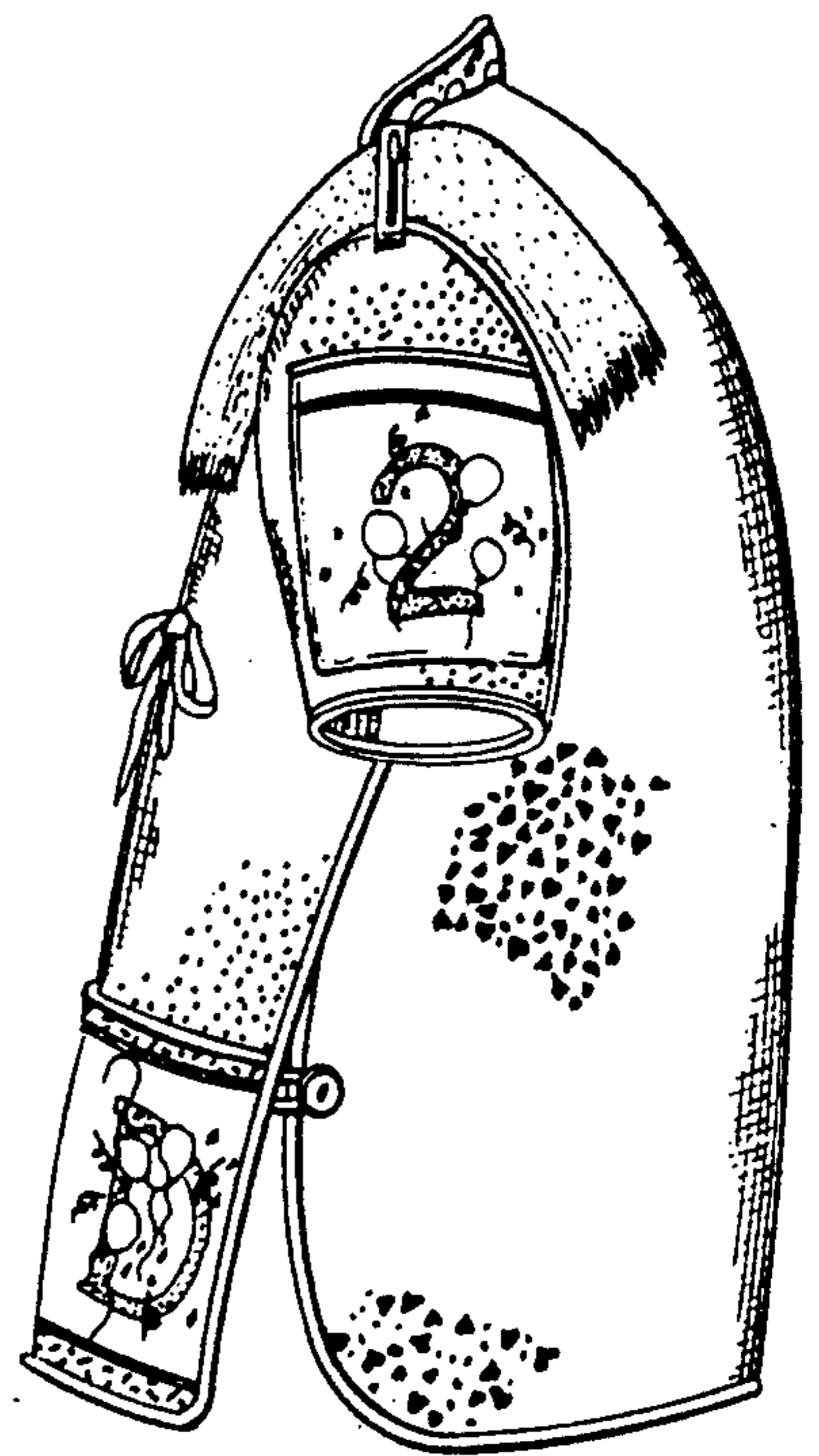

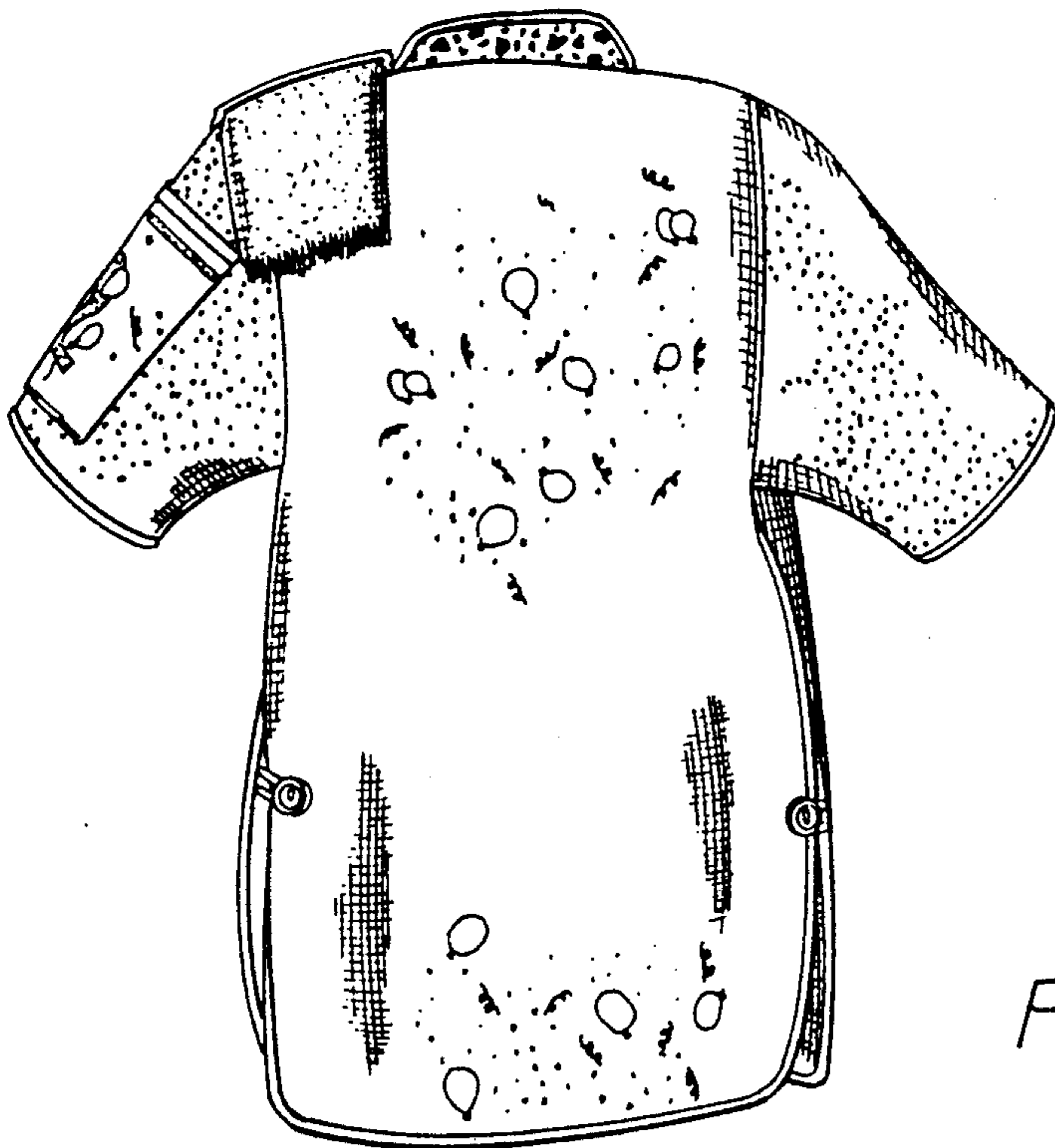

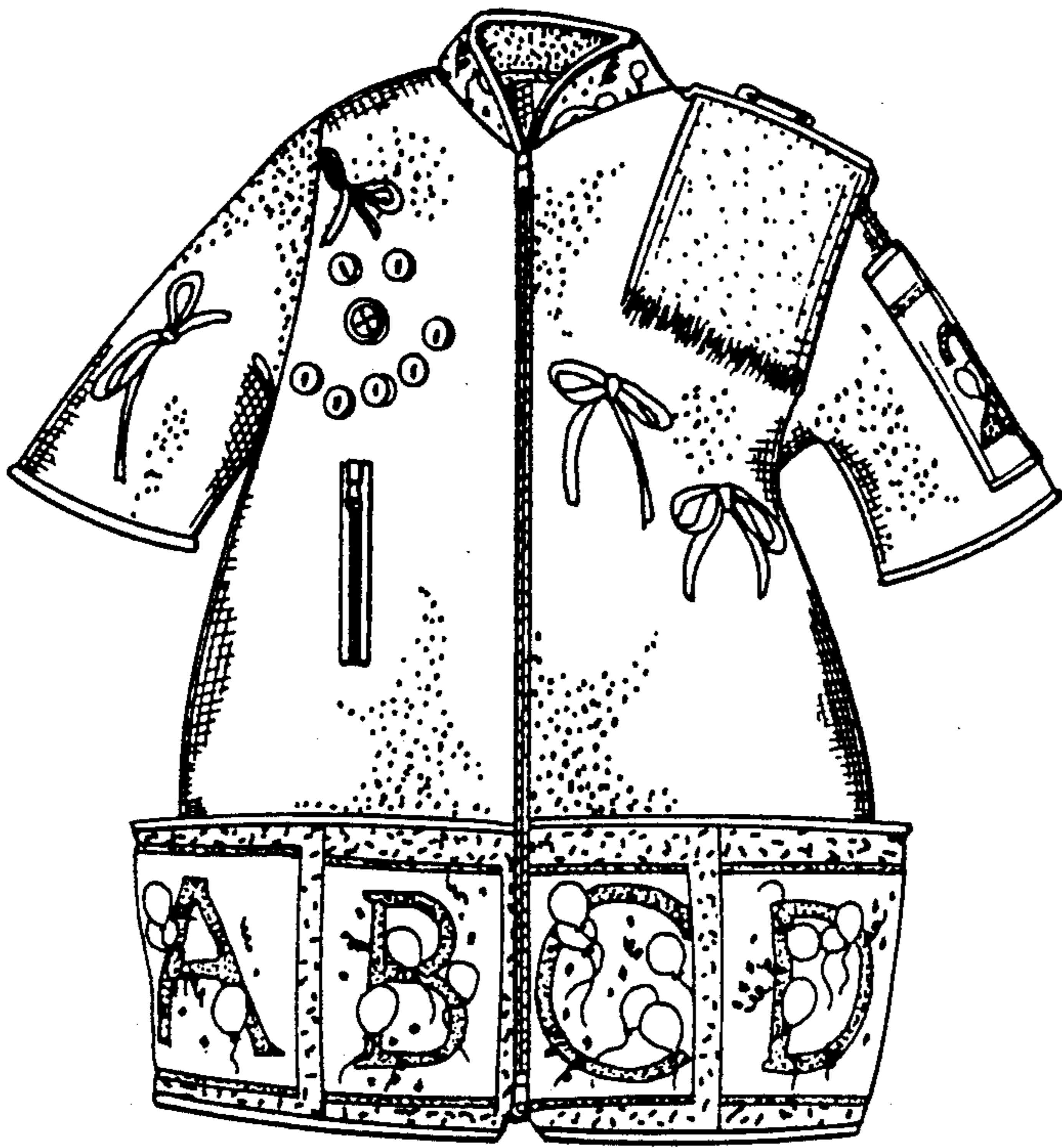

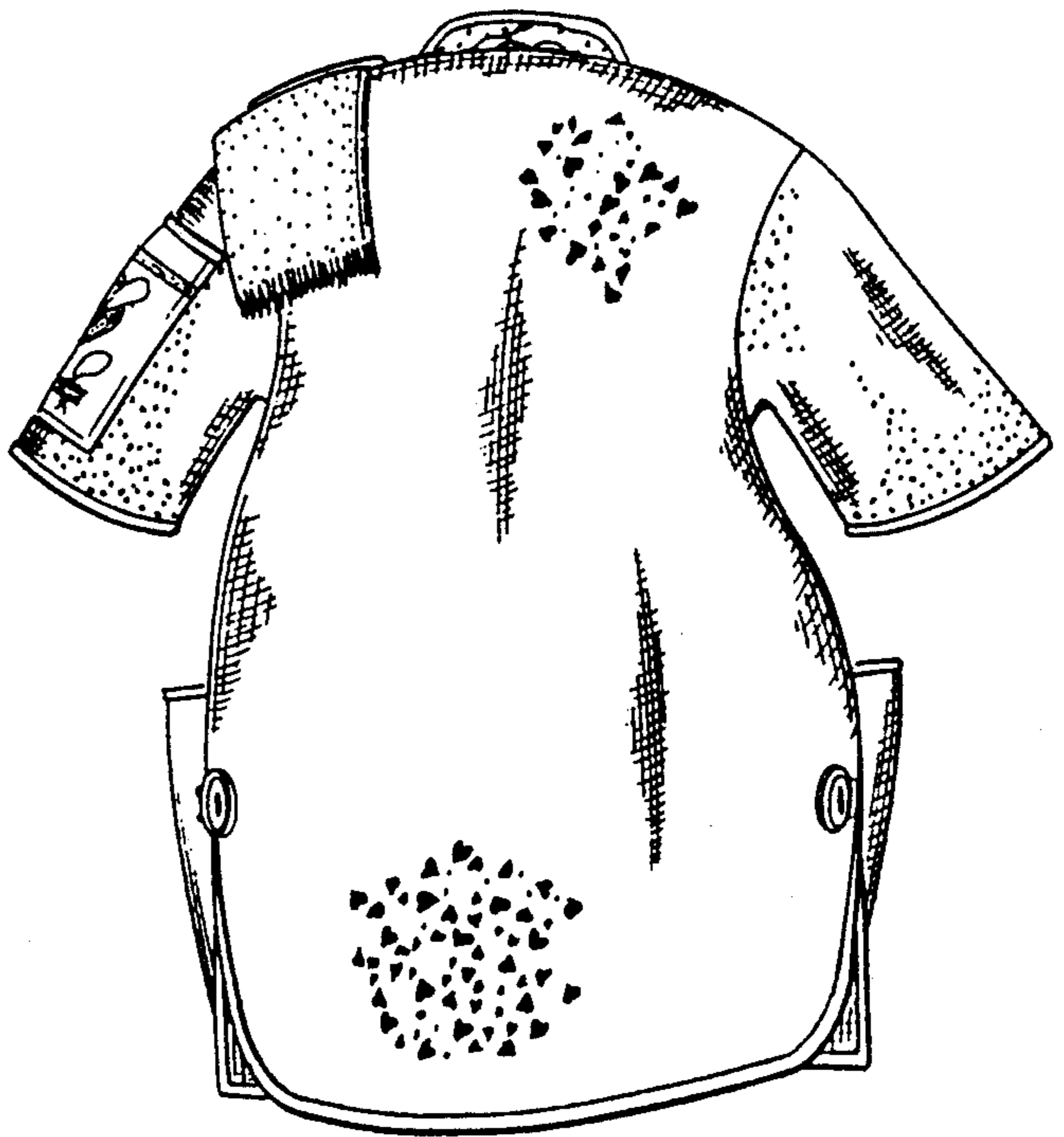
