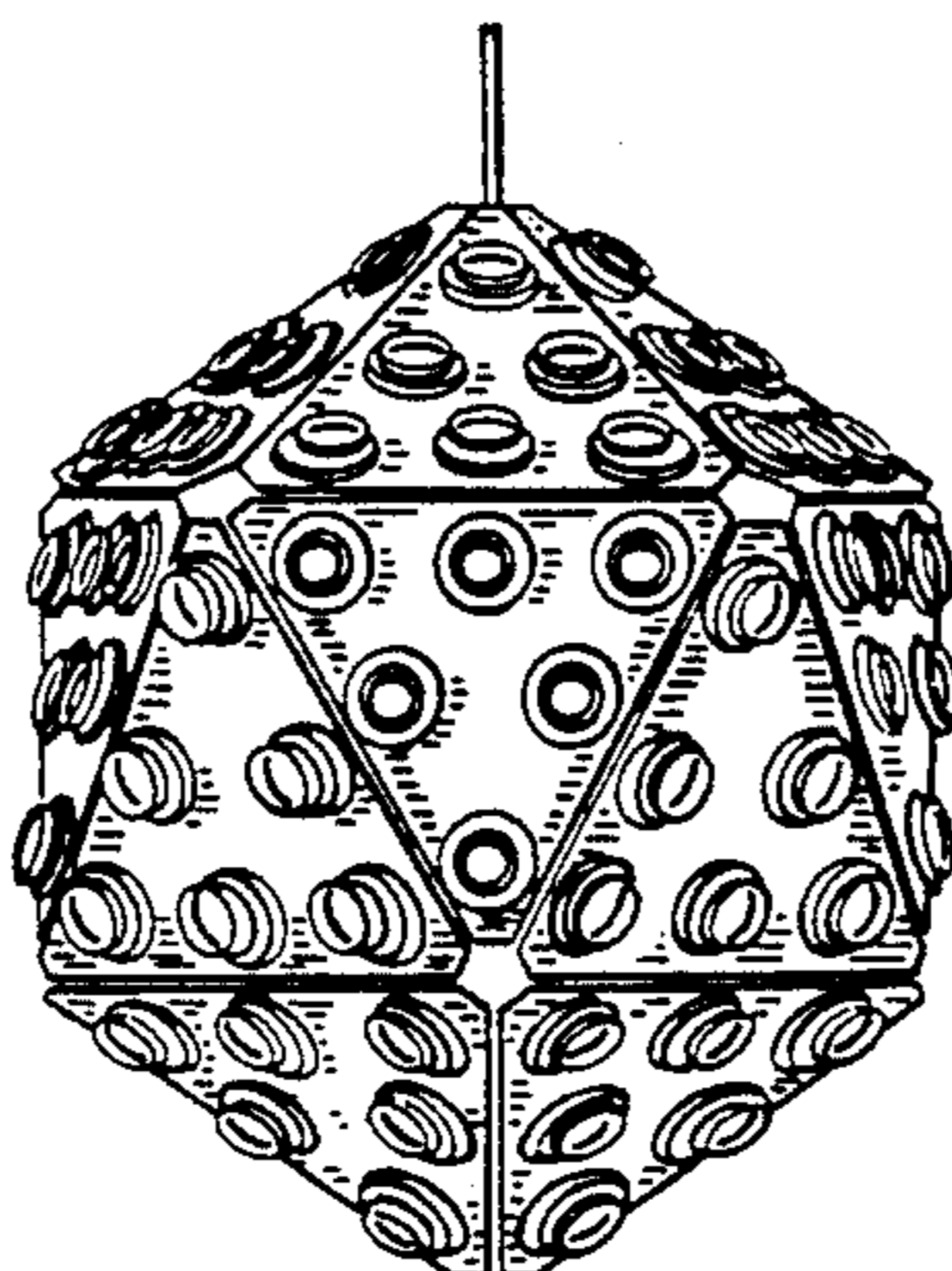
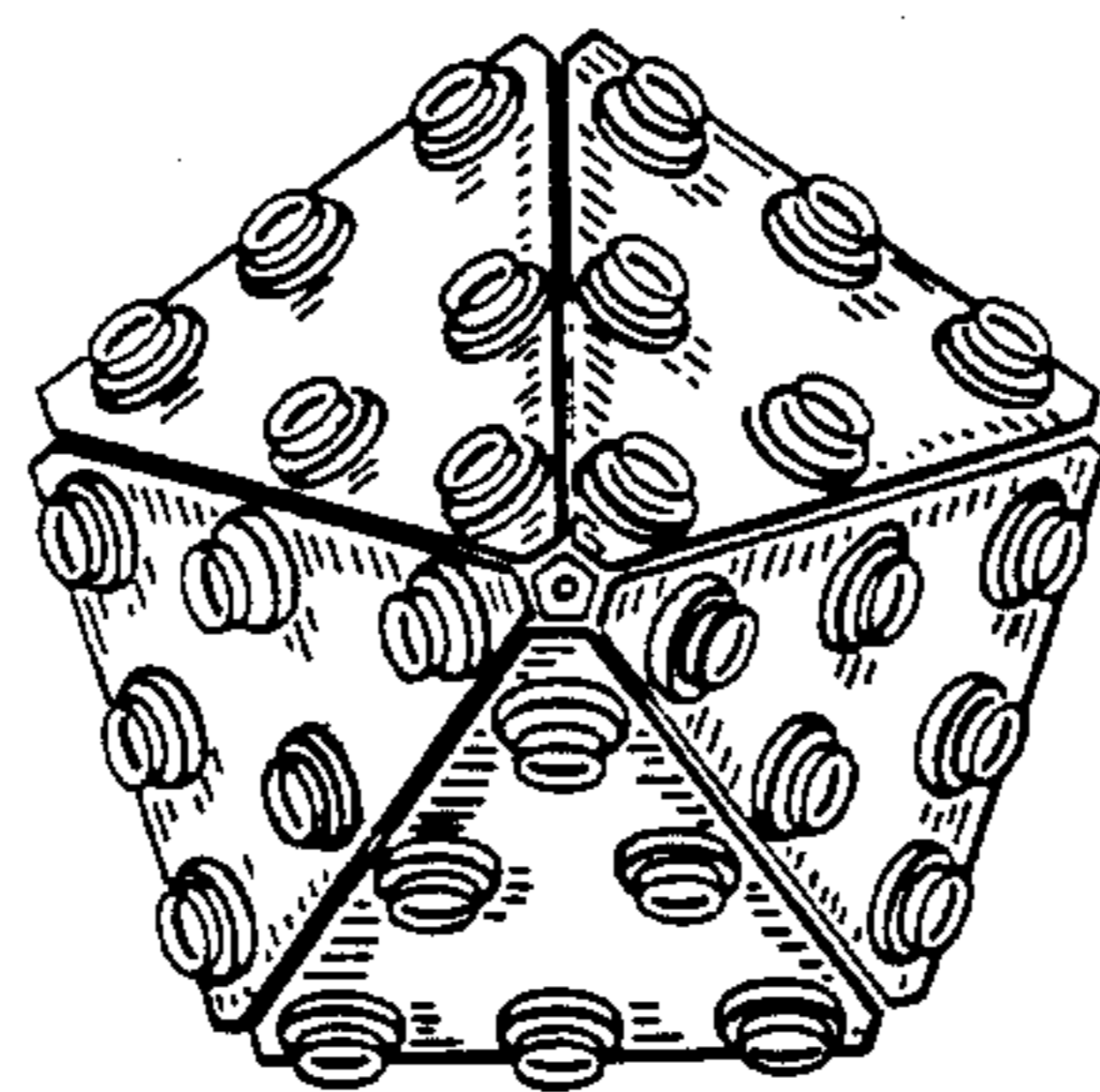

[57] **CLAIM**

The ornamental design for lighting fixture, as shown and described.

DESCRIPTION

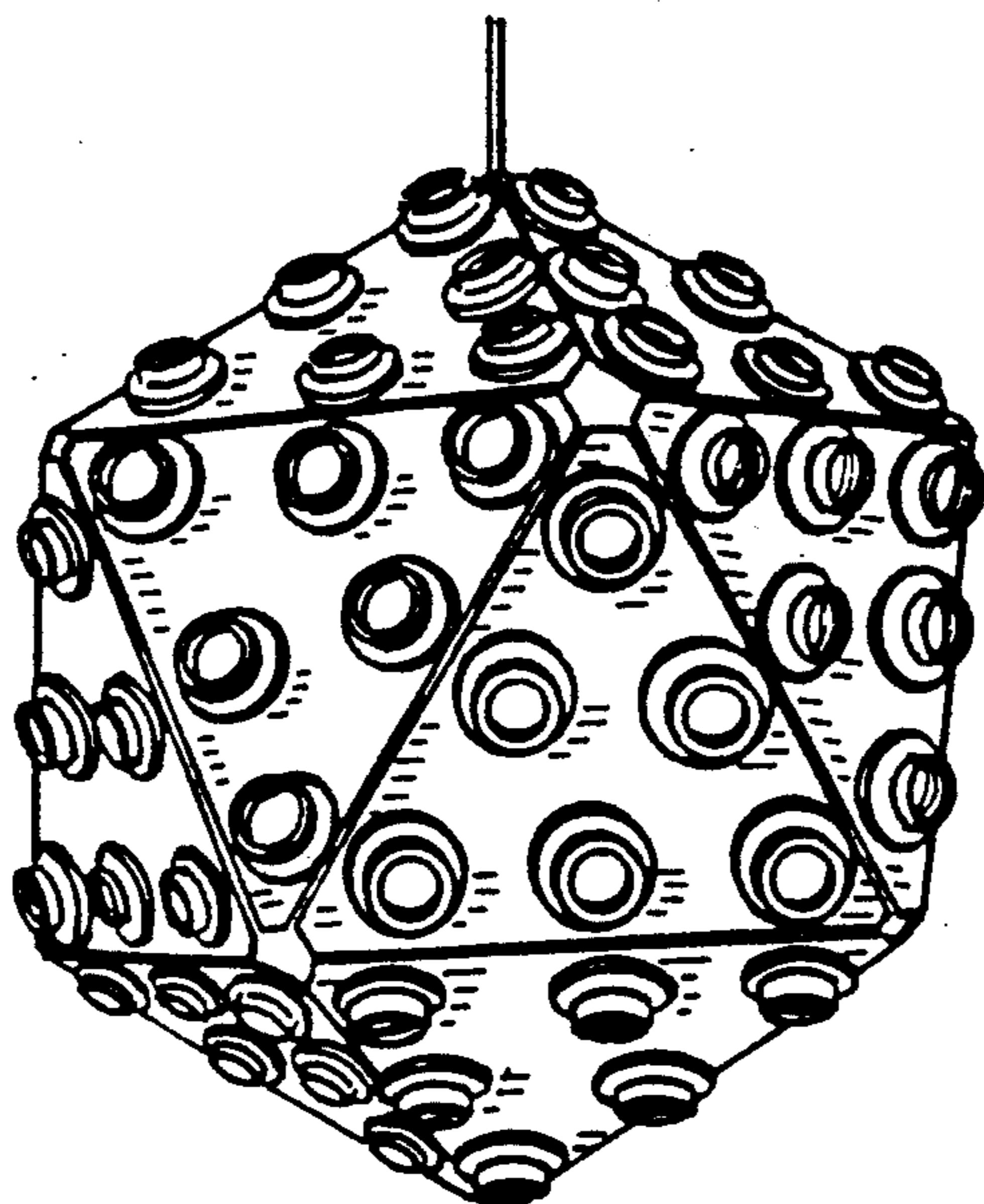

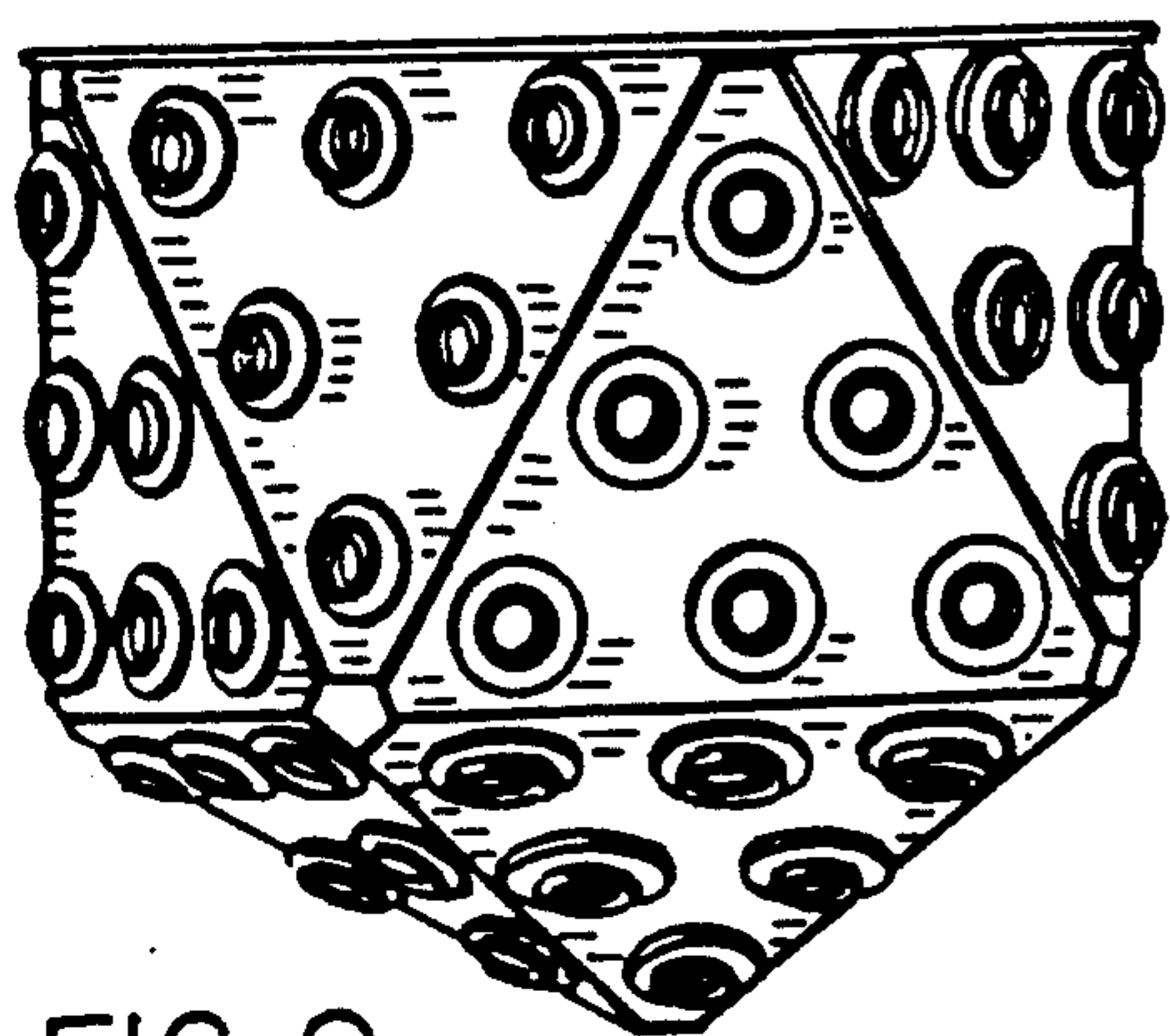

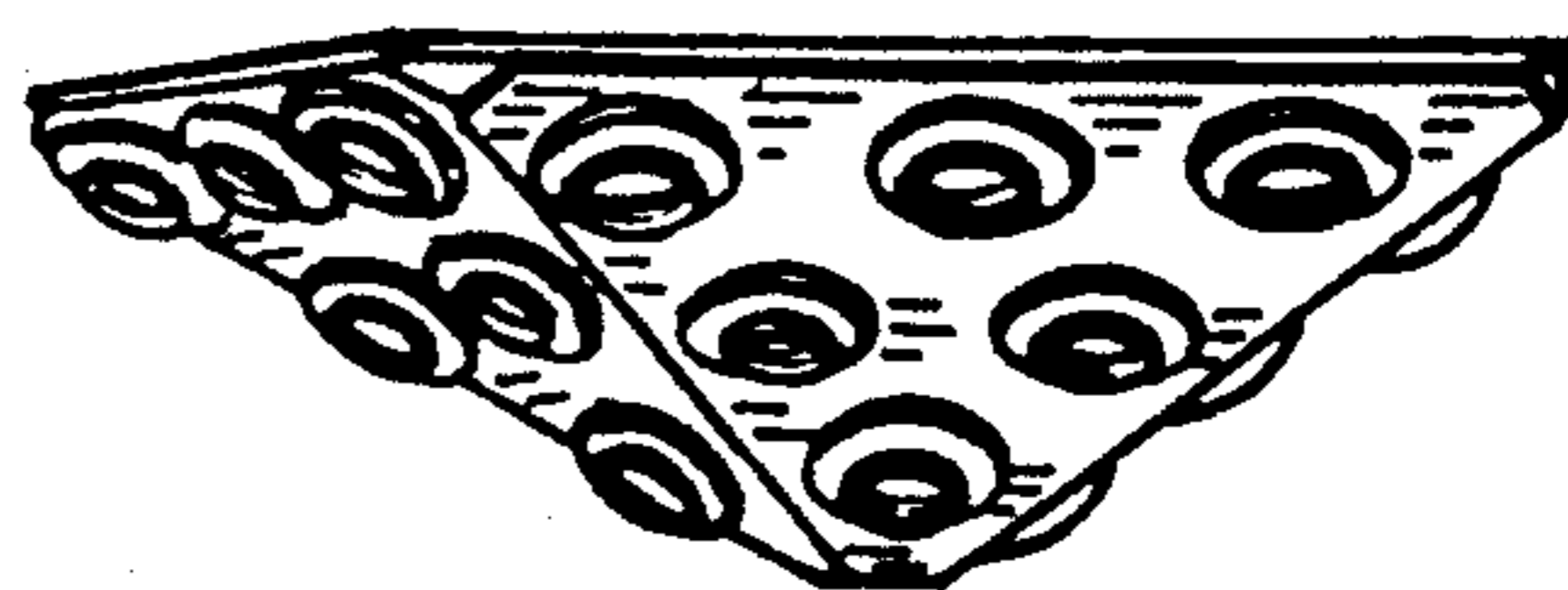

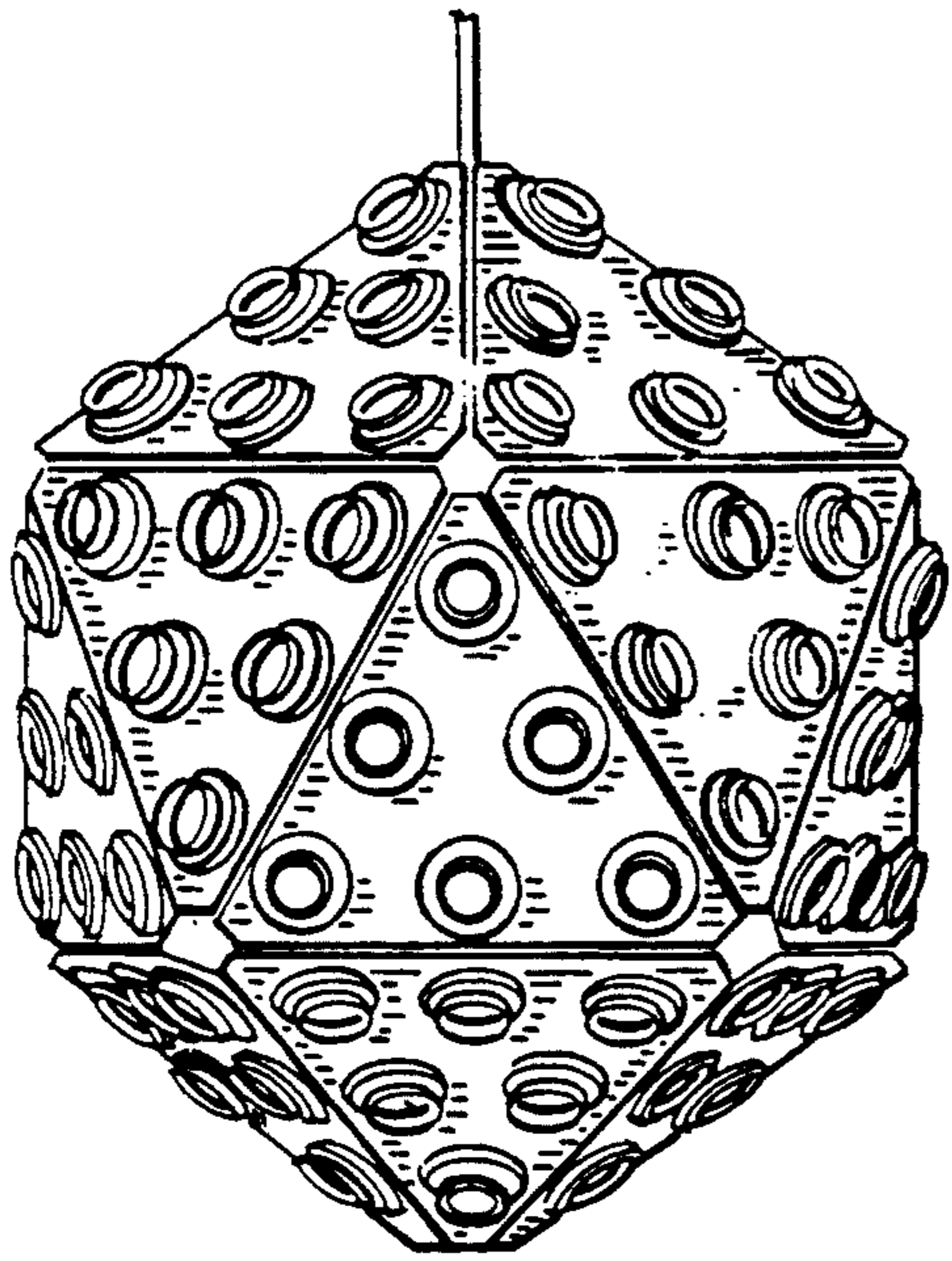

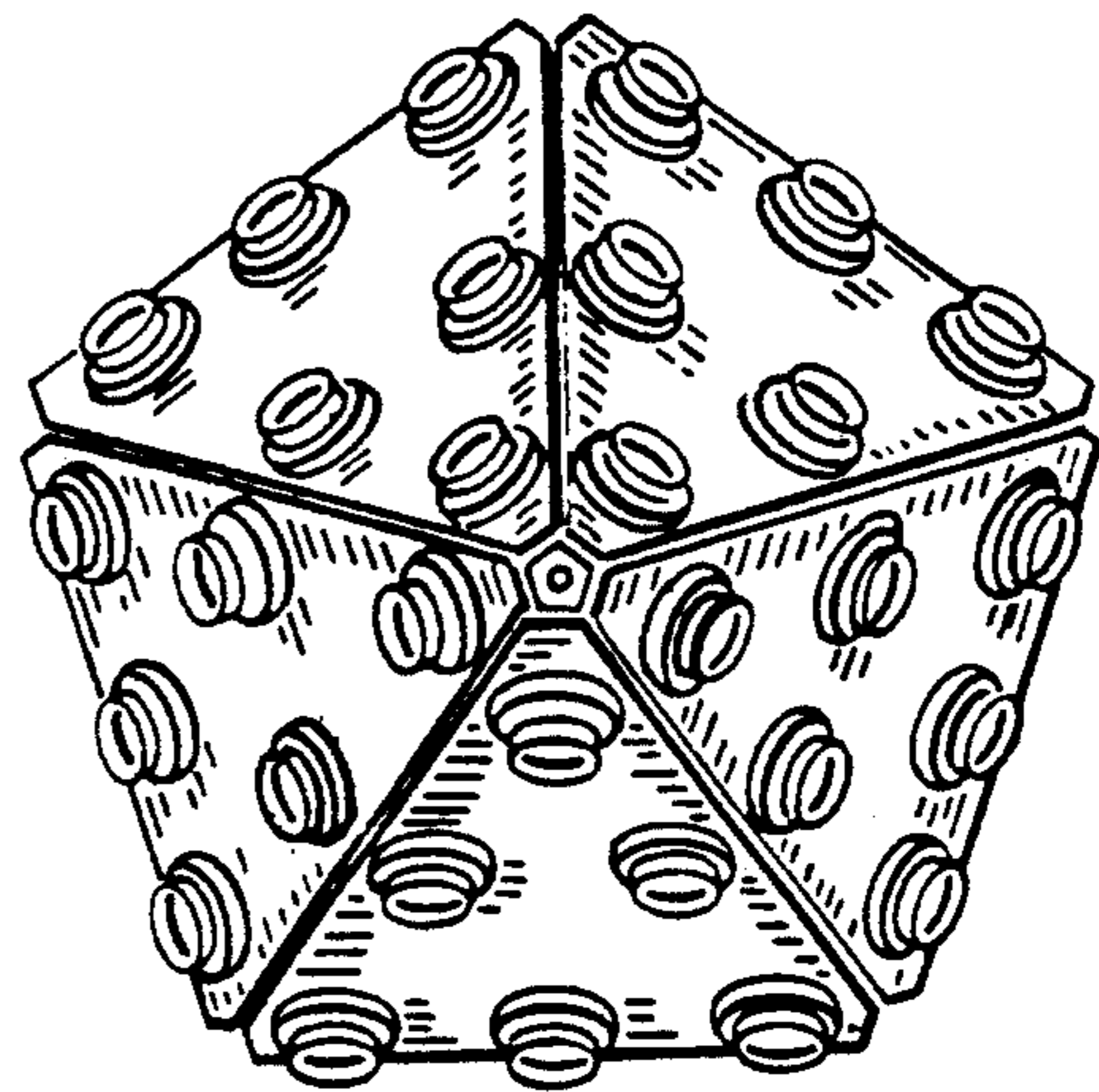

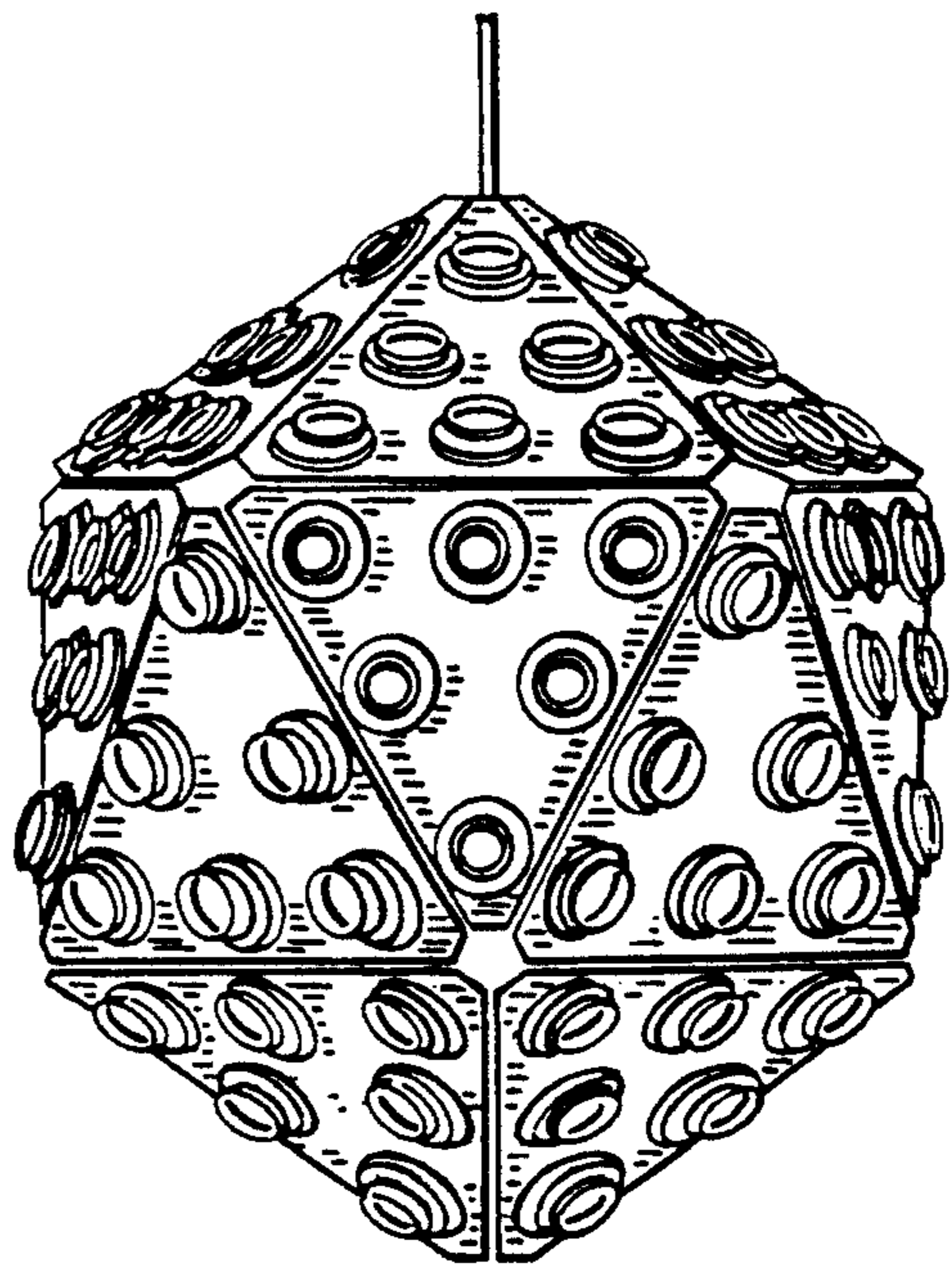

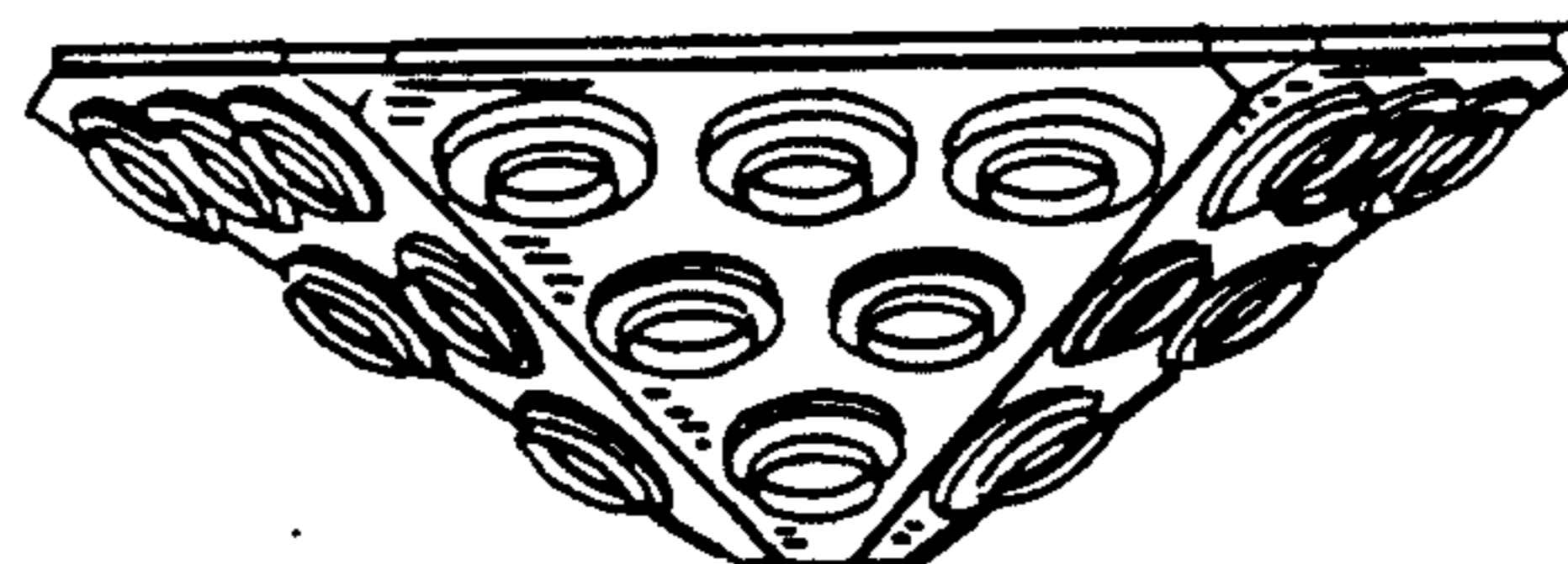

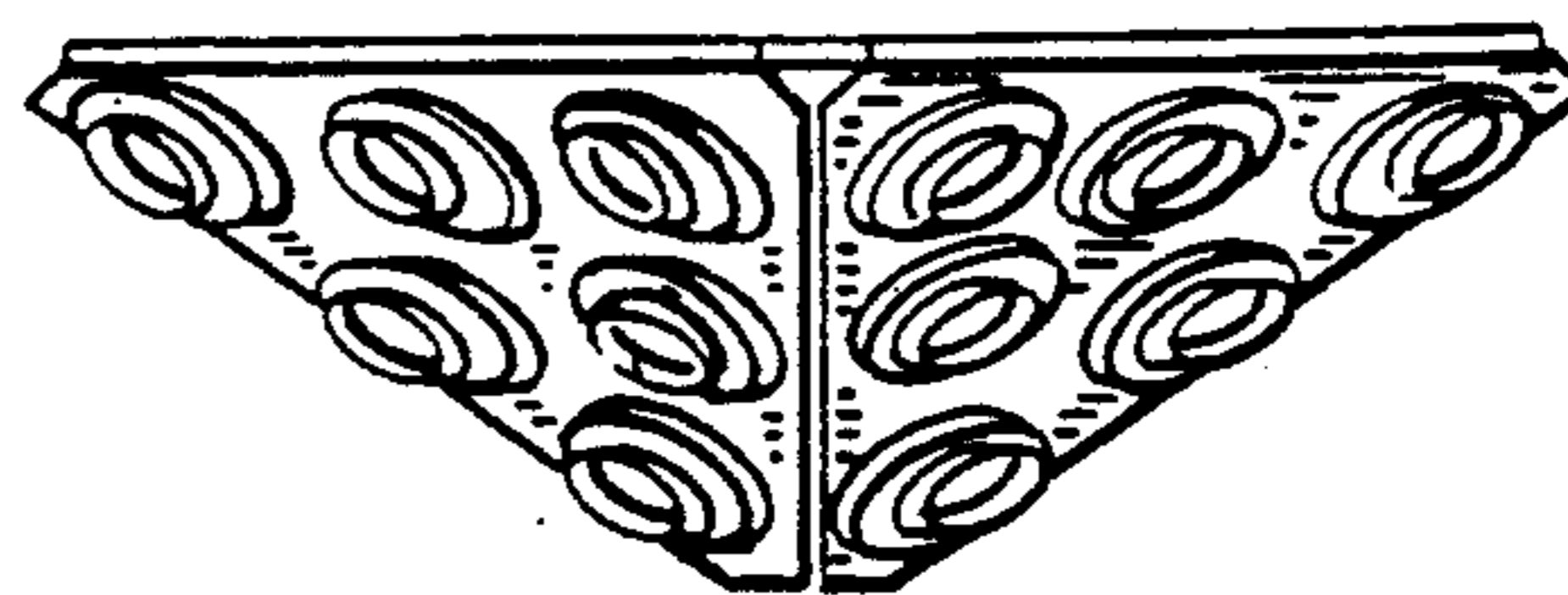
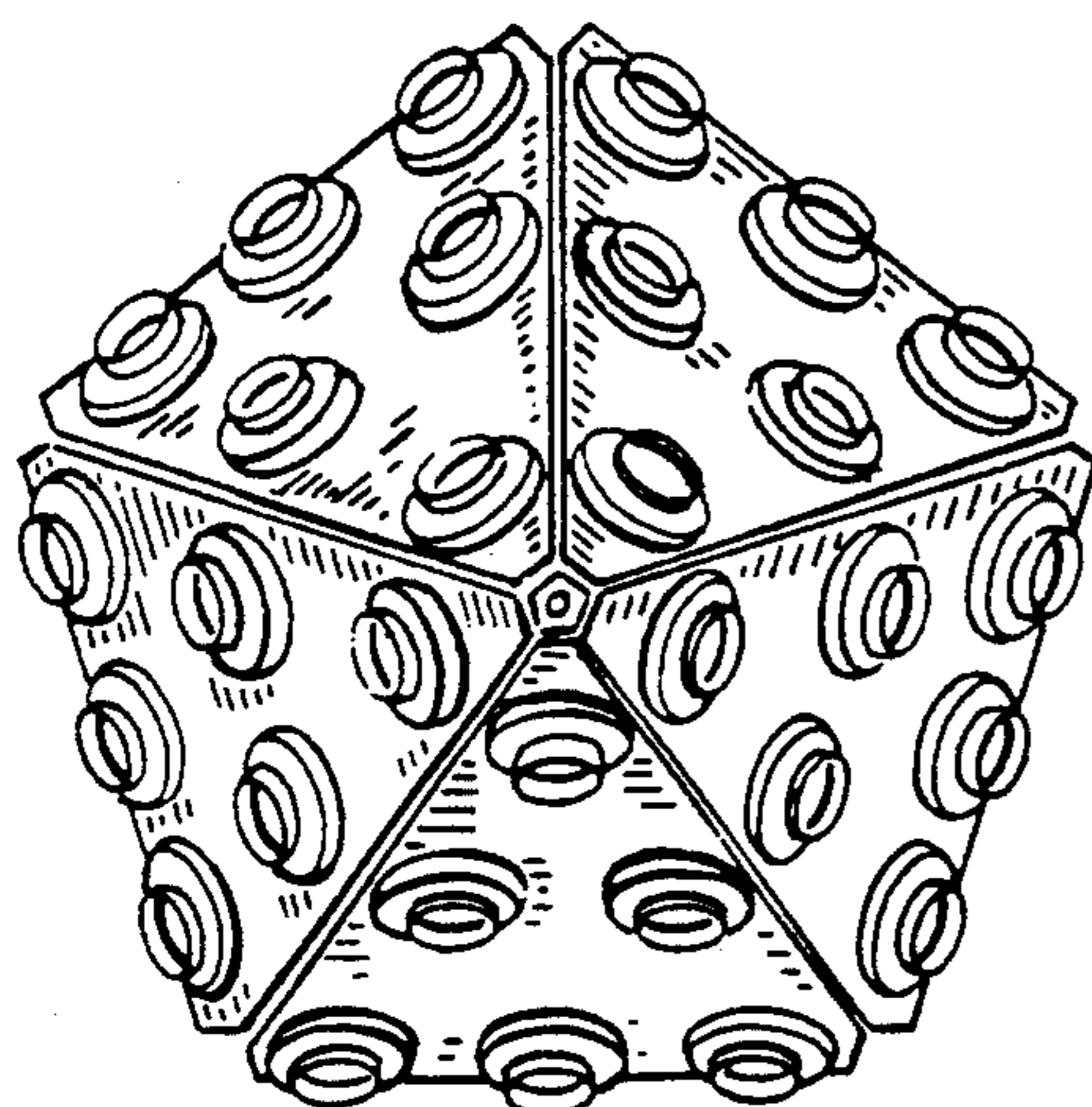

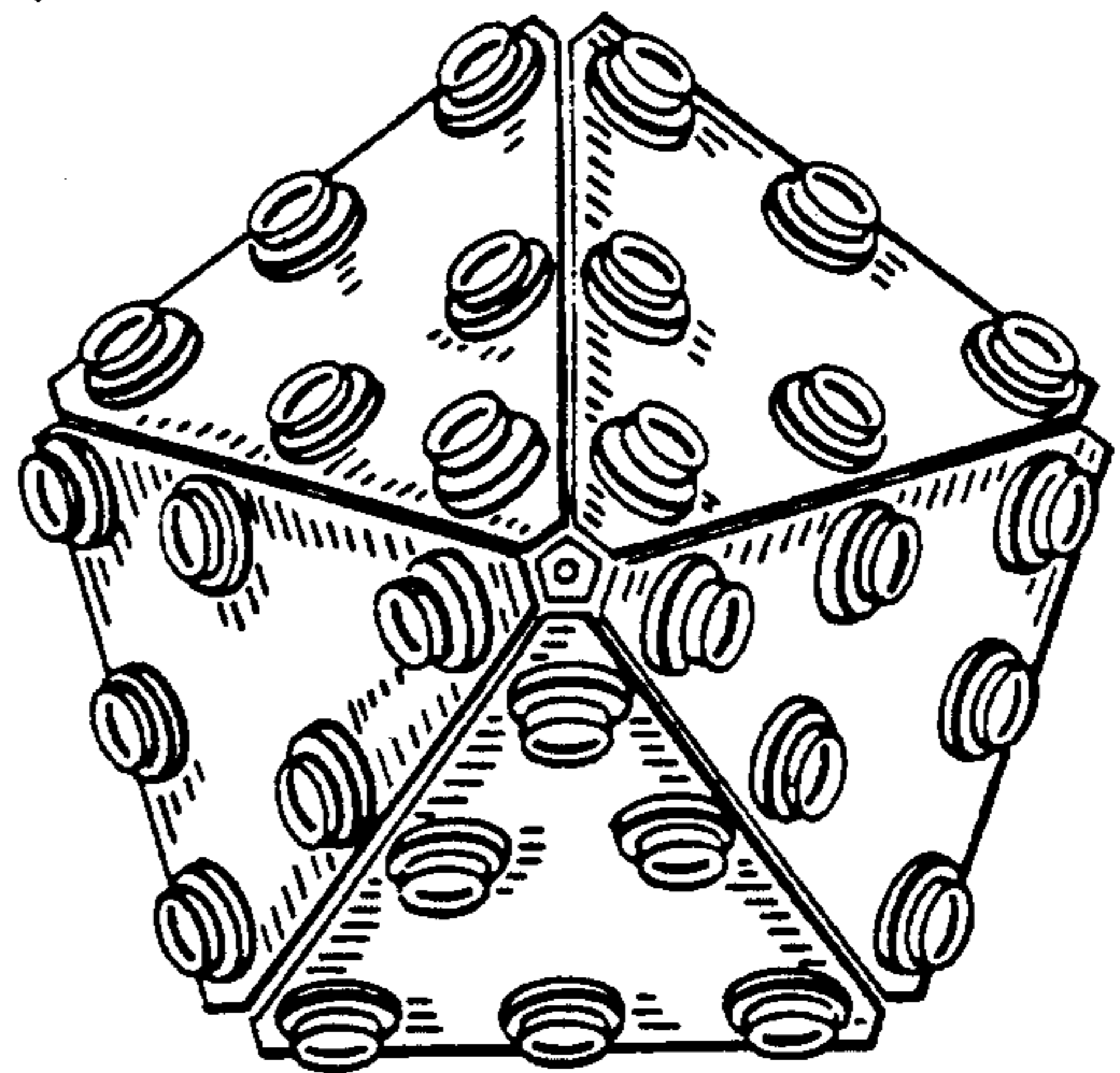

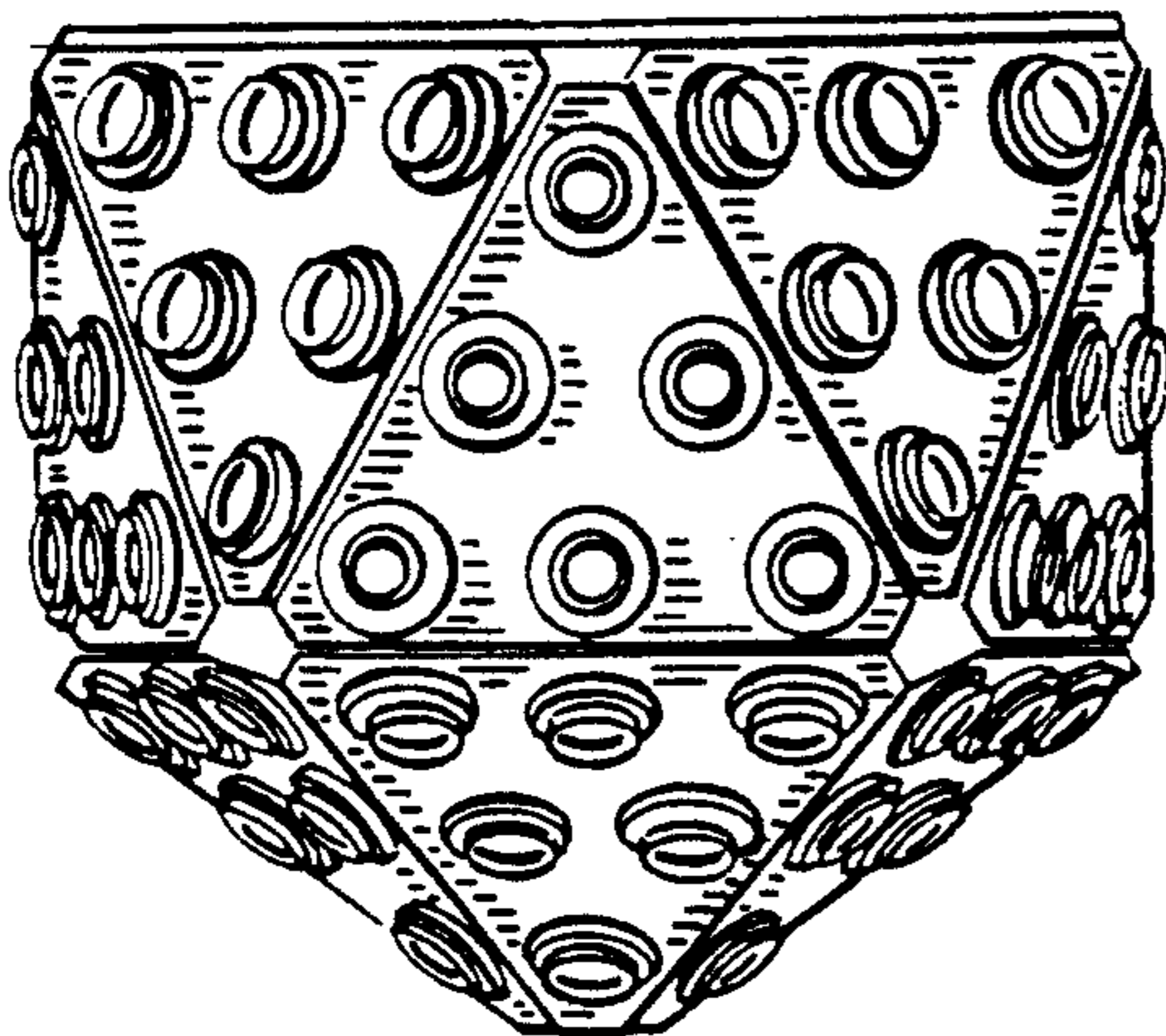

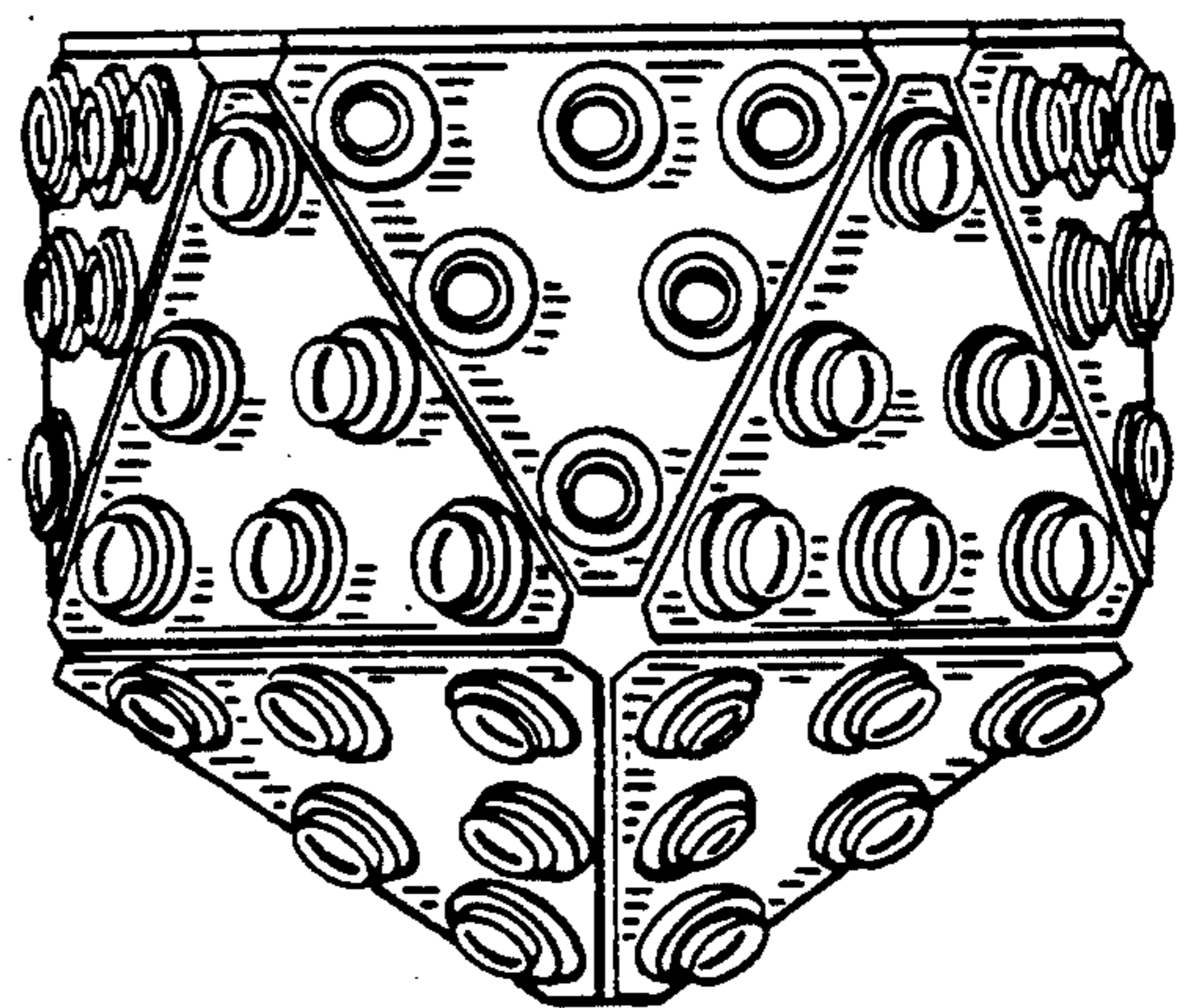

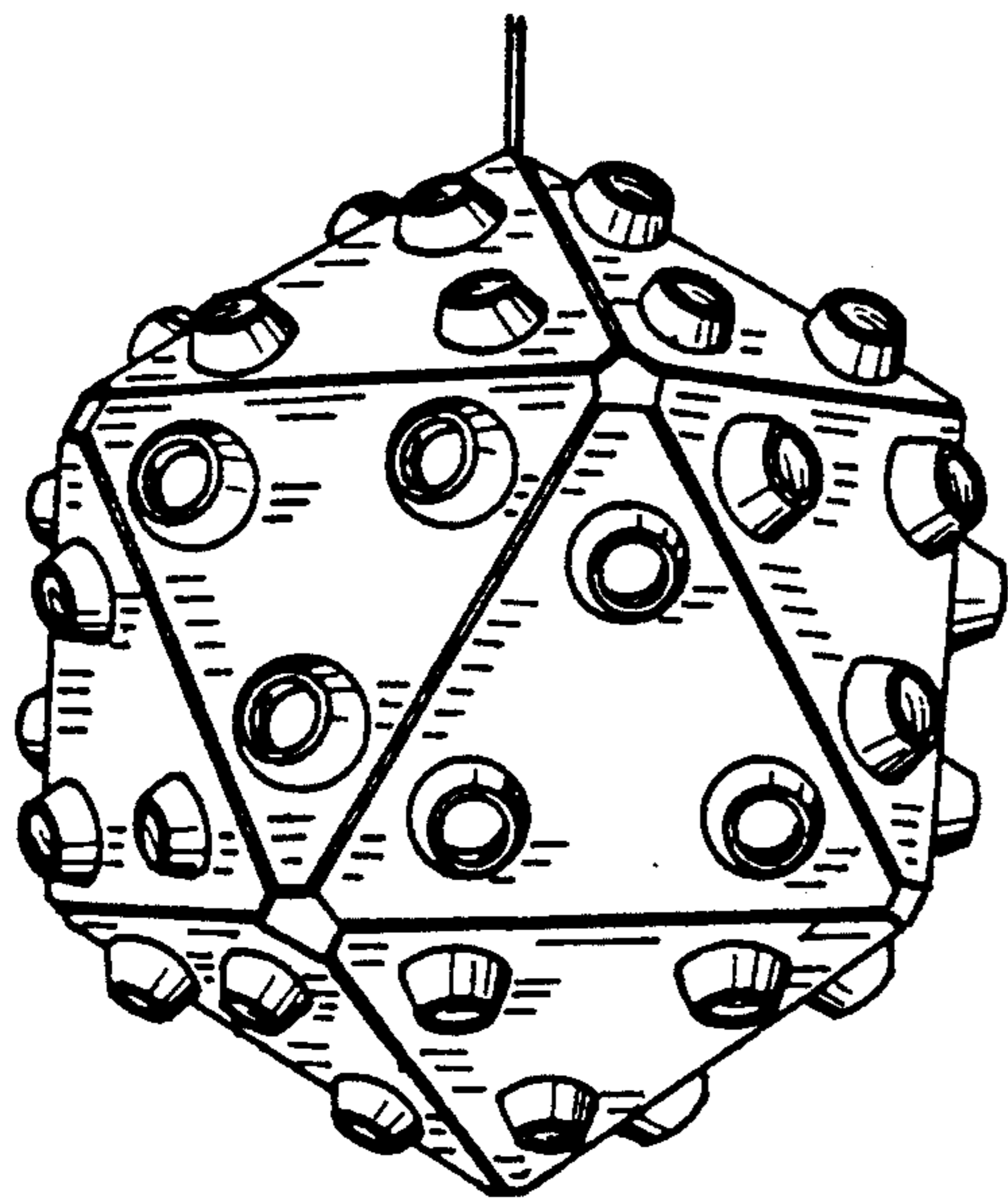

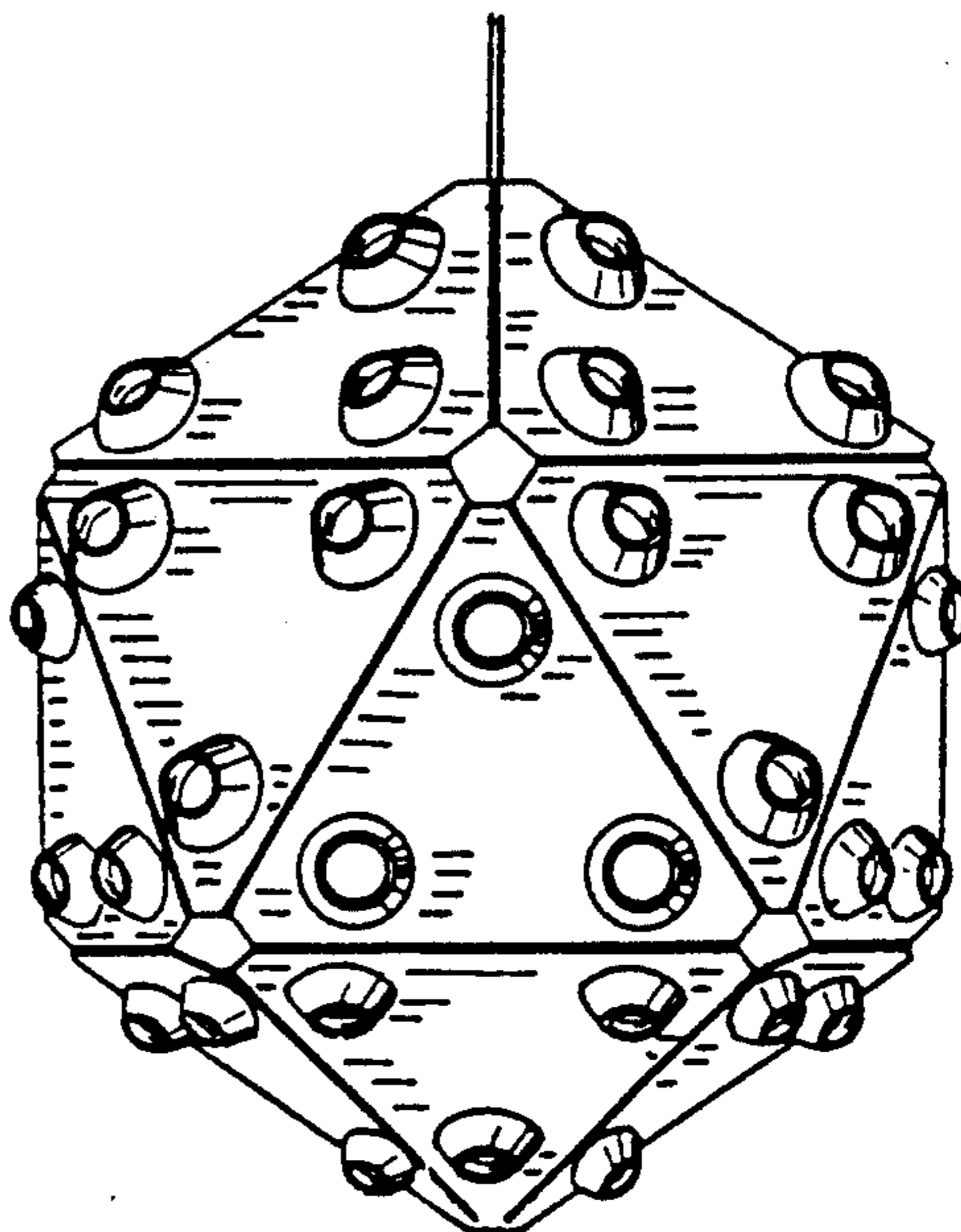

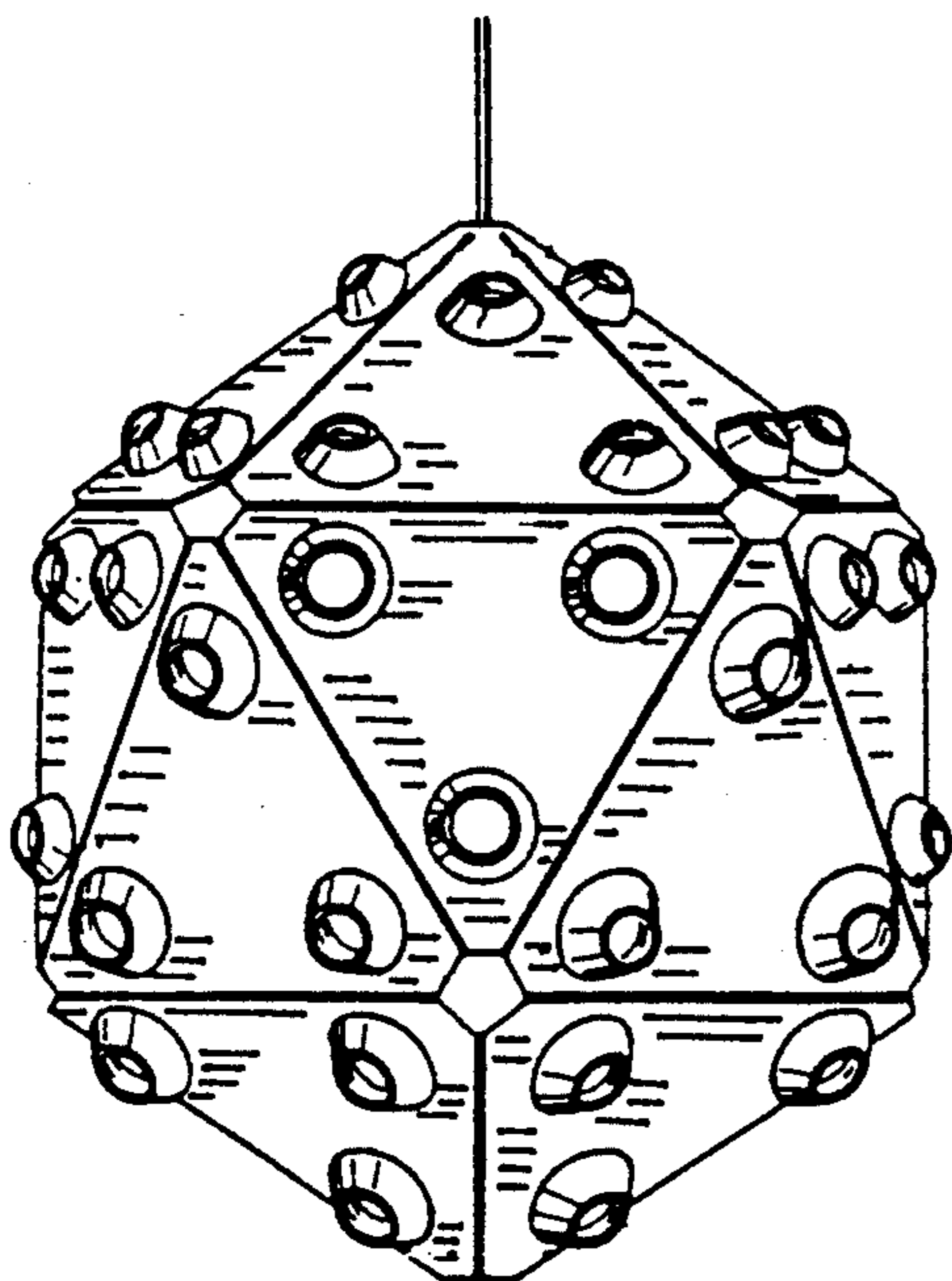

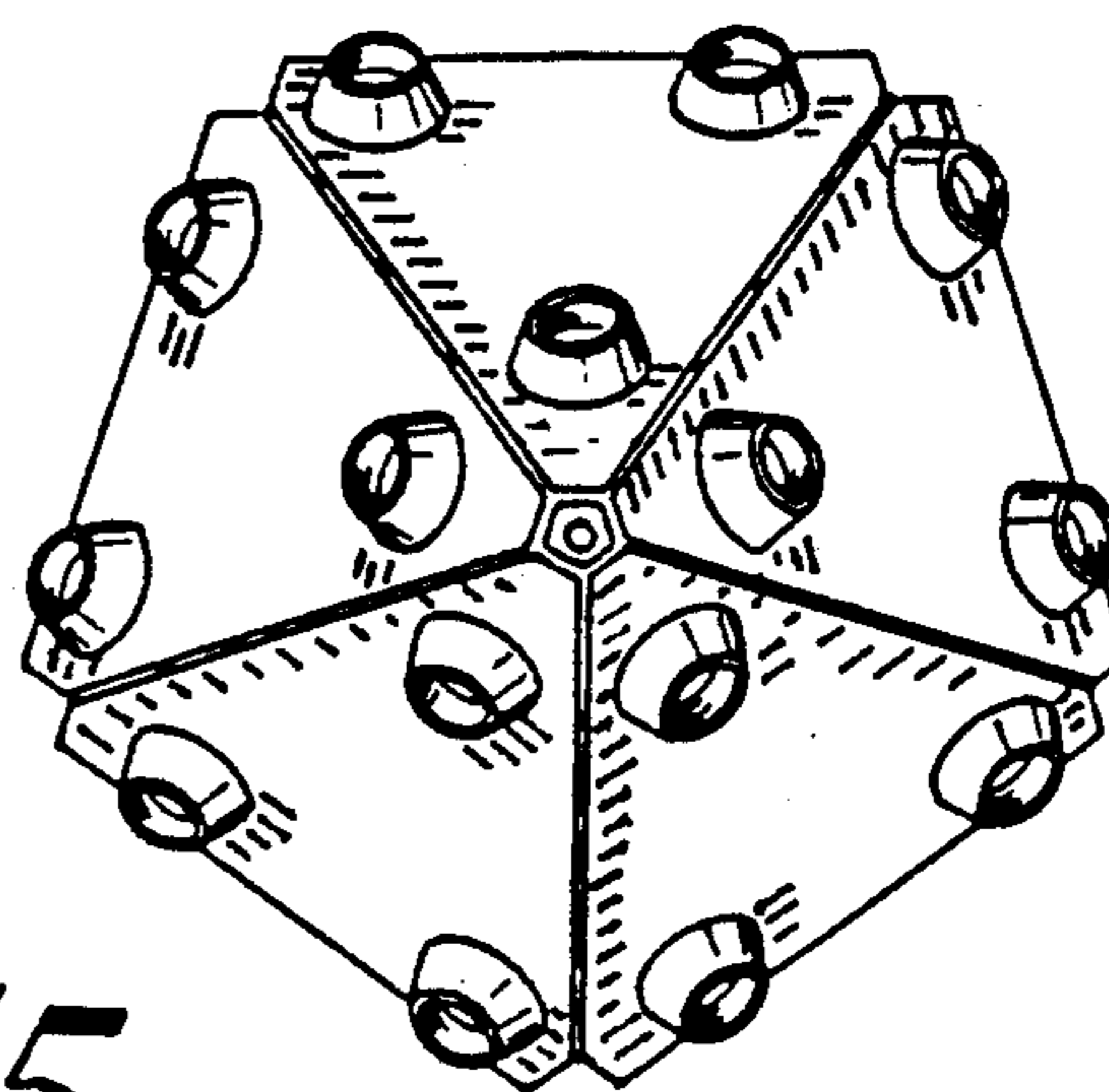

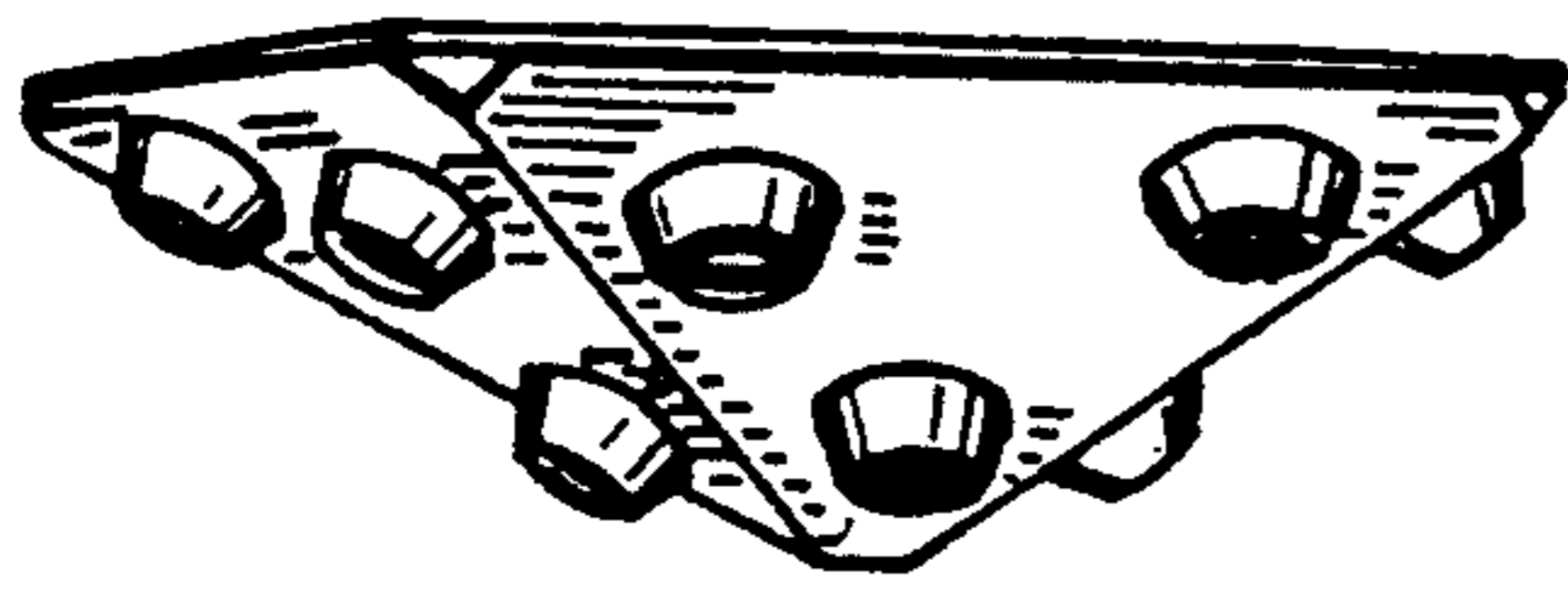

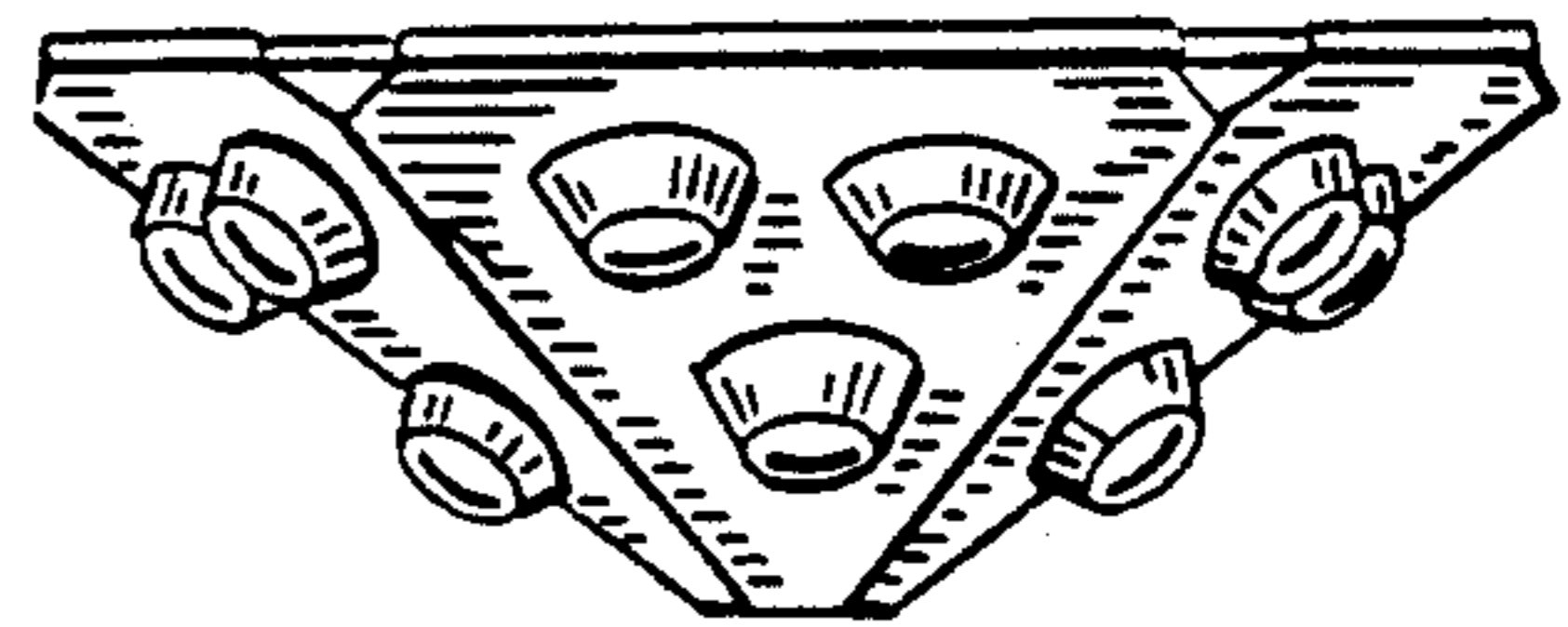

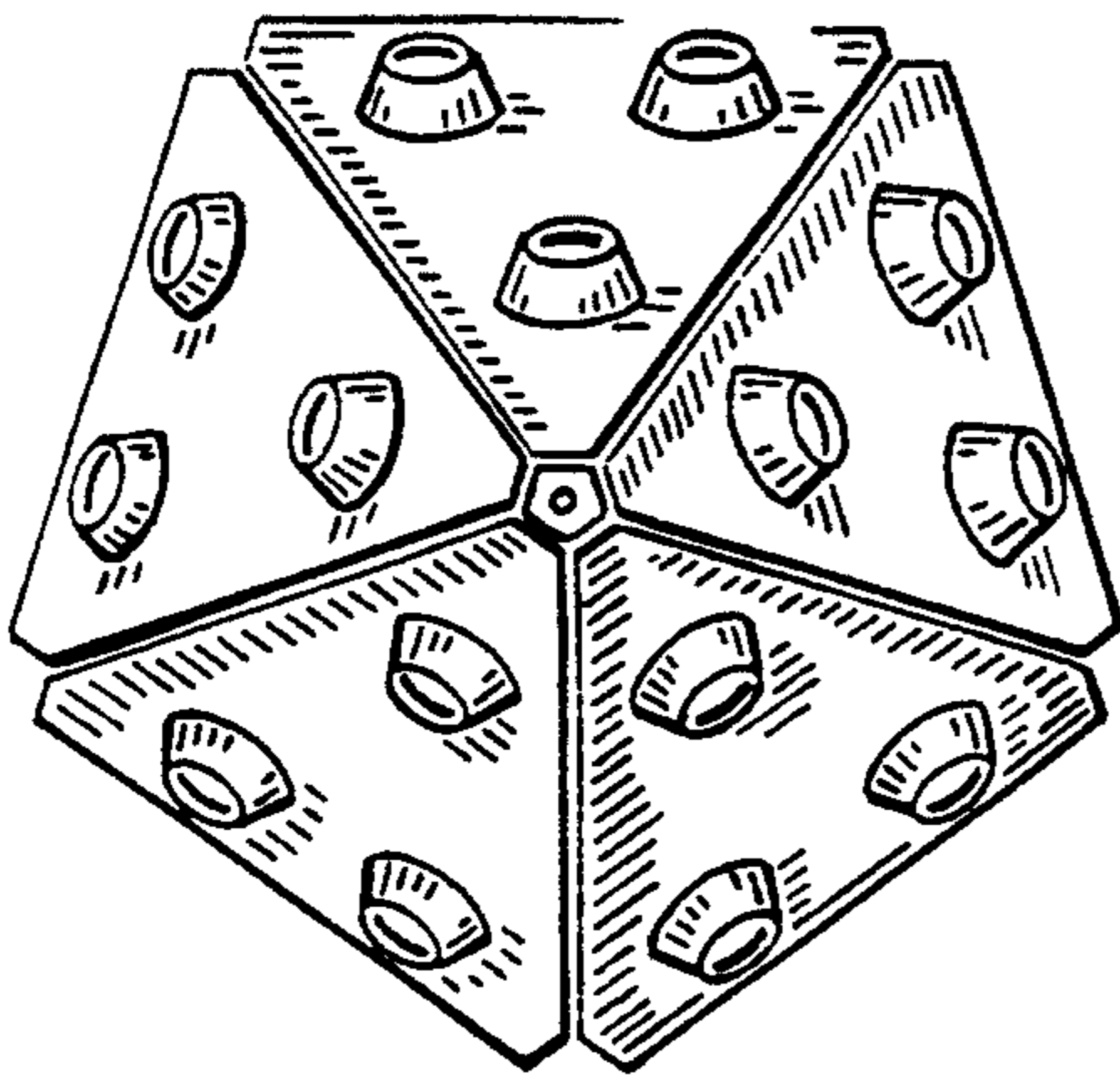

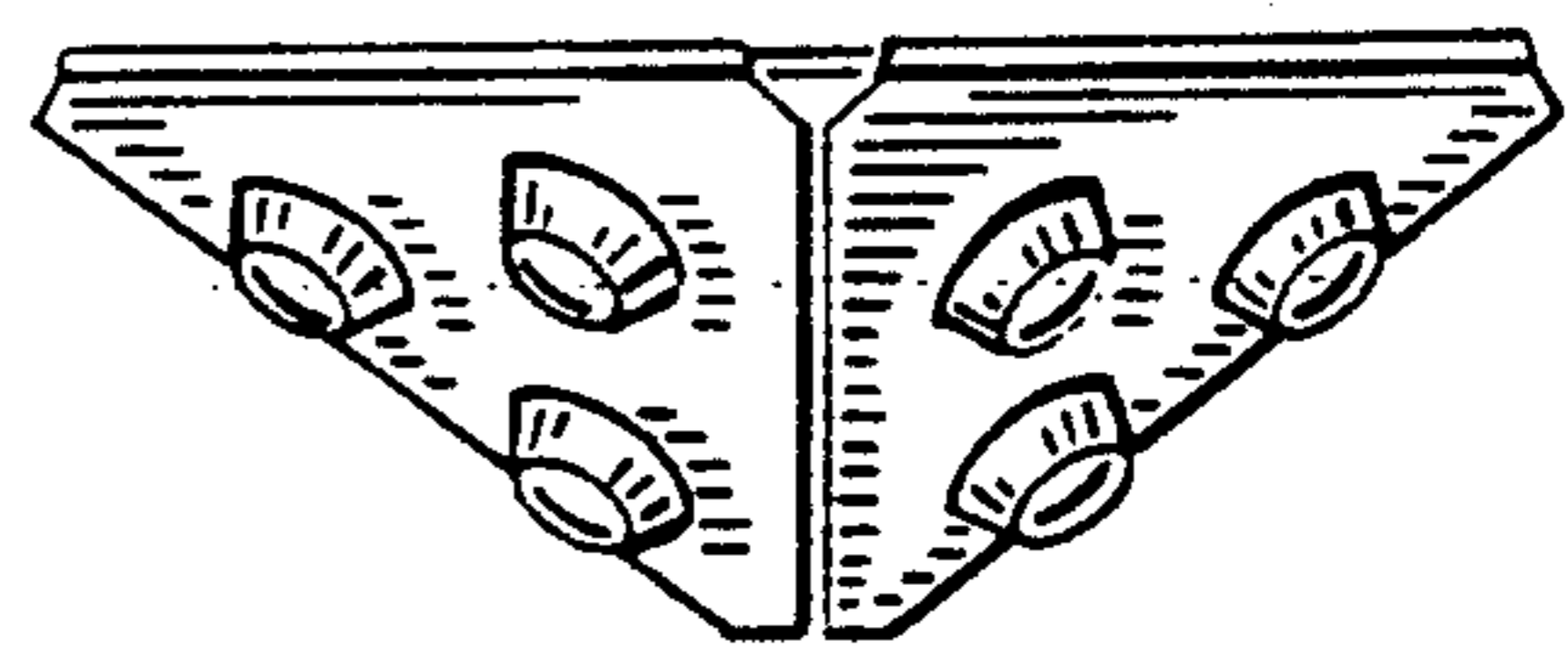

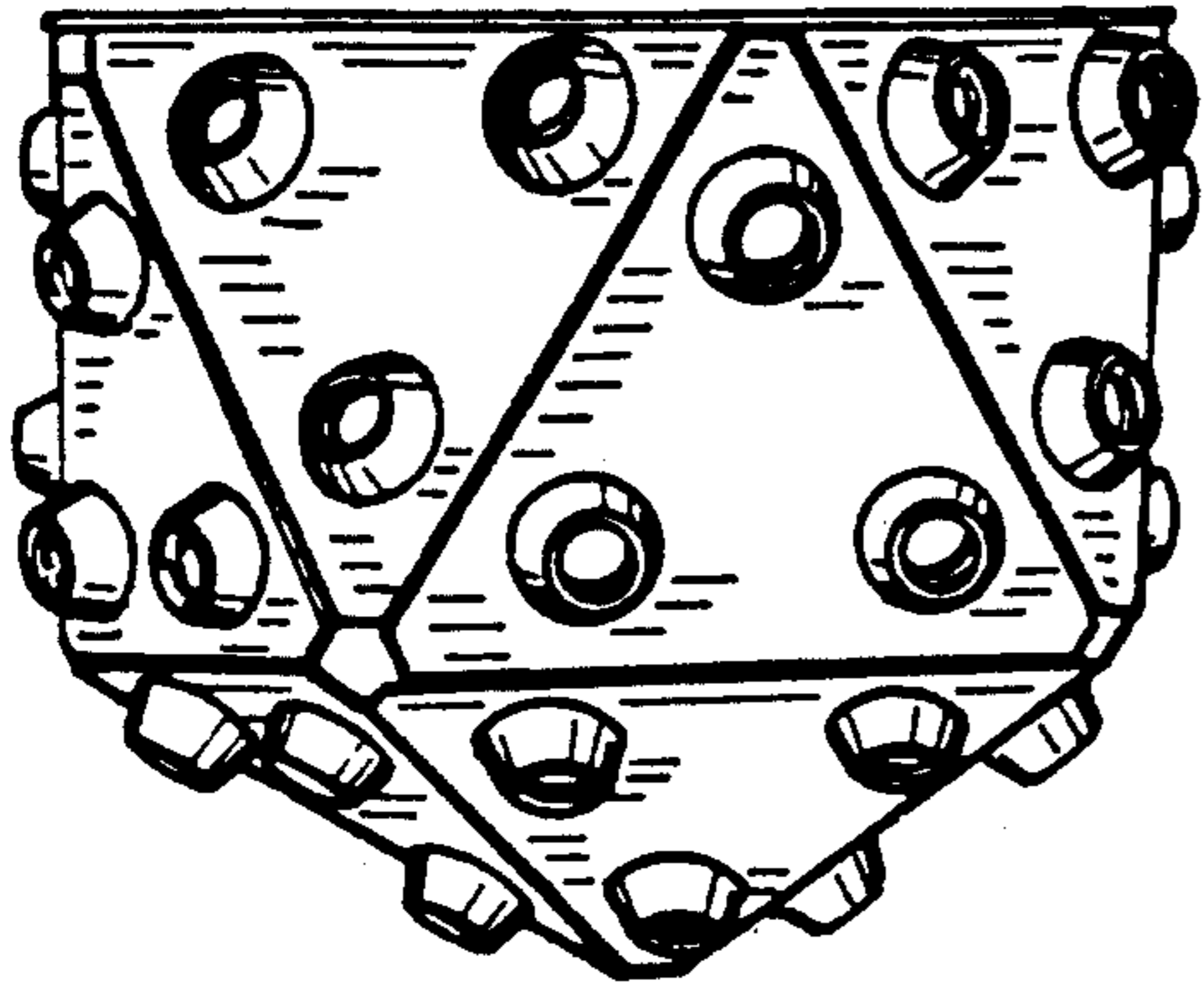

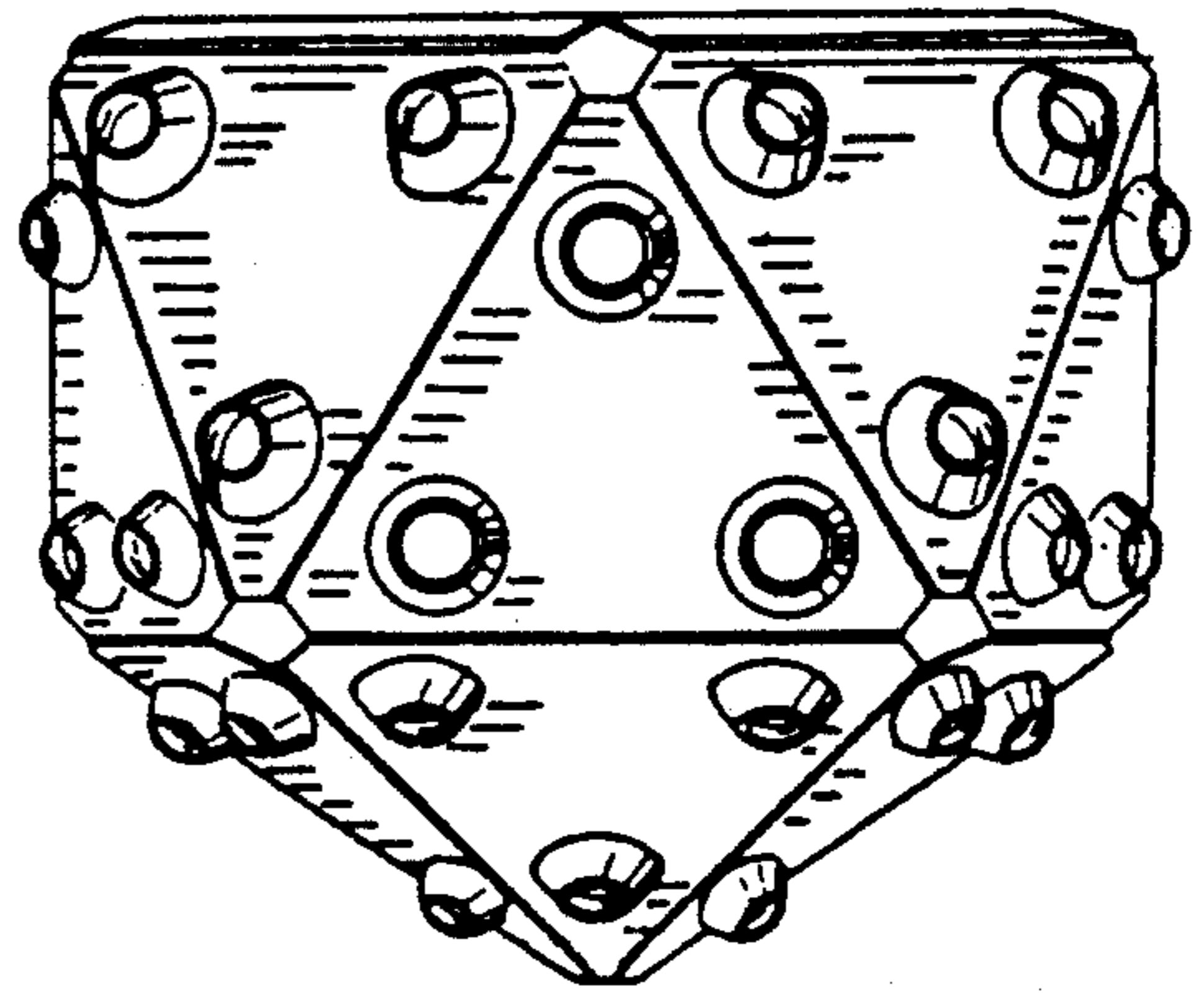

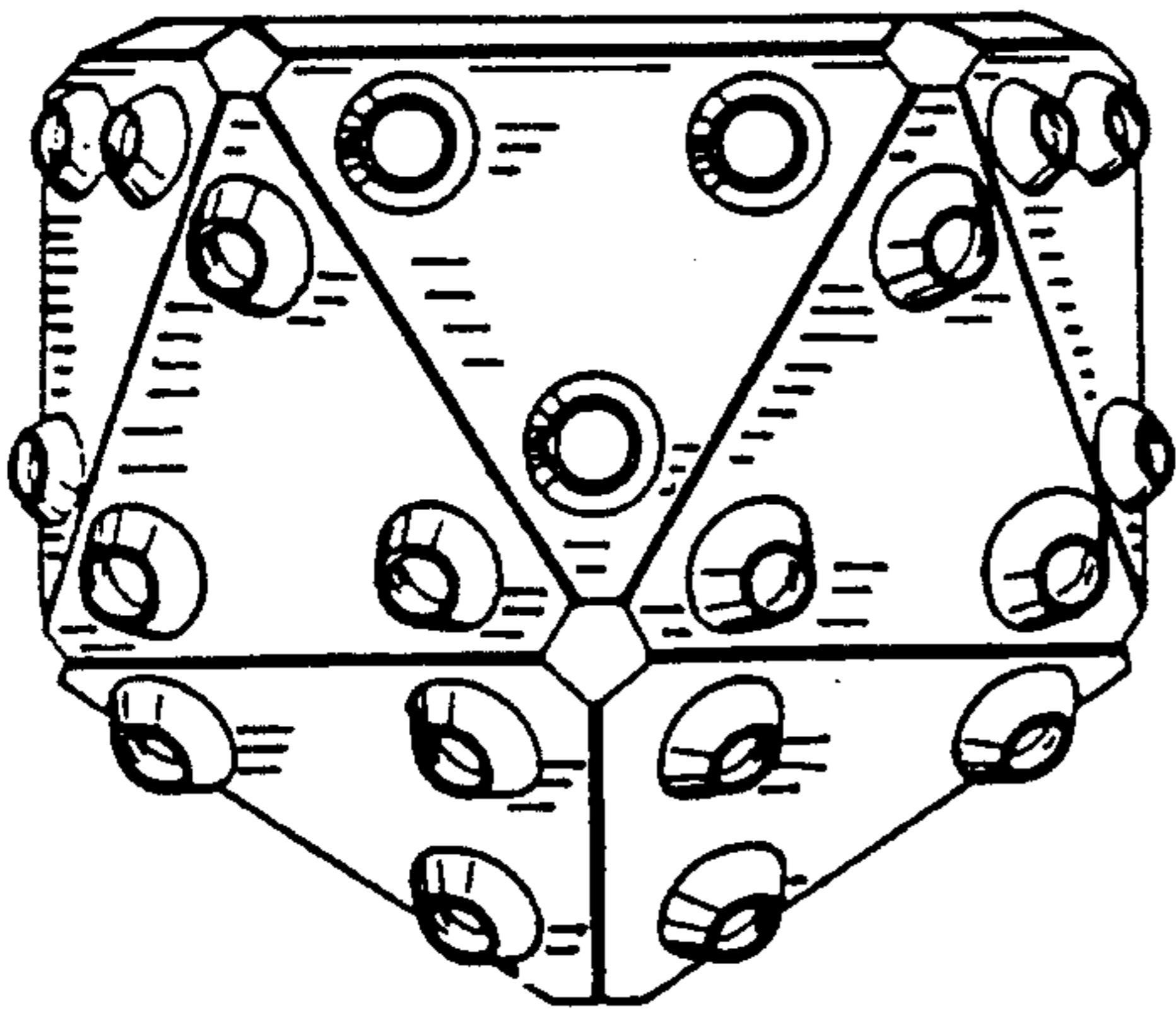

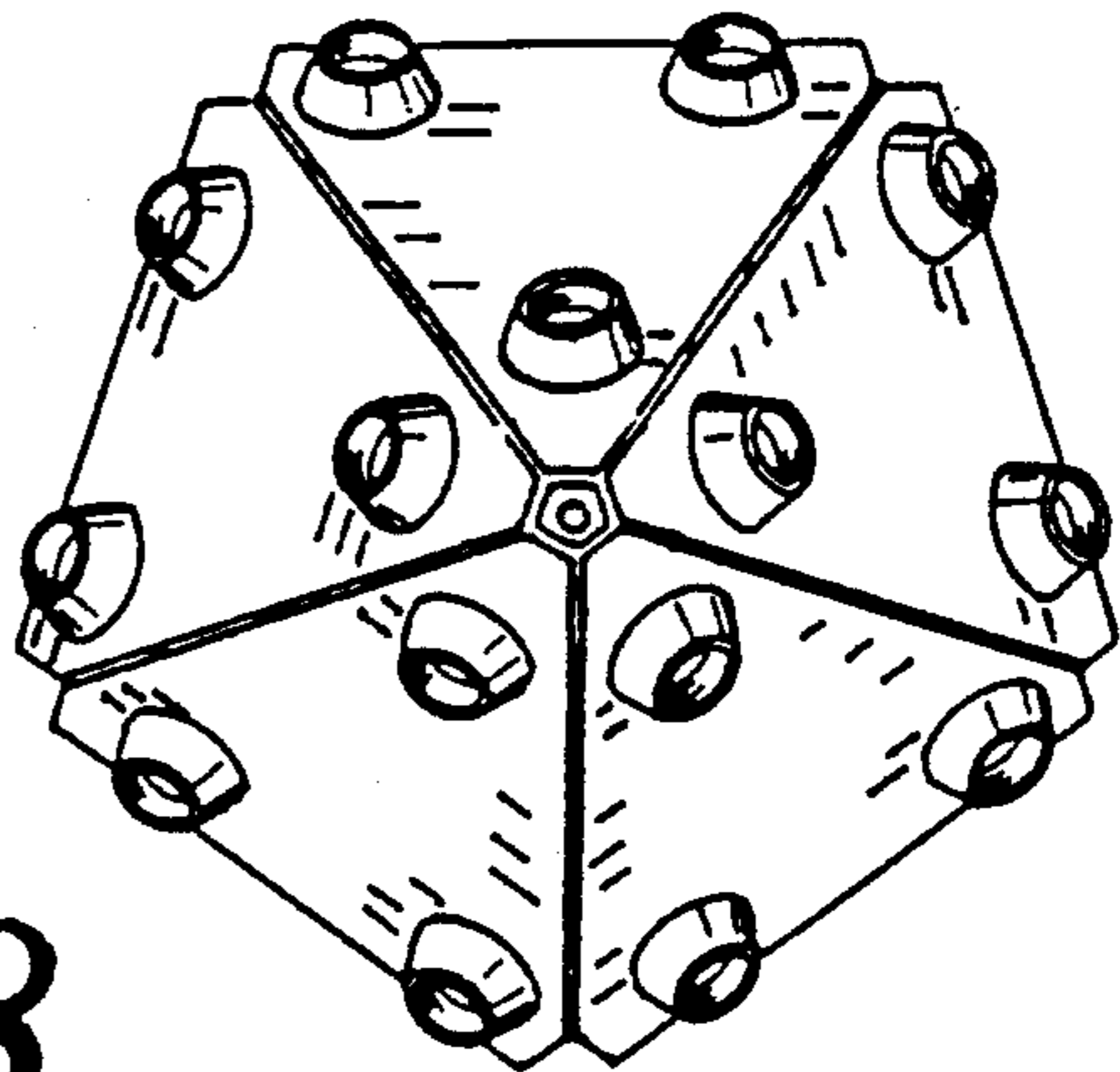
