FIG. 1 is a front elevational view of the vehicle tool box showing my new design;

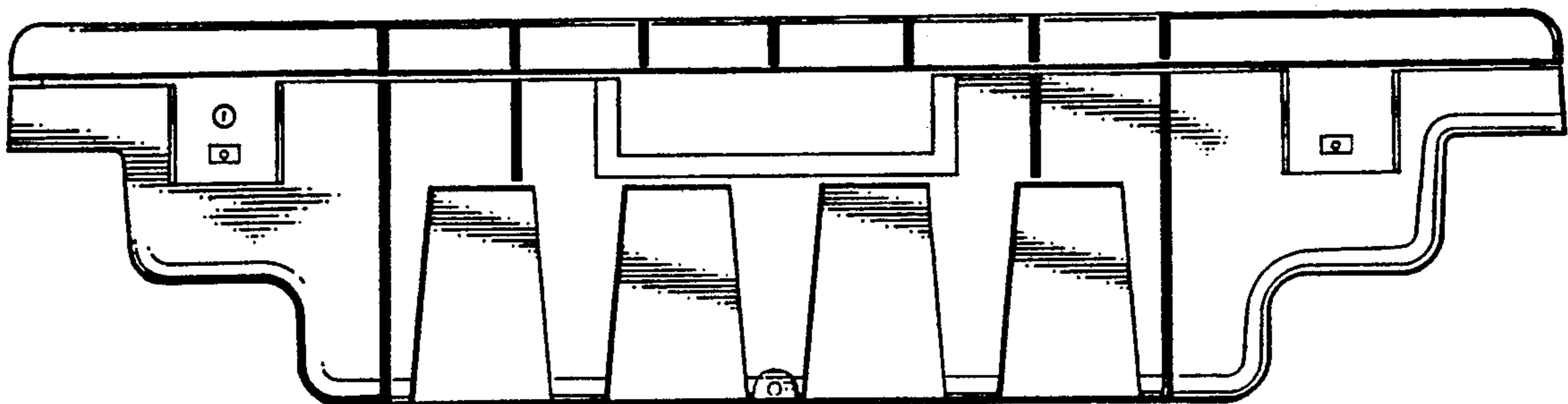
FIG. 2 is a rear elevational view thereof;

FIG. 6 is a left side elevational view thereof.



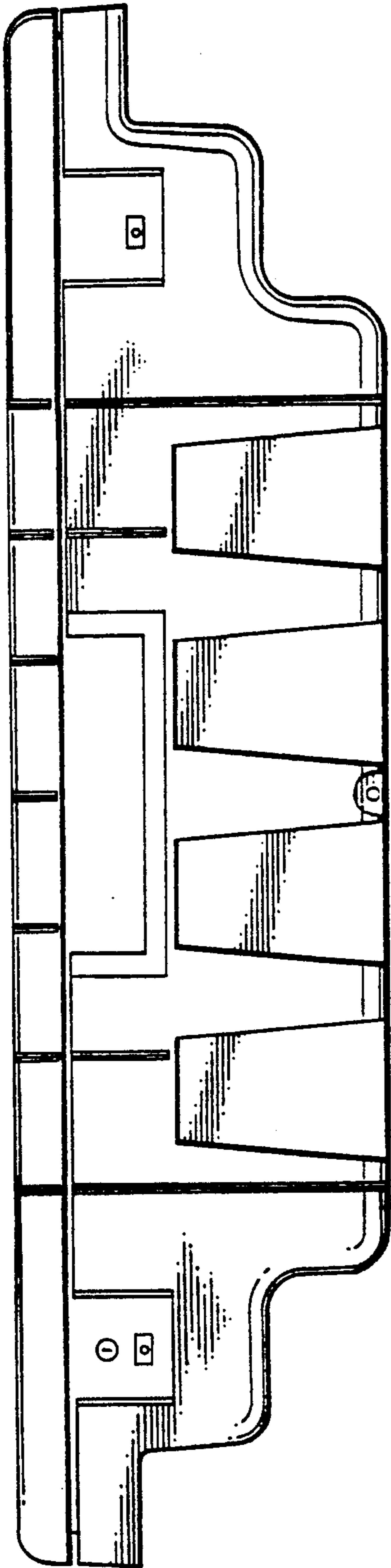

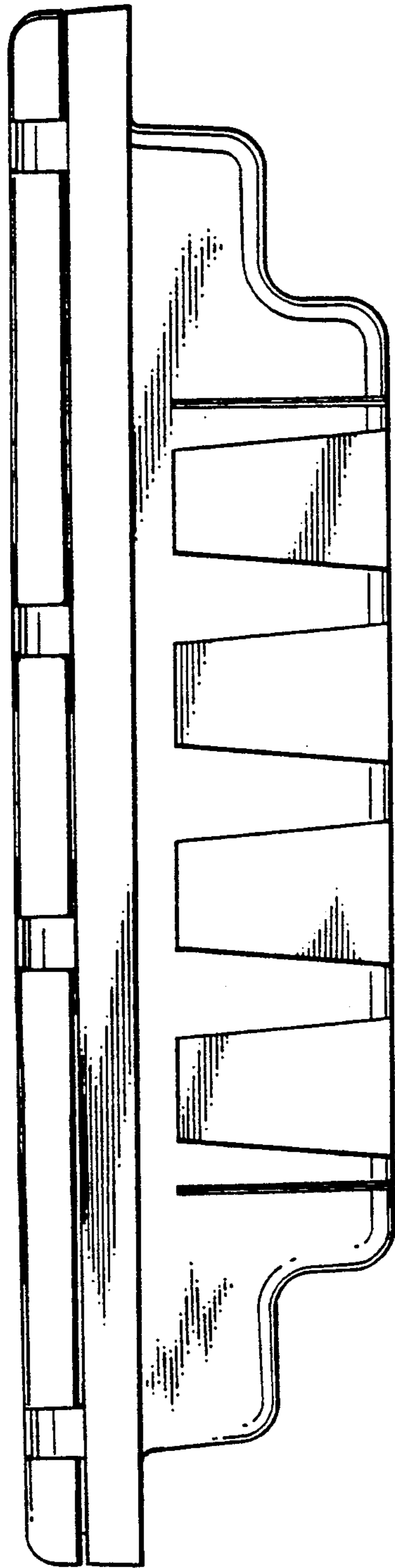

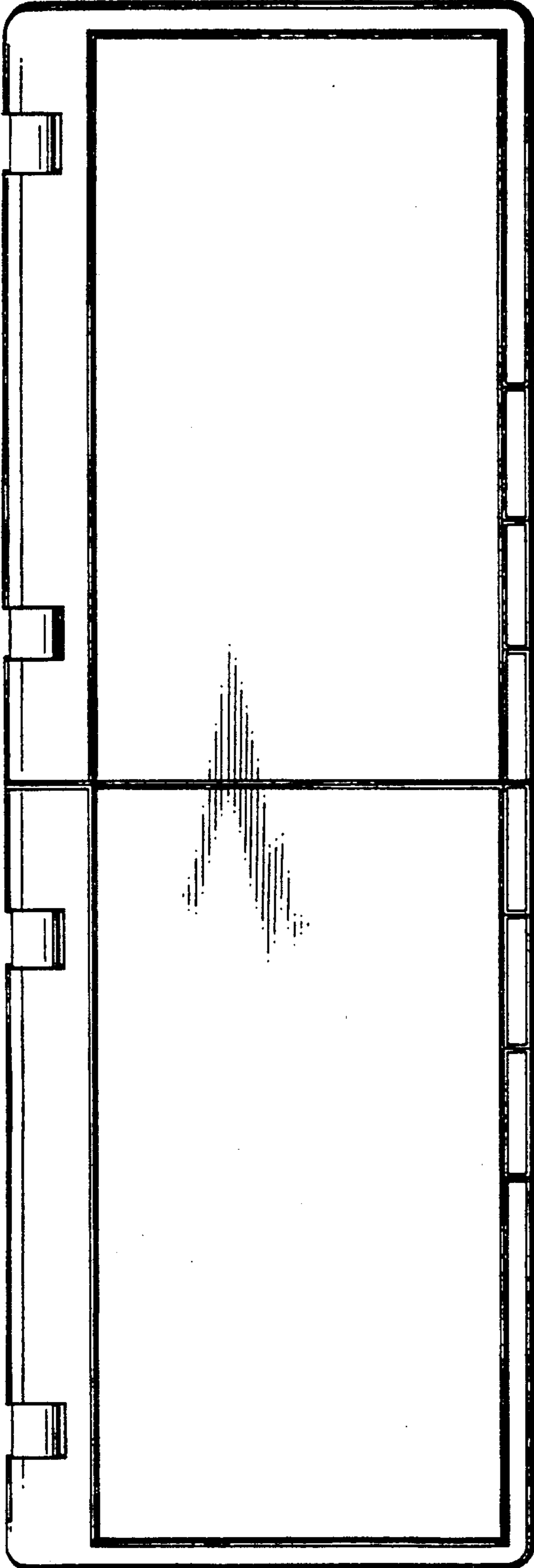

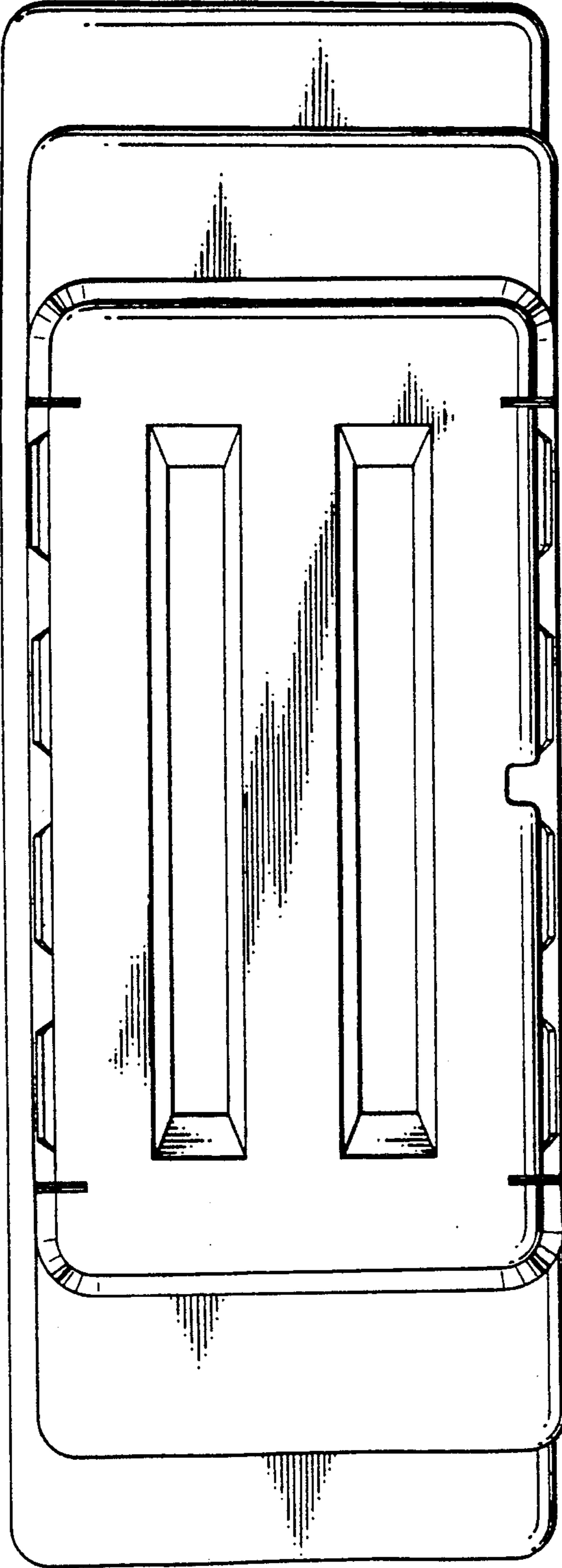

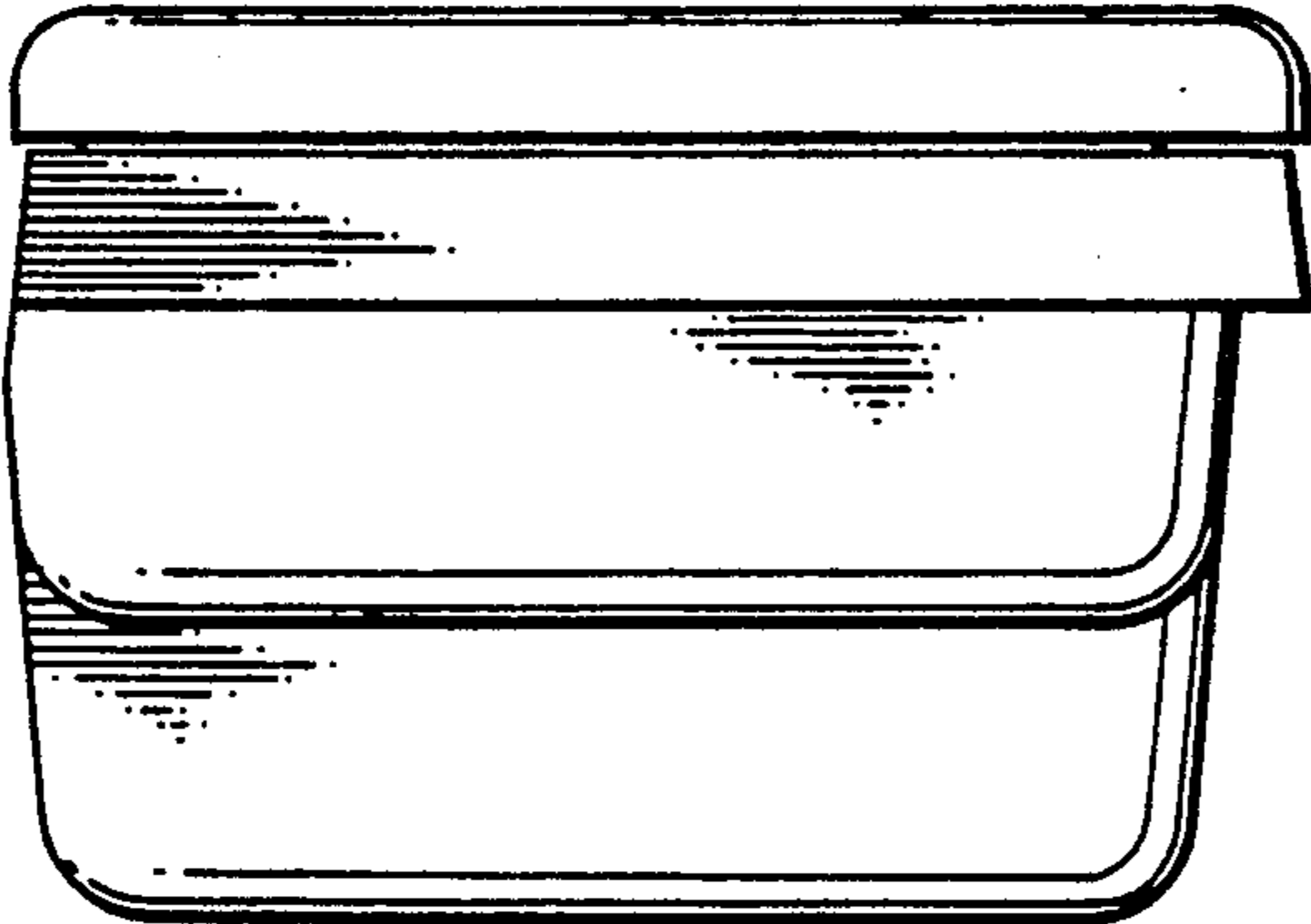

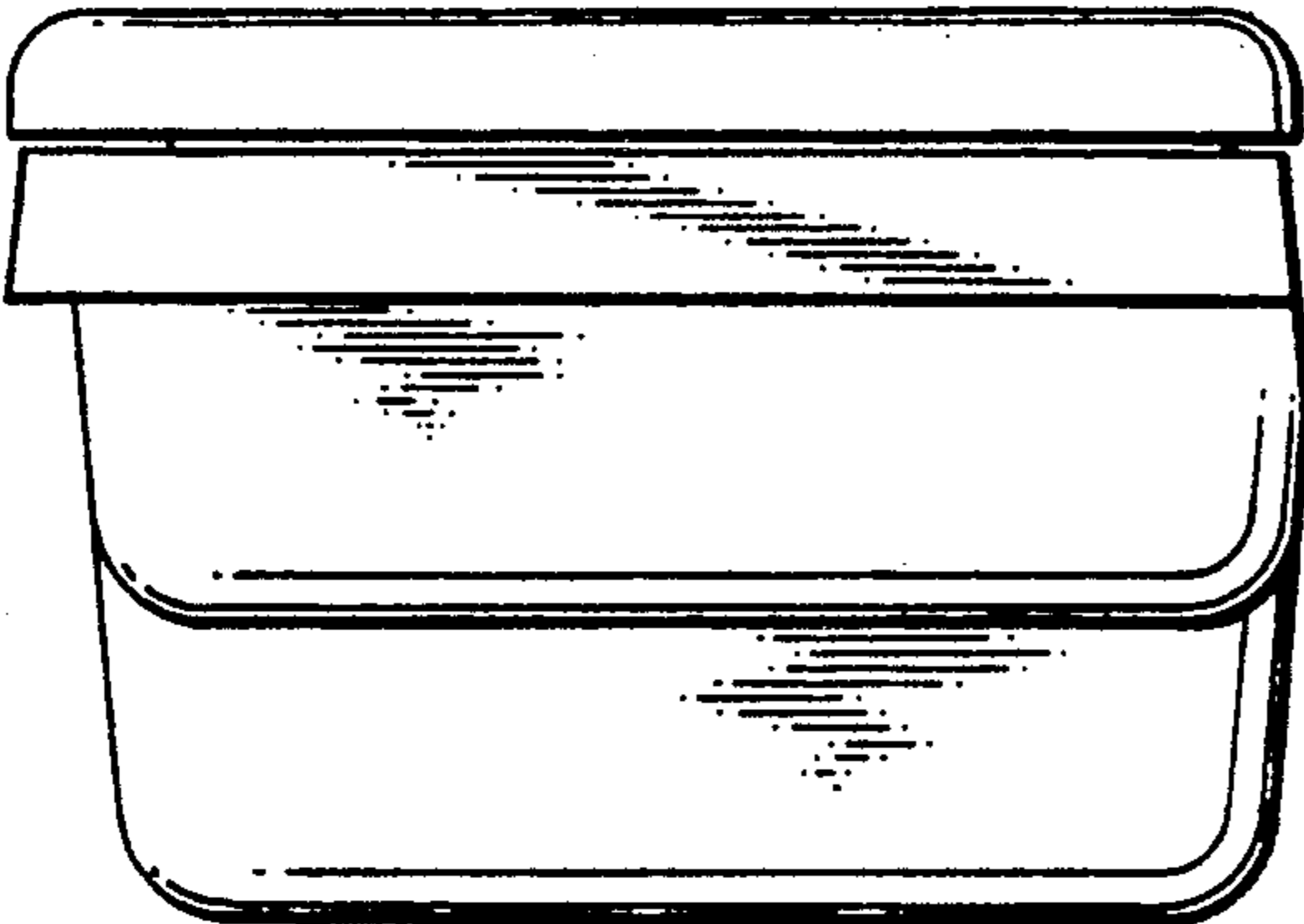
