The ornamental design for a camera, as shown and described.

DESCRIPTION

FIG. 1 is a front, side and top perspective view of a first embodiment of a camera showing our new design; FIG. 2 is a rear, top and side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is an end elevational view thereof from the left of FIG. 3; FIG. 8 is an end elevational view thereof from the right of FIG. 3; and FIG. 9 is a front, side and top perspective view of a second embodiment thereof; FIG. 10 is a rear, top and side perspective view of FIG. 9; FIG. 11 is a front elevational view of FIG. 9; FIG. 12 is a rear elevational view of FIG. 9; FIG. 13 is a top plan view of FIG. 9; FIG. 14 is a bottom plan view of FIG. 9; FIG. 15 is a left side elevational view of FIG. 11; and FIG. 16 is a right side elevational view of FIG. 11.

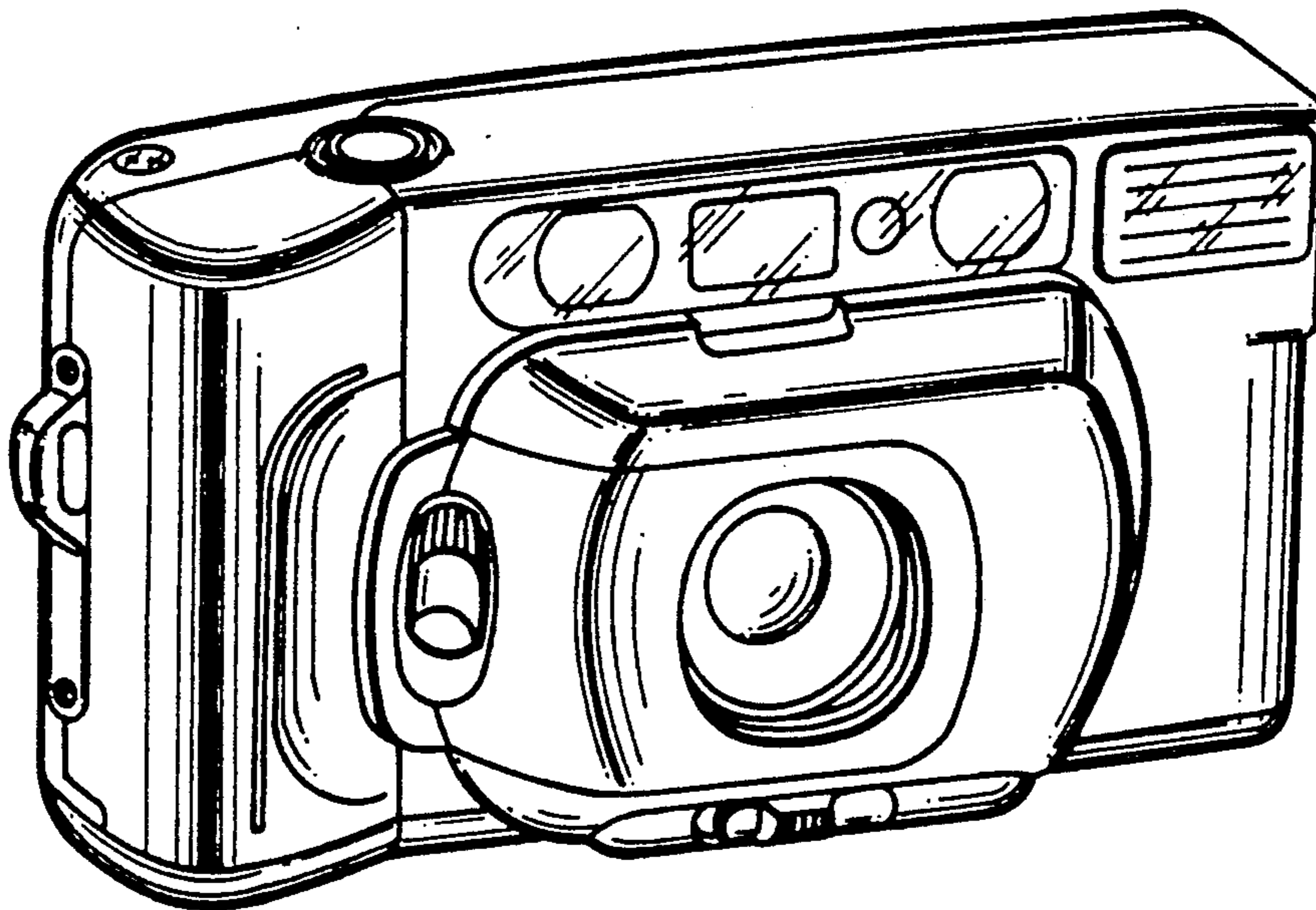

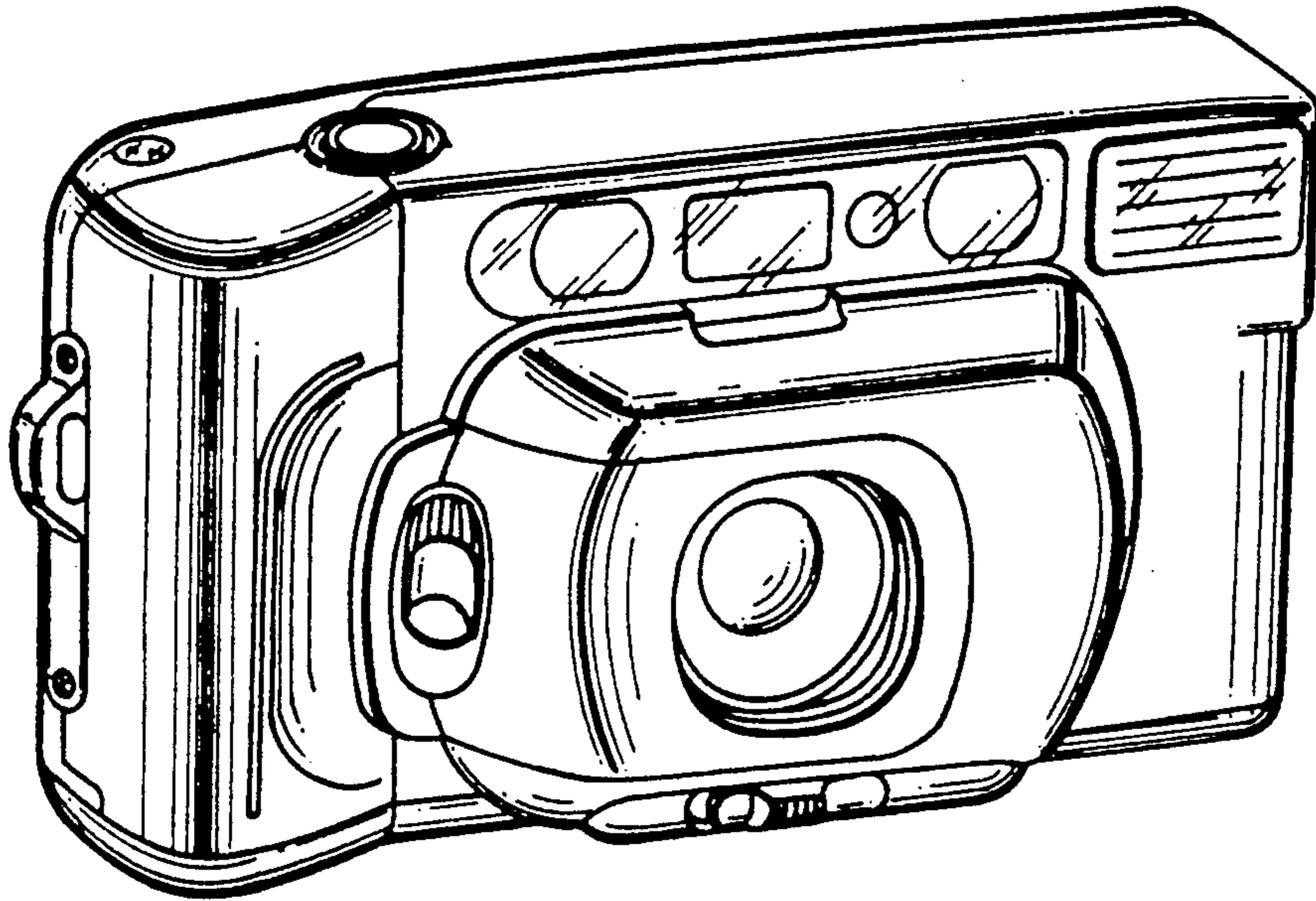

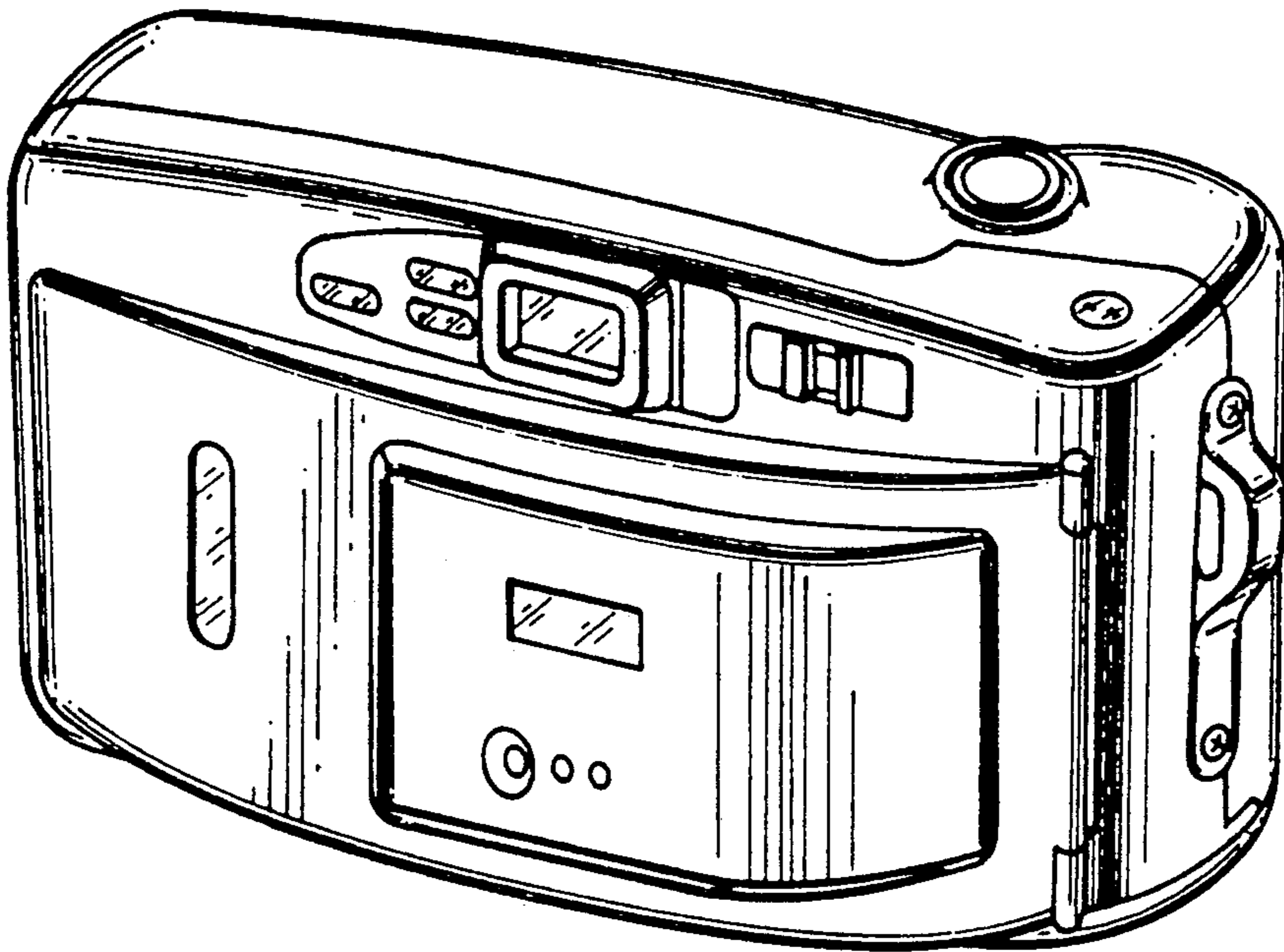

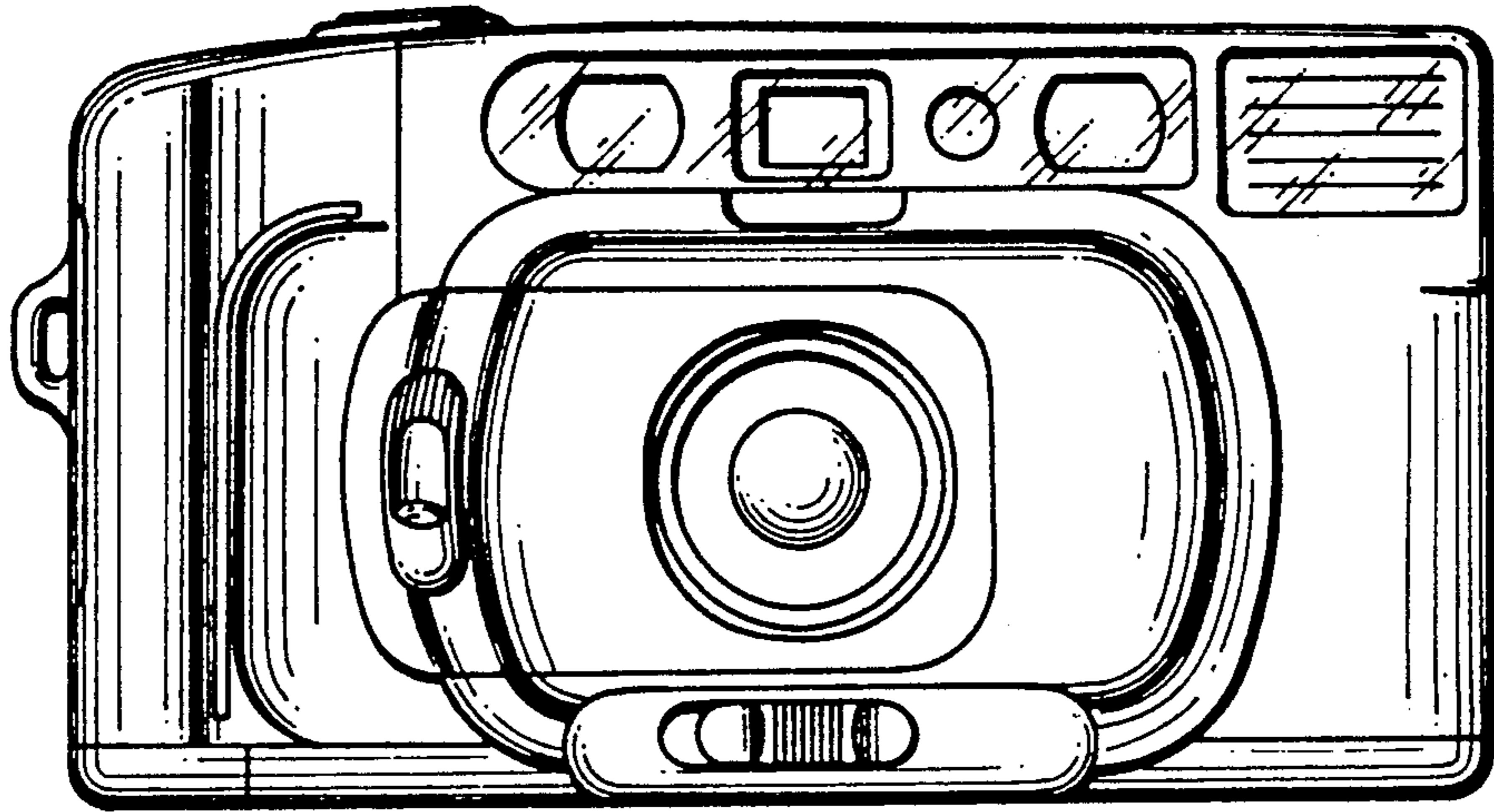

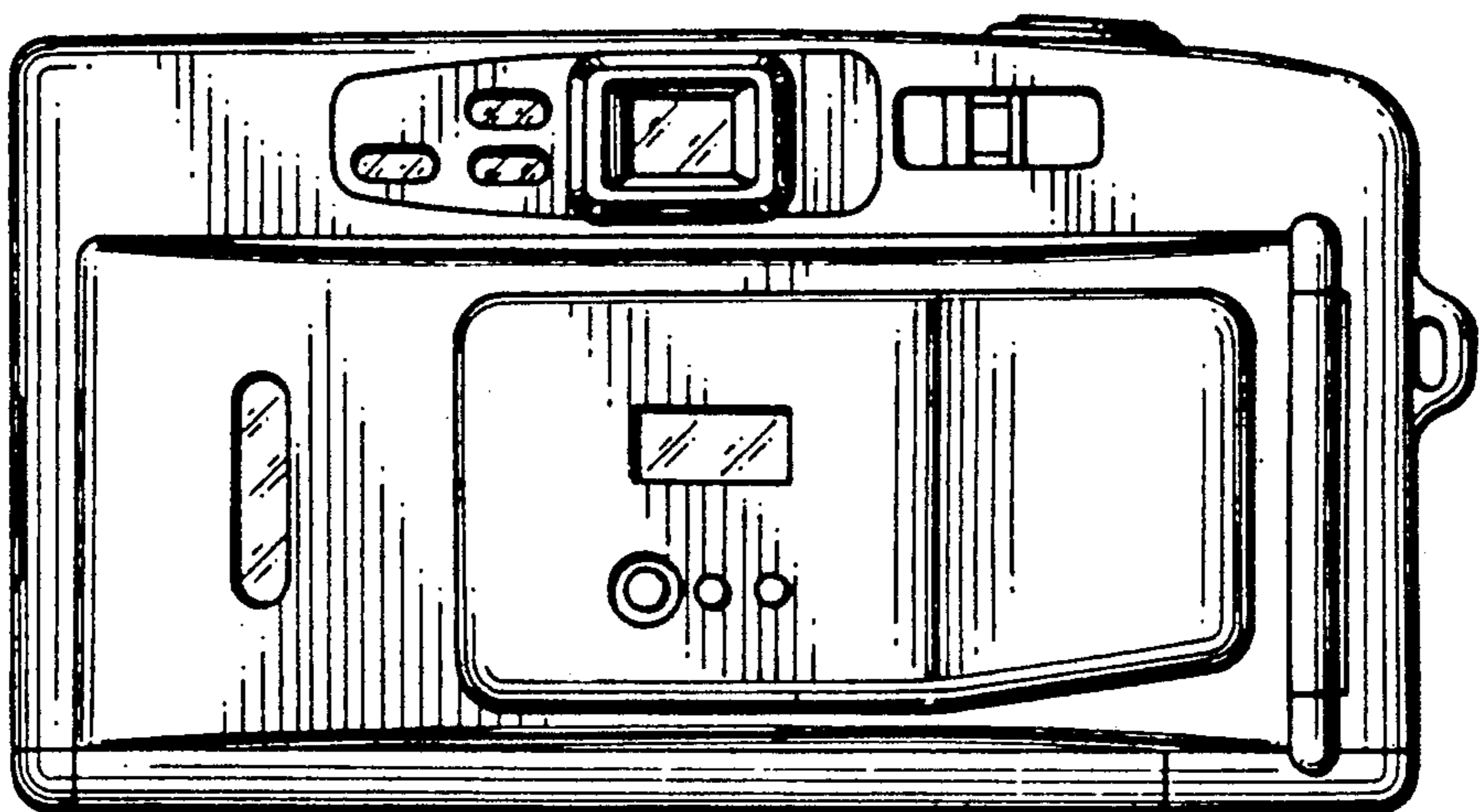

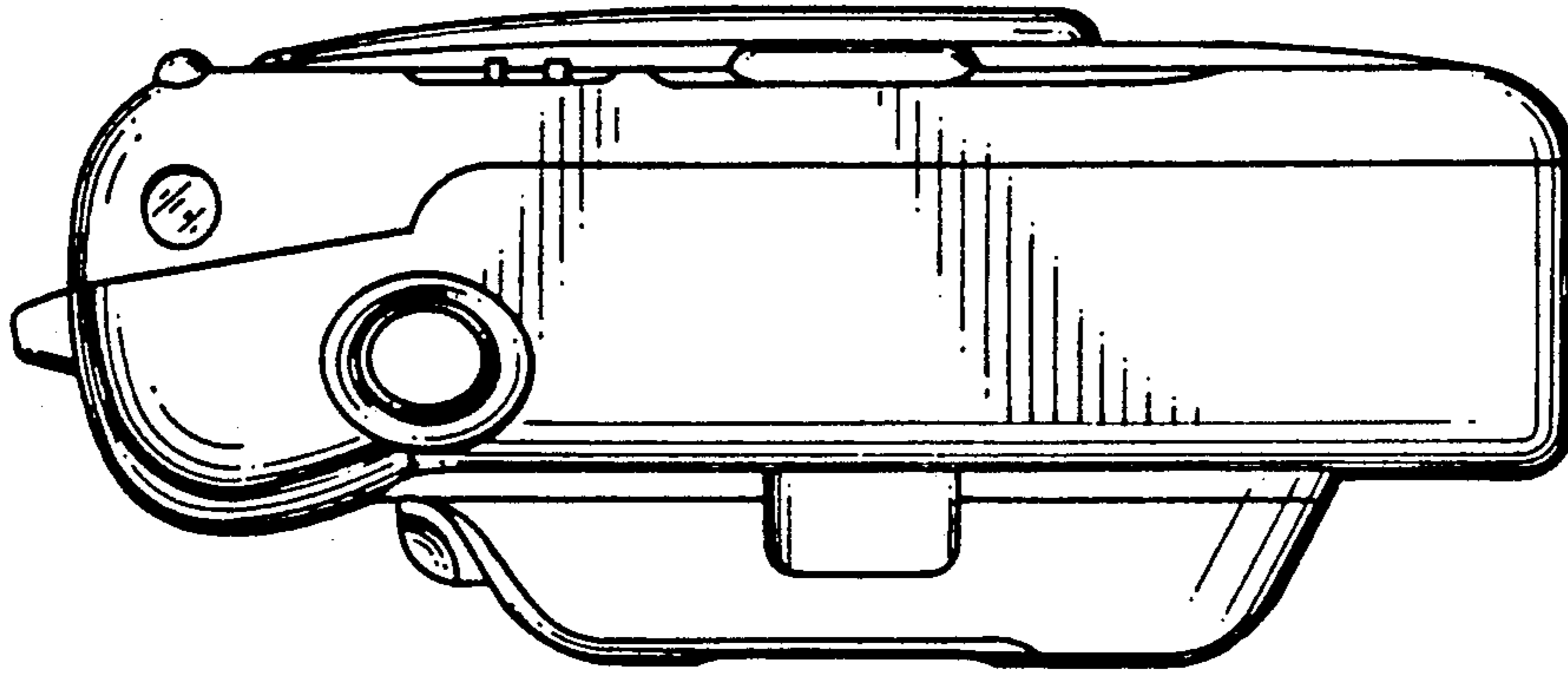

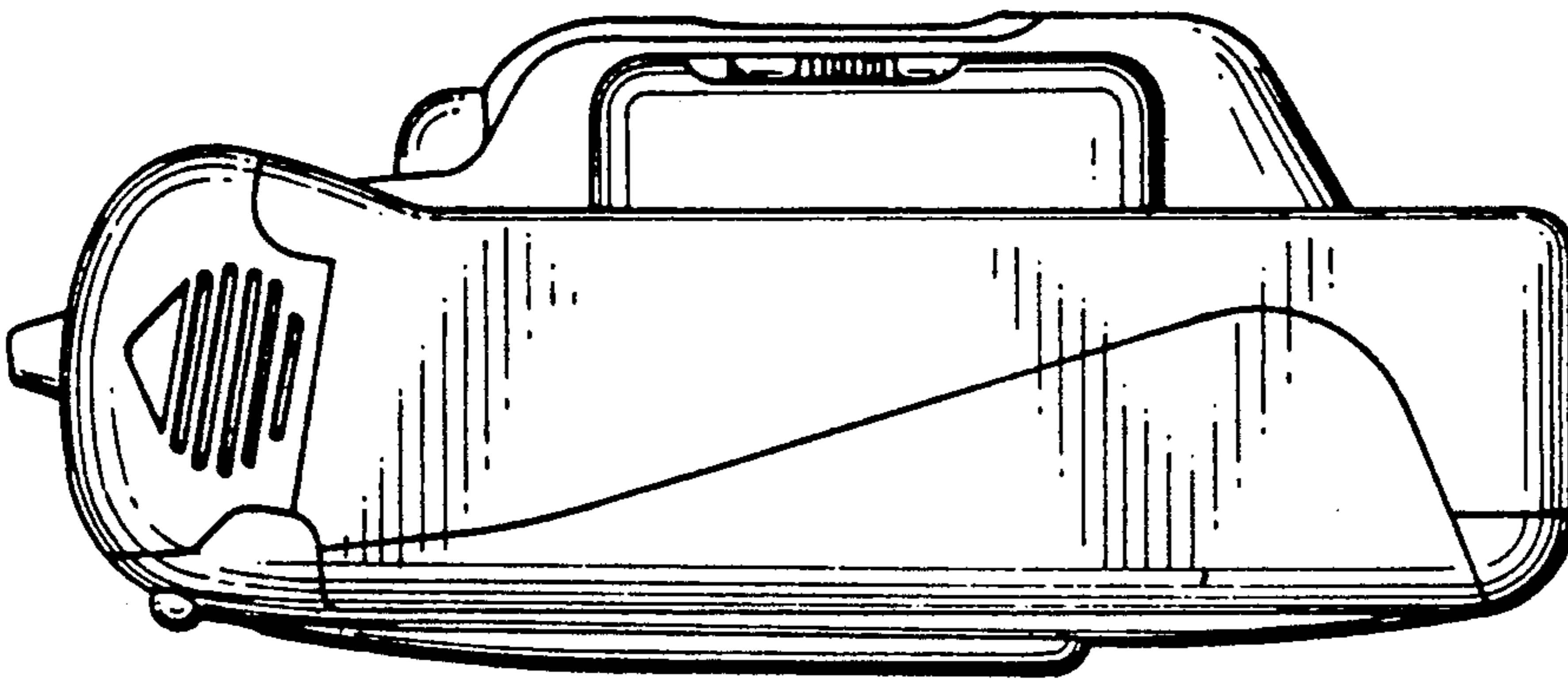

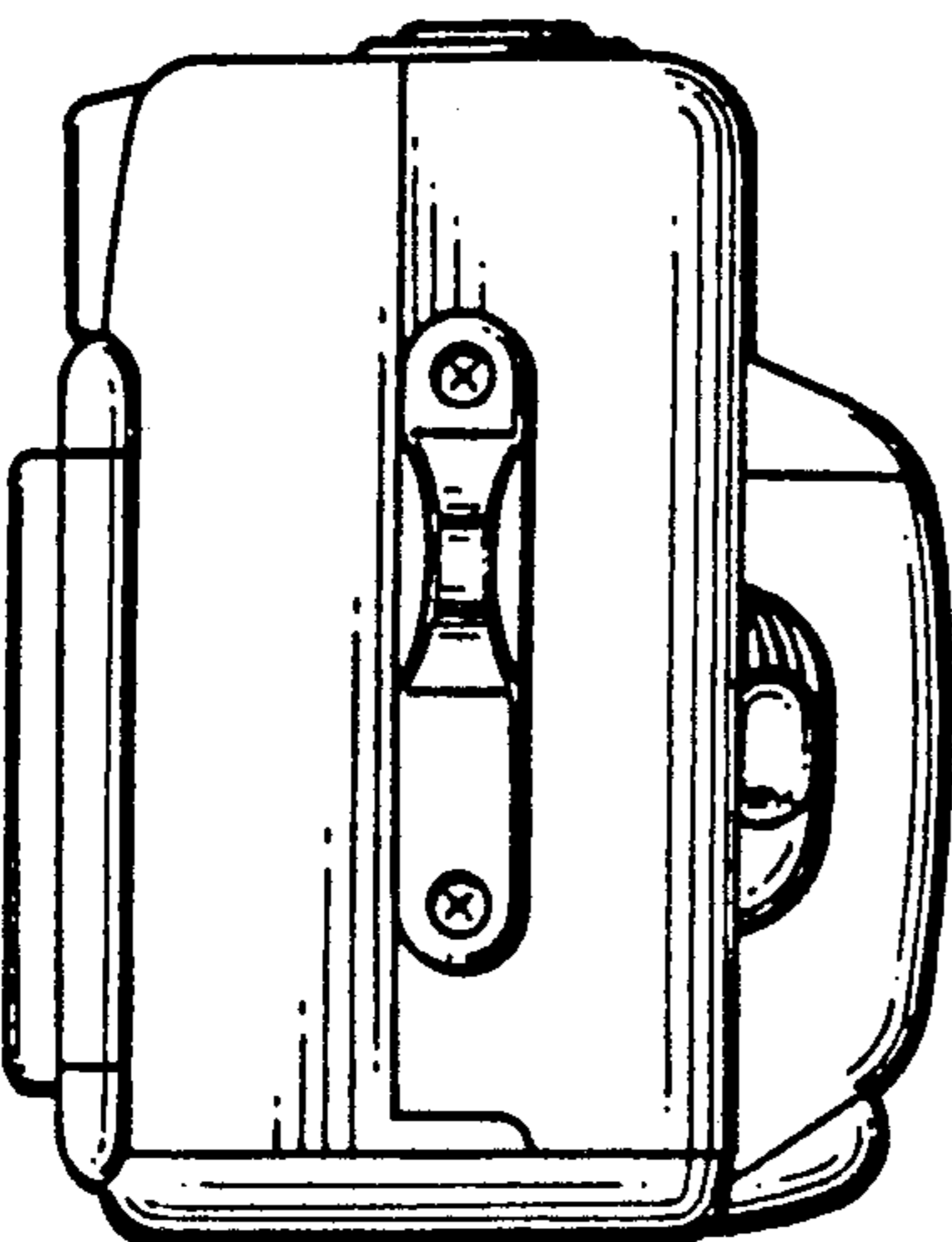

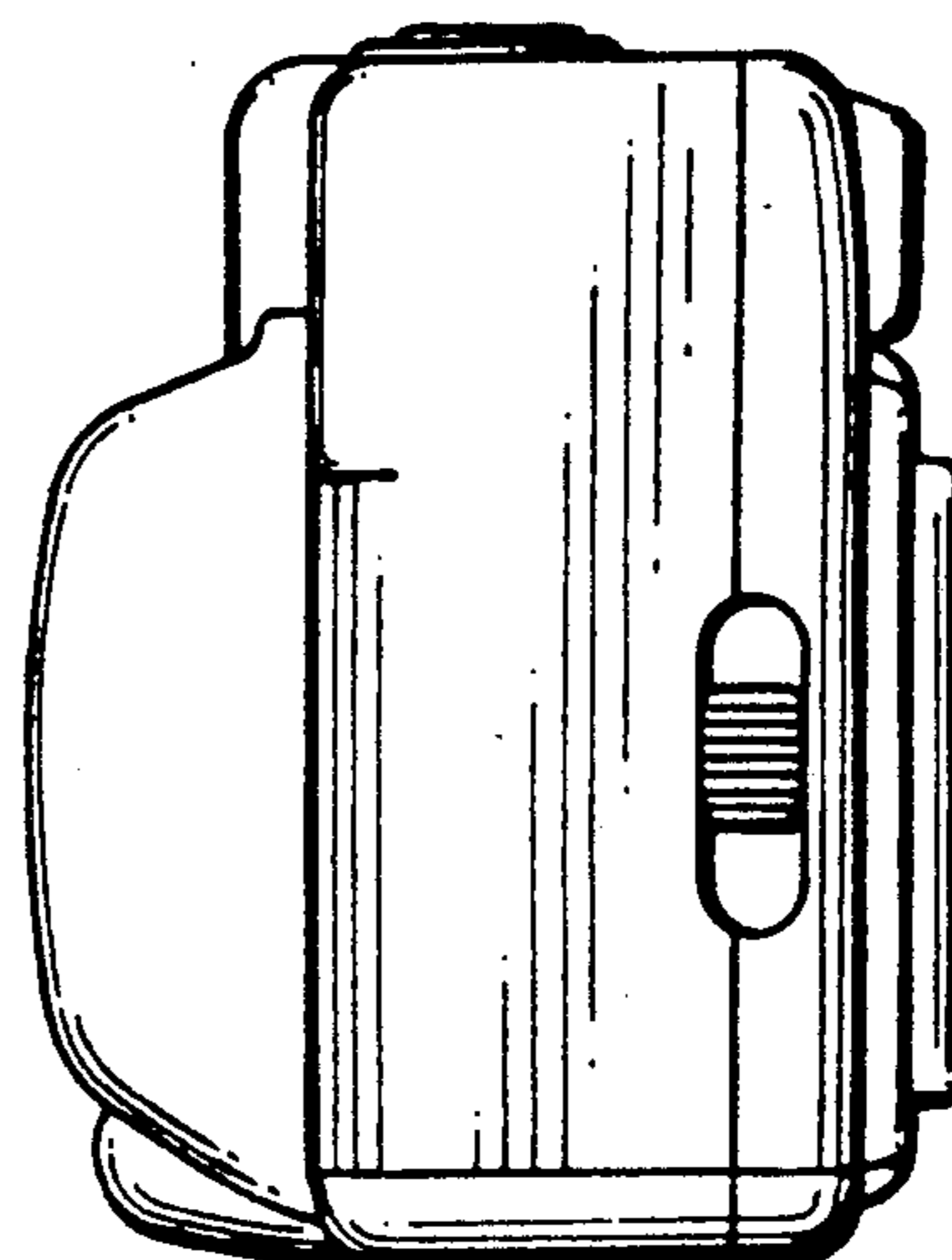

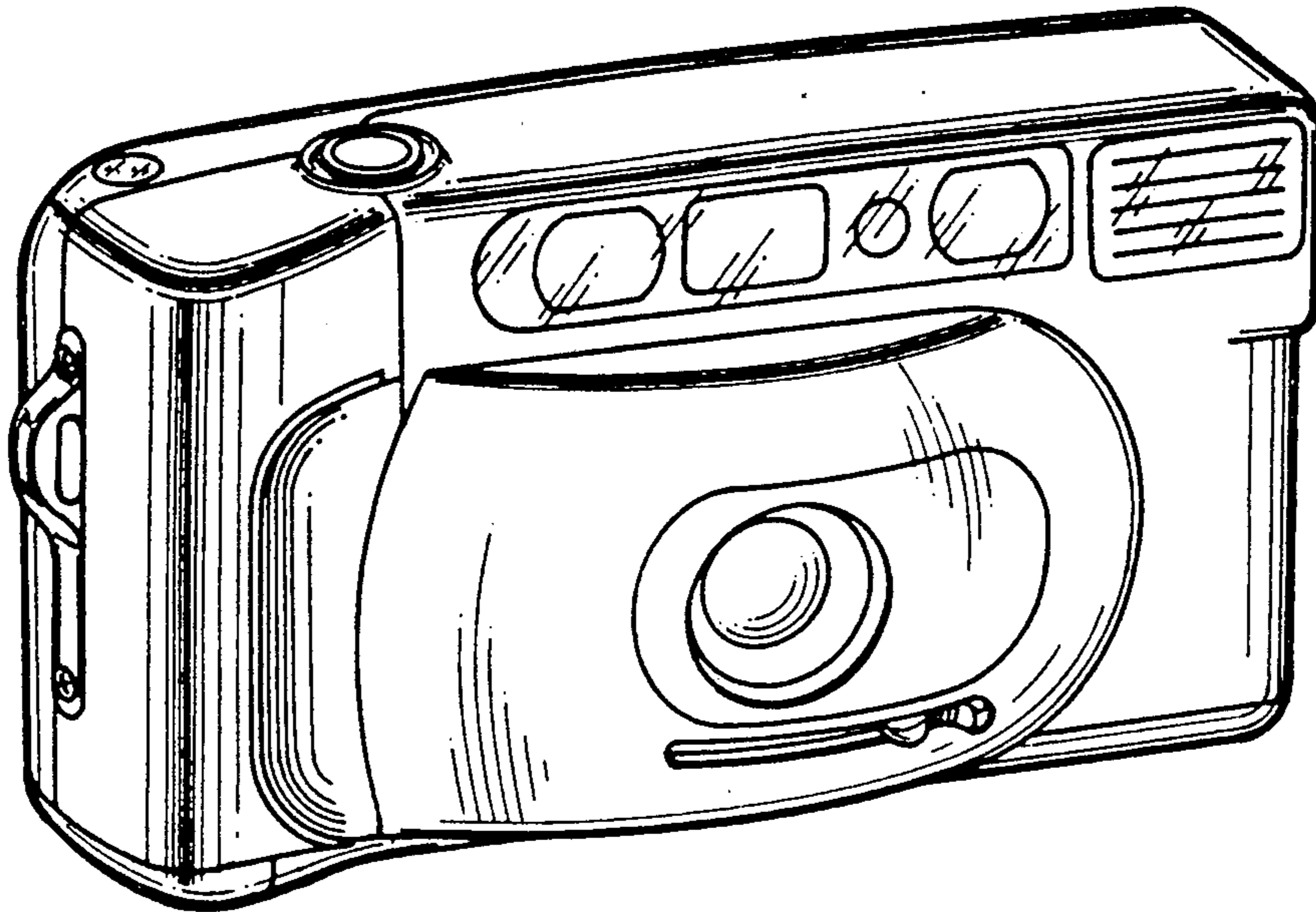

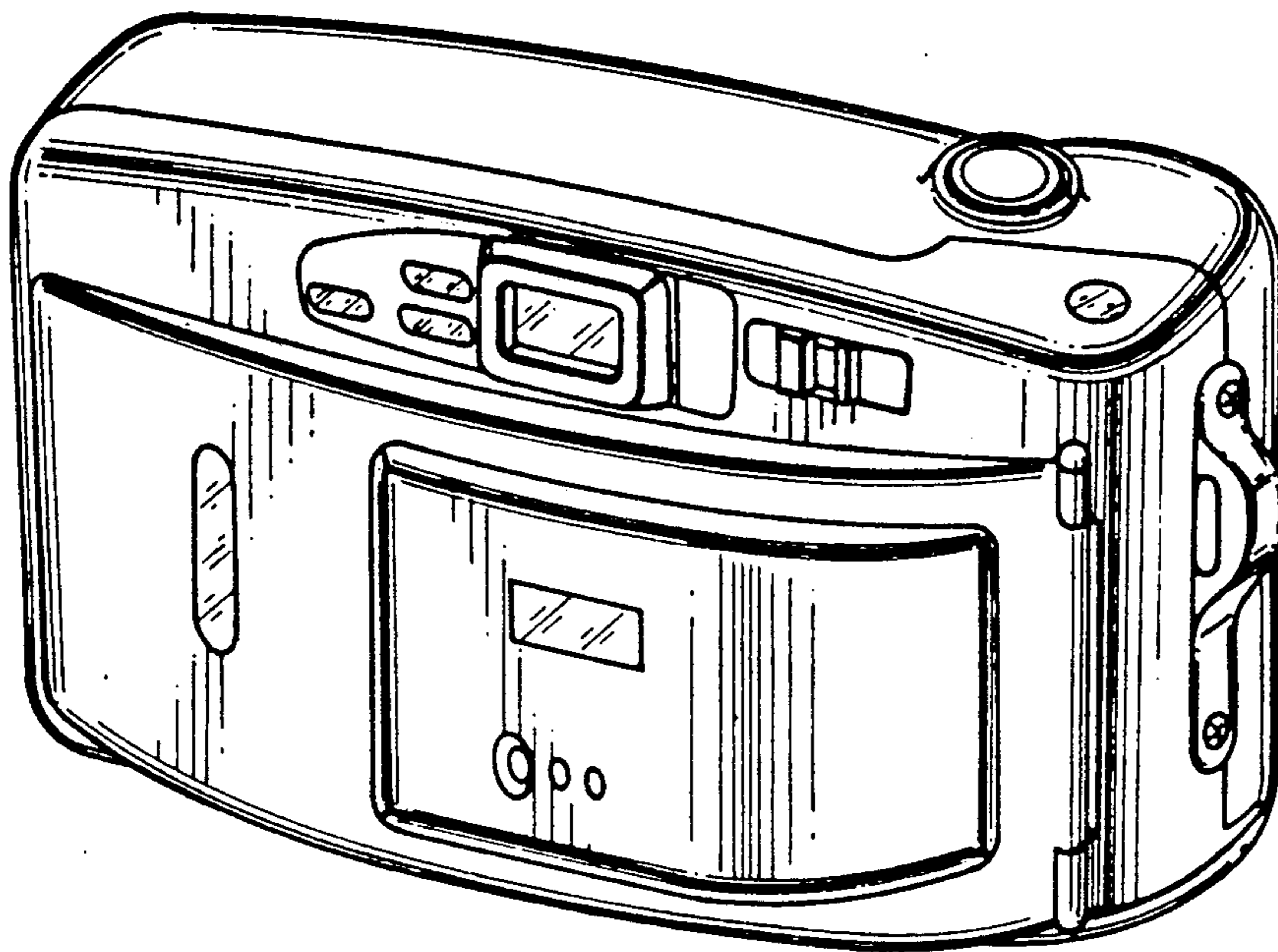

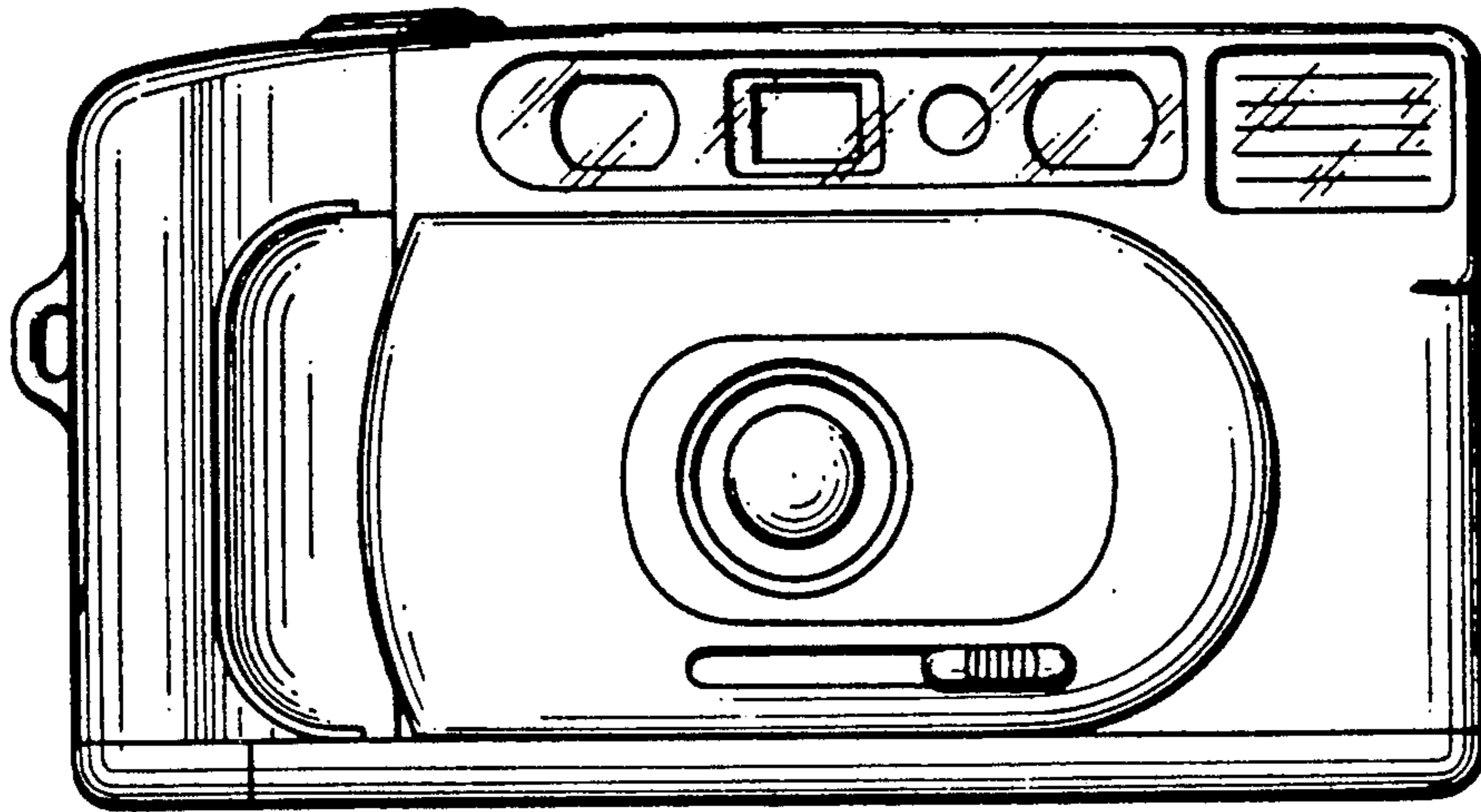

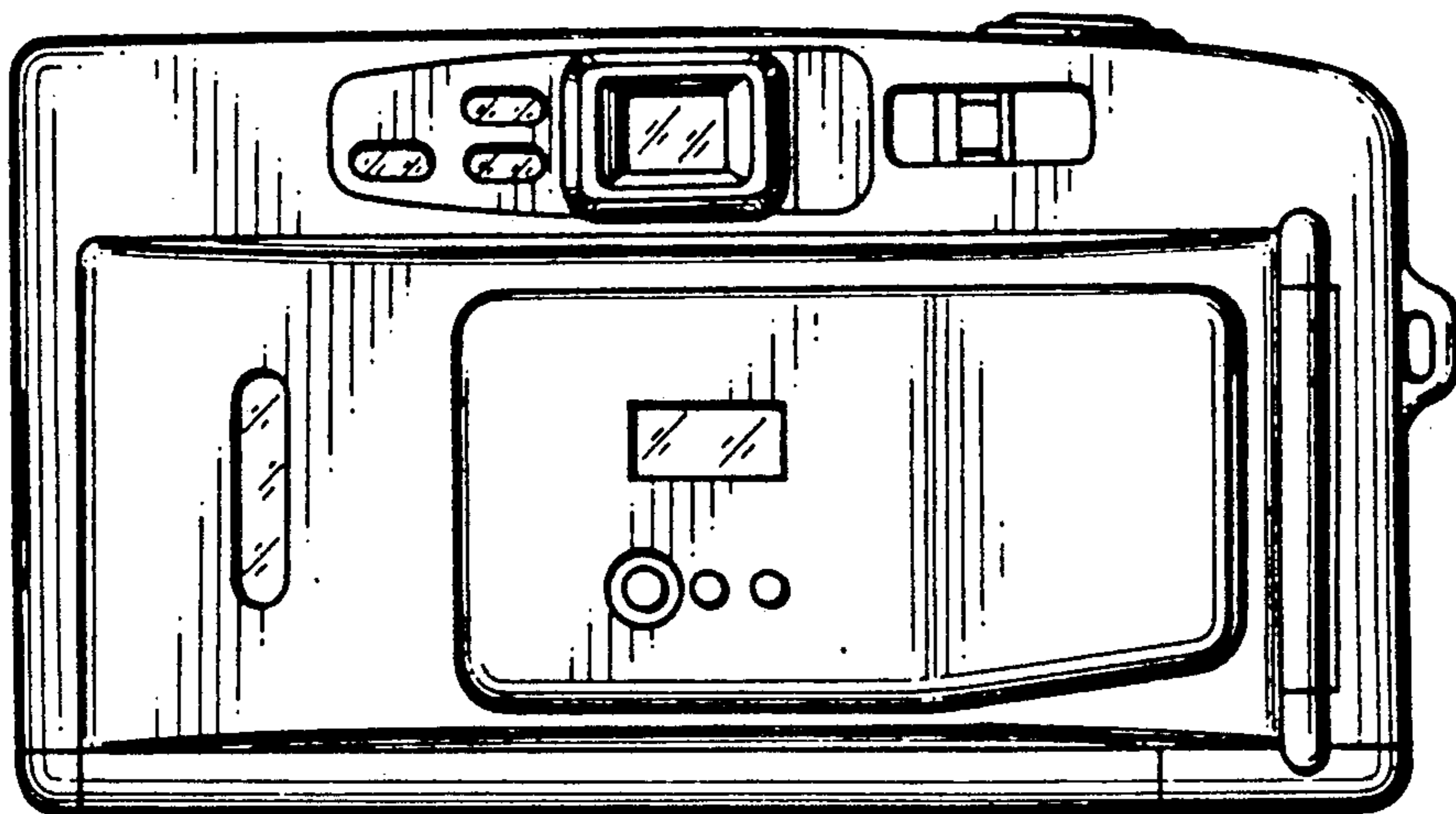

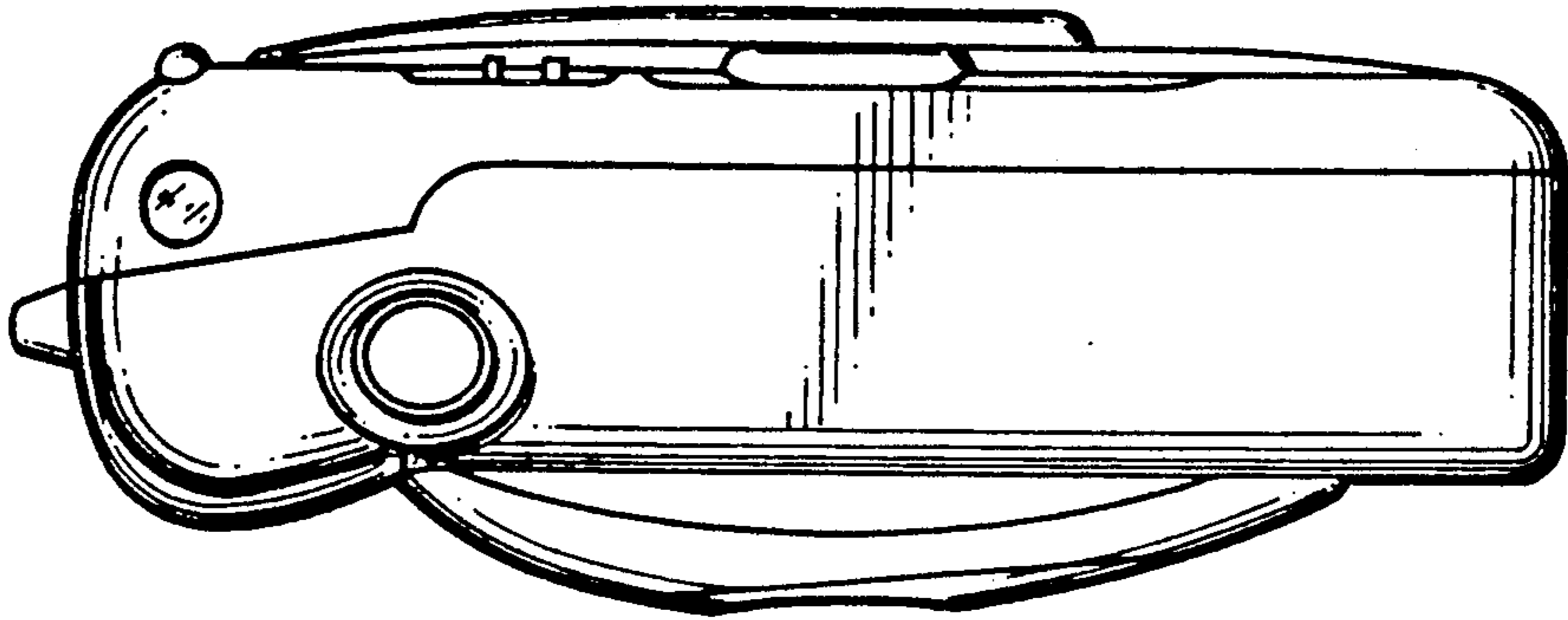

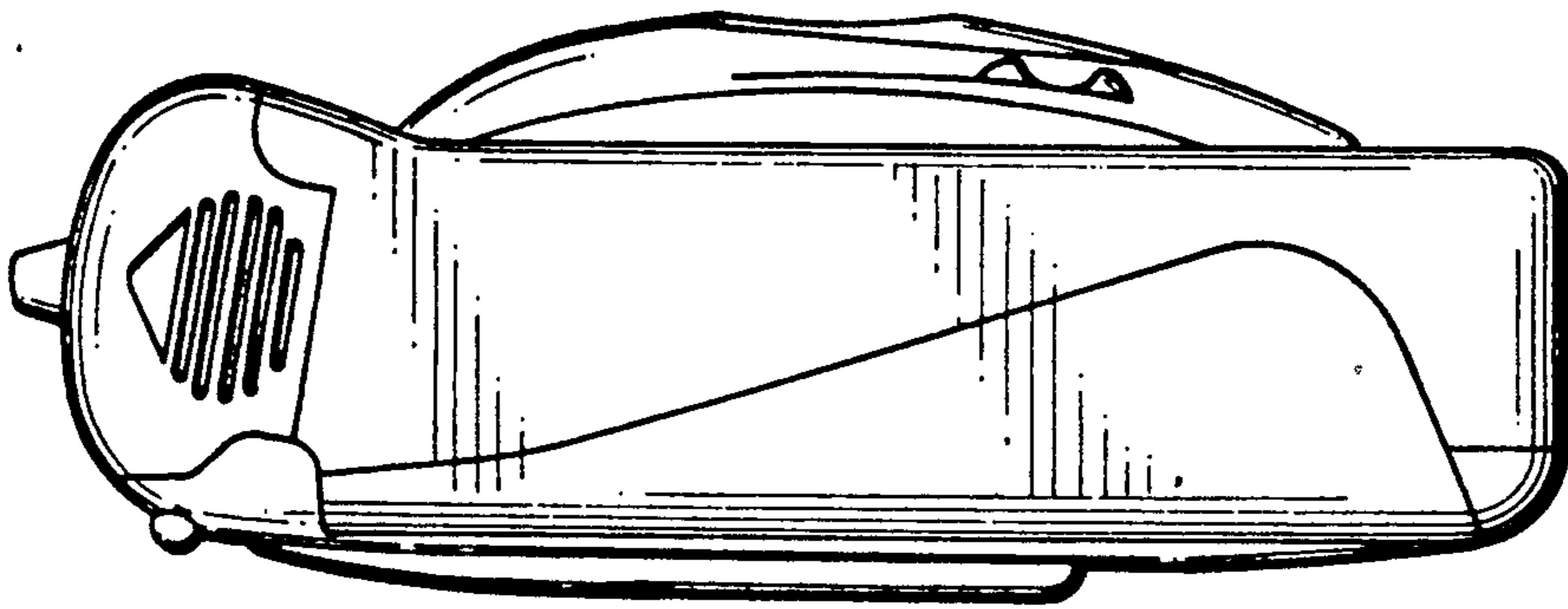

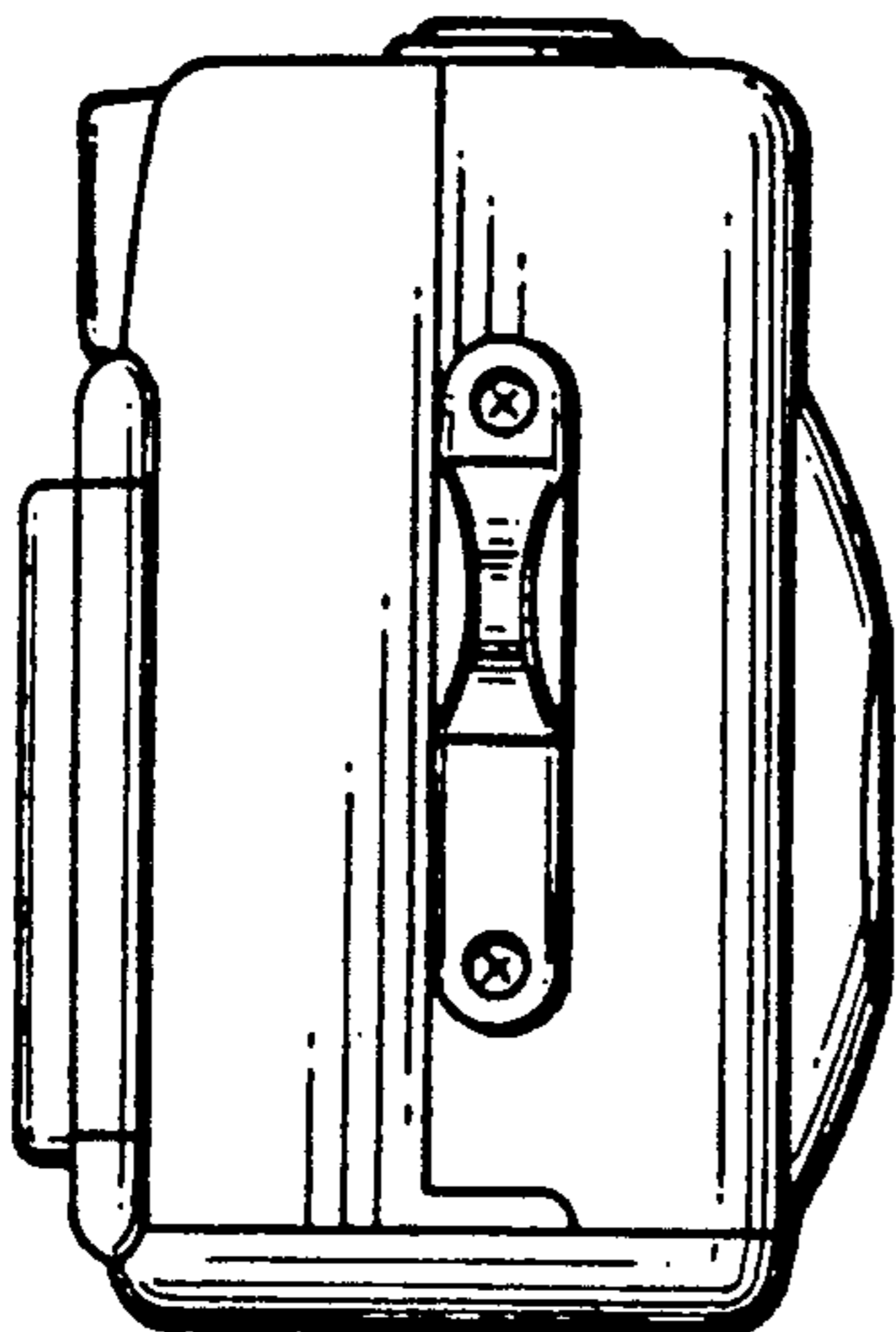
