CLAIM

[57] The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a shoe upper showing my new design;
 FIG. 2 is a right side elevational view of the shoe upper;
 FIG. 3 is a front elevational view of the shoe upper;
 FIG. 4 is a rear elevational view thereof; and
 FIG. 5 is a top plan view thereof.
 The broken line showing of a sole in FIGS. 1-4 is for illustrative purposes only and forms no part of the claimed design.

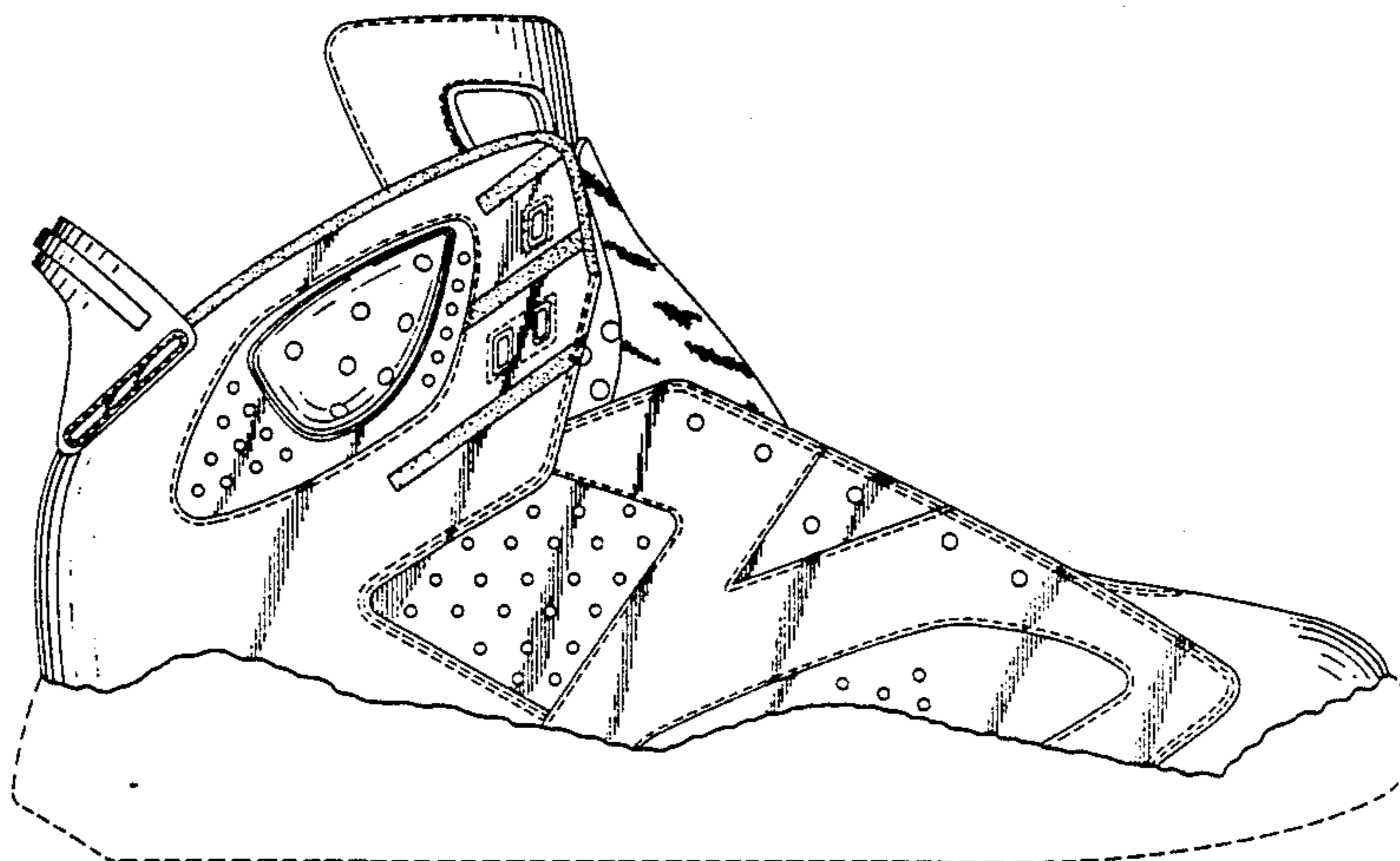
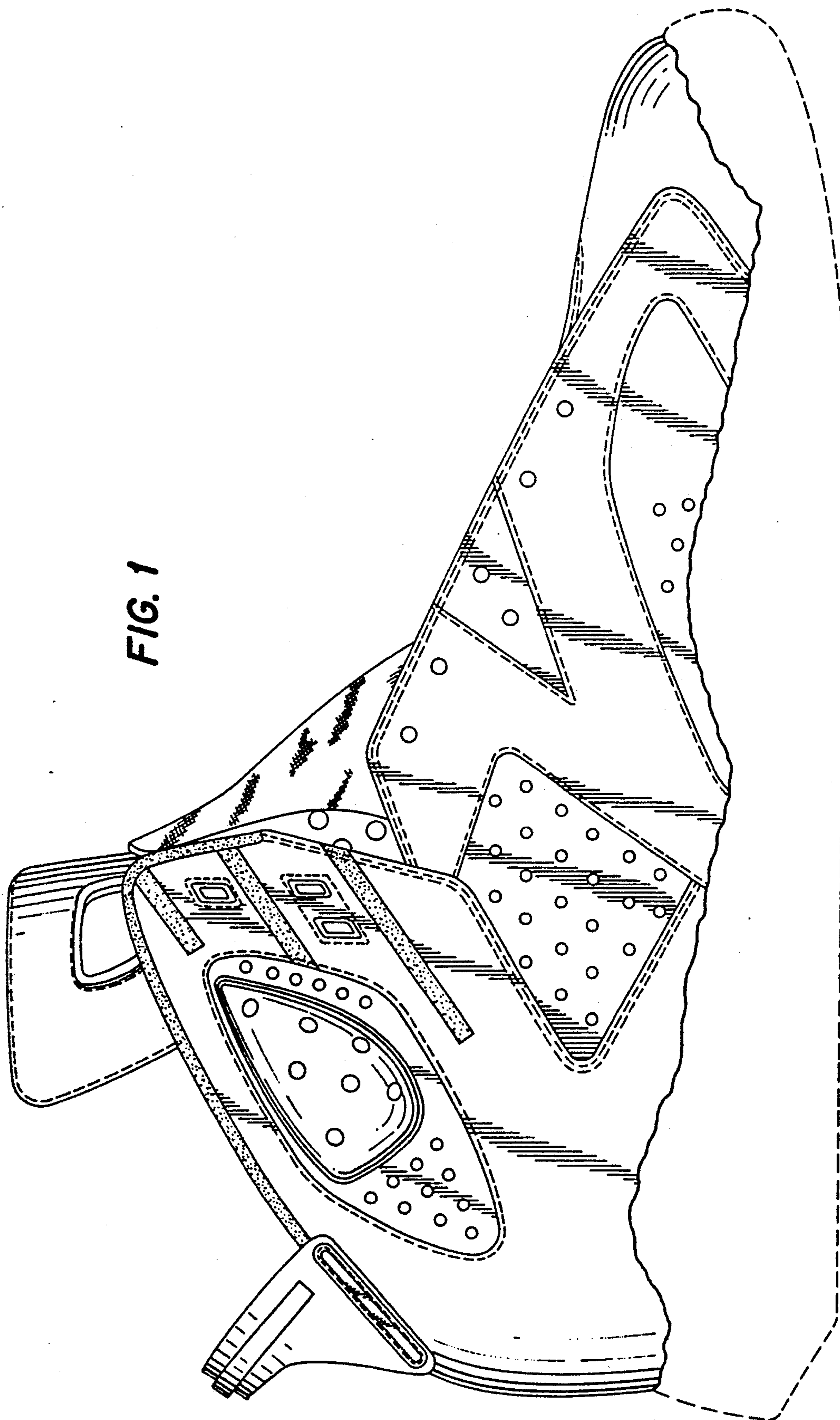

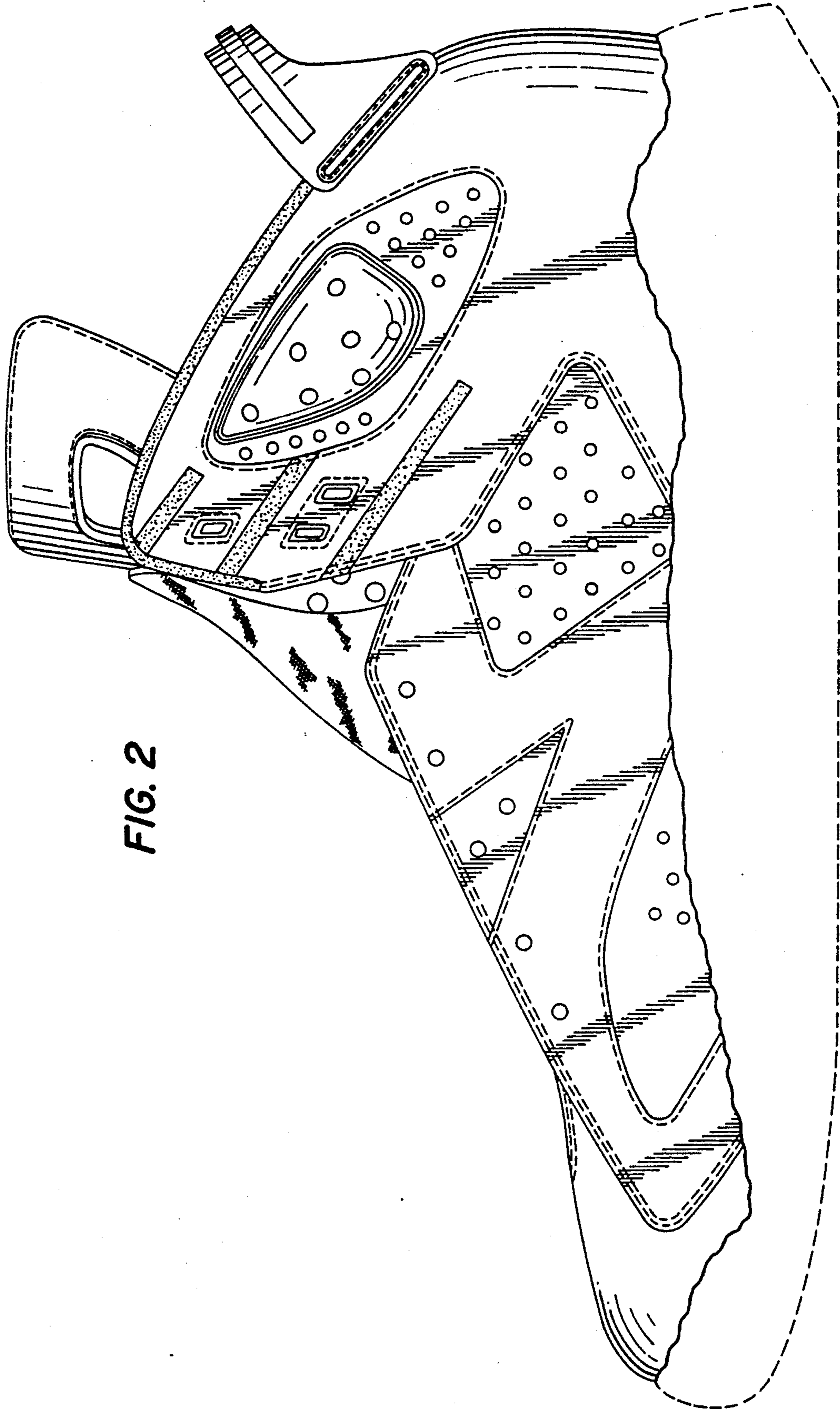

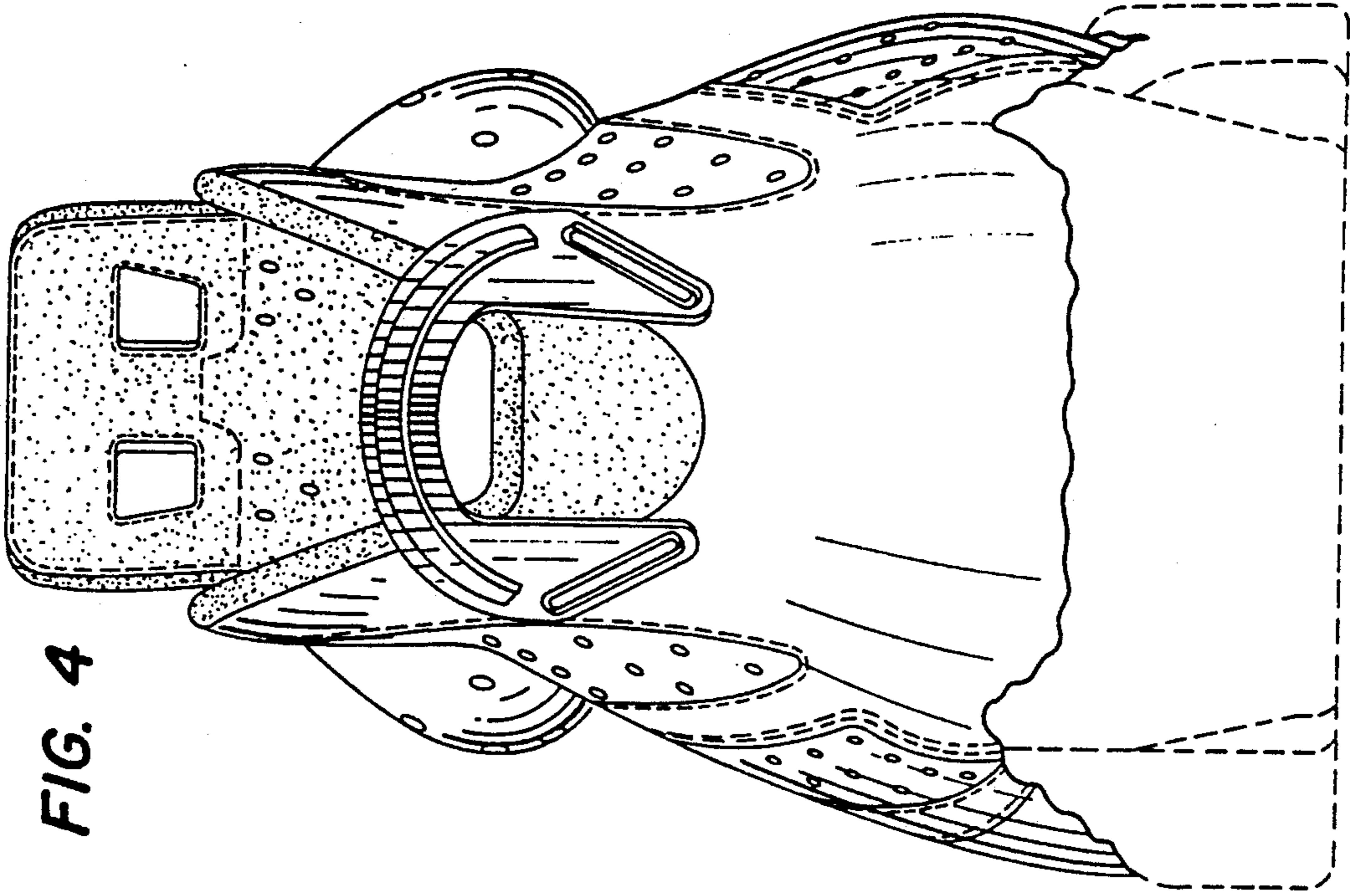

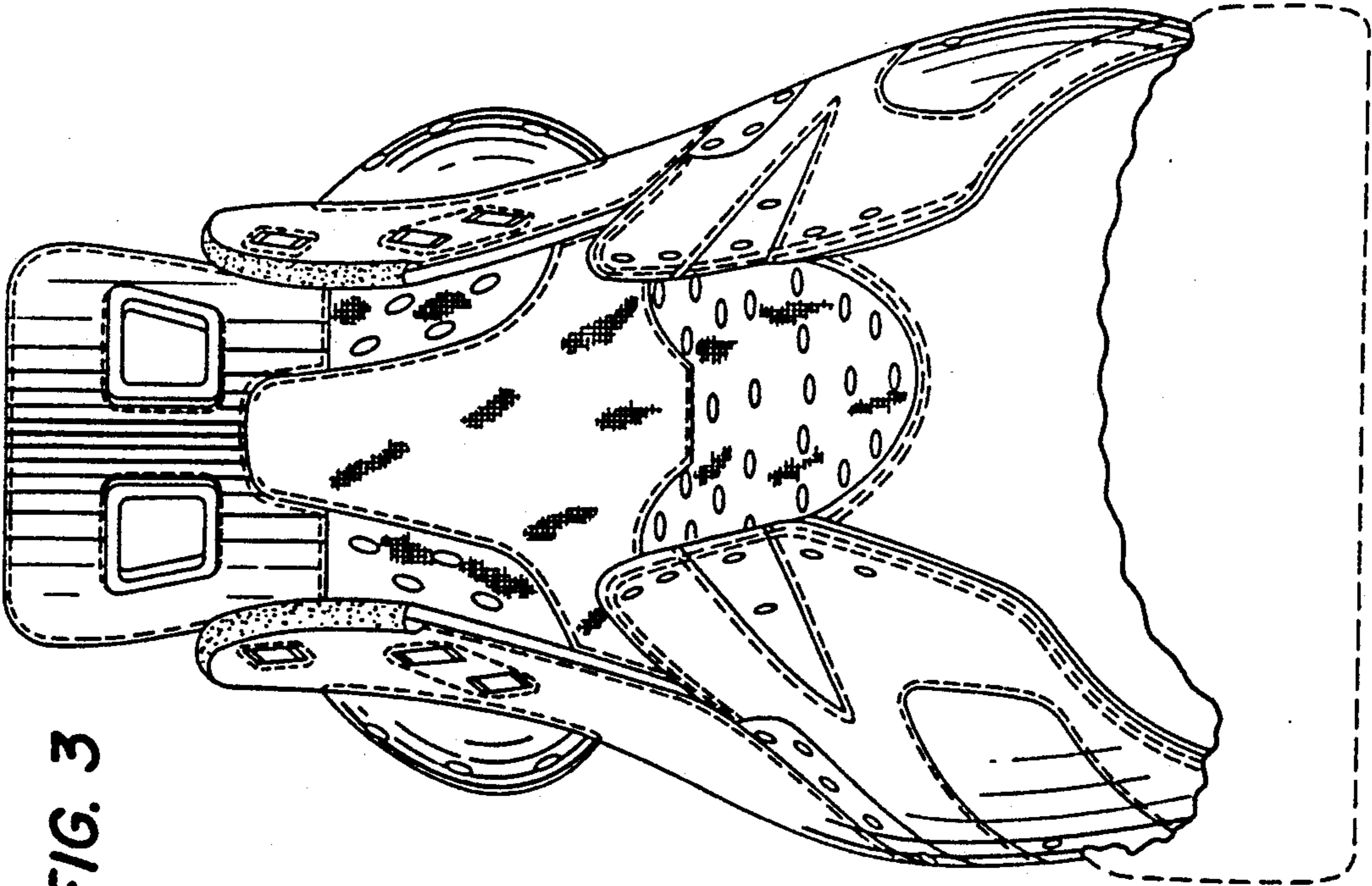
