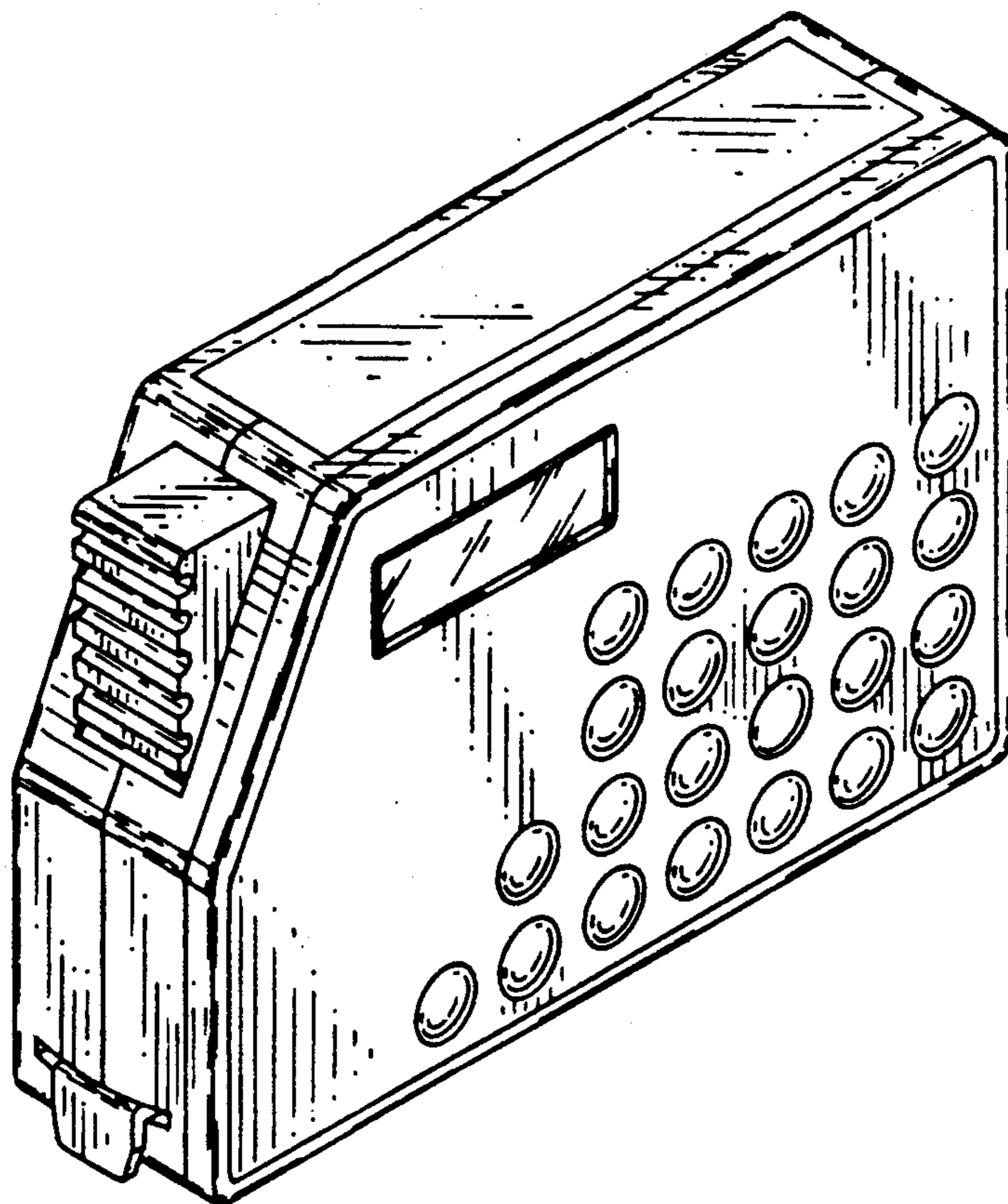

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a combined measuring tape and calculator showing my new design;

FIG. 7 is a rear elevational view.



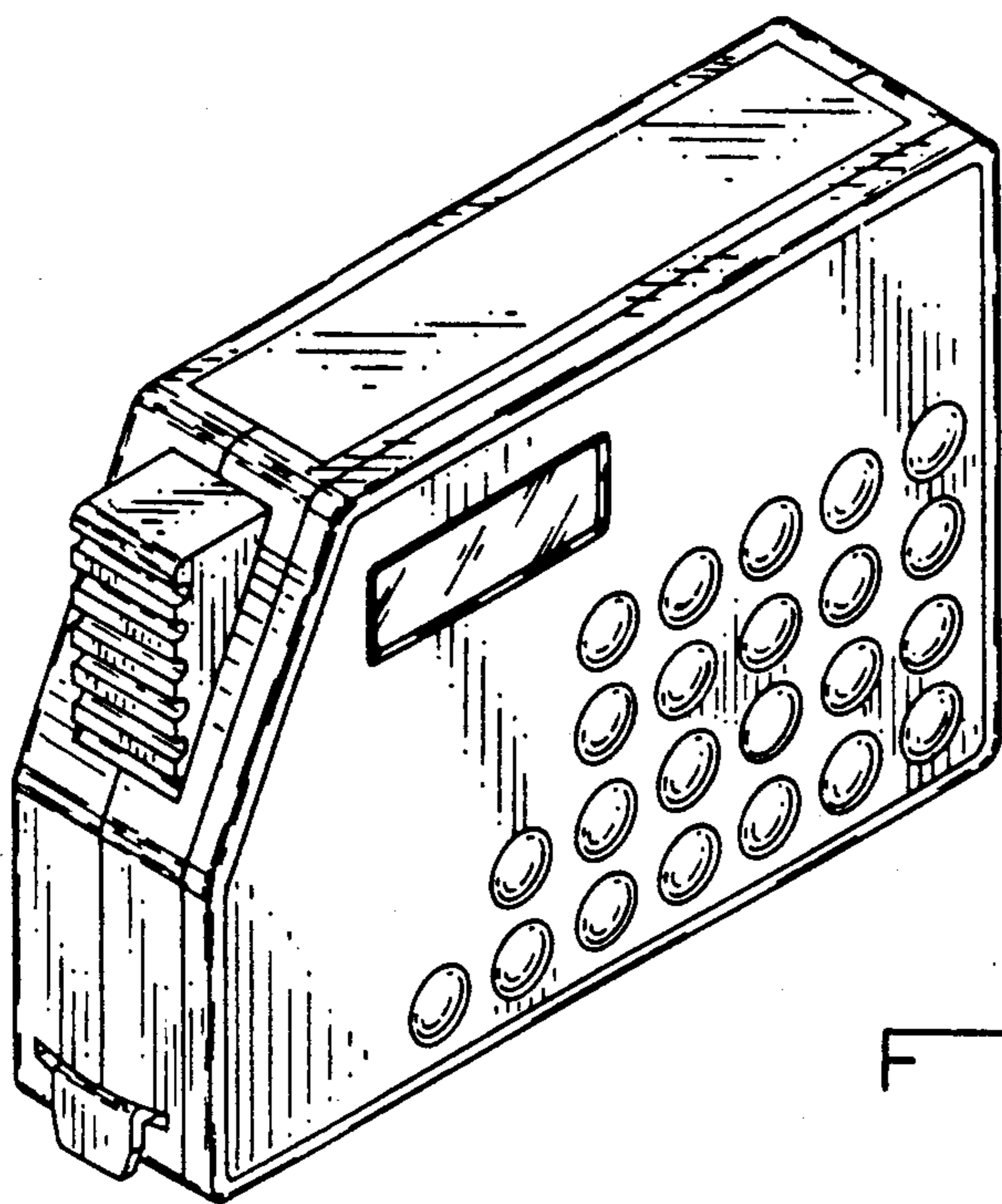

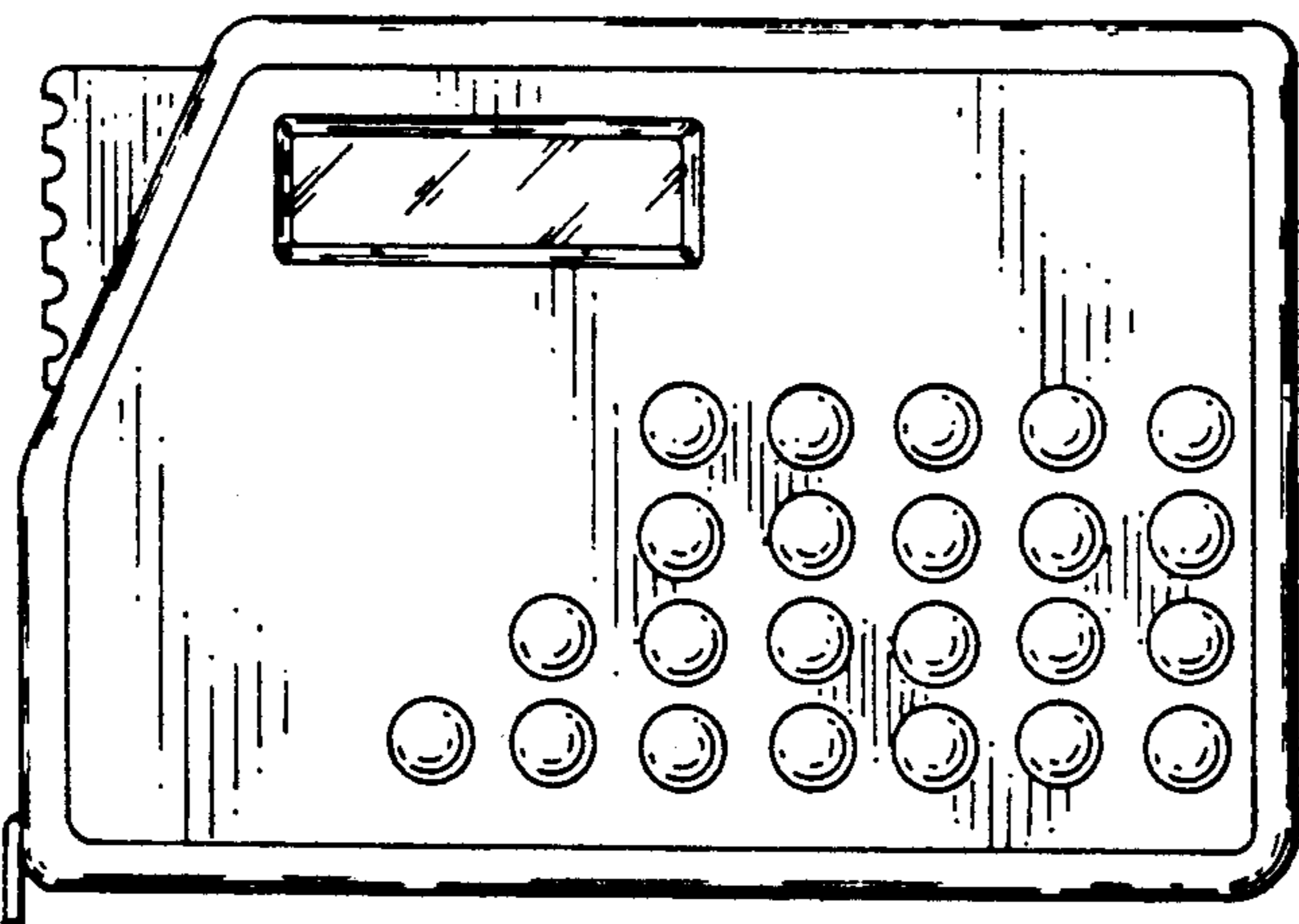

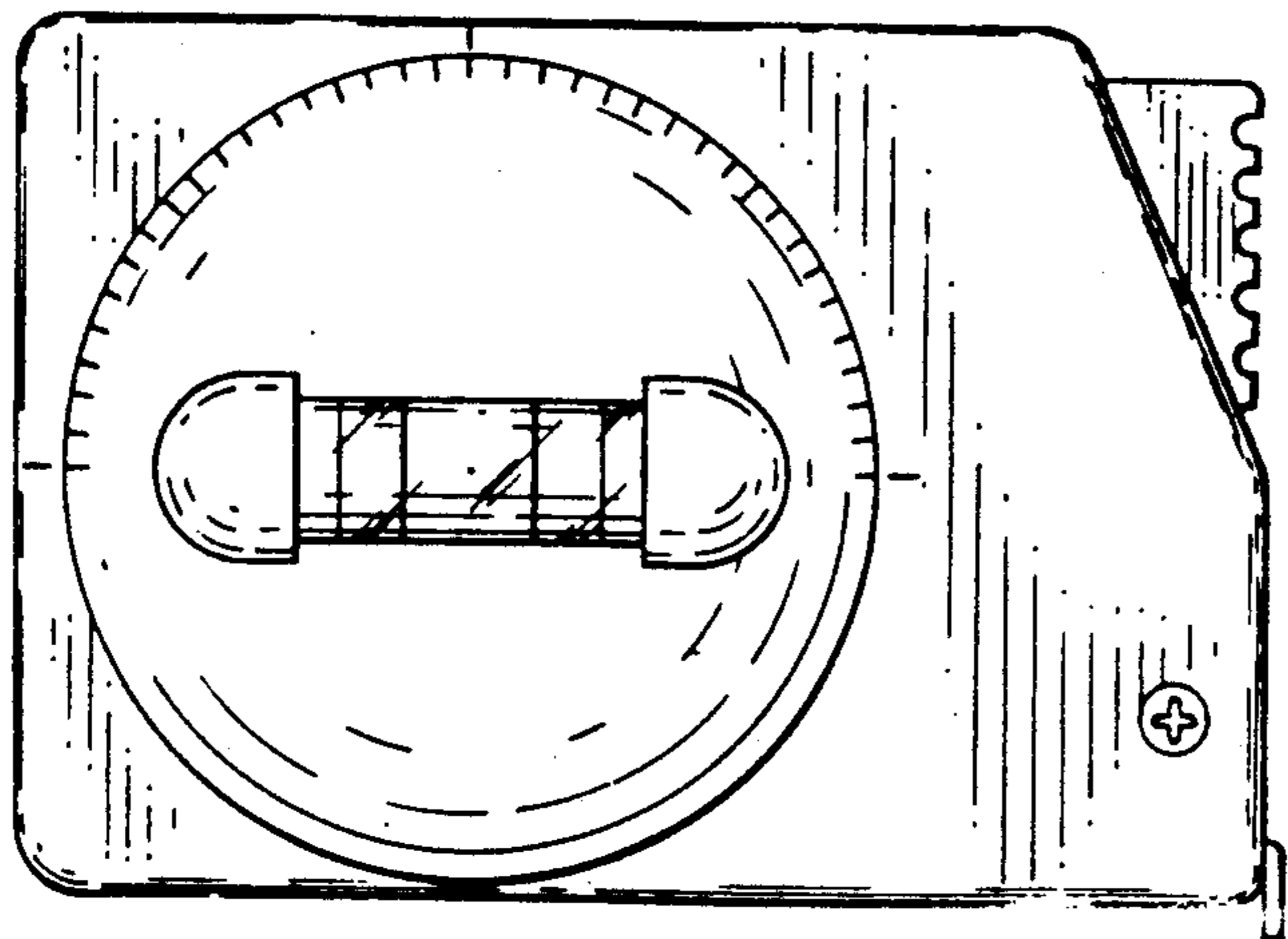

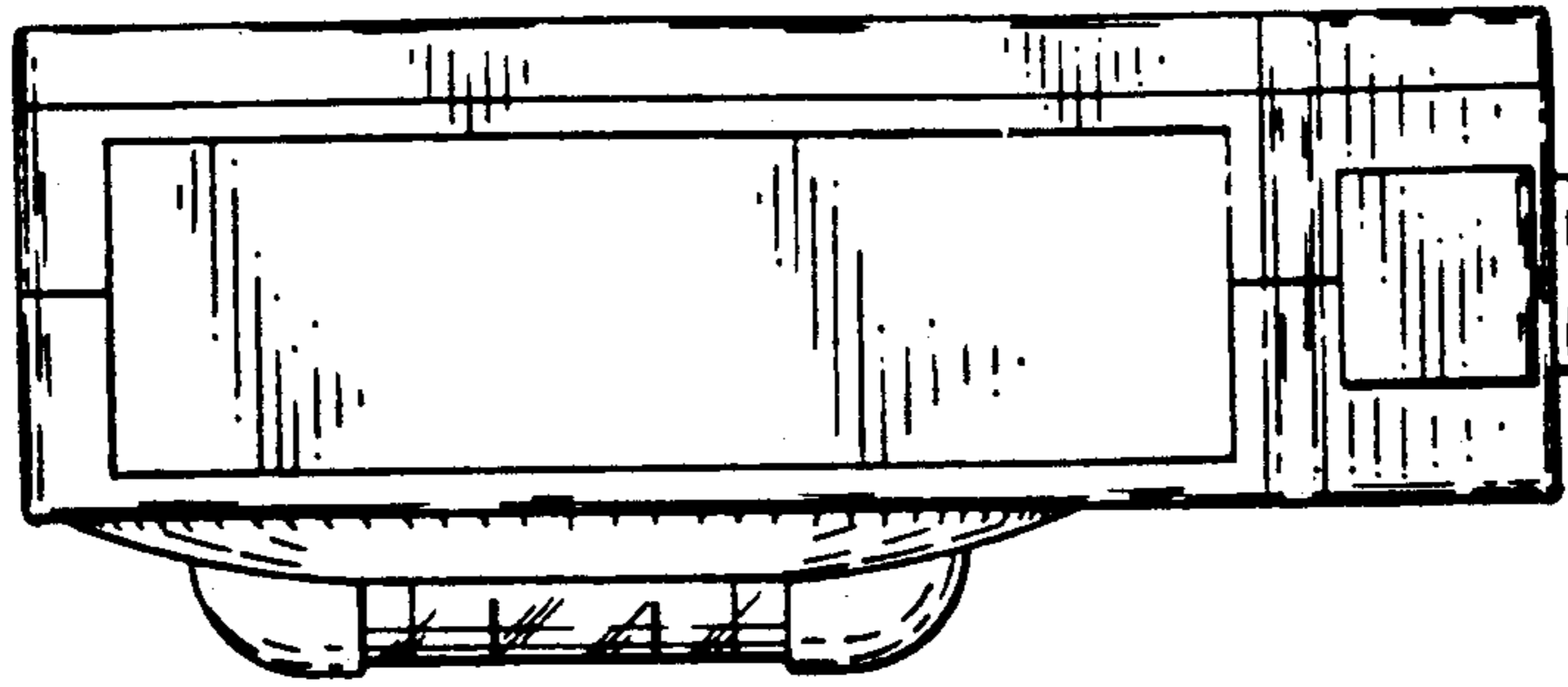

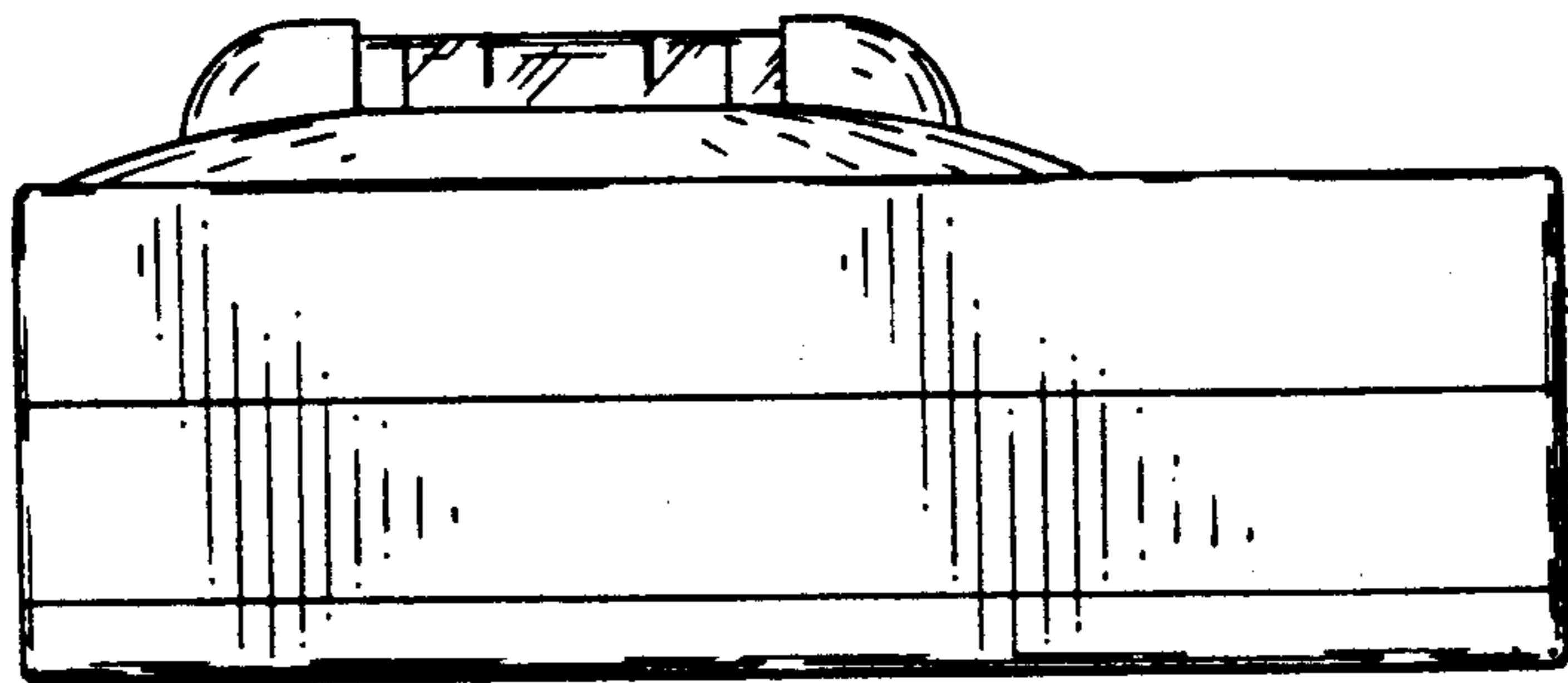

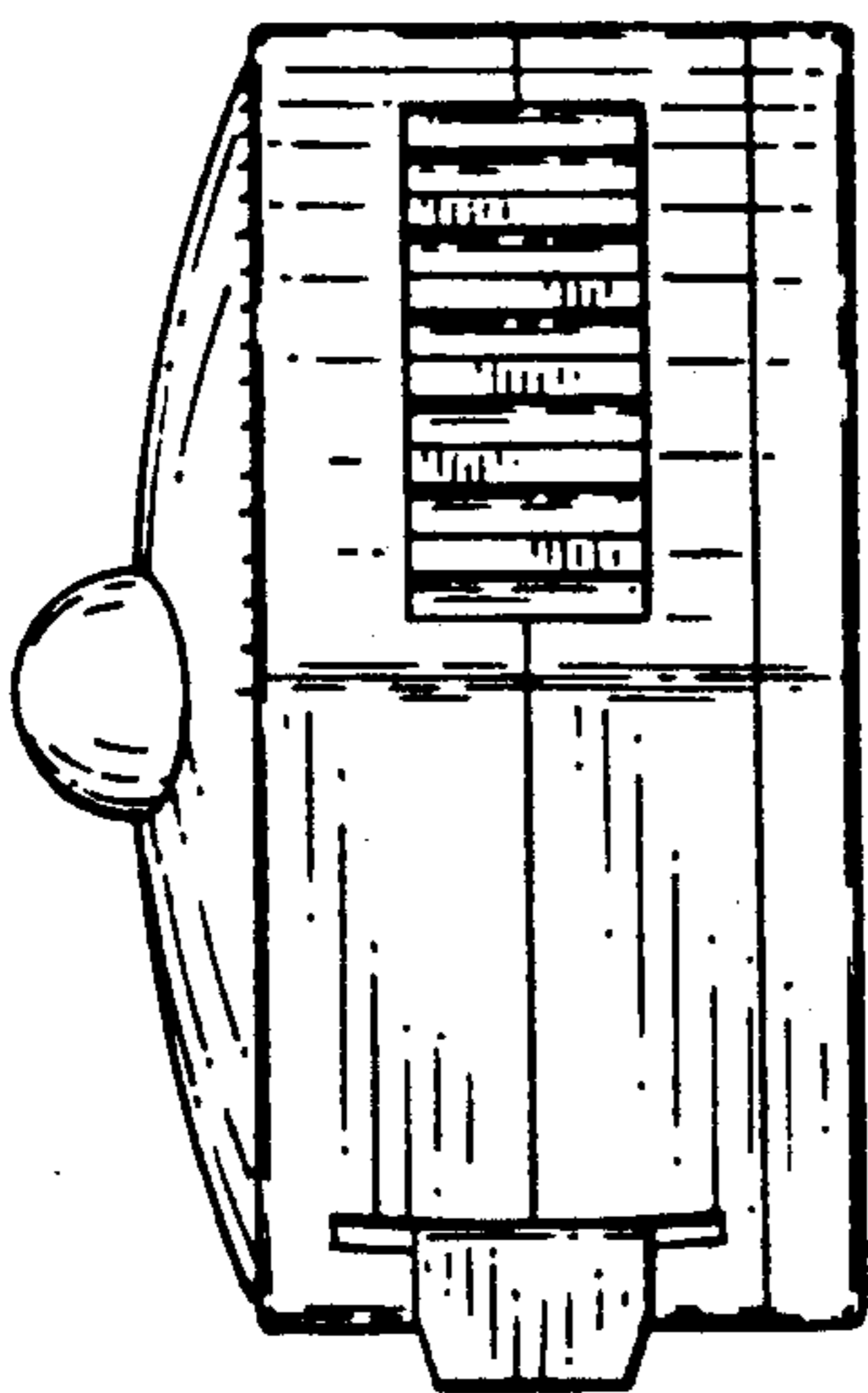

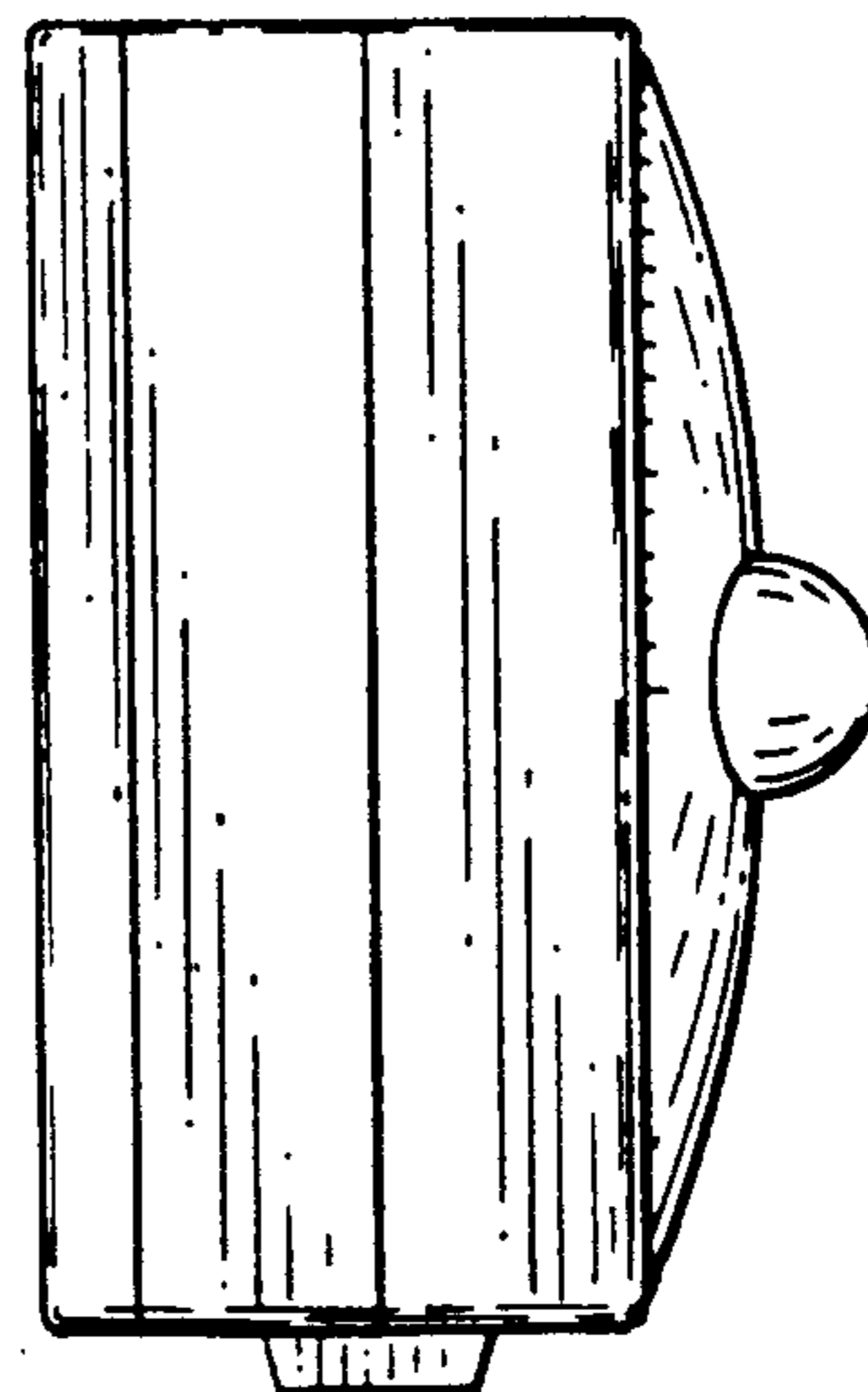
