[57] CLAIM

The ornamental design for a multipurpose office-use article, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a multipurpose office-use article showing my new design;
 FIG. 2 is a left side elevational view;
 FIG. 3 is a front elevational view;
 FIG. 4 is a bottom plan view;
 FIG. 5 is a right side elevational view;
 FIG. 6 is a rear elevational view;
 FIG. 7 is a front elevational view in an exploded condition with the writing instrument extended;
 FIG. 8 is a front elevational view showing the stapler in the extended position;
 FIG. 9 is a front elevational view showing the cutter in the extended position;
 FIG. 10 is a front elevational view with the cover member in extended position;
 FIG. 11 is a front elevational view in an exploded condition with the screw driver extended;
 FIG. 12 is a rear elevational view showing the pin/staple puller in the extended position;
 FIG. 13 is a rear elevational view showing the scissors in the extended position;
 FIG. 14 is a left front perspective view of the article as shown in FIG. 1 through 6; and
 FIG. 15 is a right rear perspective view of FIG. 14.

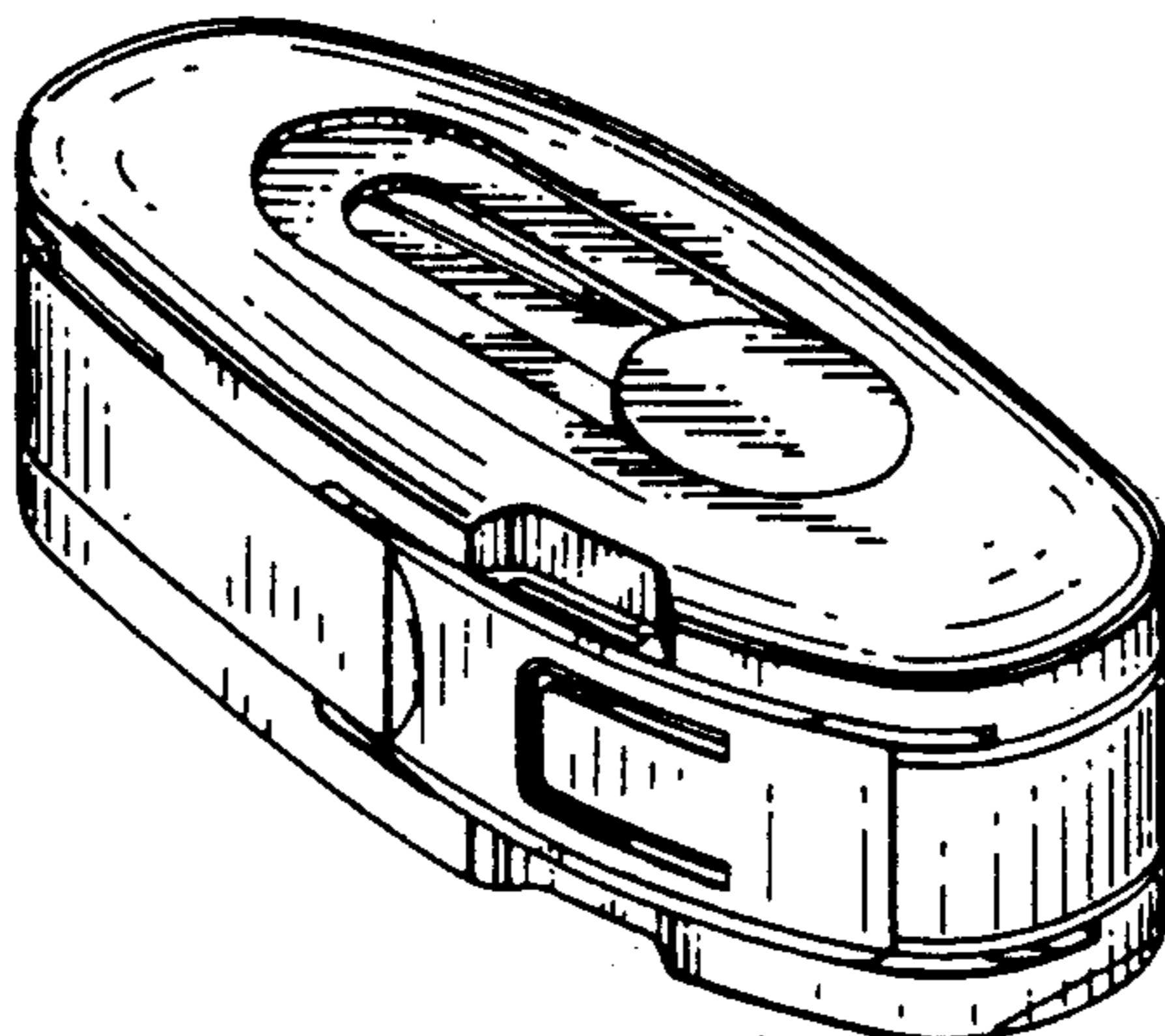
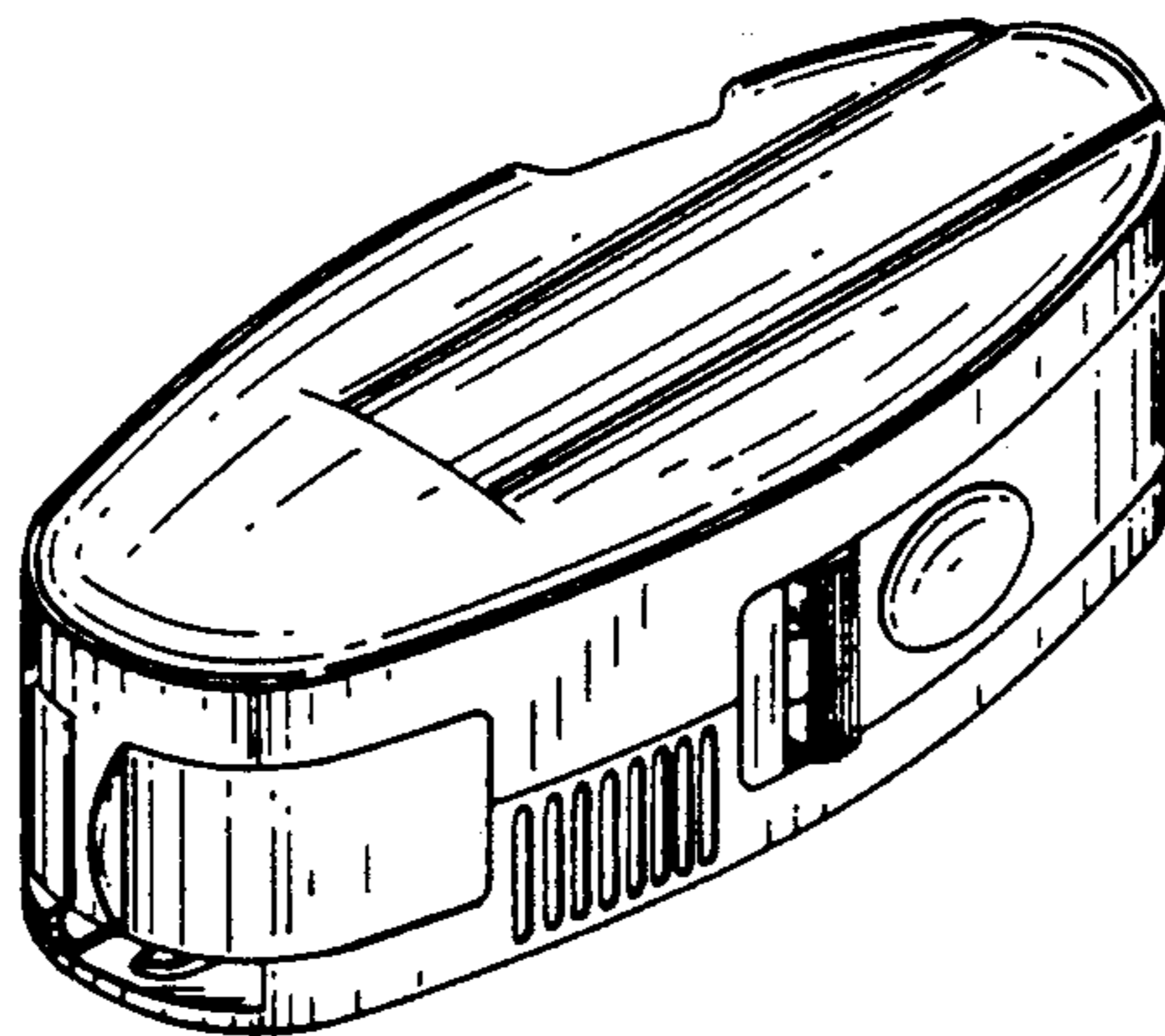

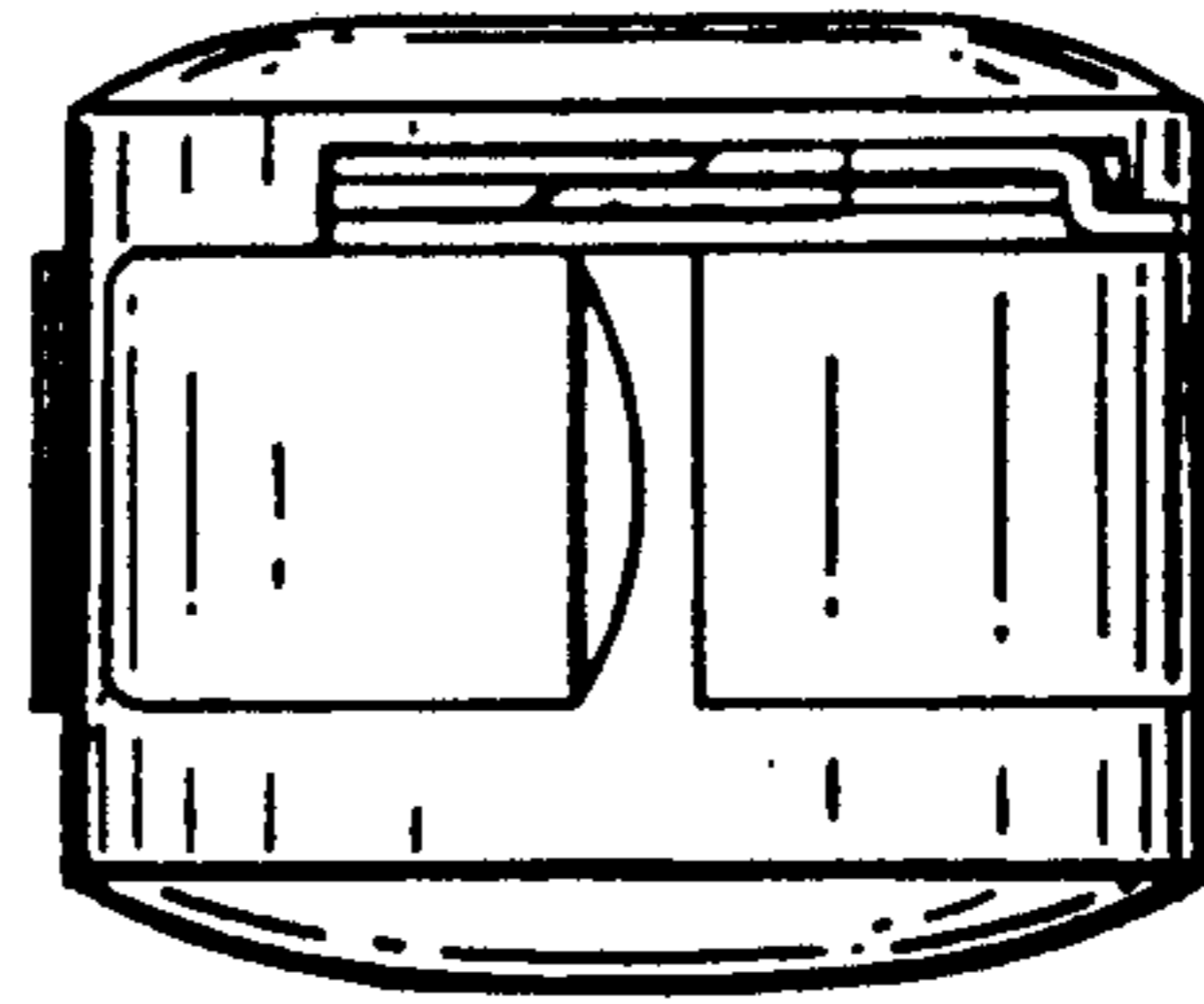

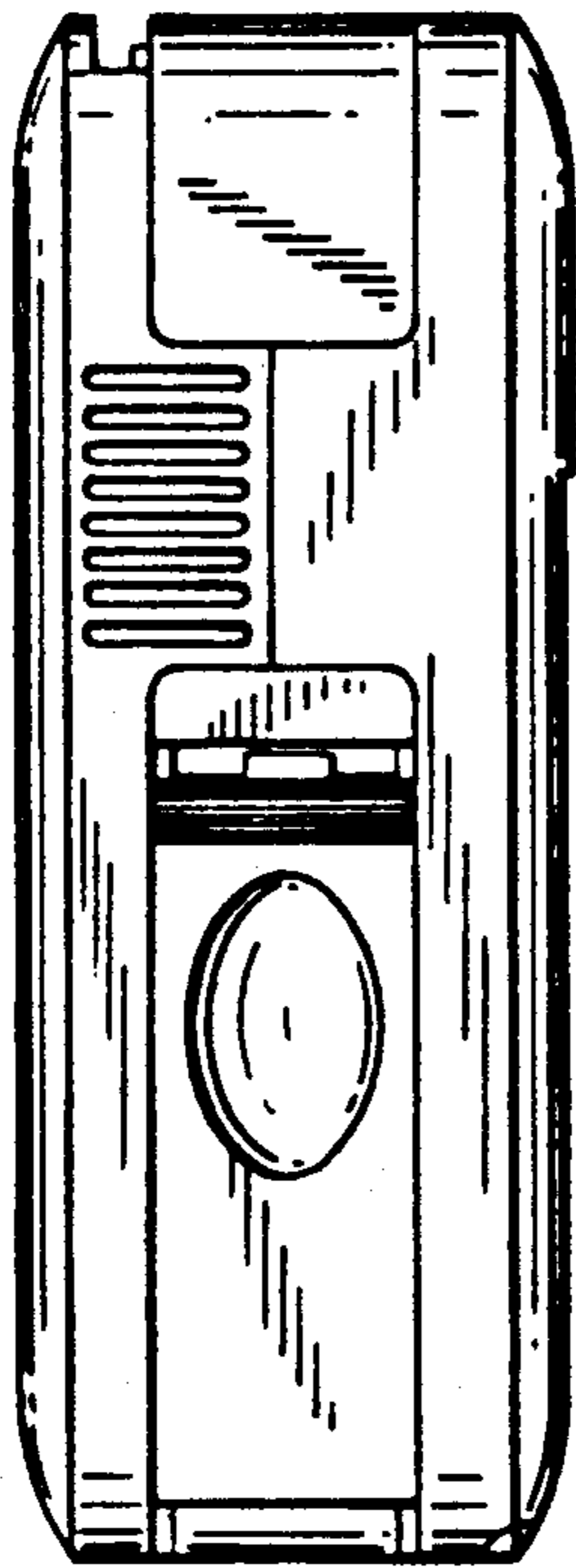

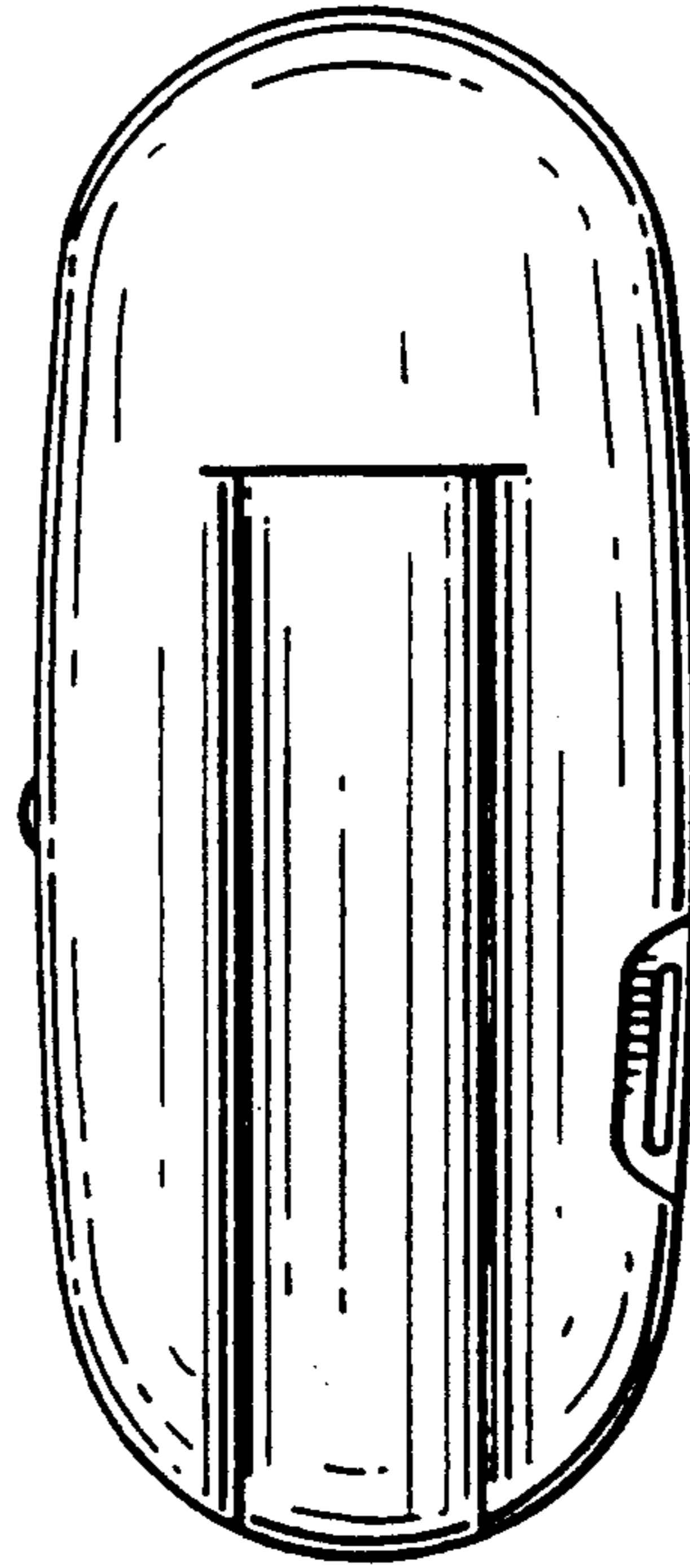

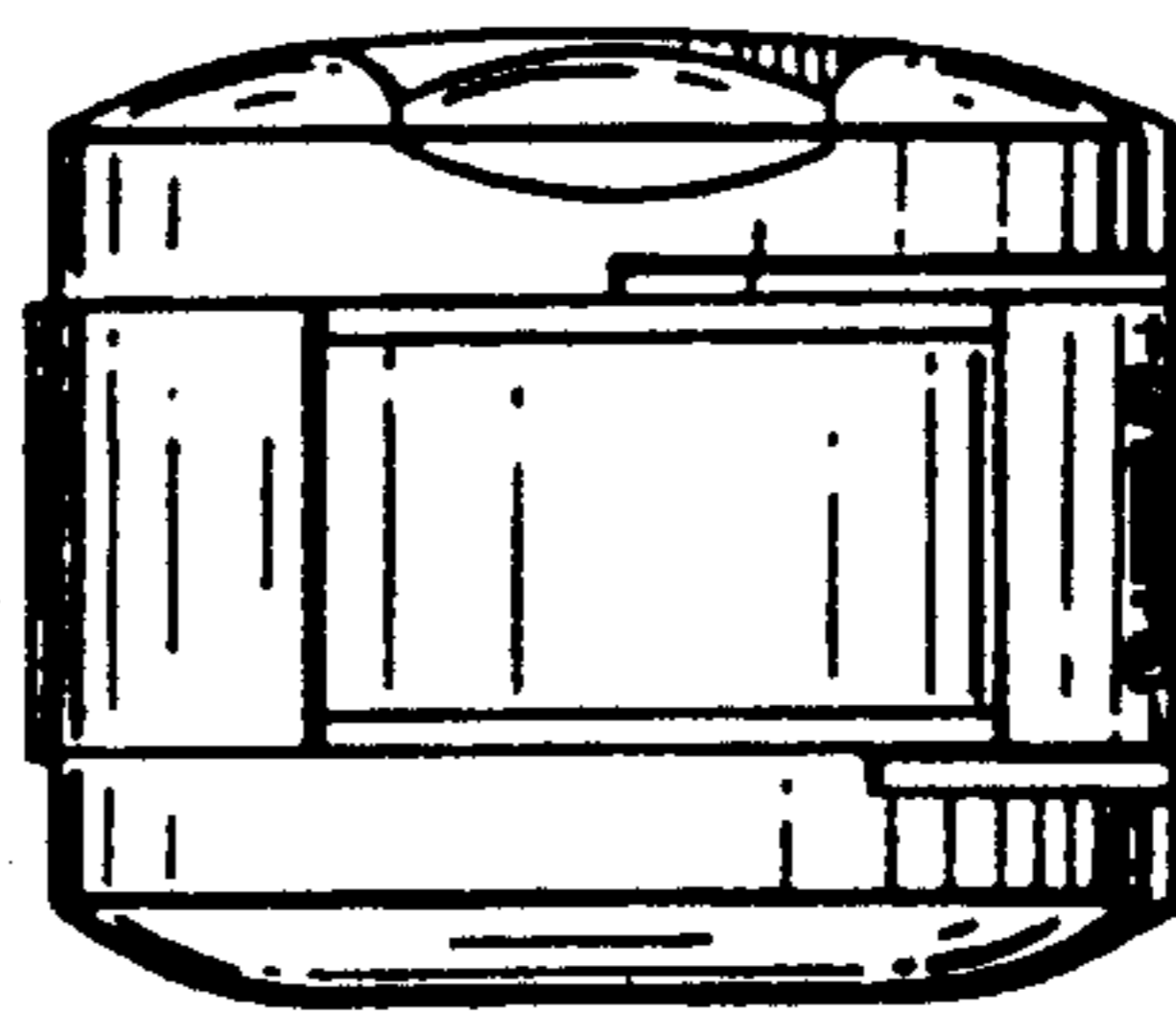

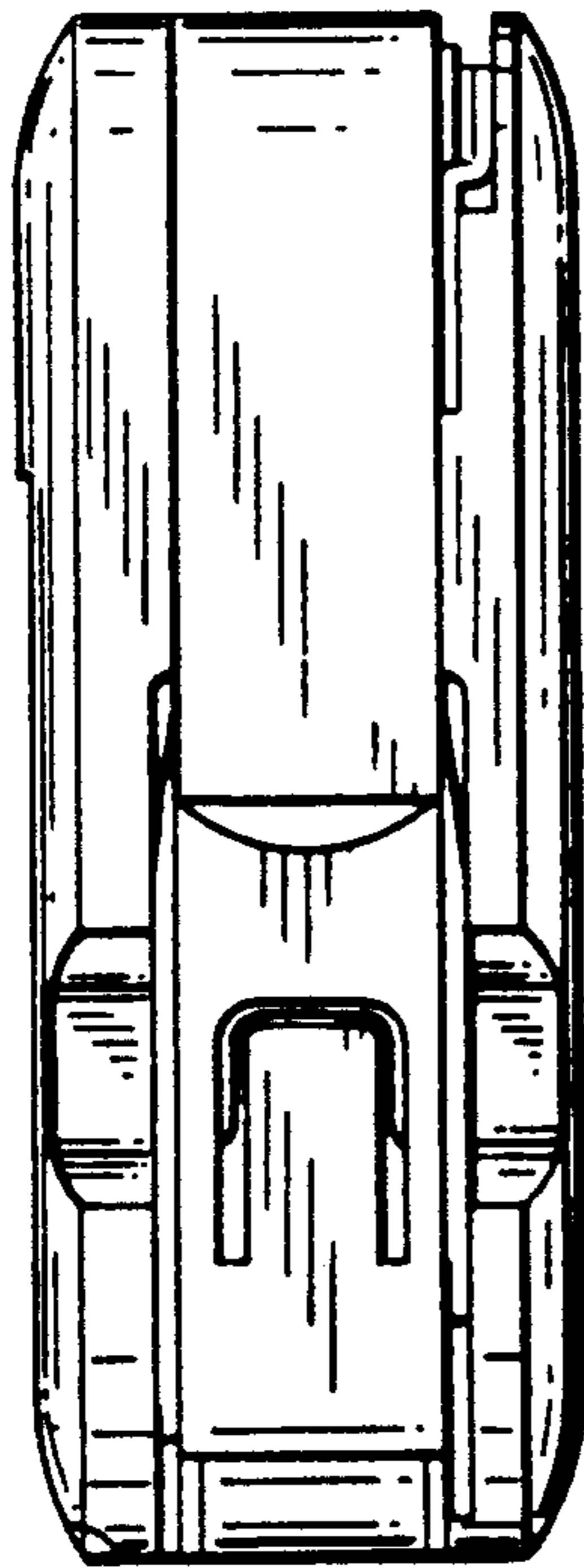

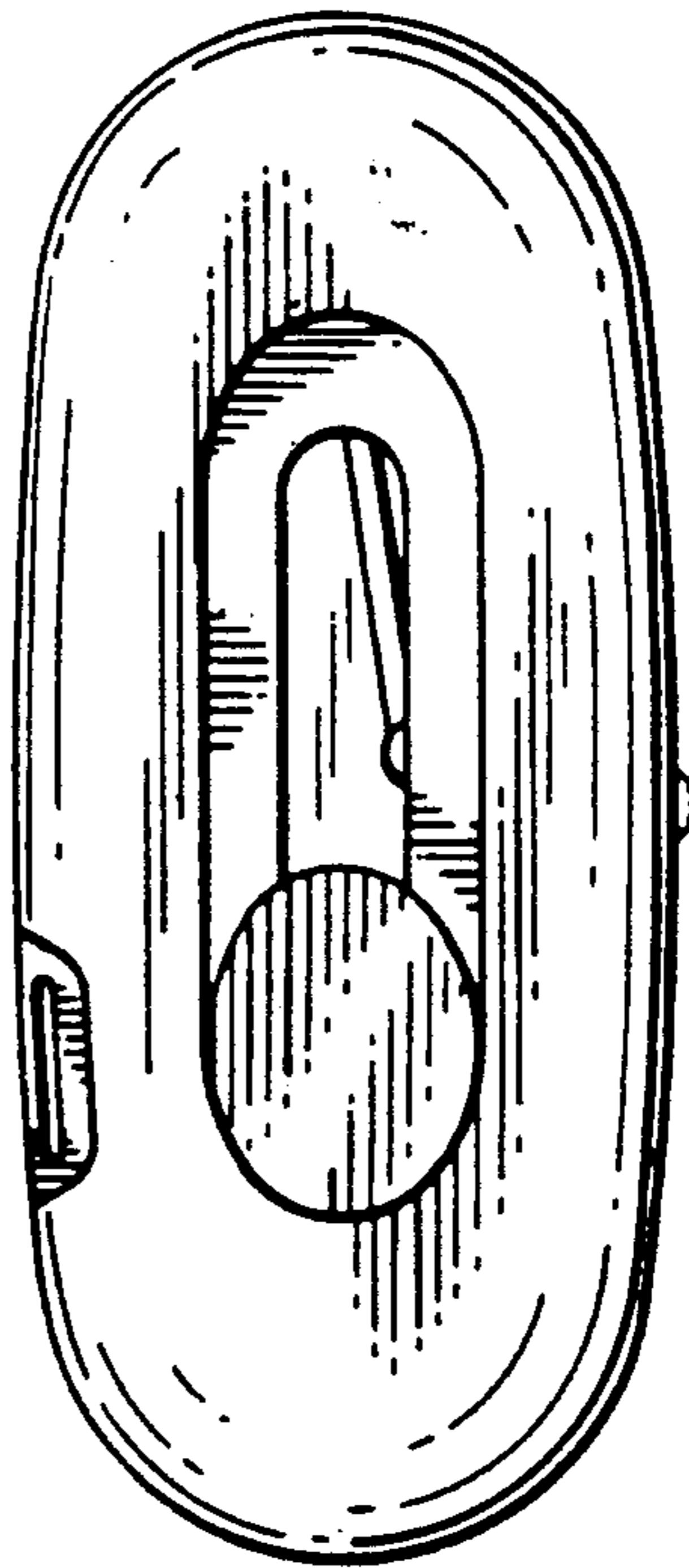

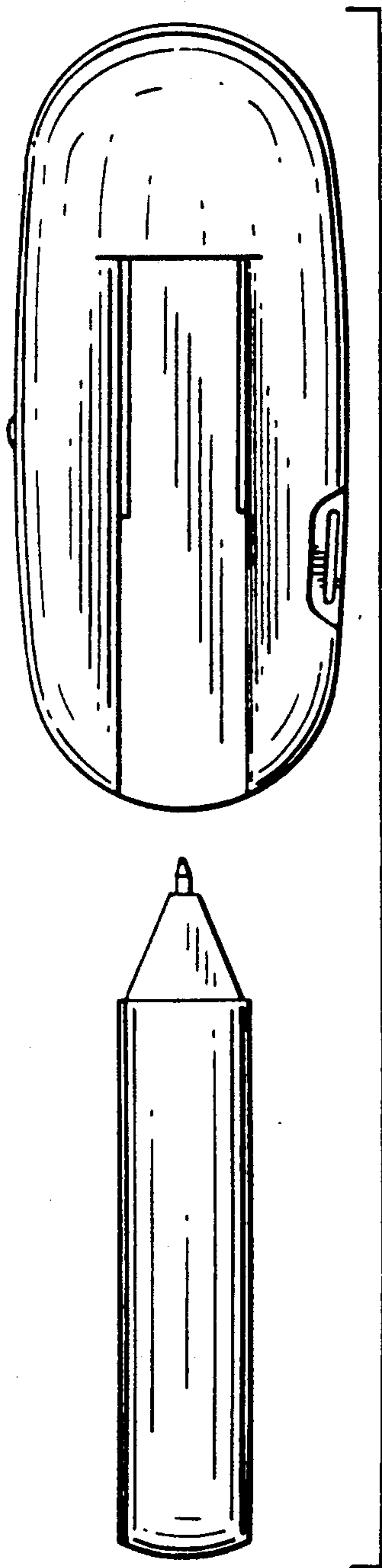

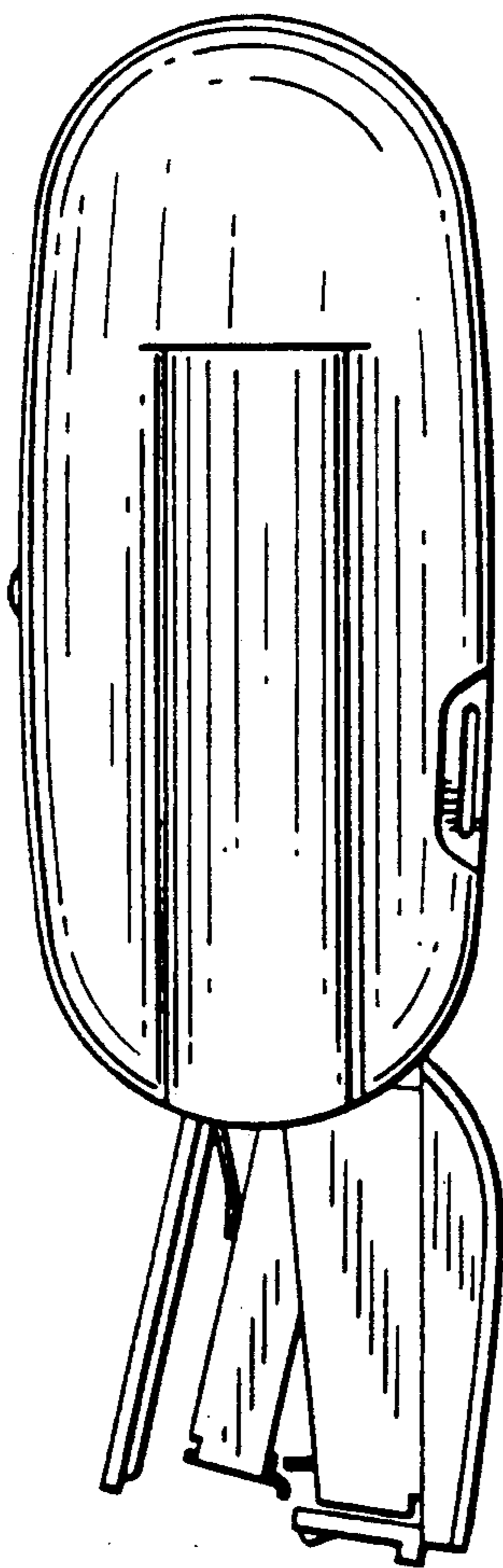

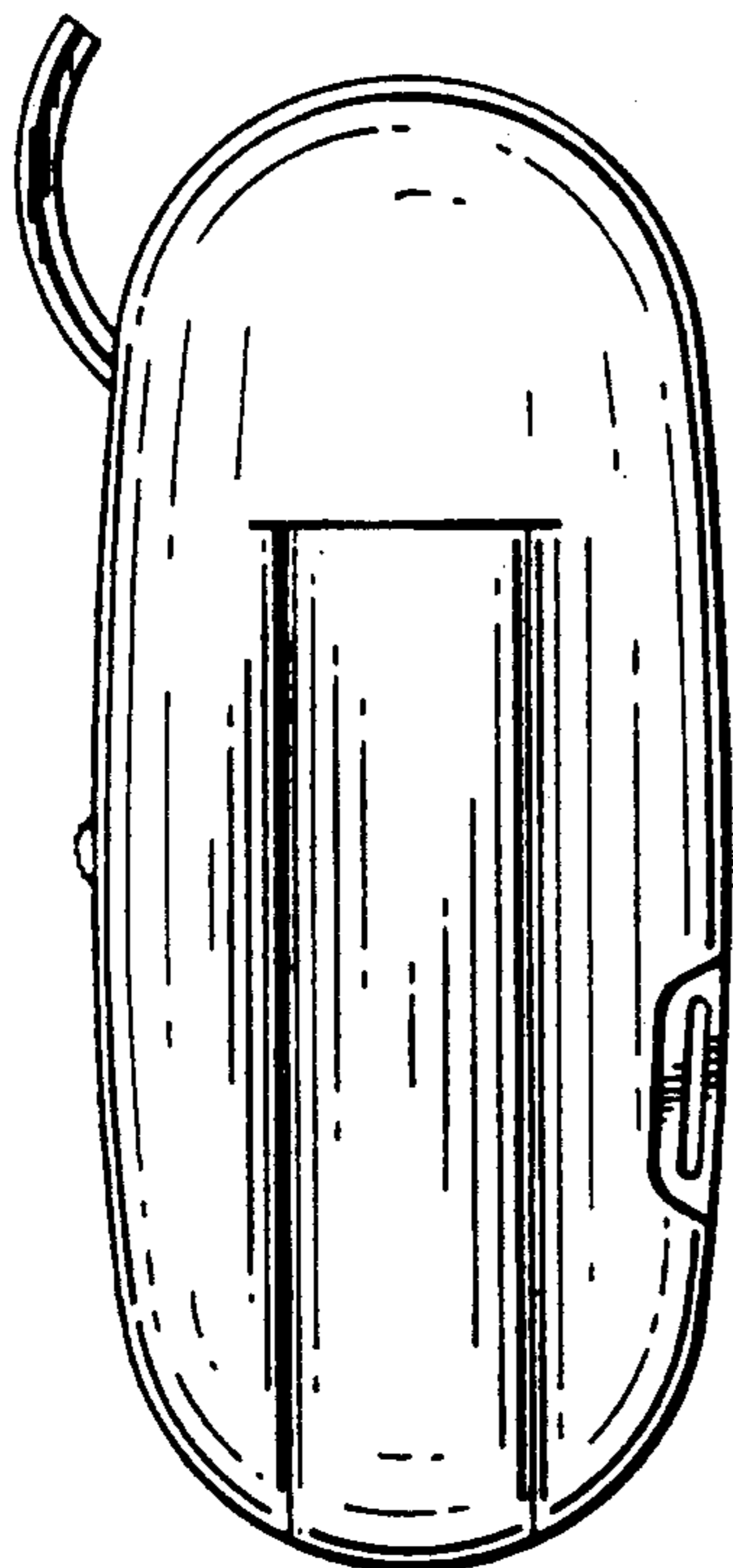

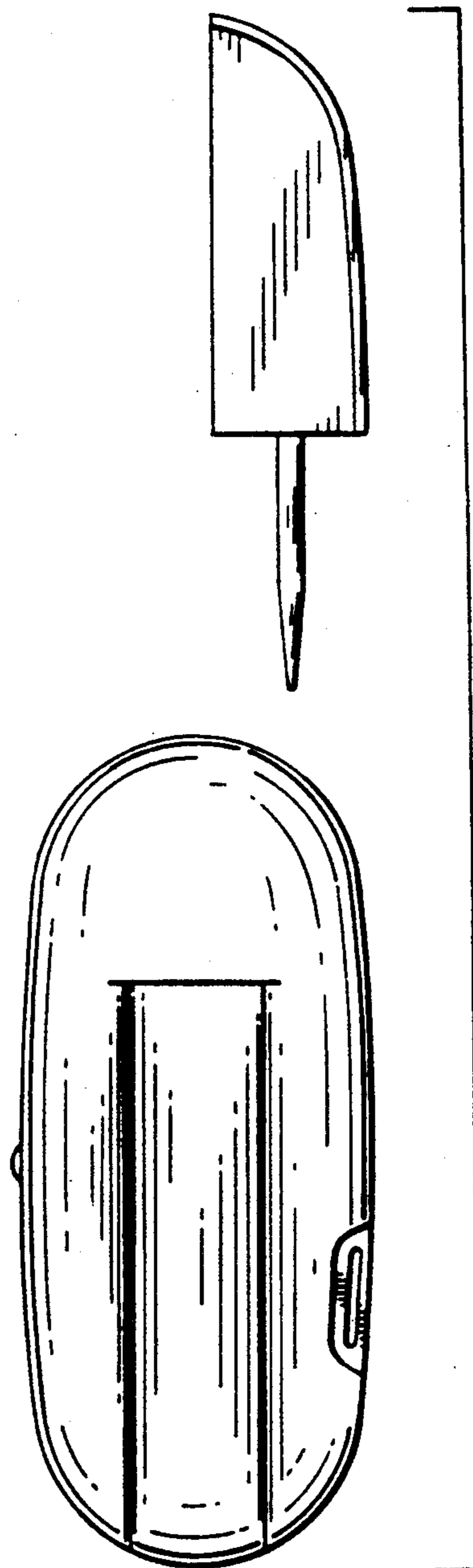

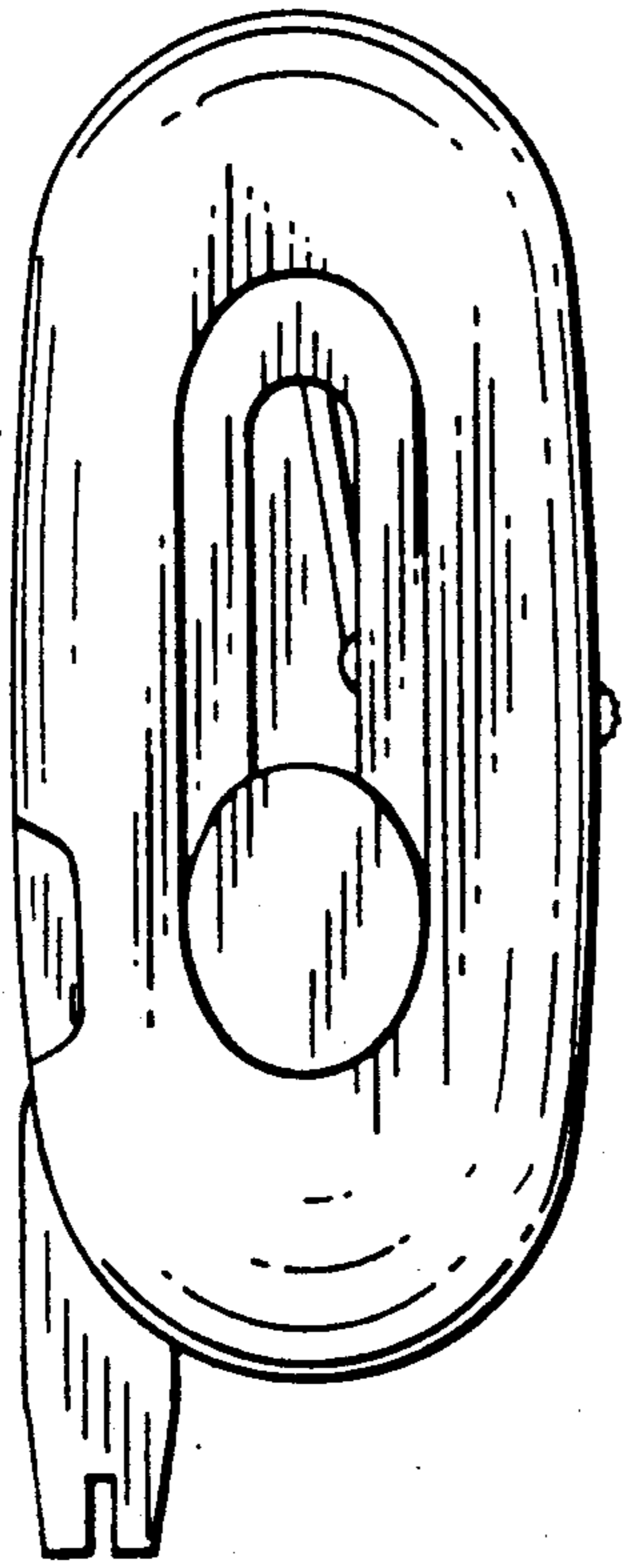

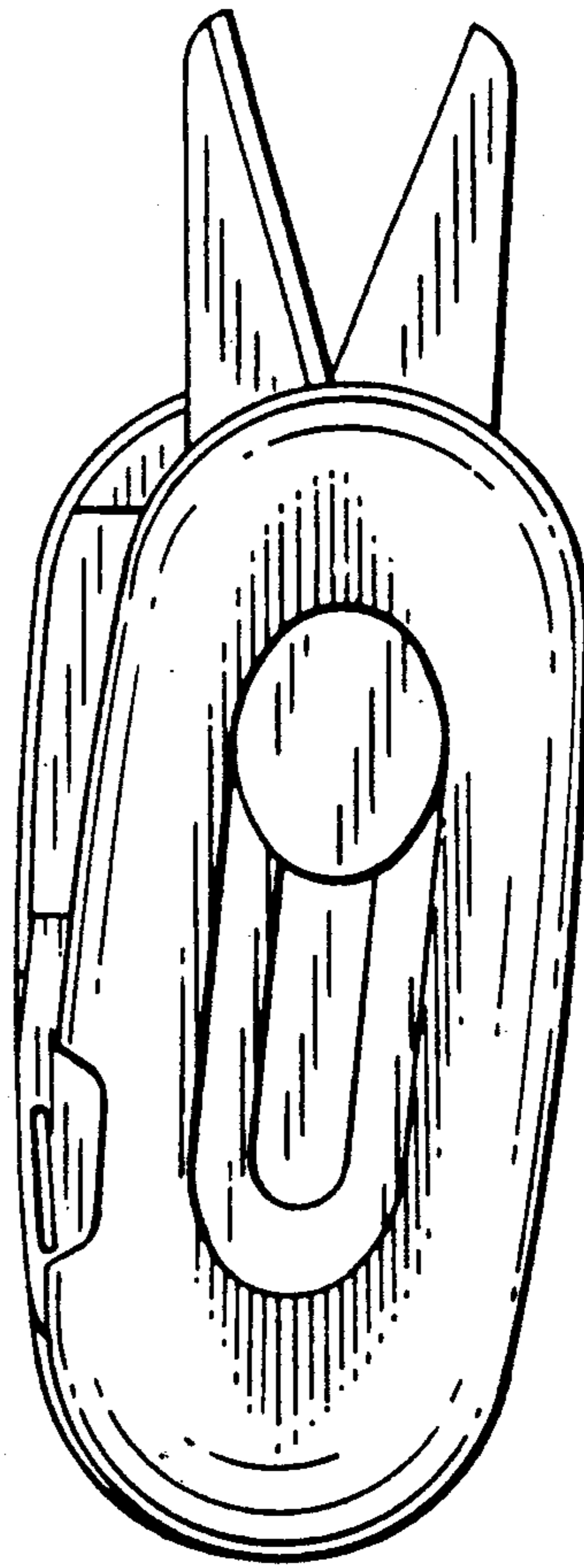

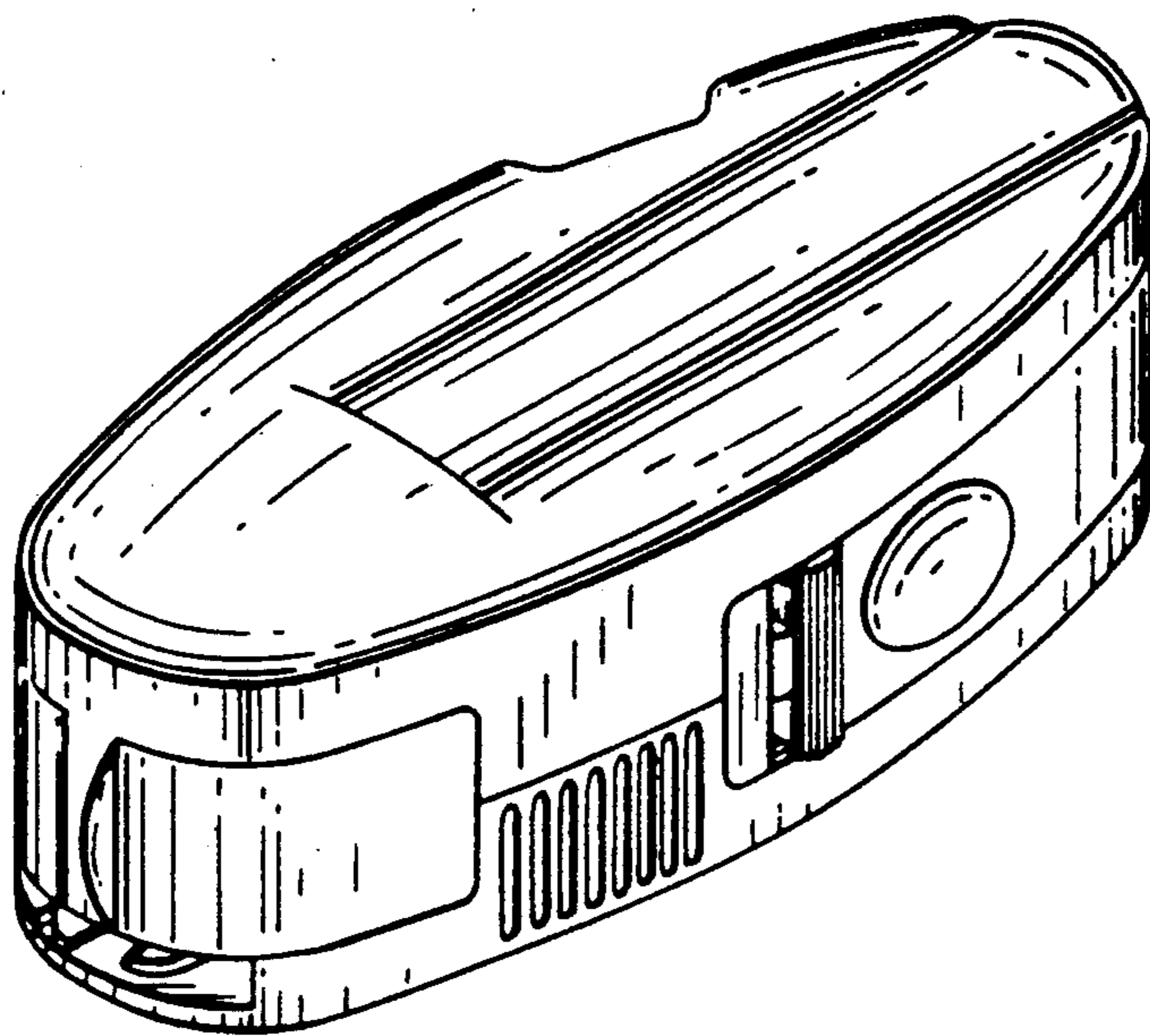
