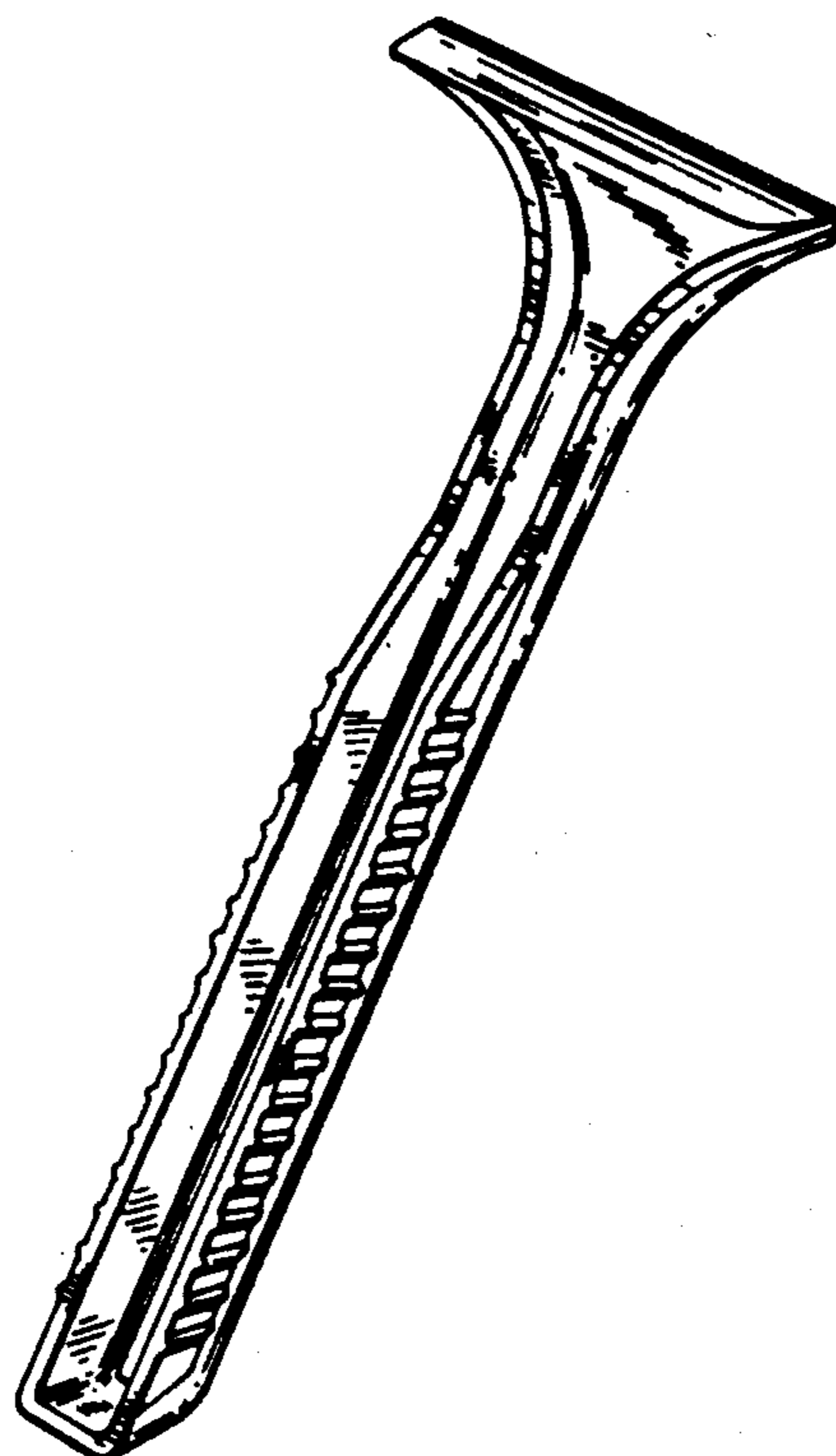

DESCRIPTION

FIG. 1 is a top plan view of a razor showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a cross-sectional view taken along line 3—3 of FIG. 1;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a cross-sectional view taken along line 5—5 of FIG. 6;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a right side elevational view thereof; and
 FIG. 8 is a perspective view thereof.



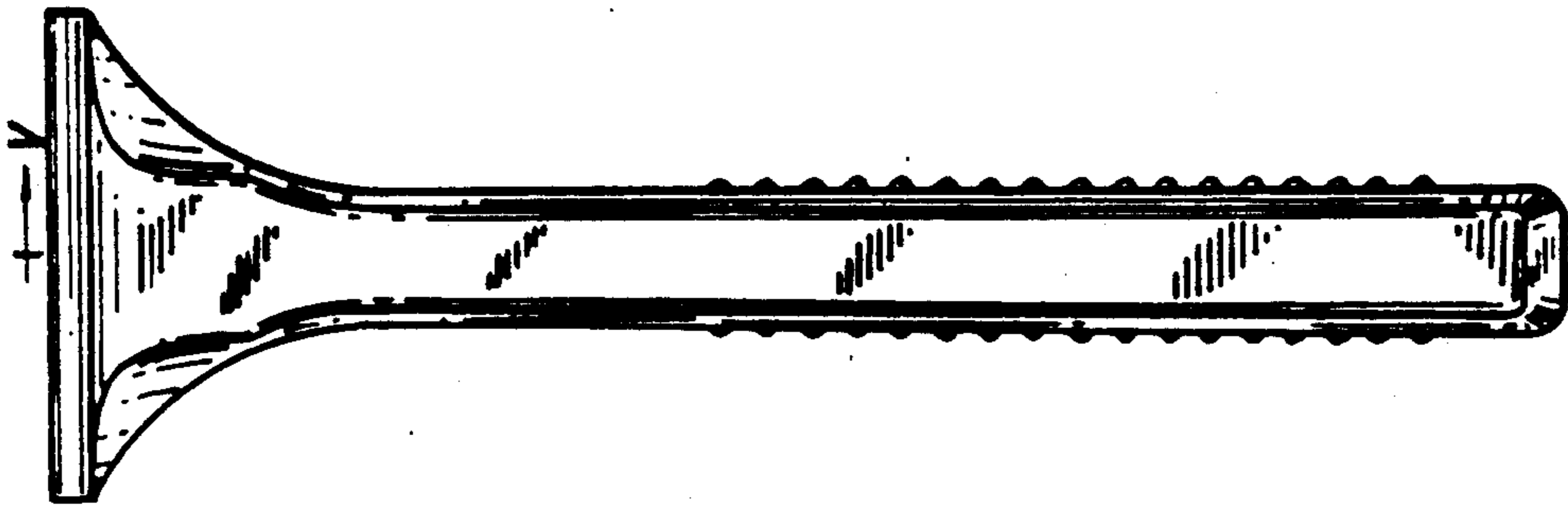

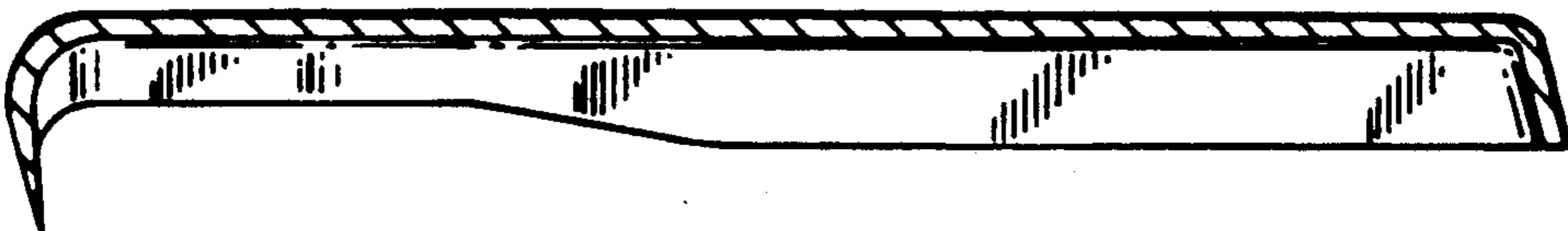

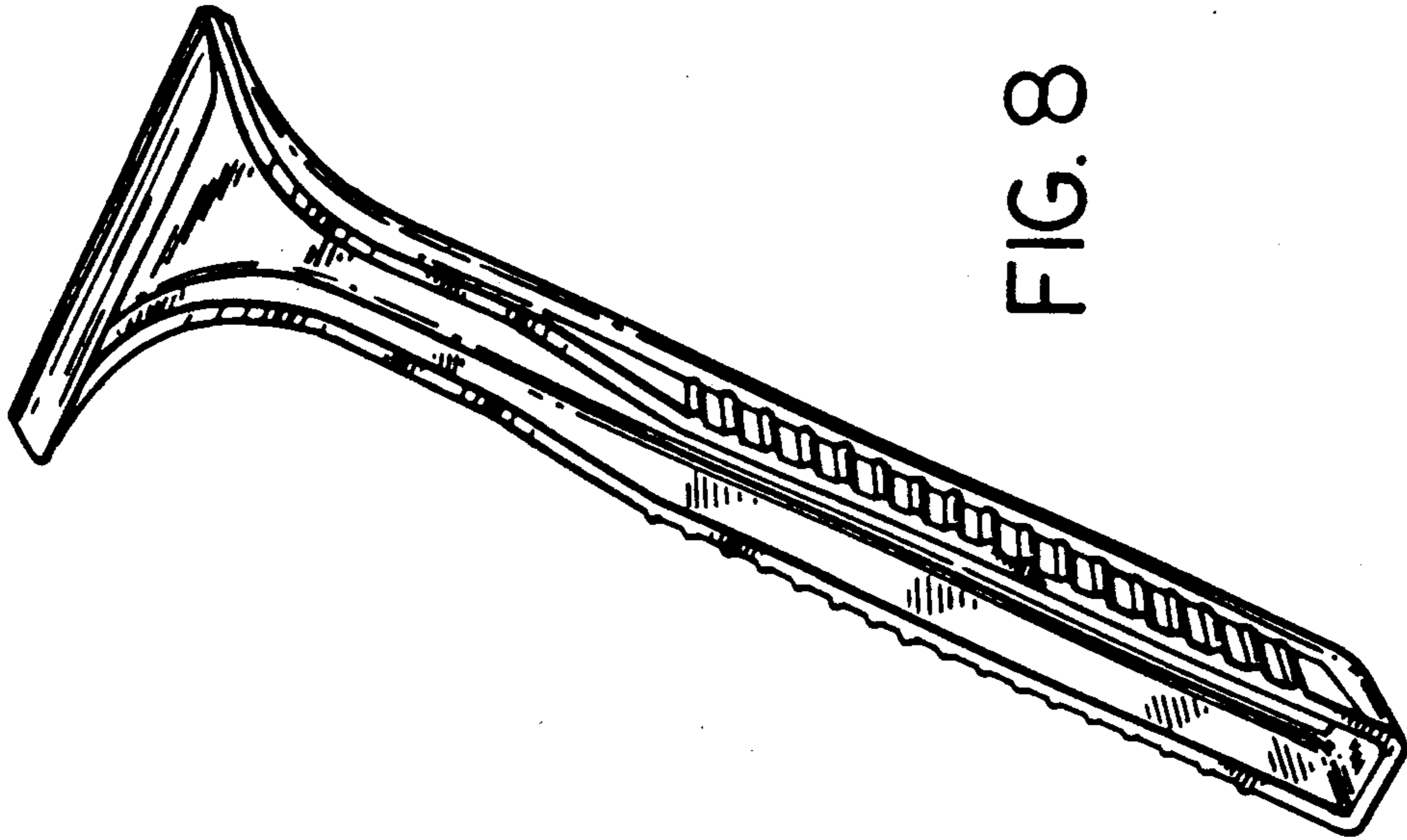
