DESCRIPTION

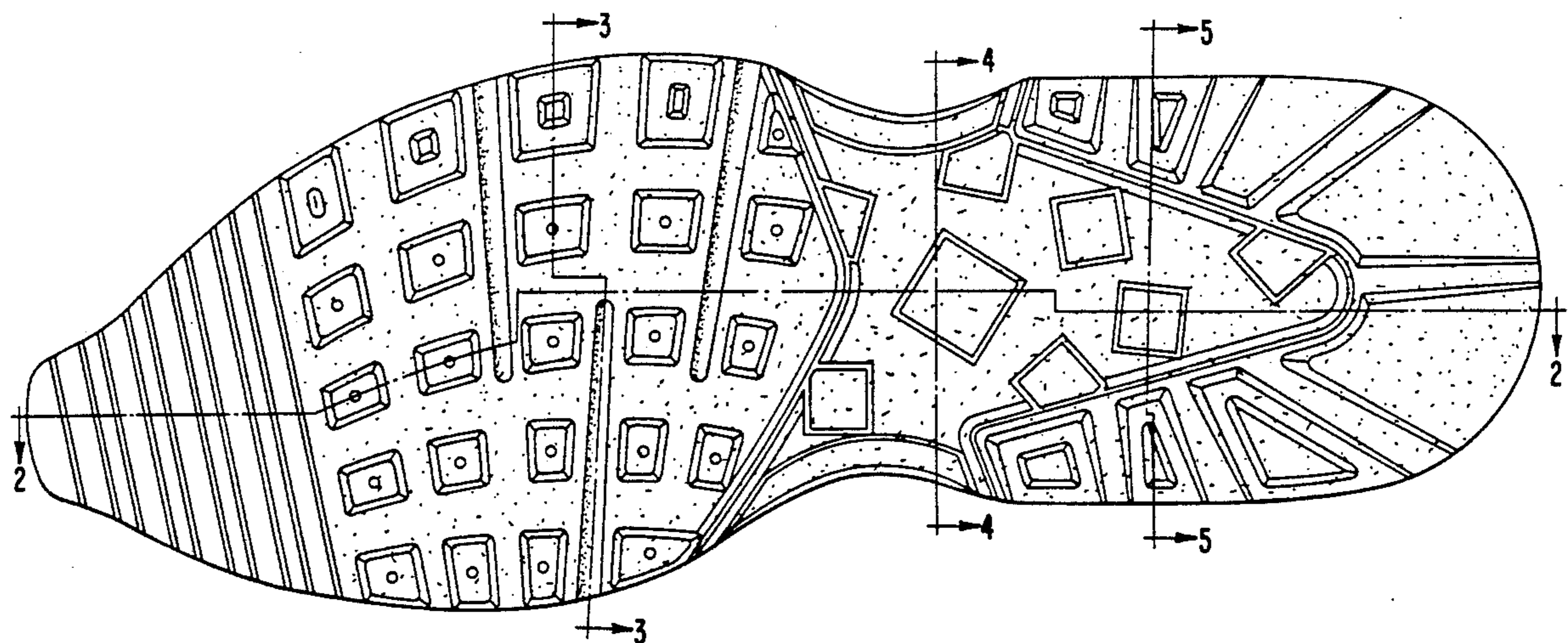
FIG. 1 is a bottom plan view of an outsole bottom showing my new design;

FIG. 2 is a cross-section taken generally along line 2-2 of FIG. 1;

FIG. 3 is a cross-section taken generally along line 3-3 of FIG. 1; and

FIG. 4 is a cross-section taken generally along line 4-4 of FIG. 1; and

FIG. 5 is a cross-section taken generally along line 5-5 of FIG. 1.



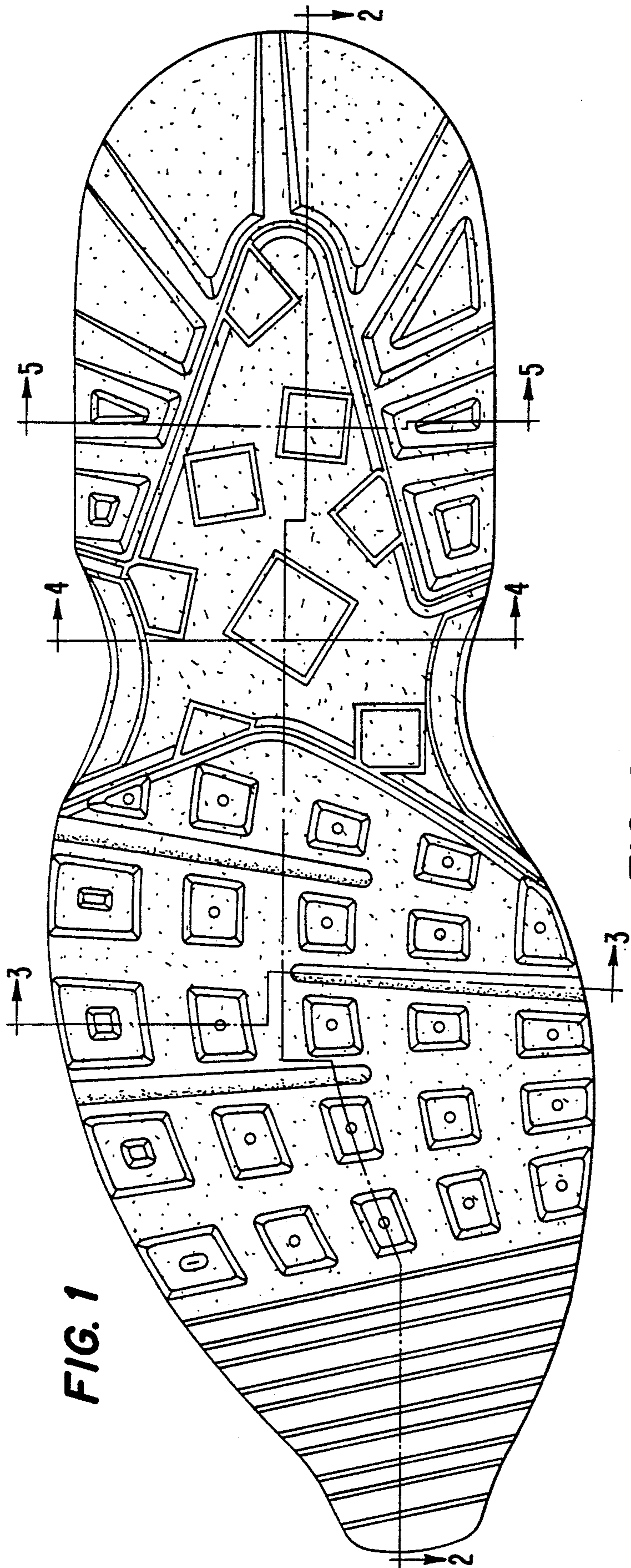
