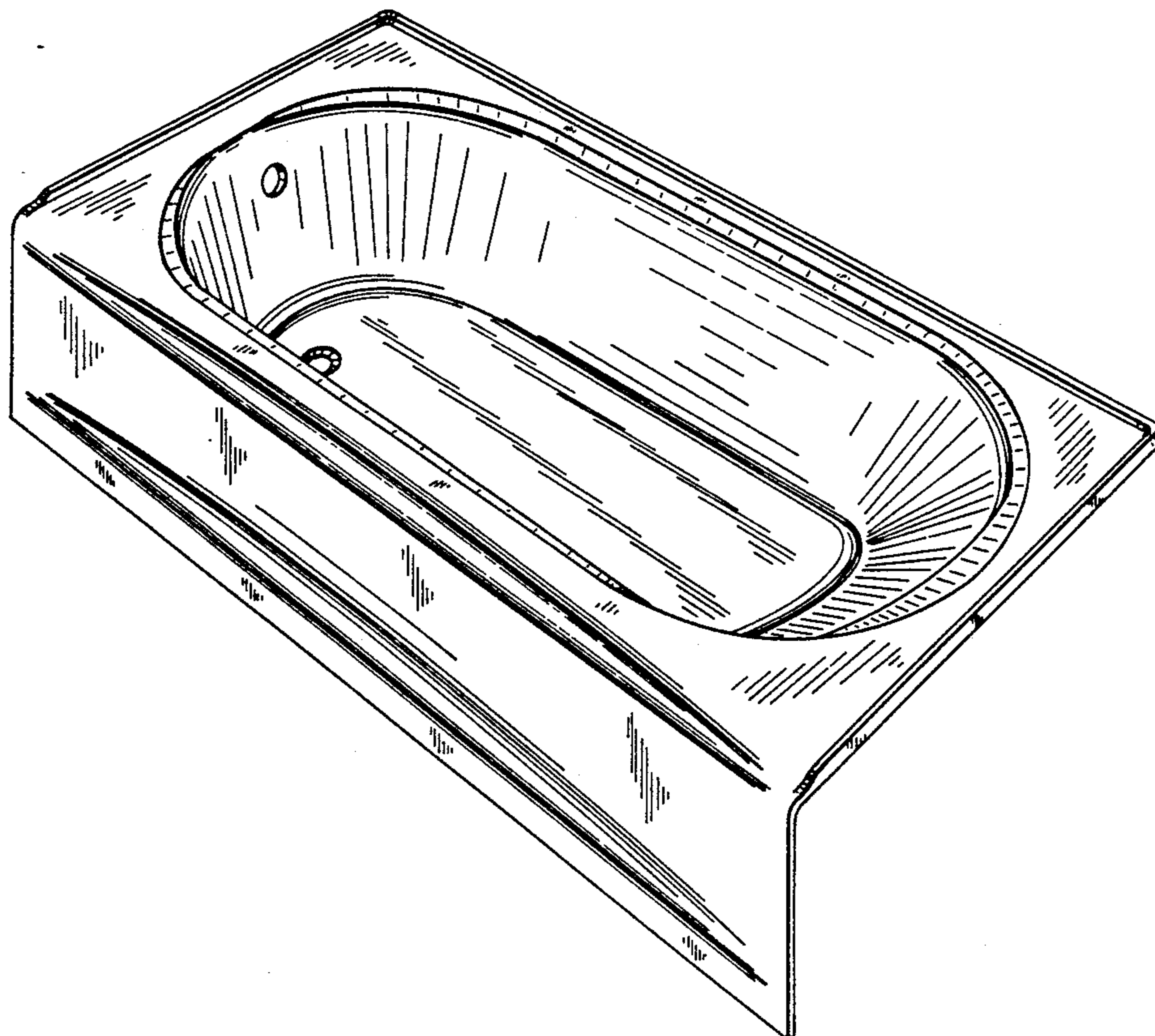

[57] CLAIM

The ornamental design of a bathtub, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a bathtub showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a left side elevational view thereof;
 FIG. 7 is a cross sectional view taken on line 7—7 of FIG. 2;
 FIG. 8 is a bottom plan view thereof;
 FIG. 9 is a top plan view of a second embodiment thereof;
 FIG. 10 is an isometric view of a third embodiment thereof;
 FIG. 11 is a right side elevational view of FIG. 10;
 FIG. 12 is an isometric view of a fourth embodiment thereof;
 FIG. 13 is a right side elevational view of FIG. 12;

 FIG. 15 is a right side elevational view of FIG. 14.



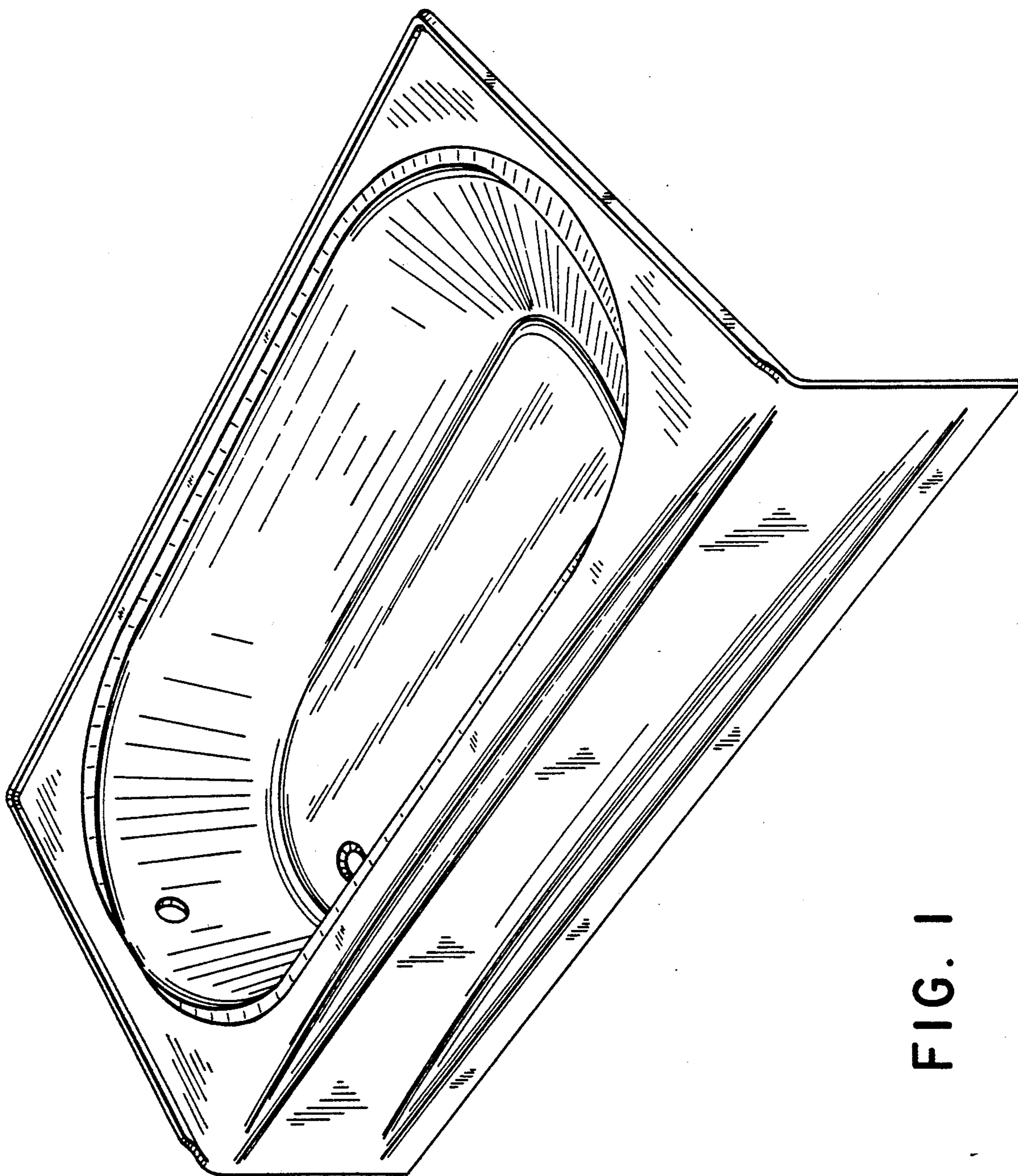

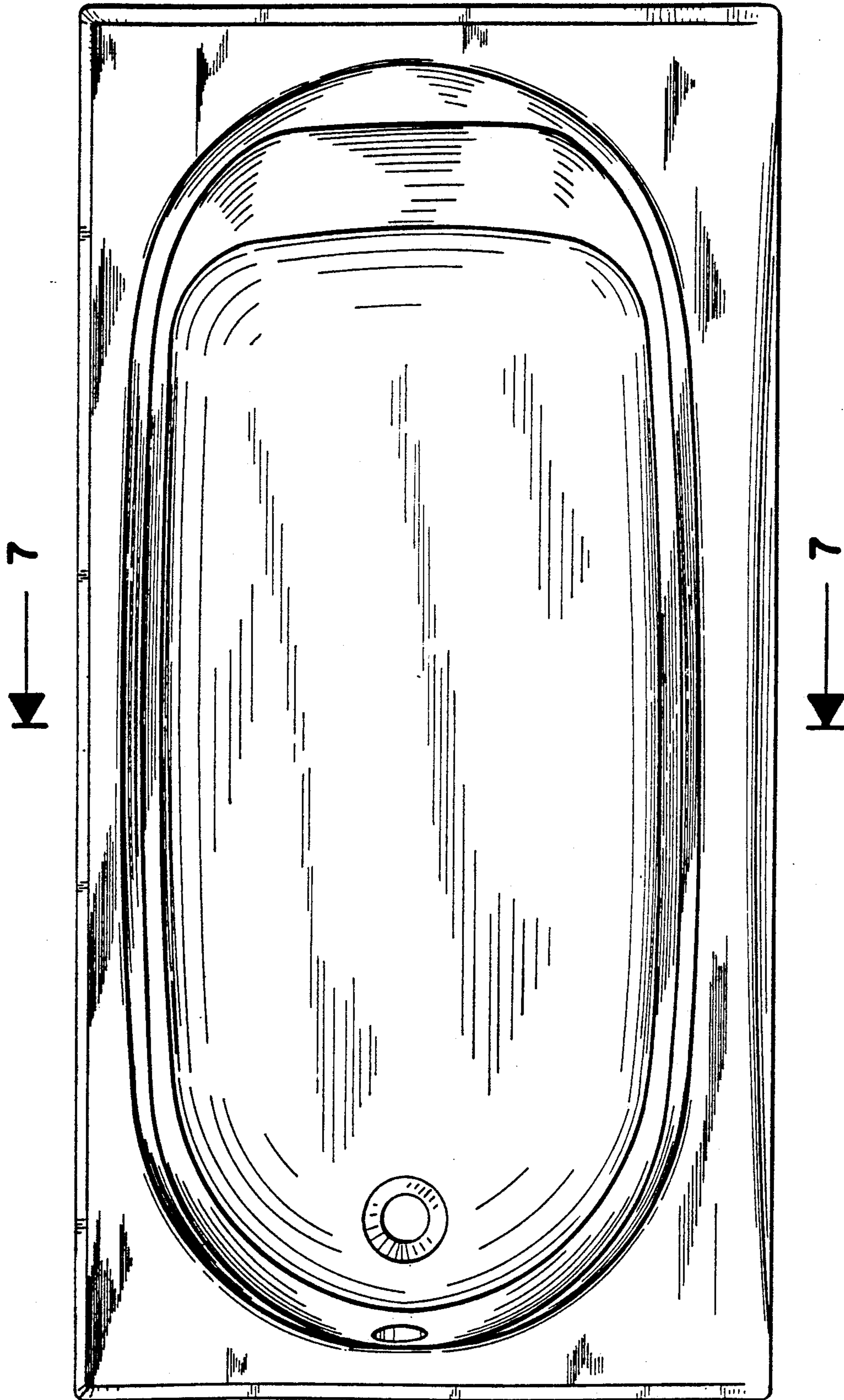

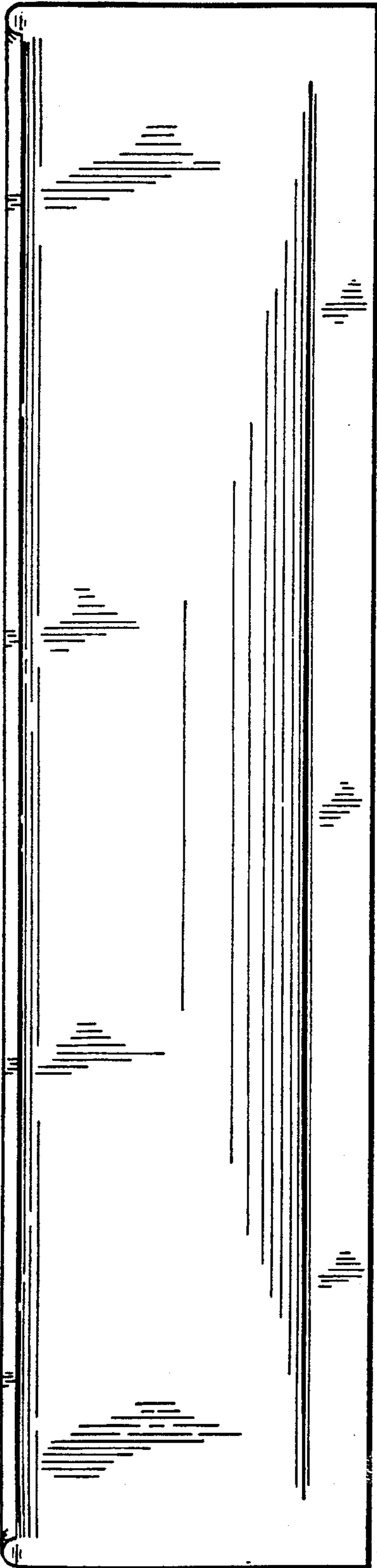

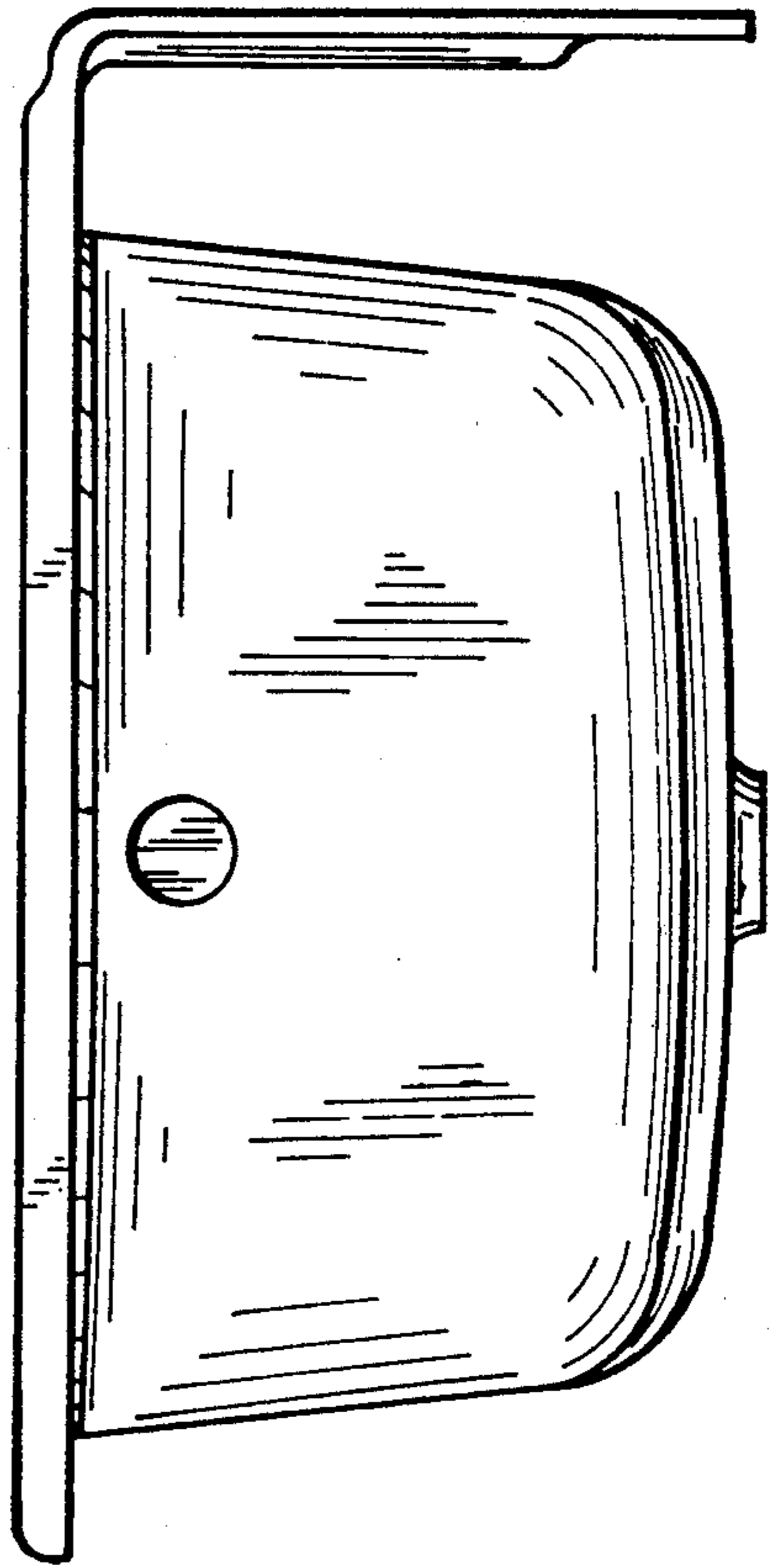

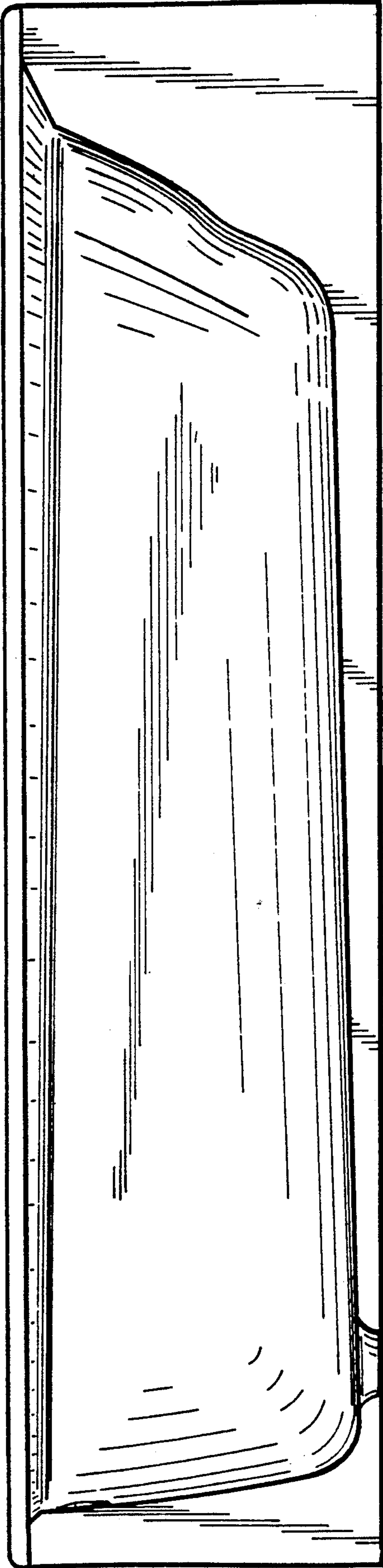

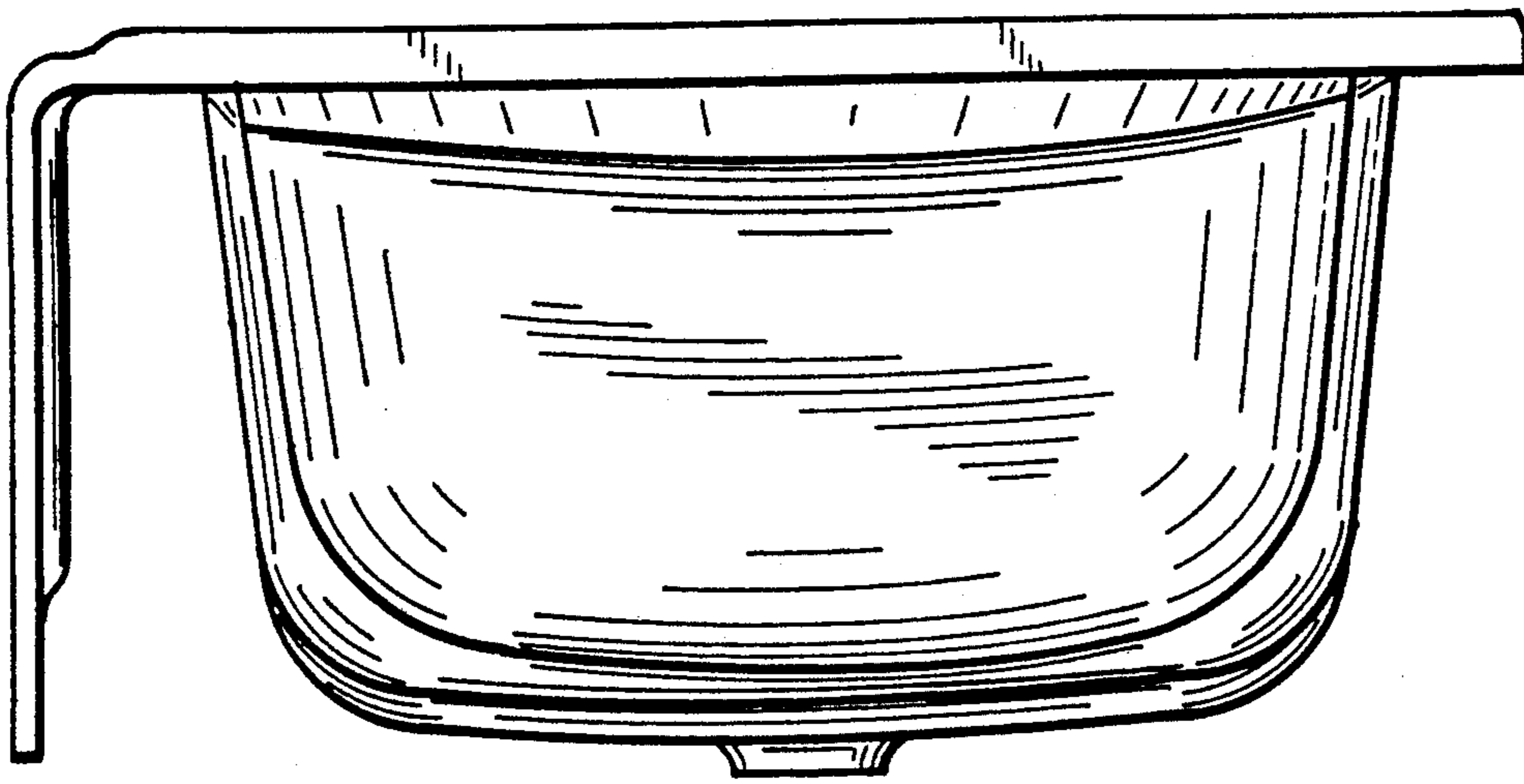

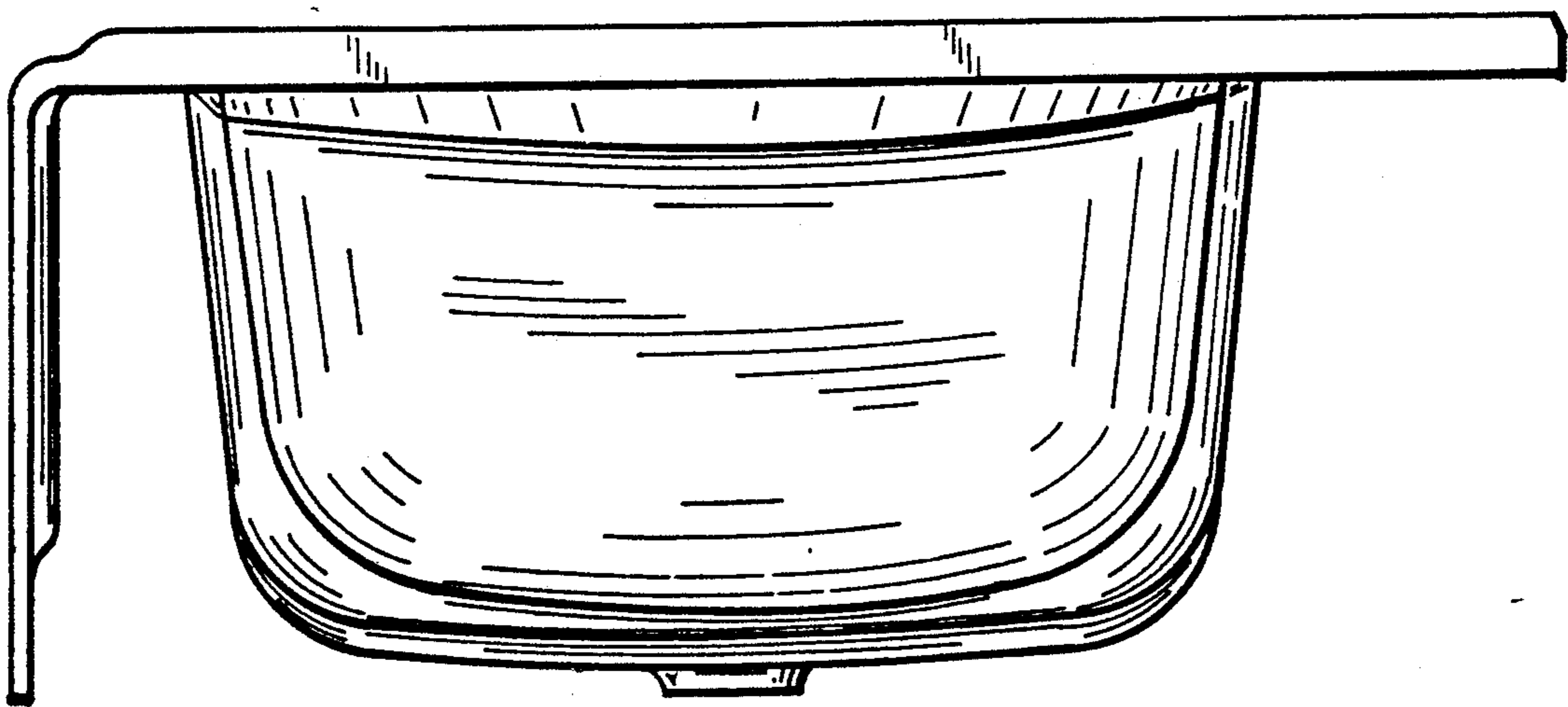

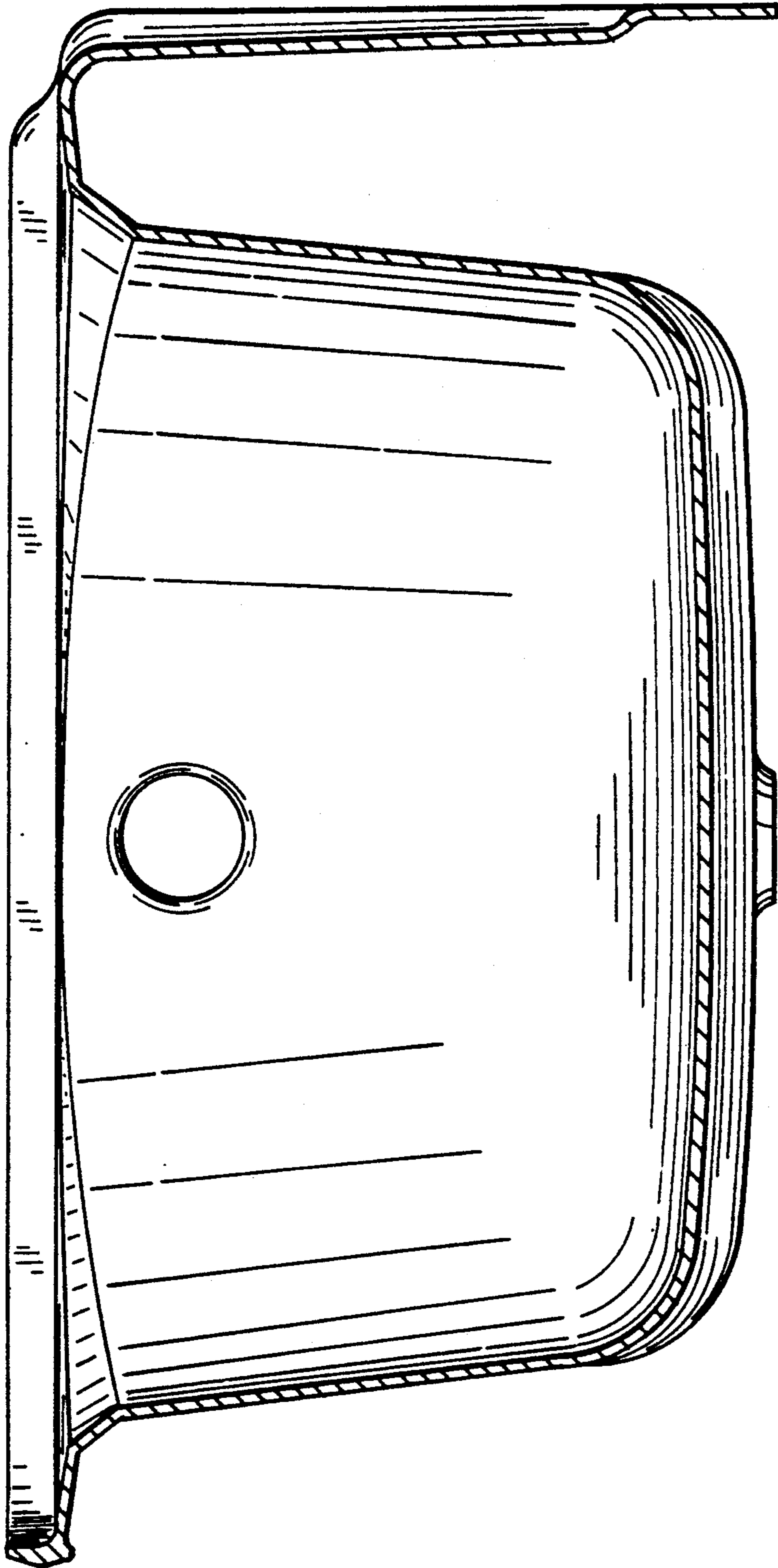

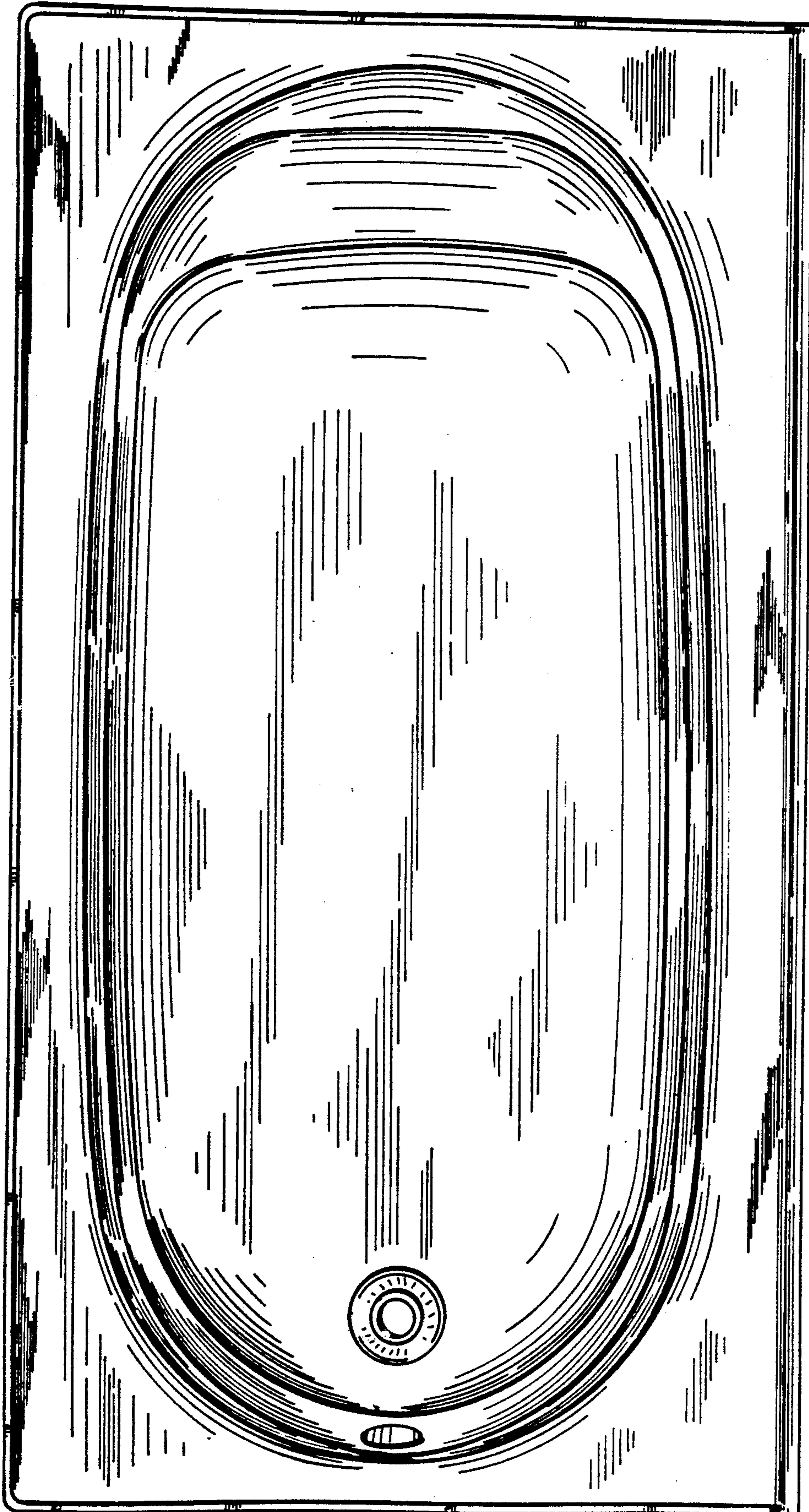

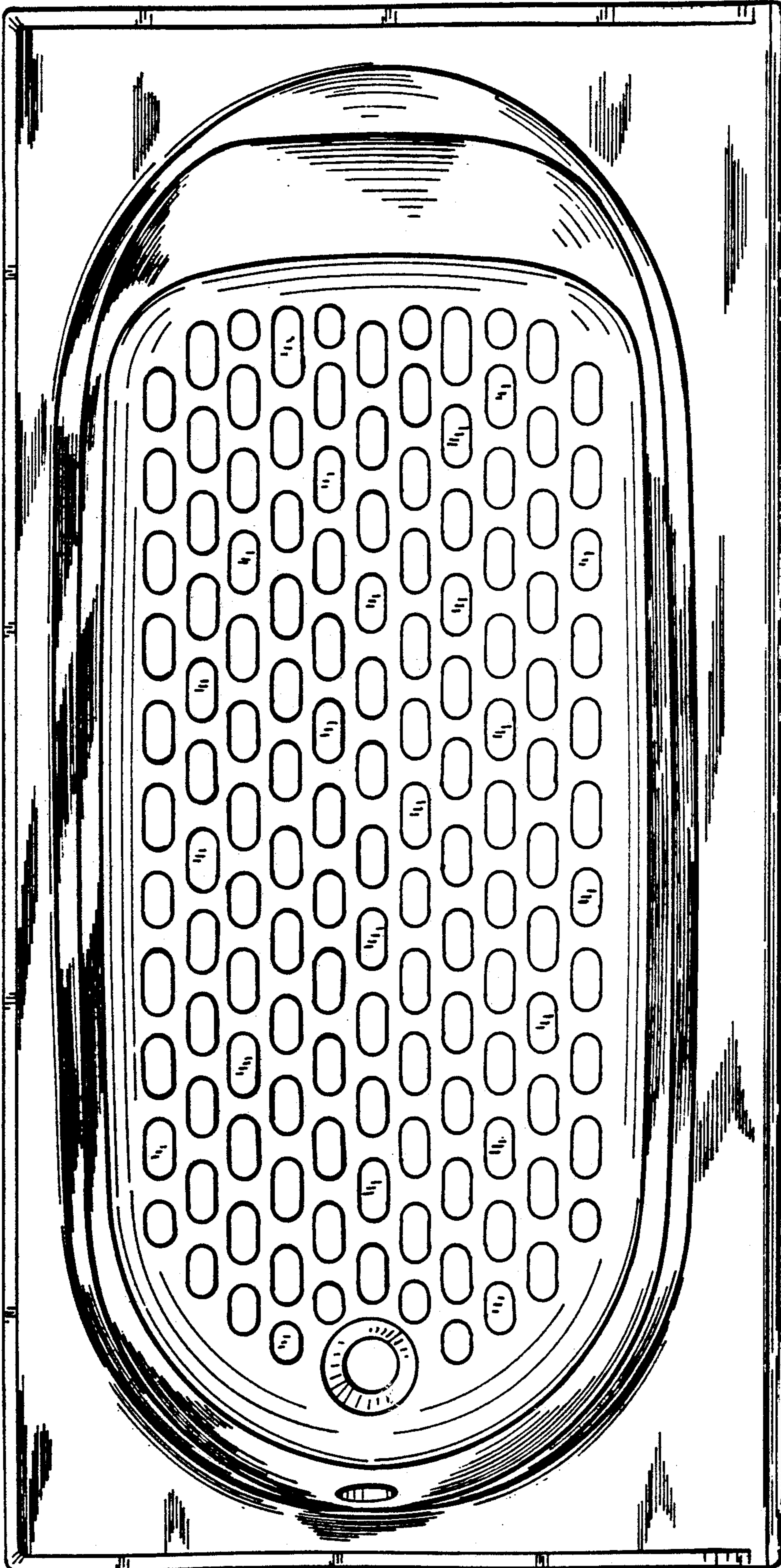

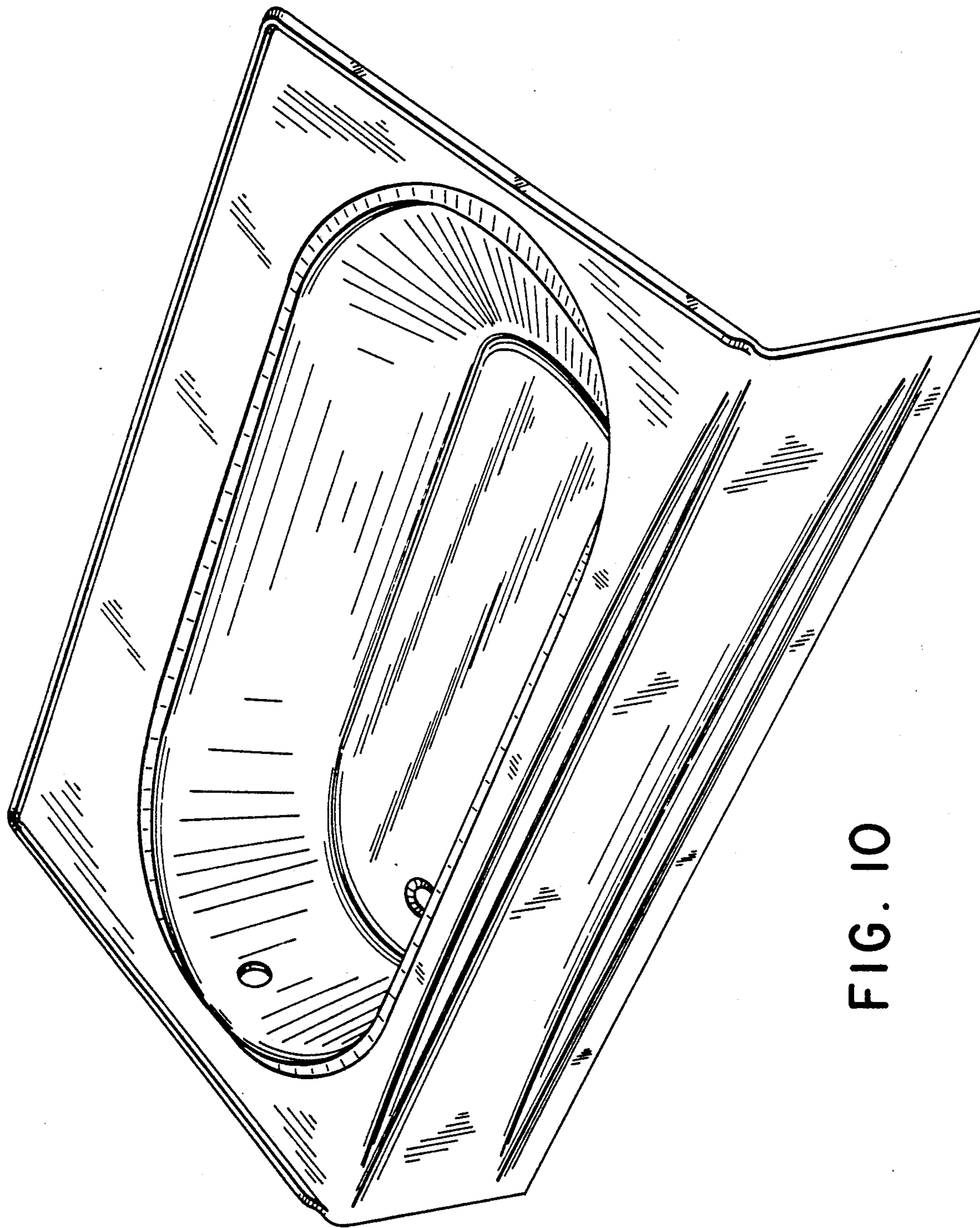

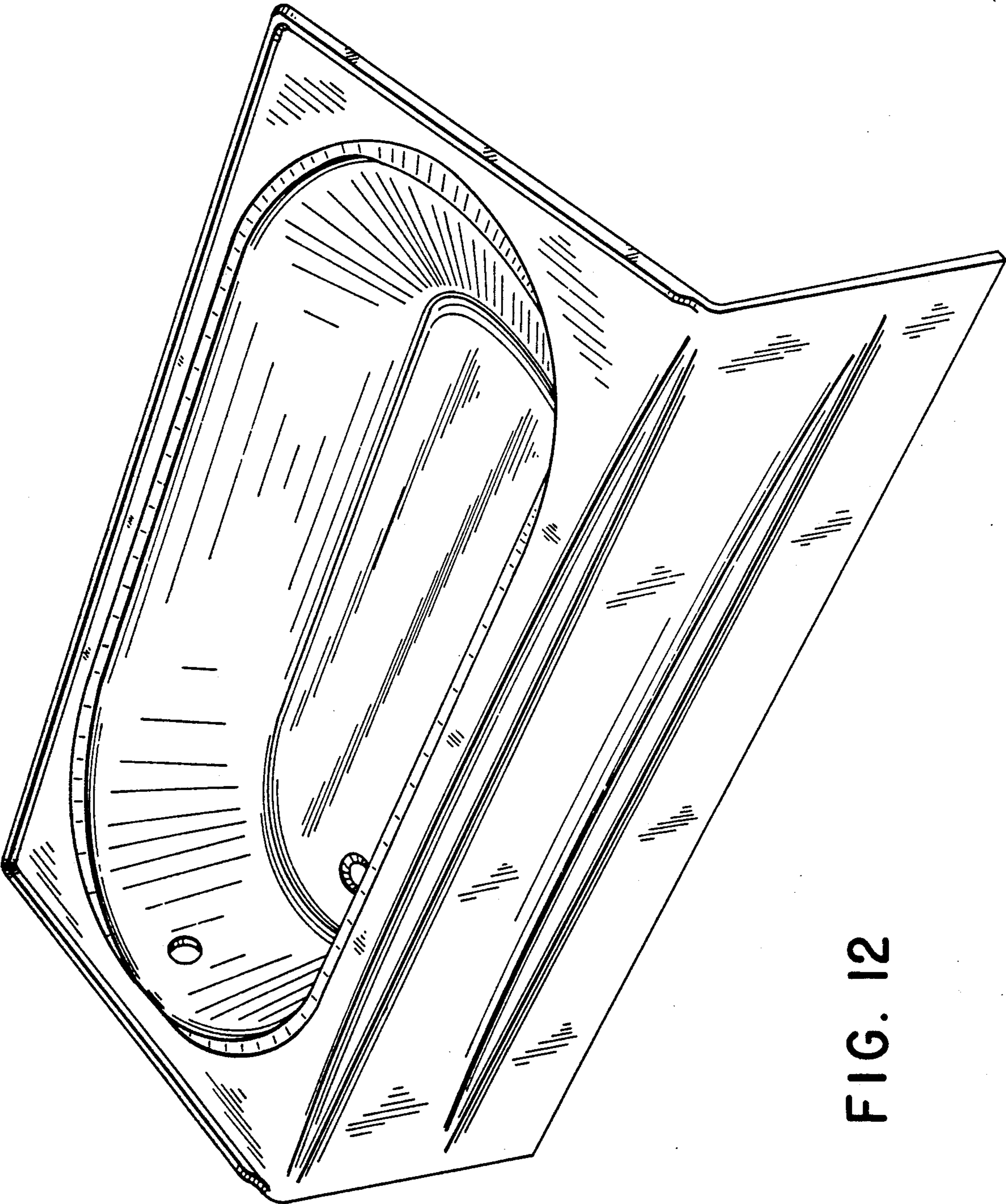

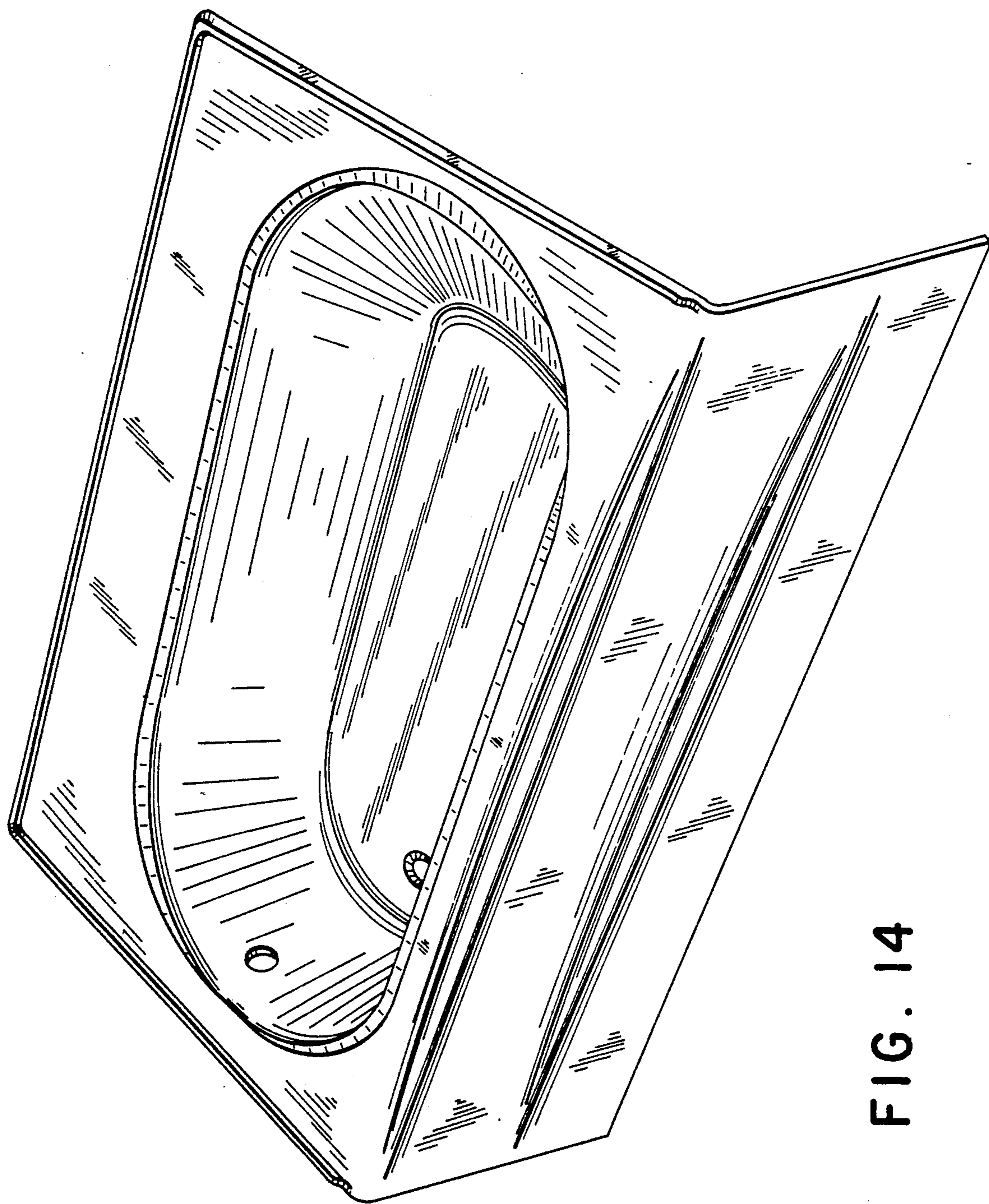

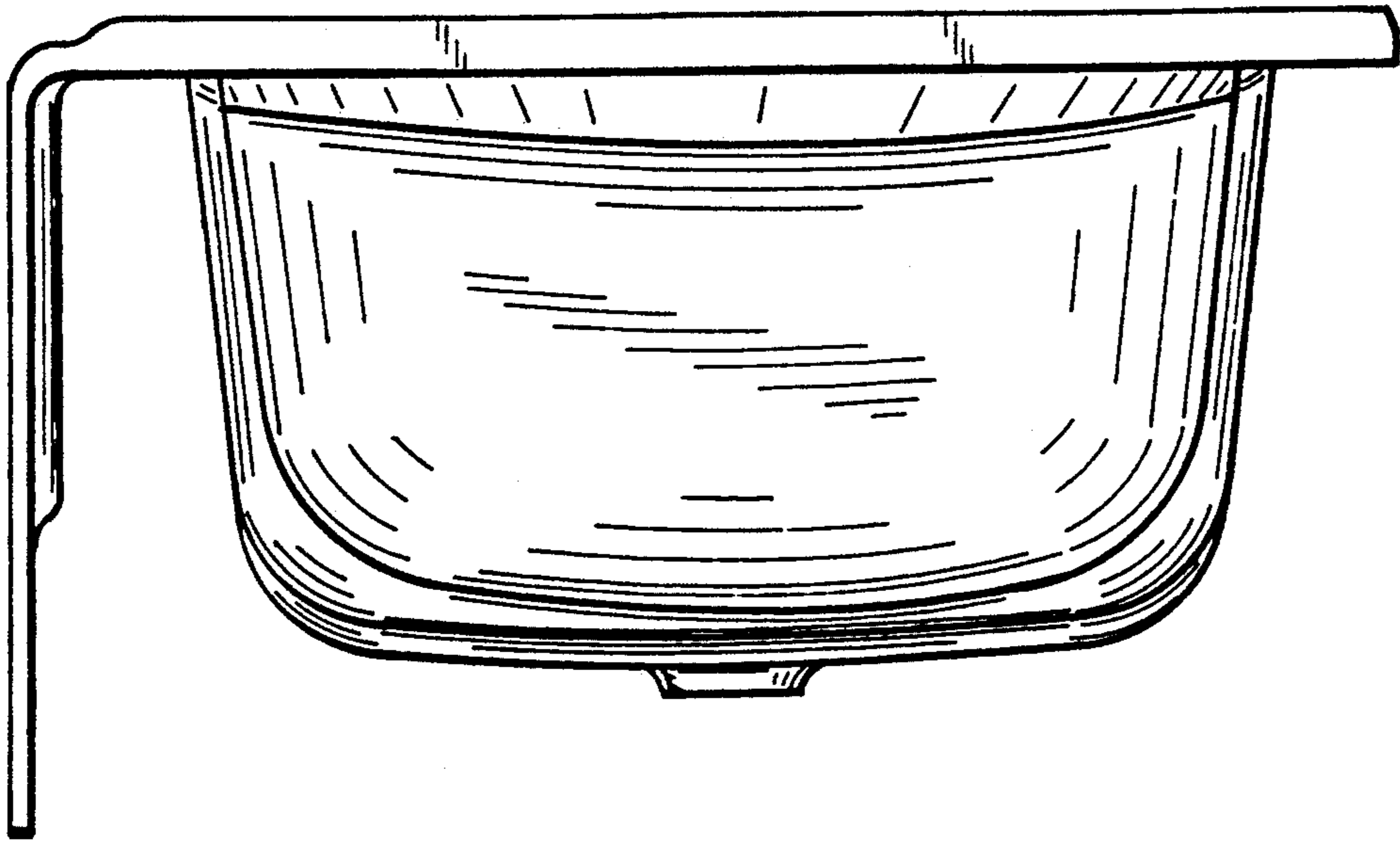

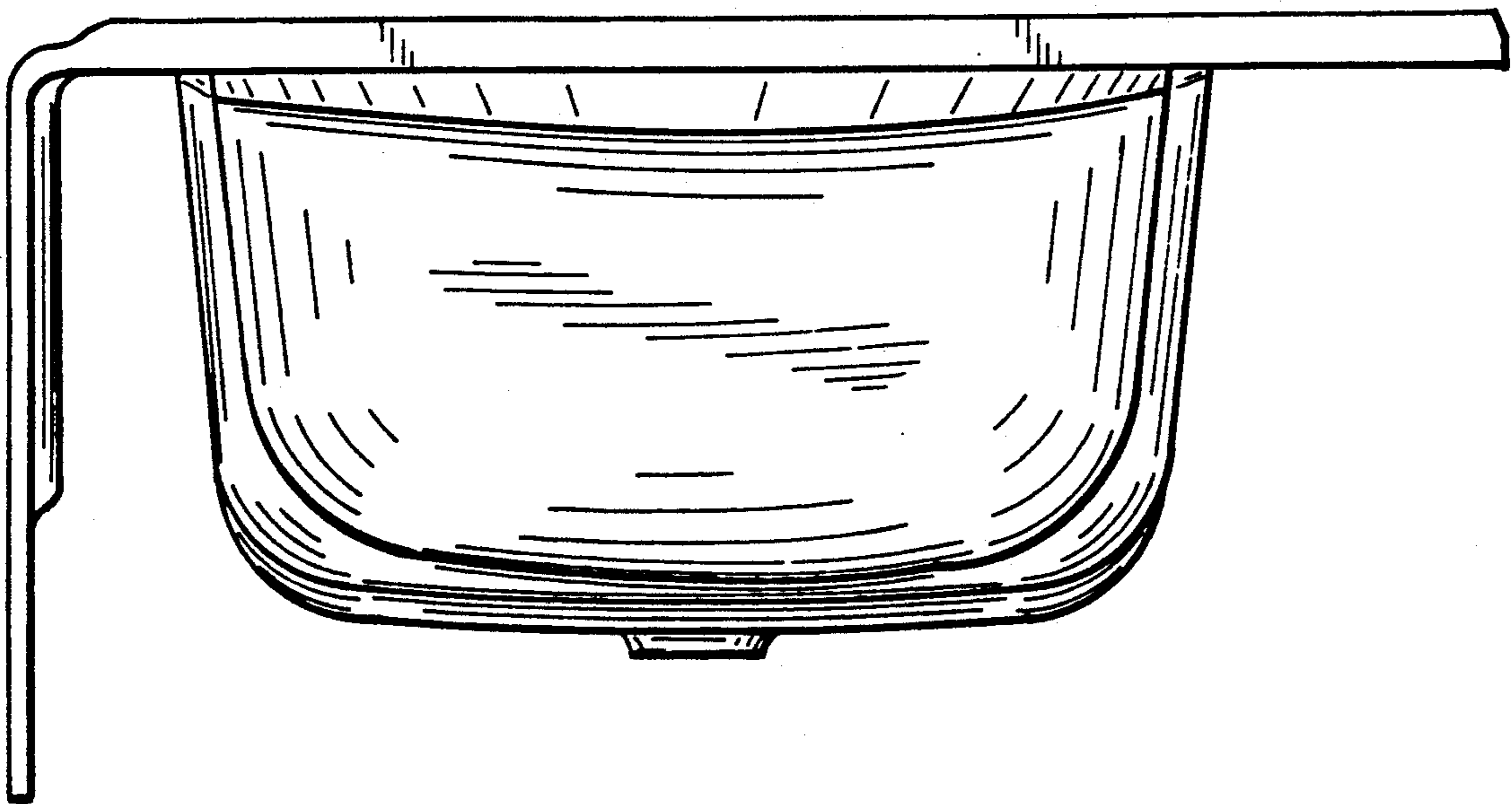
