The ornamental design for a three point extrusion, as  
shown and described.

**DESCRIPTION**  
FIG. 1 is a perspective view of a three point extrusion  
showing my new design;  
FIG. 2 is a right side elevational view thereof, as  
viewed in FIG. 3, the left side elevational view being  
substantially identical;  
FIG. 3 is a front elevational view thereof, the rear ele-  
vational view being substantially identical;  
FIG. 4 is a top plan view thereof, the bottom plan view  
being substantially identical;  
FIG. 5 is a perspective view of a second embodiment of  
a three point showing another extrusion showing my  
new design;  
FIG. 6 is a right side elevational view thereof, as  
viewed in FIG. 7, the left side elevational view being  
substantially identical;  
FIG. 7 is a front elevational view thereof, the rear ele-  
vational view being substantially identical; and  
FIG. 8 is a top plan view thereof, the bottom plan view  
being substantially identical.

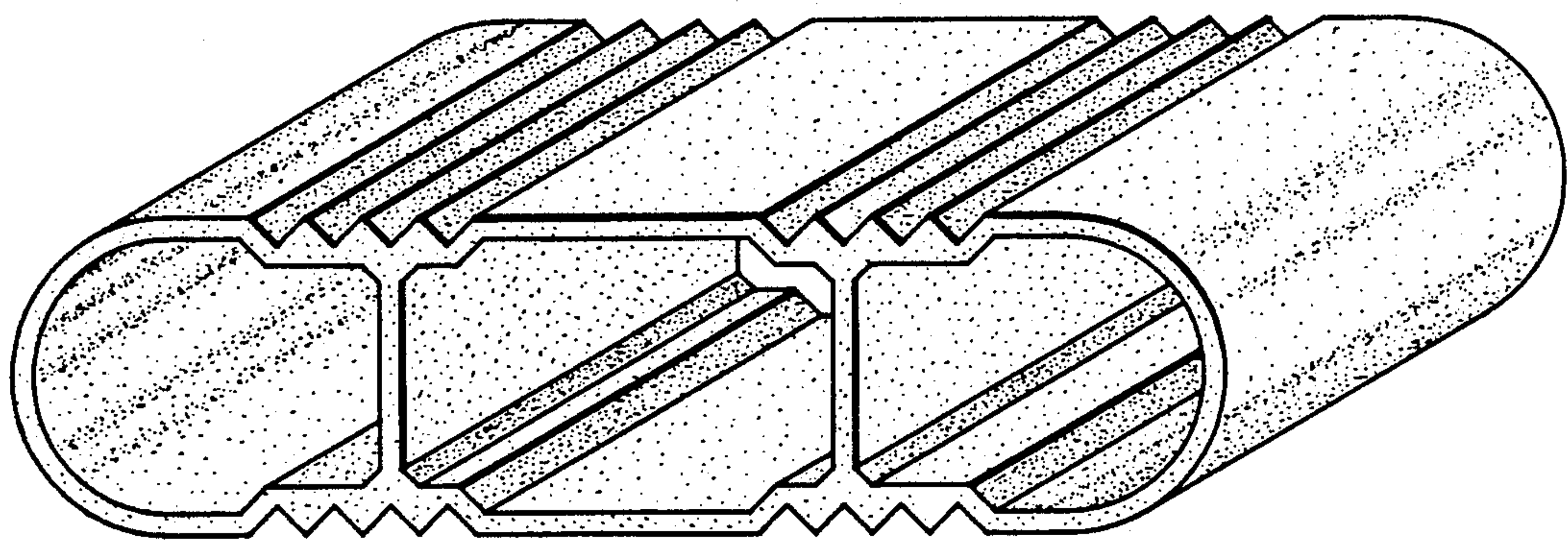

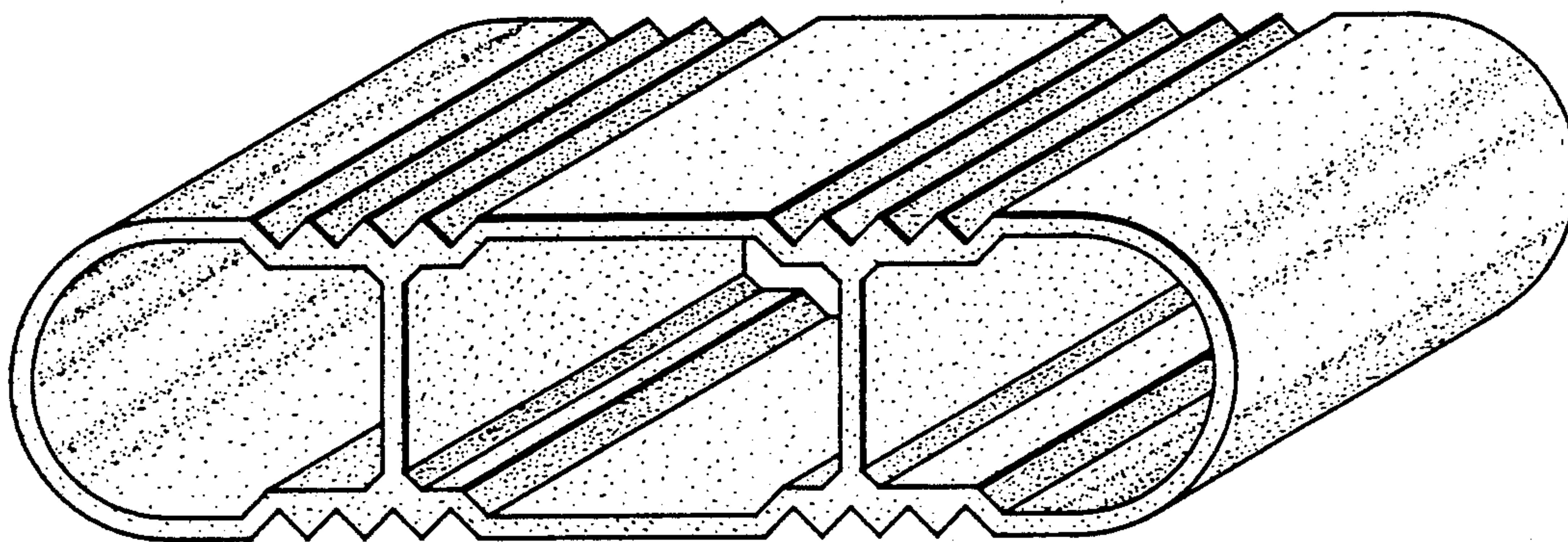
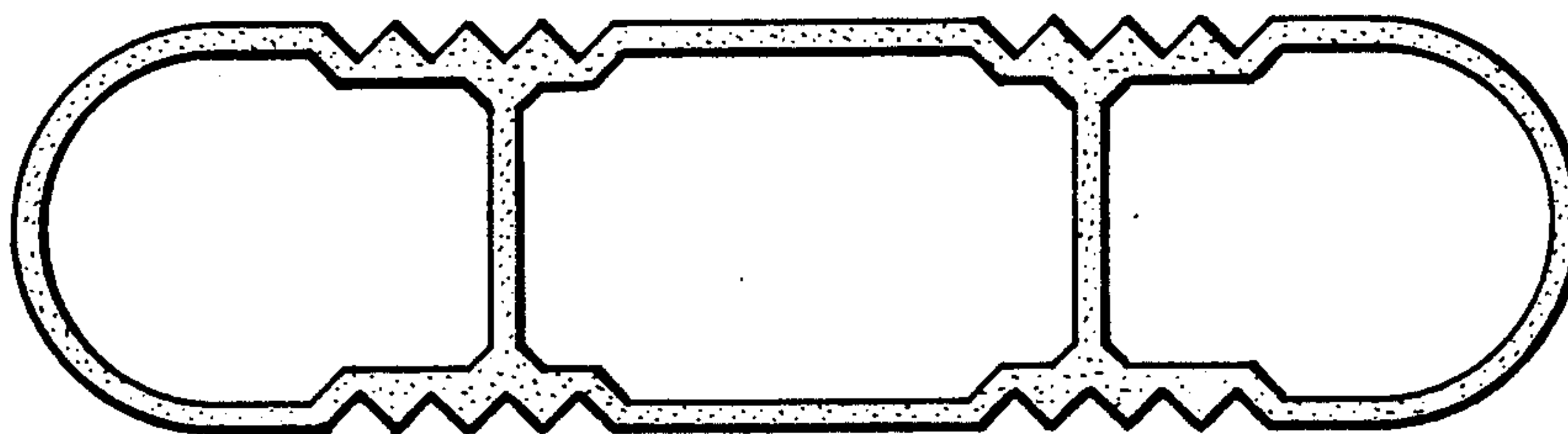
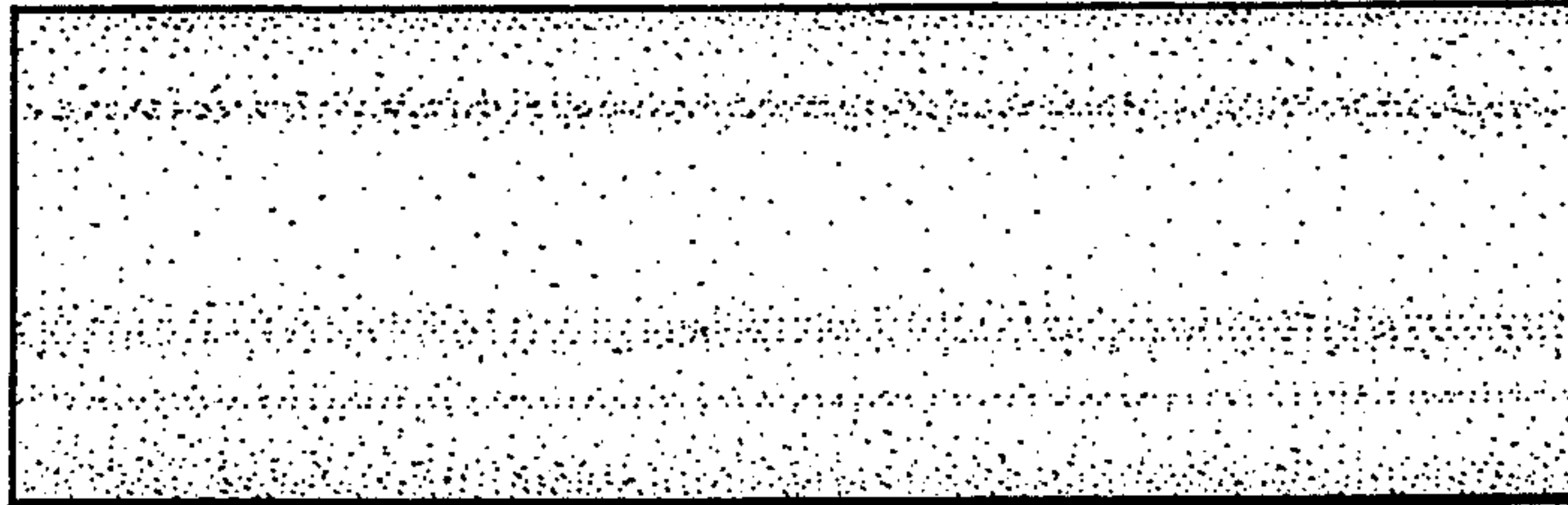


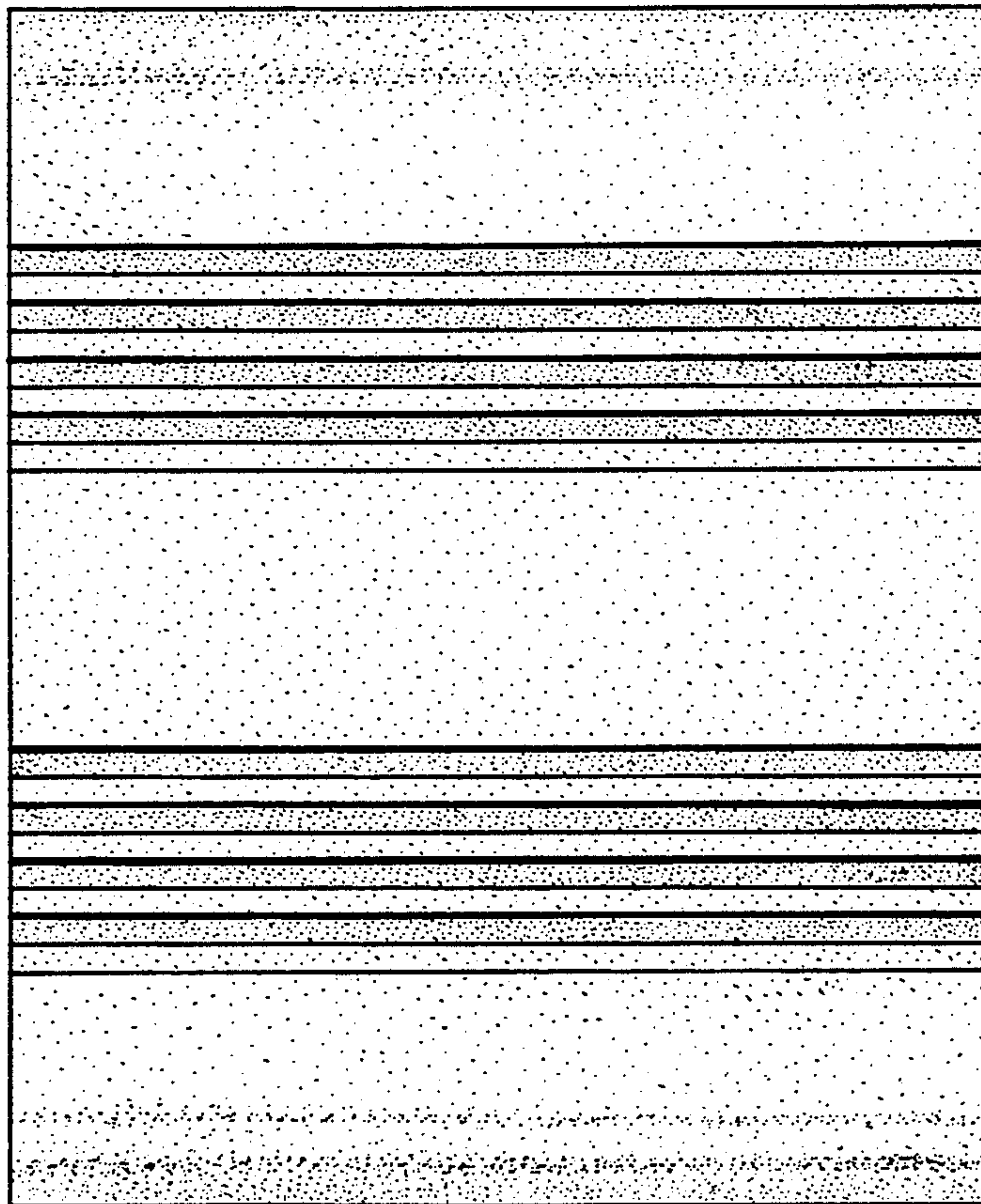

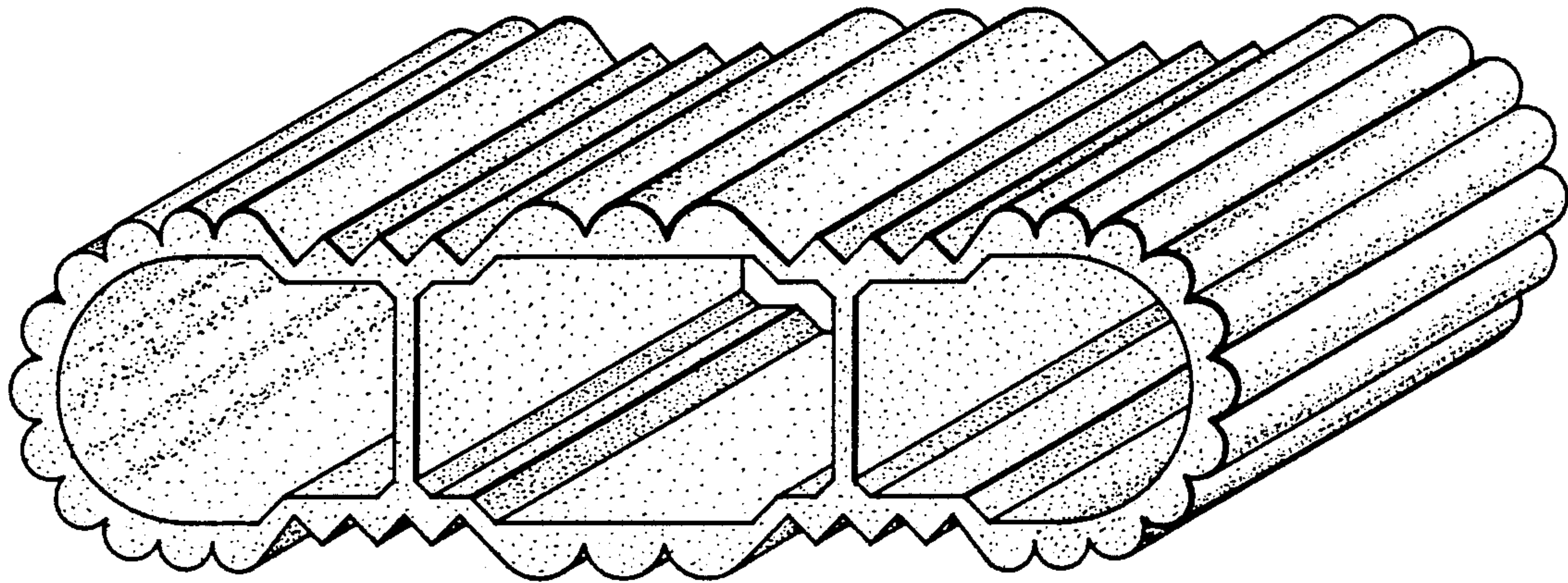

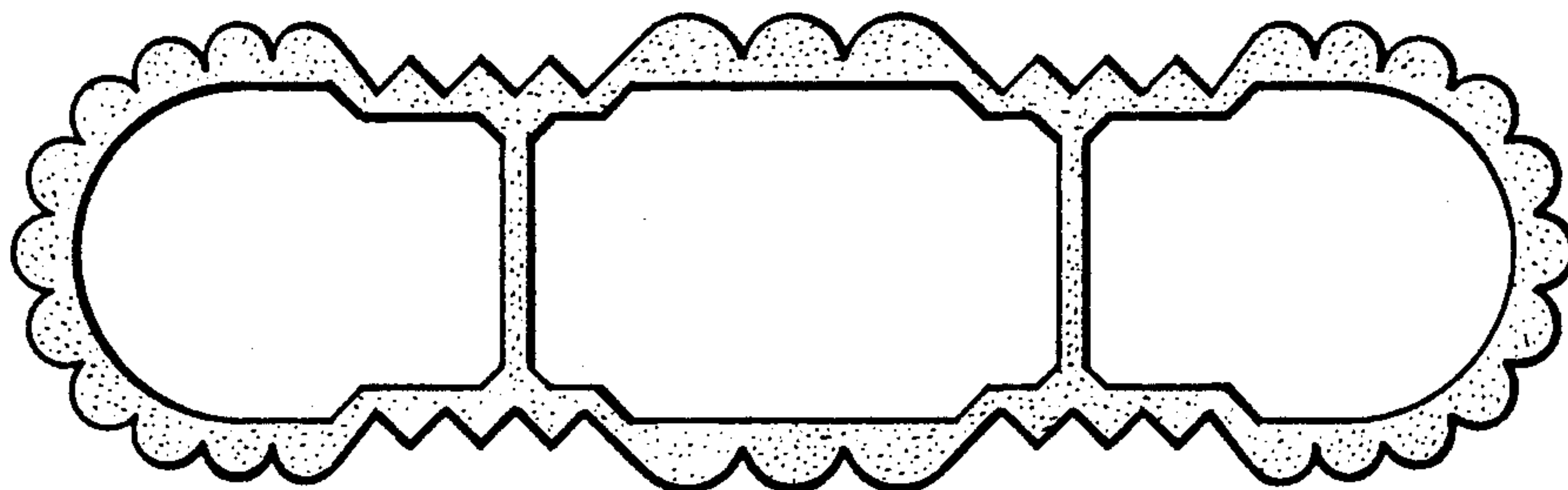

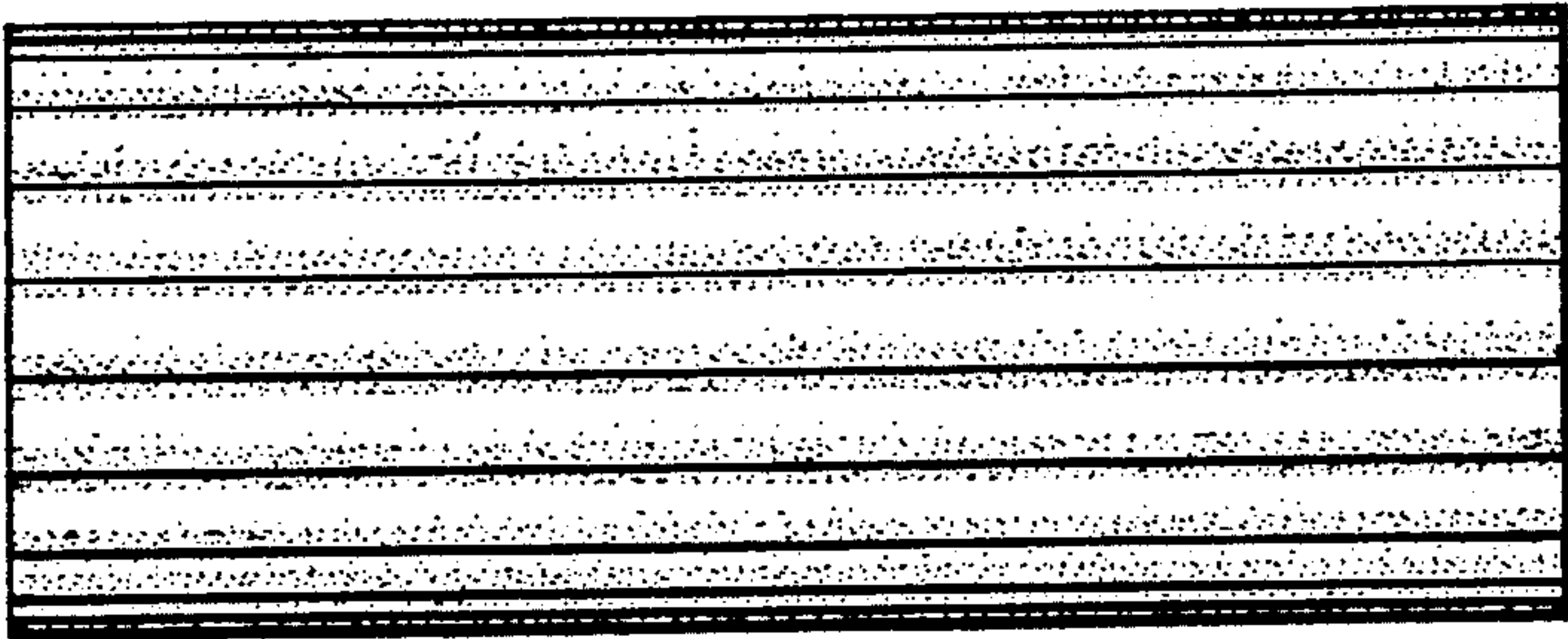
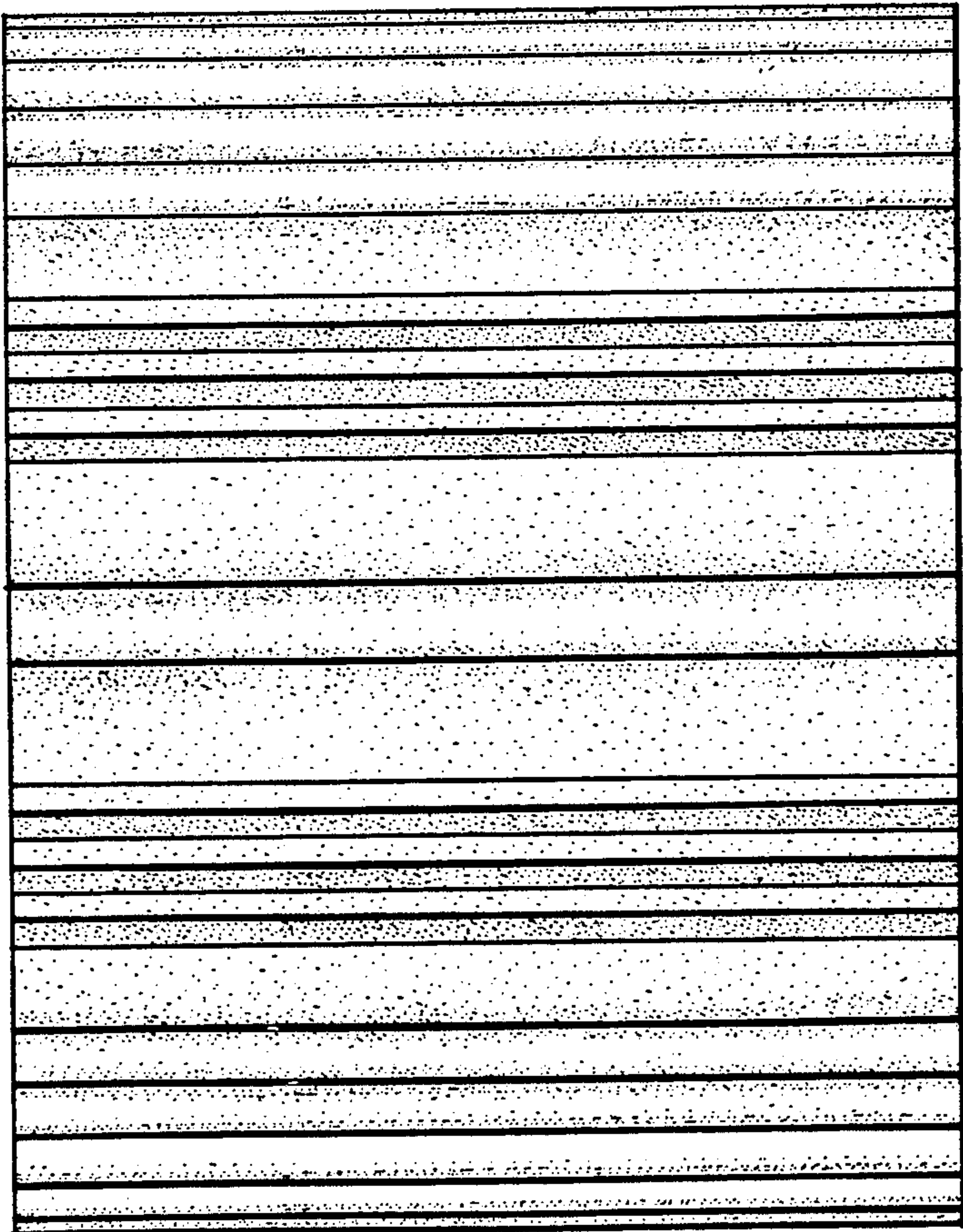
