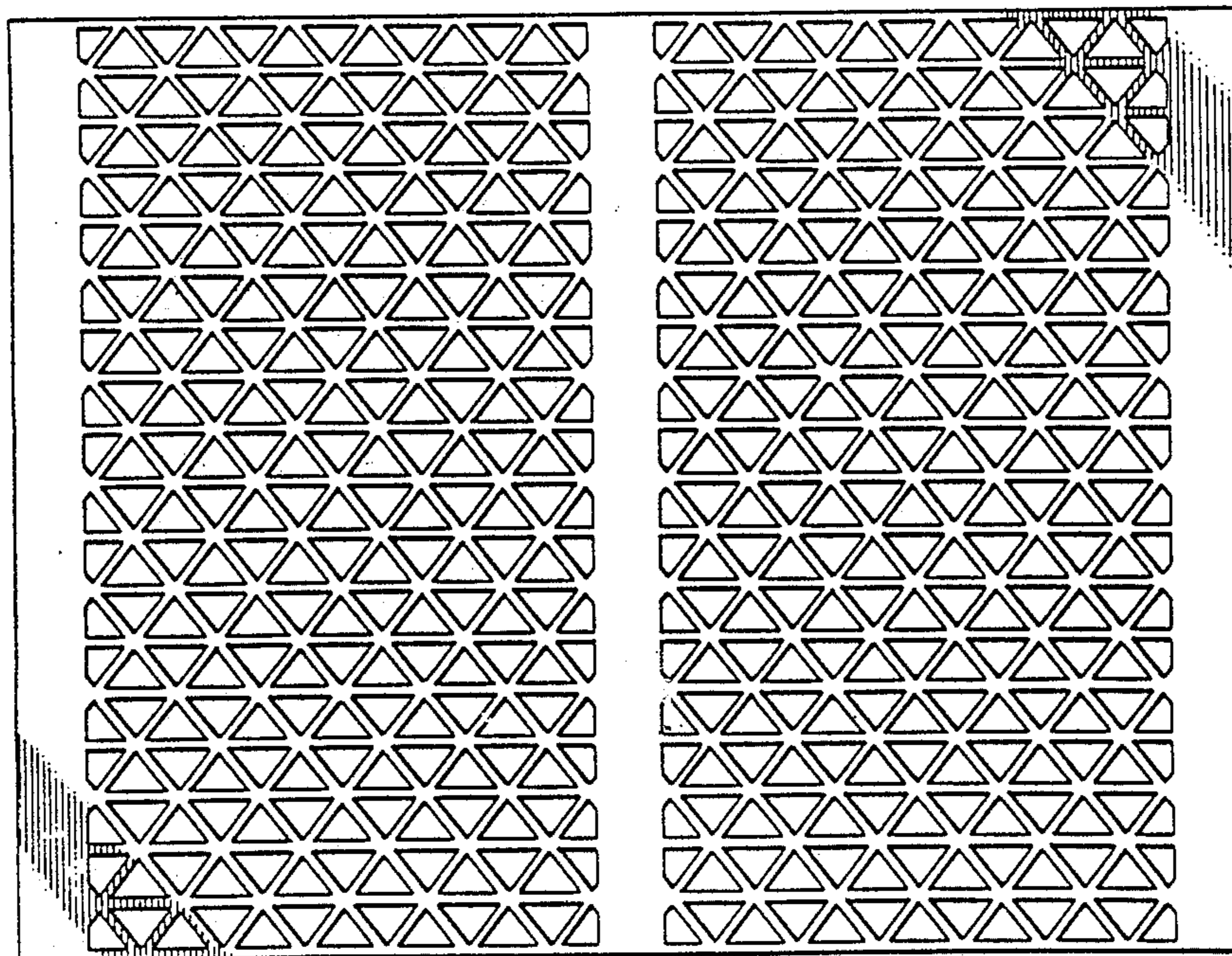

The ornamental design for a poultry decking module, as shown and described.

DESCRIPTION

 FIG. 24 is an end elevational view opposite of the end shown in FIG. 23 thereof.



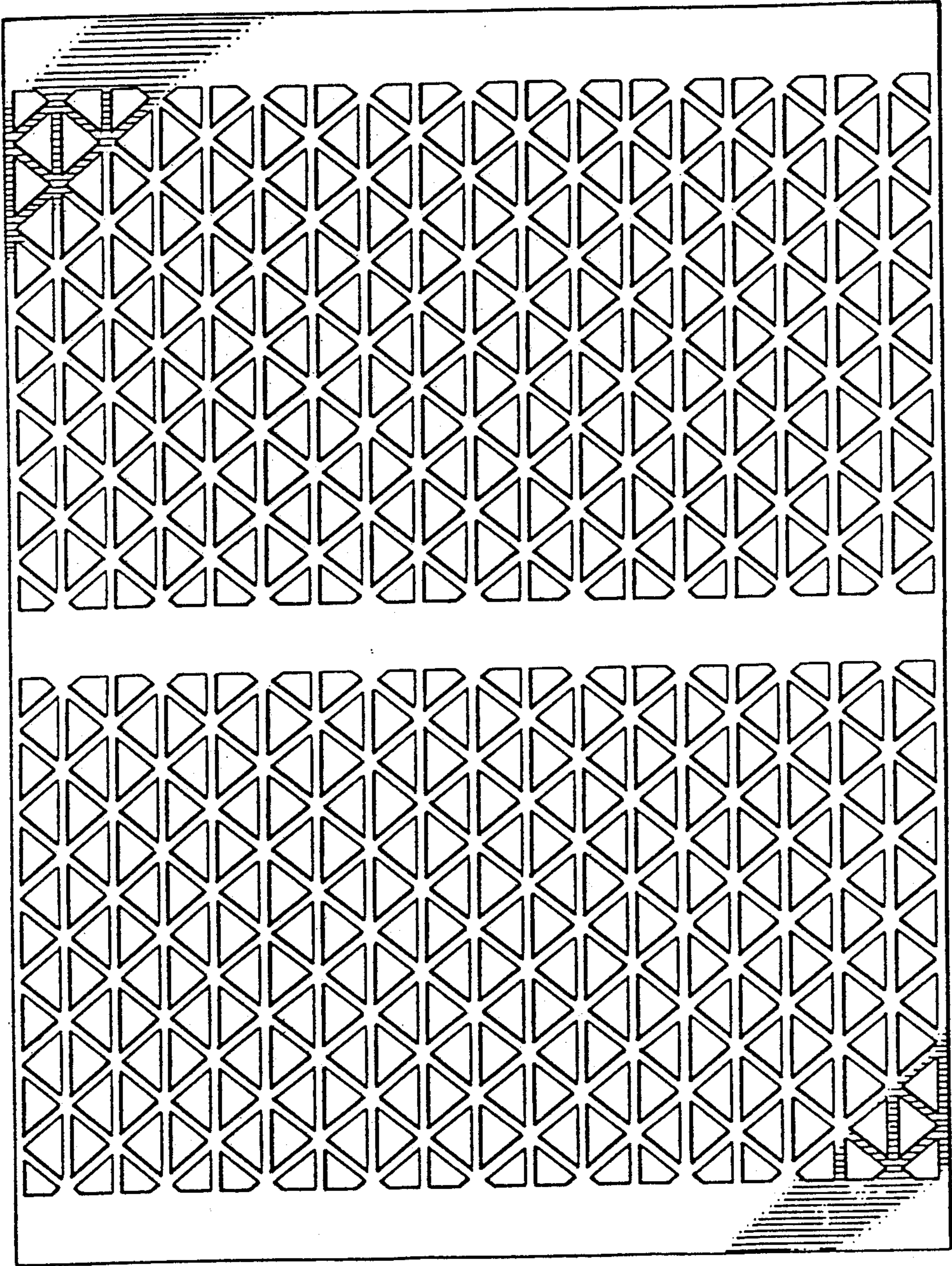

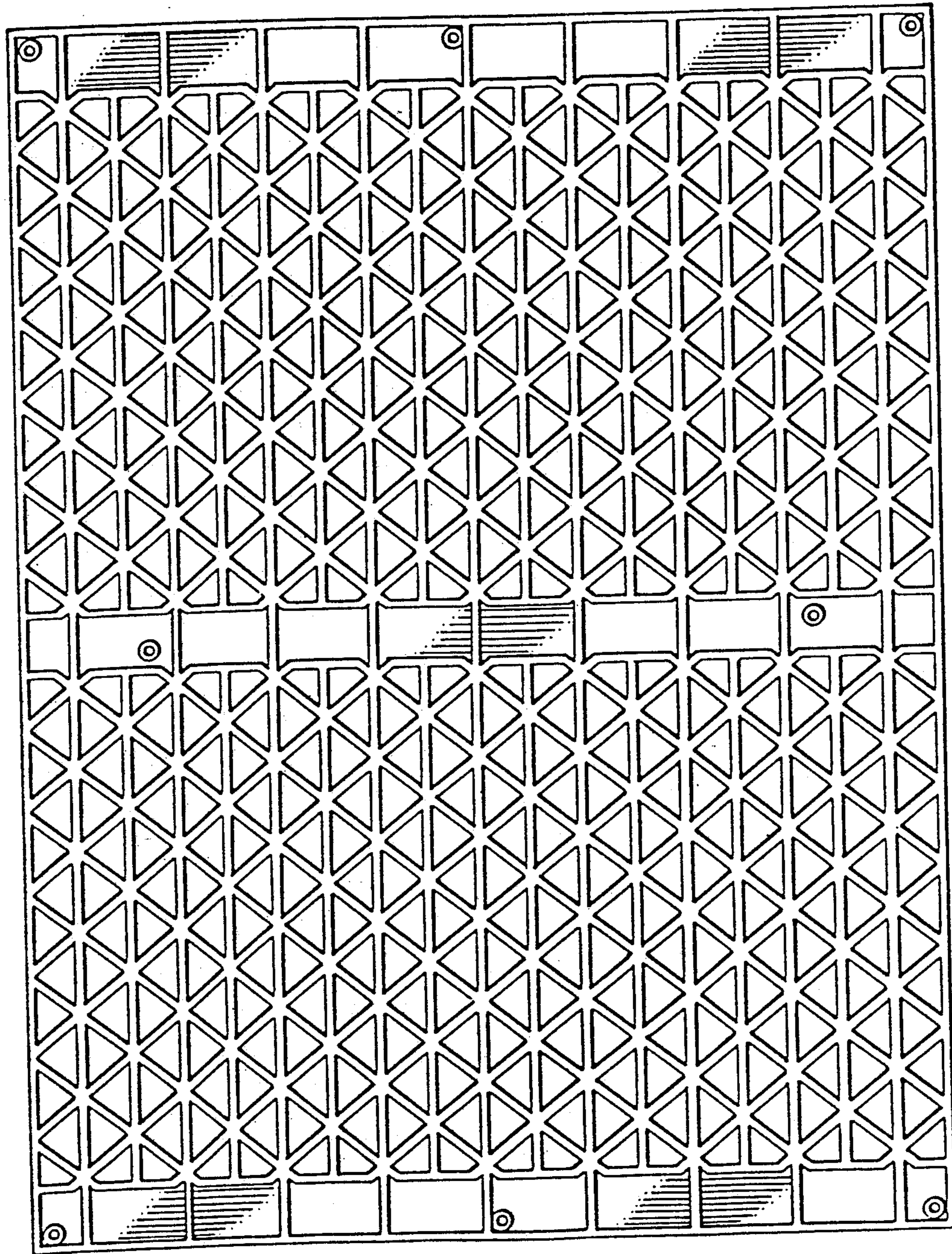

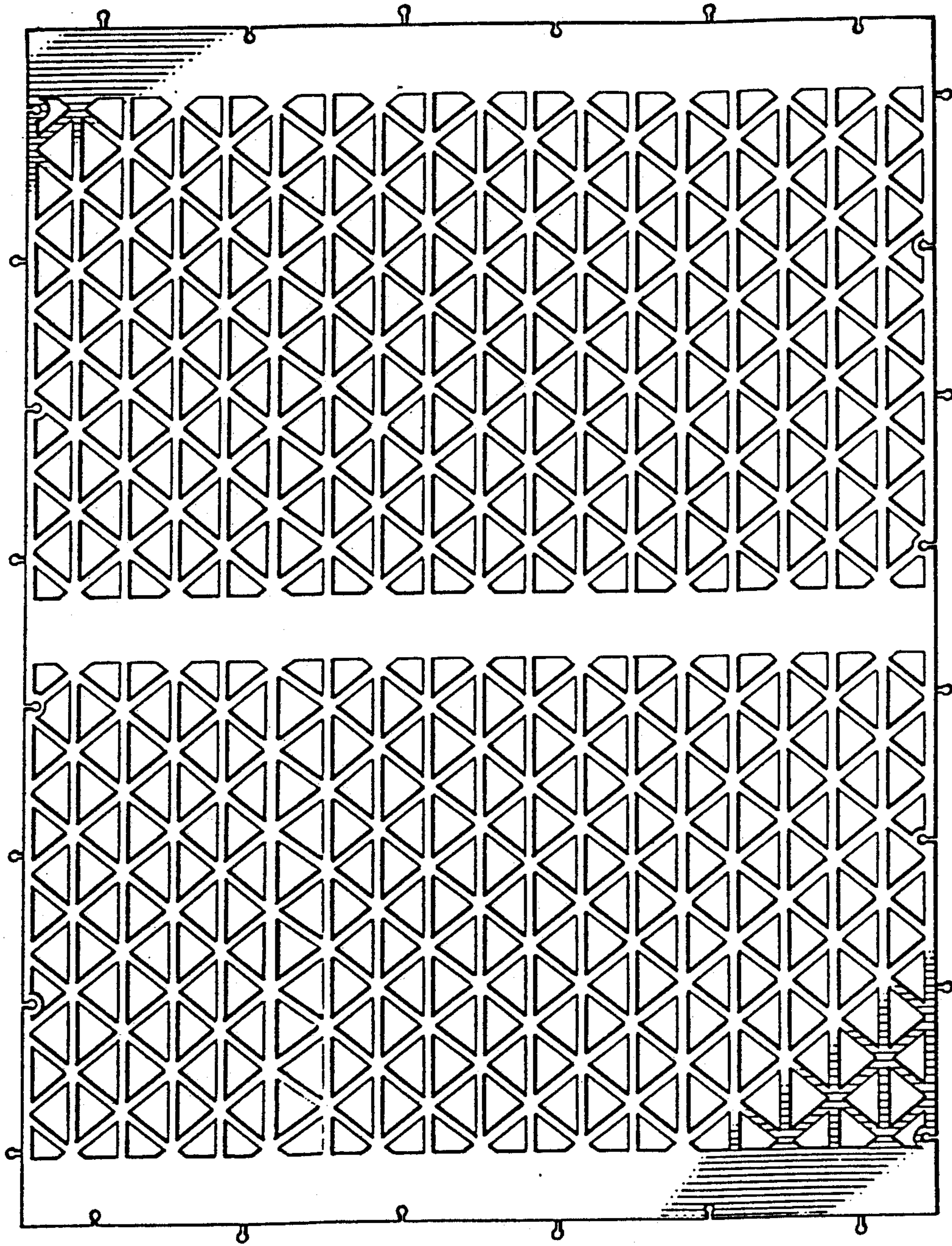

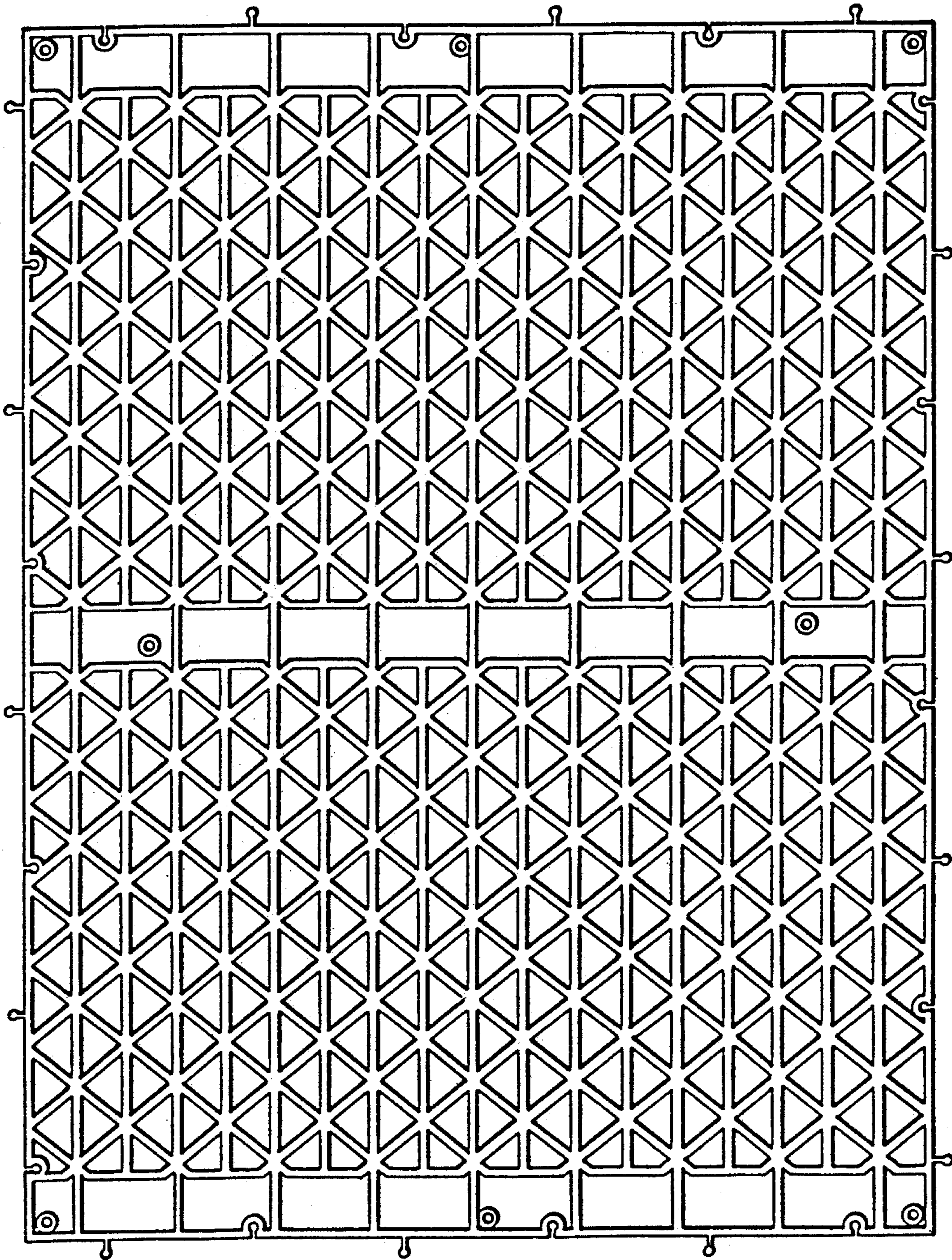

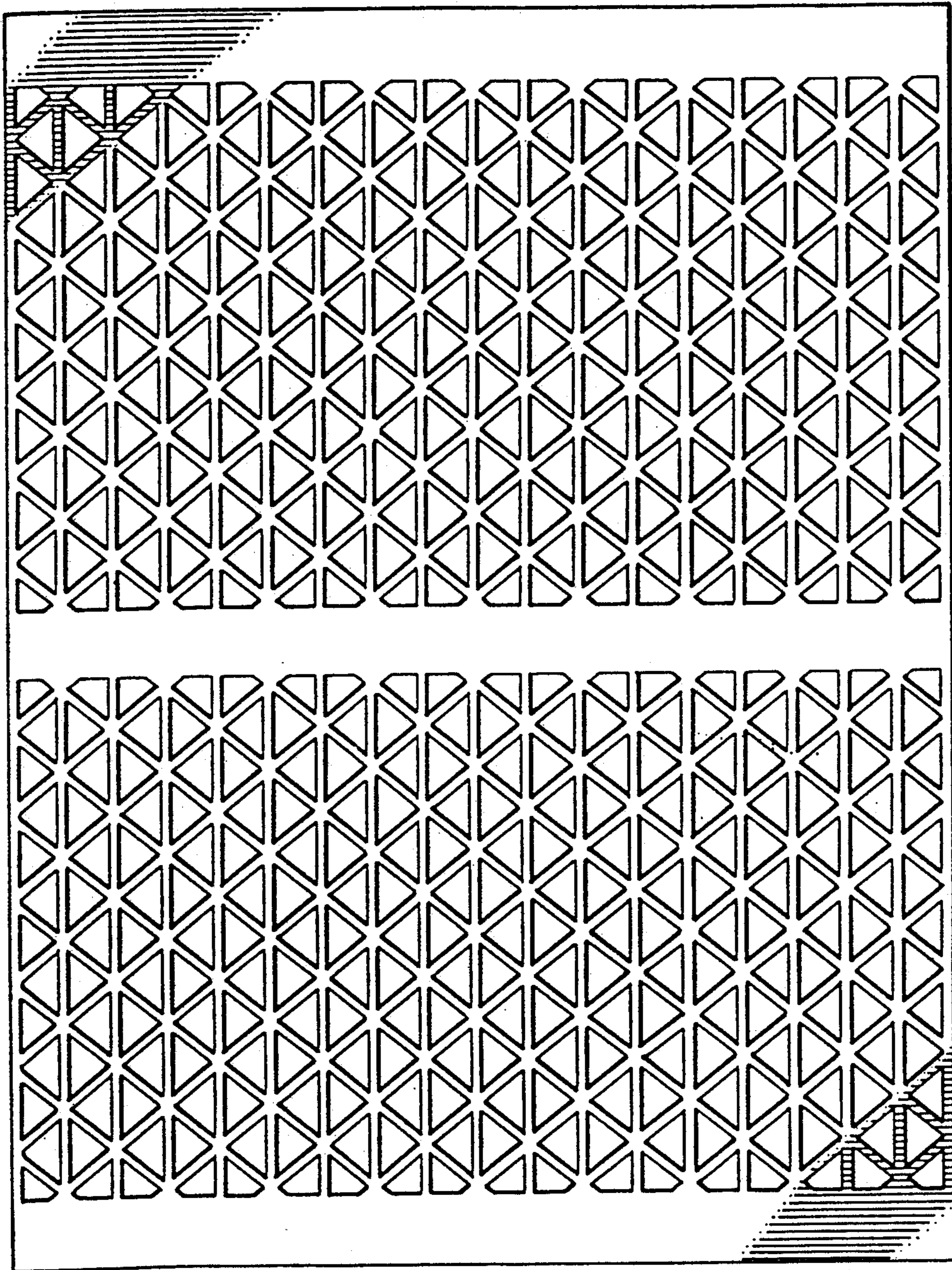

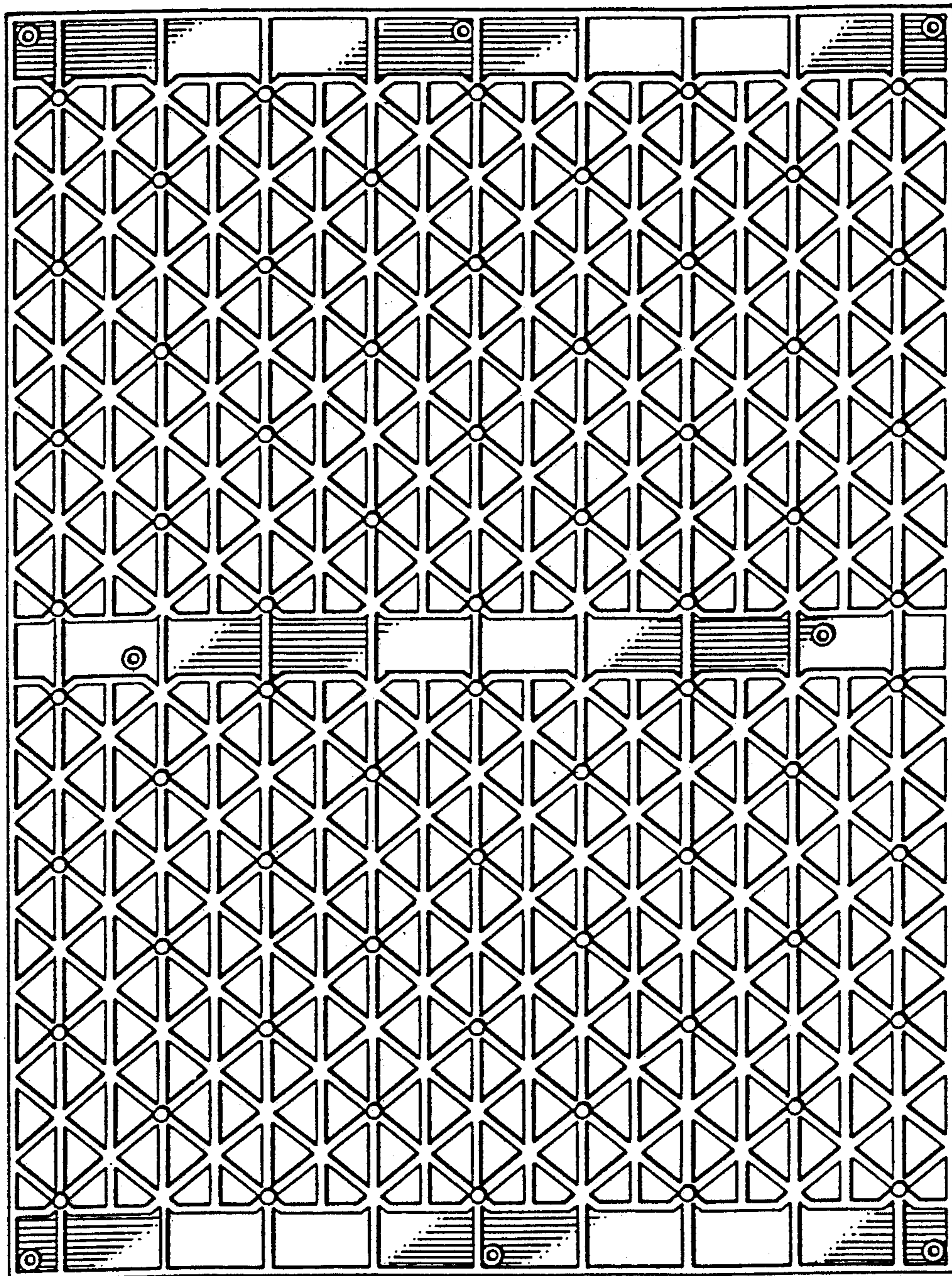

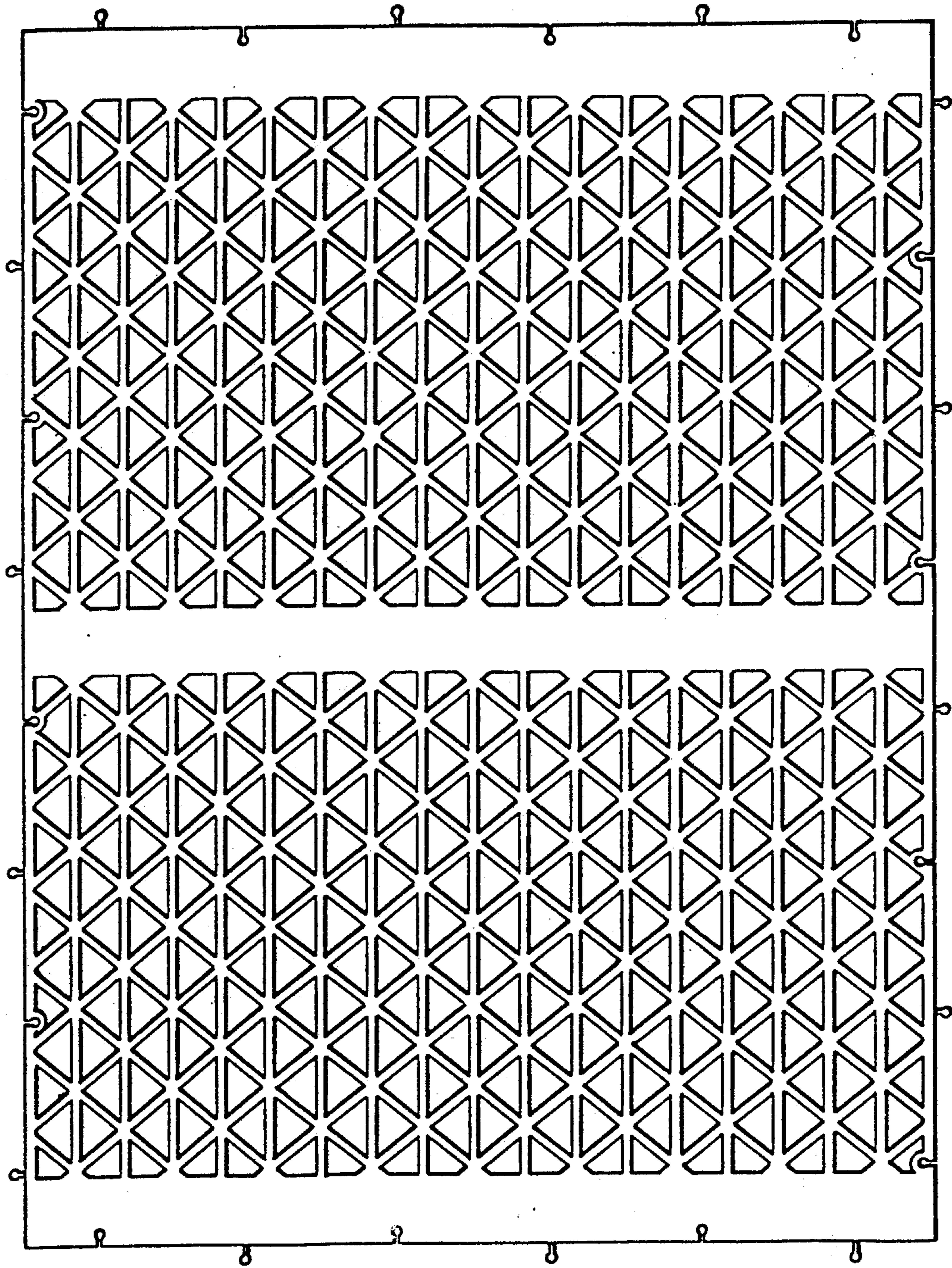

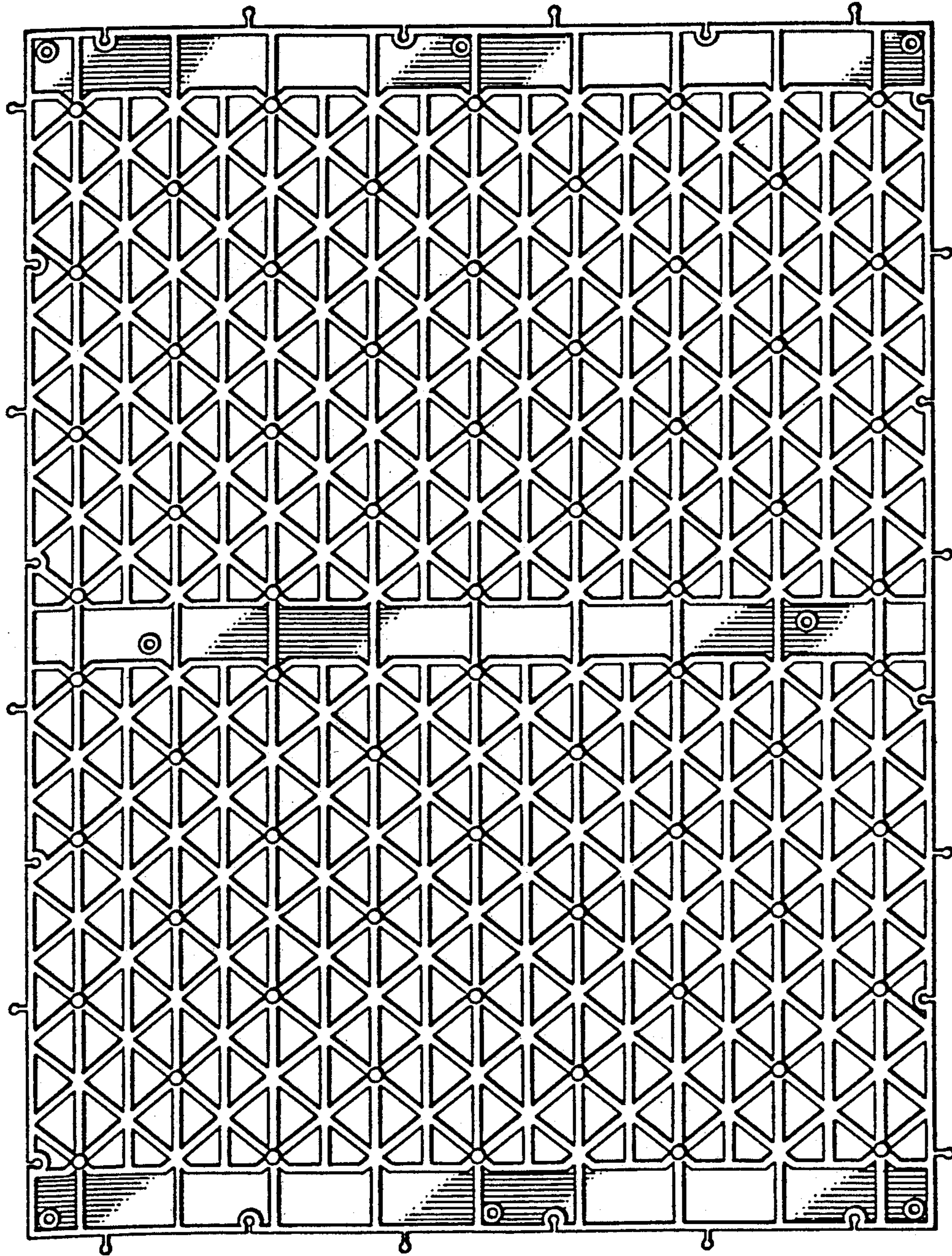

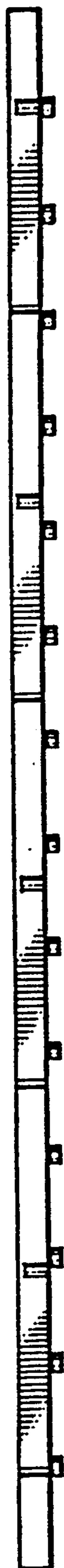
