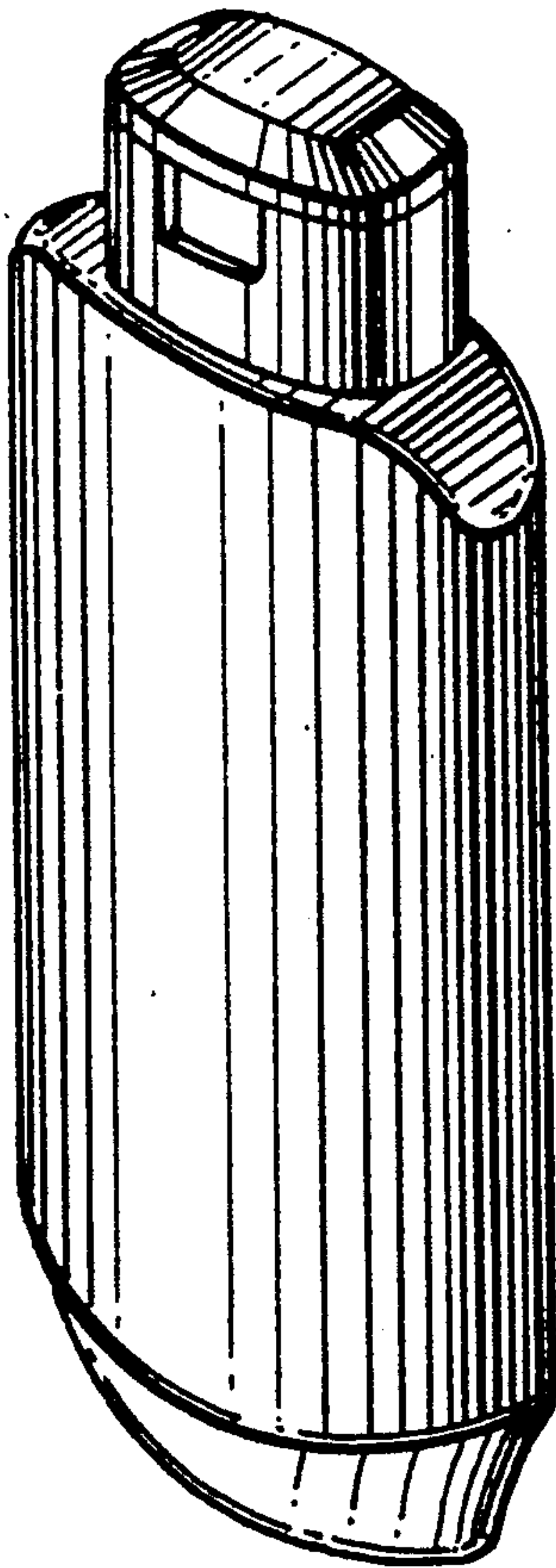

cap.





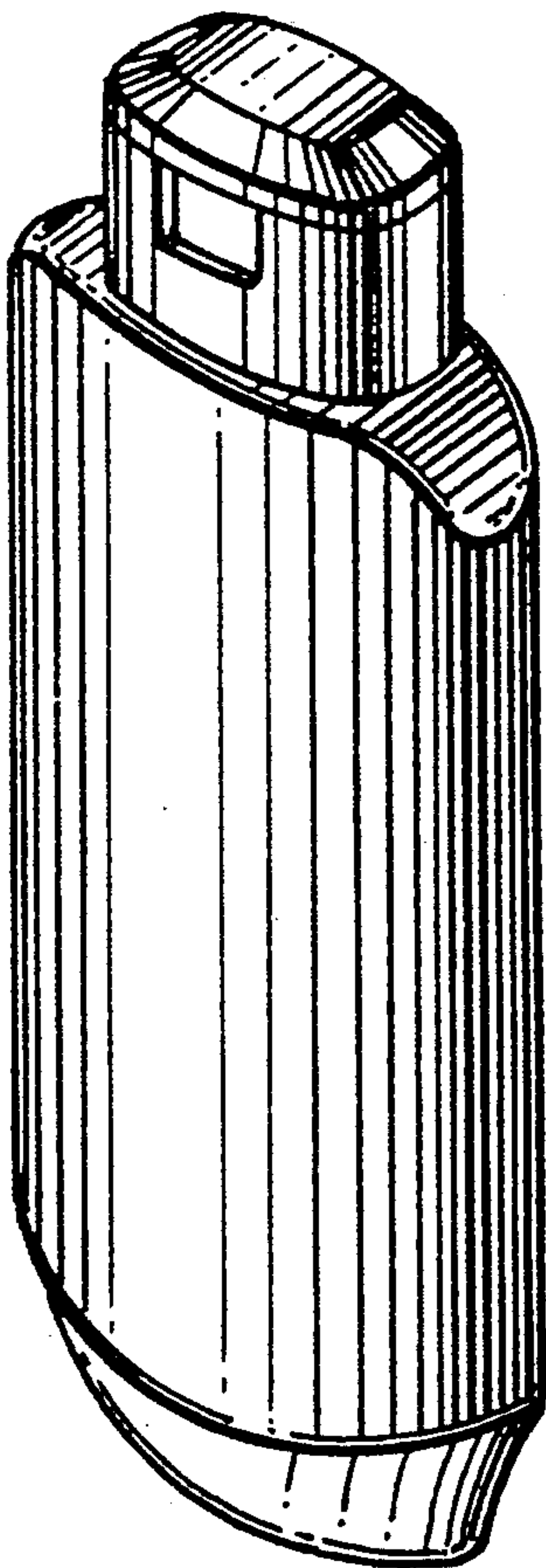

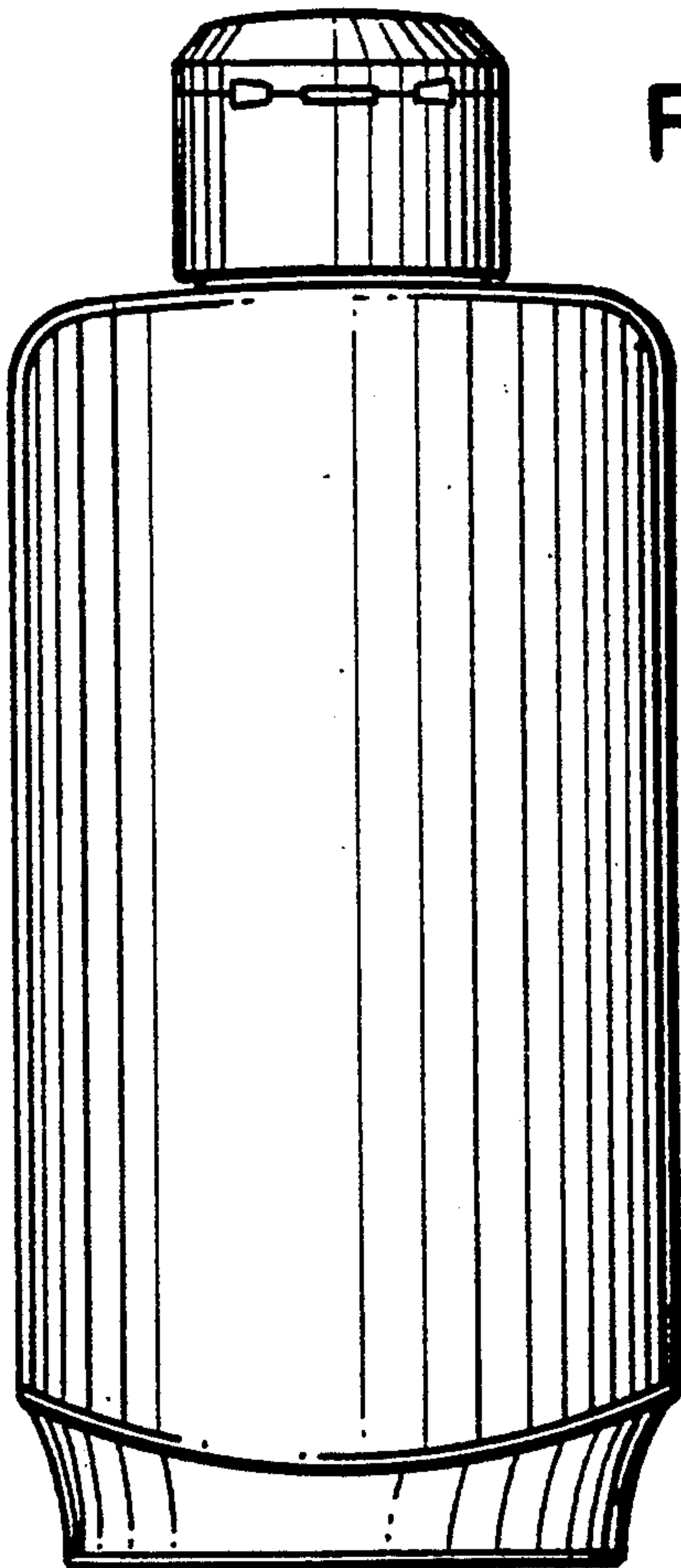

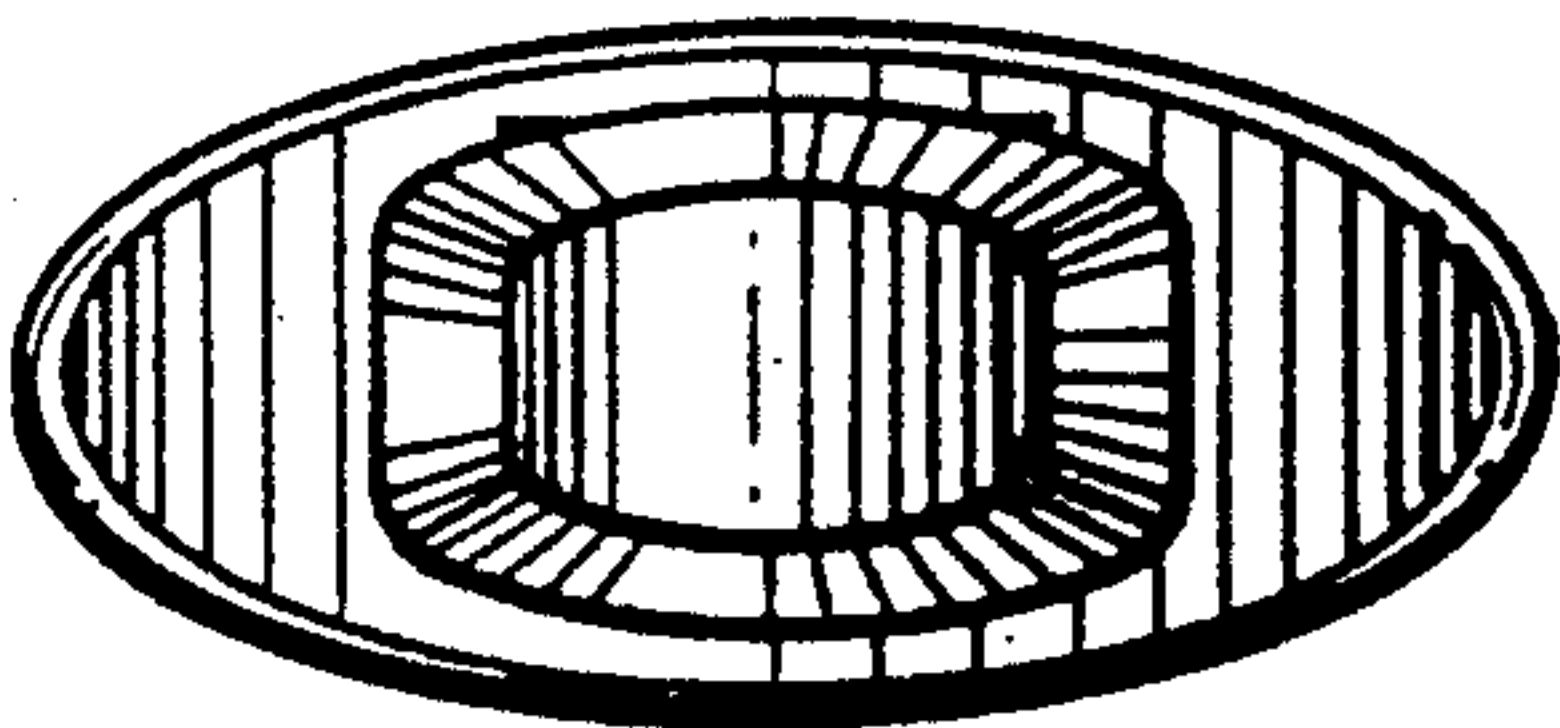

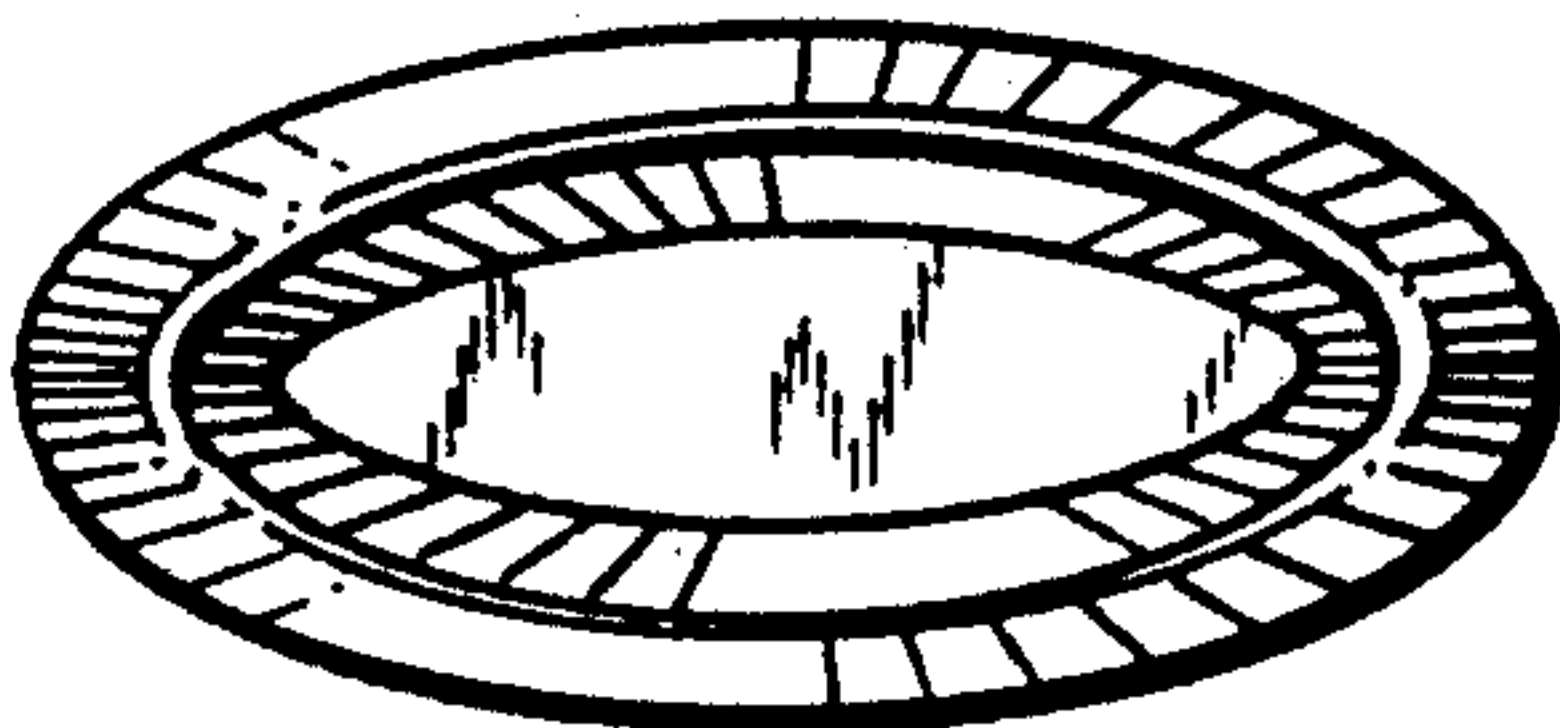
