DESCRIPTION

FIG. 1 is a perspective view of a package for wipes
showing my new design;
FIG. 2 is a front elevation thereof;
FIG. 3 is a rear elevation thereof;
FIG. 4 is a right side elevation thereof;
FIG. 5 is a left side elevation thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a perspective view thereof; showing undis-
closed sides in FIG. 1;
FIG. 9 is a sectional view thereof; taken along line 9—9
of FIG. 6;
FIG. 10 is a sectional view thereof; taken along line
10—10 of FIG. 6;
FIG. 11 is a sectional view thereof; taken along line
11—11 of FIG. 6; and
FIG. 12 is a perspective view thereof; in open position.

purpose only and forms no part of the claim.

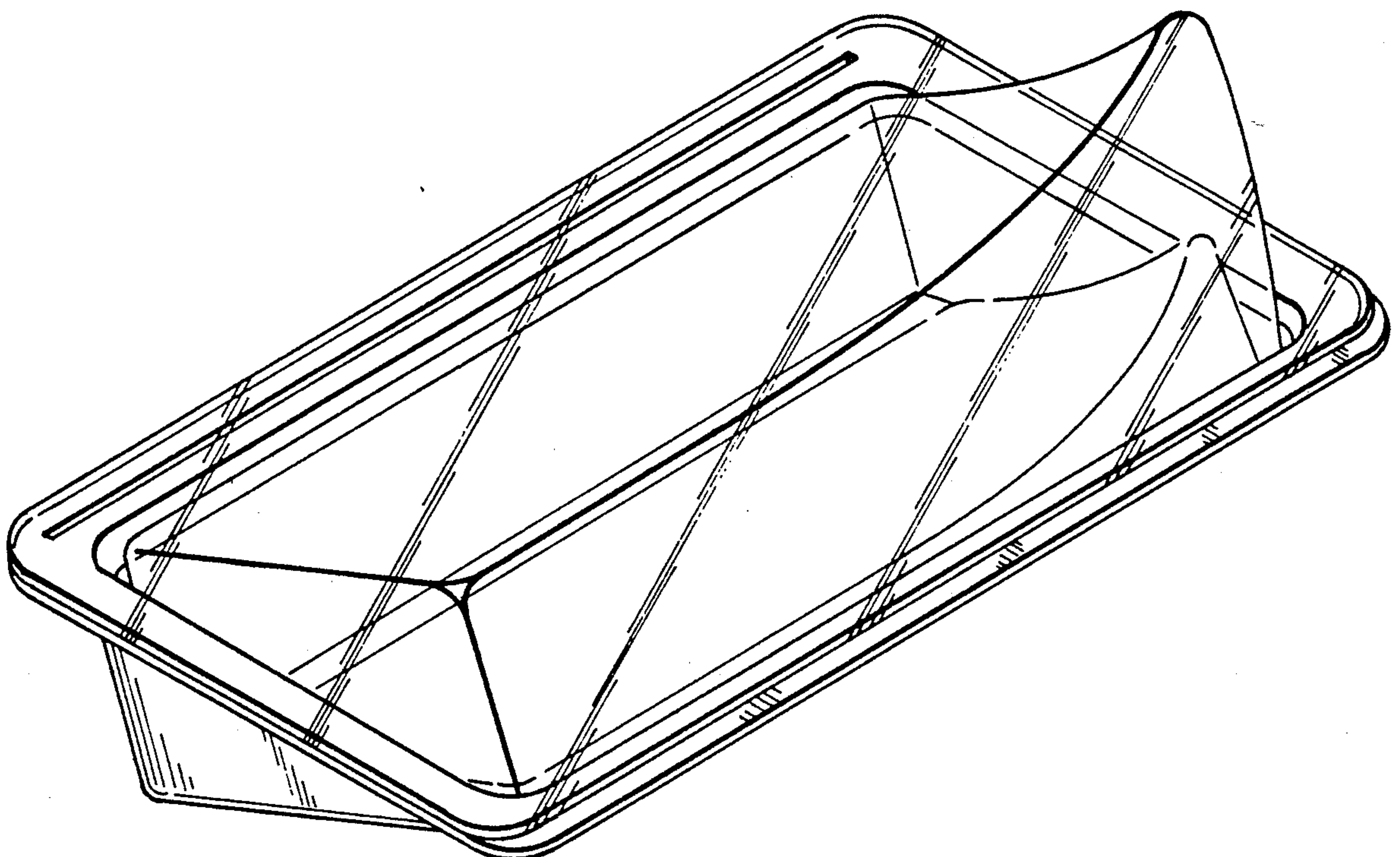

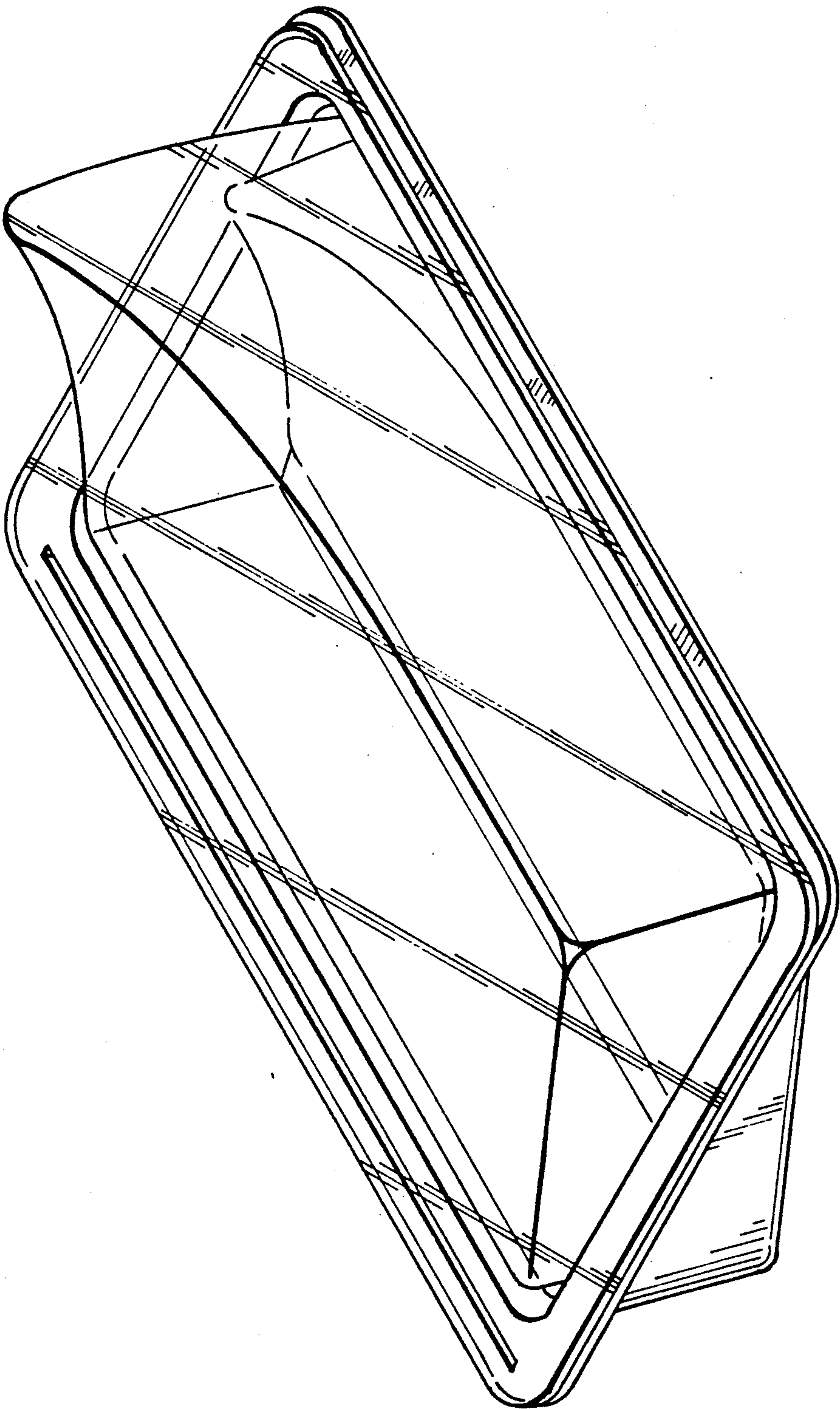

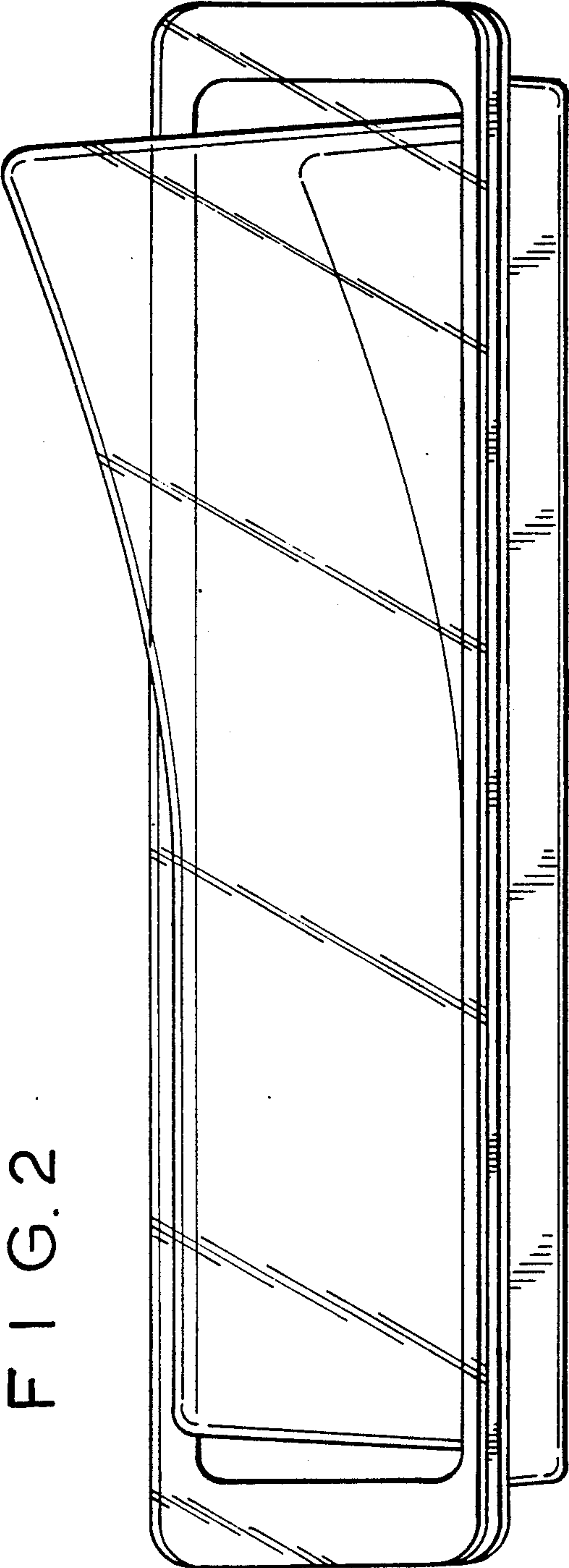

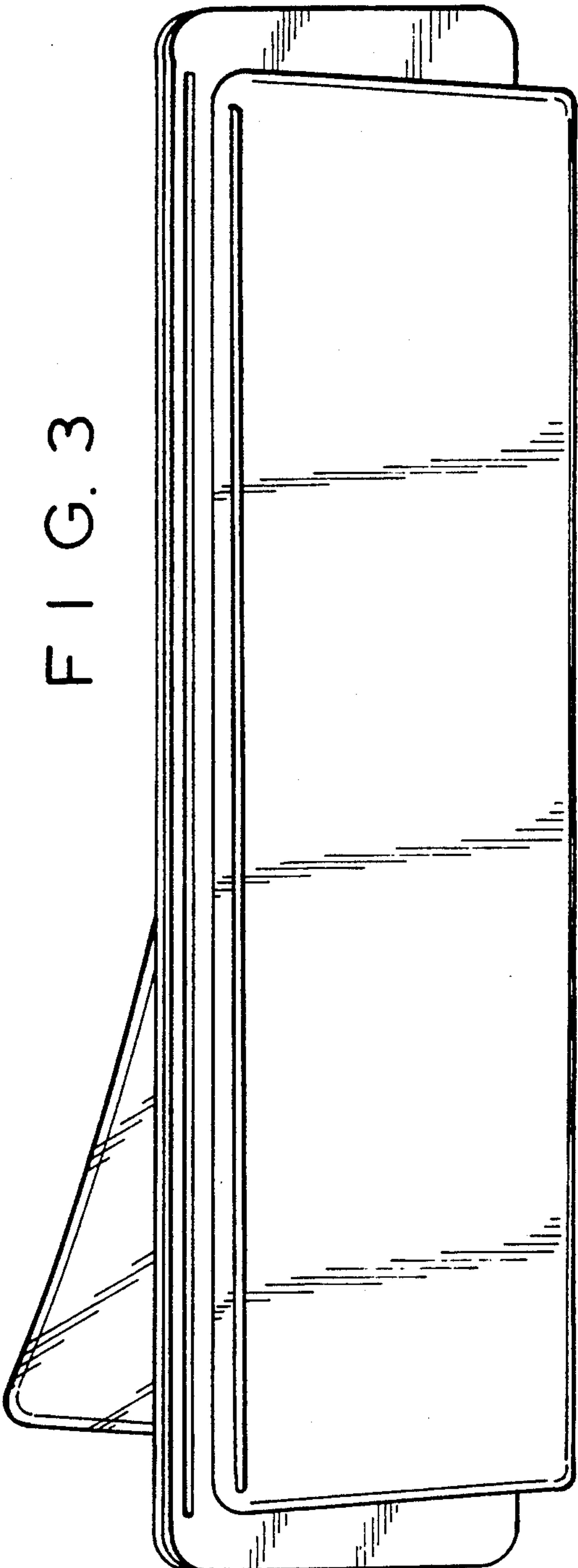

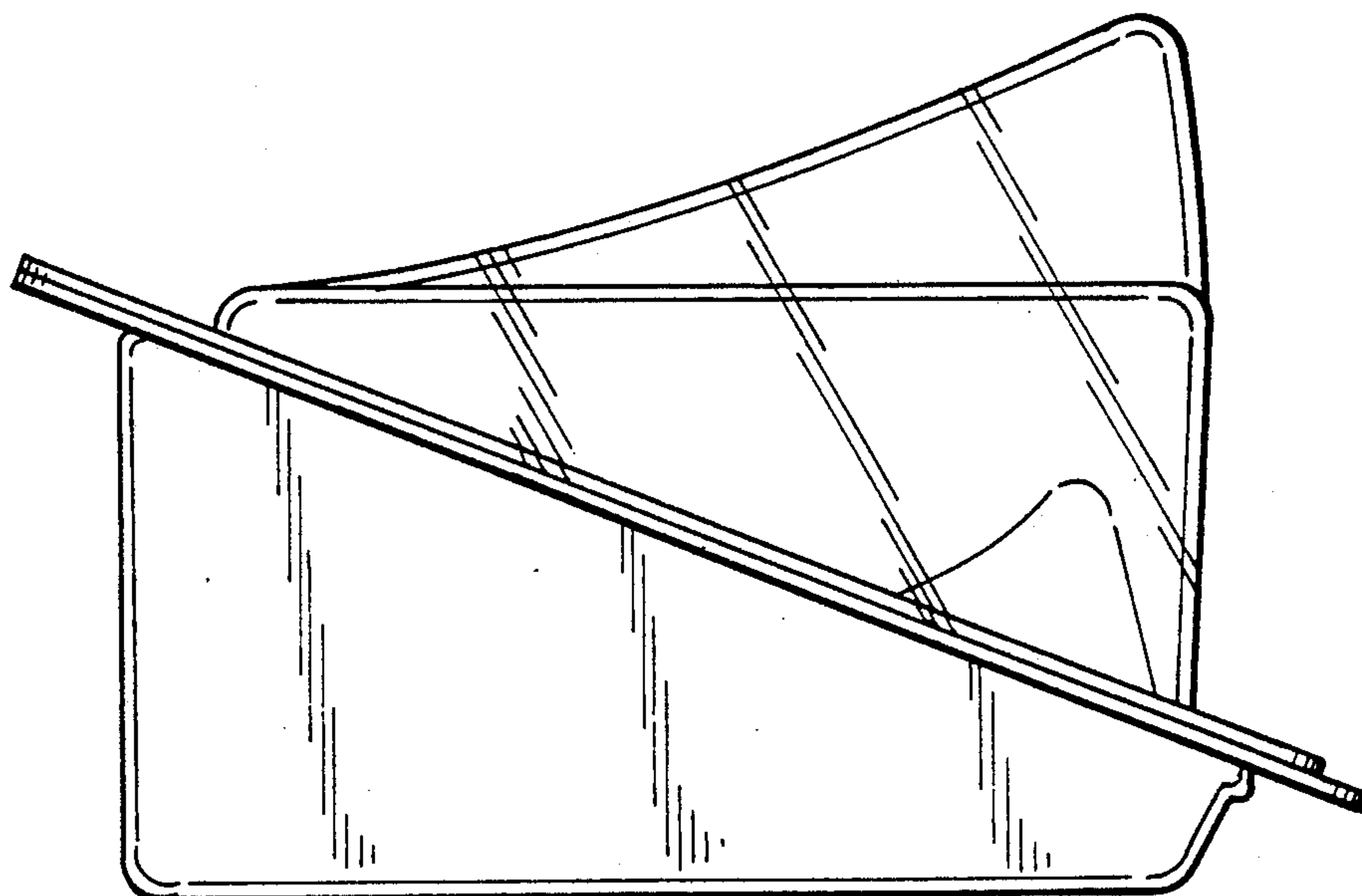
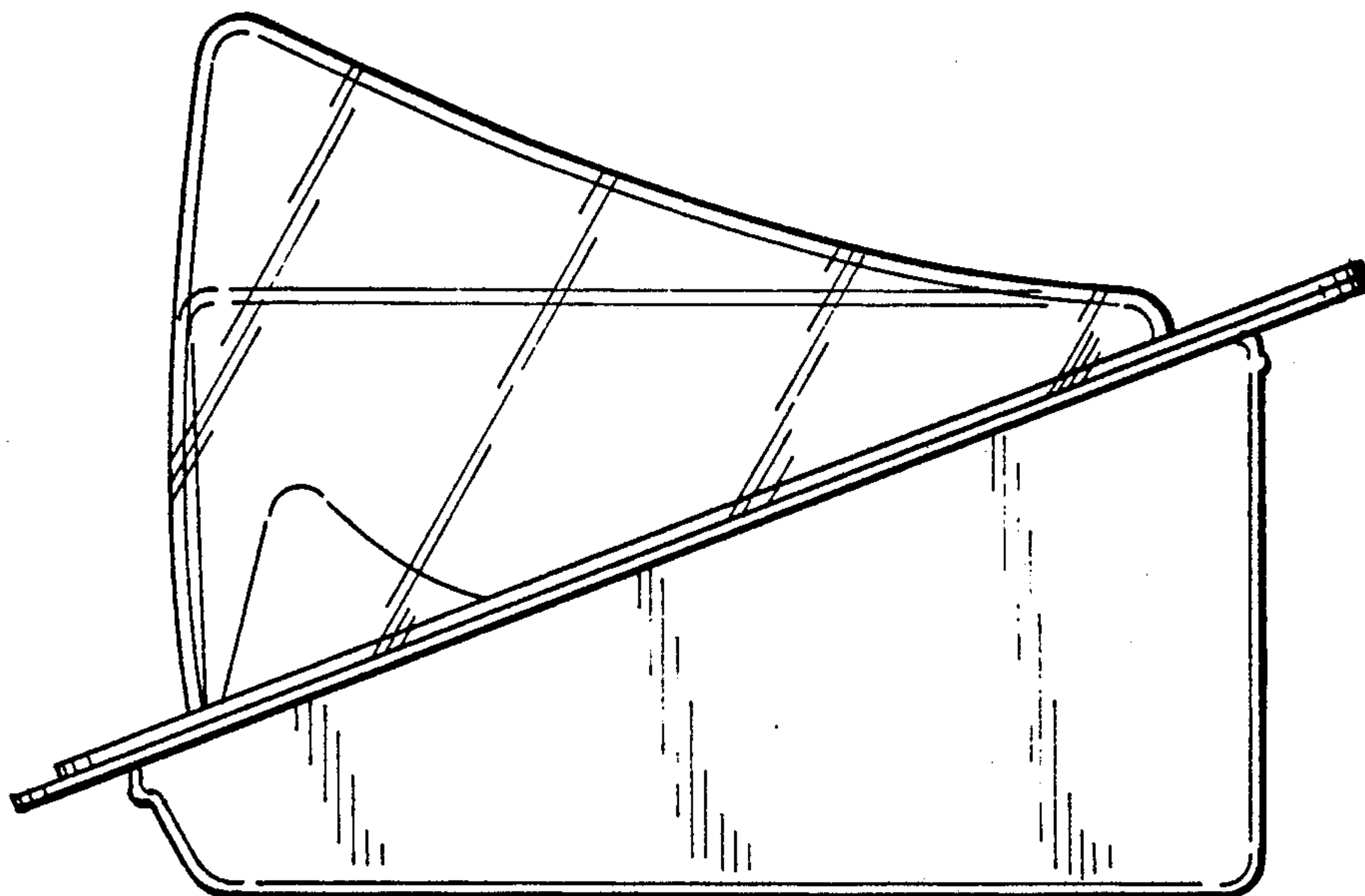
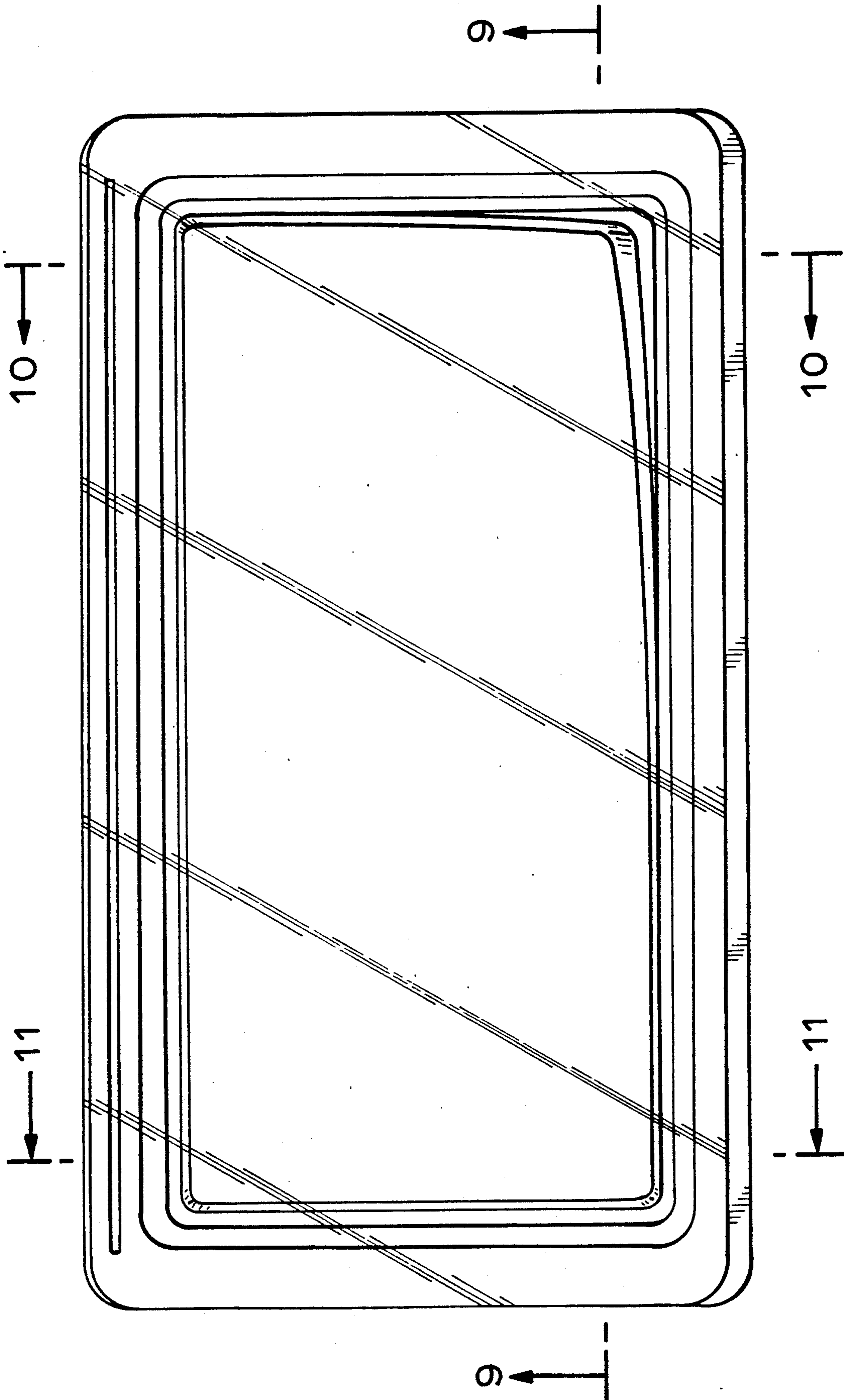

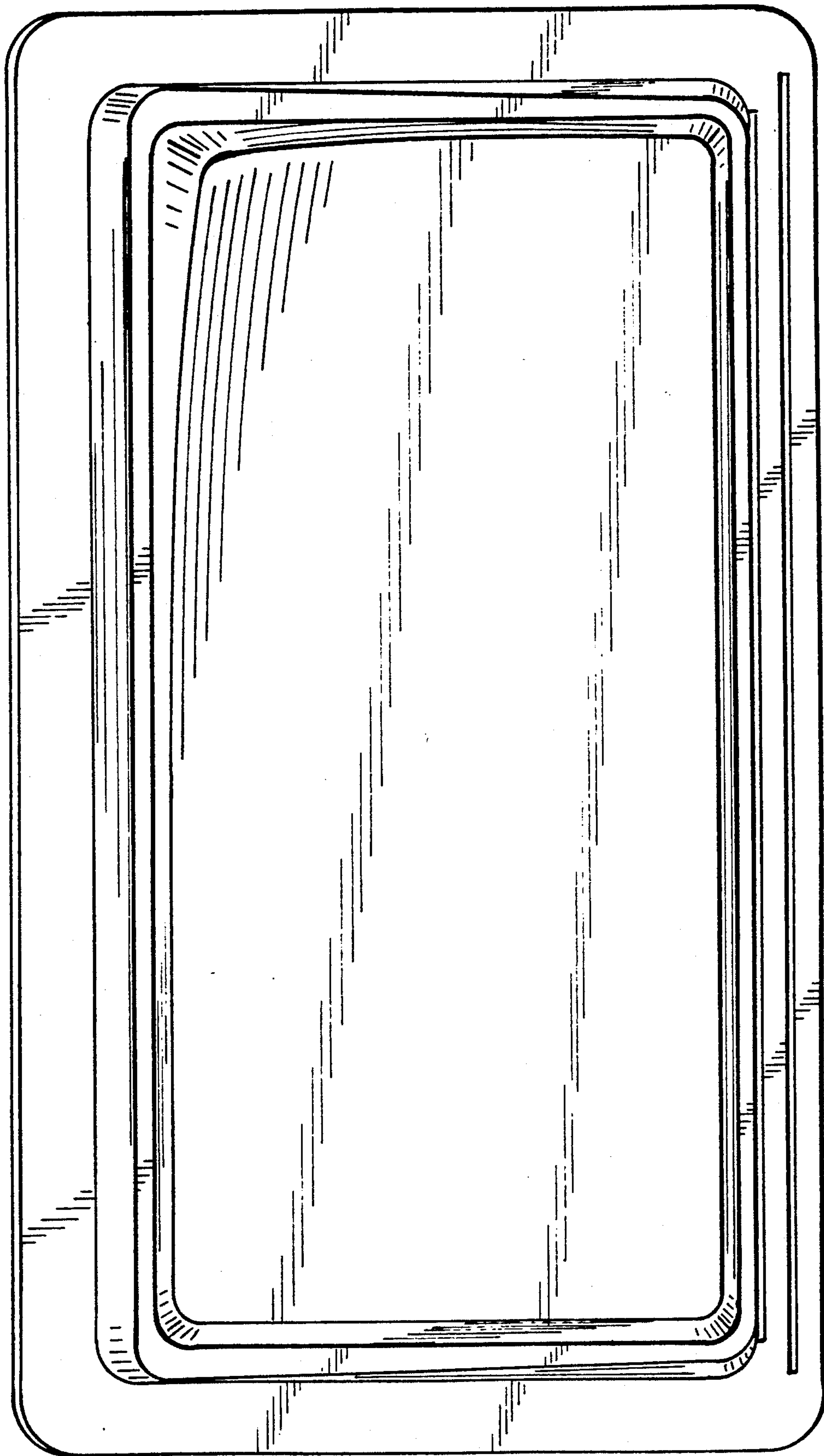

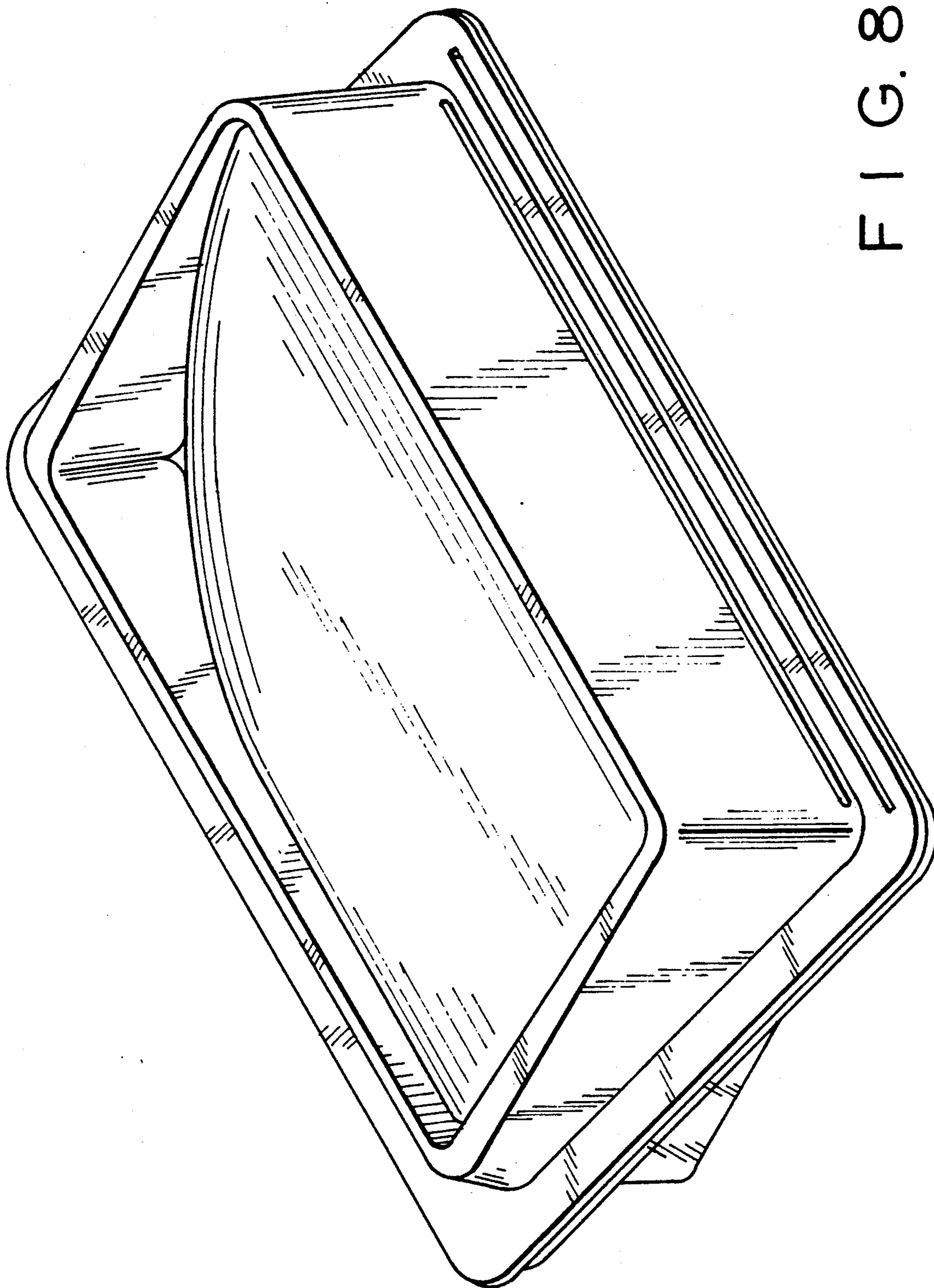
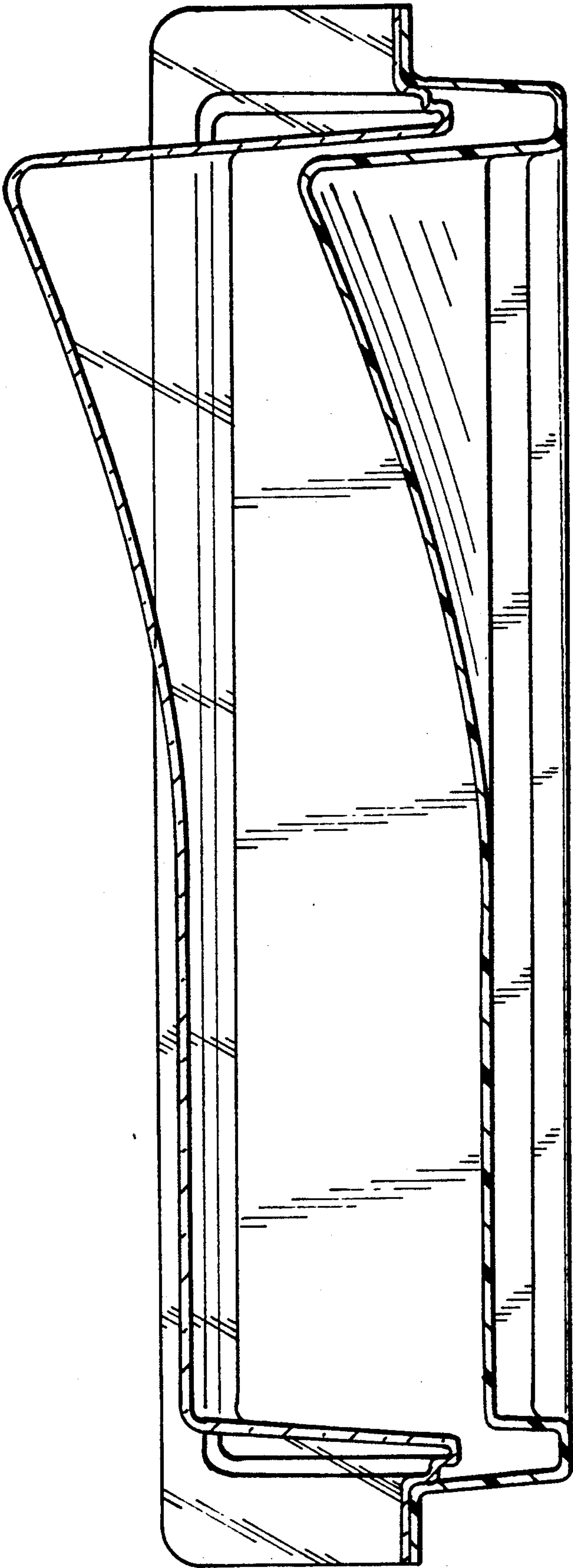
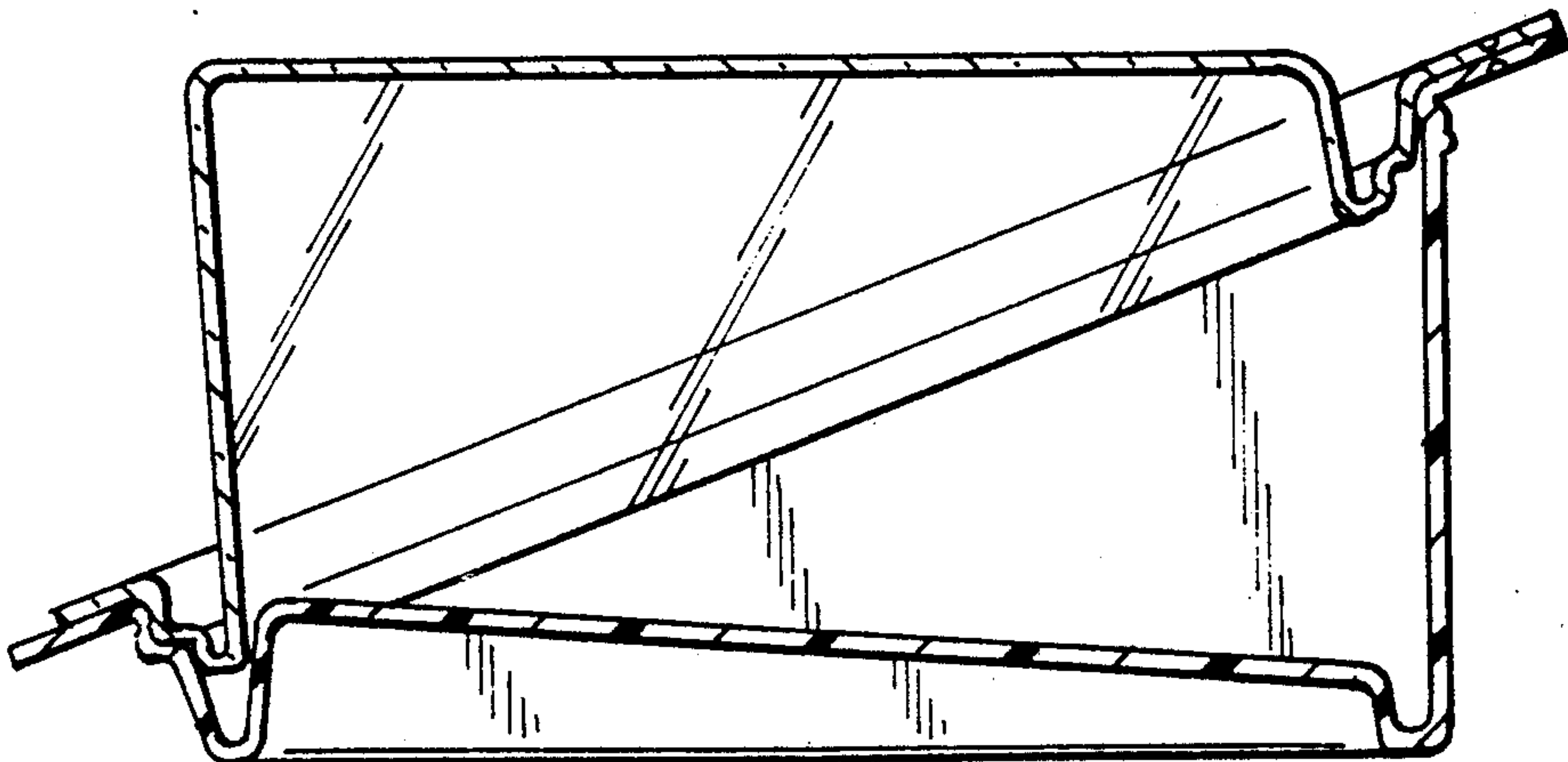
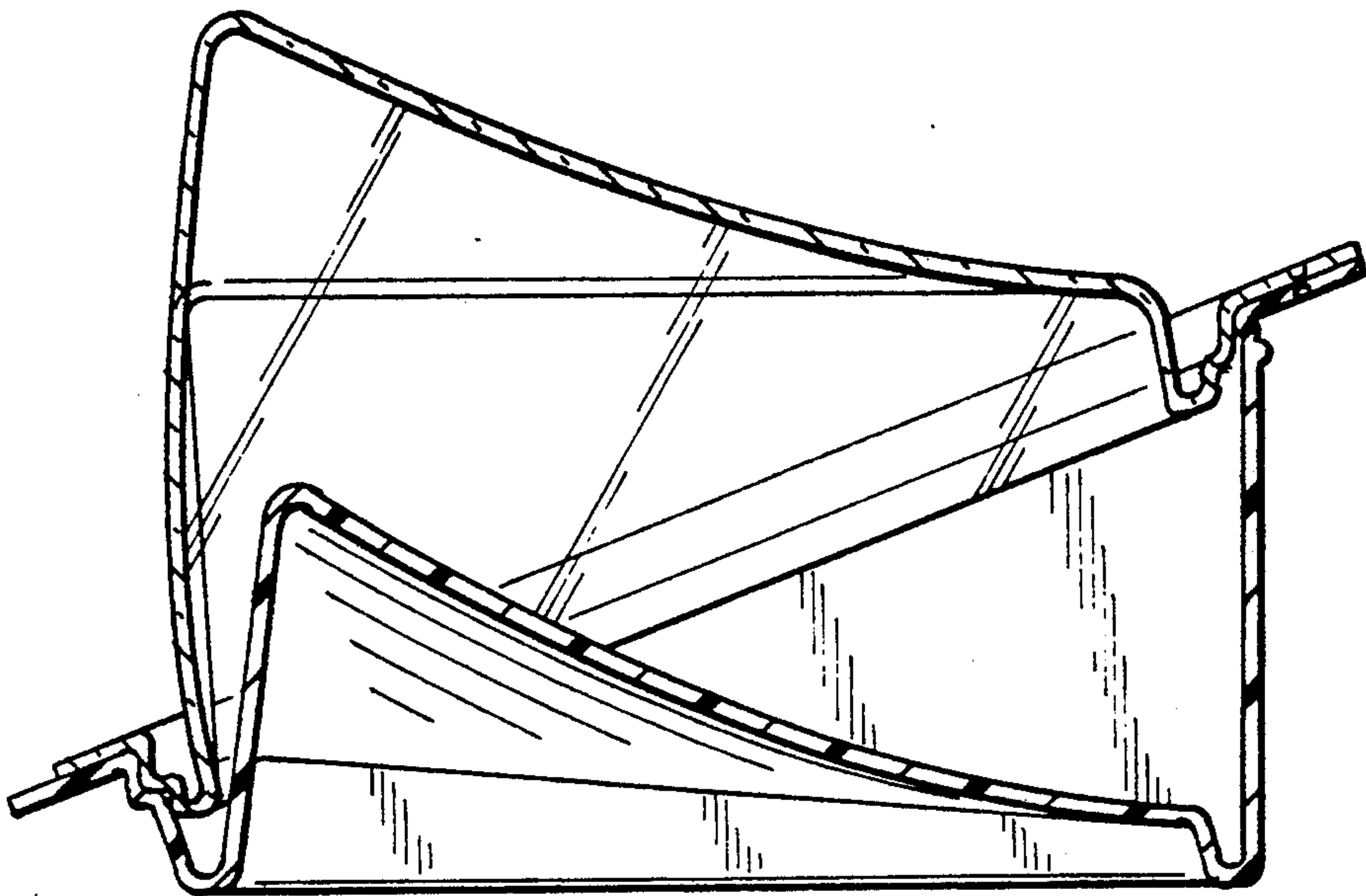

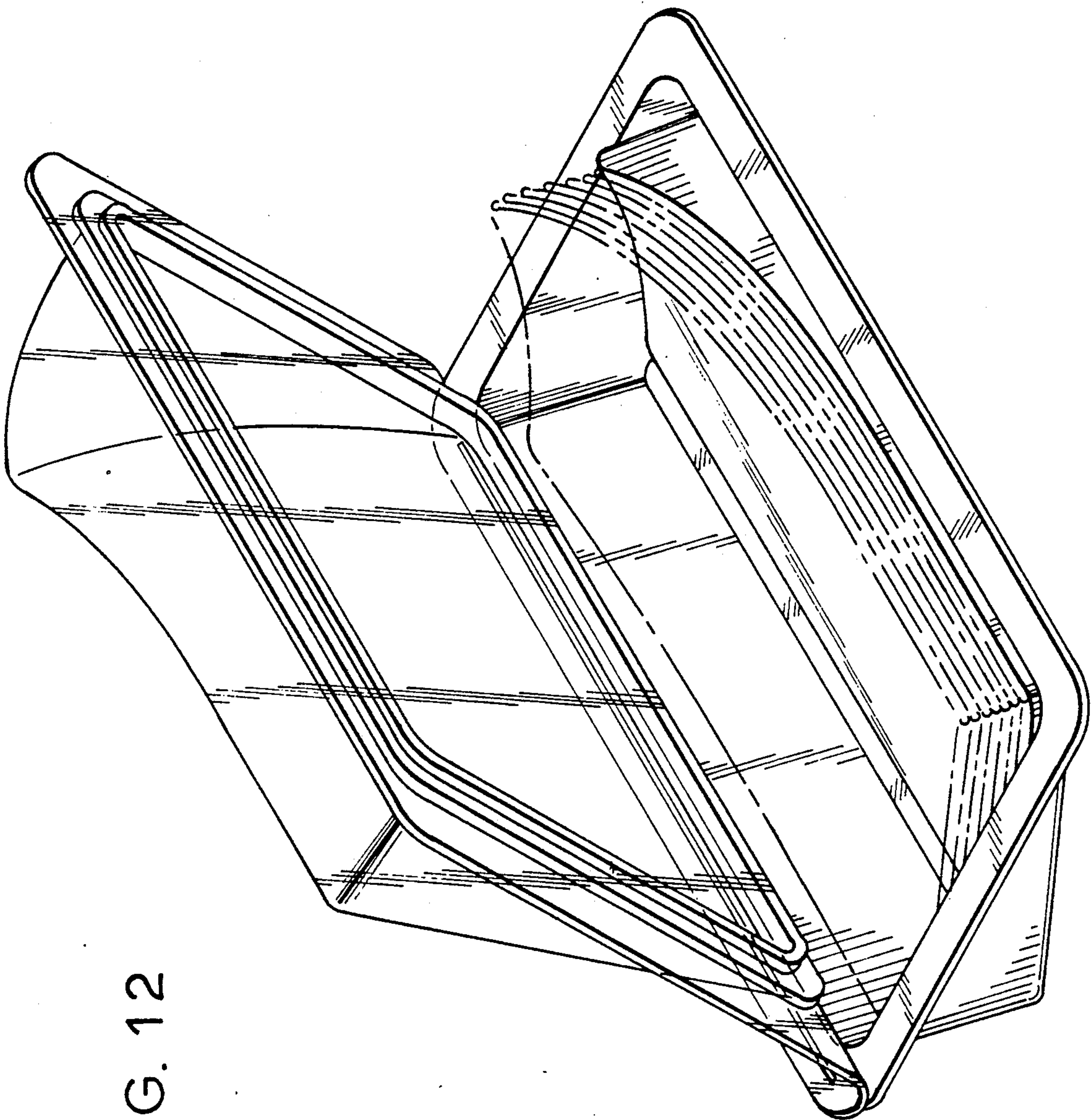
