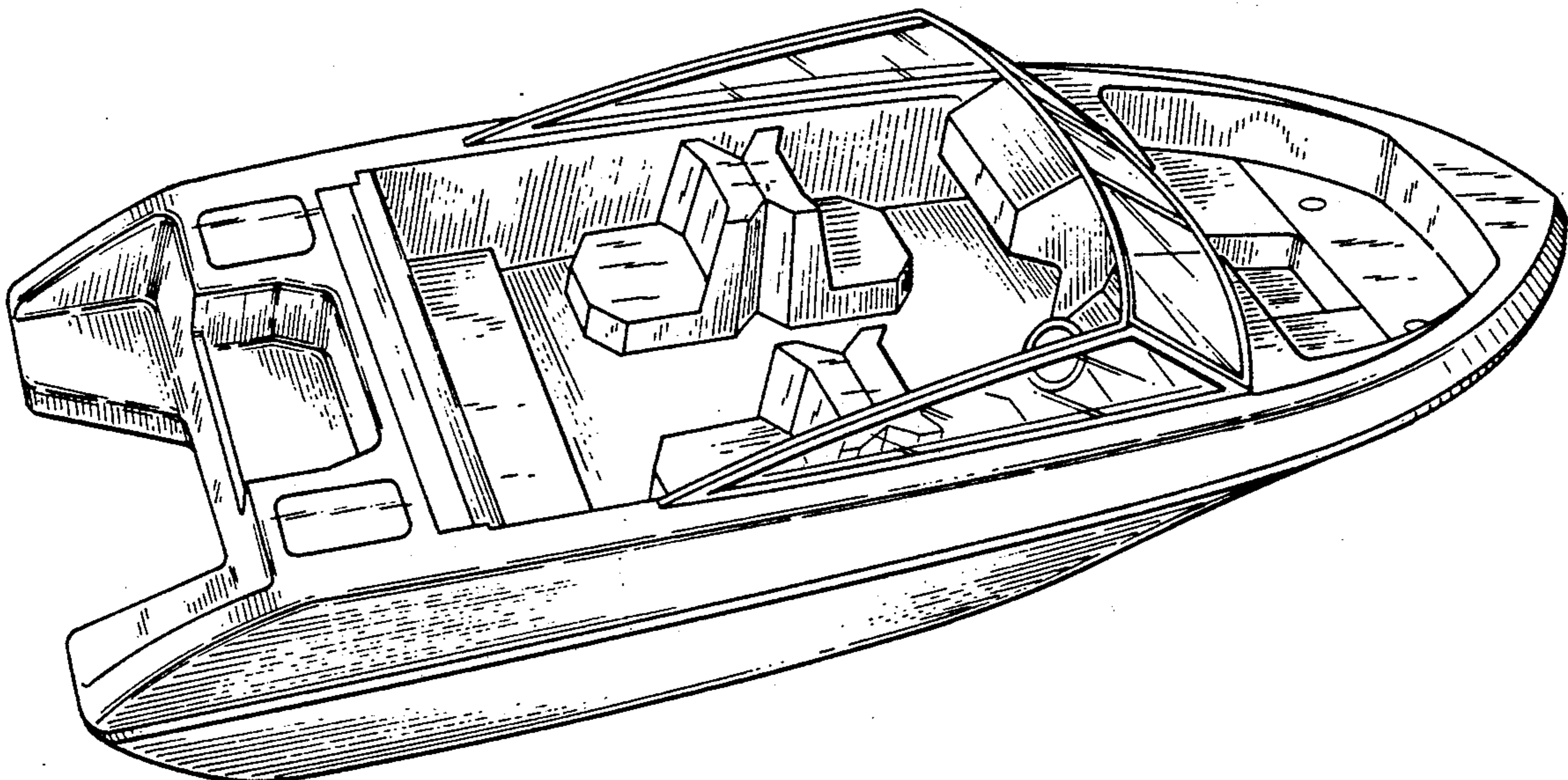

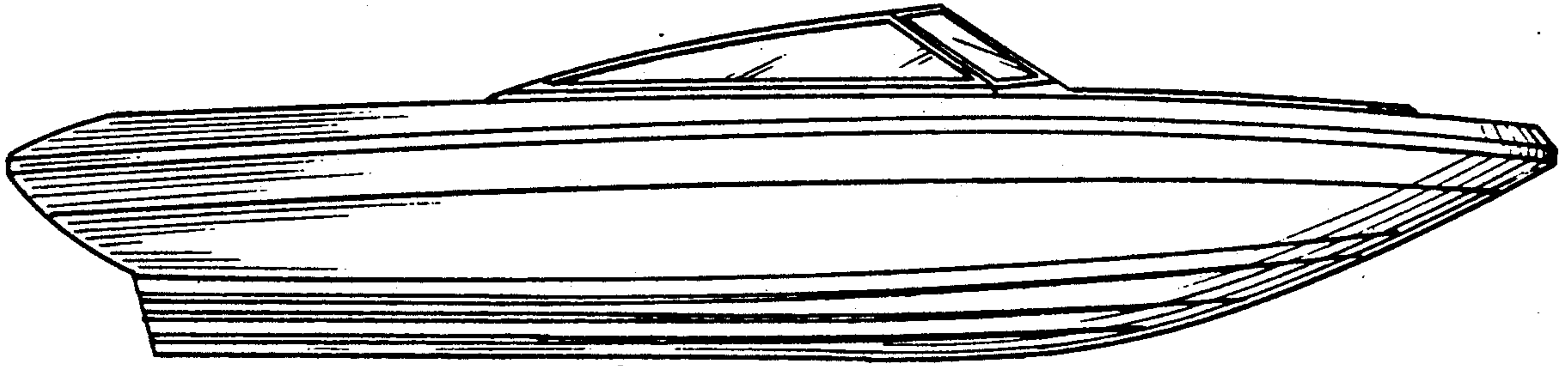
[57] CLAIM

The ornamental design for a recreational boat, as shown and described.

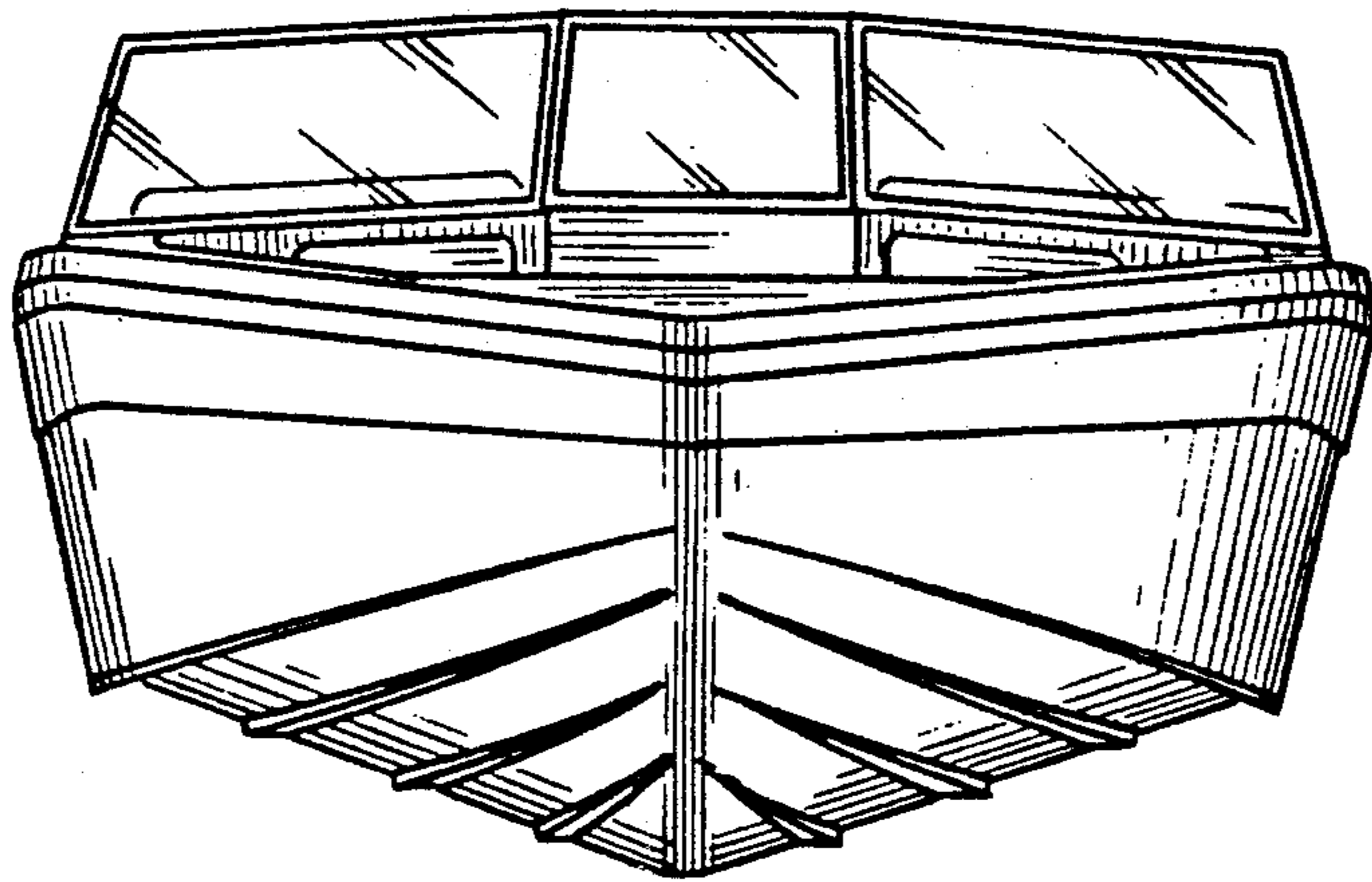
DESCRIPTION

FIG. 1 is a side elevational view of a recreational boat showing my new design, the opposite side elevational view being a mirror image of that shown; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view of a second embodiment of the recreational boat; FIG. 7 is a bottom plan view of FIG. 6; FIG. 8 is a rear elevational view of FIG. 6, the sides and front elevational views thereof being the same as FIGS. 1 and 2; FIG. 9 is a top and rear perspective view of FIG. 1; and FIG. 10 is a top and rear perspective view of FIG. 6.

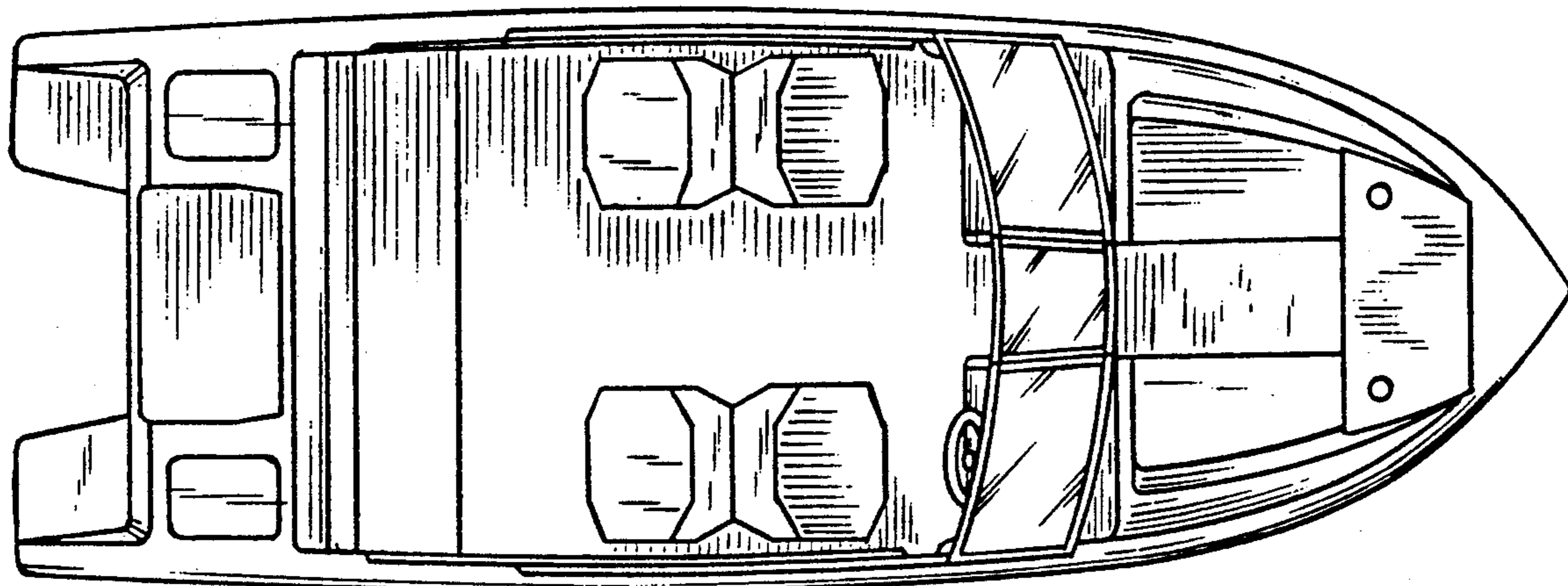




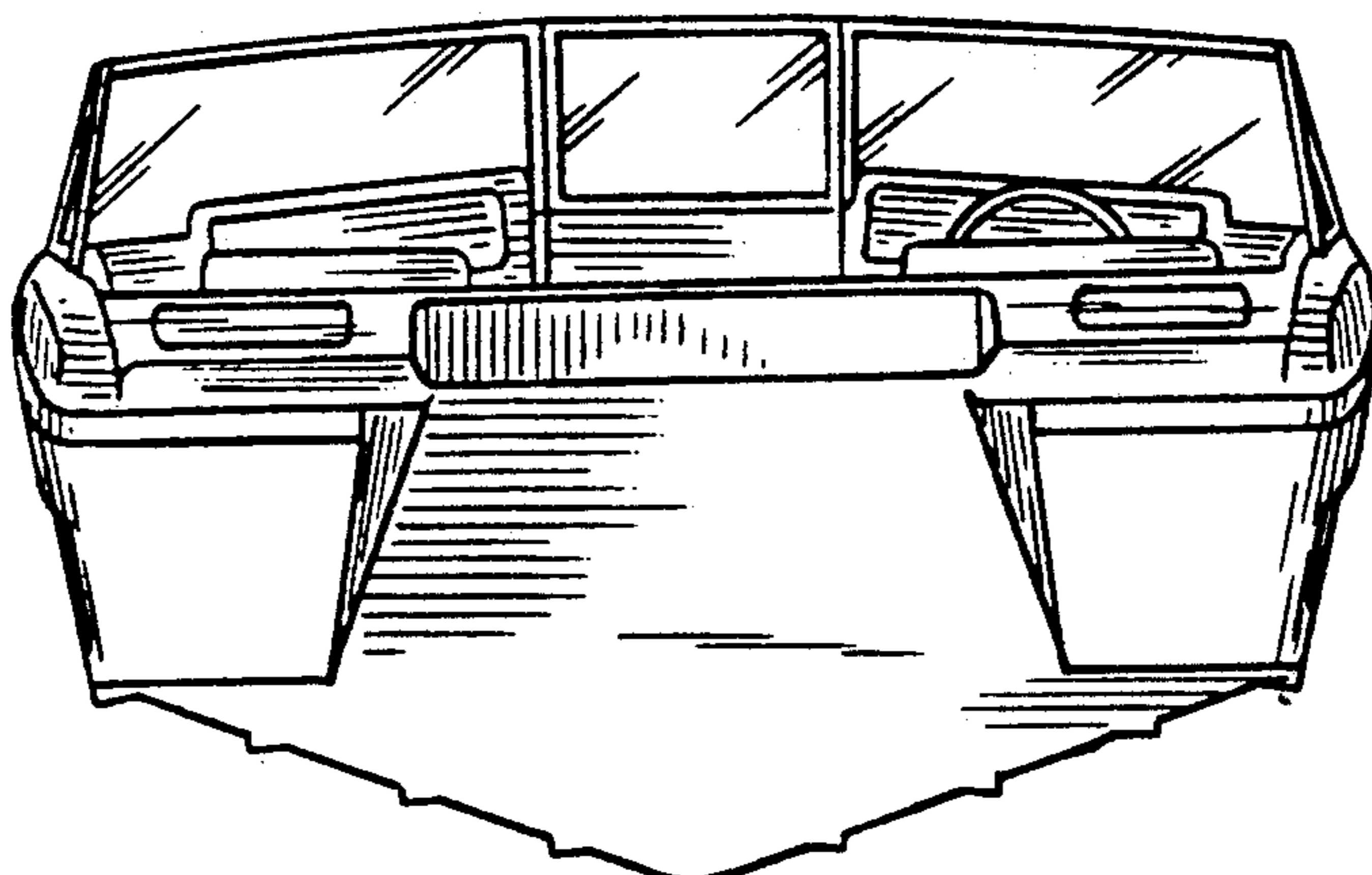

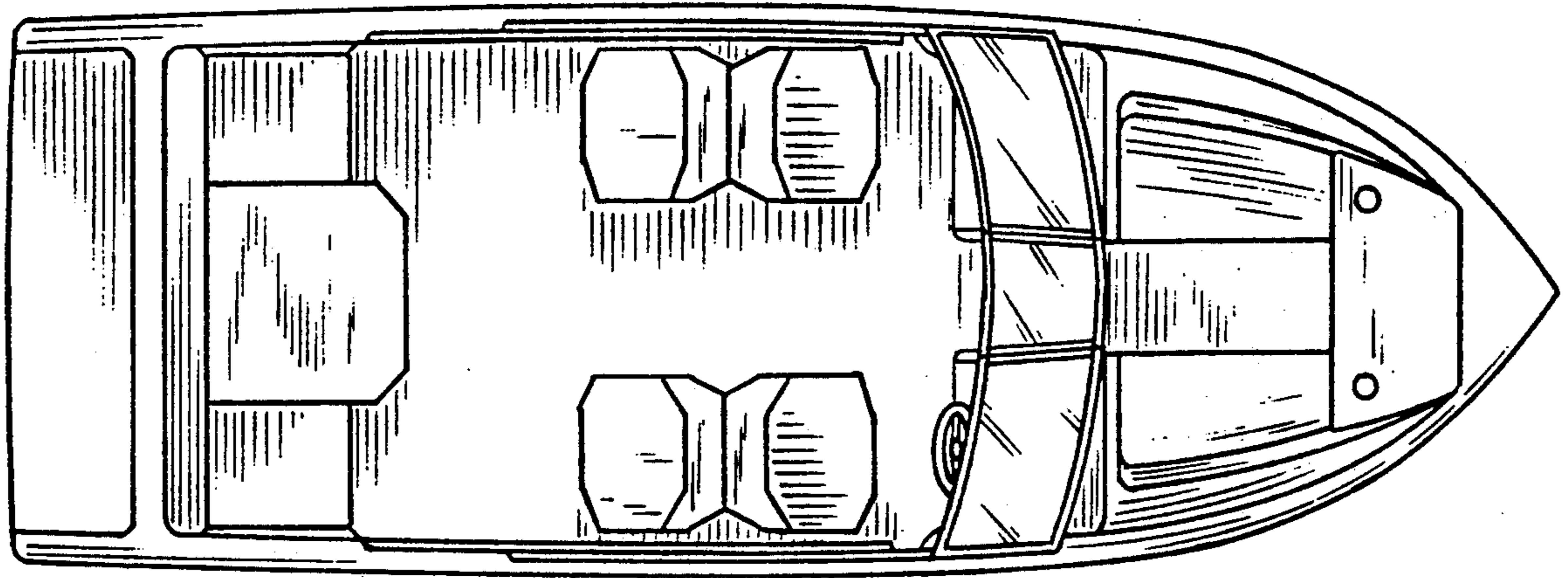

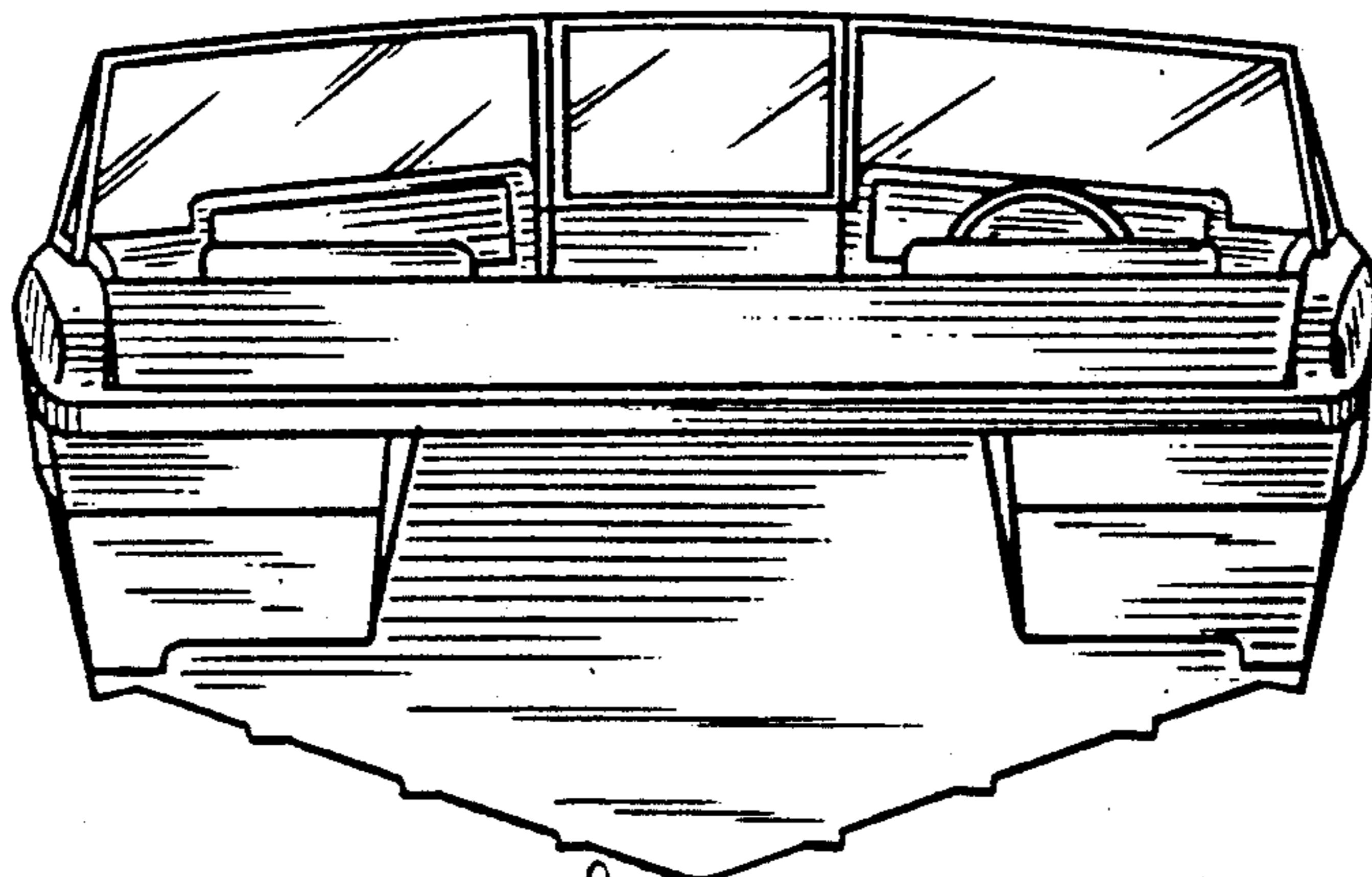

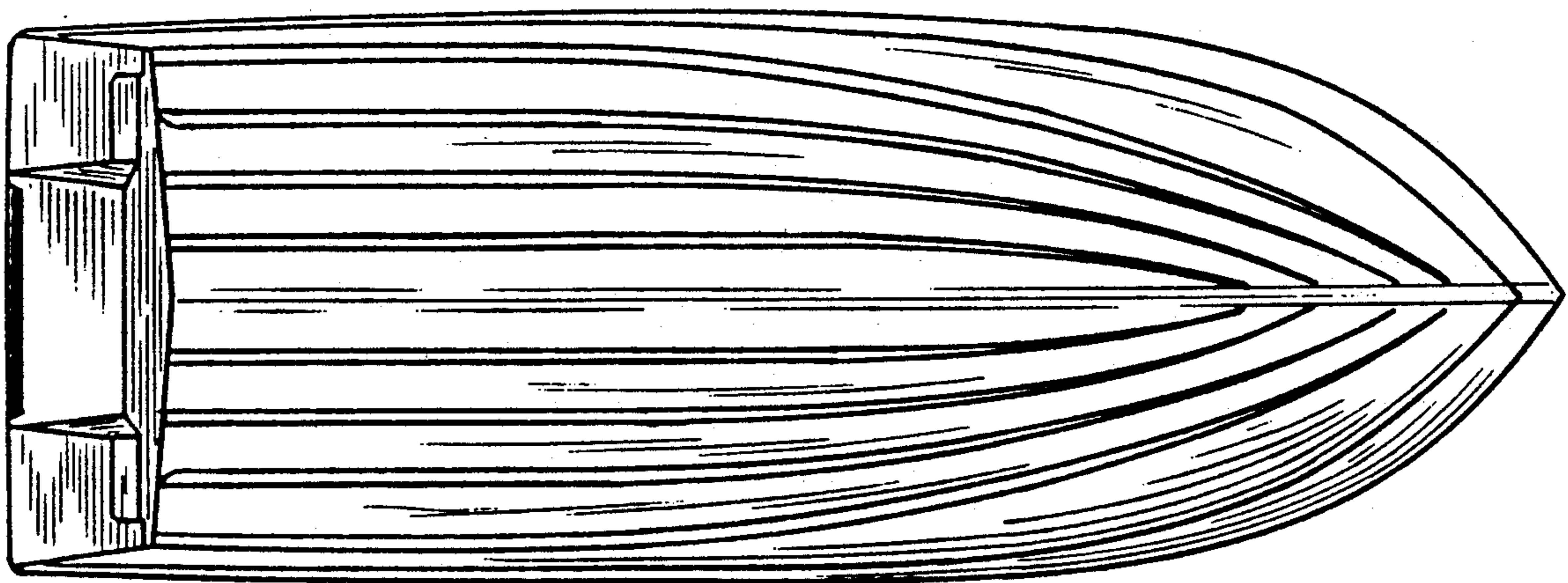

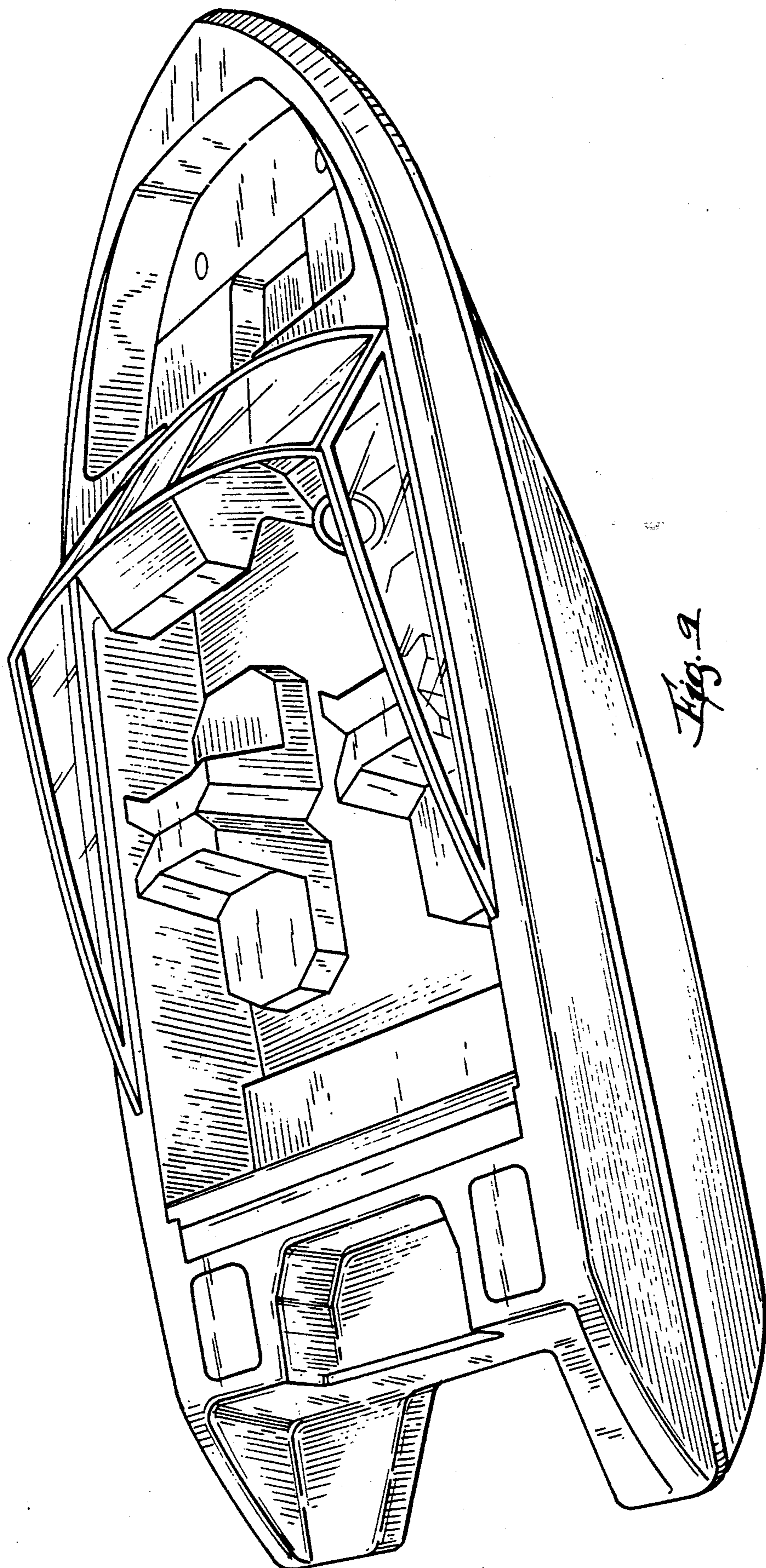

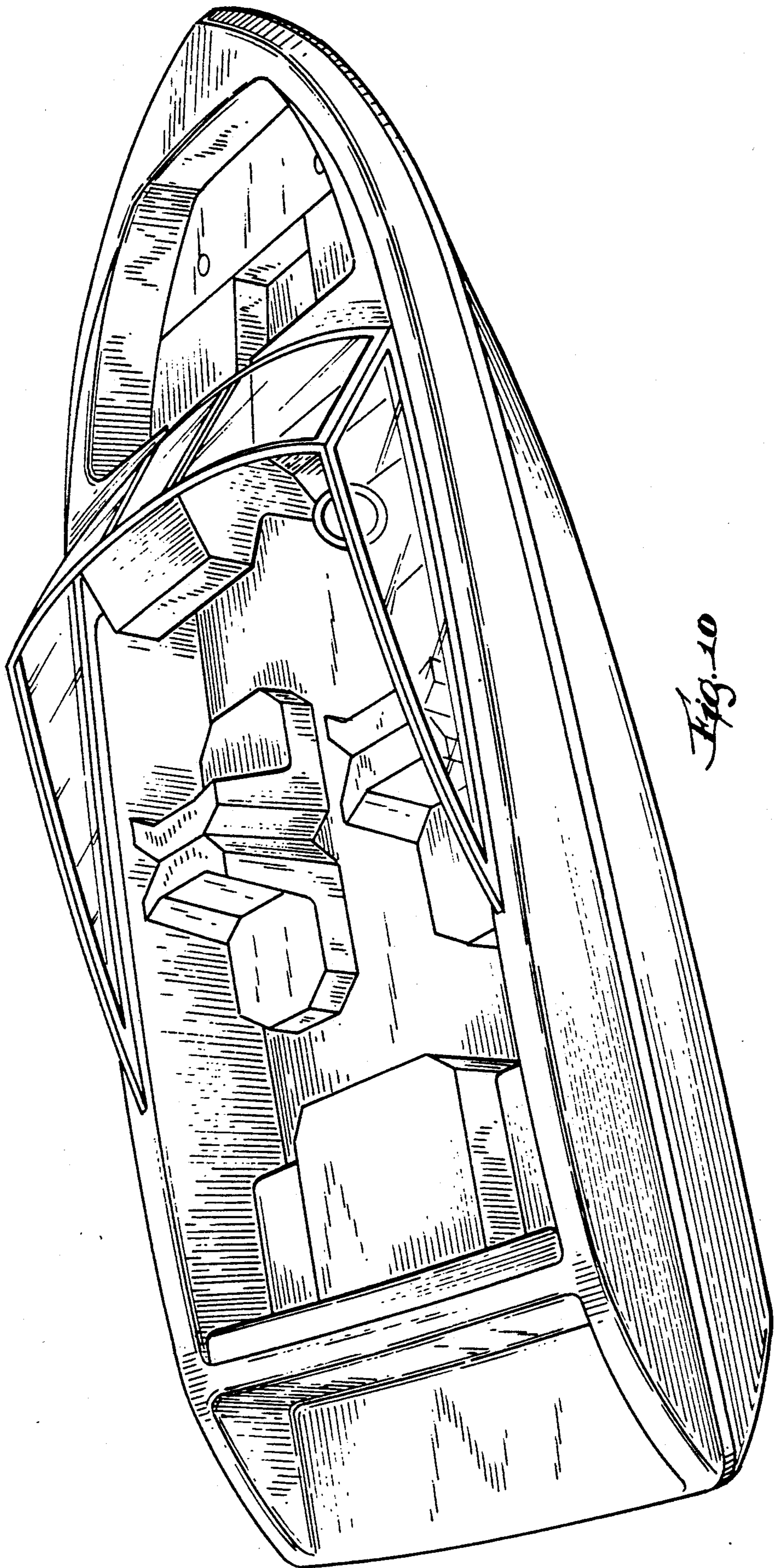
