[57] **CLAIM**

The ornamental design for a charging and telecommunicating cradle for a portable teletransaction computer terminal, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, rear, right side perspective view of a charging and telecommunicating cradle for a portable teletransaction computer terminal showing my new design;

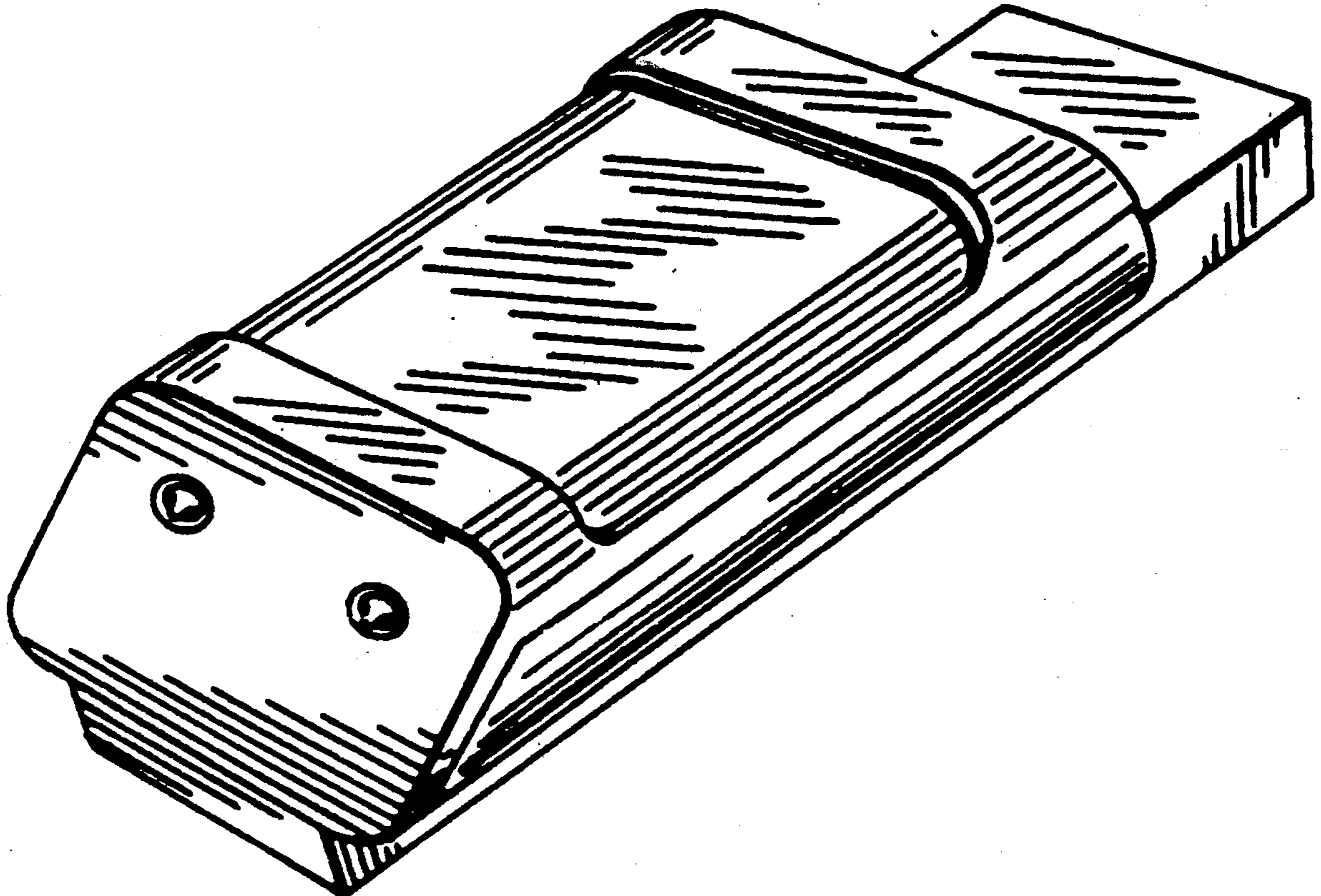
FIG. 2 is an enlarged top plan view thereof;

FIG. 6 is an enlarged front elevational view thereof.



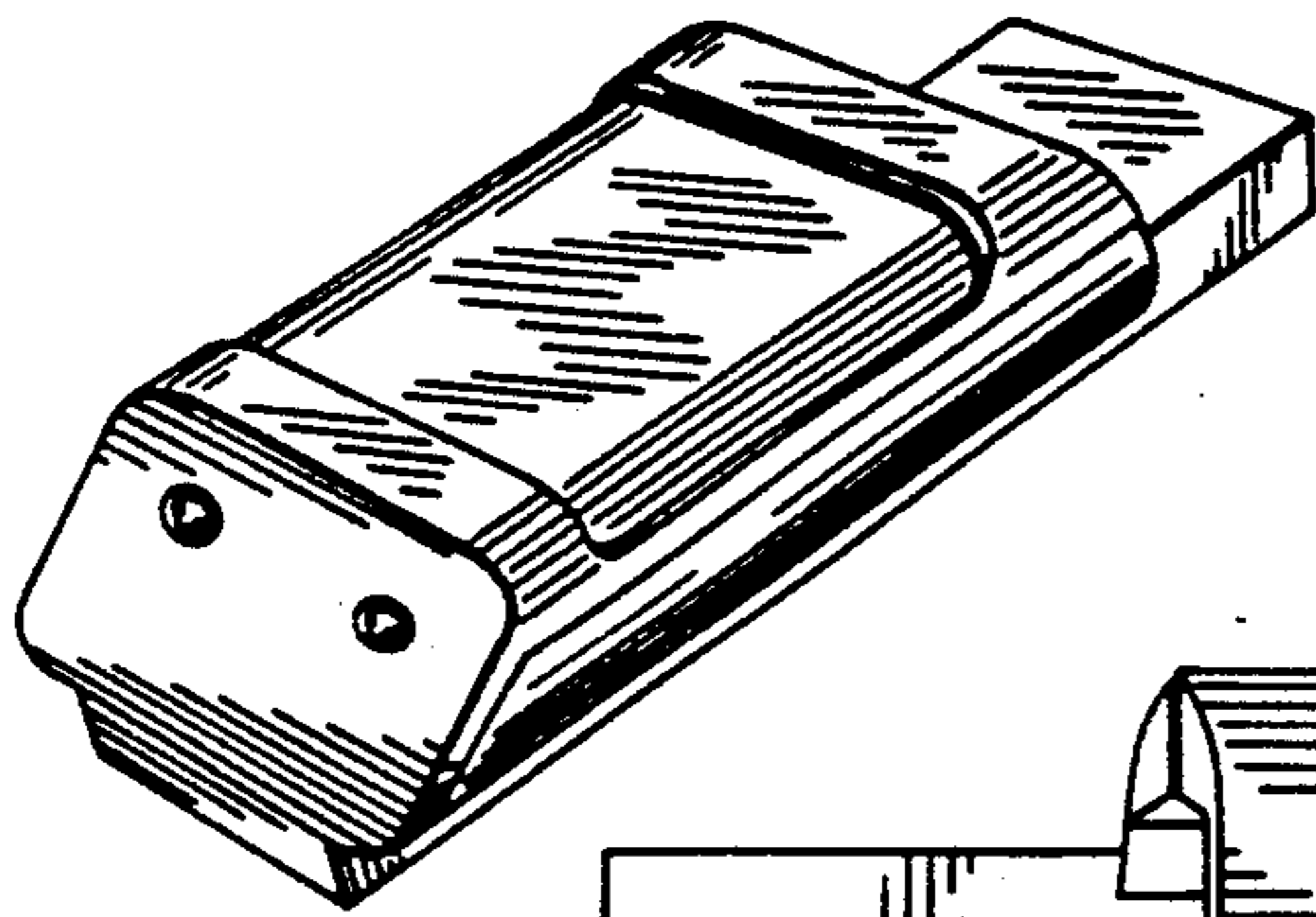

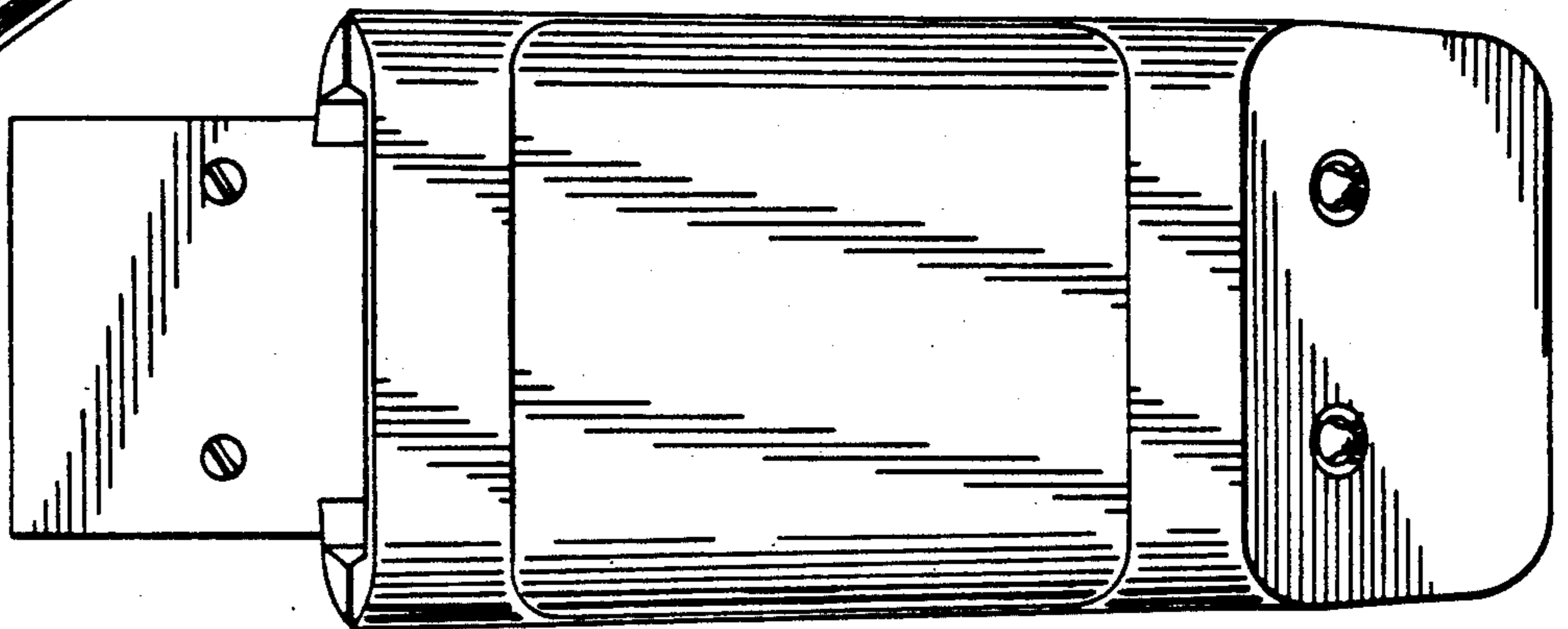

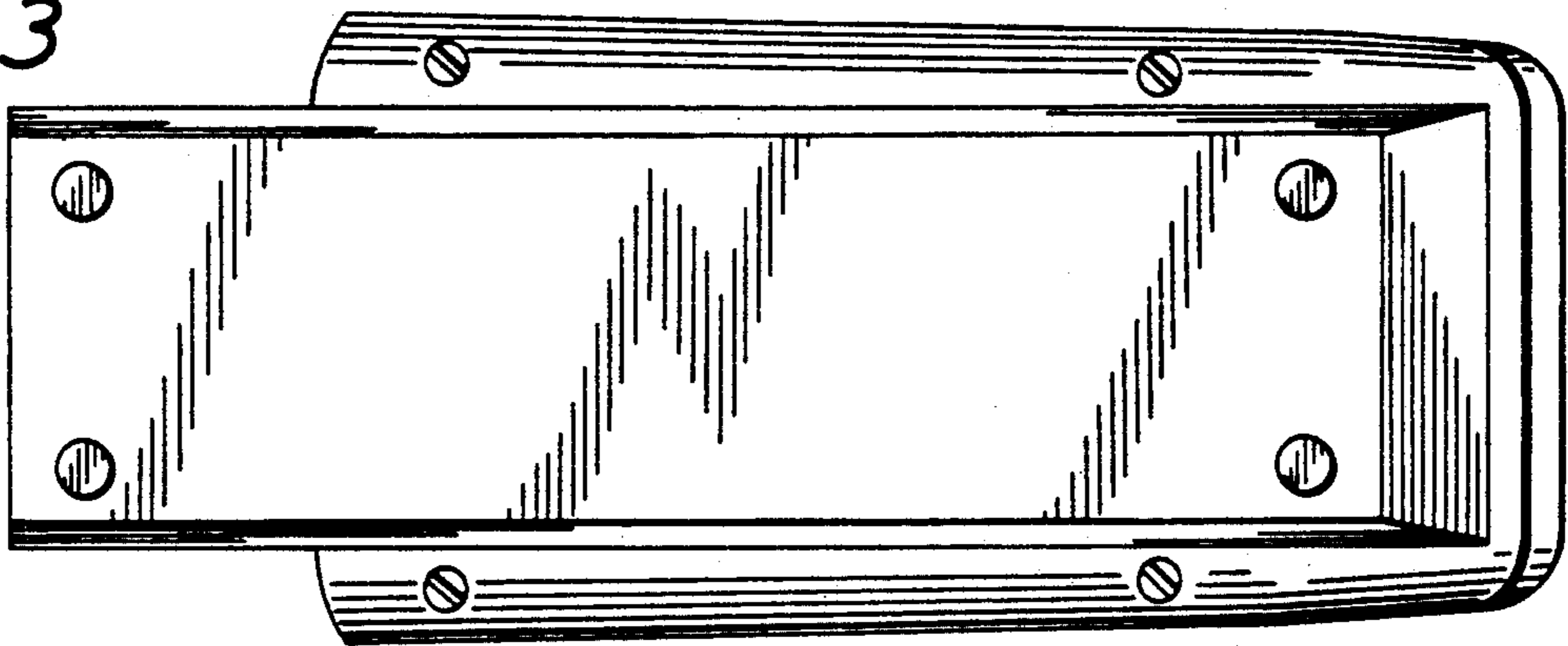

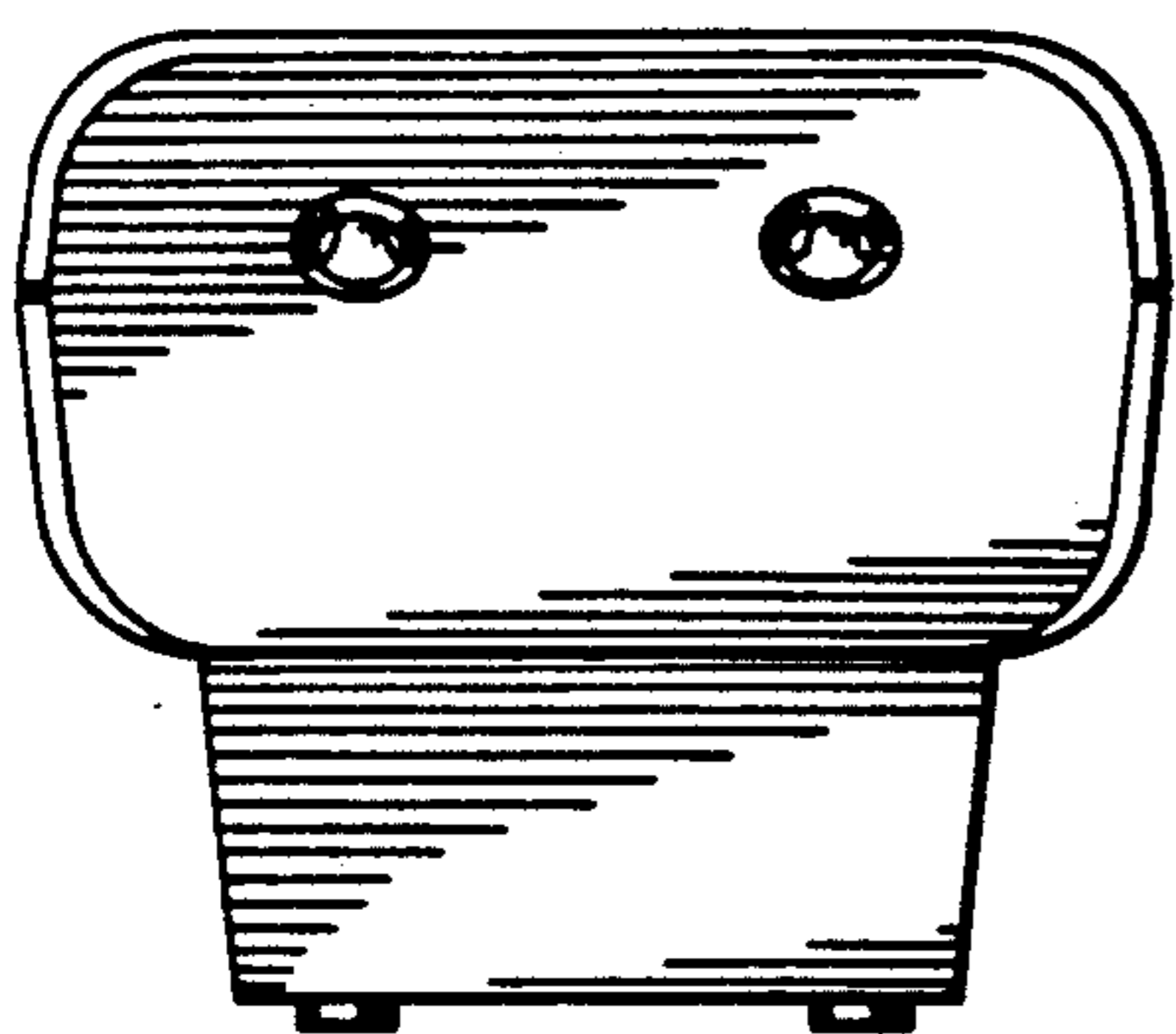
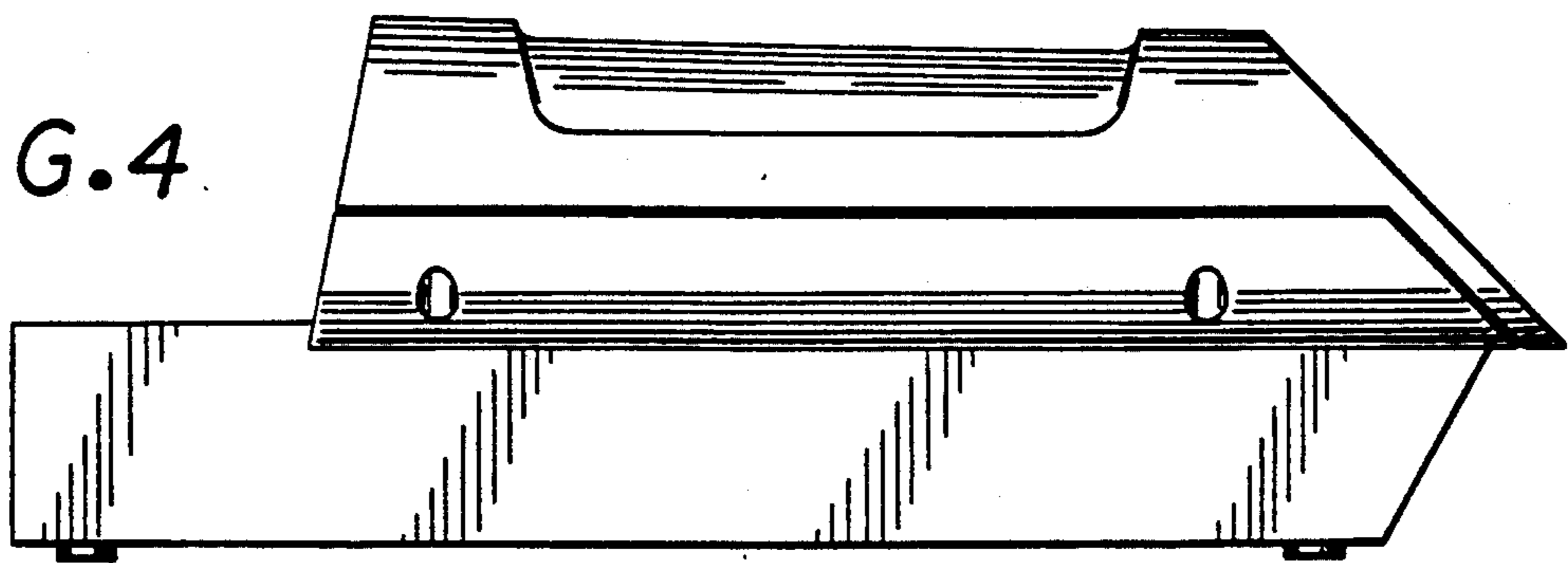
