The ornamental design for an electronic music keyboard, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of an electronic music keyboard showing my new design;
 FIG. 2 is a left side elevational view thereof;

 FIG. 14 is a top, right, front perspective view thereof.

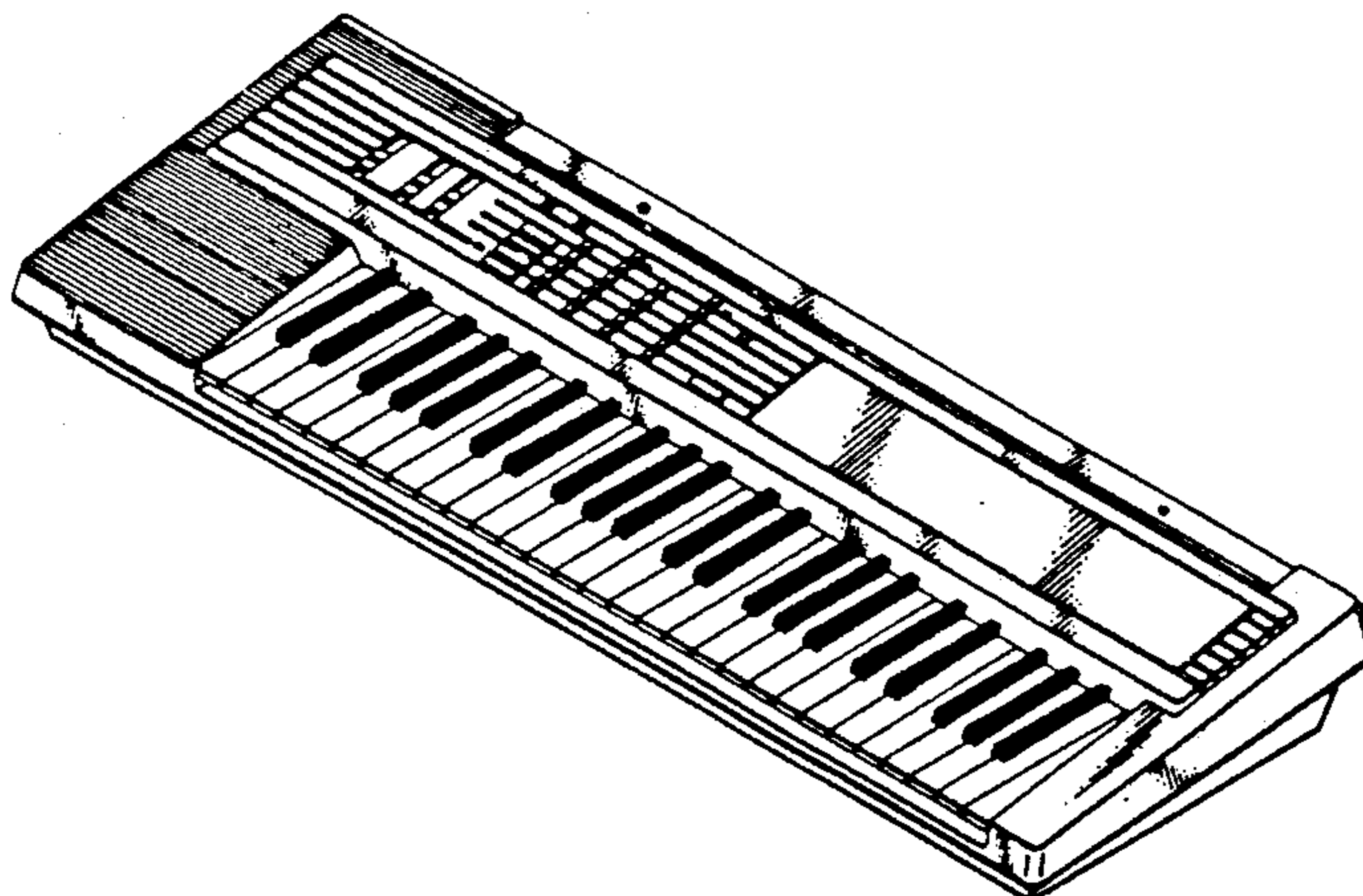
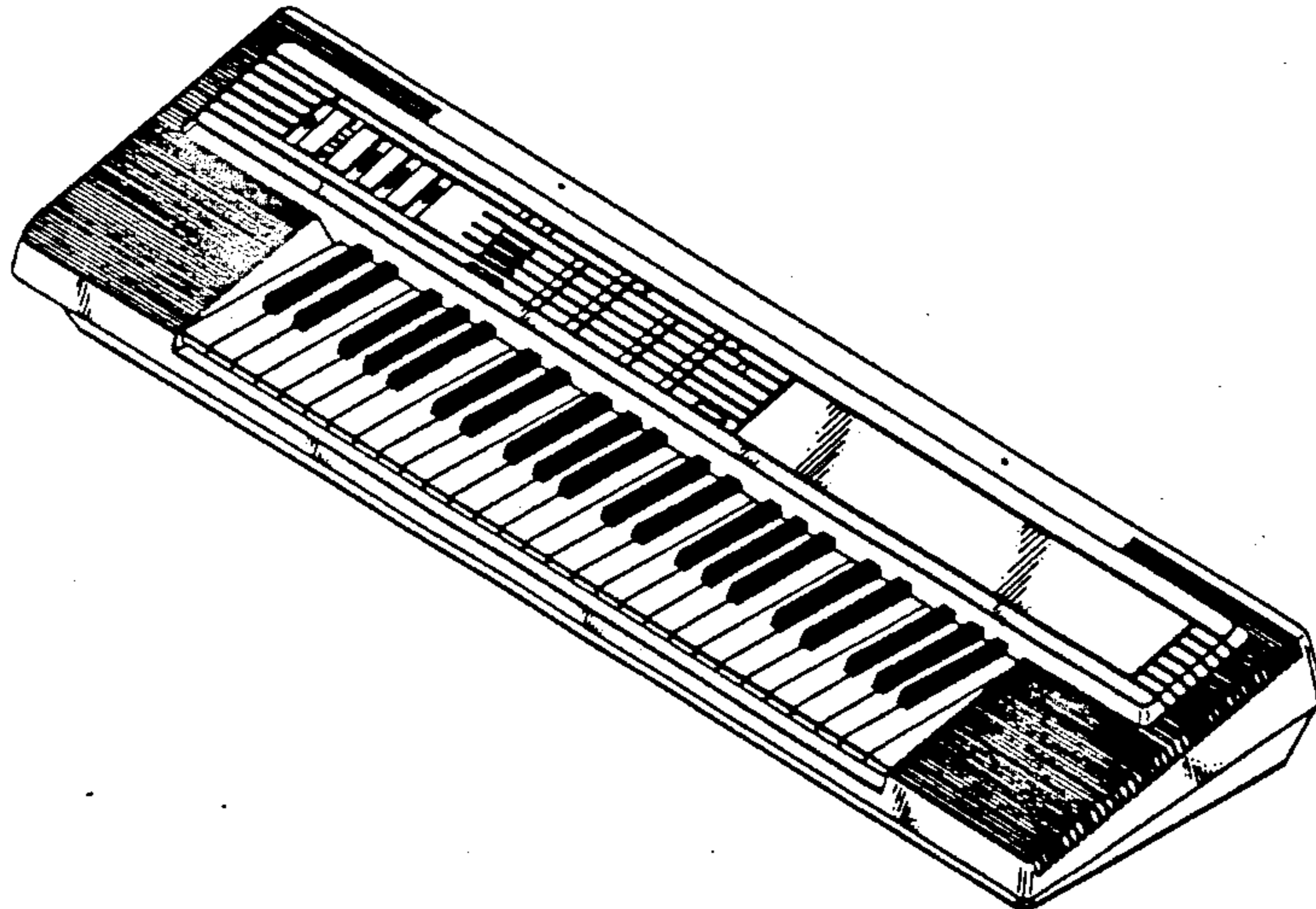

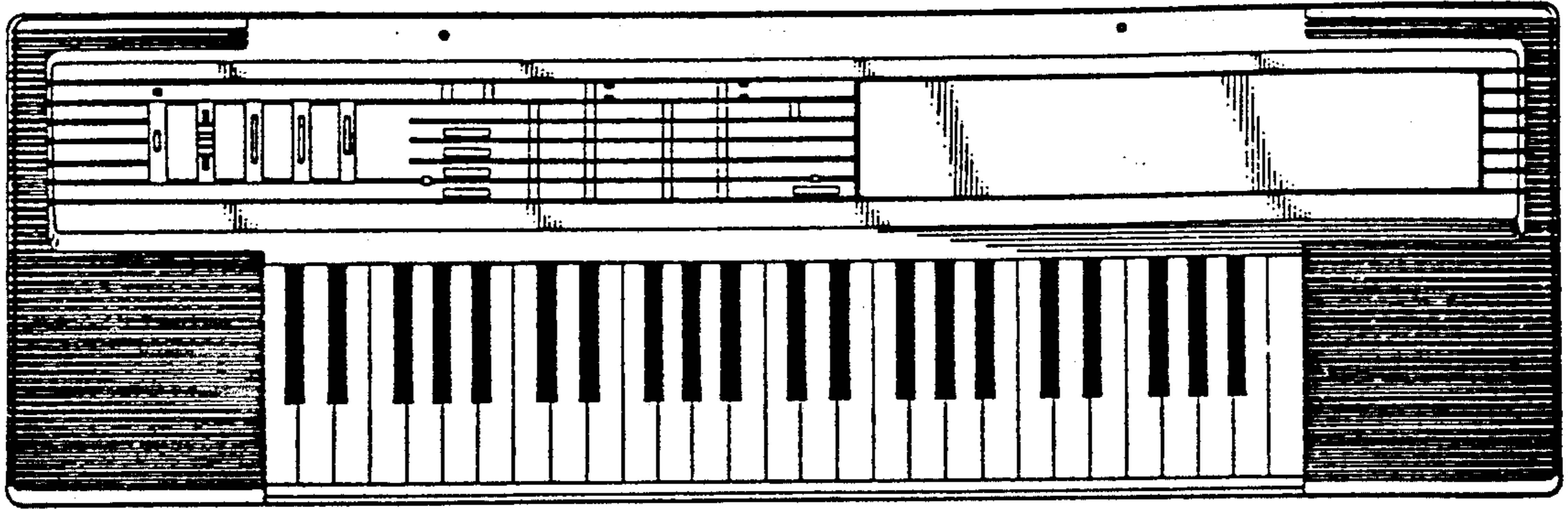

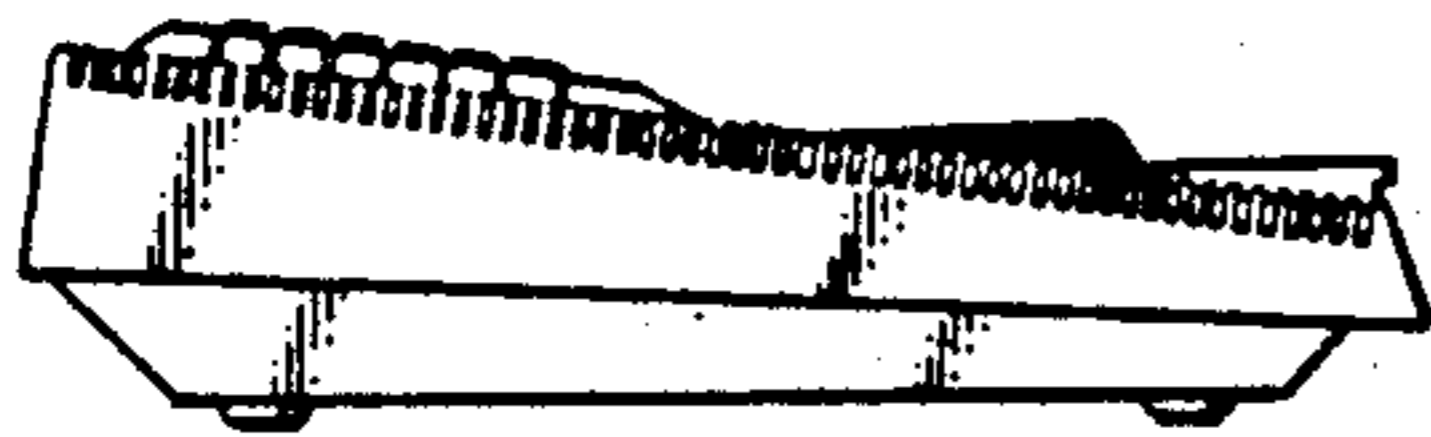

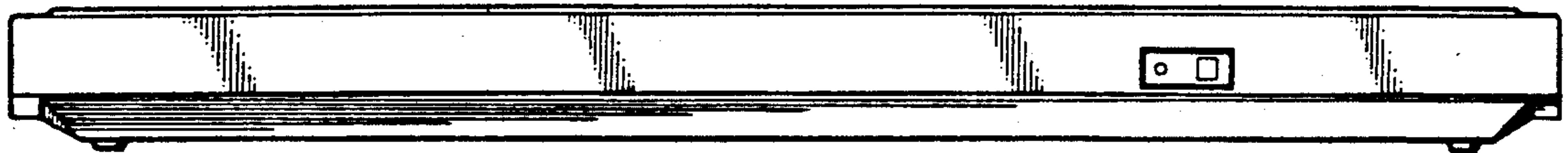

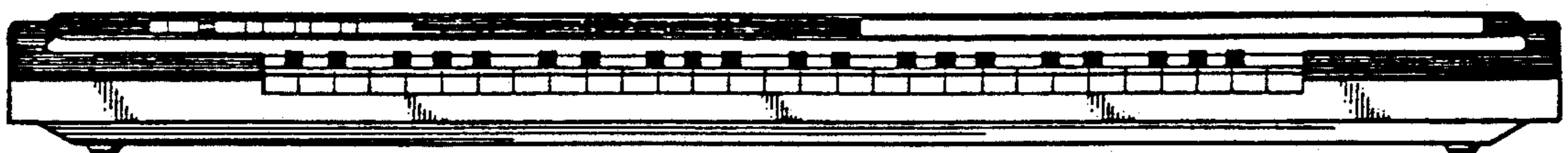

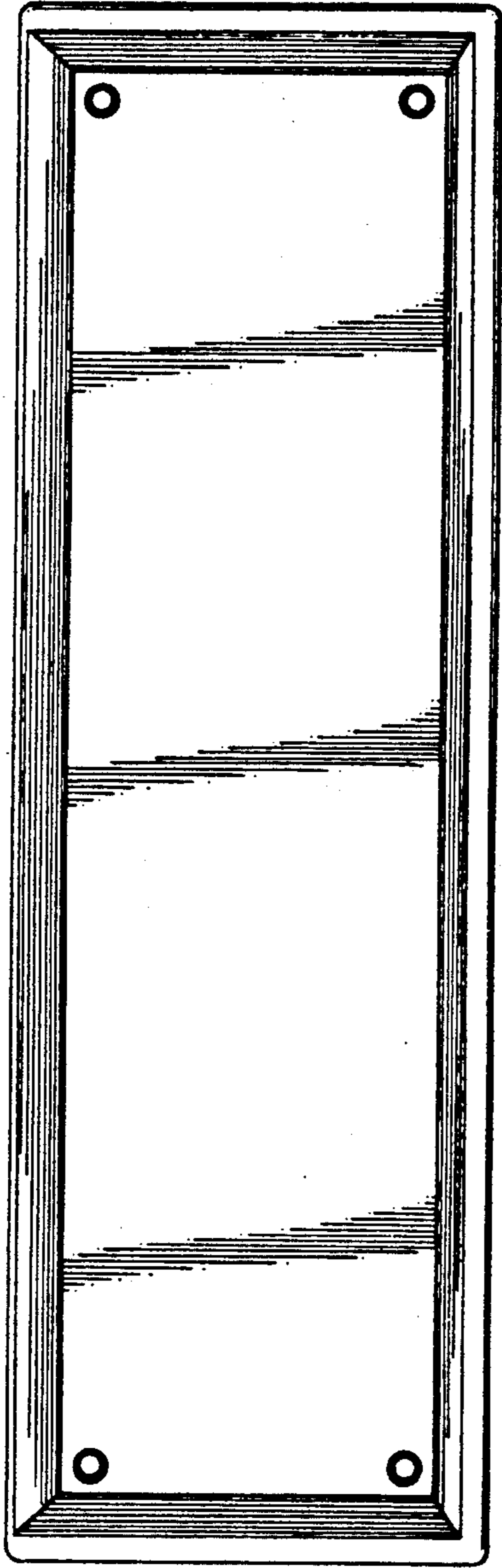

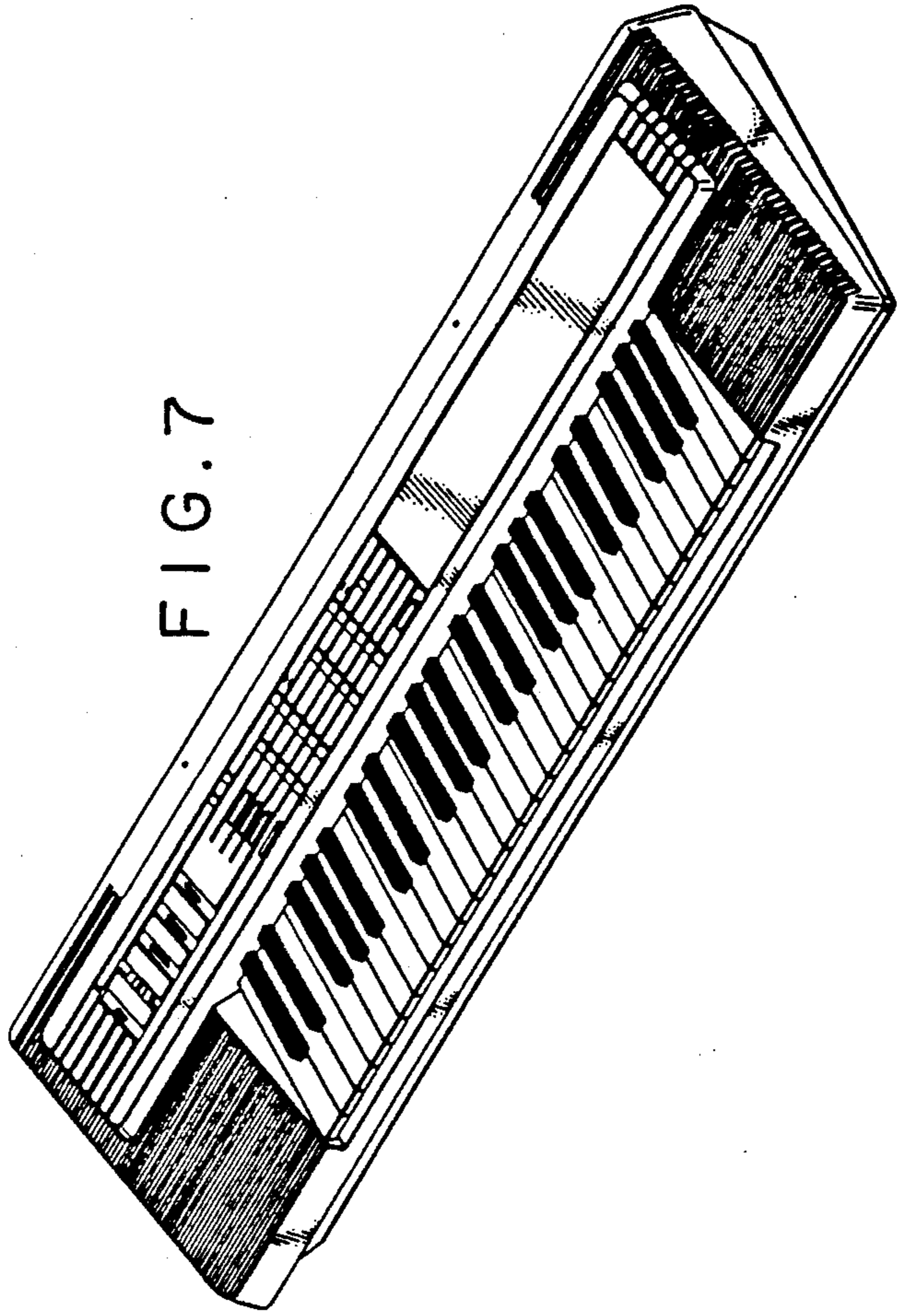

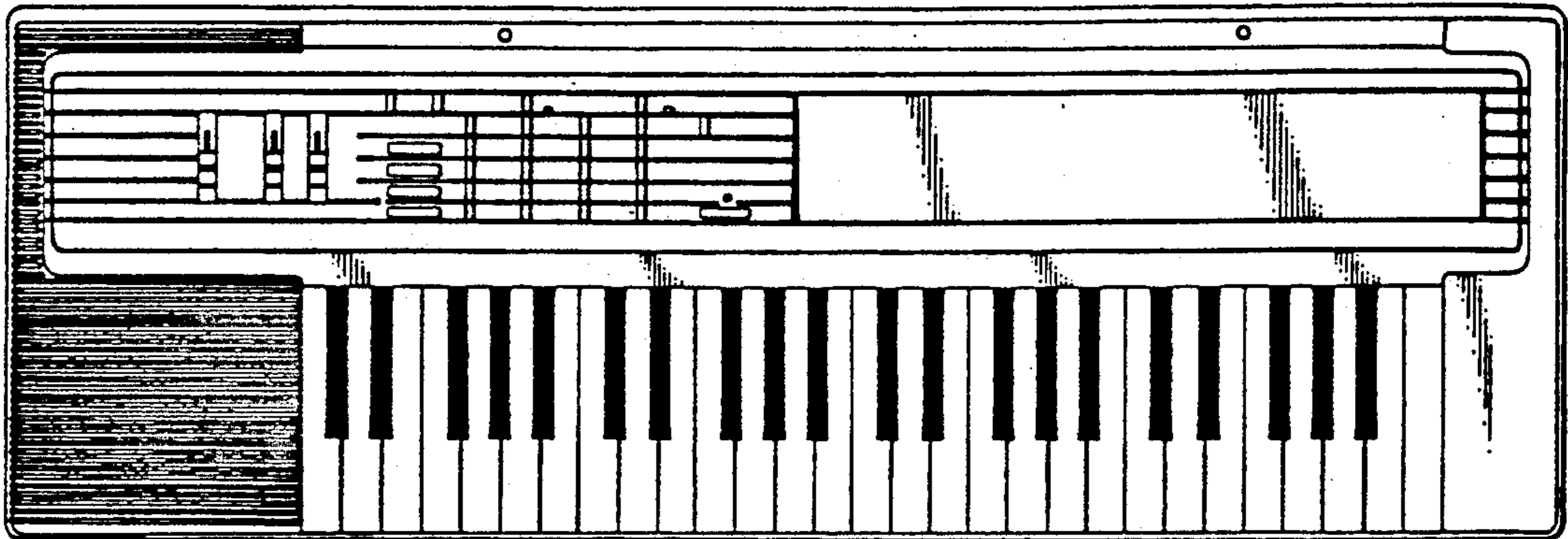

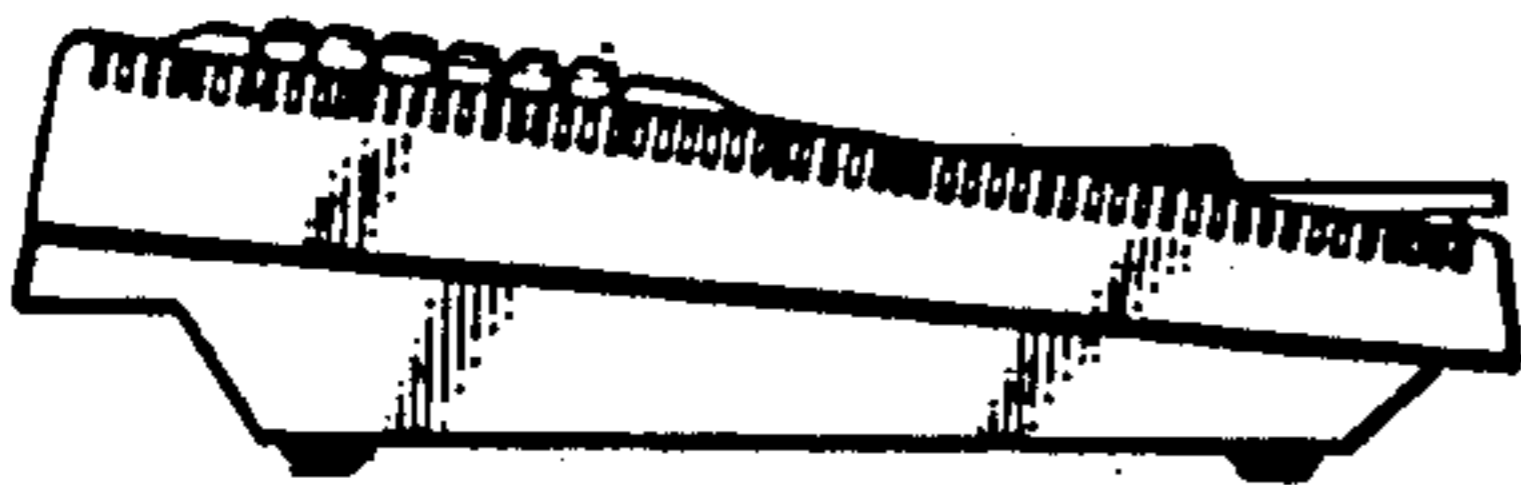

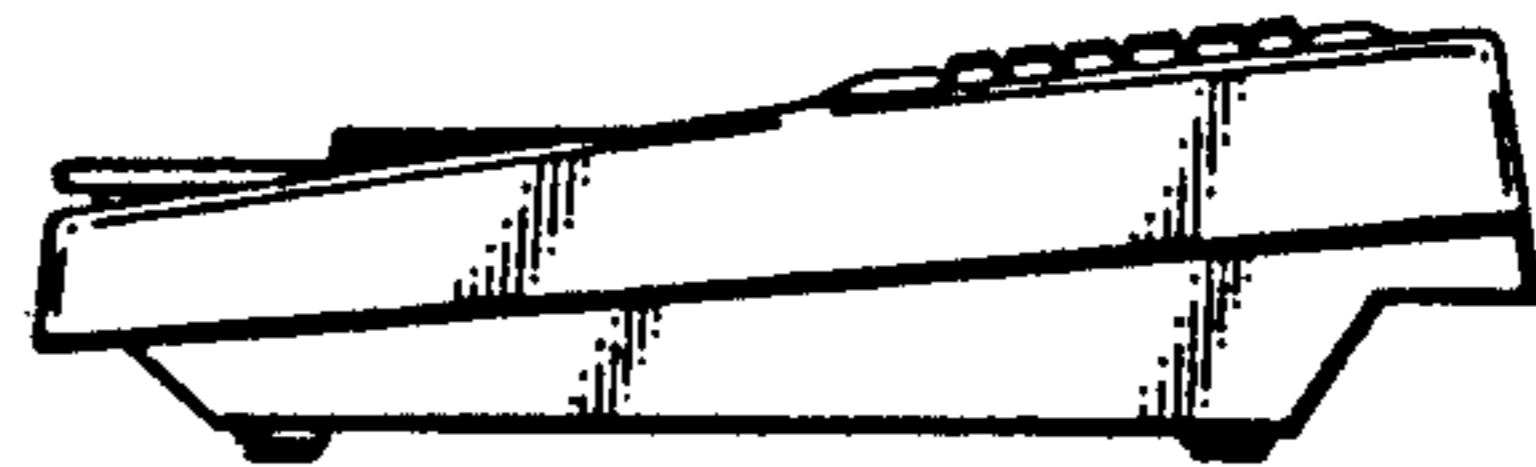

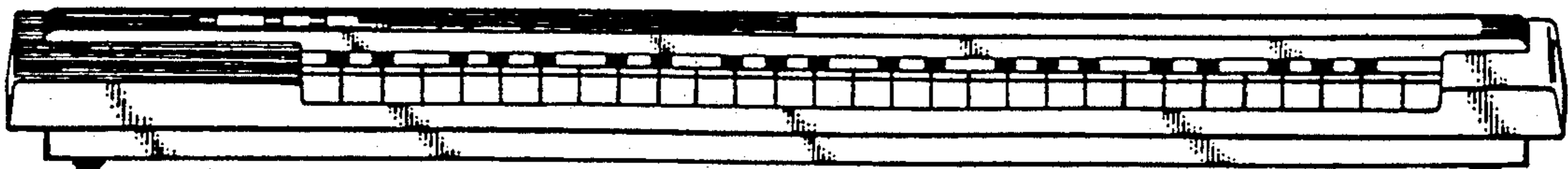

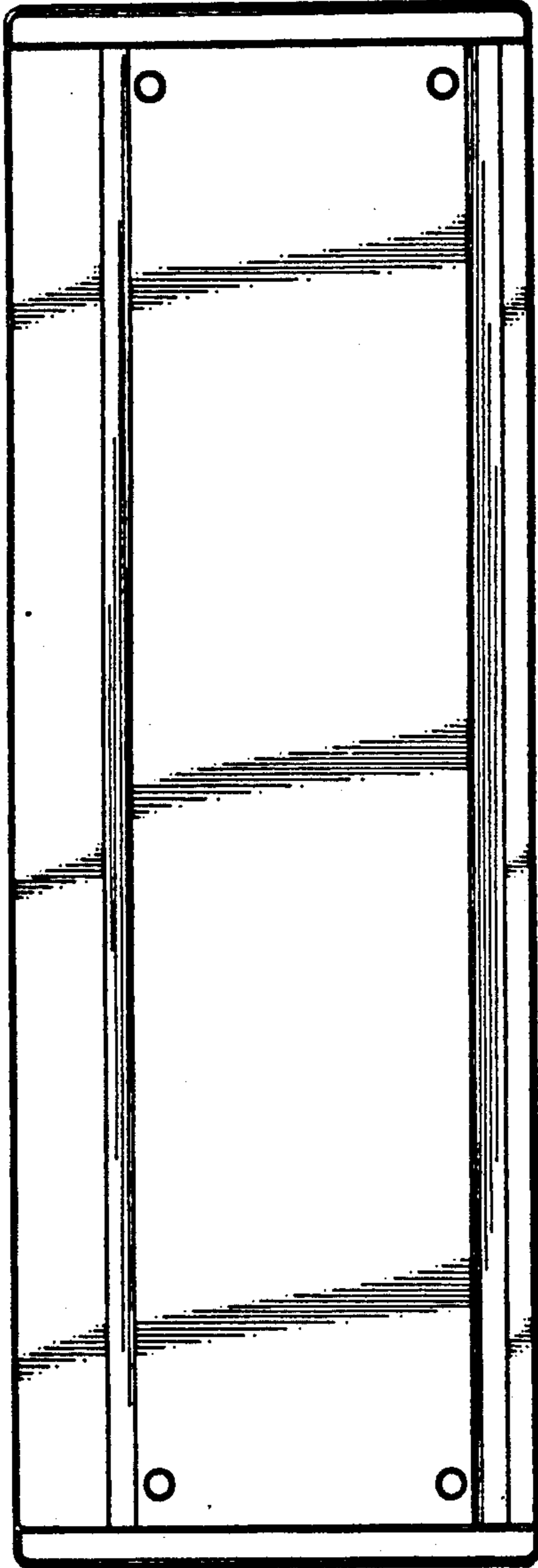
