[57] CLAIM

The ornamental design for set of vehicle lamp guards, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of one guard of the set of vehicle lamp guards showing my new design, the

guard in FIG. 1 being for the front right hand vehicle lamp, the other guards of the set being omitted for clarity and convenience of disclosure;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a top, front, left hand side perspective view thereof;

FIG. 5 is a front elevational view of a second guard of the set of vehicle lamp guards, the guard in FIG. 2 being for the front left hand vehicle lamp, the other guards of the set being omitted for clarity and convenience of disclosure;

FIG. 6 is a right hand side elevational view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a top, front, left hand side perspective view thereof;

FIG. 9 is a front elevational view of a third guard of the set of vehicle lamp guards, the guard in FIG. 9 being for the rear right hand vehicle lamp, the other guards of the set being omitted for clarity and convenience of disclosure;

FIG. 10 is a right hand side elevational view thereof;

FIG. 11 is a top plan view thereof;

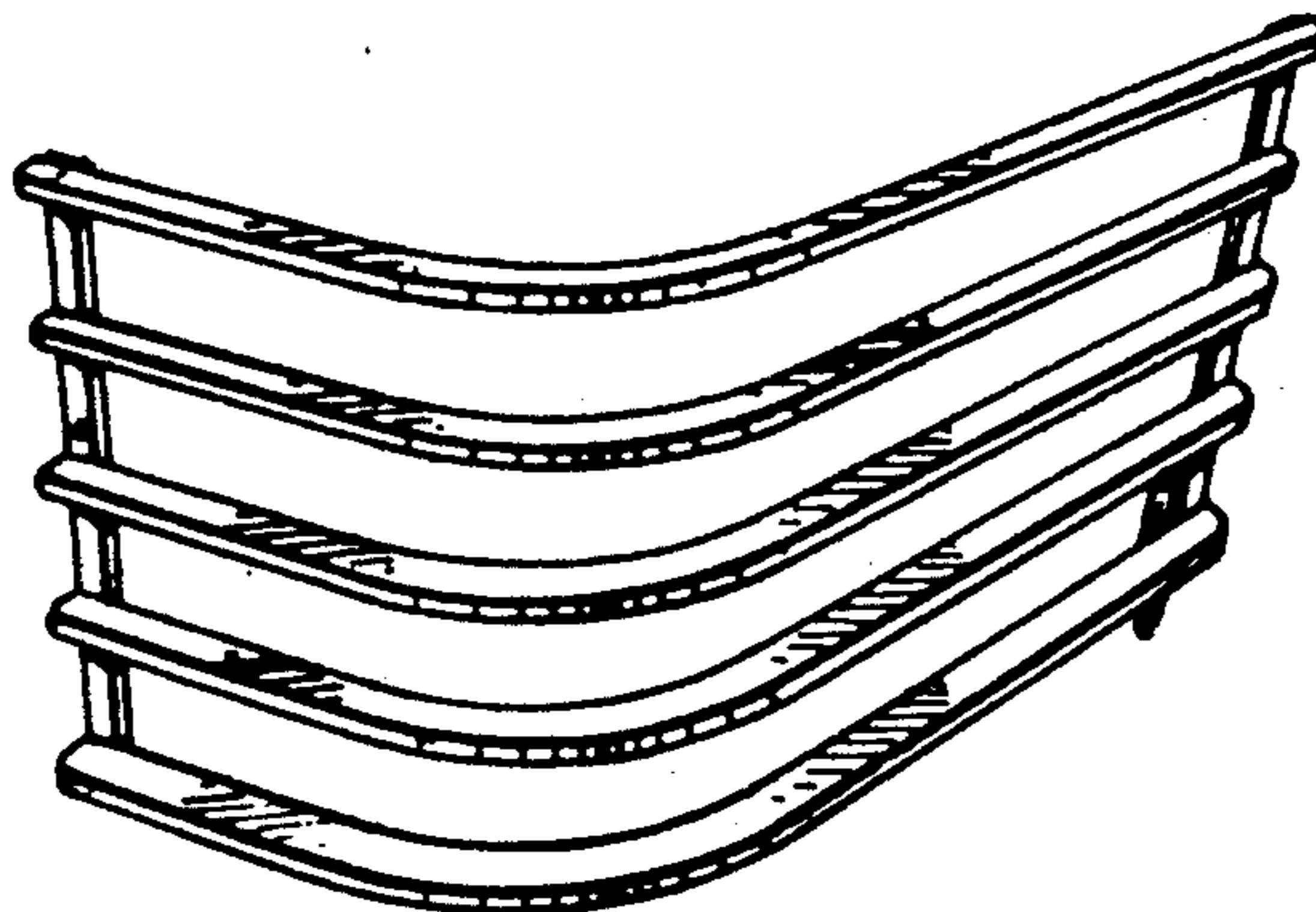
FIG. 12 is a top, front, left hand side perspective view thereof;

FIG. 16 is a top, front, left hand side perspective view thereof.



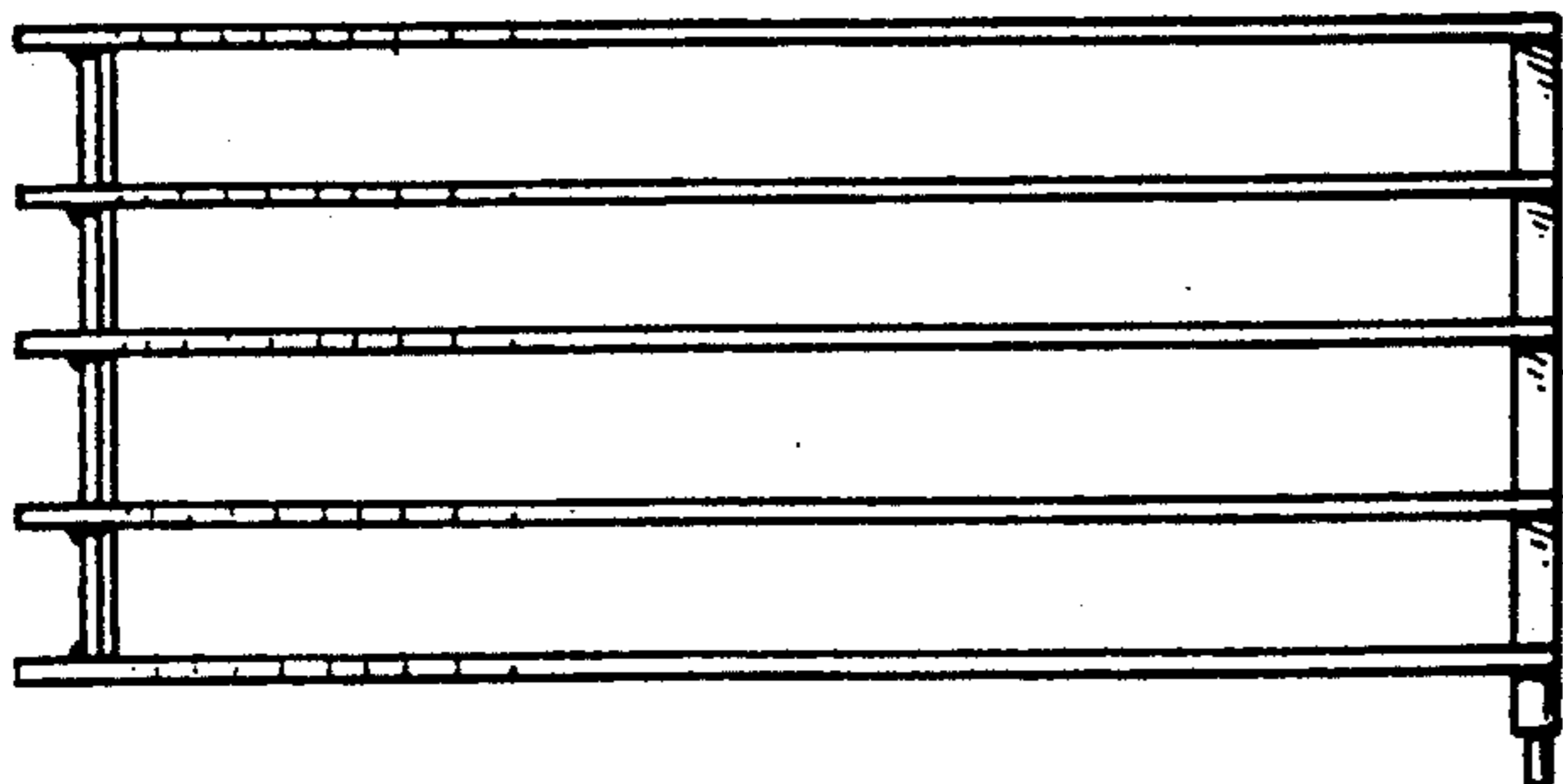

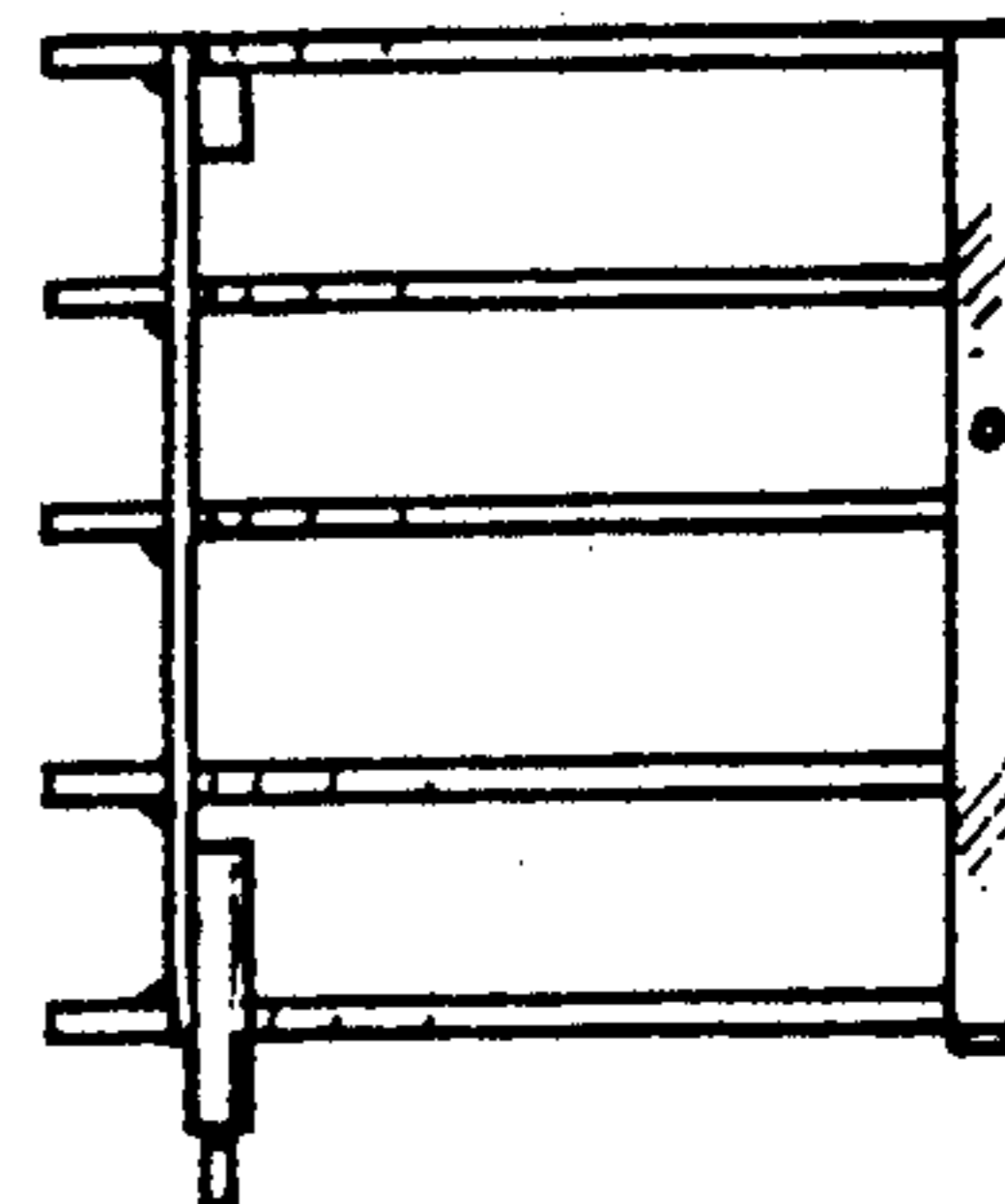

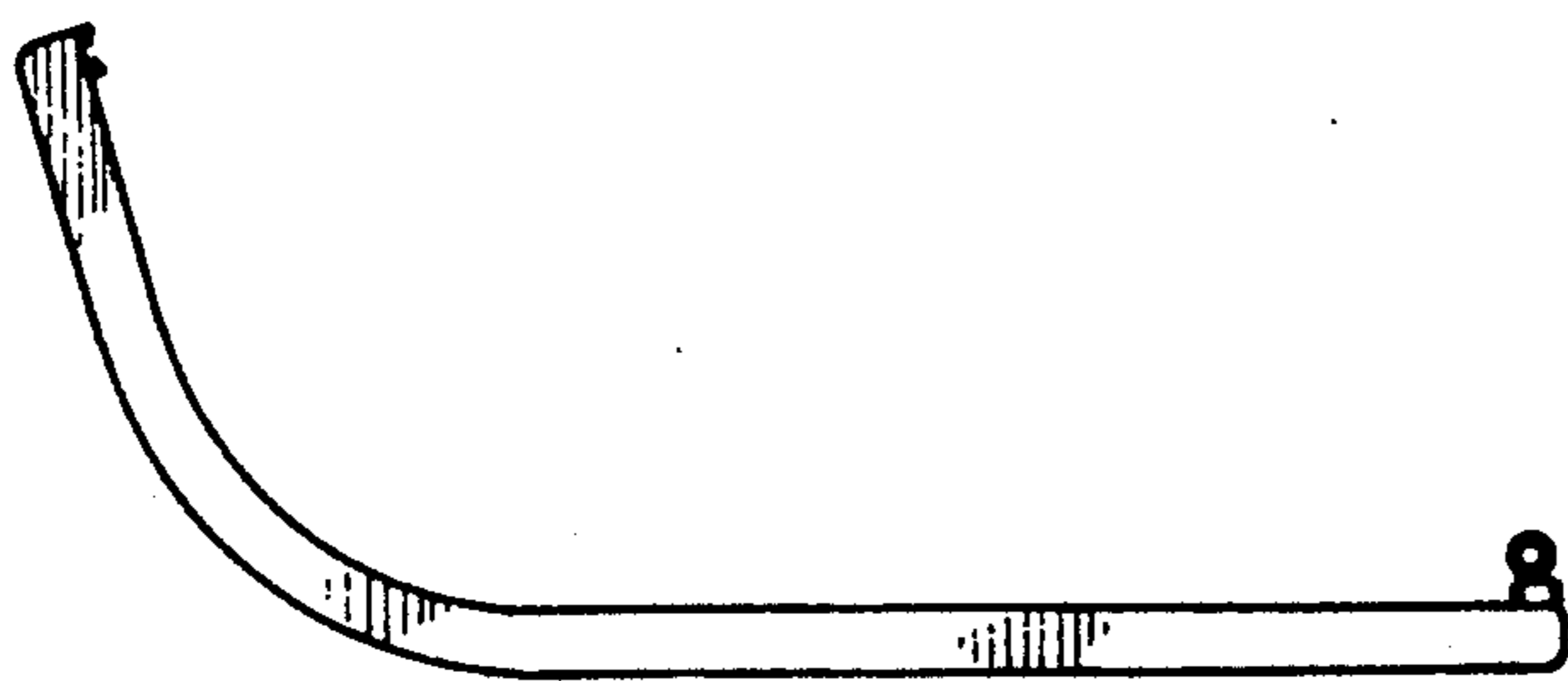

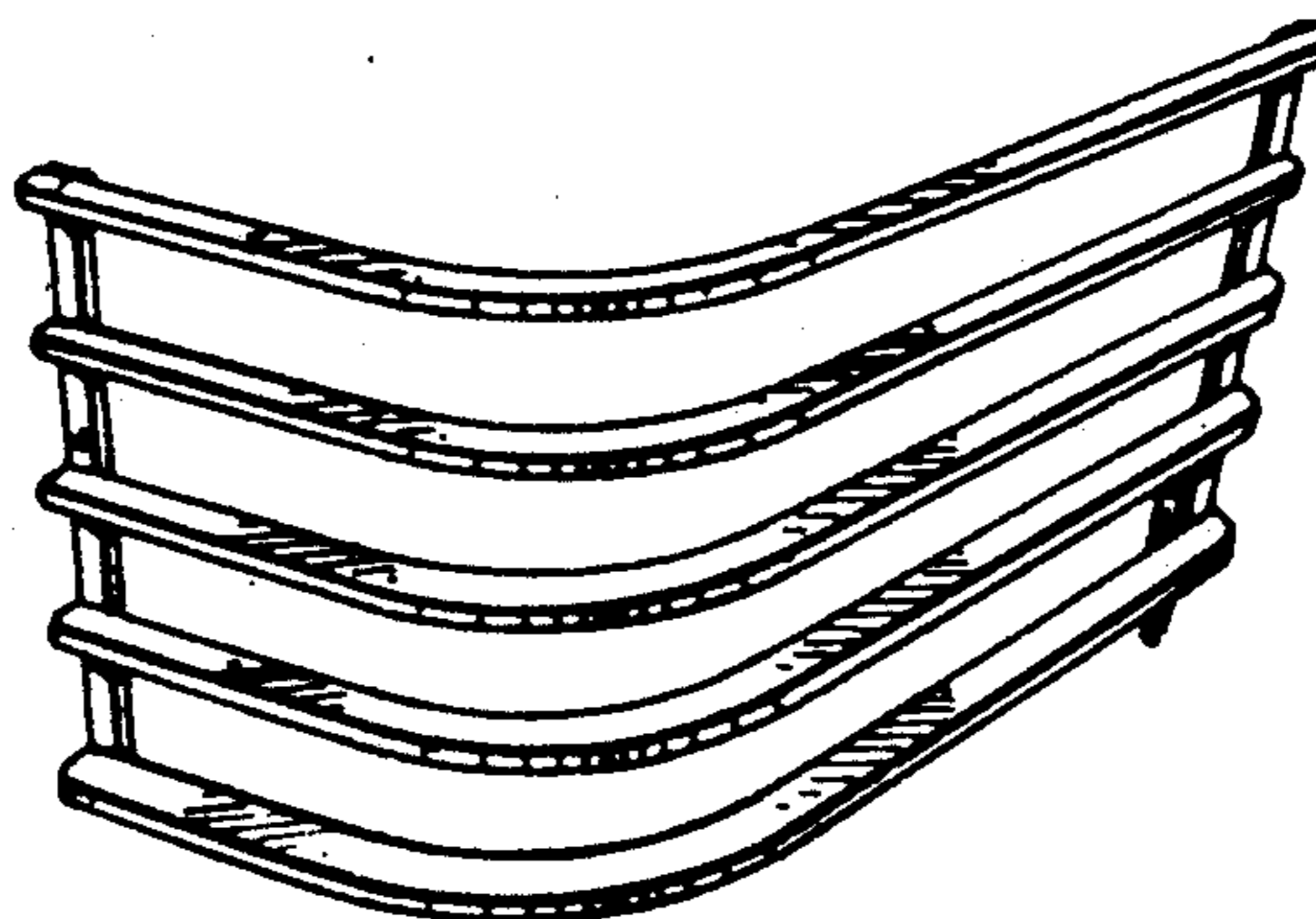

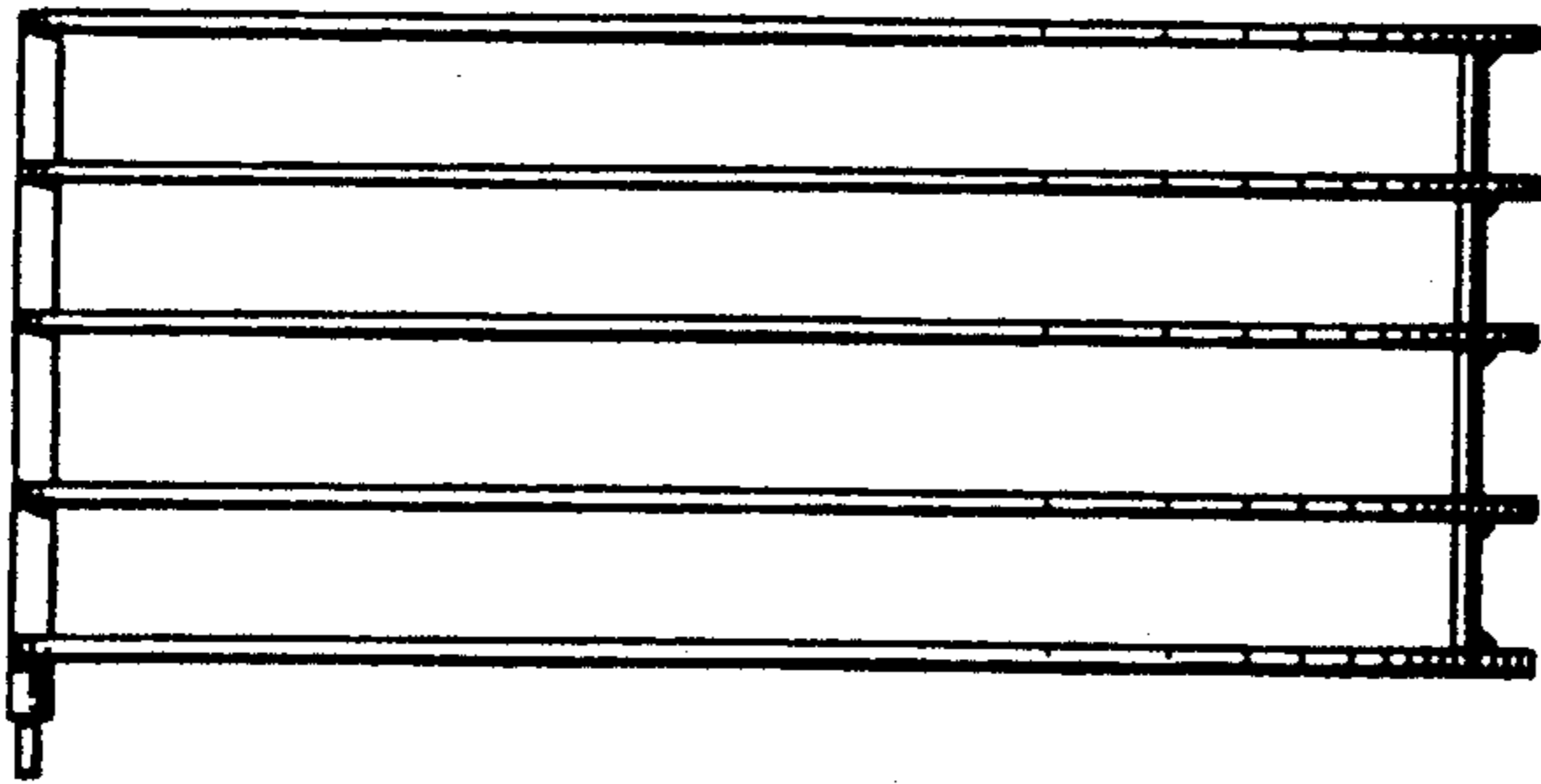

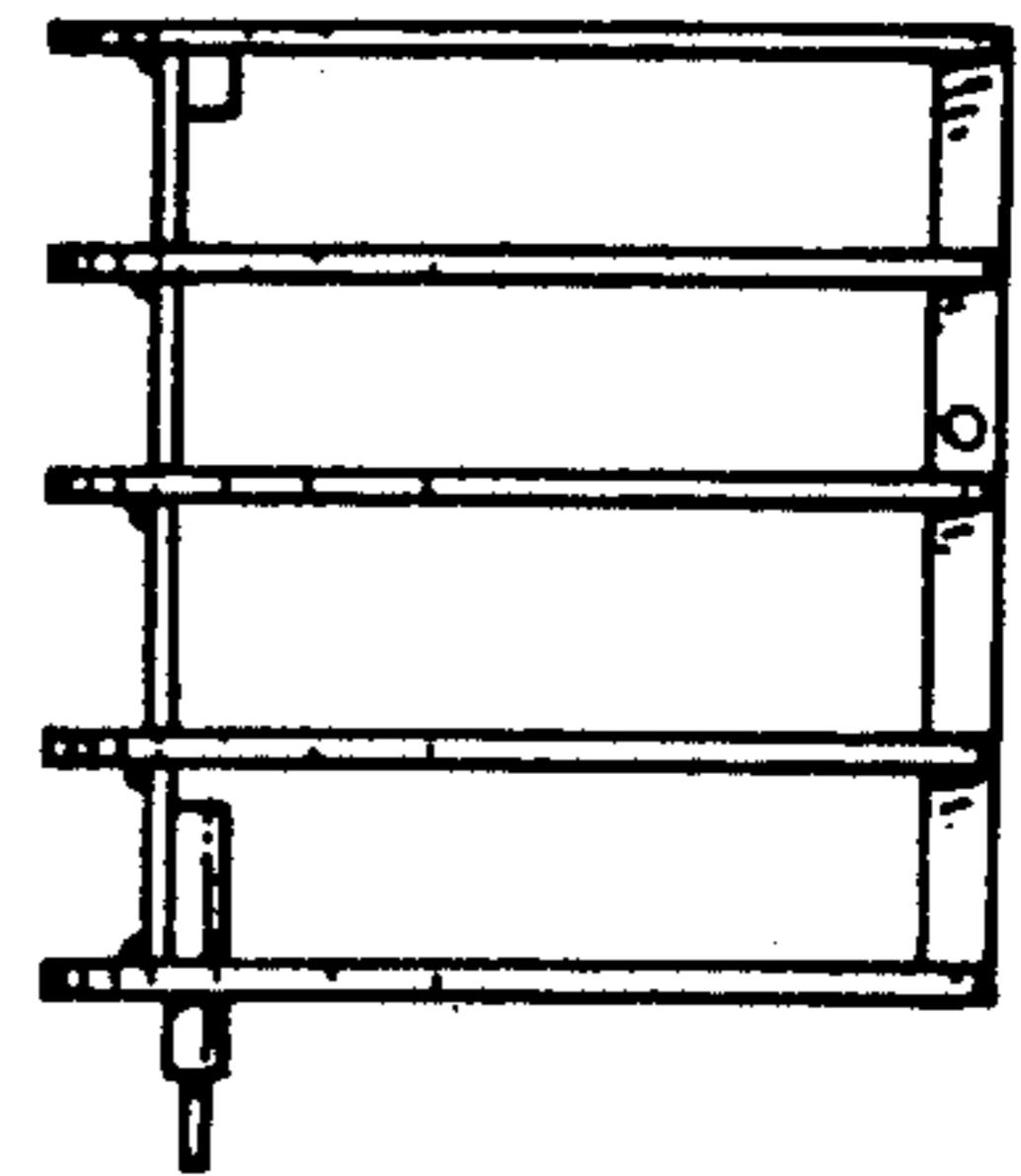

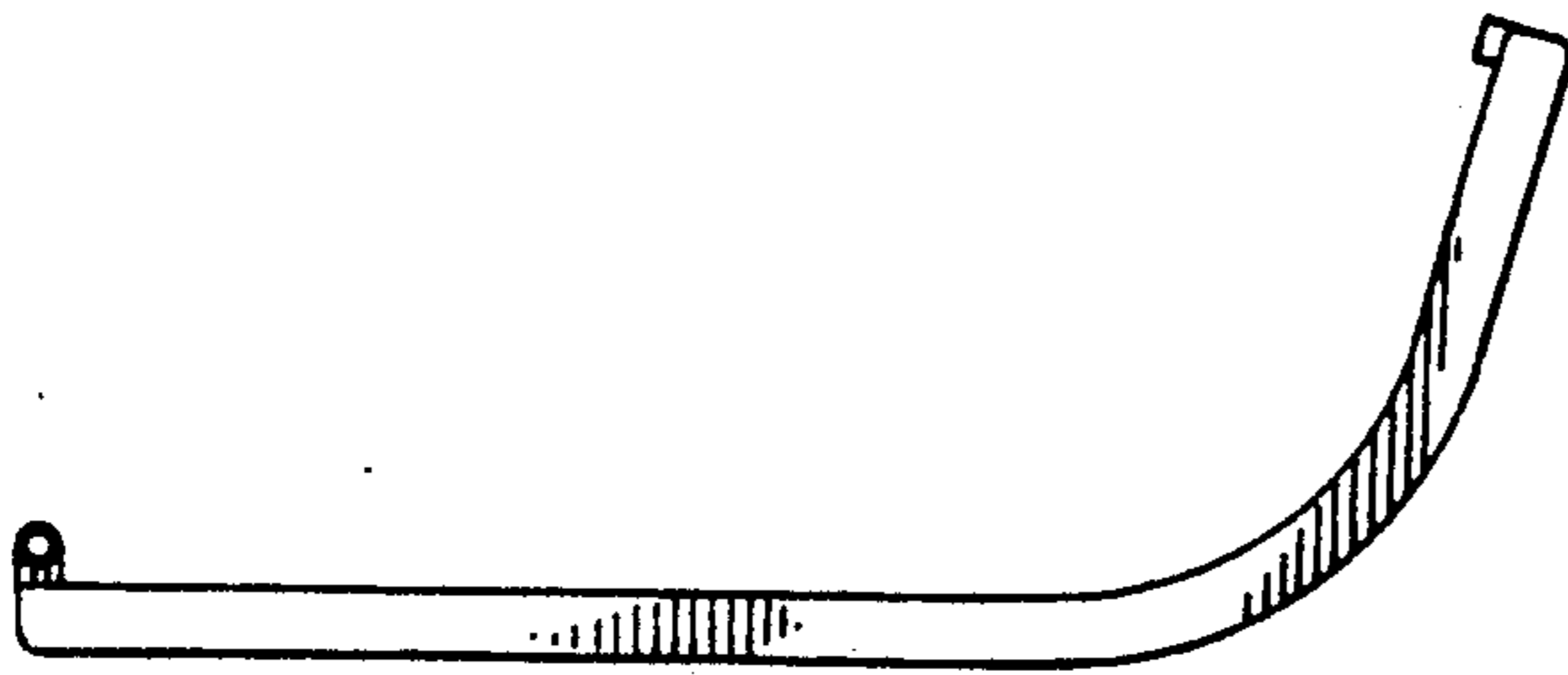

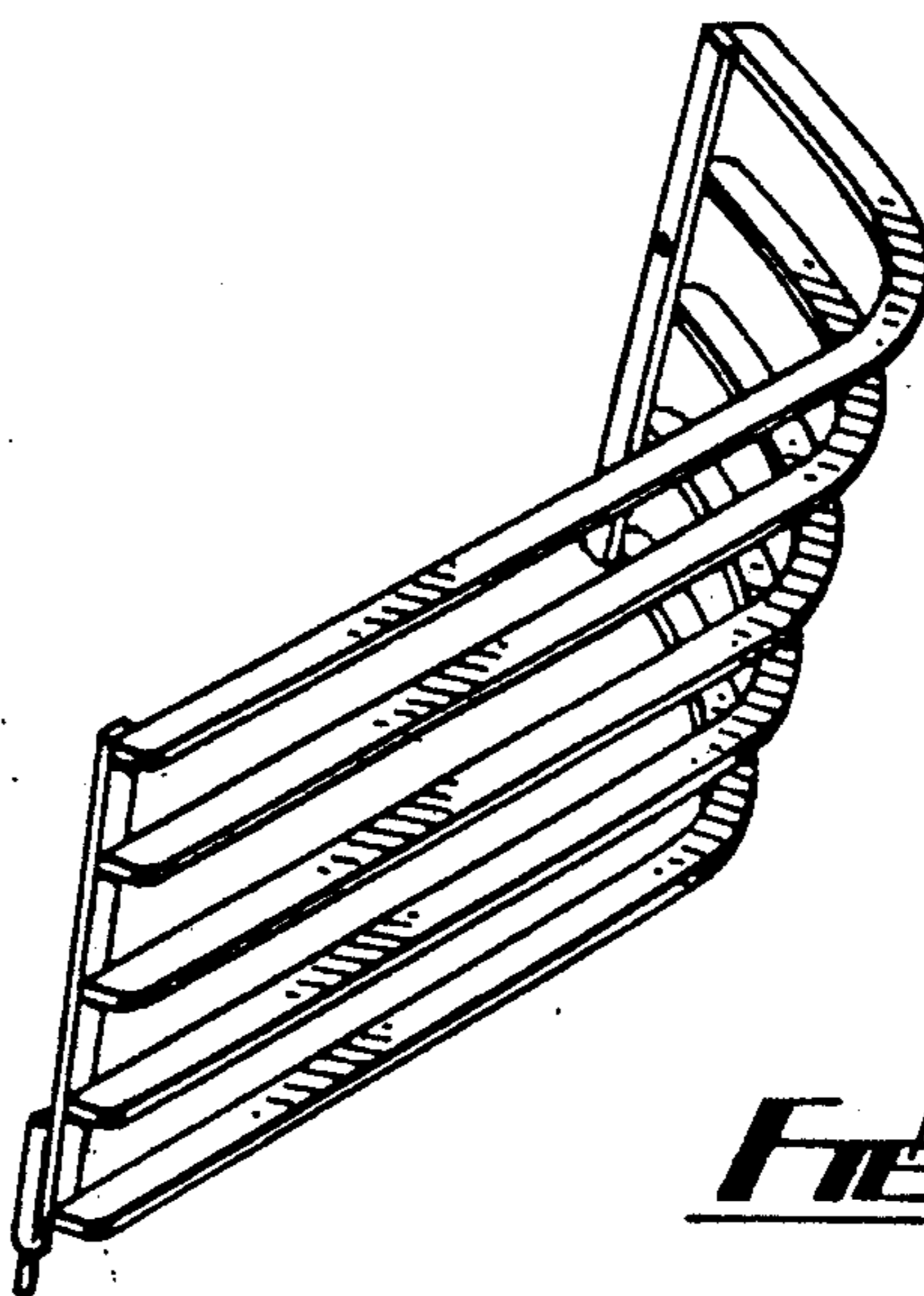

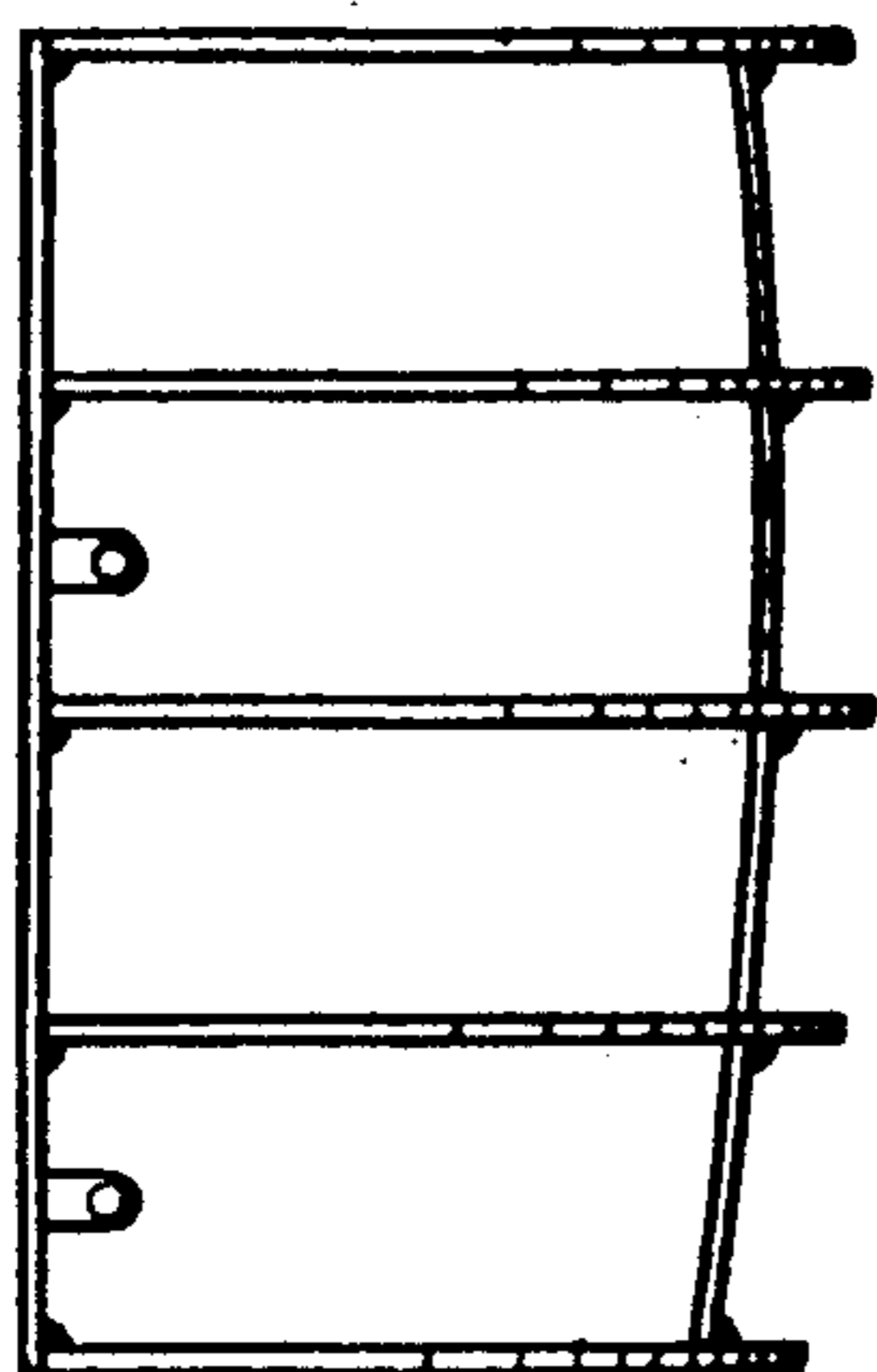

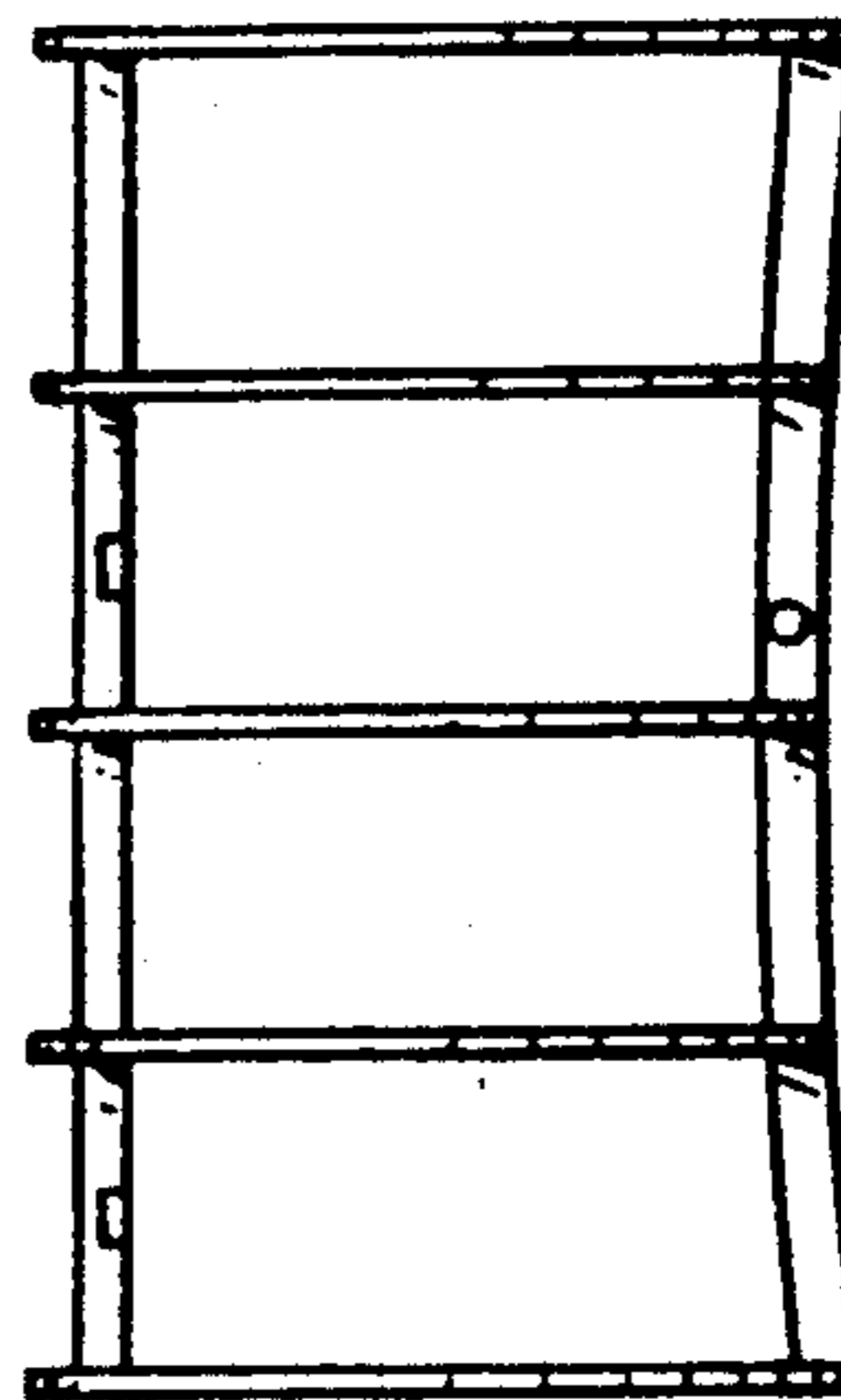

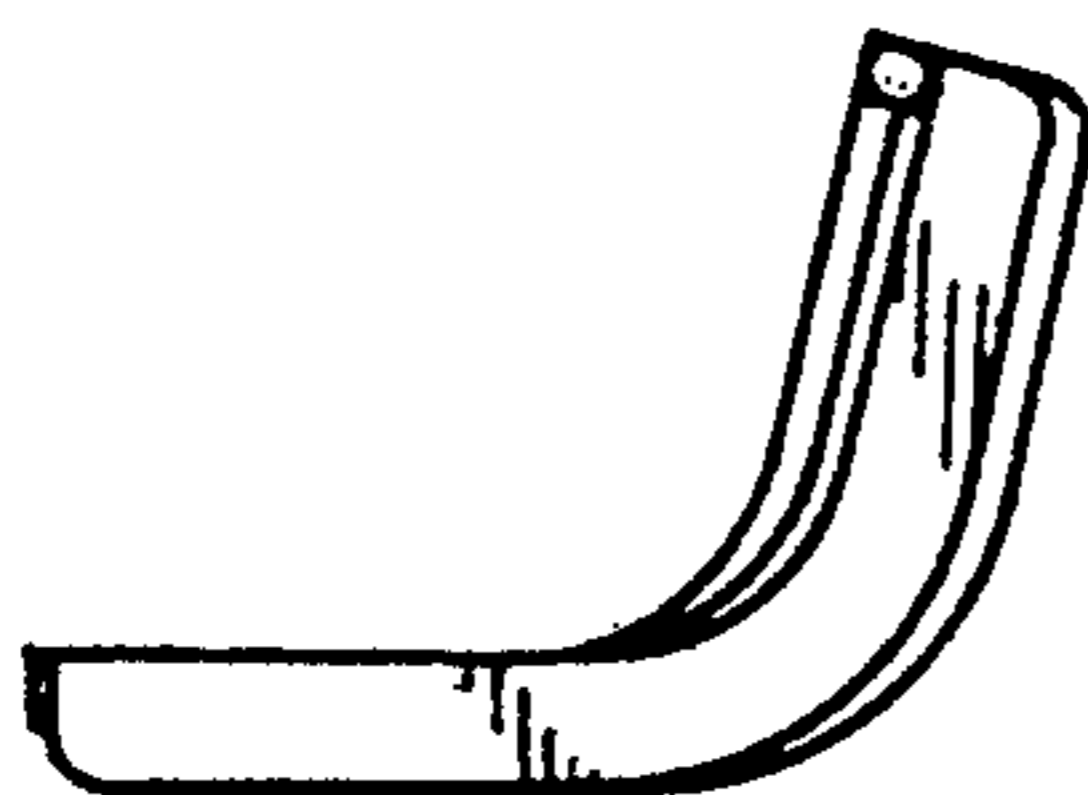

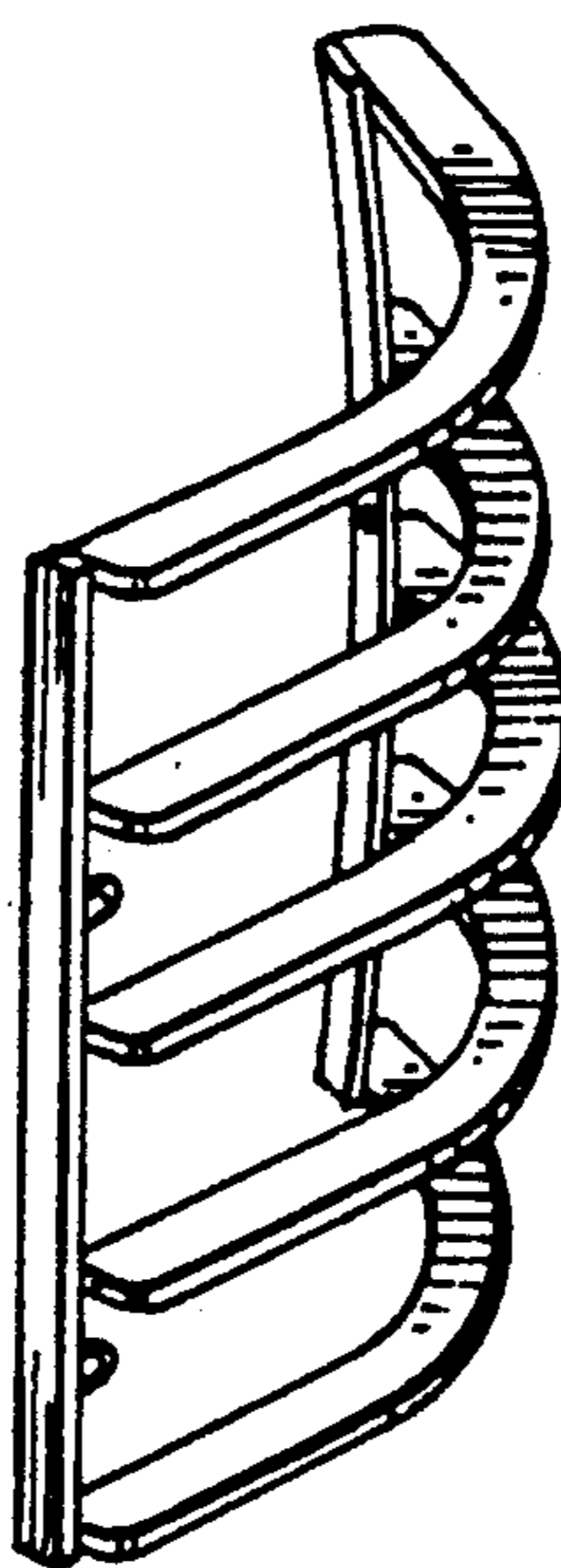

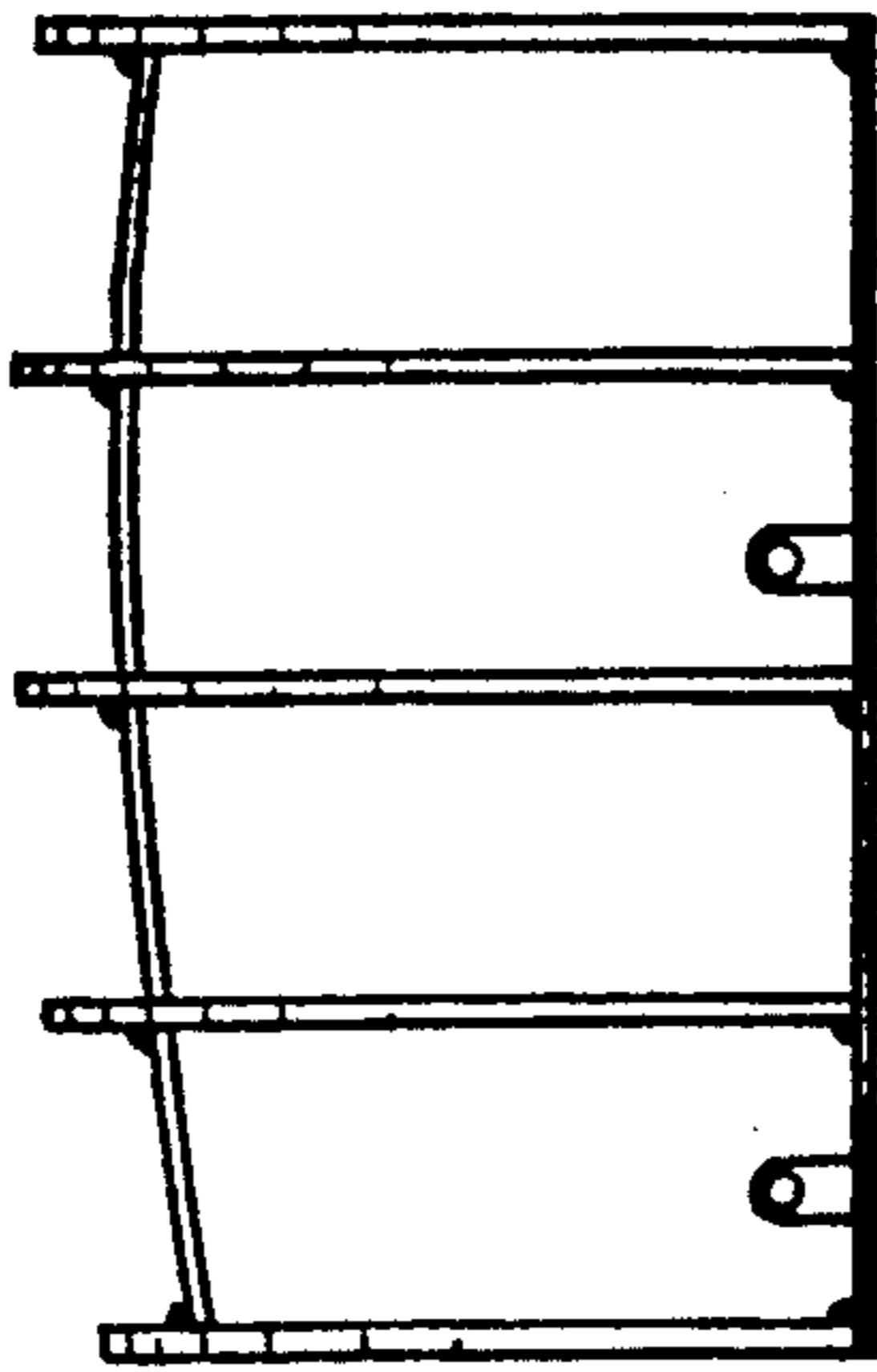

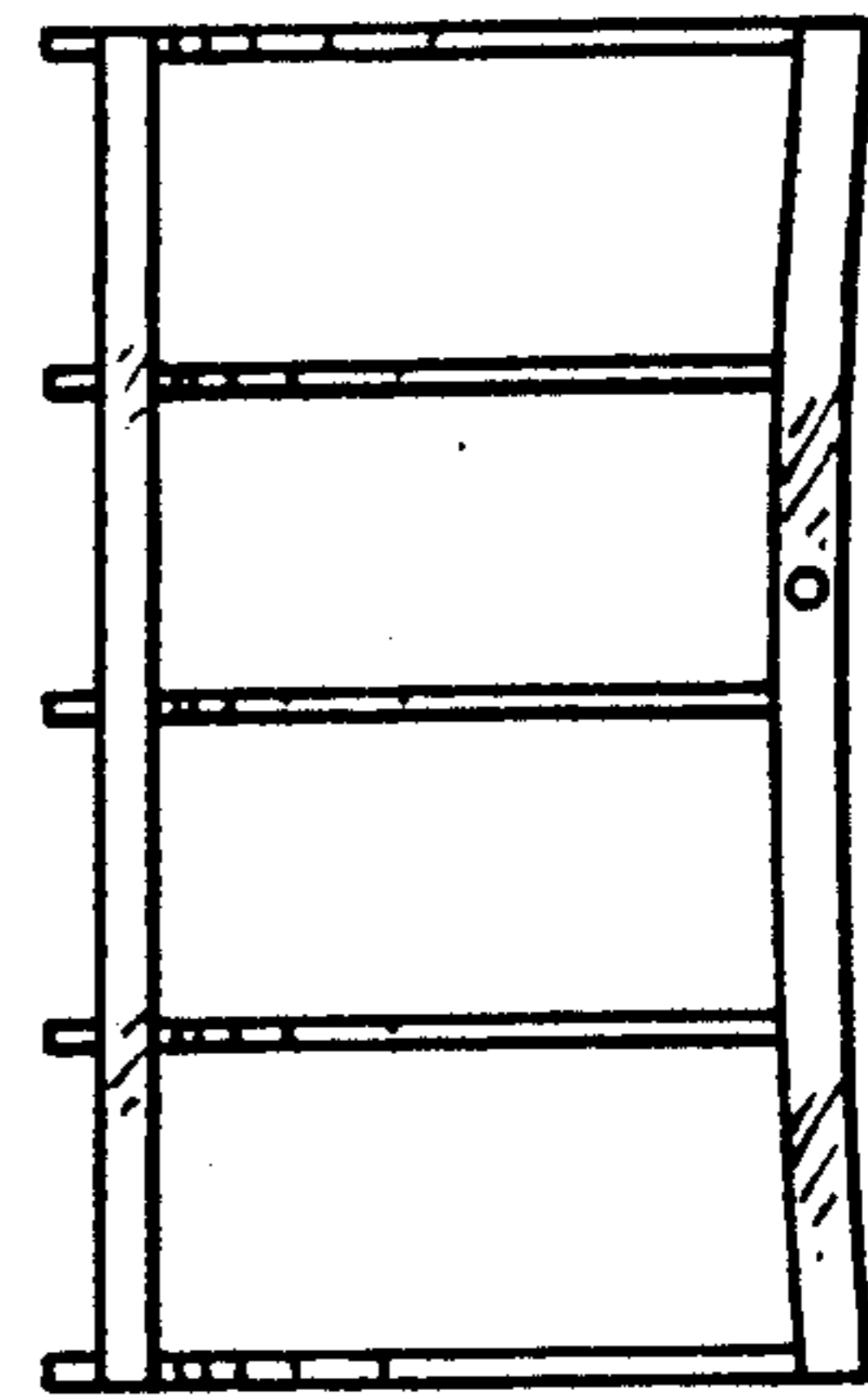

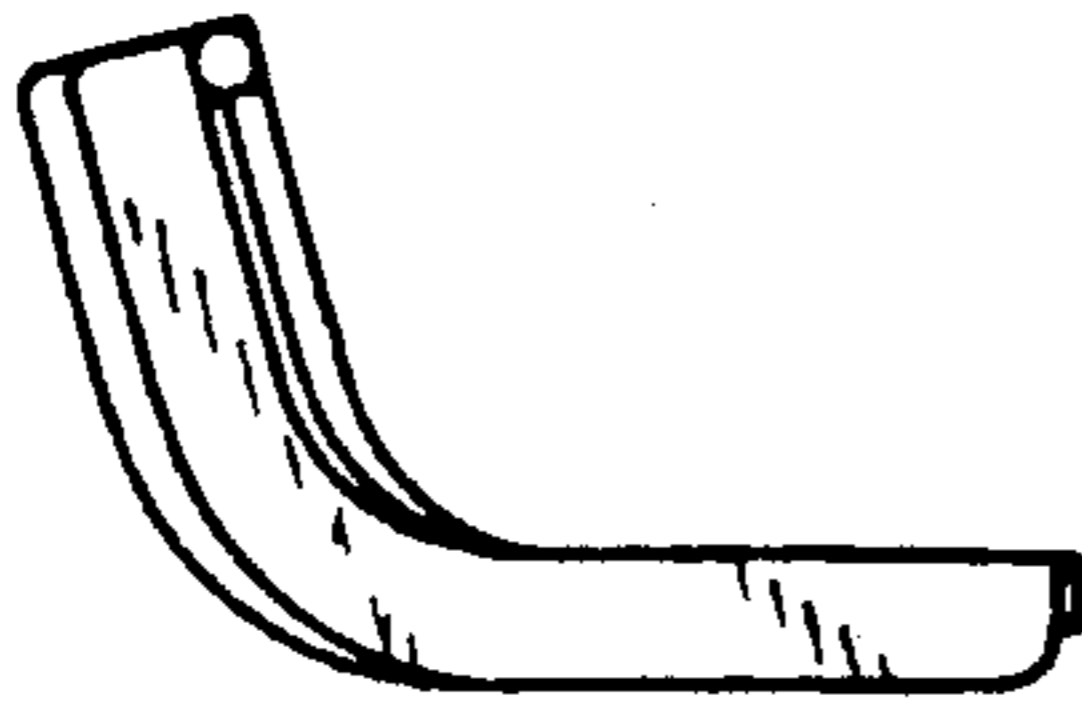

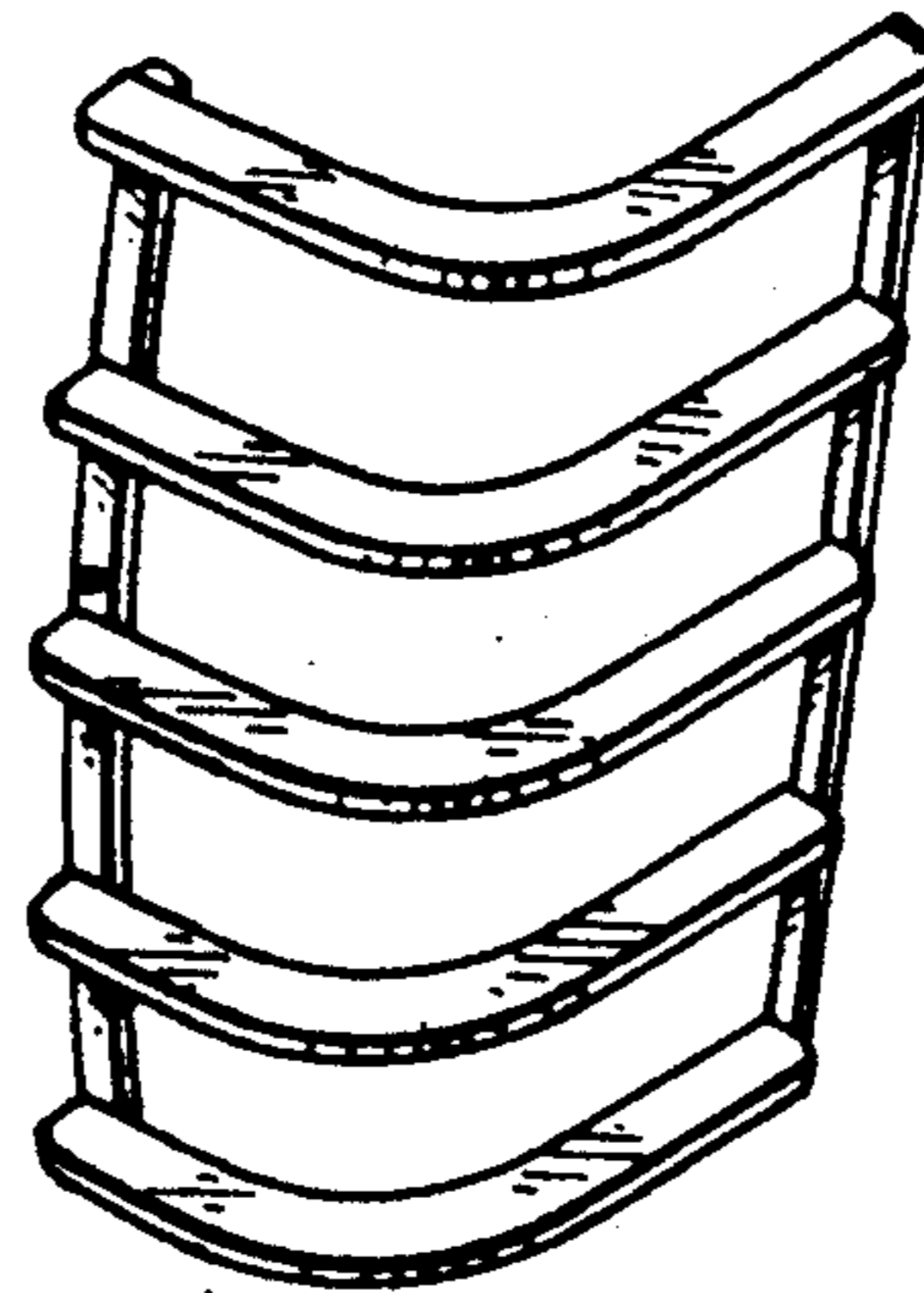
